(57) **CLAIM**

The ornamental design for a container assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container assembly showing my new design;

FIG. 2 is a front elevation thereof;

FIG. 3 is a rear elevation thereof;

FIG. 4 is a left side elevation thereof, the right side elevation view being a mirror image;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a front elevation view of the cap portion of the container assembly, shown separately for clarity of illustration;

FIG. 8 is a rear elevation view thereof;

FIG. 9 is a left side elevation thereof, the right side elevation view being a mirror image;

FIG. 10 is a top plan view thereof, rotated 90° from FIG. 7;

FIG. 11 is a side elevation view of the container portion of the container assembly, shown separately for clarity of illustration;

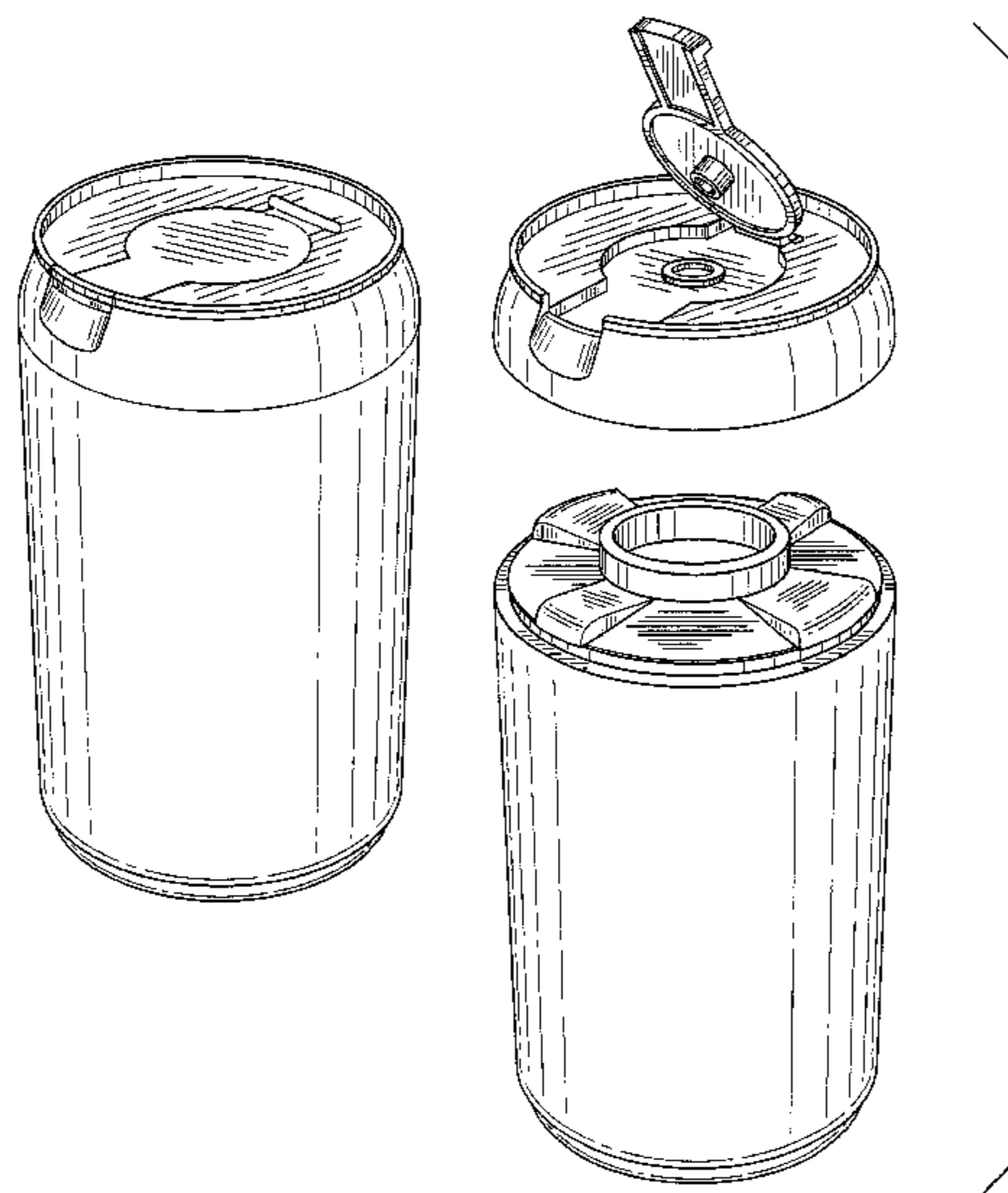
FIG. 12 is a front elevation thereof;

FIG. 13 is a top plan view thereof; and,

FIG. 14 is an exploded perspective view of the container assembly of FIG. 1, showing the independent parts of the container assembly.

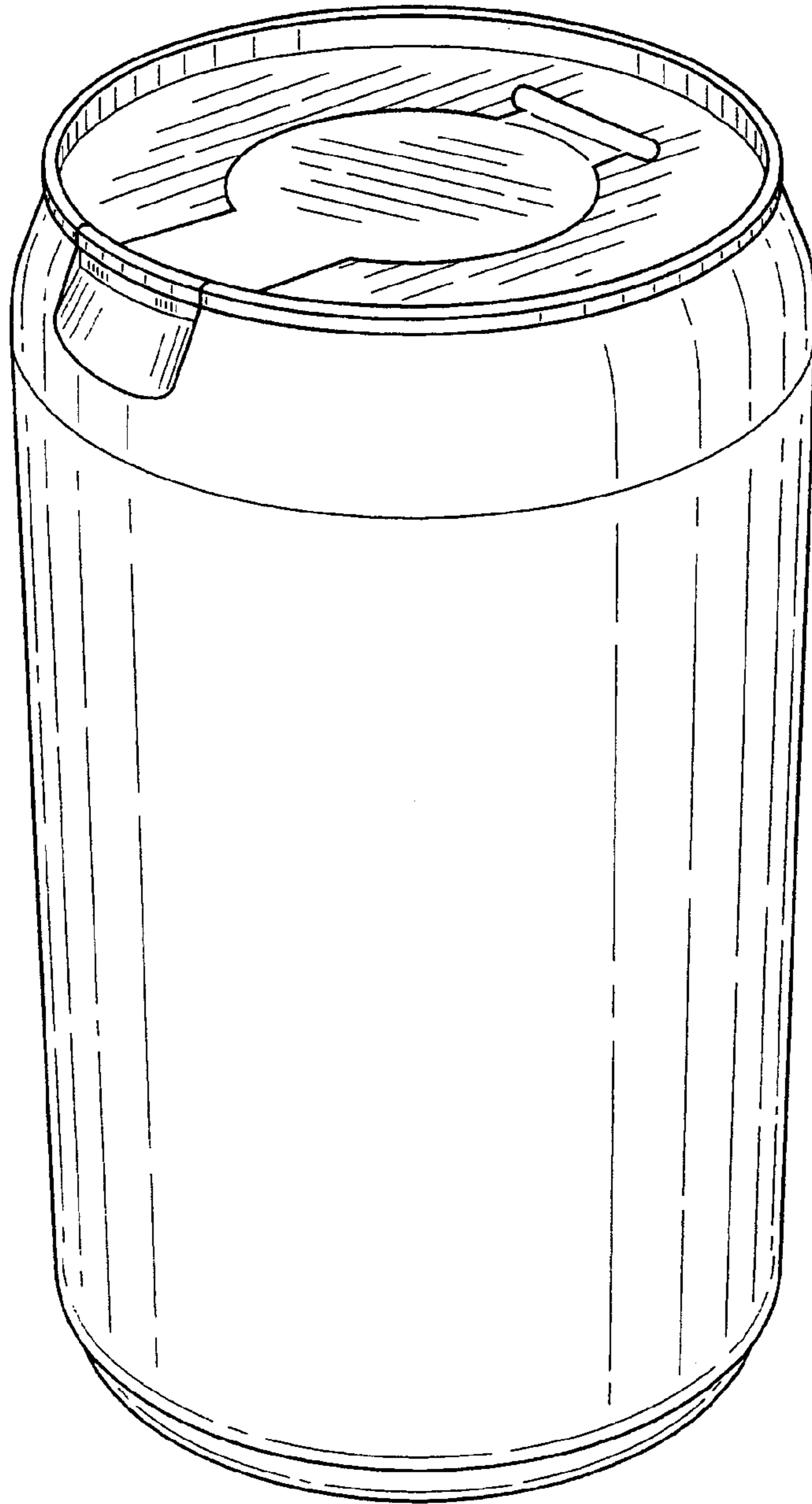

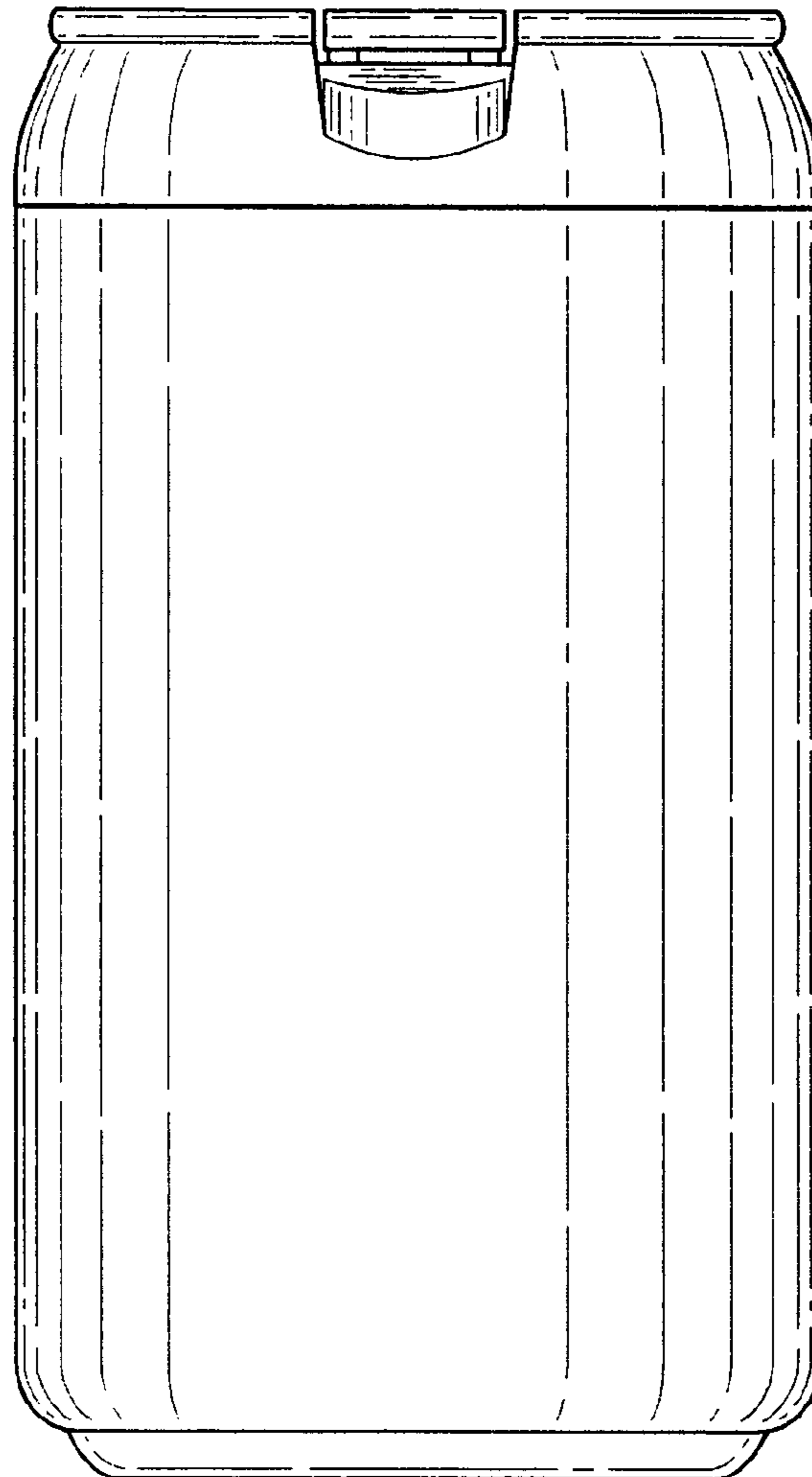

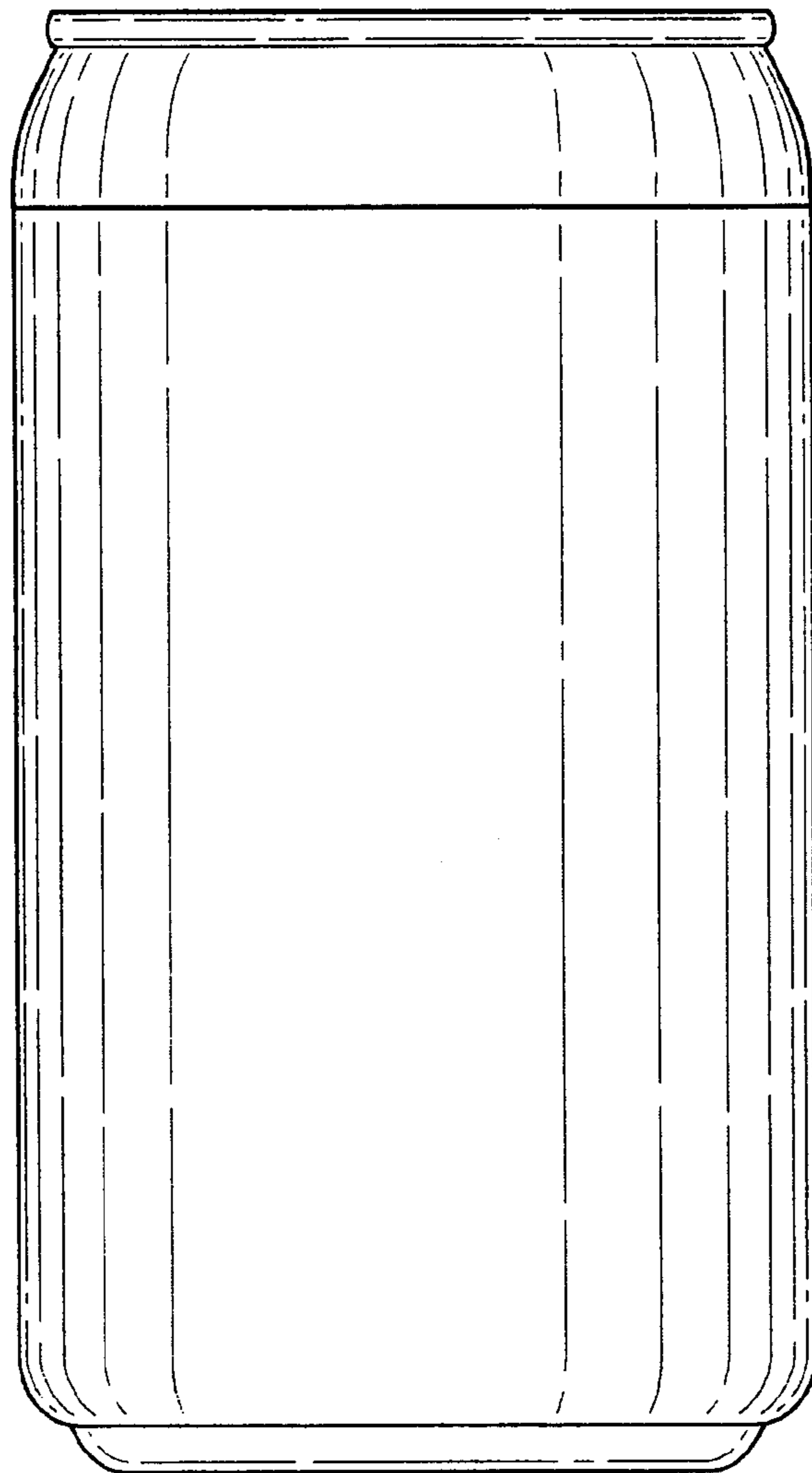

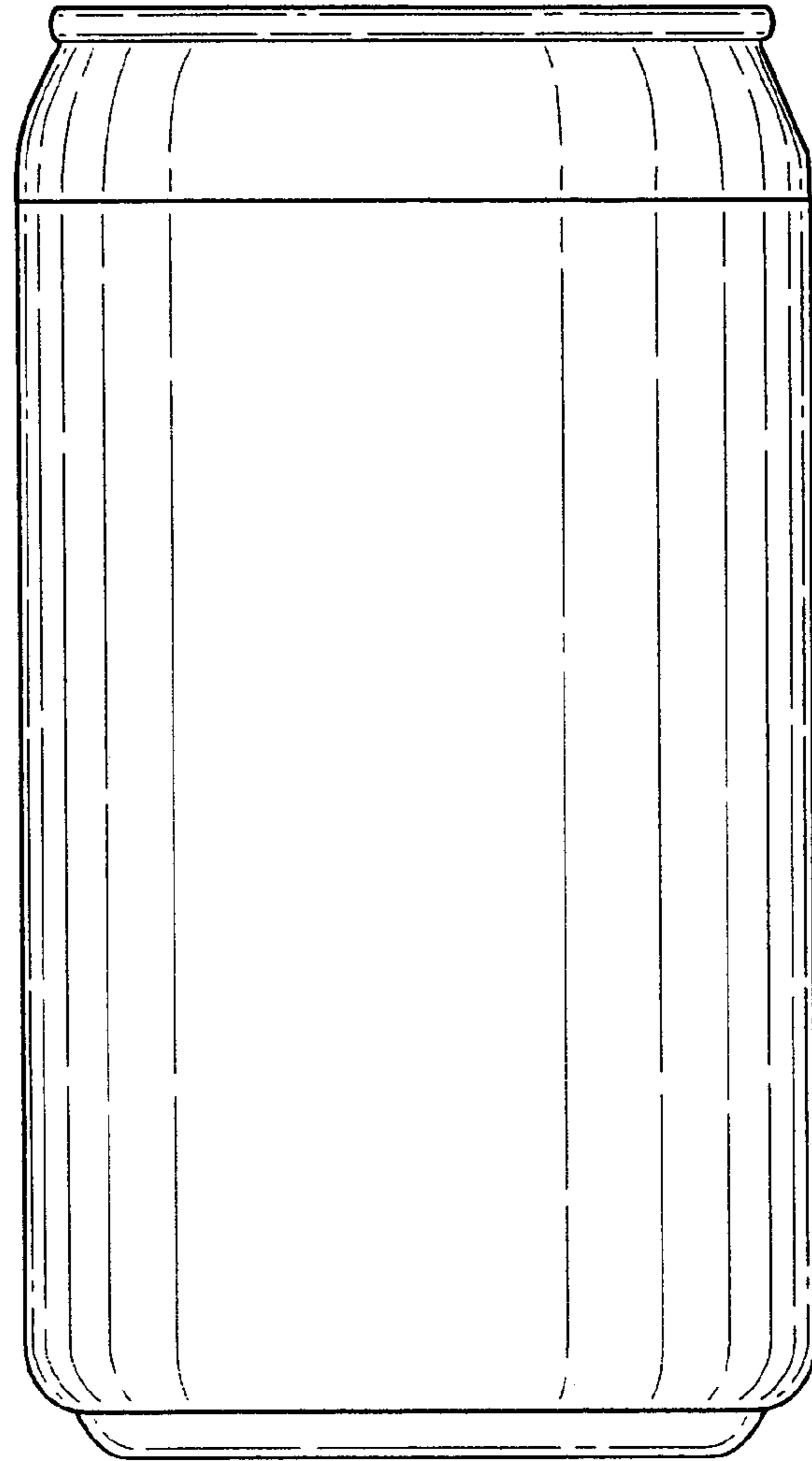

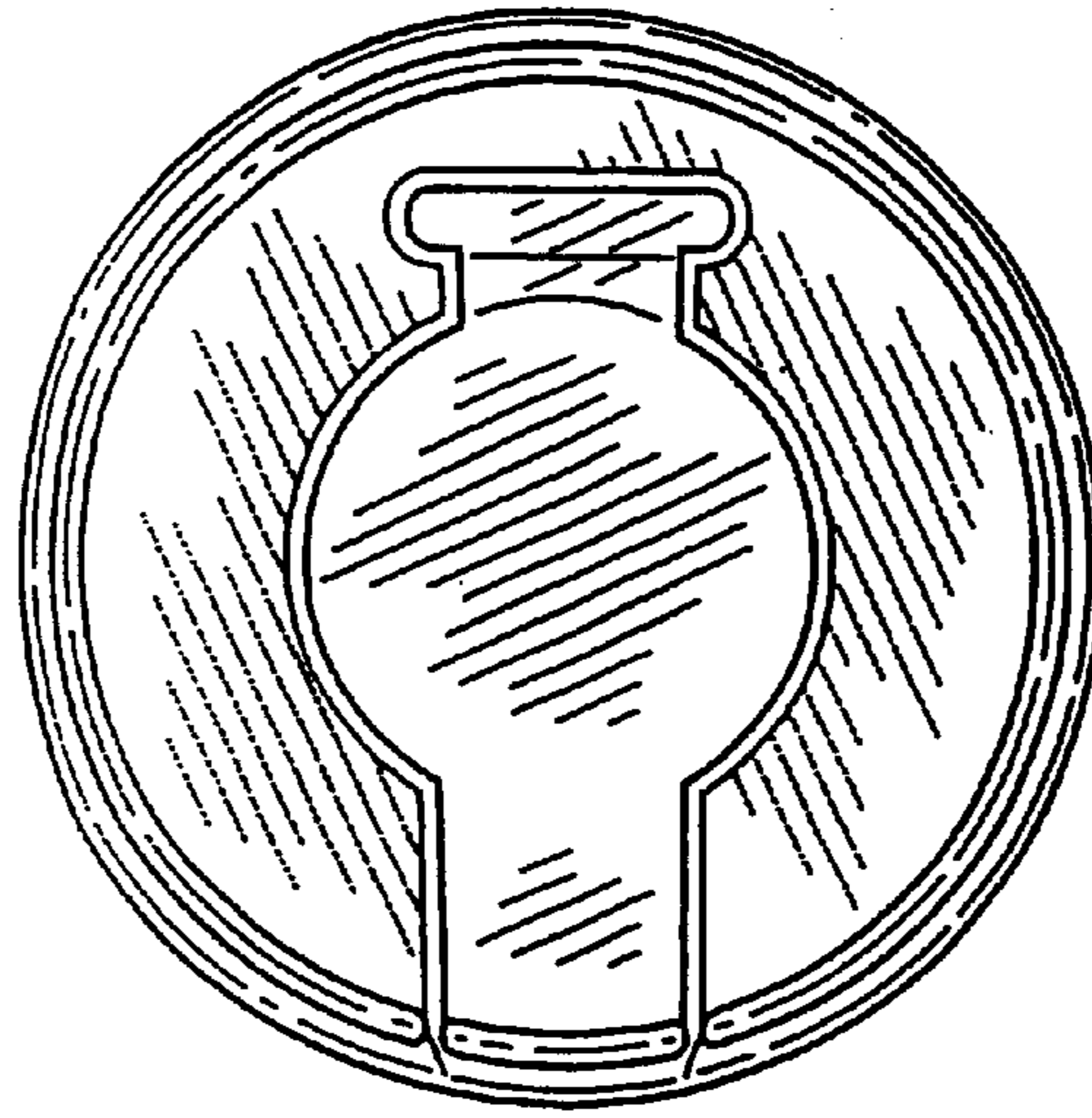

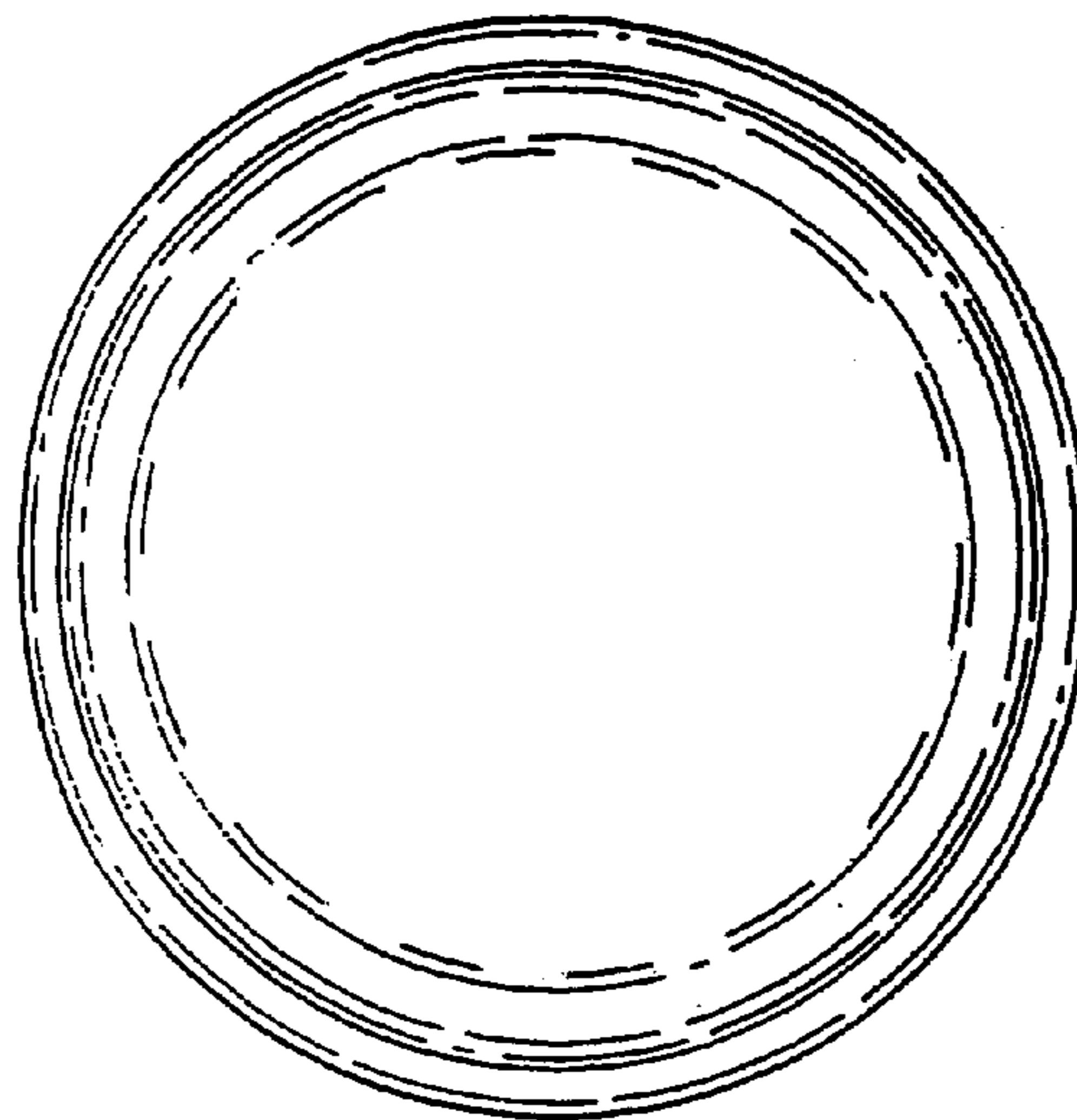

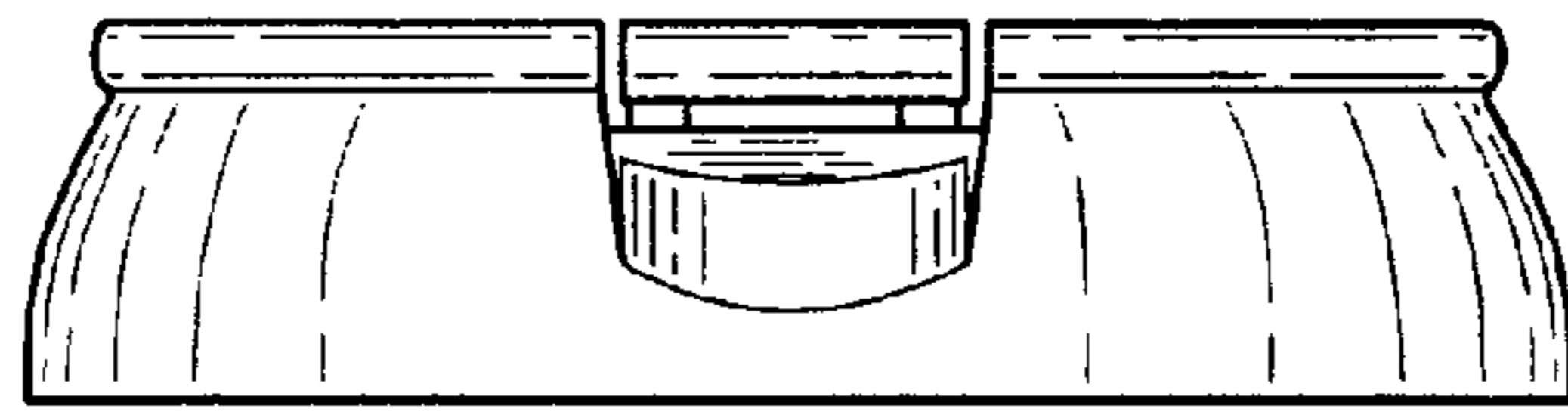

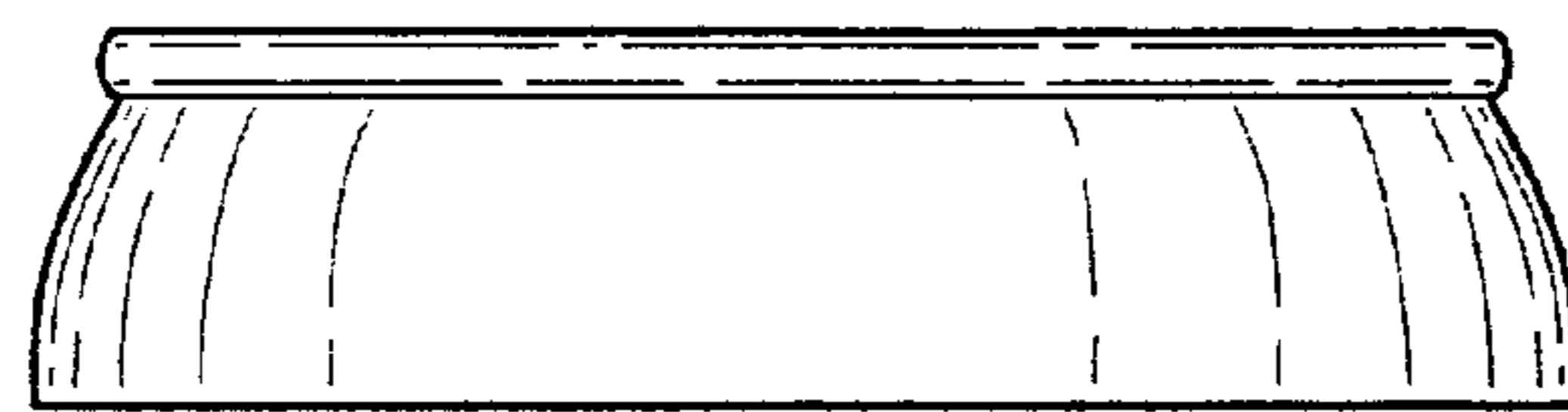

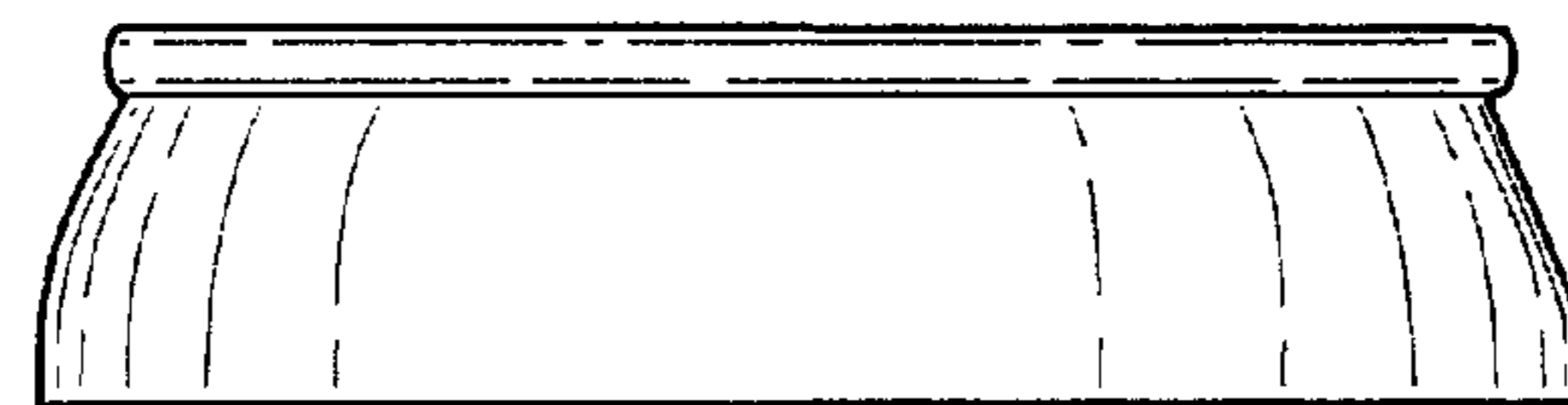

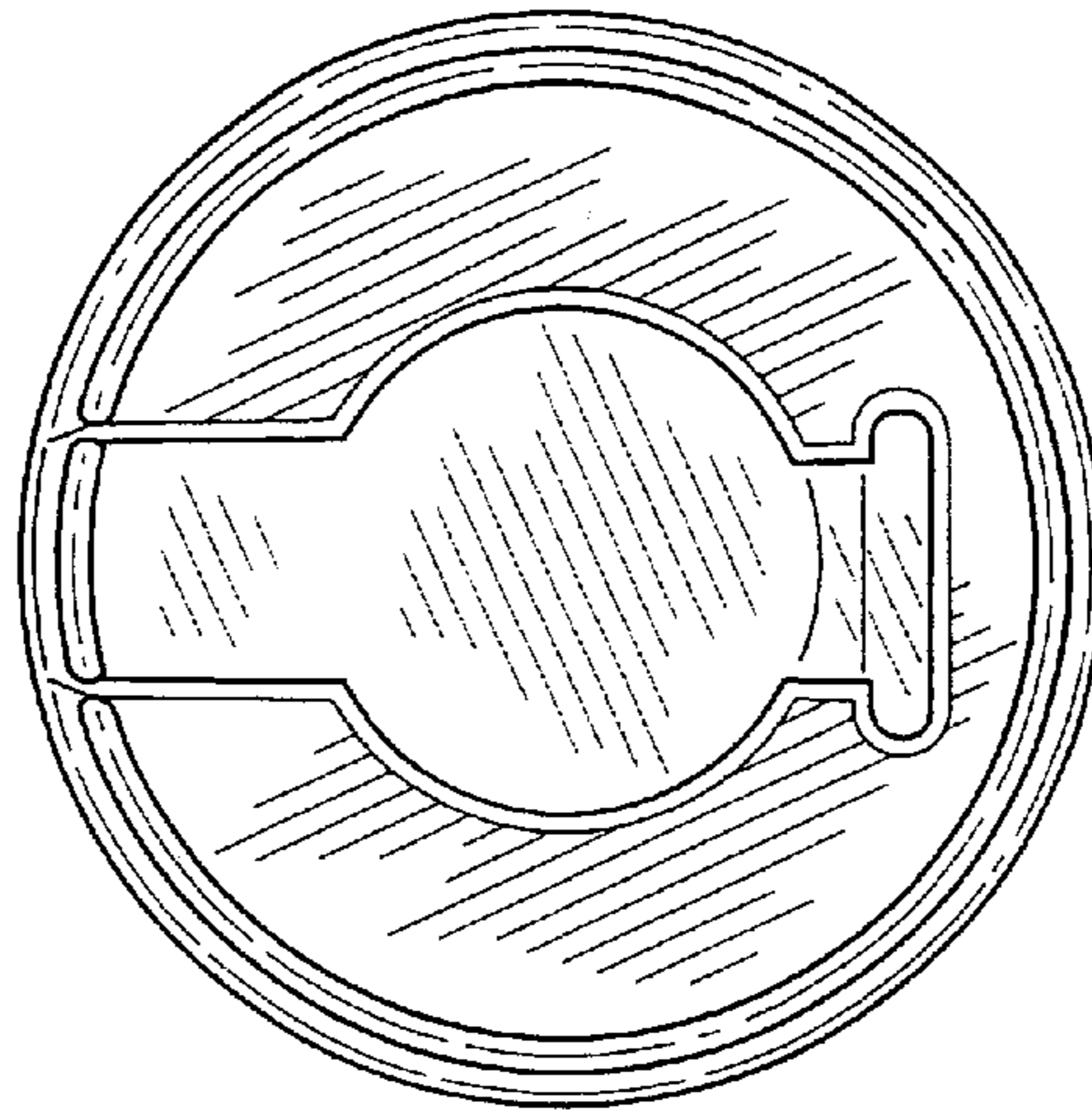

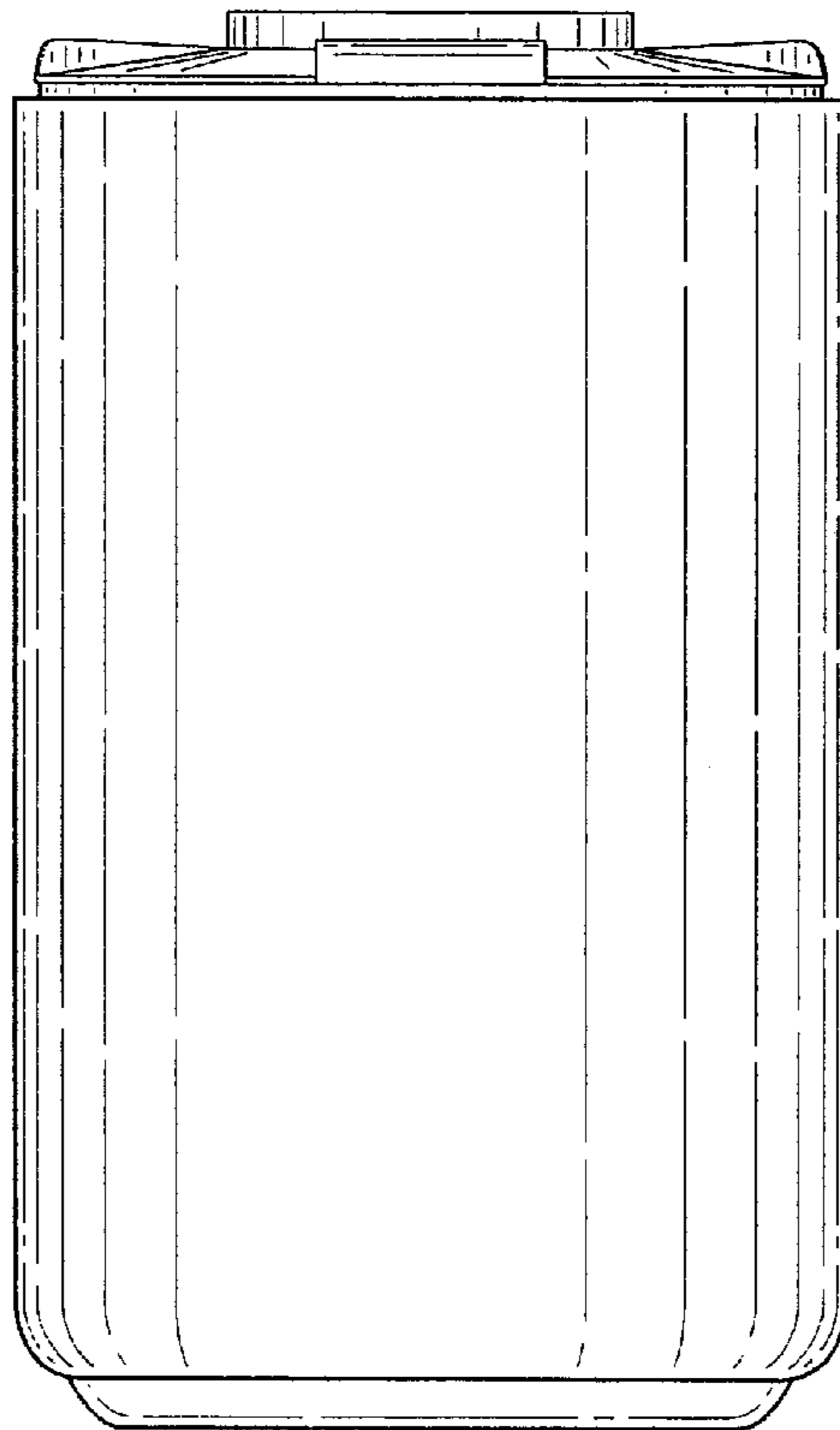

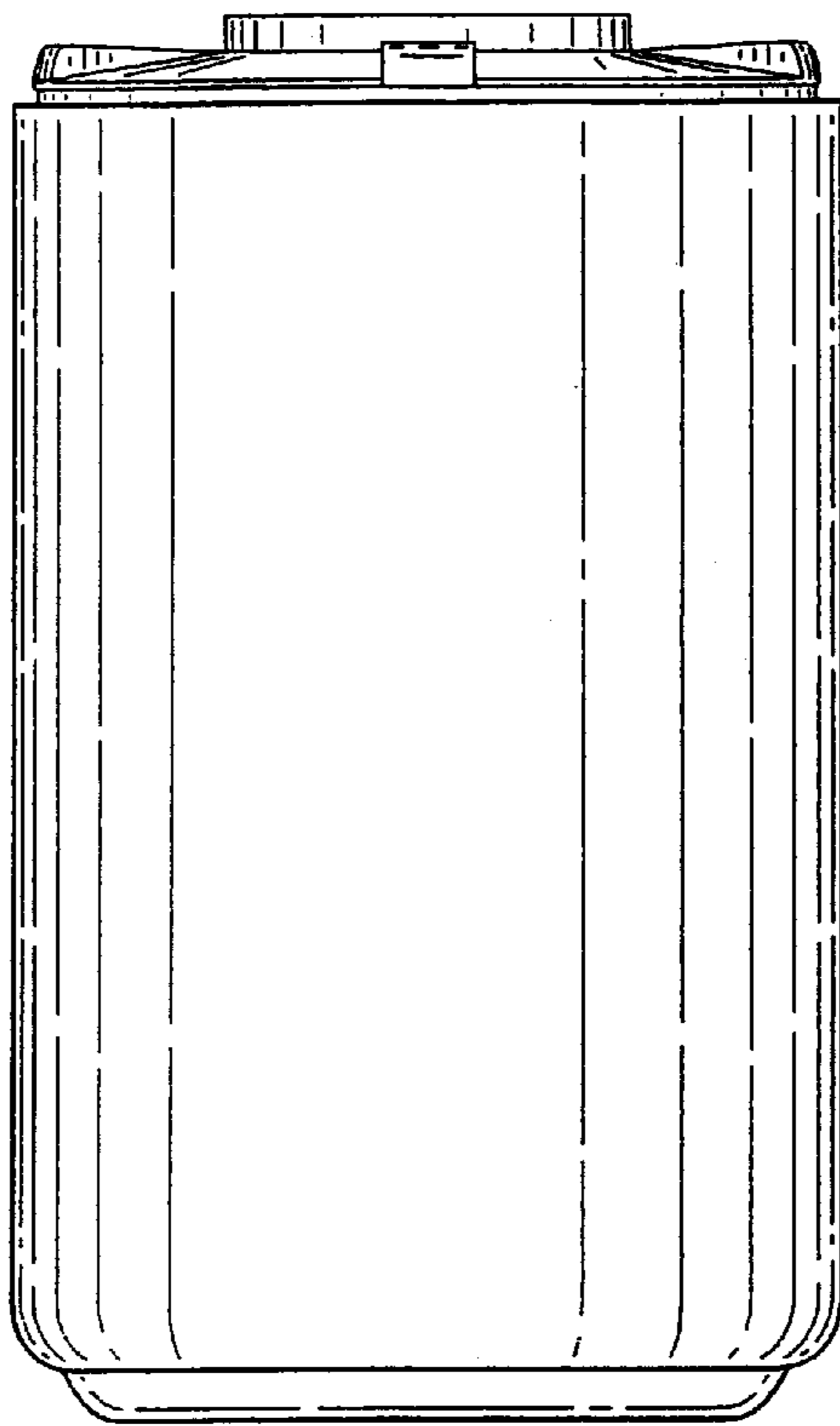

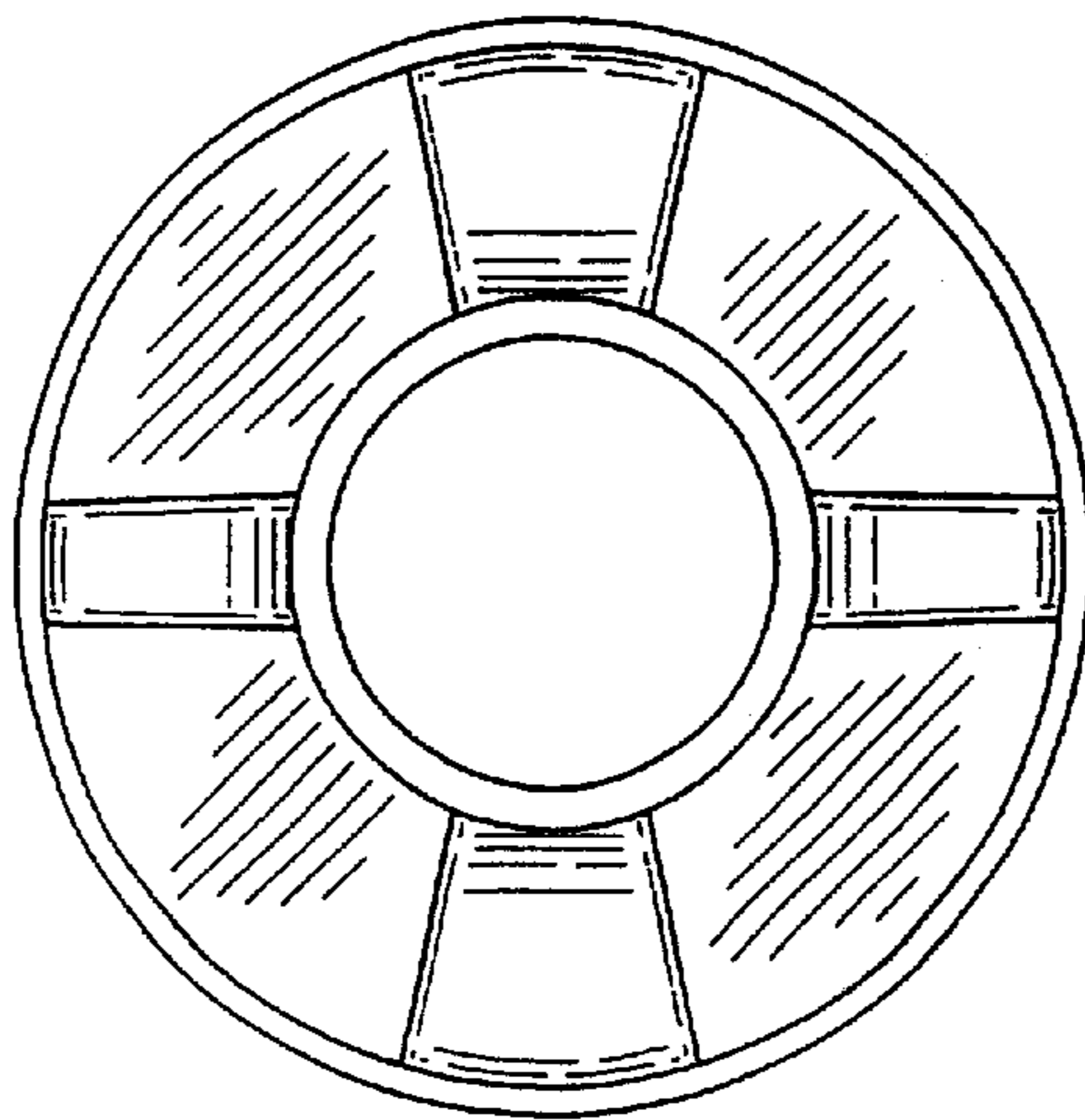

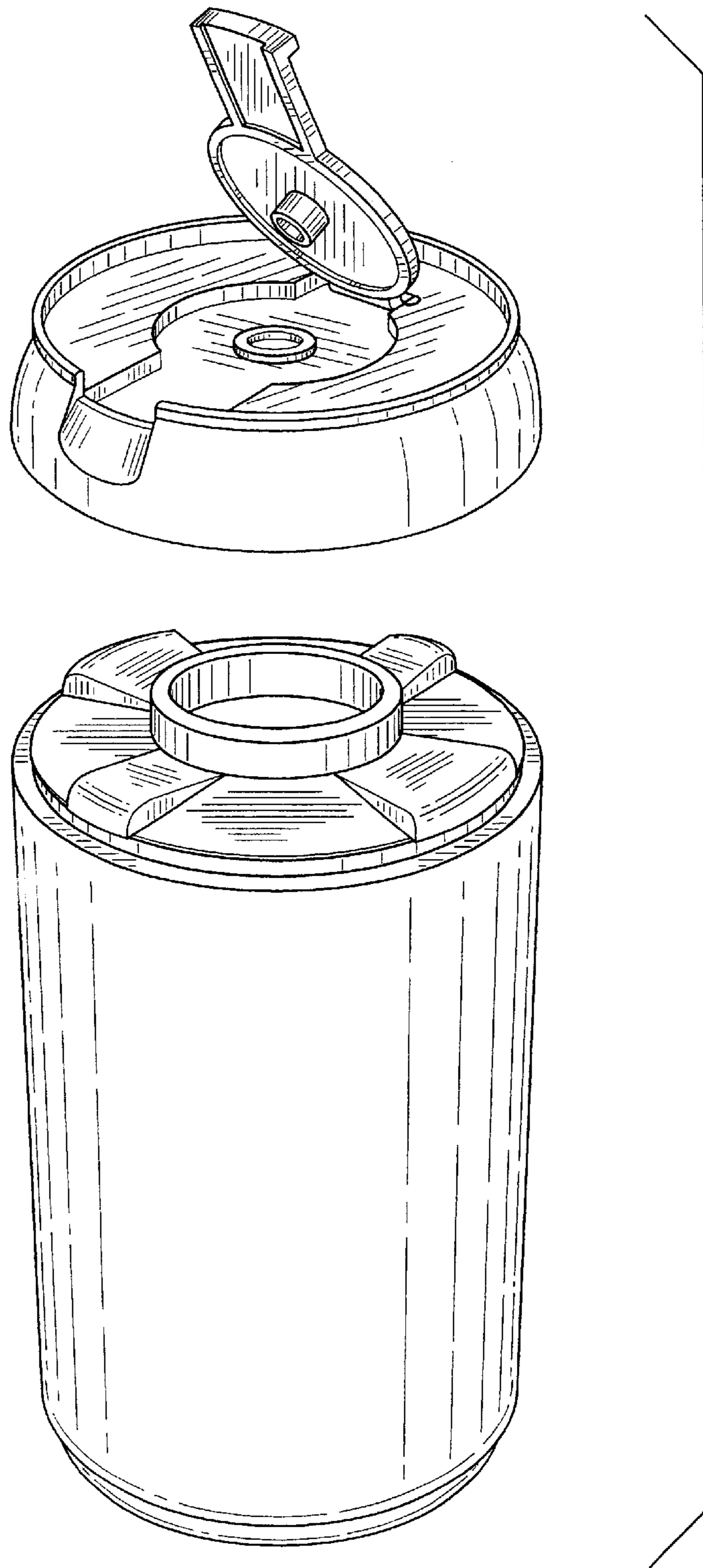
