The ornamental design for the food product container, as shown and described.

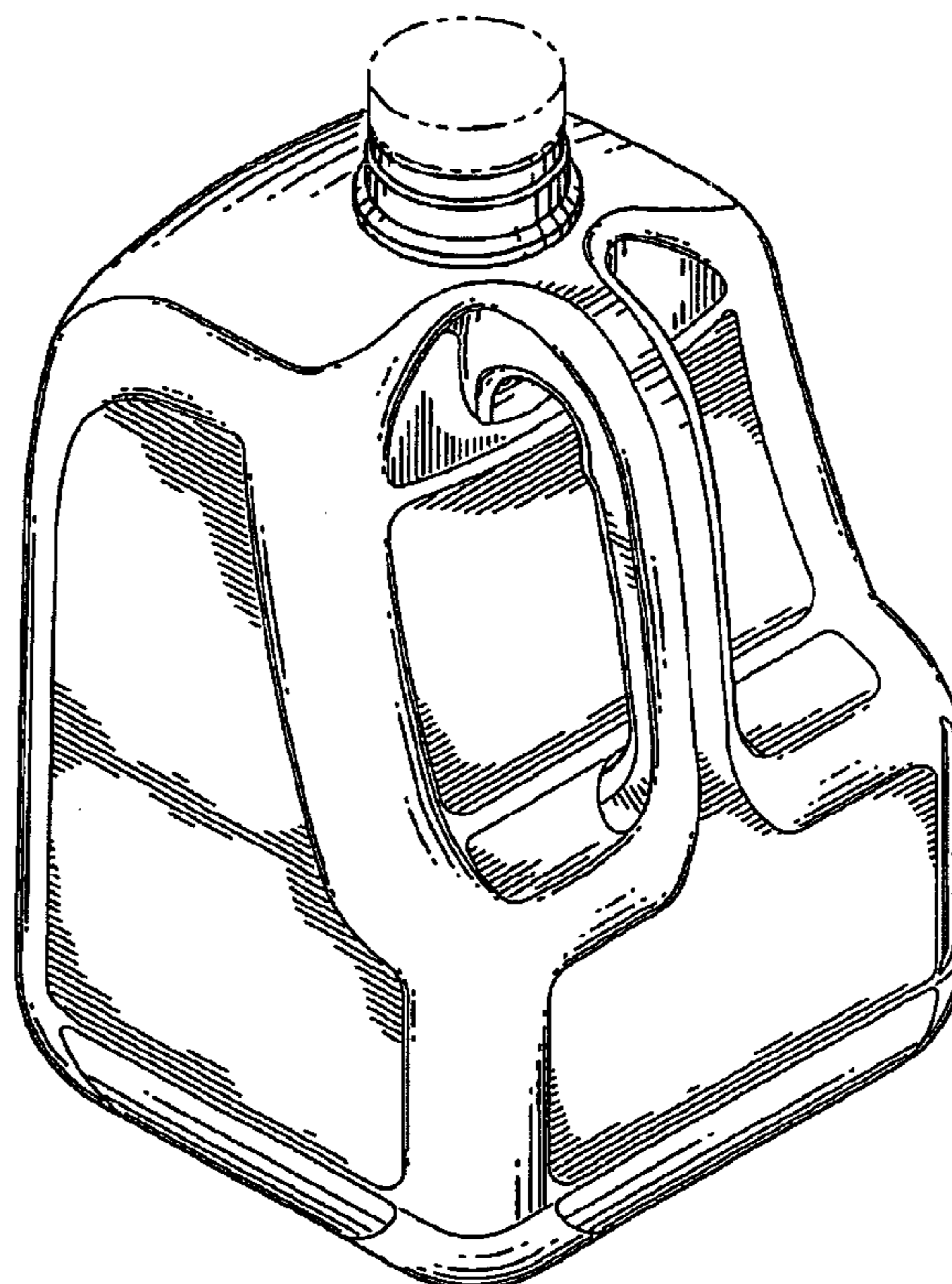
**DESCRIPTION**

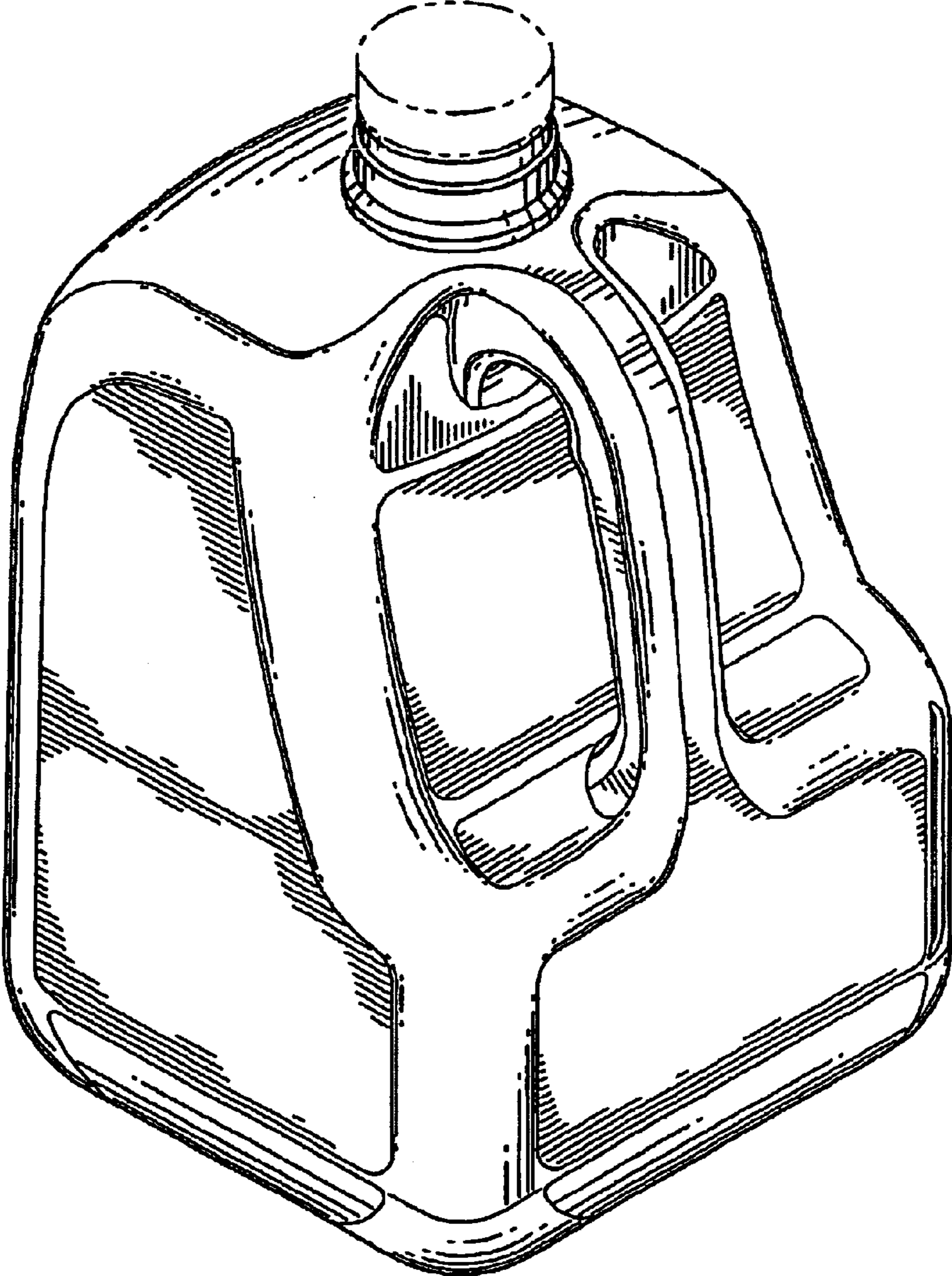
FIG. 1 is a perspective view from above rotated one quarter turn from the back of a second embodiment of the food product container;

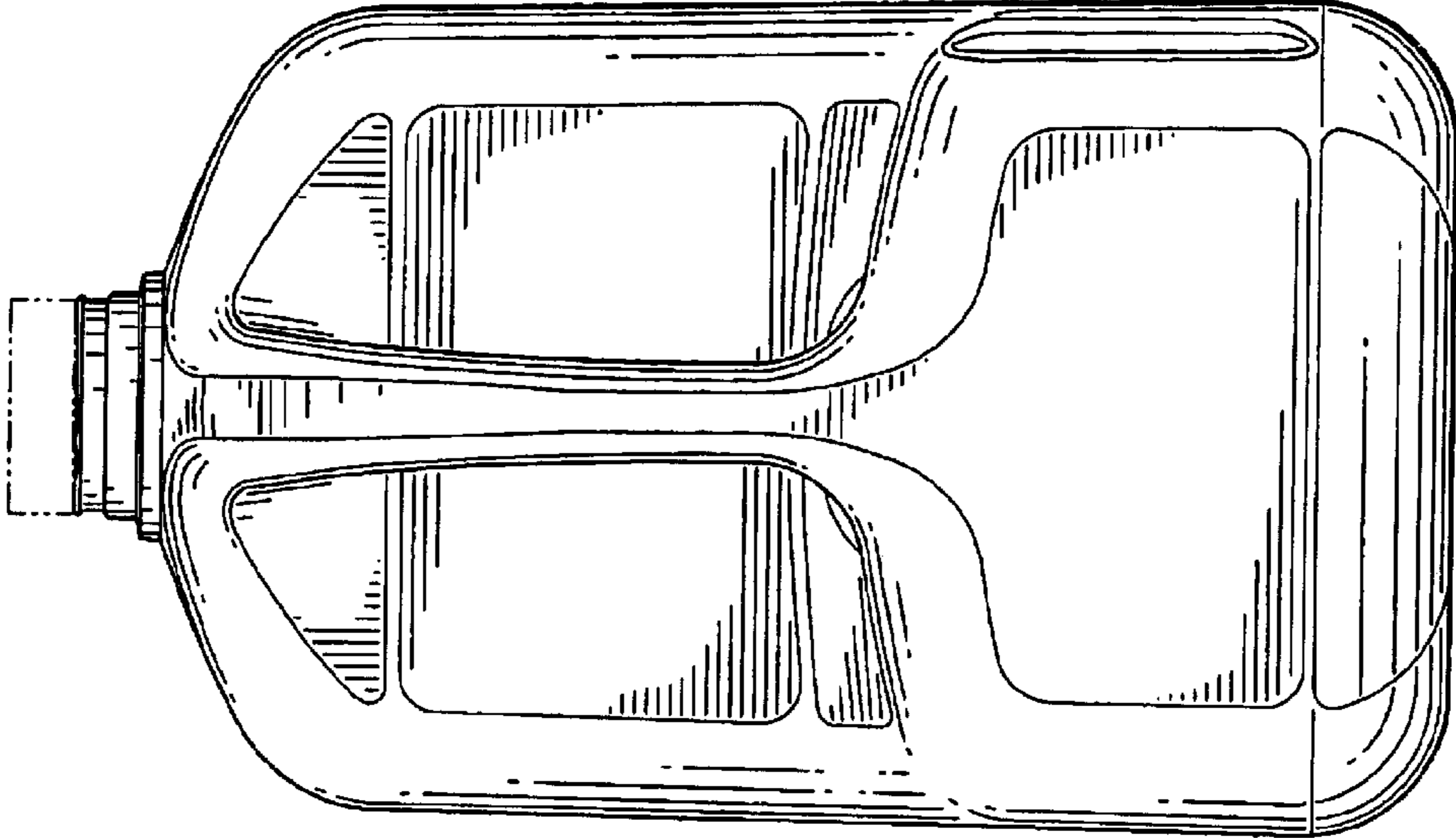

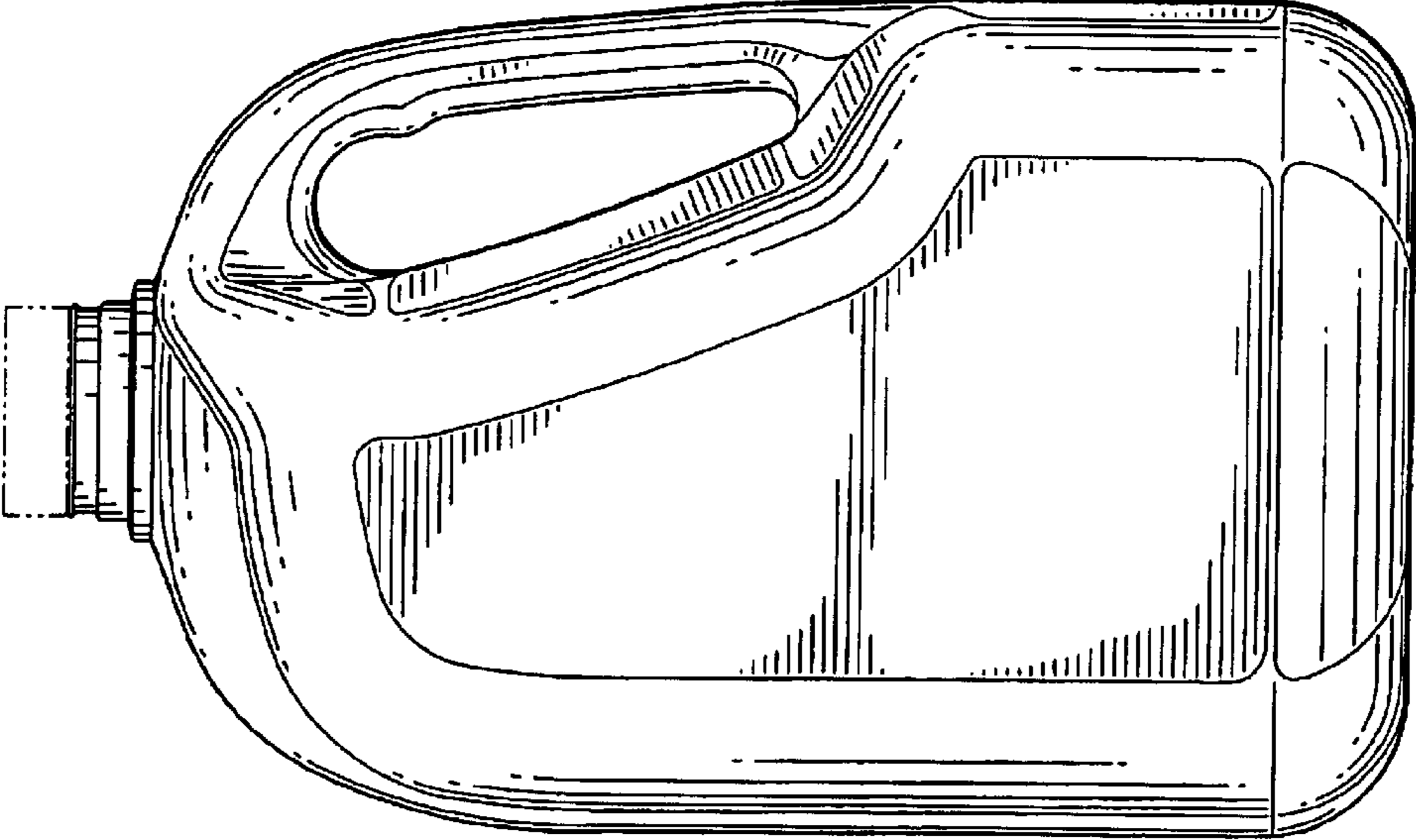

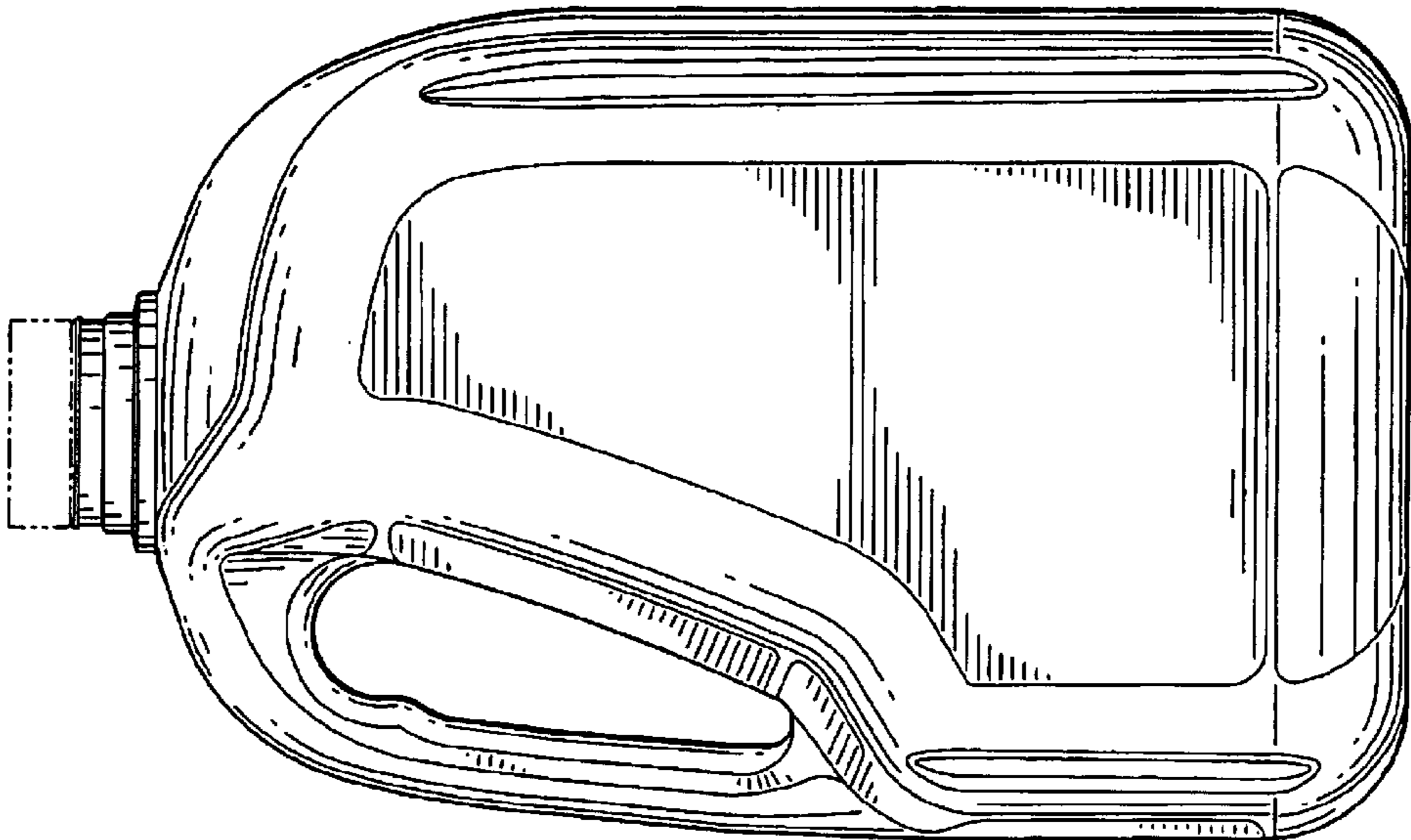

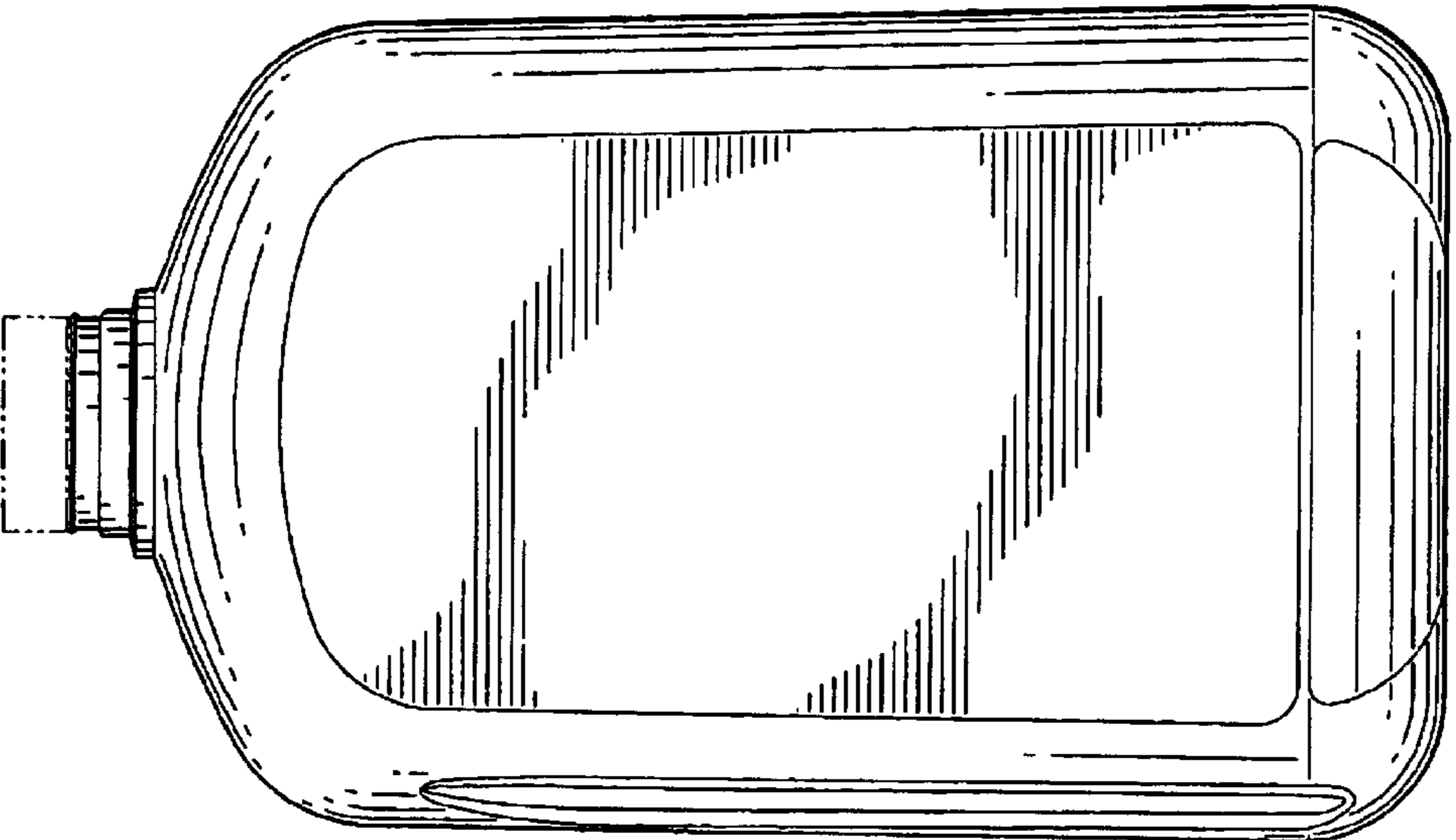
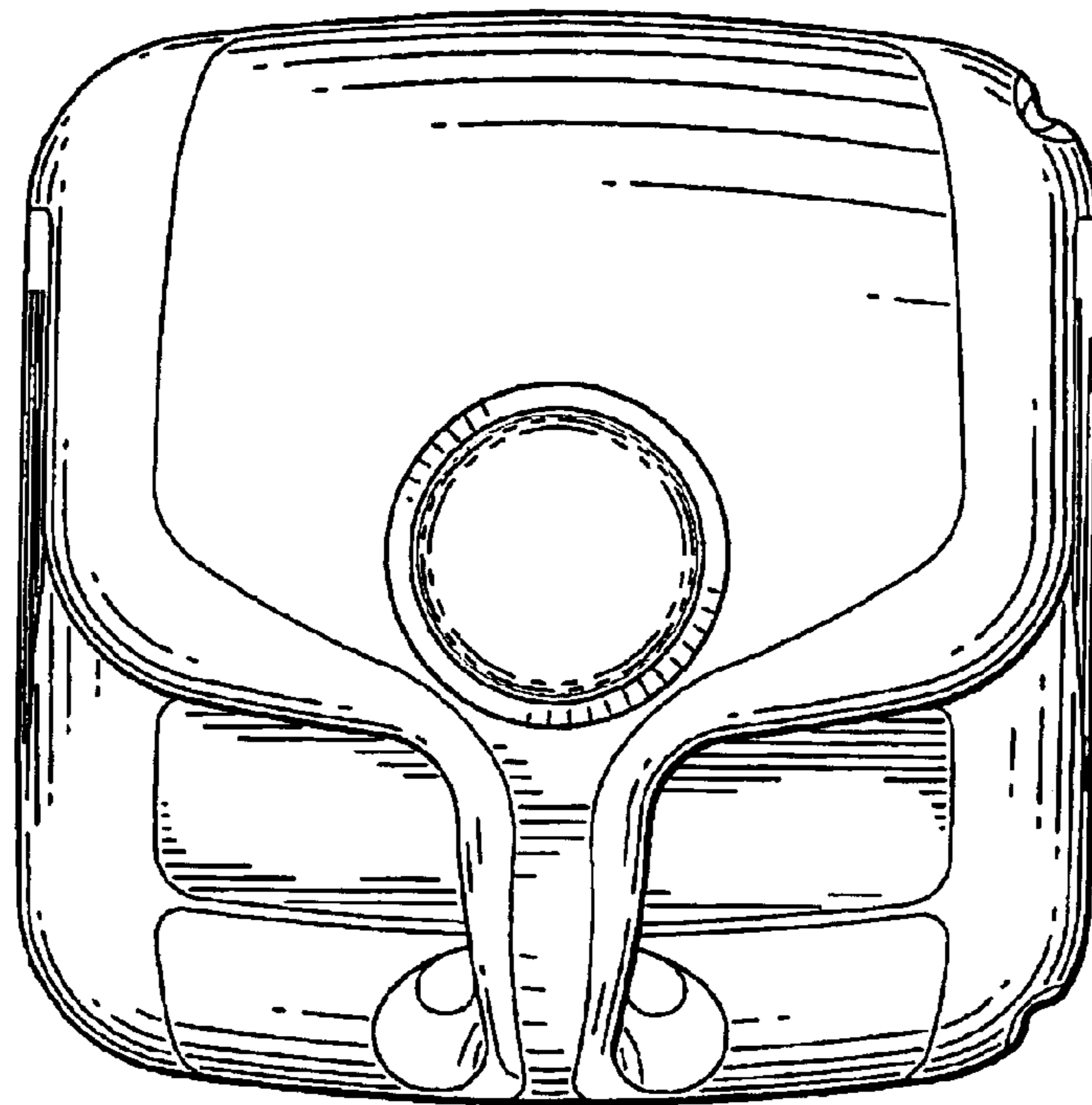
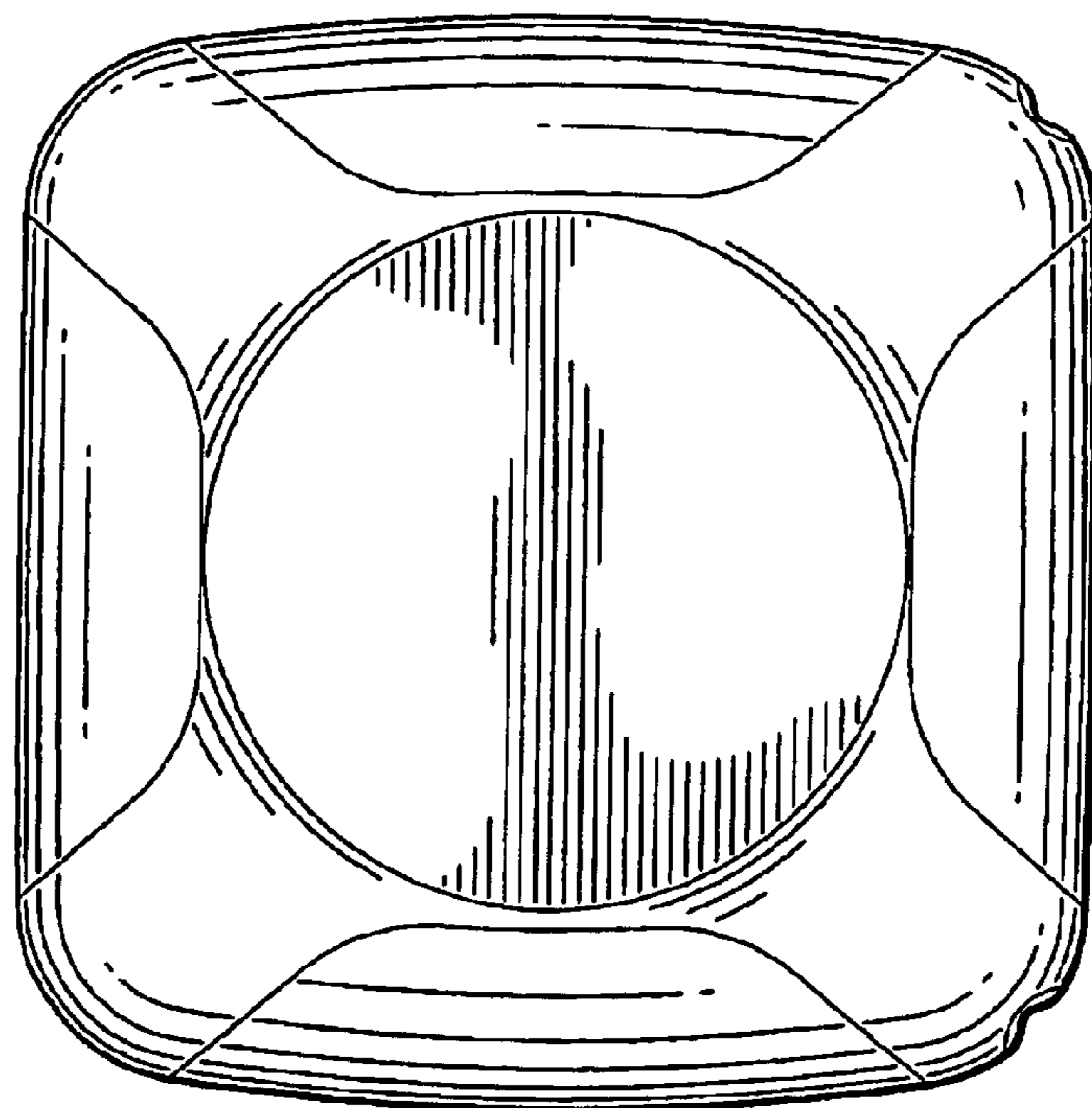
