FIG. 1 is a perspective view of an electrical connector showing our new design;

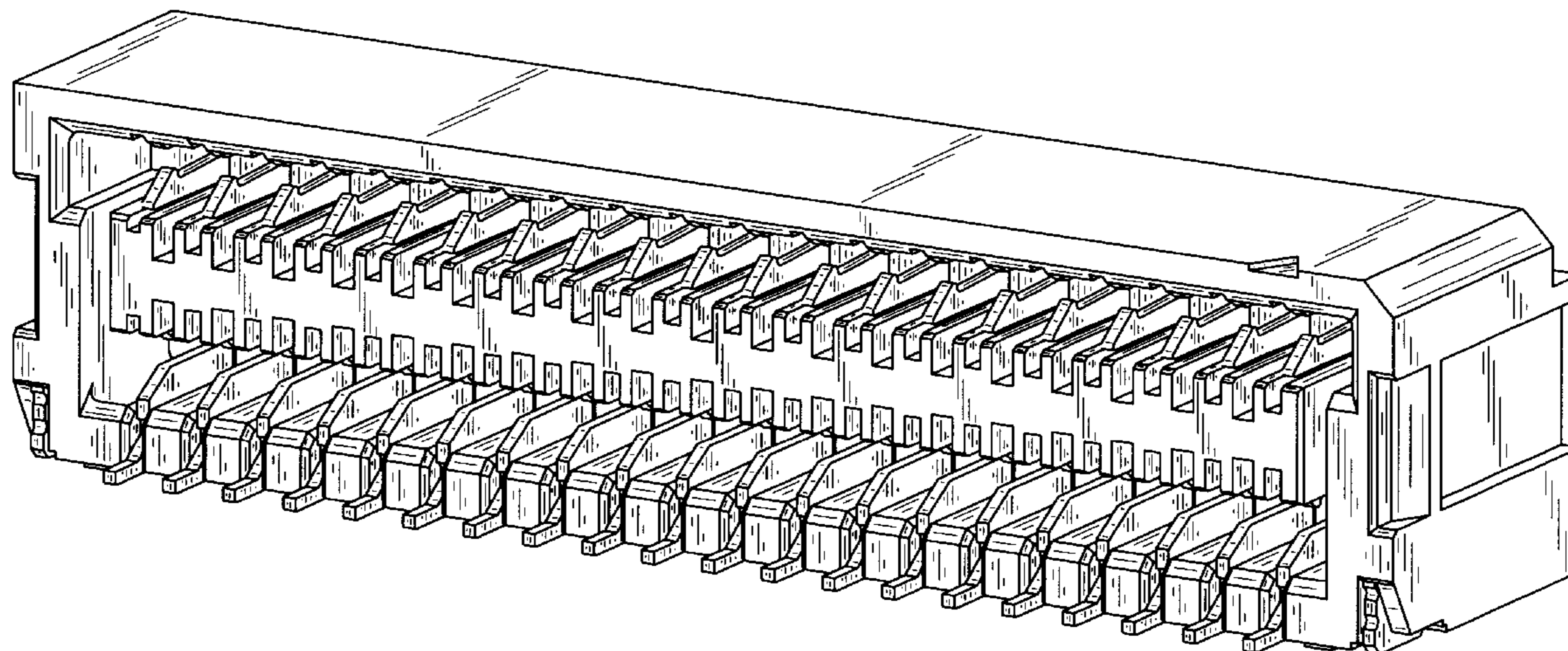
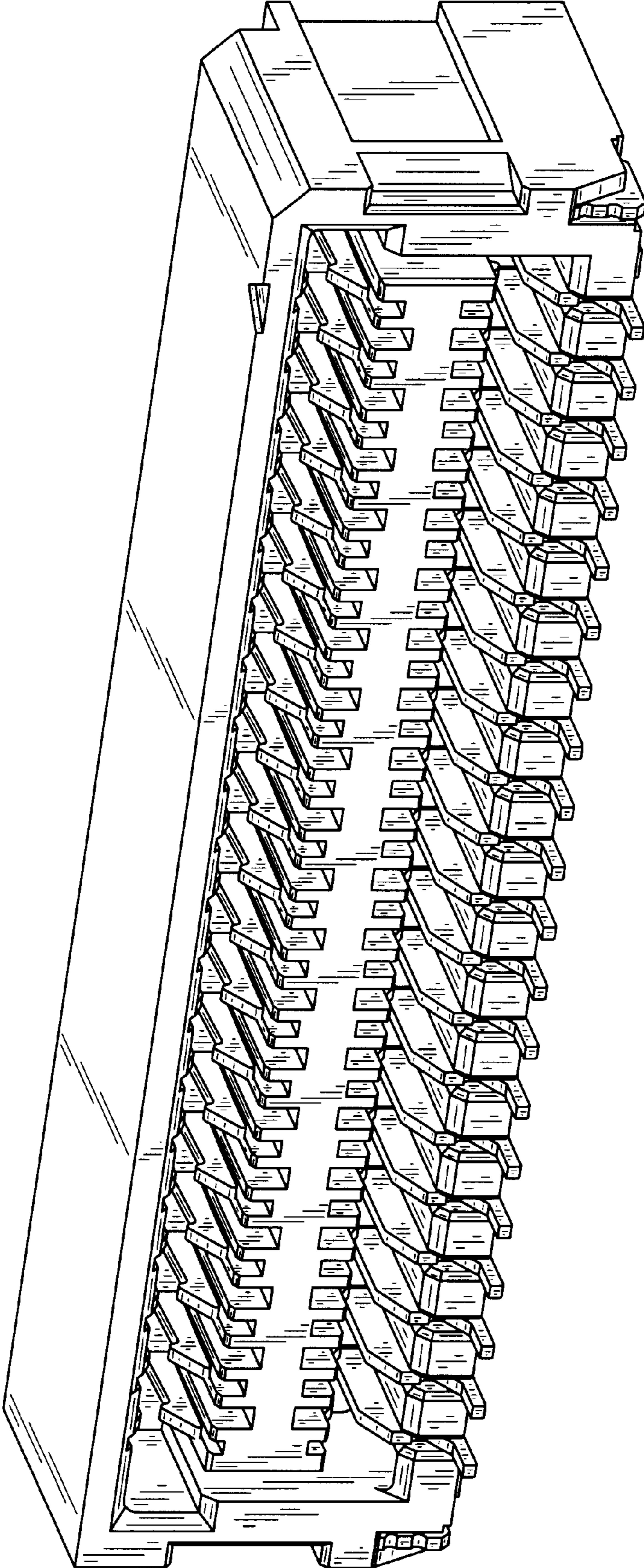

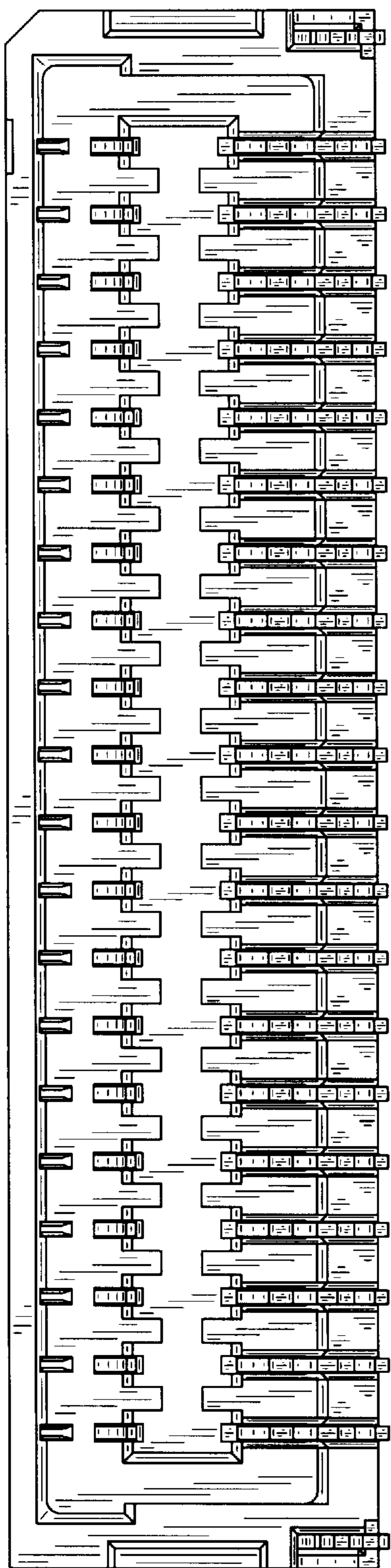

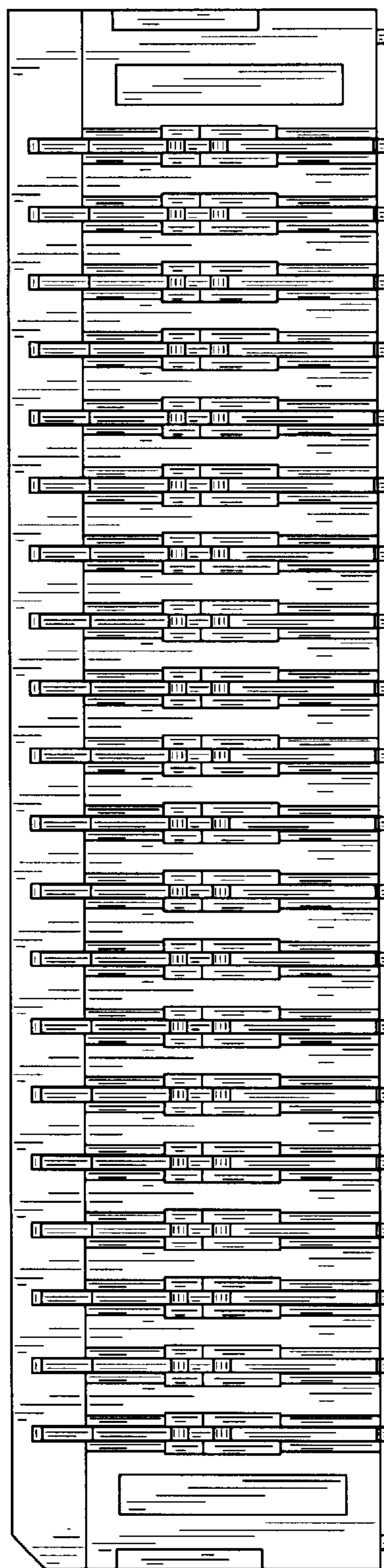

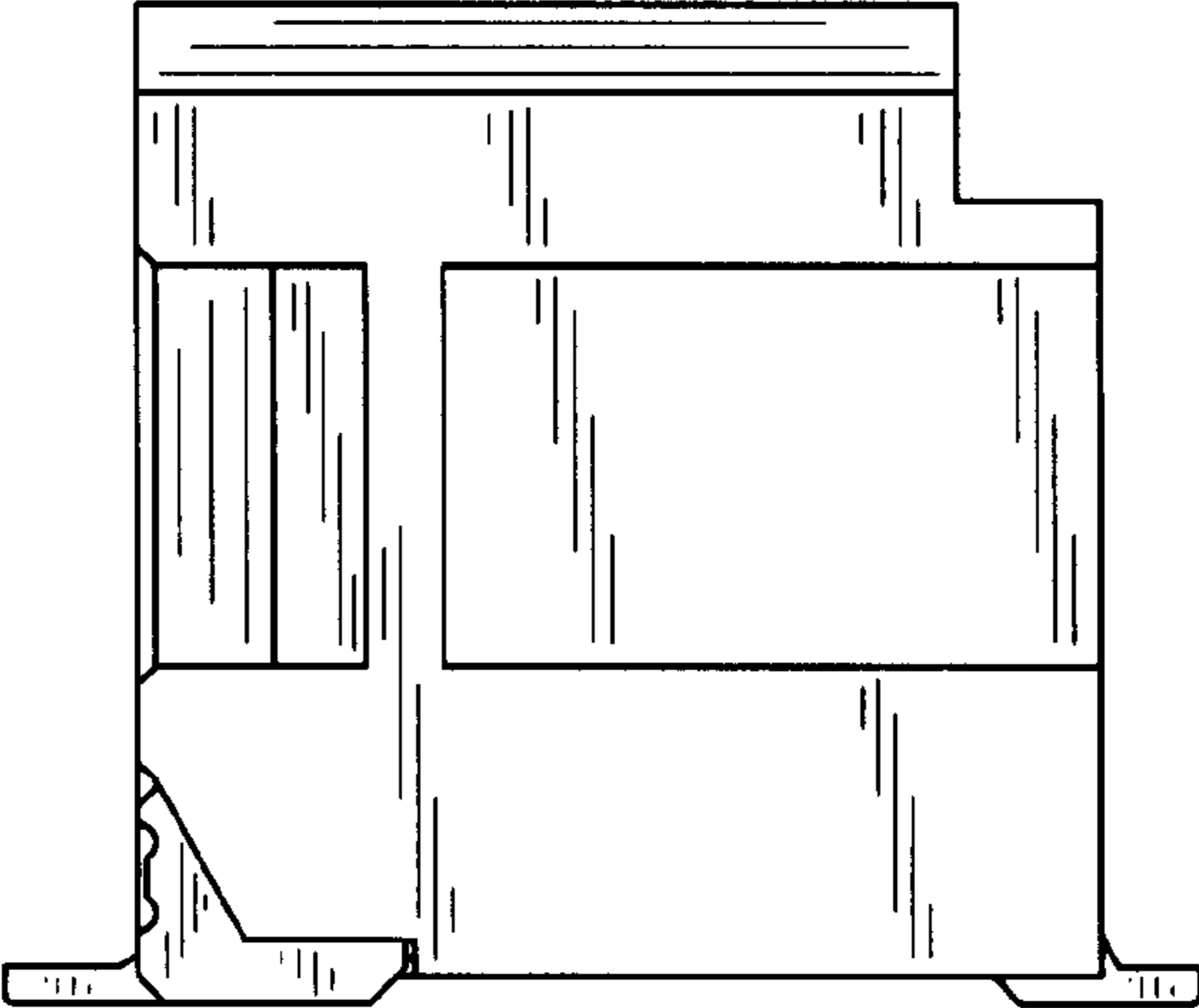
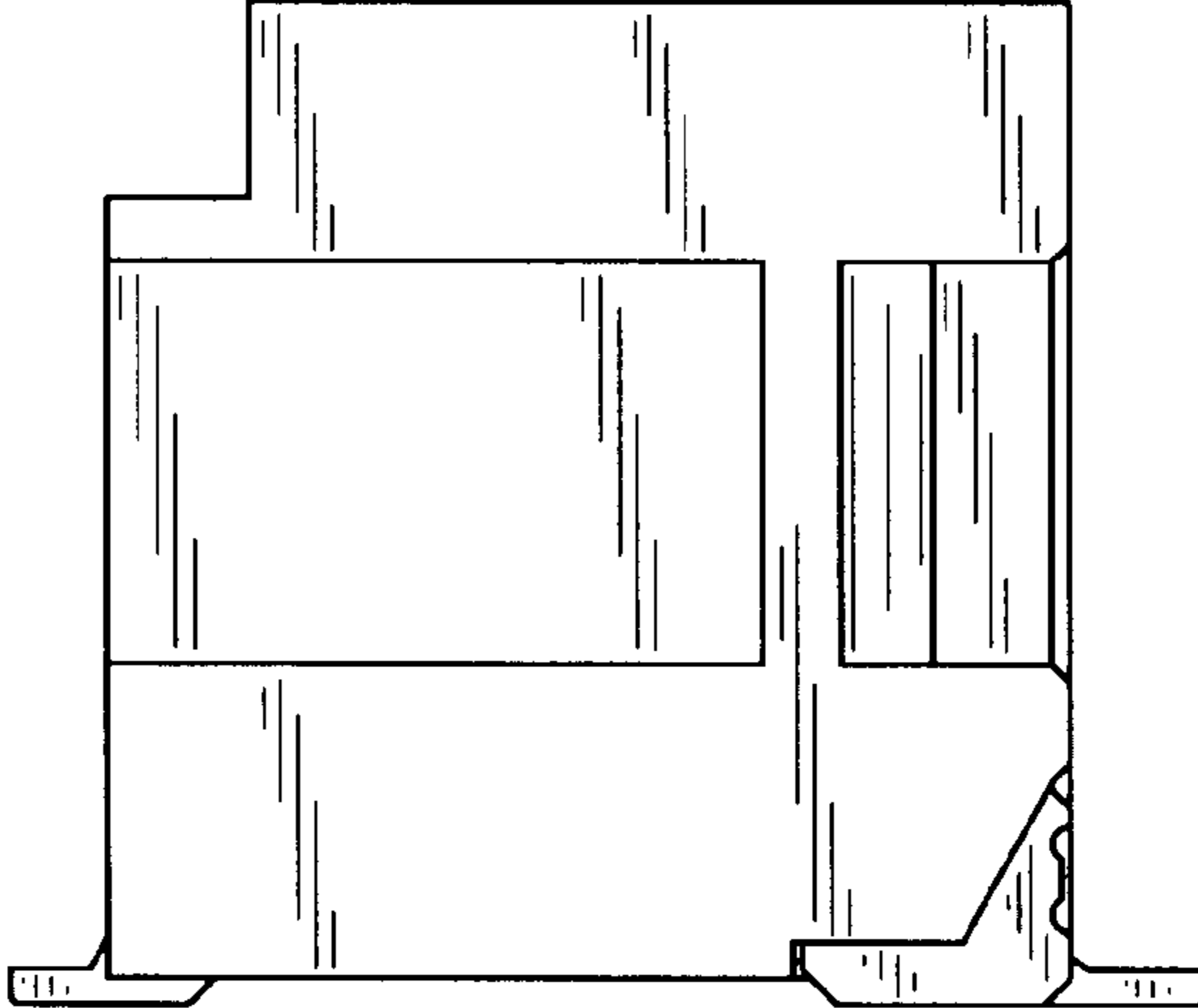

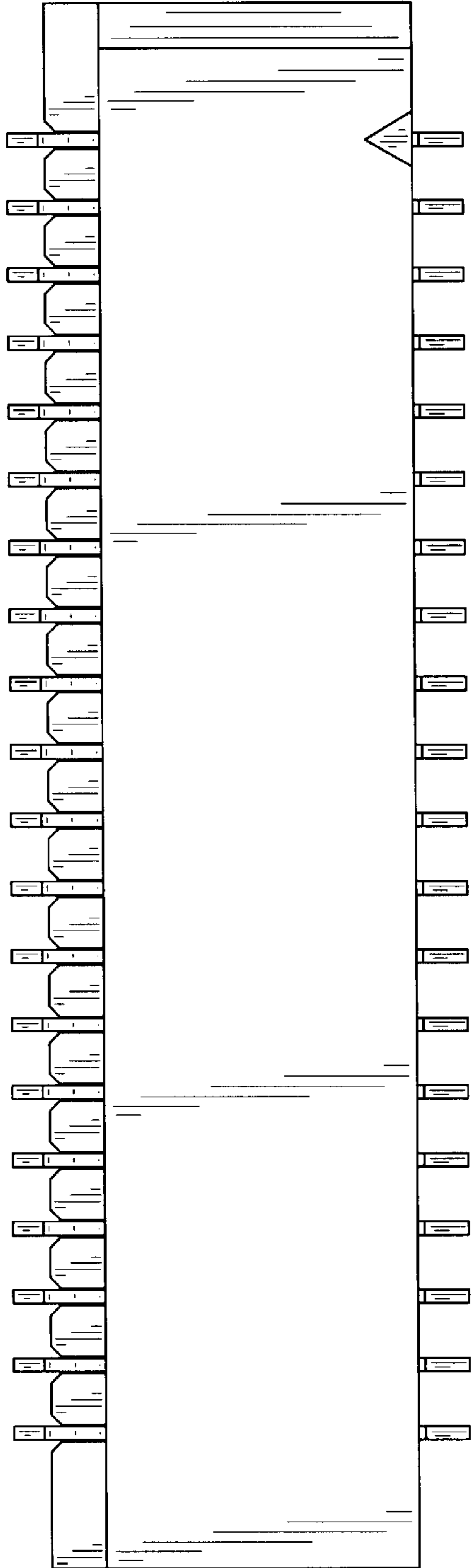

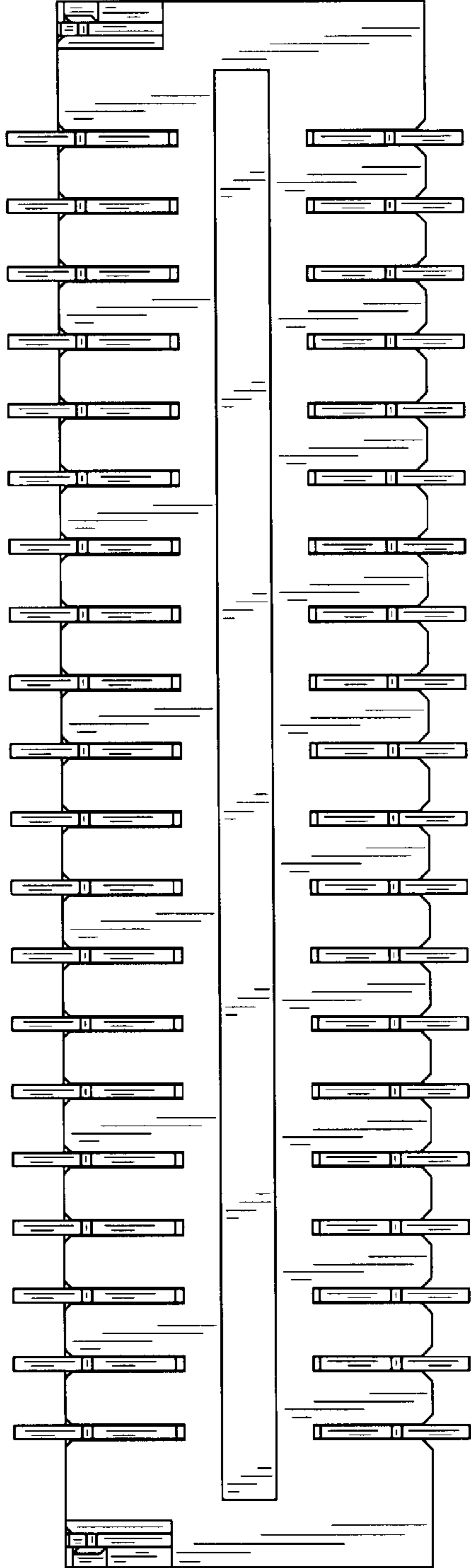
