DESCRIPTION

FIG. 1 is a front view of a screen border showing my new design being attached to a monitor that is shown in dotted

lines for environment and forms no part of the claimed invention;

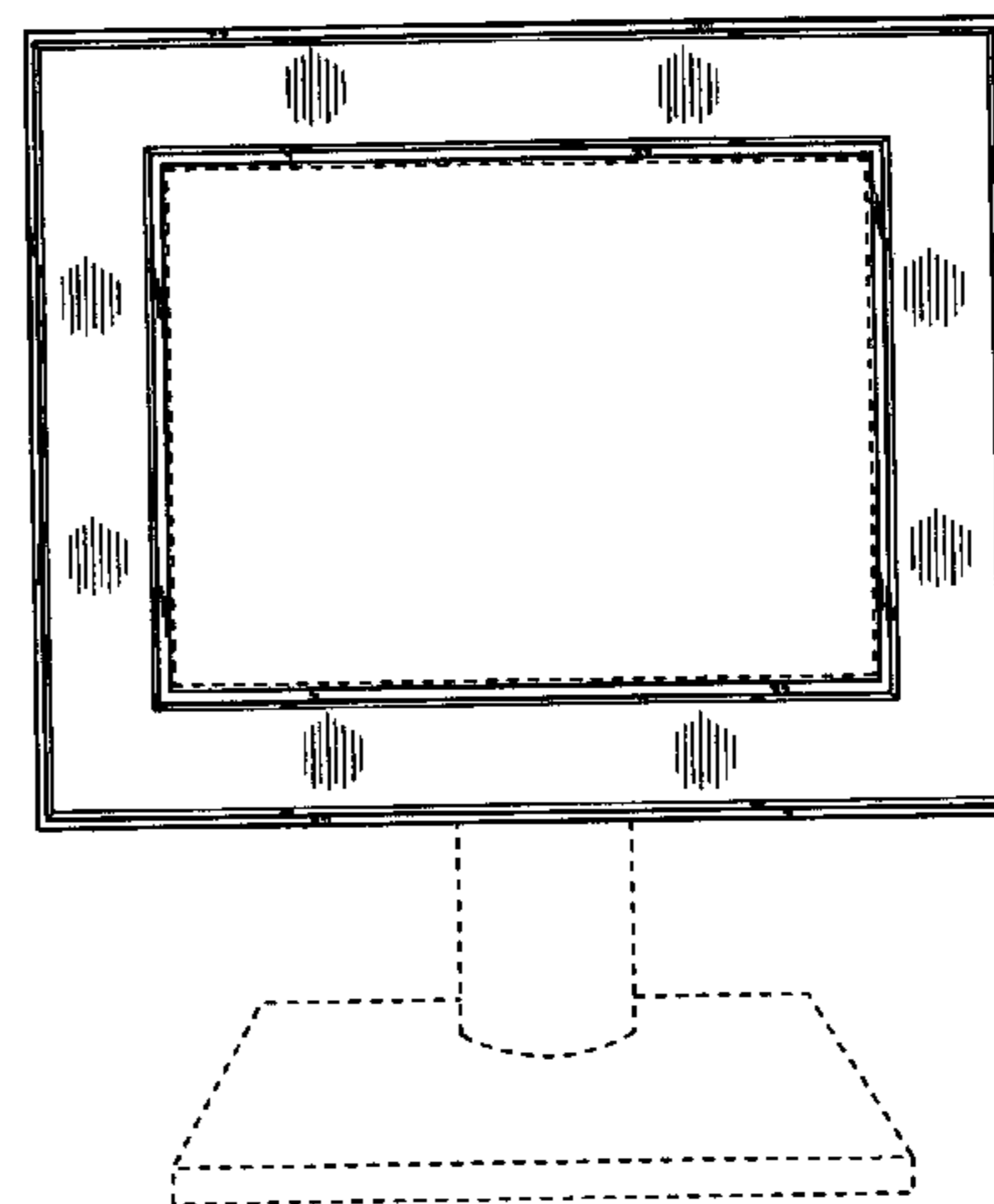
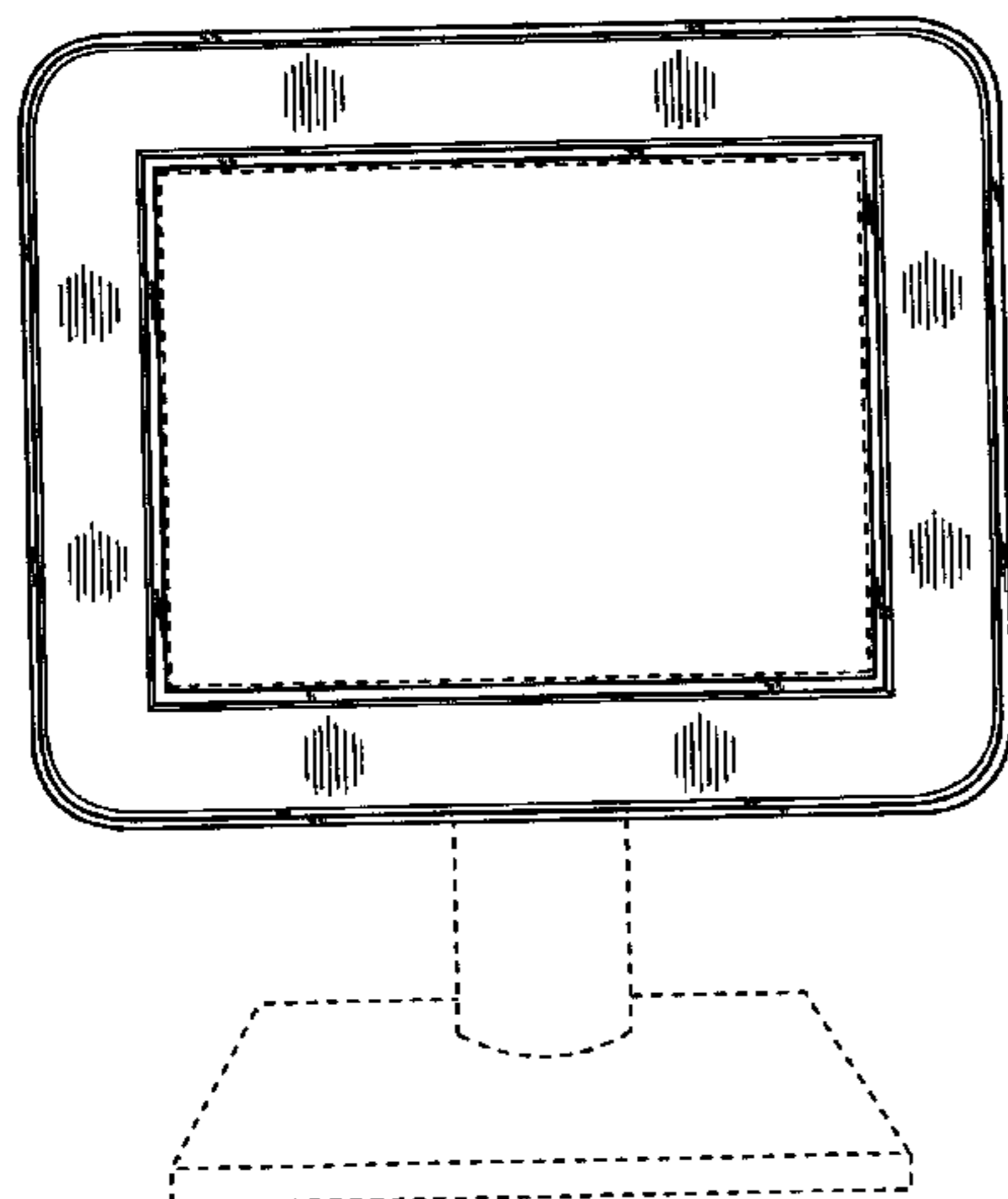

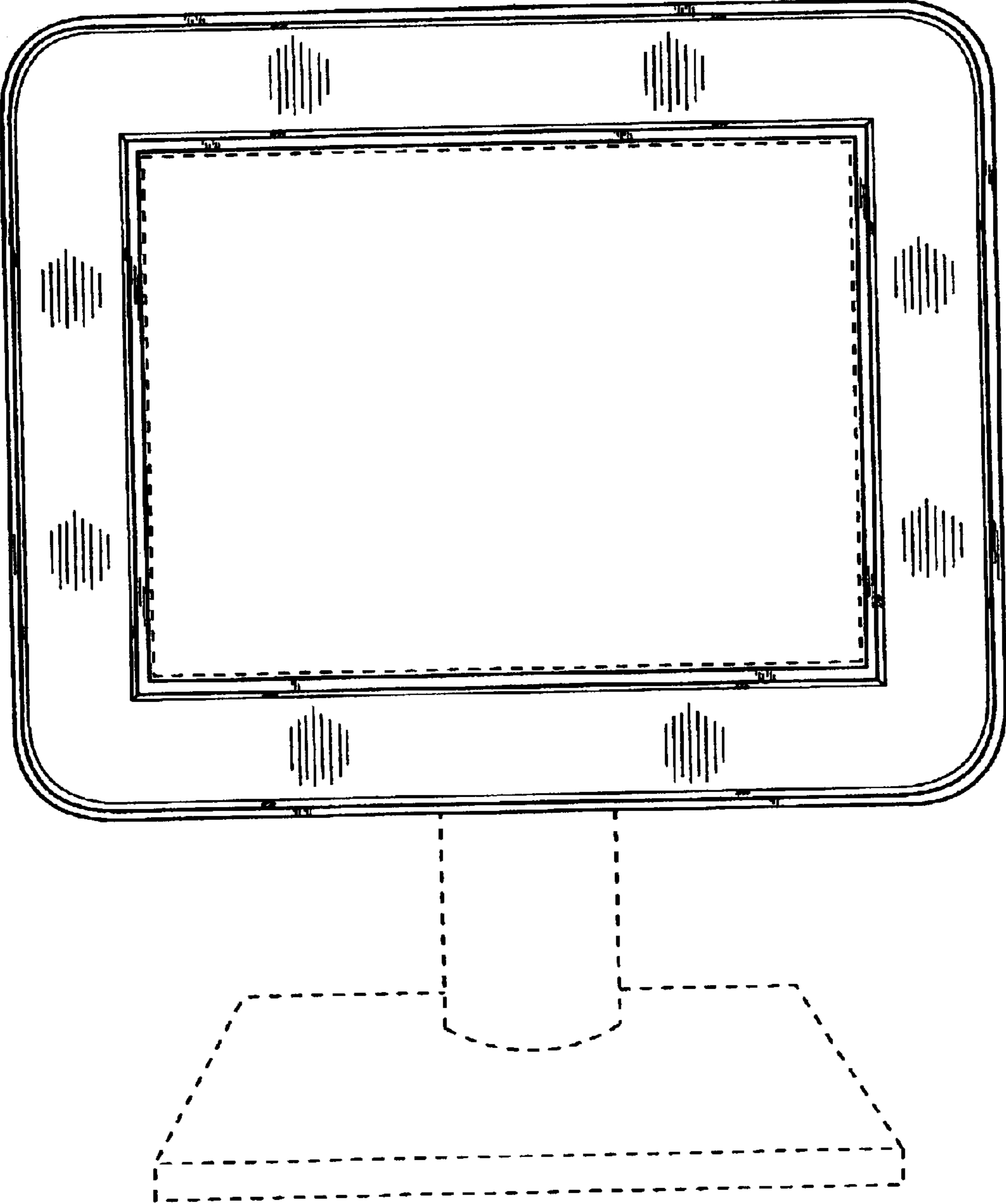

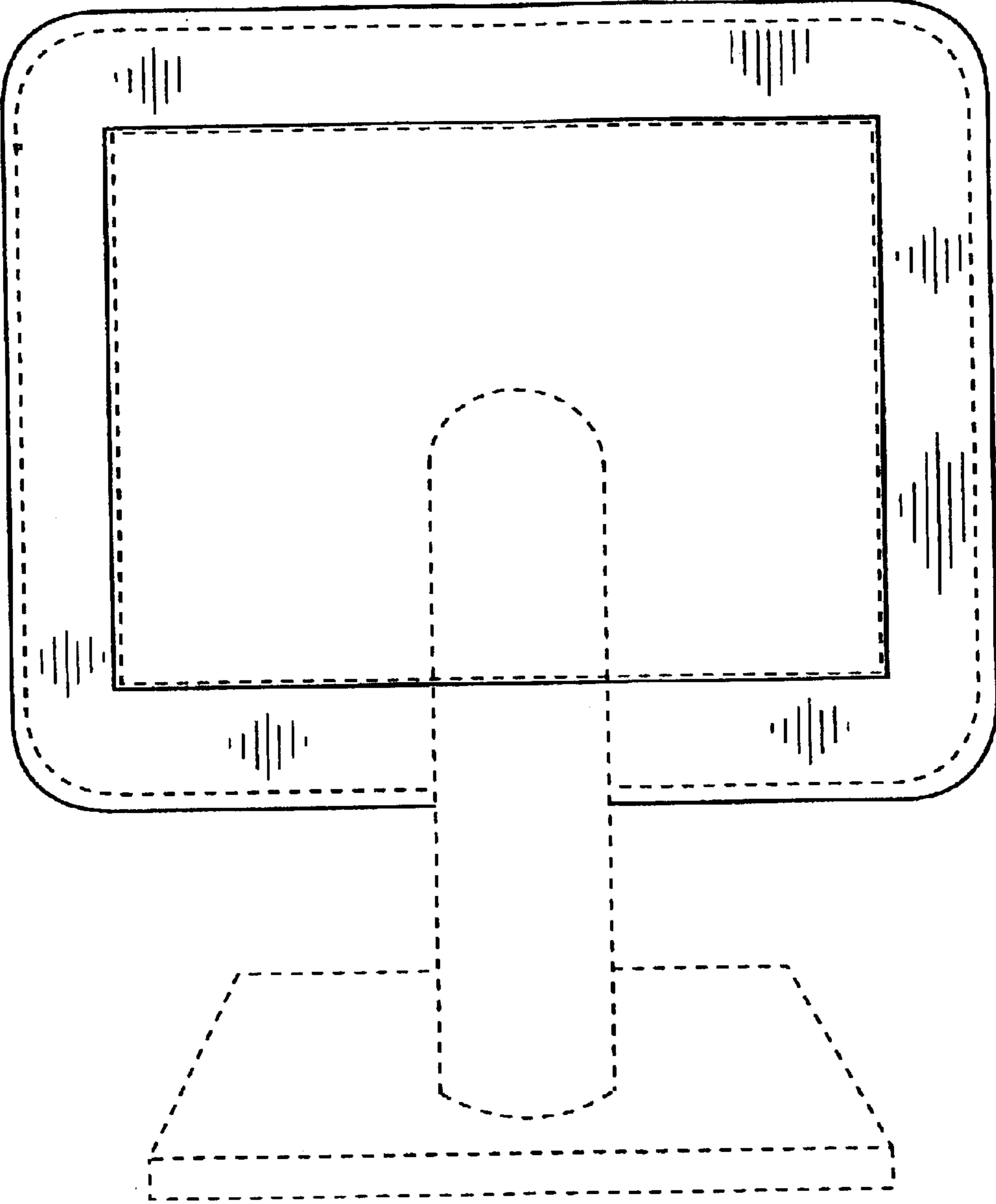

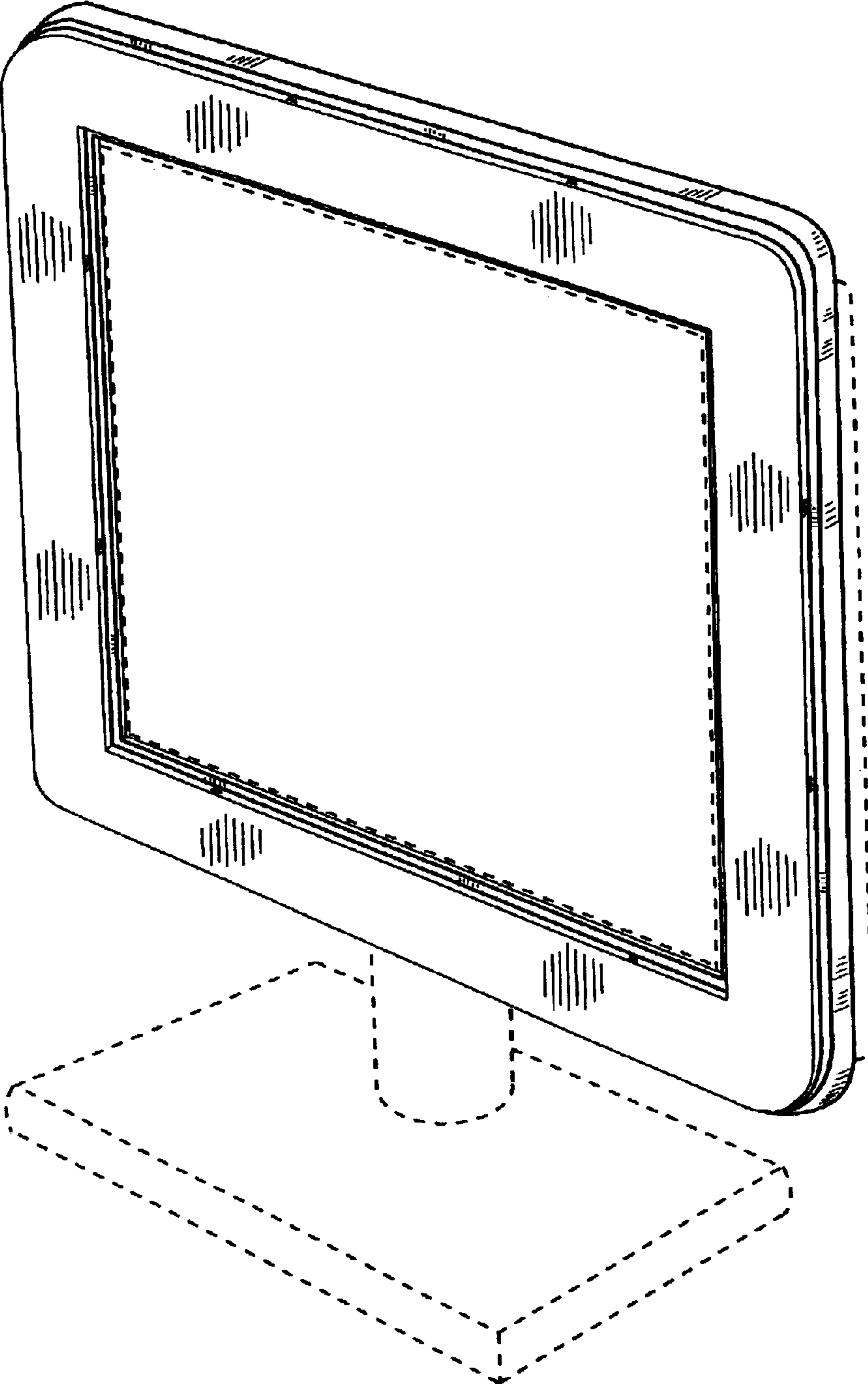

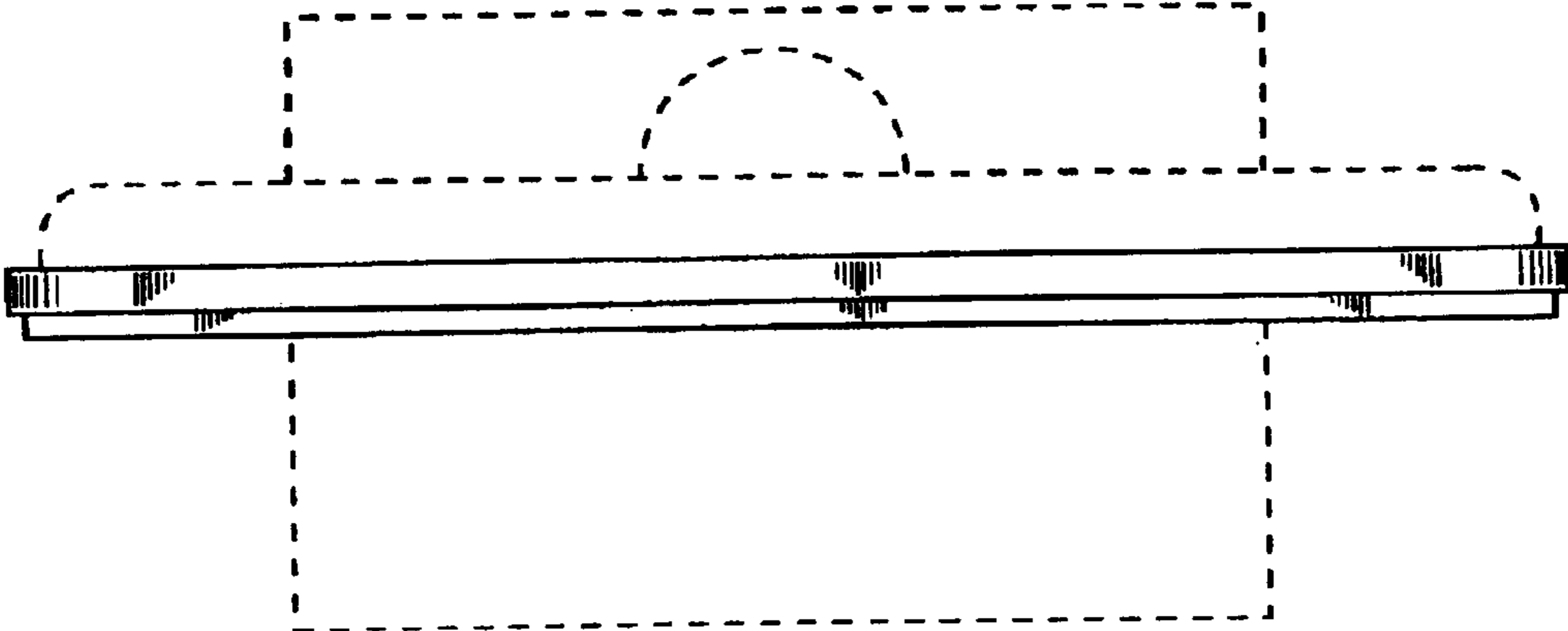

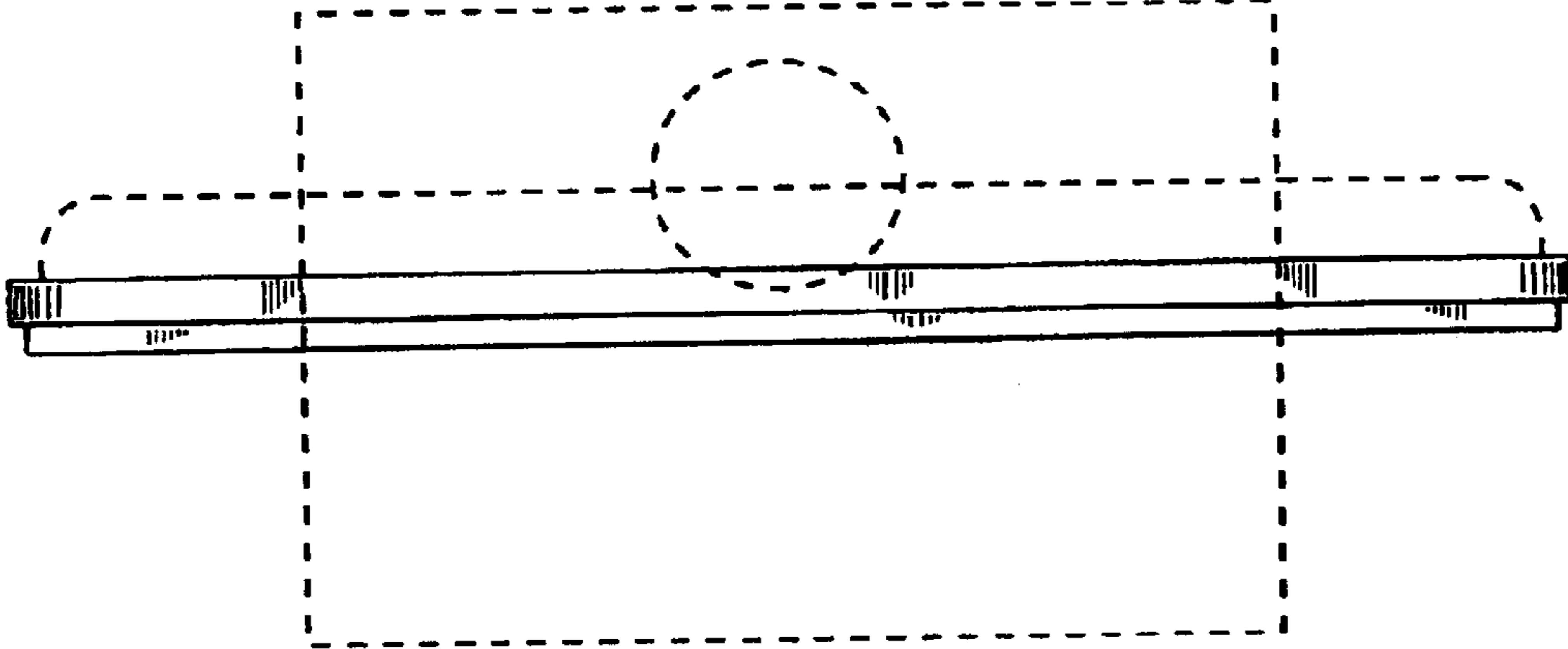

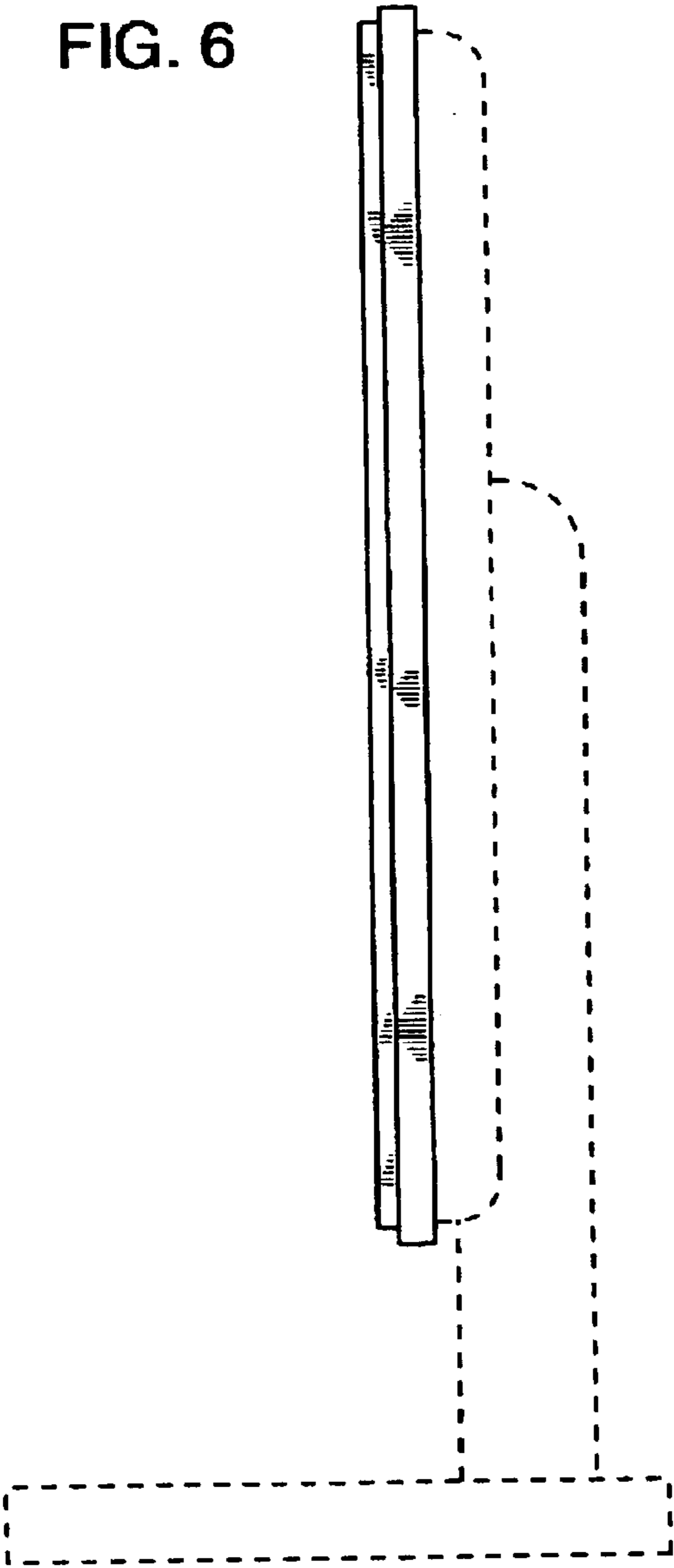

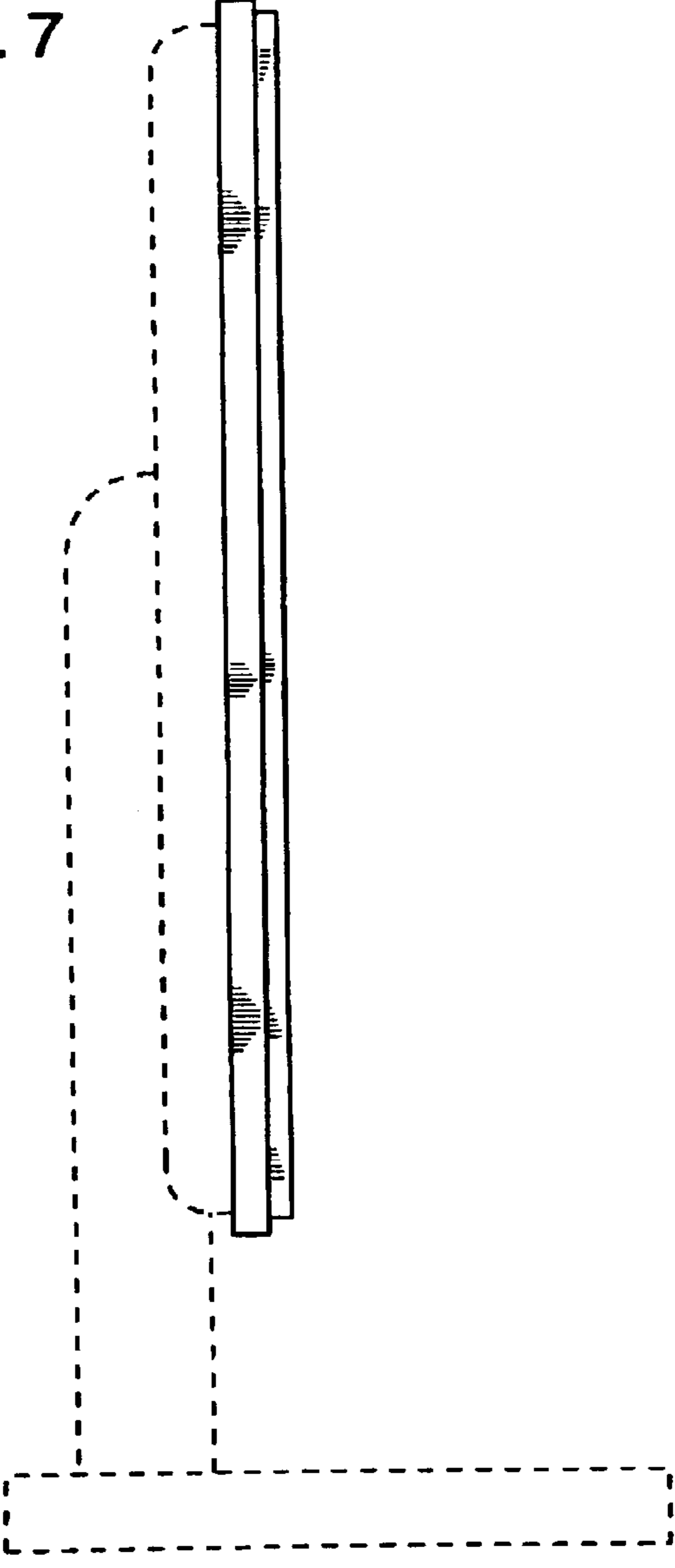

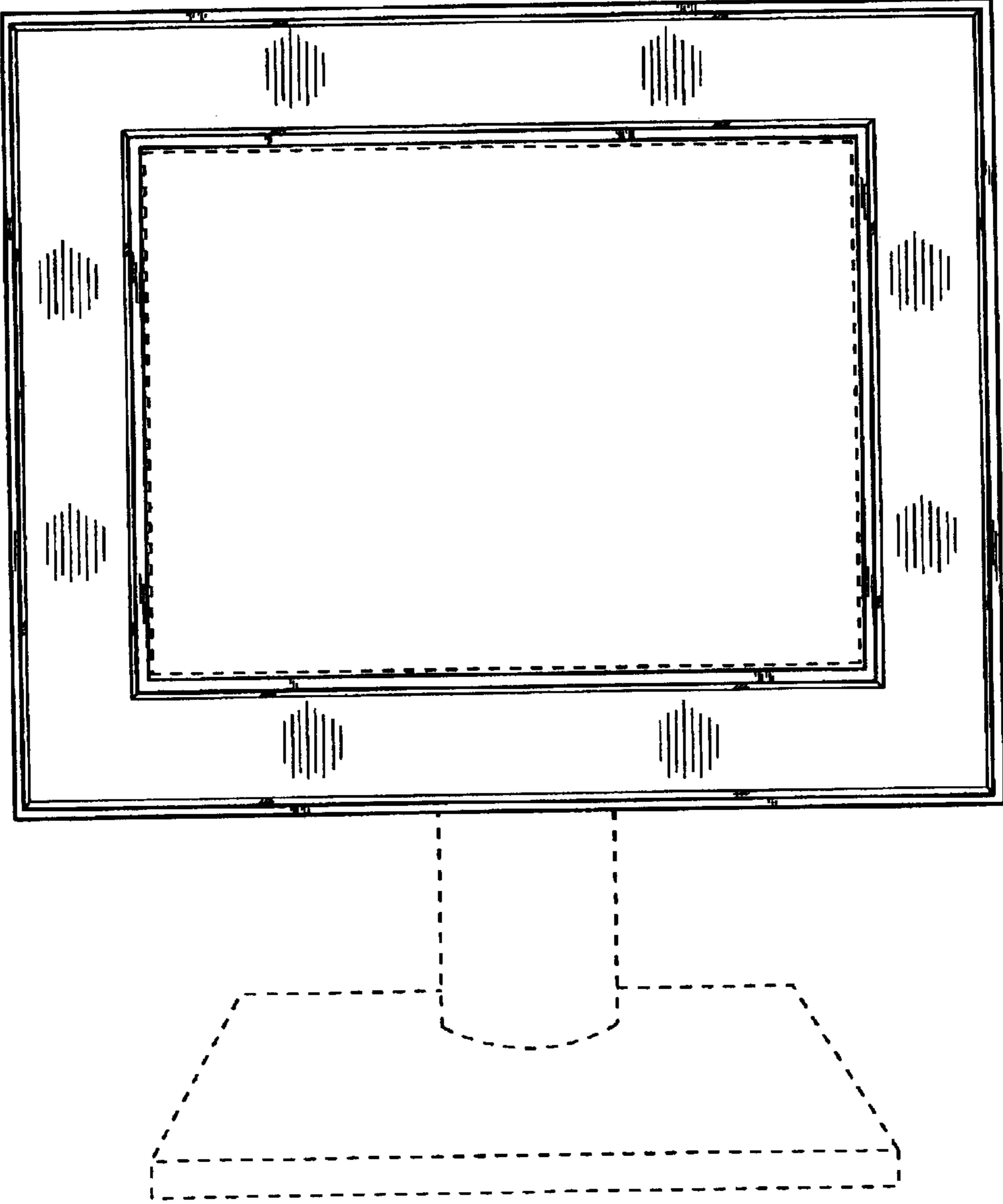

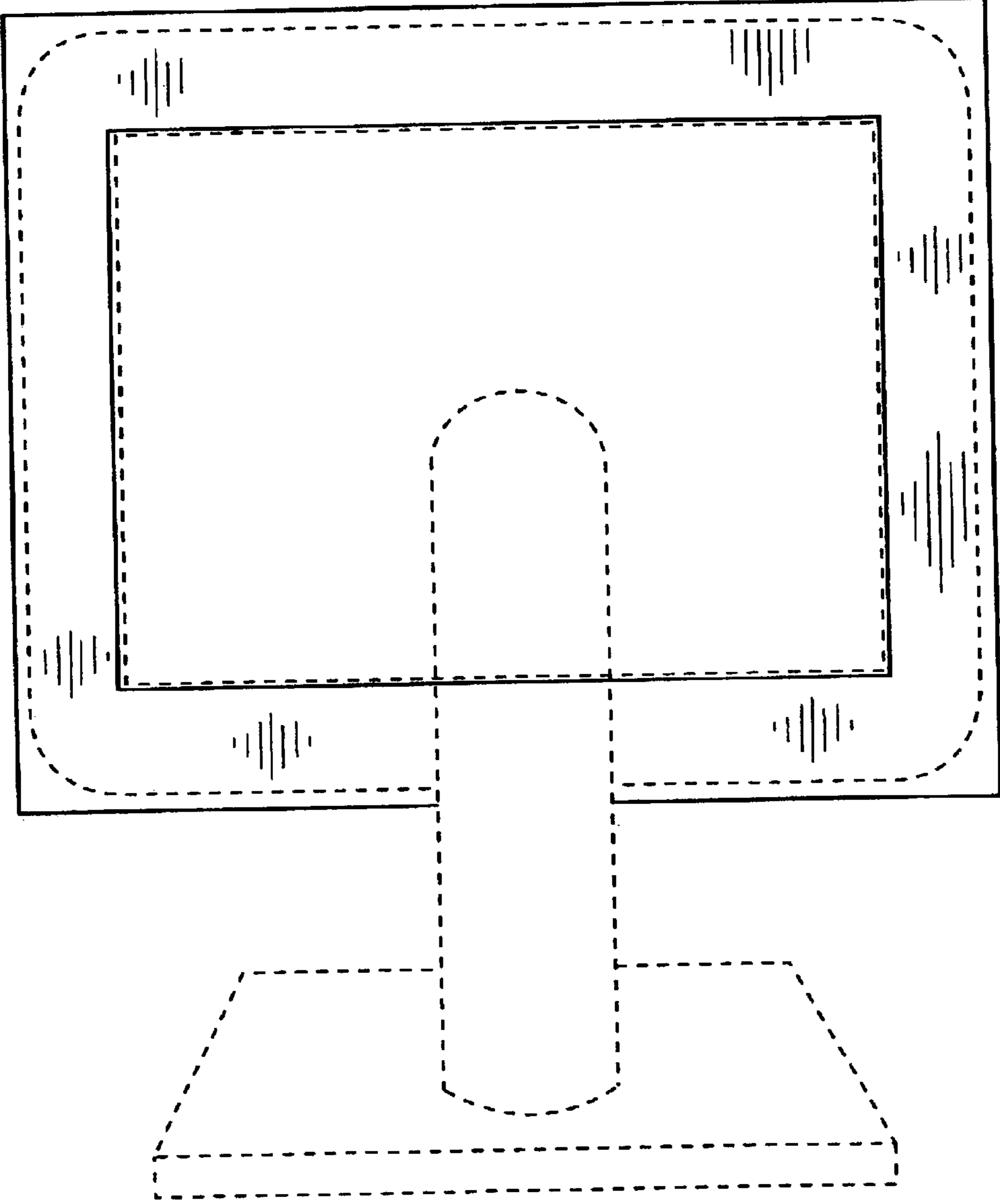

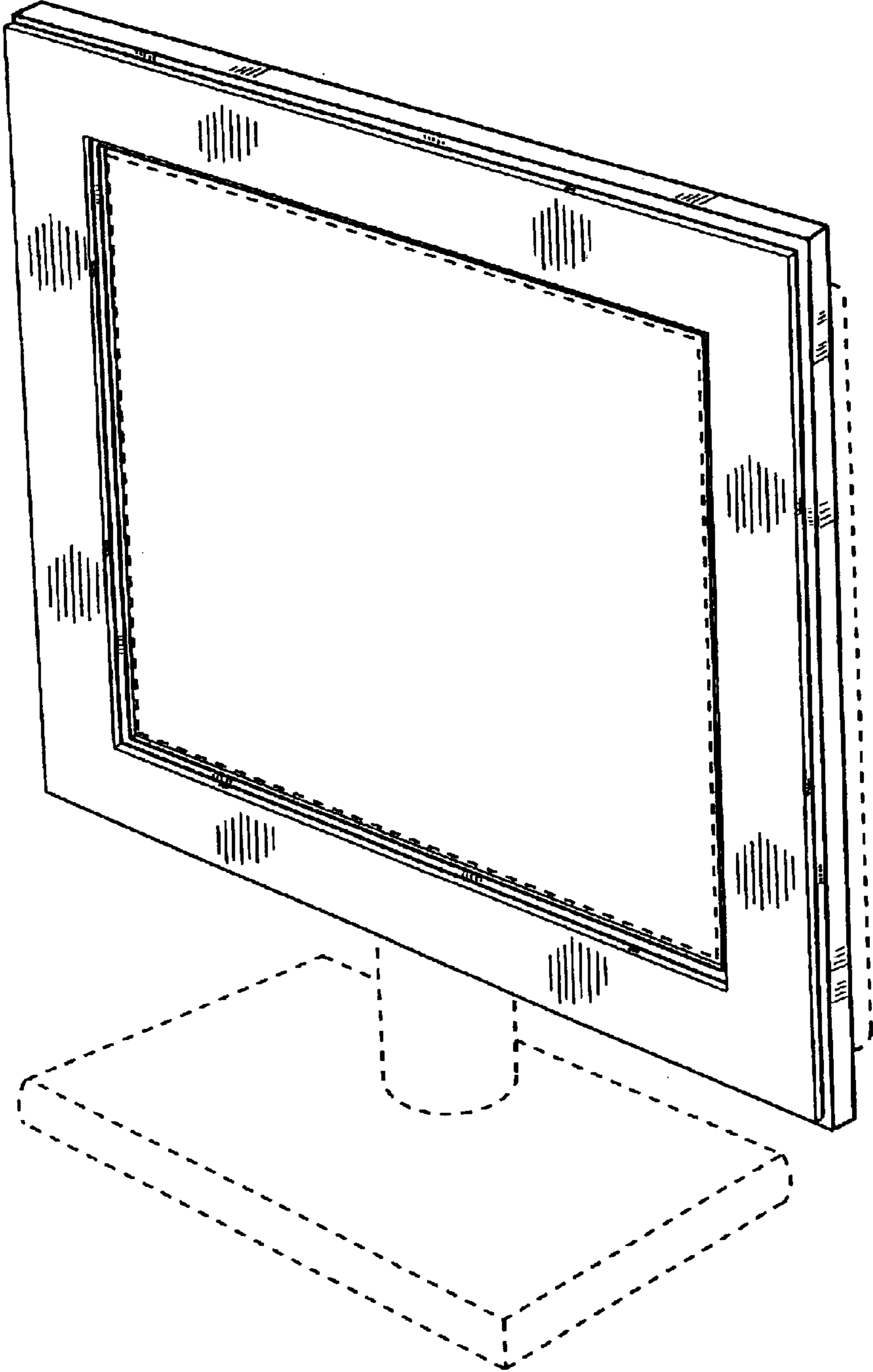

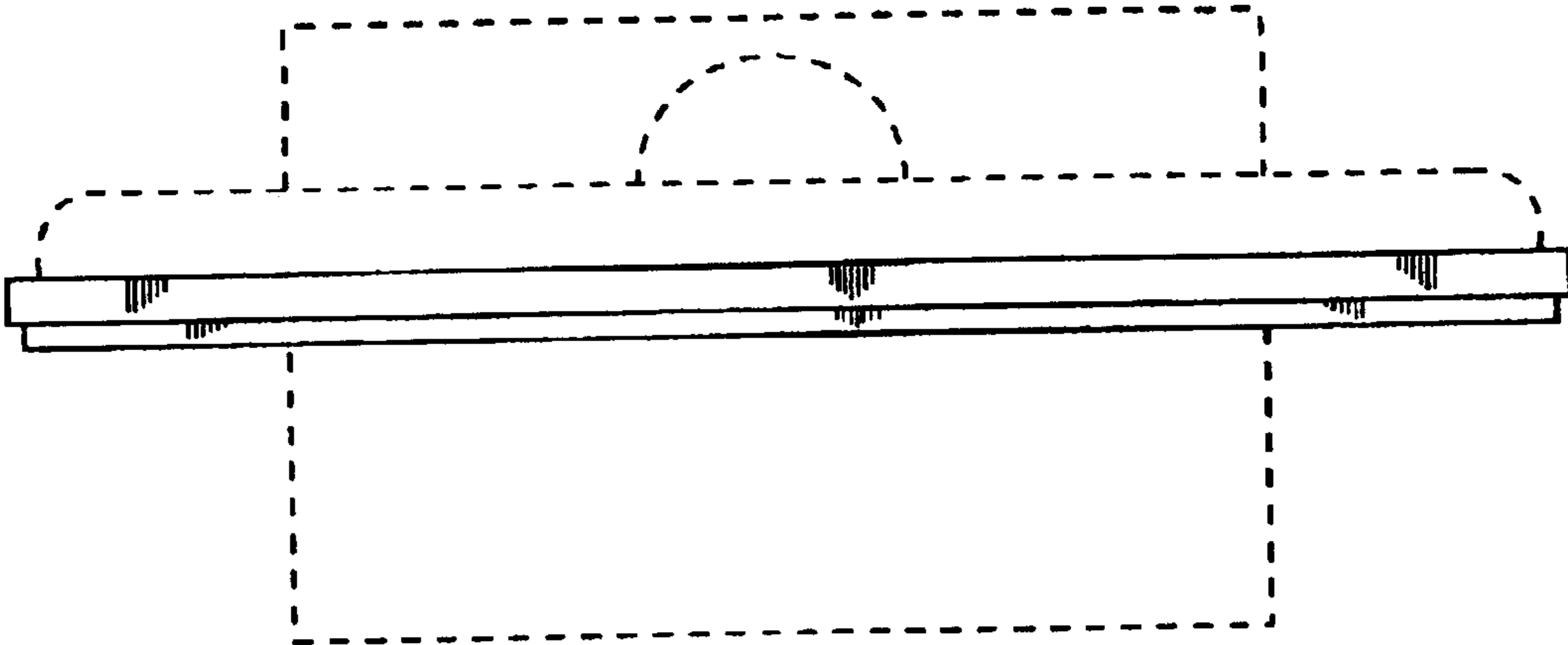

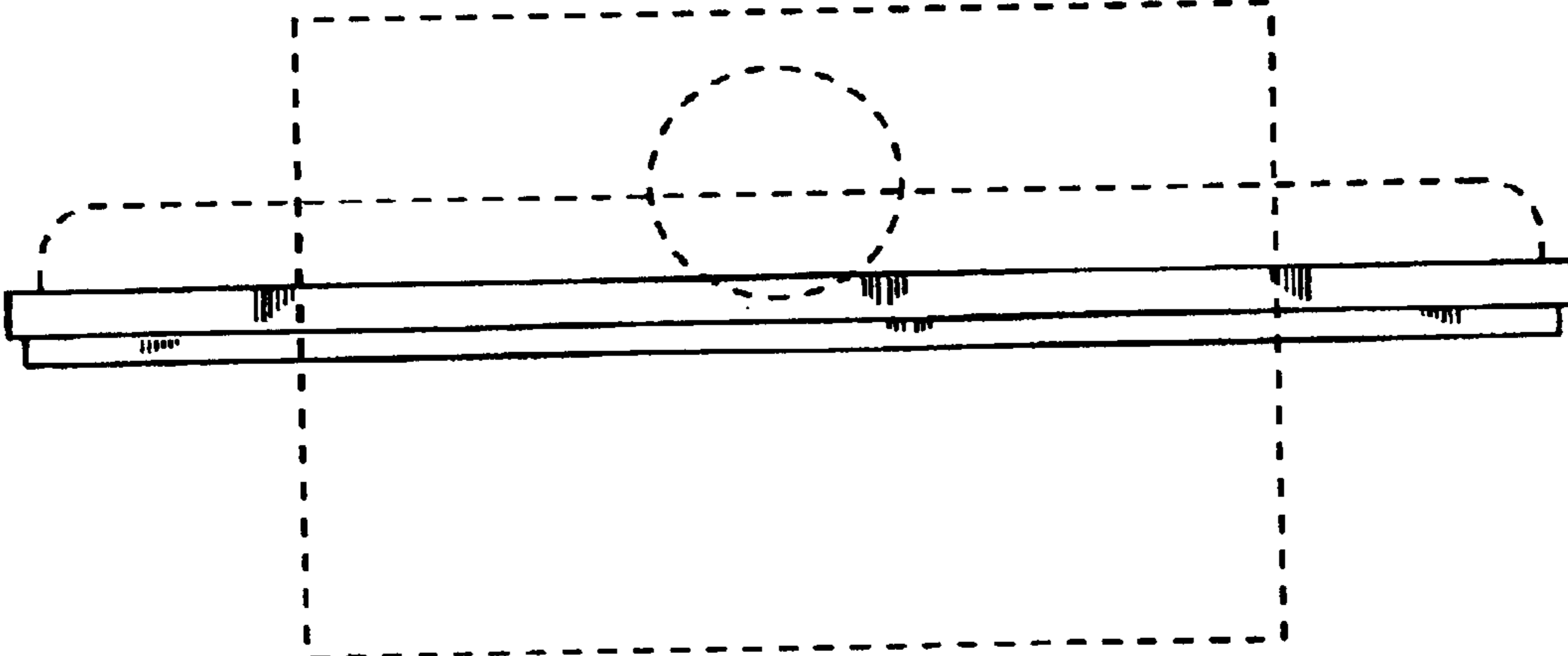

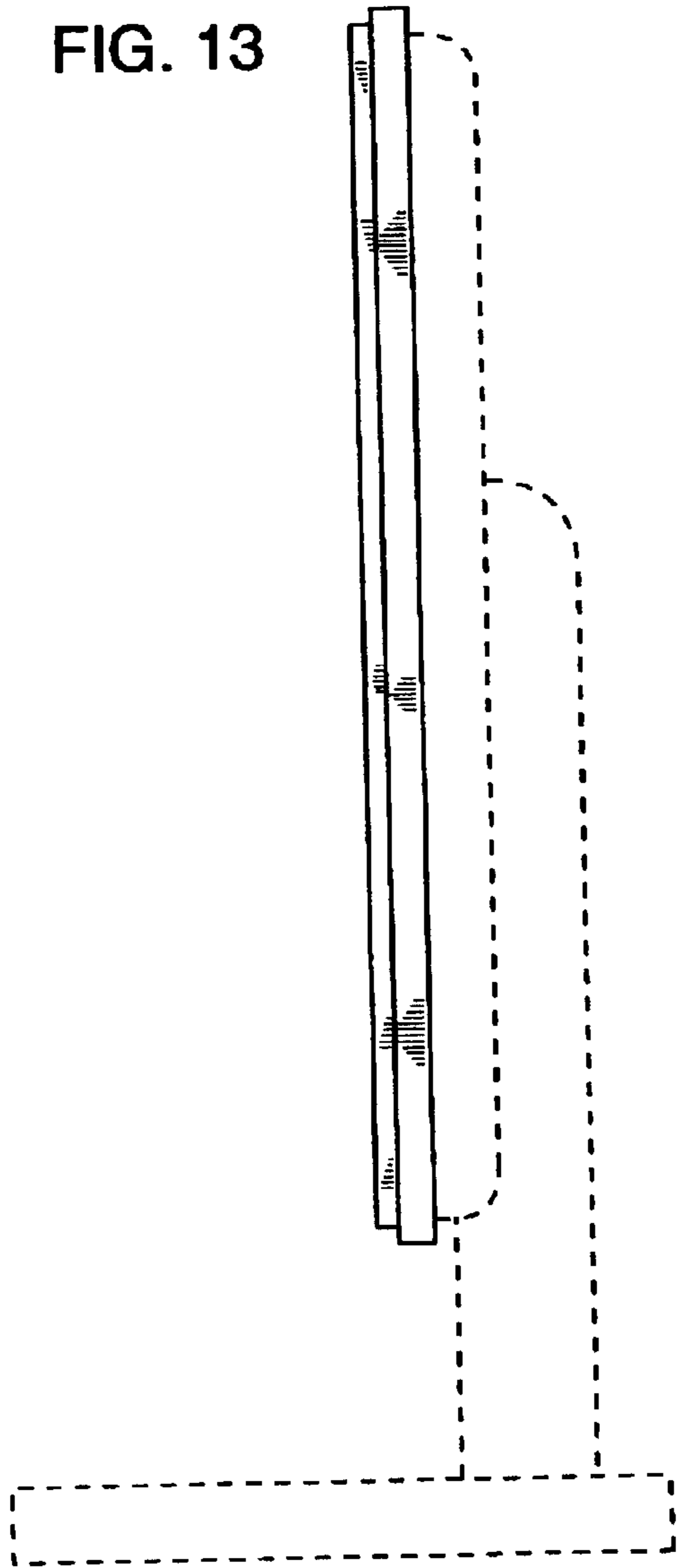

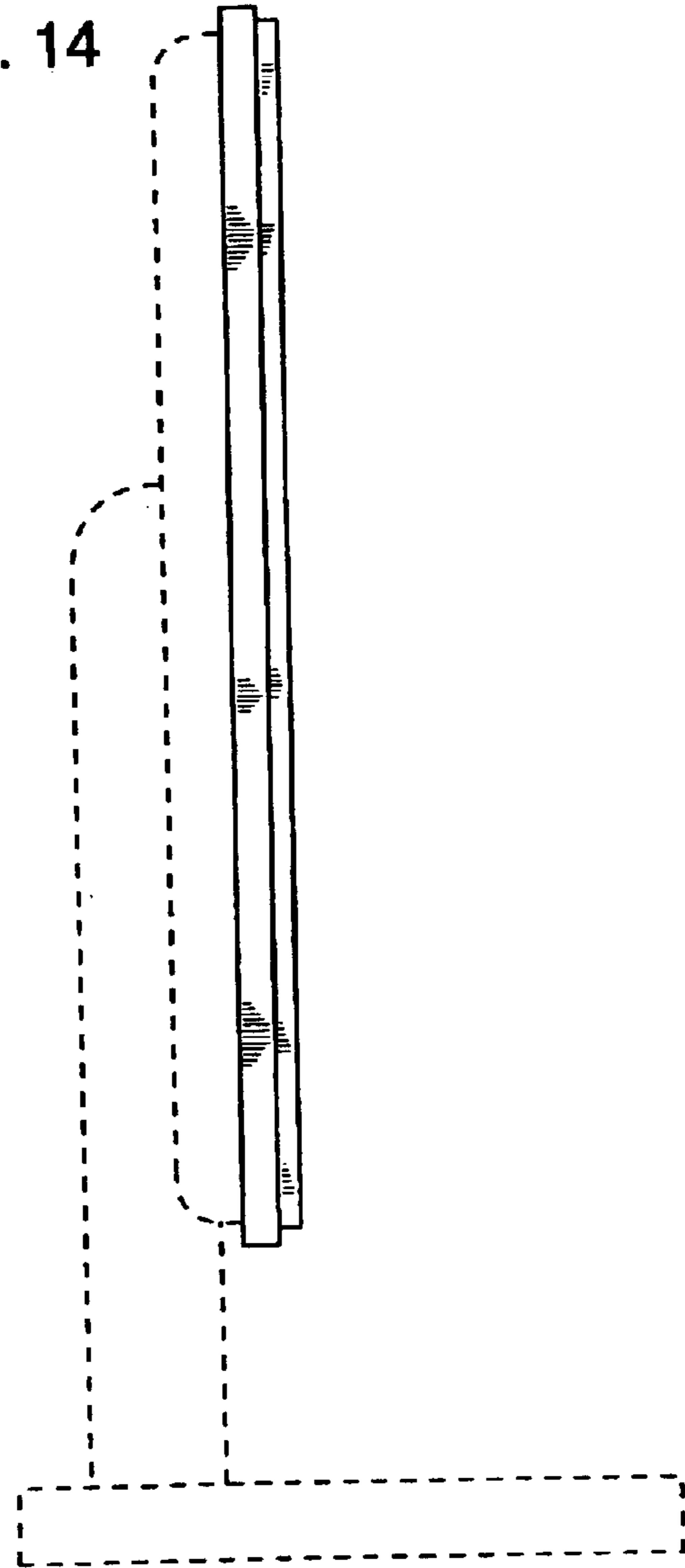

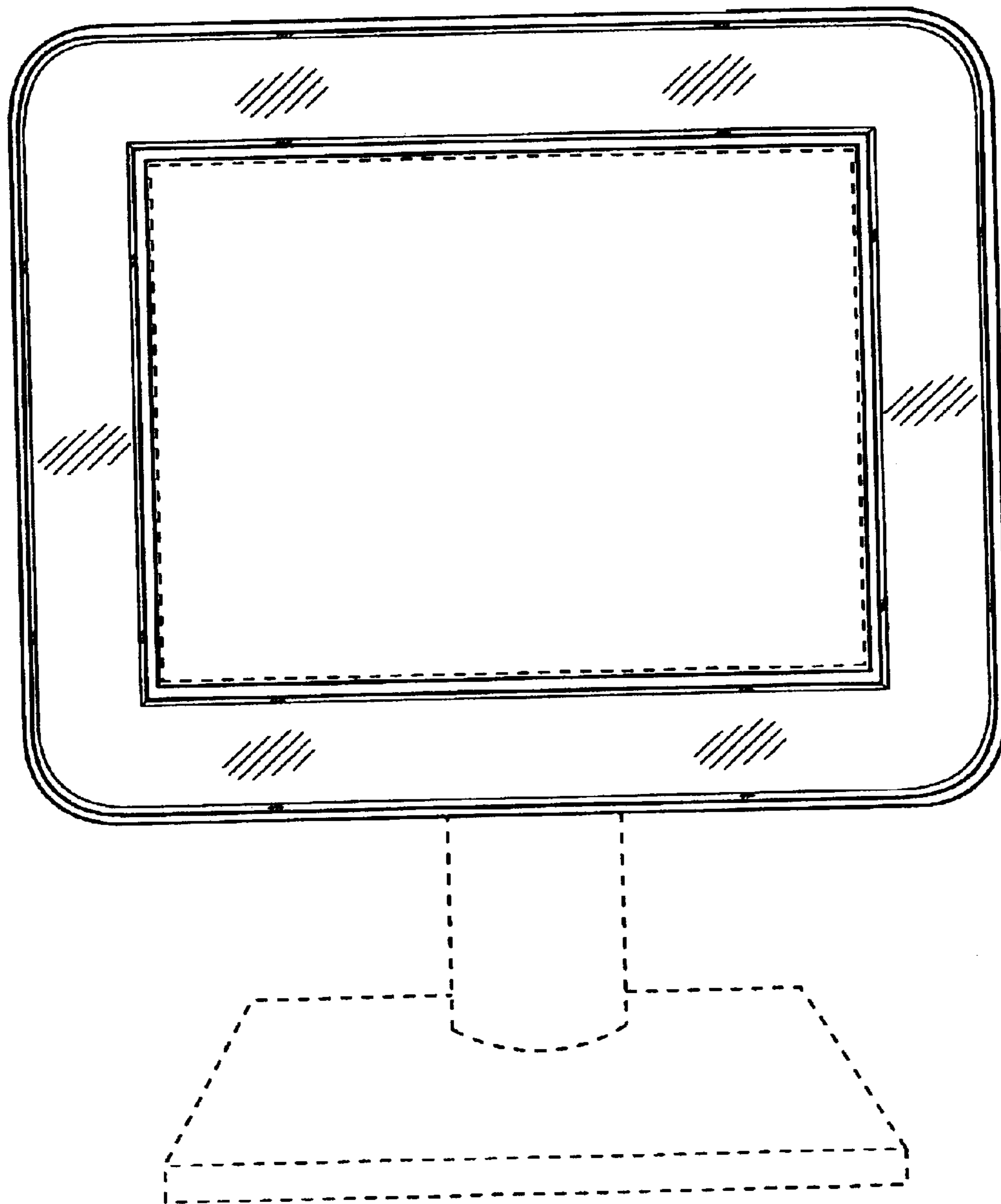

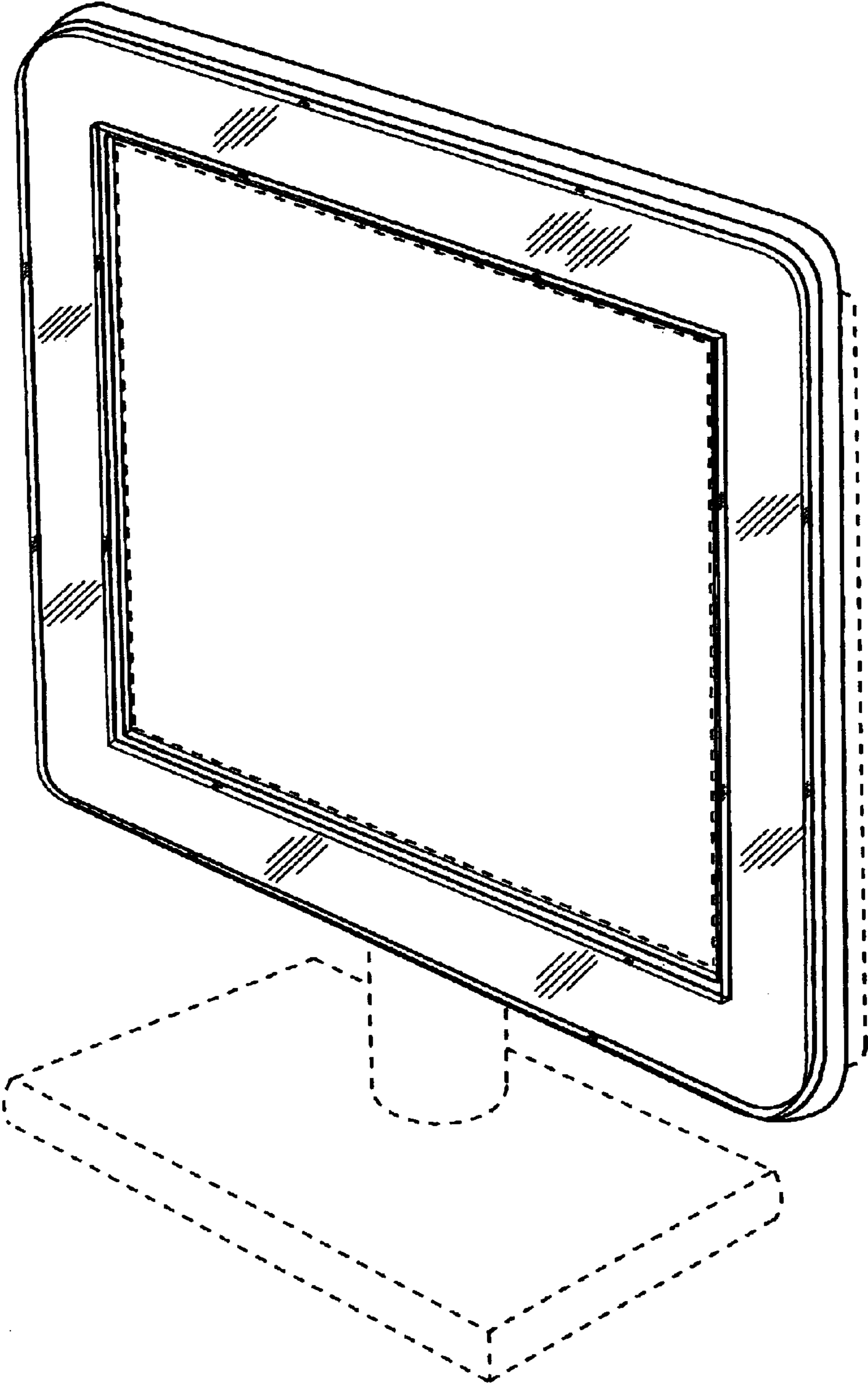

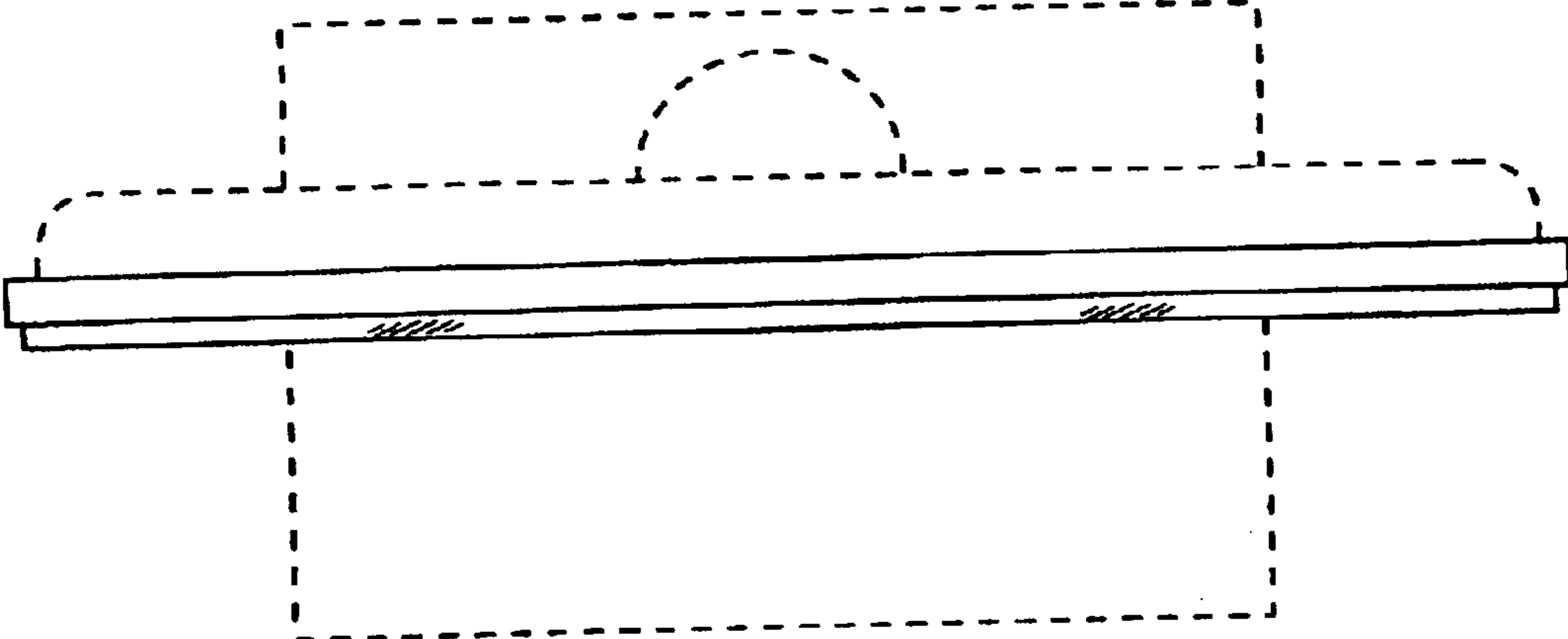

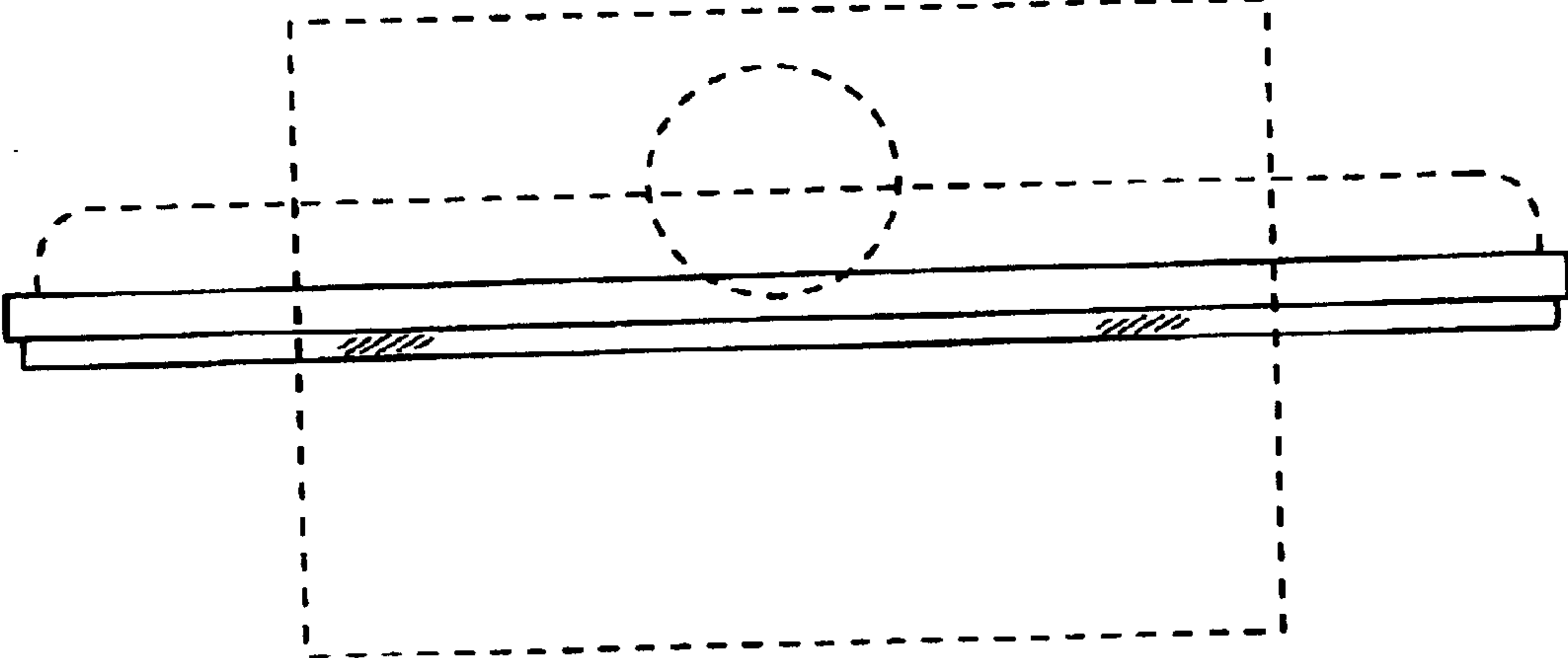

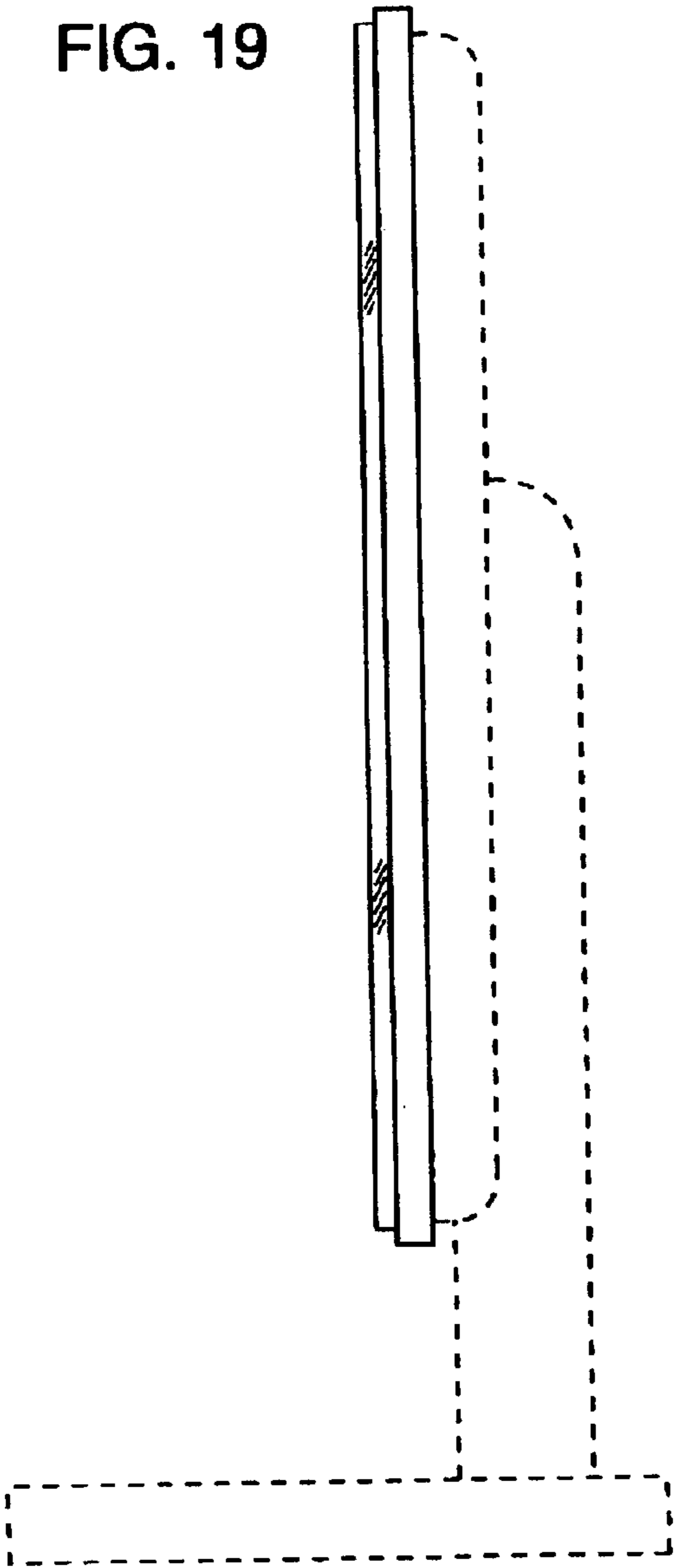

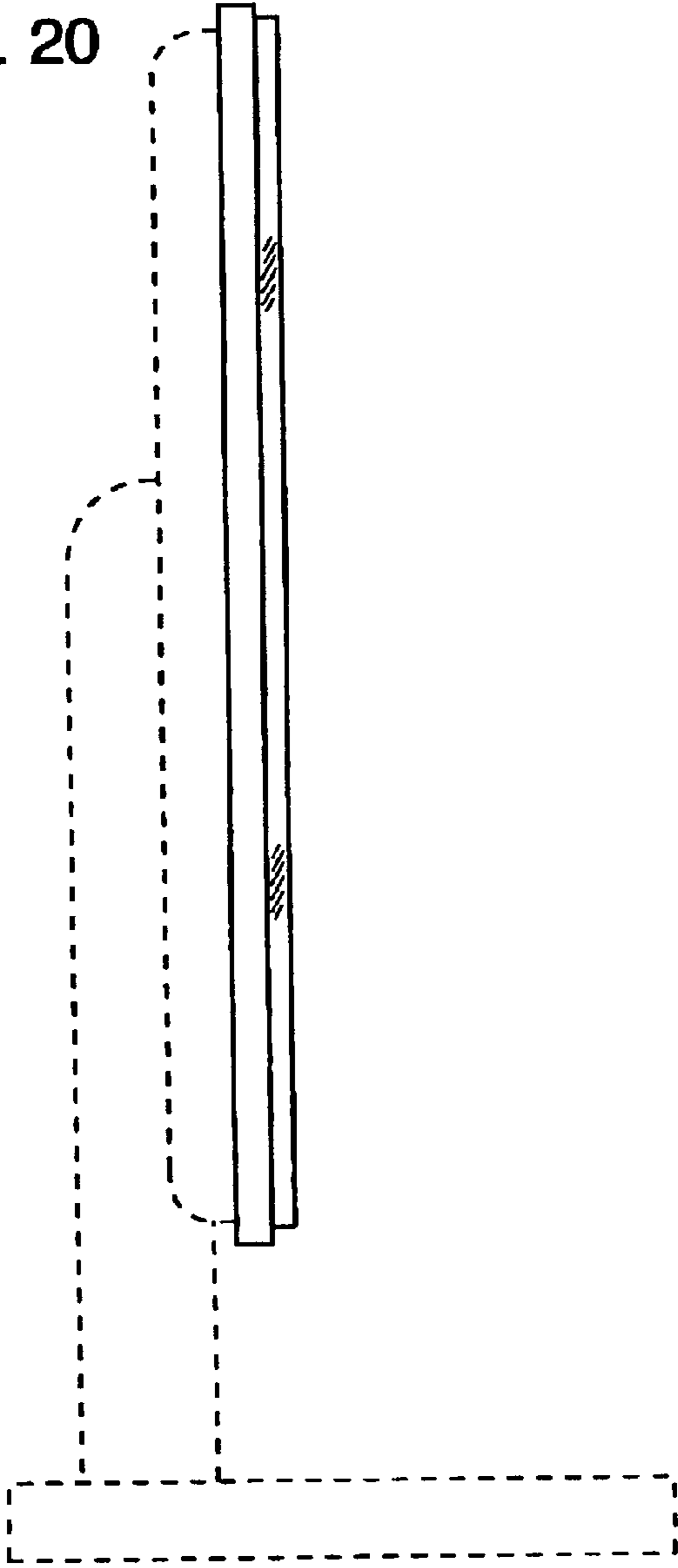

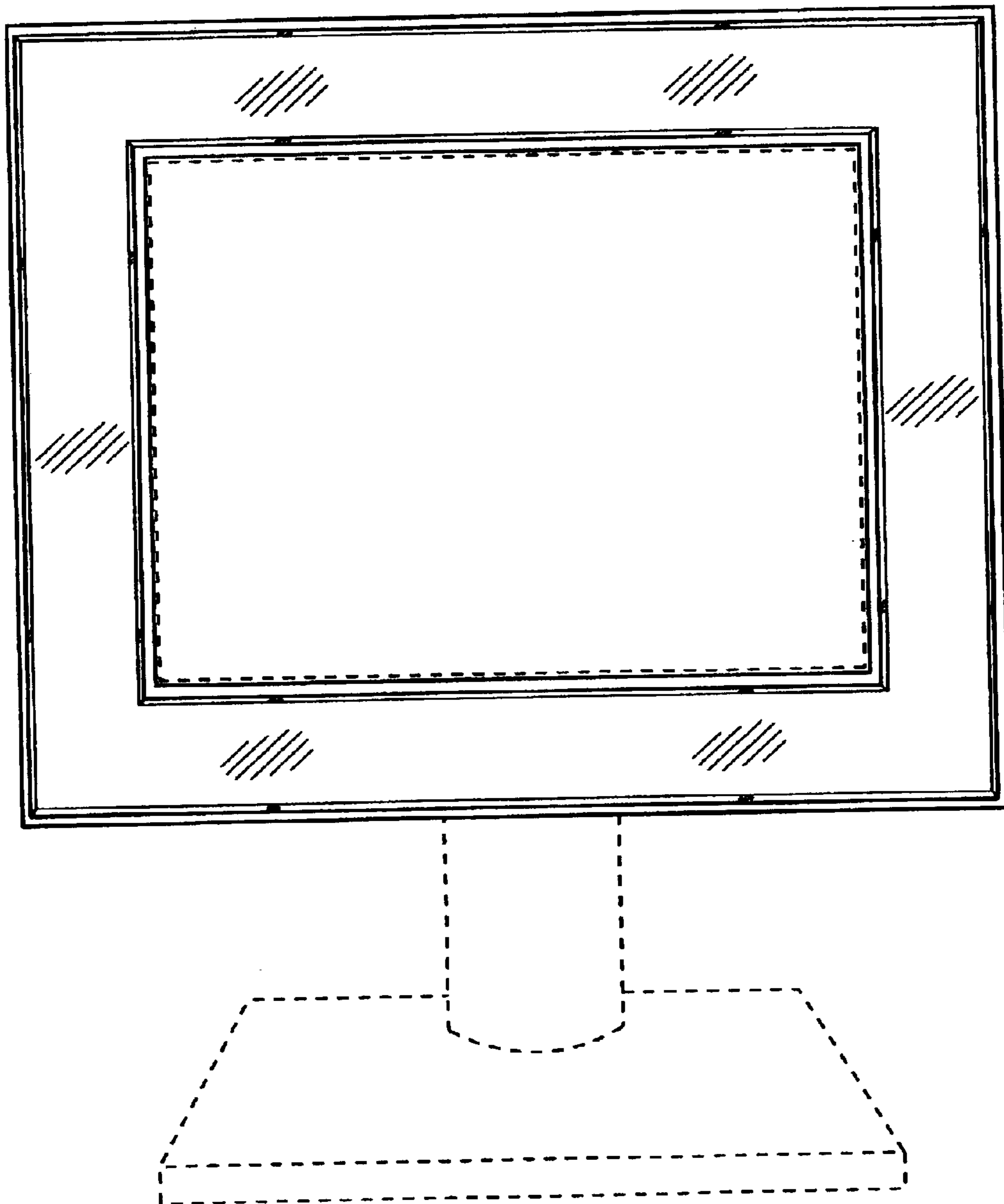

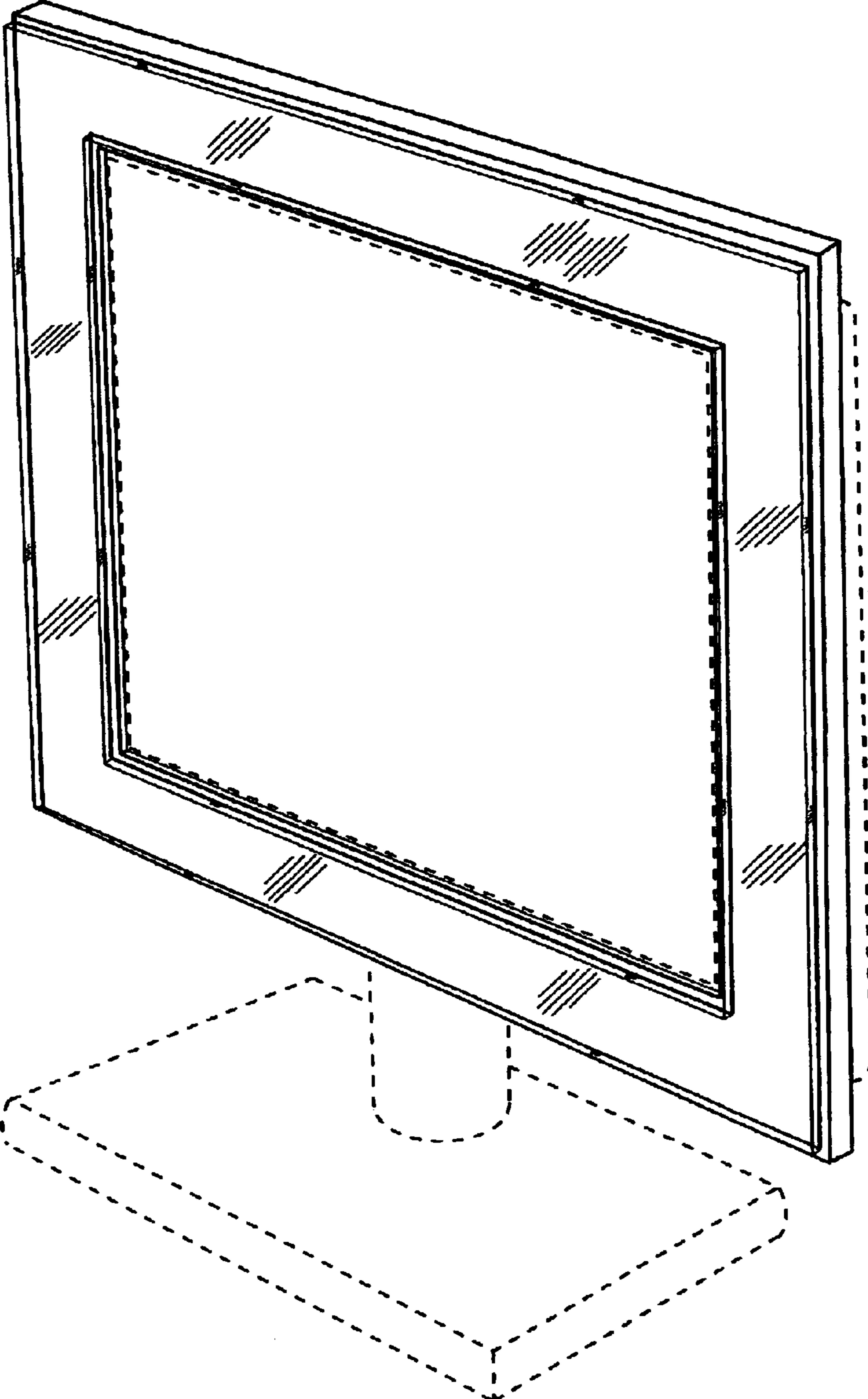

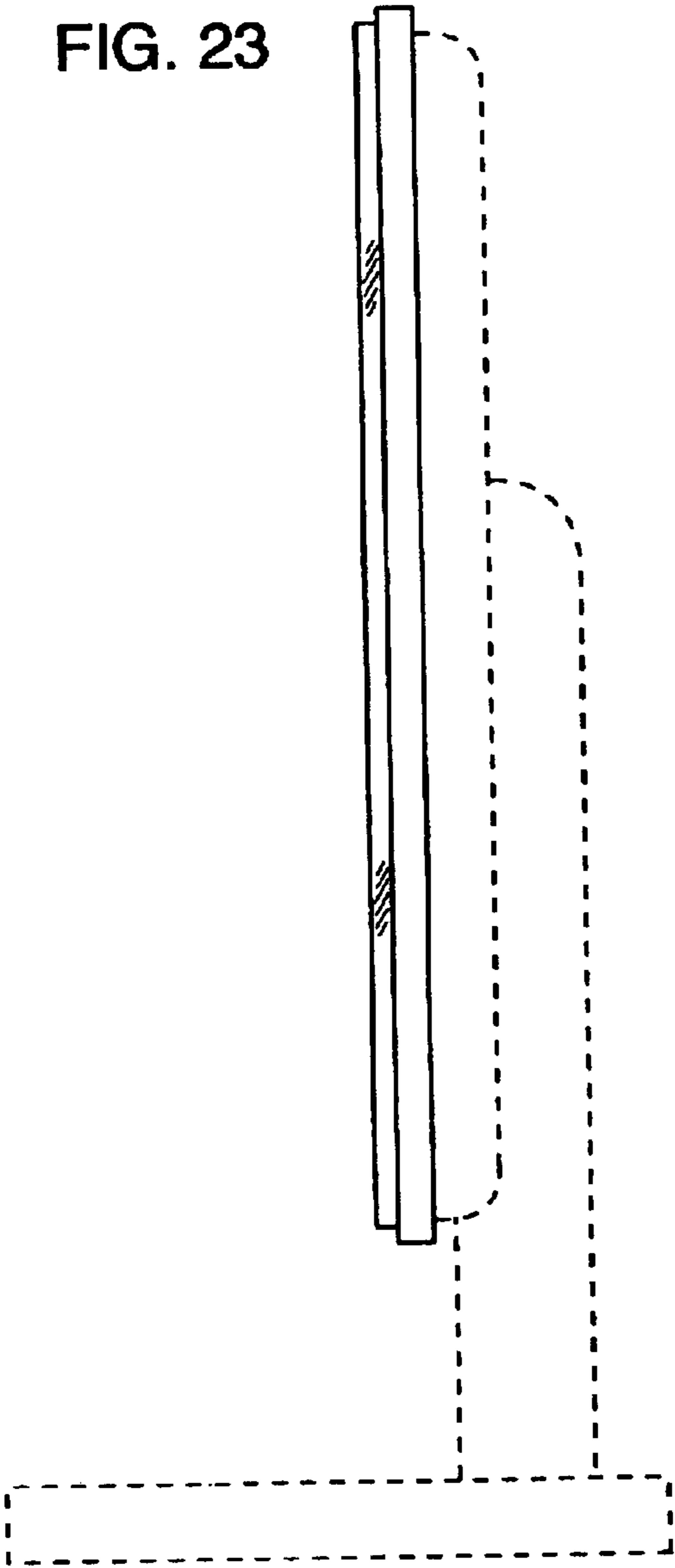

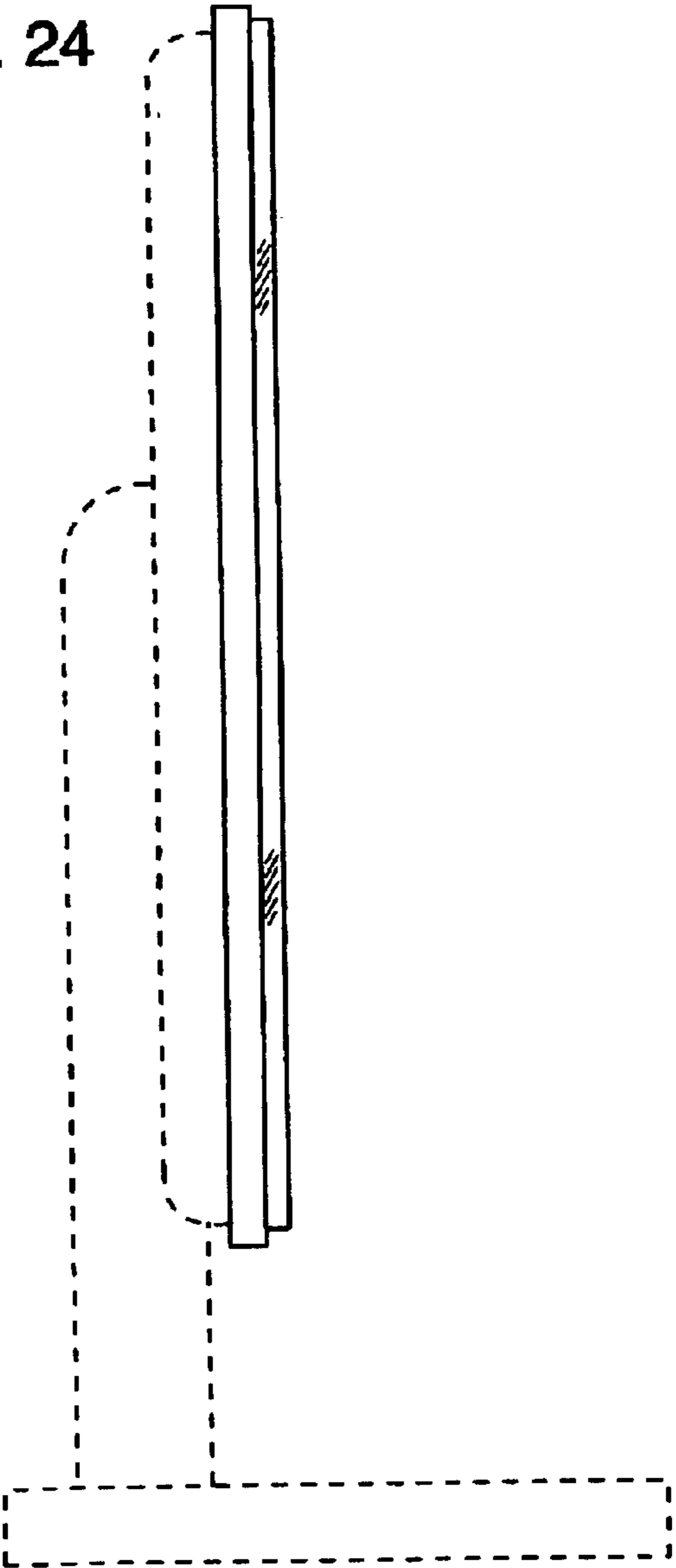

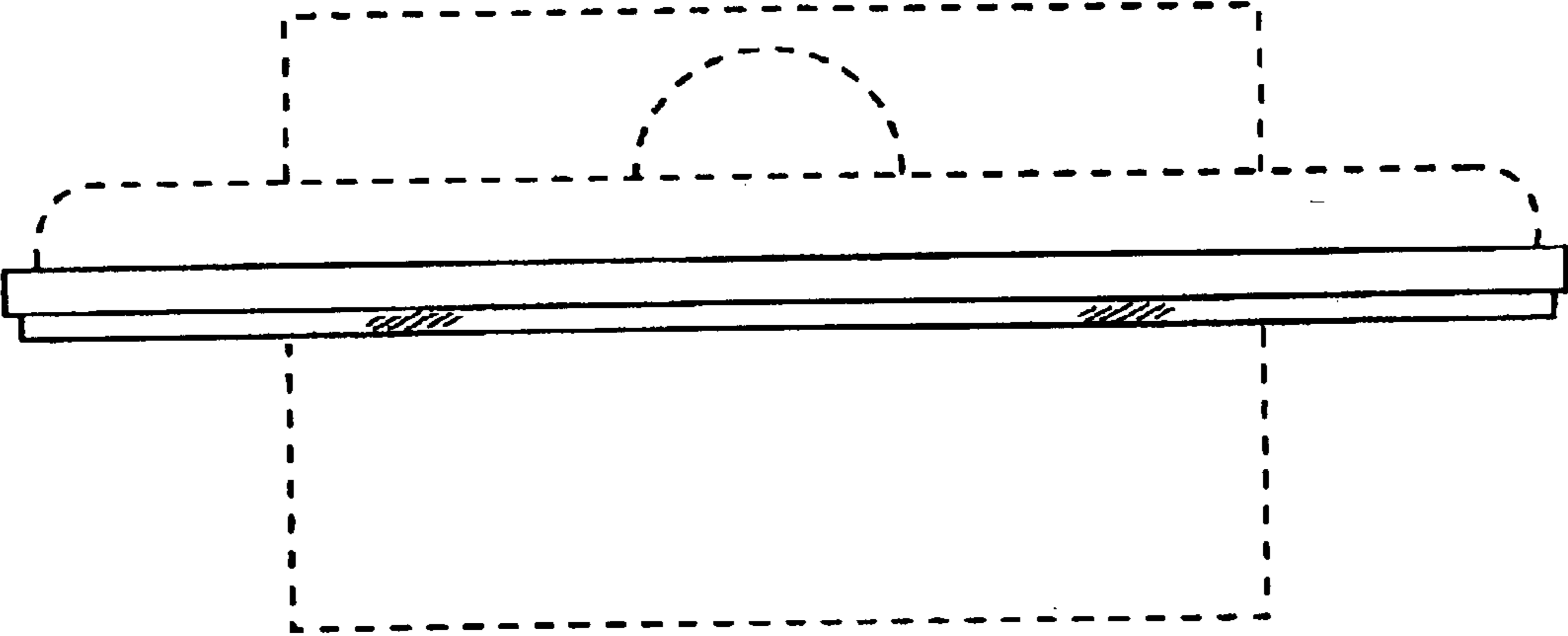
