The ornamental design for a toner cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a Front Elevation View of a toner cartridge of the present invention;

FIG. 2 is a Top Plan View thereof;

FIG. 3 is a Right Side View thereof;

FIG. 4 is a Left Side View thereof;

FIG. 5 is a Rear Elevation View thereof;

FIG. 6 is a Bottom Plan View thereof;

FIG. 7 is a top perspective view thereof;

FIG. 8 is a bottom perspective view thereof; and,

FIG. 9 is an enlarged cross section view taken along line 9—9 in FIG. 2.

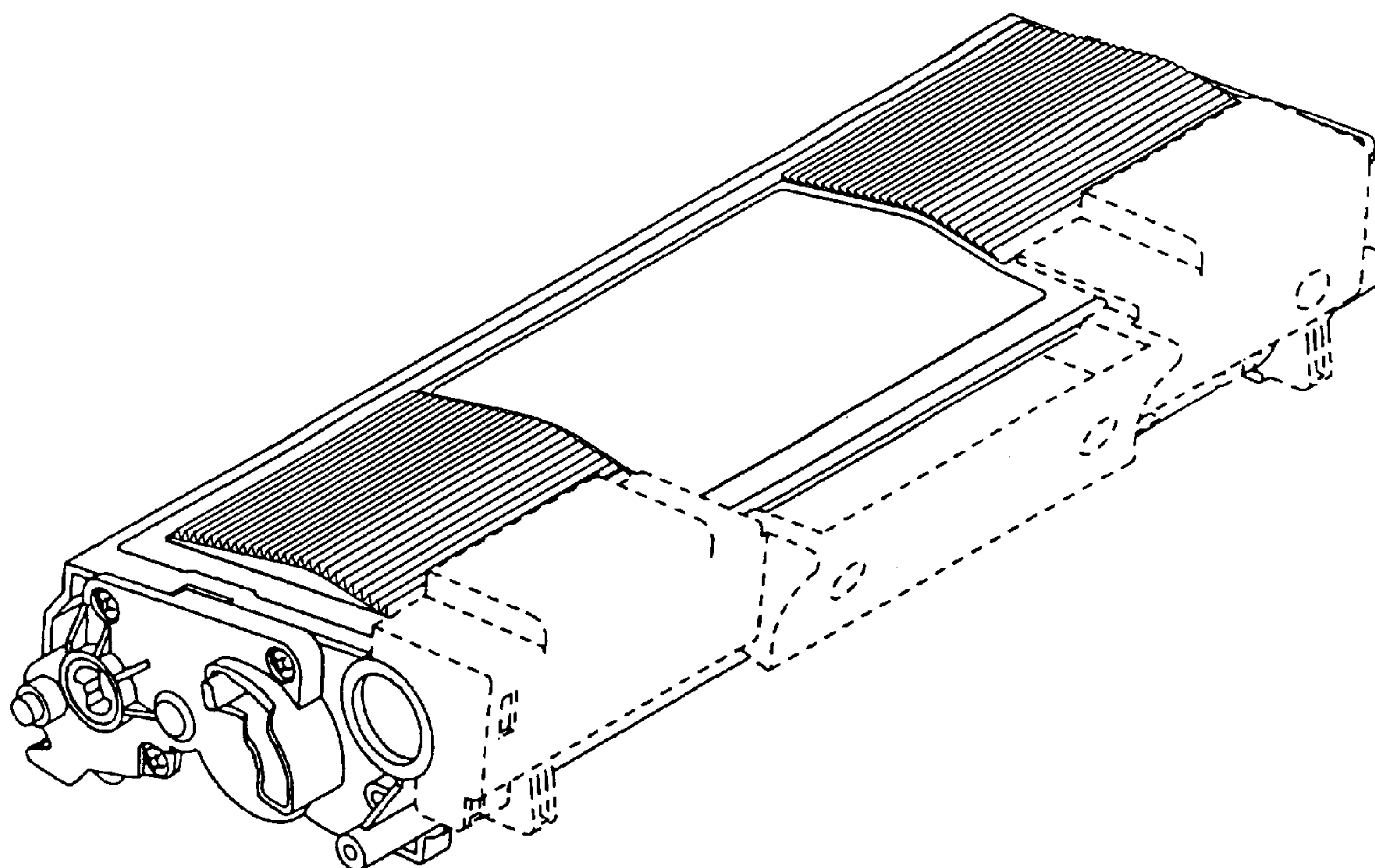

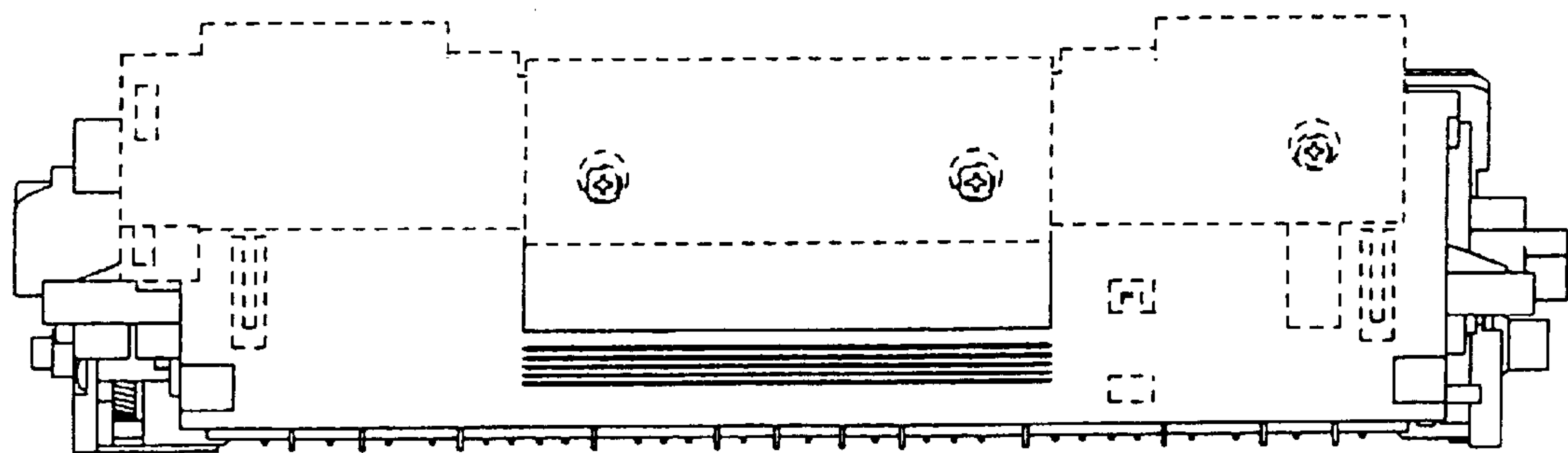

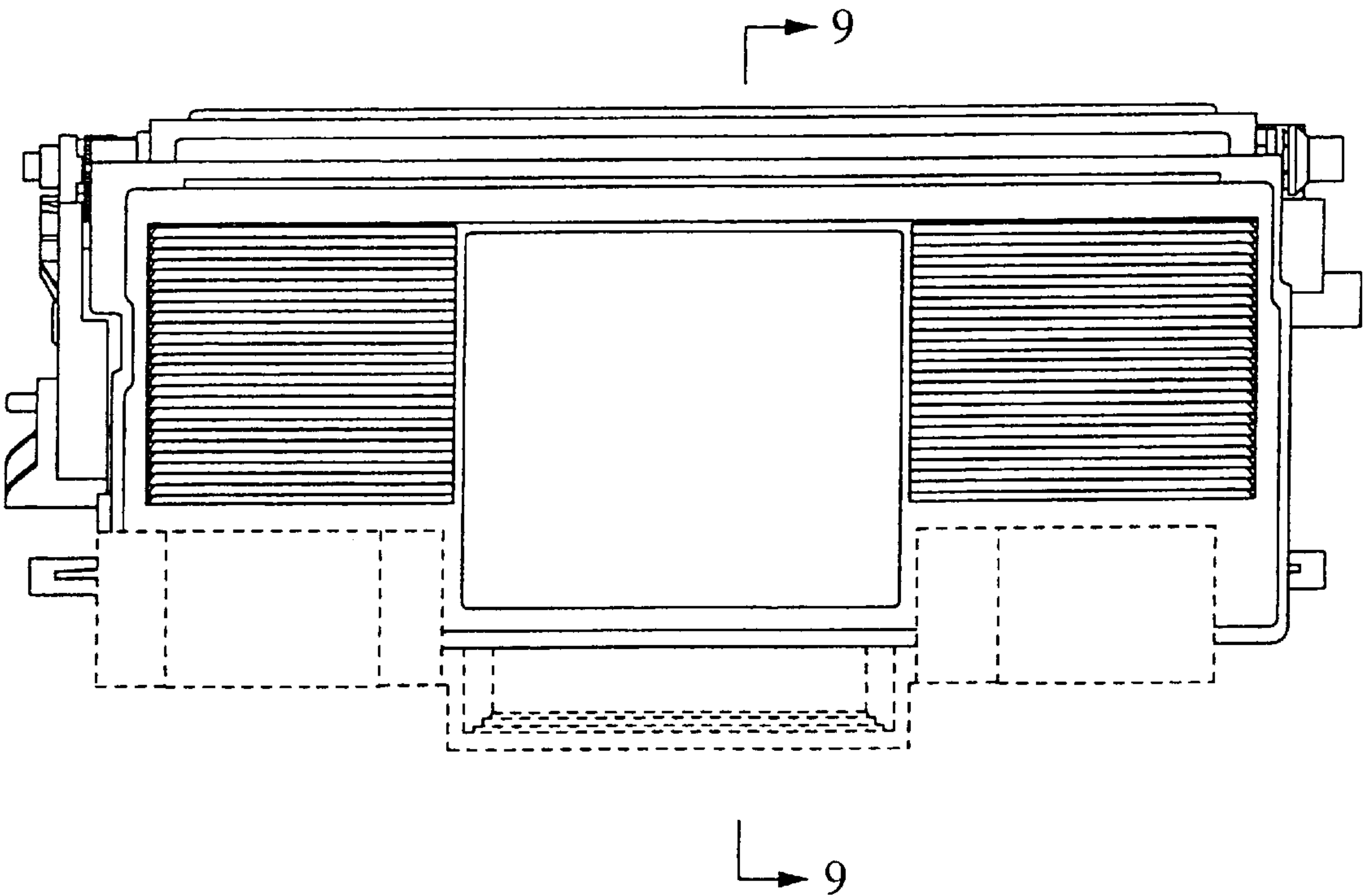

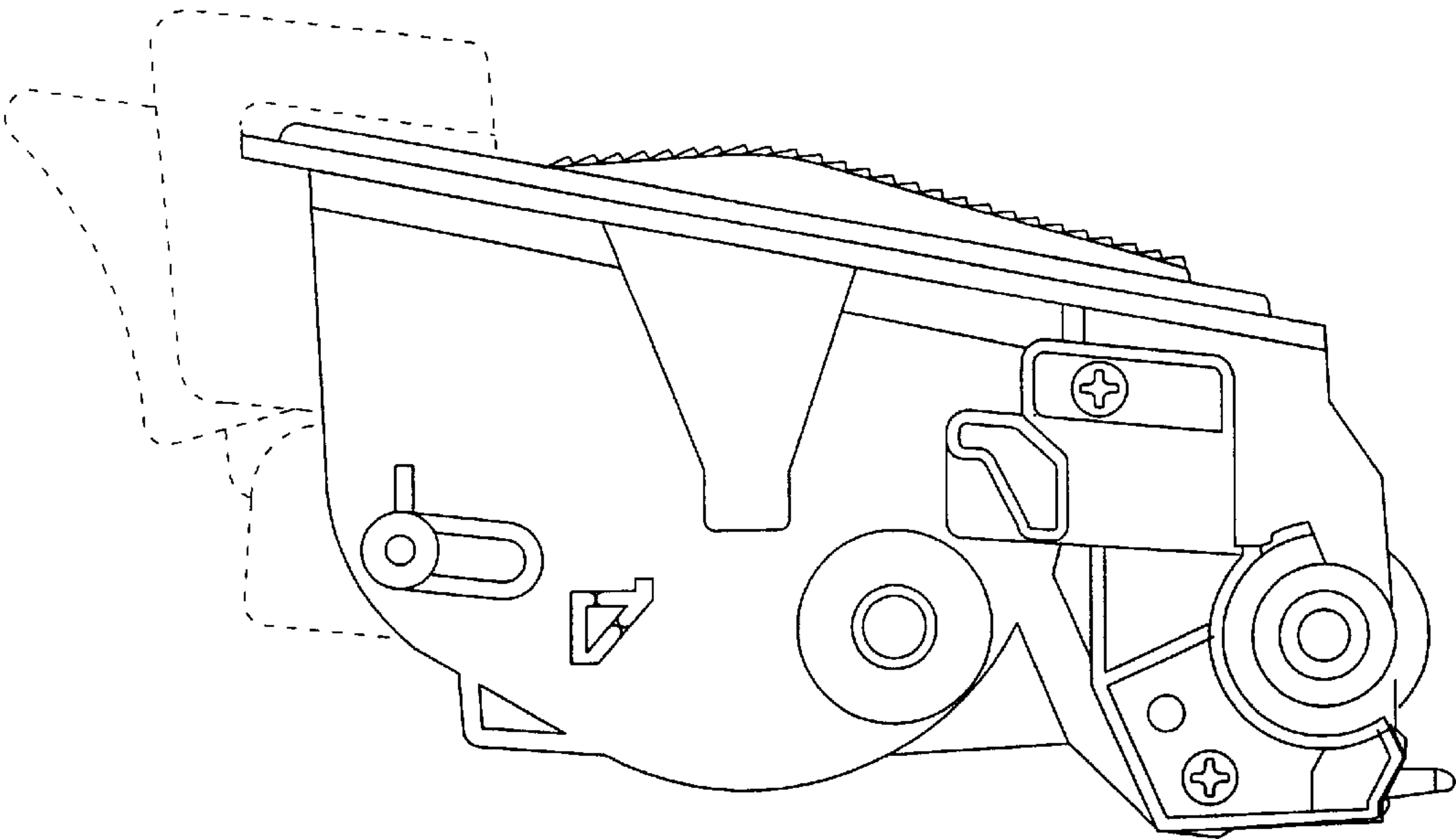

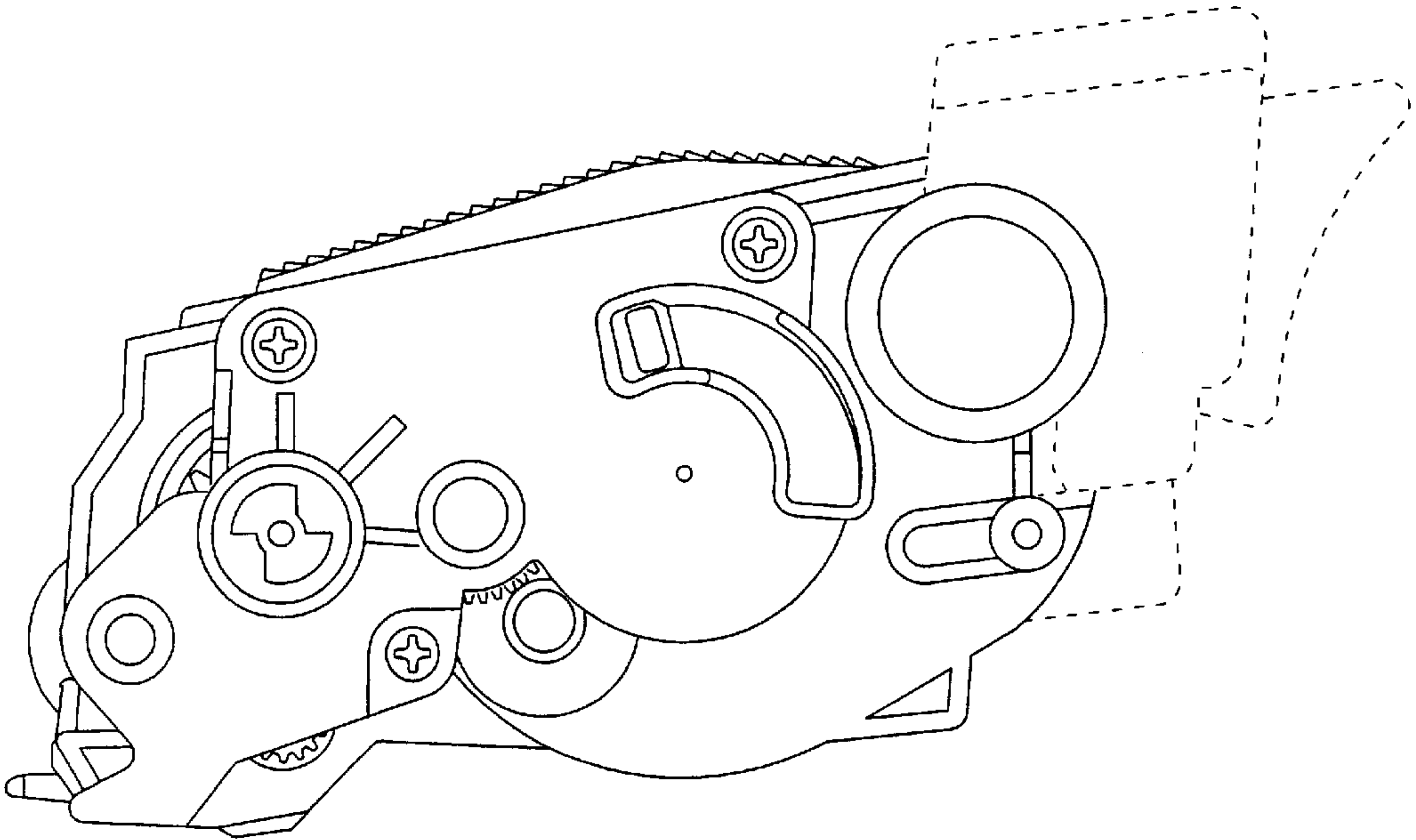

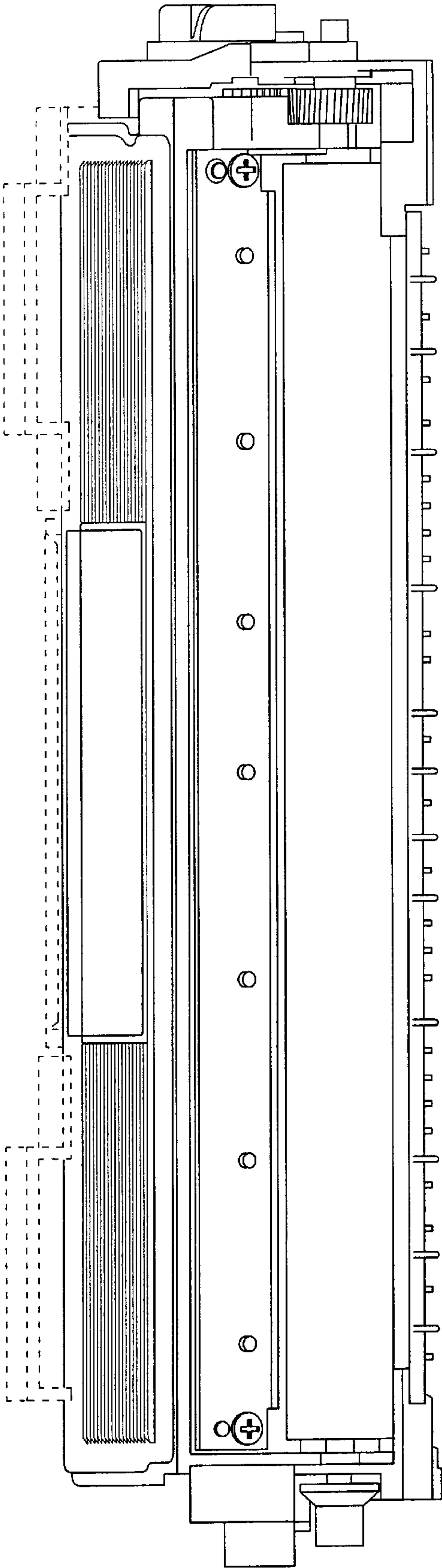

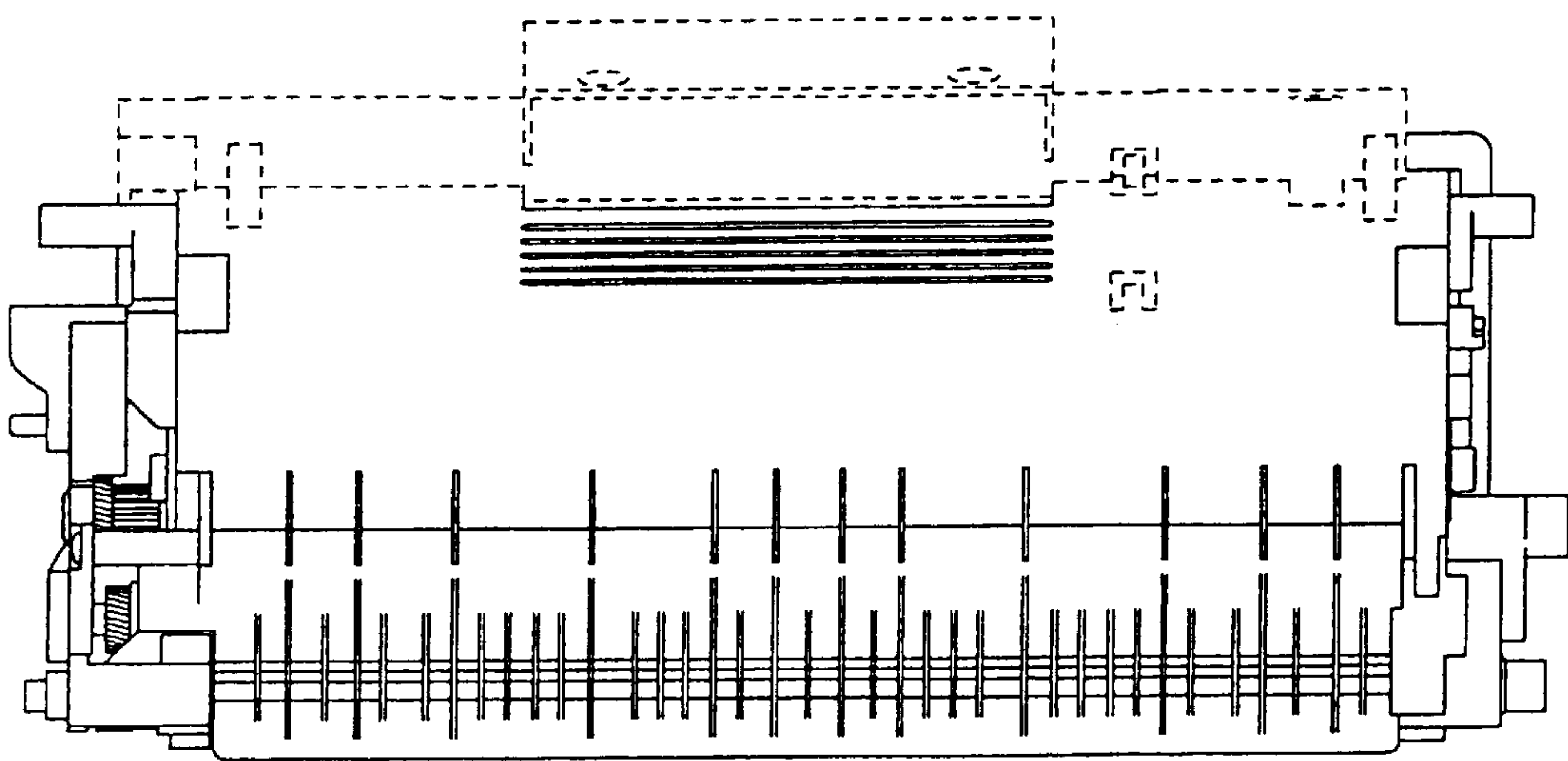

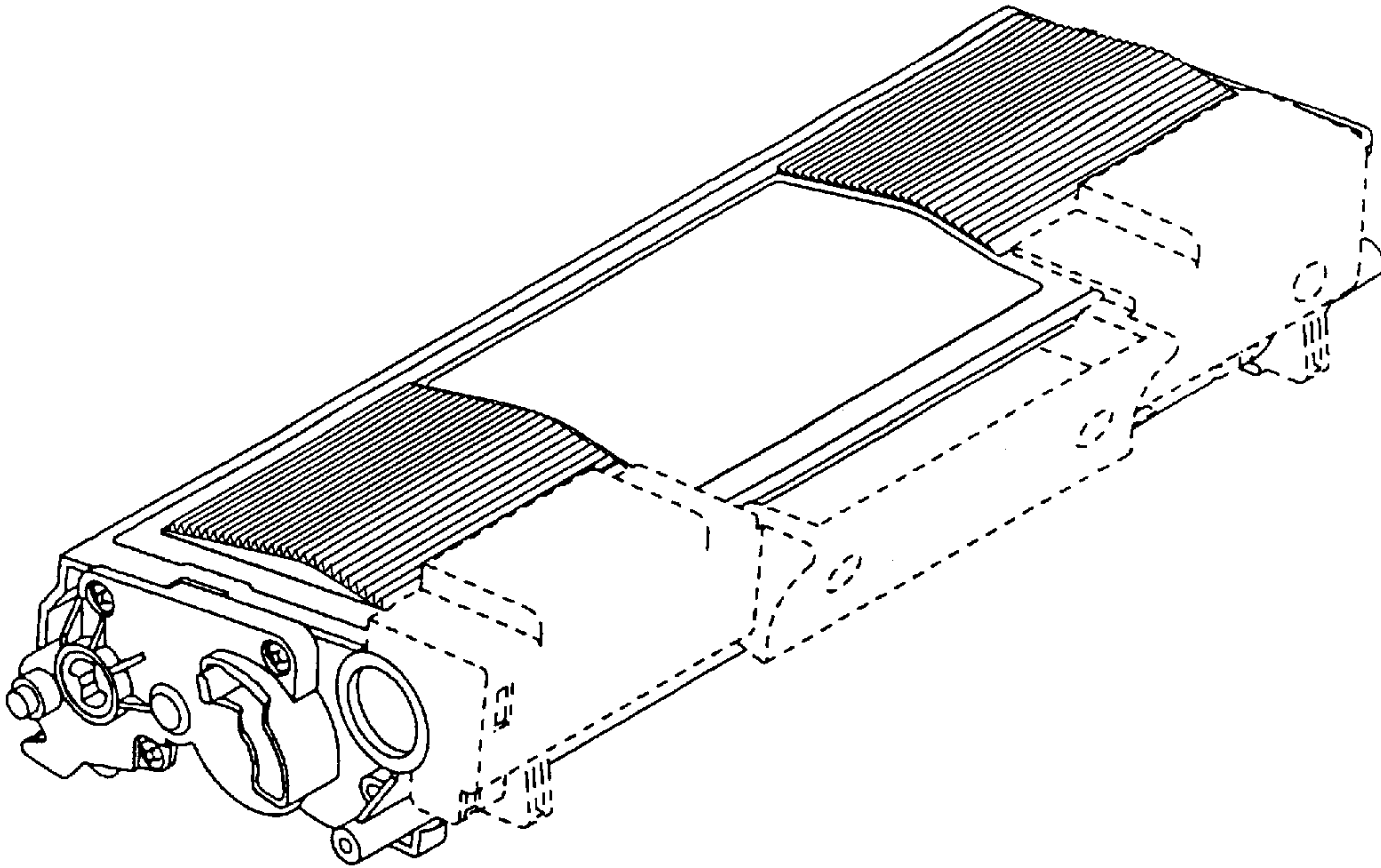

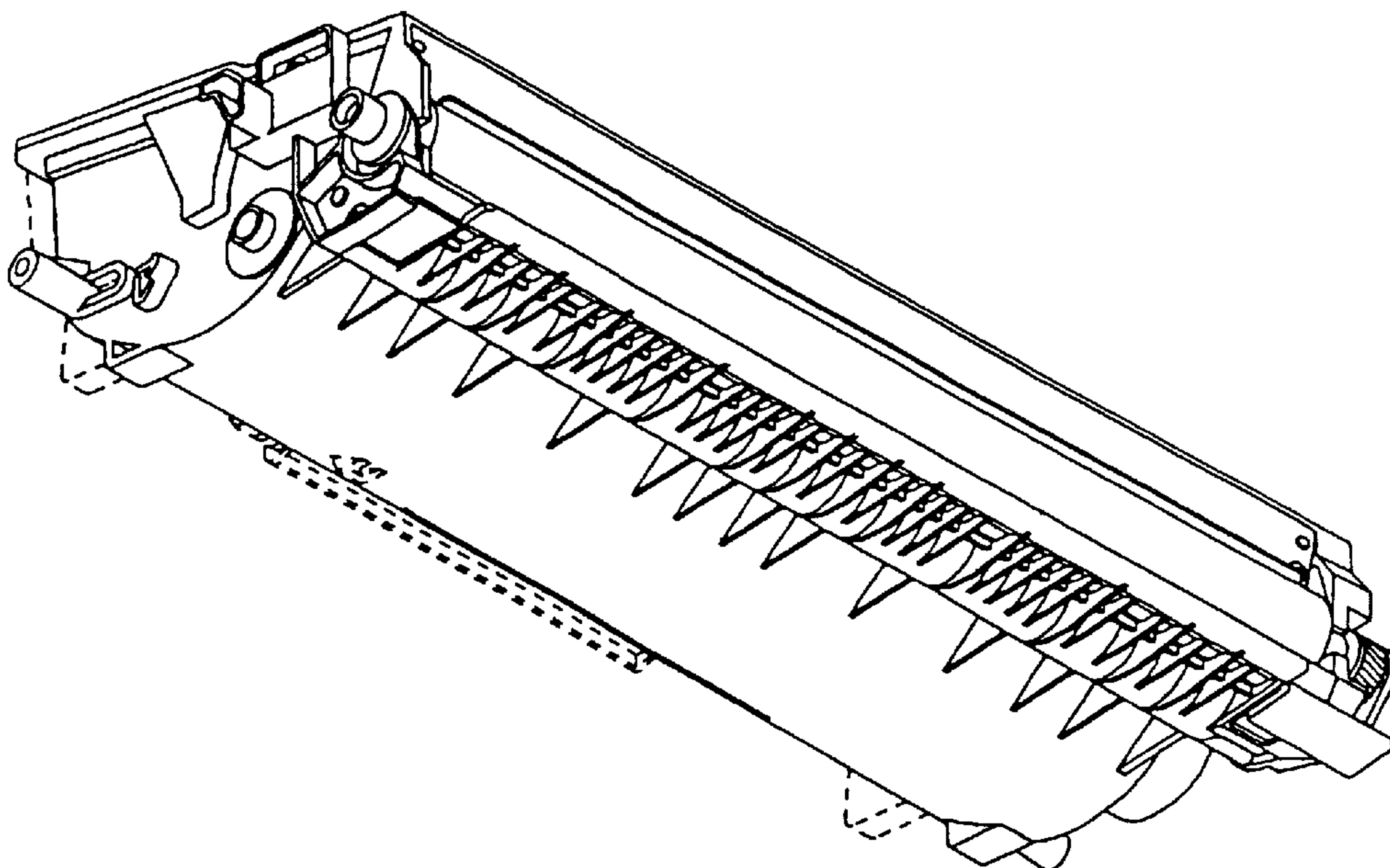
