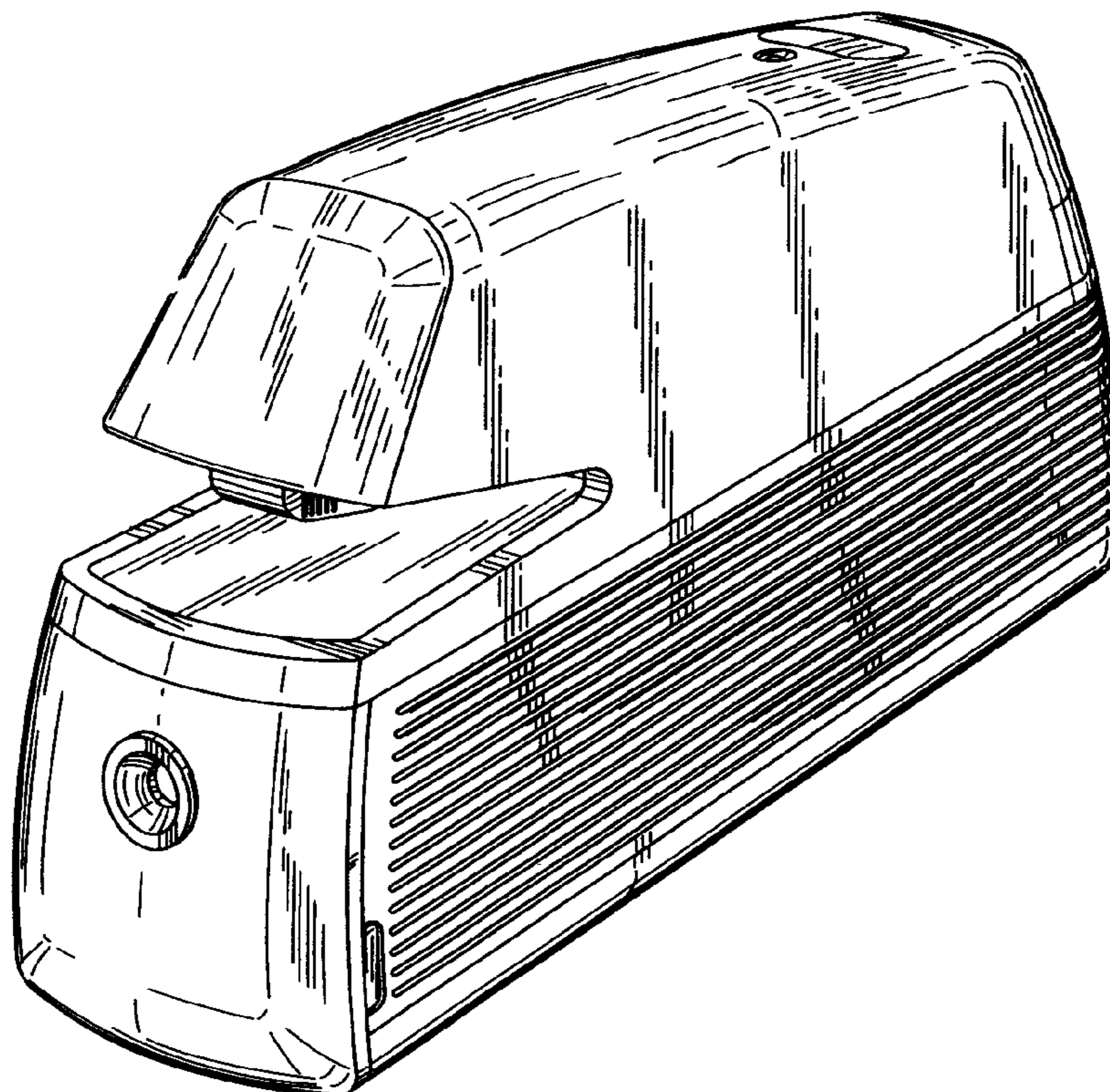
(57) **CLAIM**

I claim the ornamental design for a combined stapler and pencil sharpener, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a combined stapler and pencil sharpener of the present invention; FIG. 2 is a top view thereof; FIG. 3 is a first side view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a front view thereof; FIG. 6 is a rear view thereof; and, FIG. 7 is a second side view thereof.

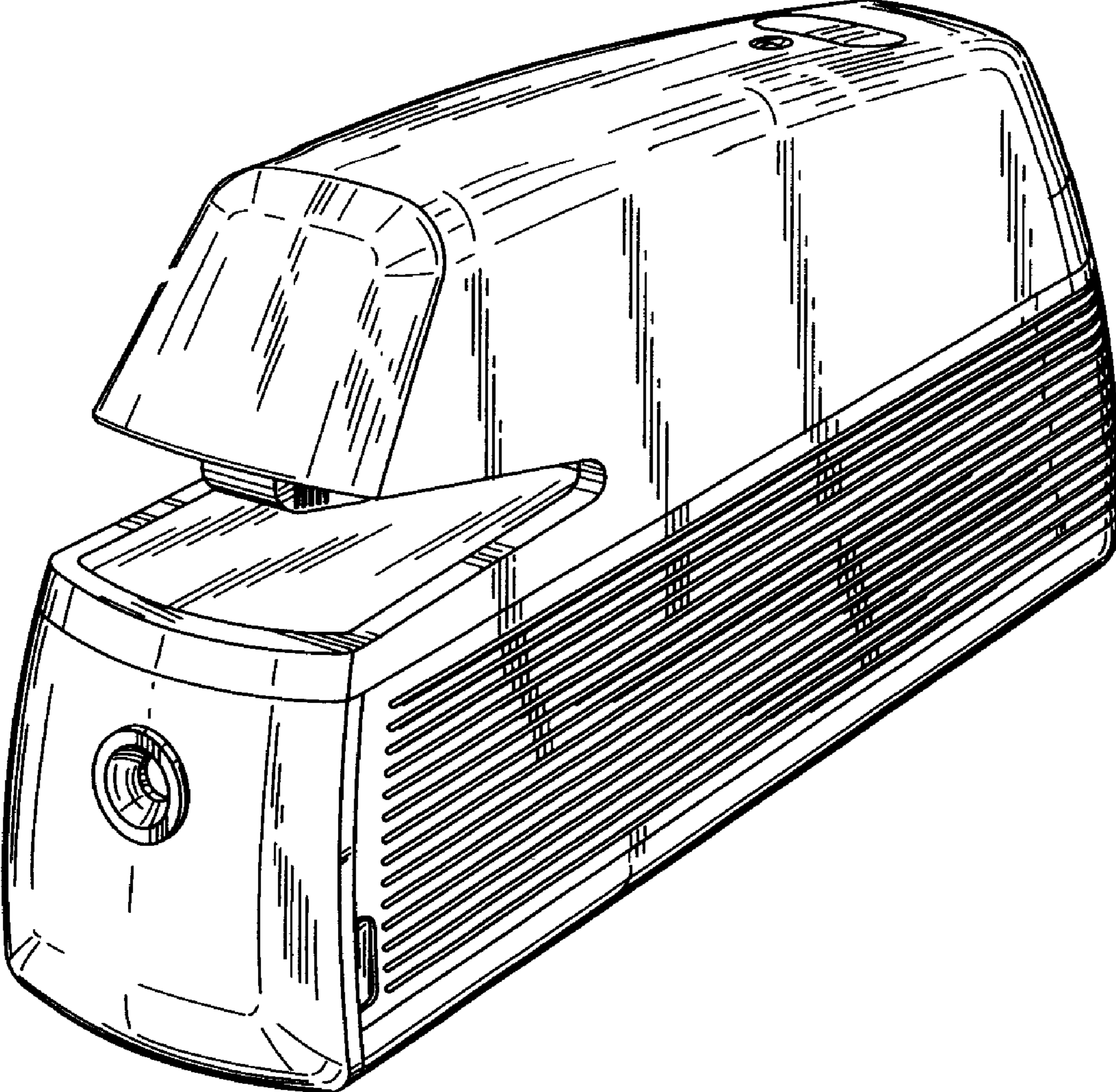

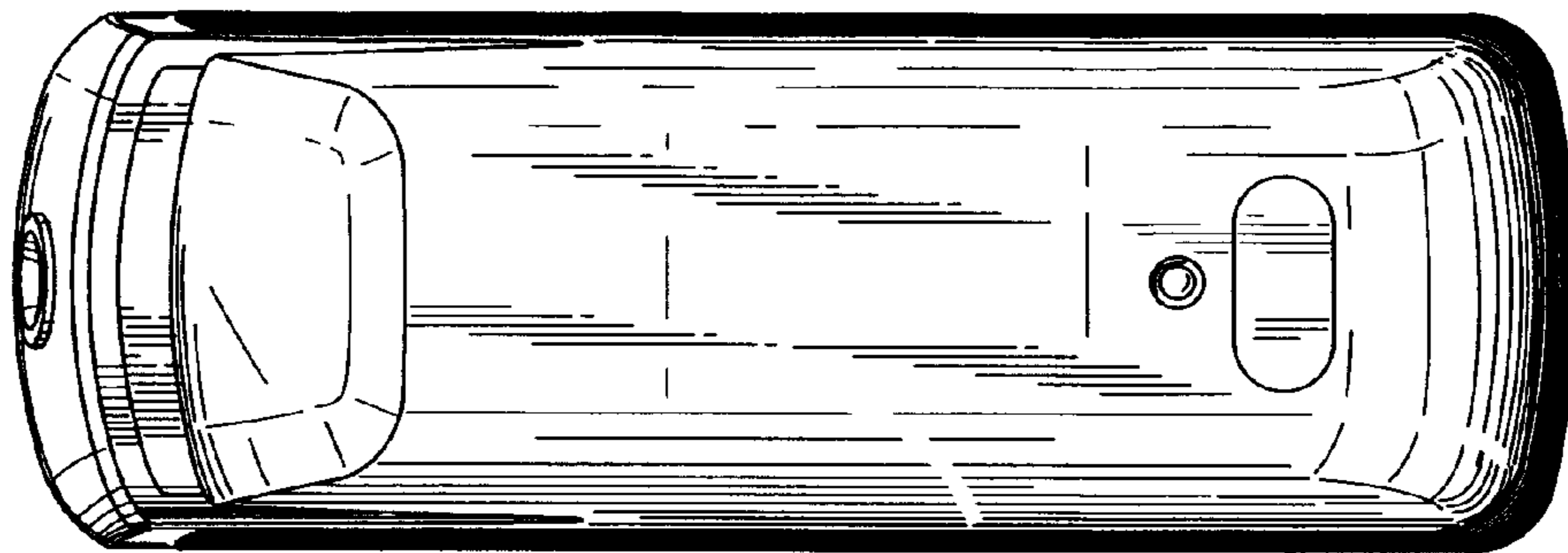

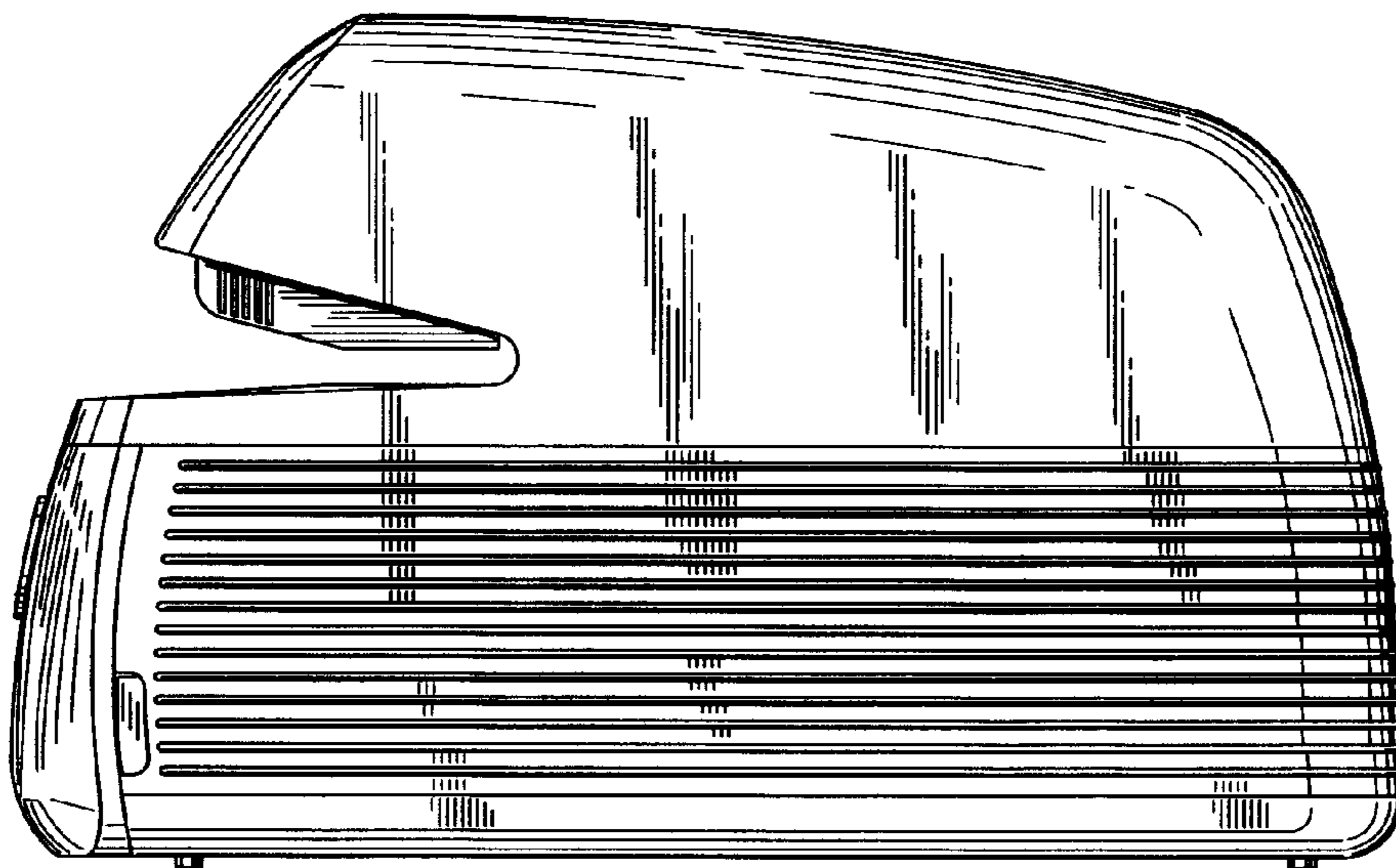

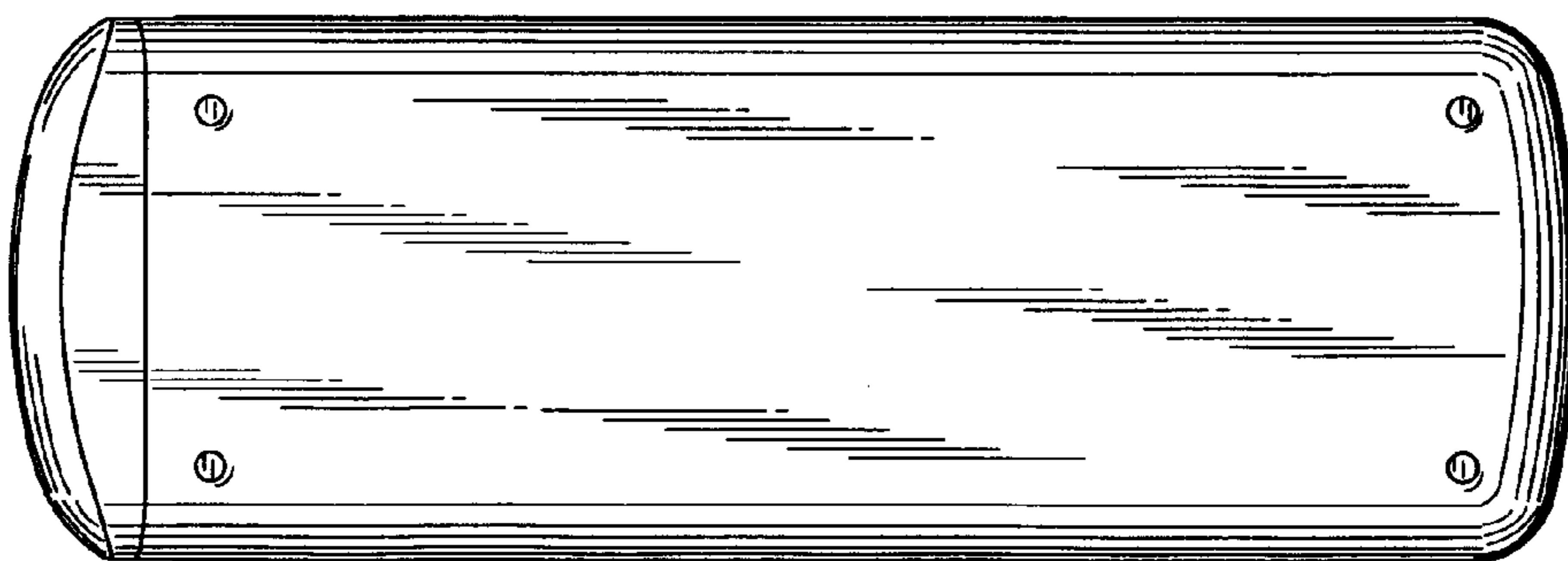

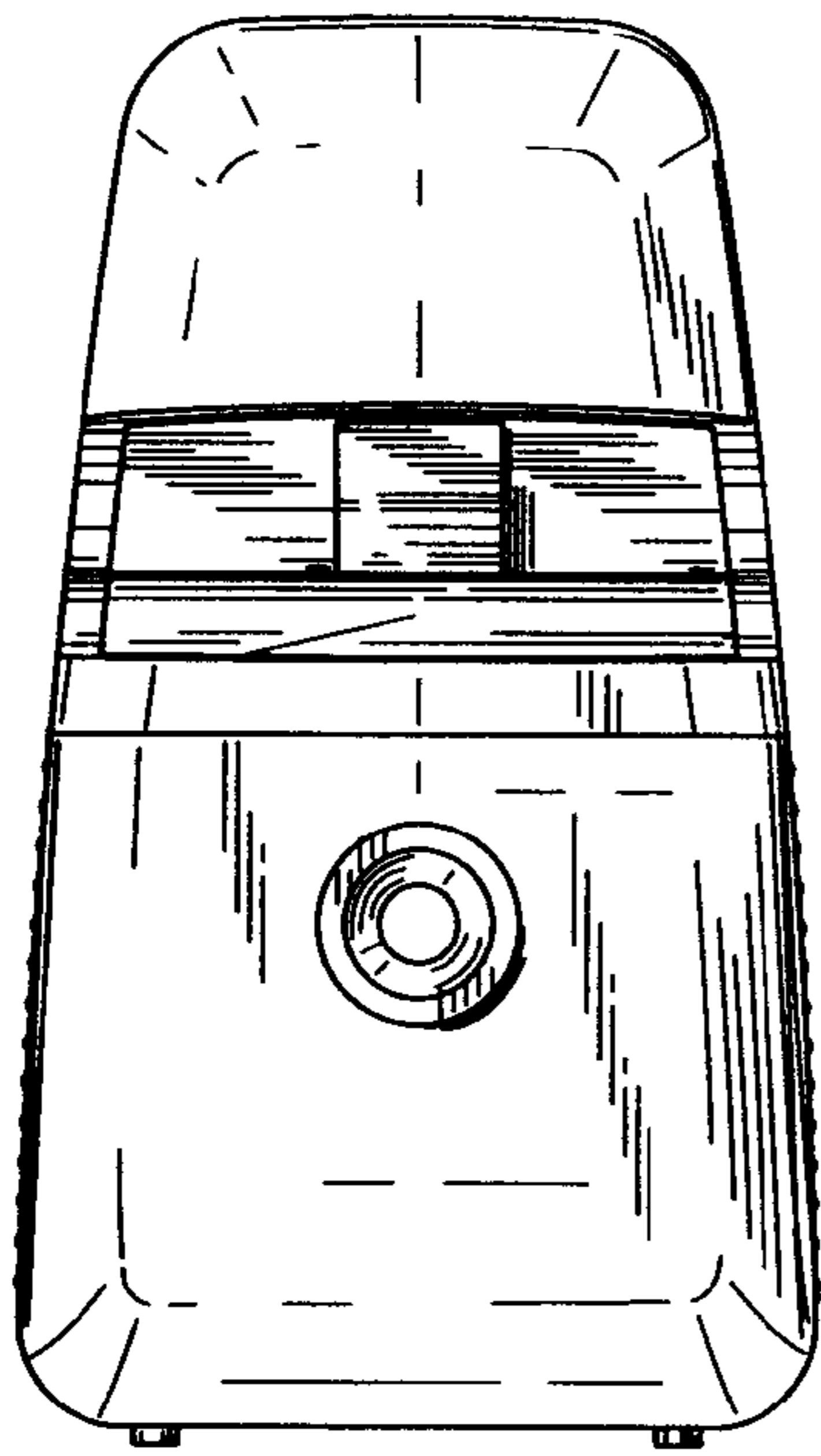

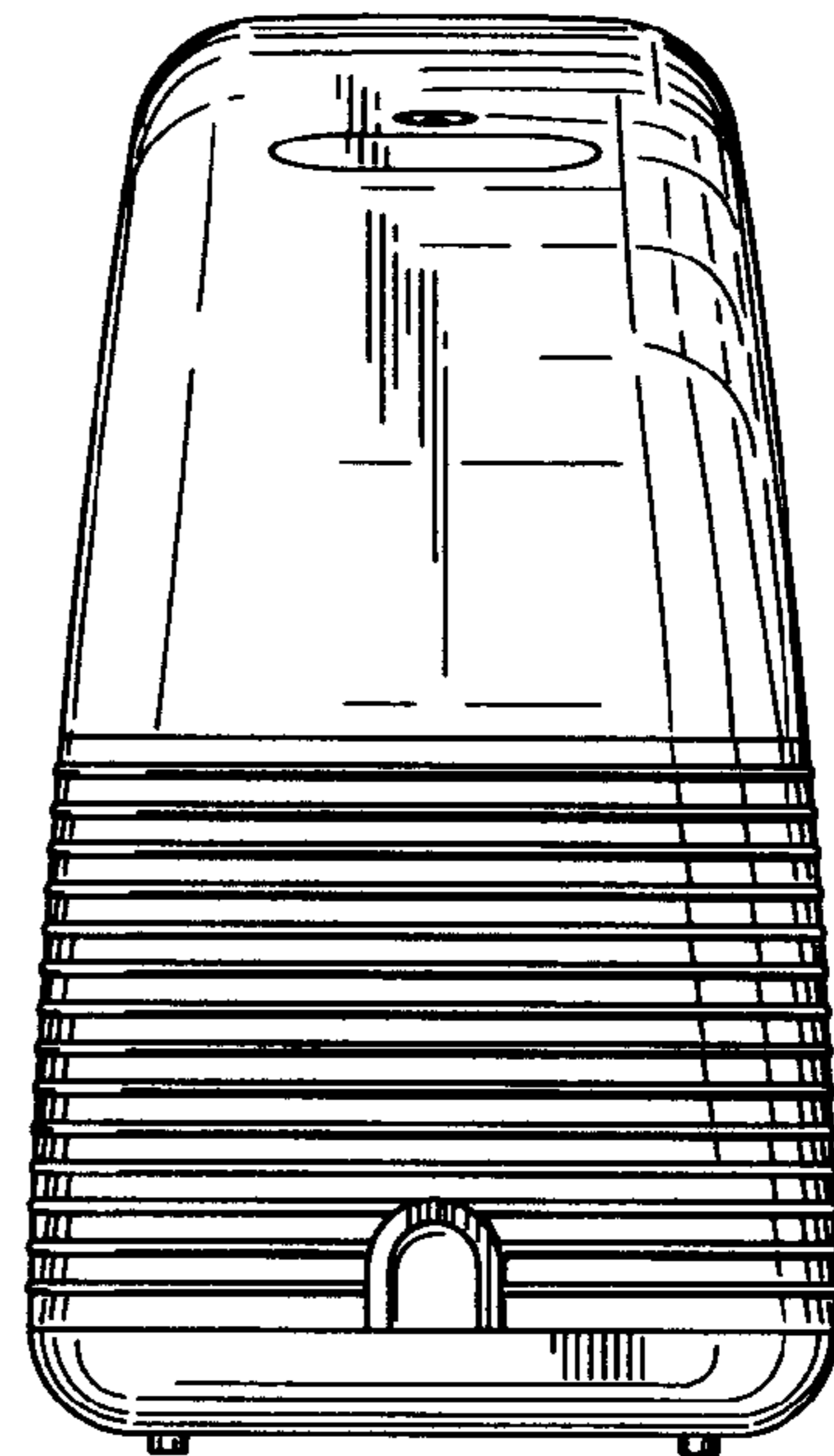

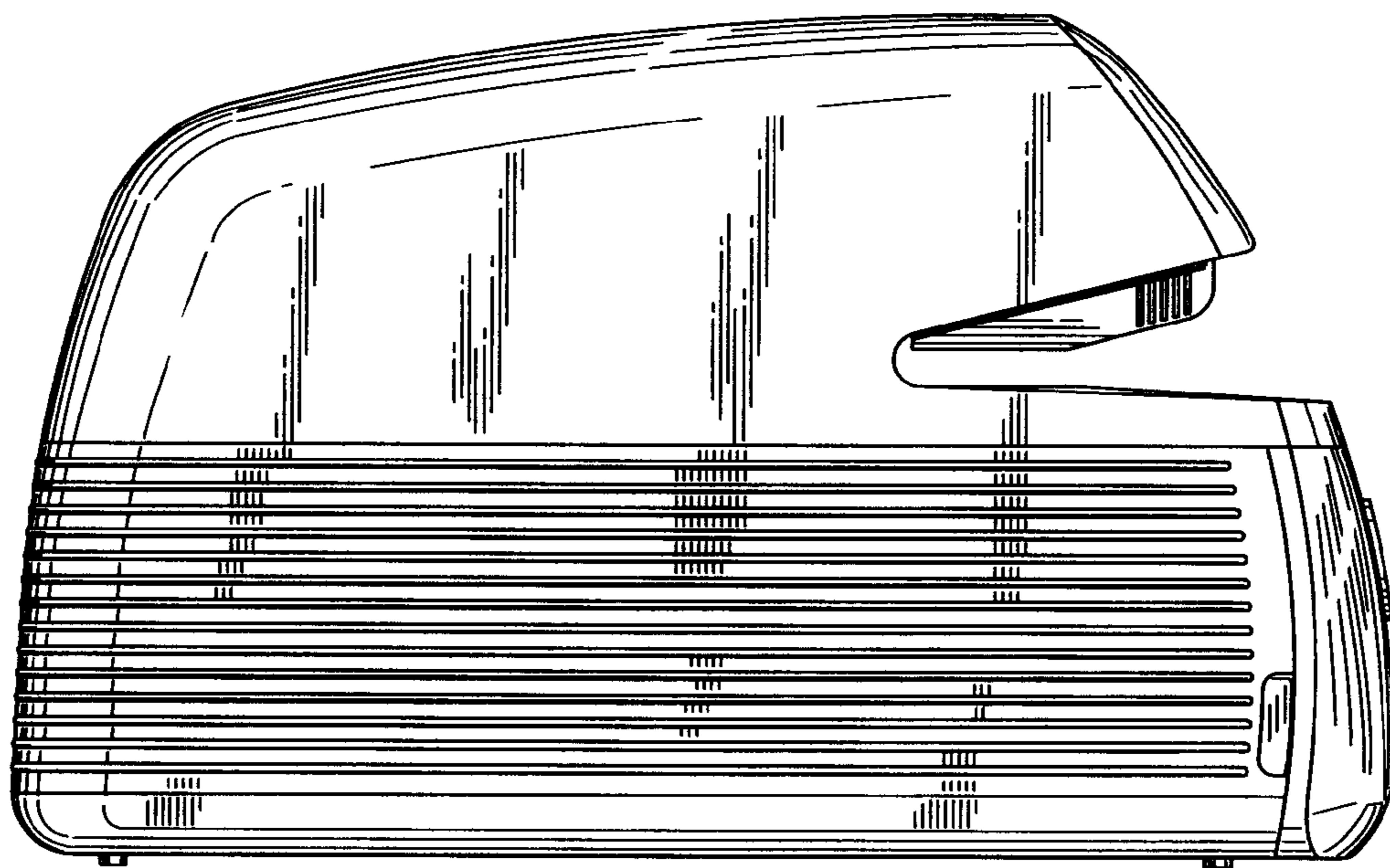
