**DESCRIPTION**

FIG. 5 is a toe view thereof;

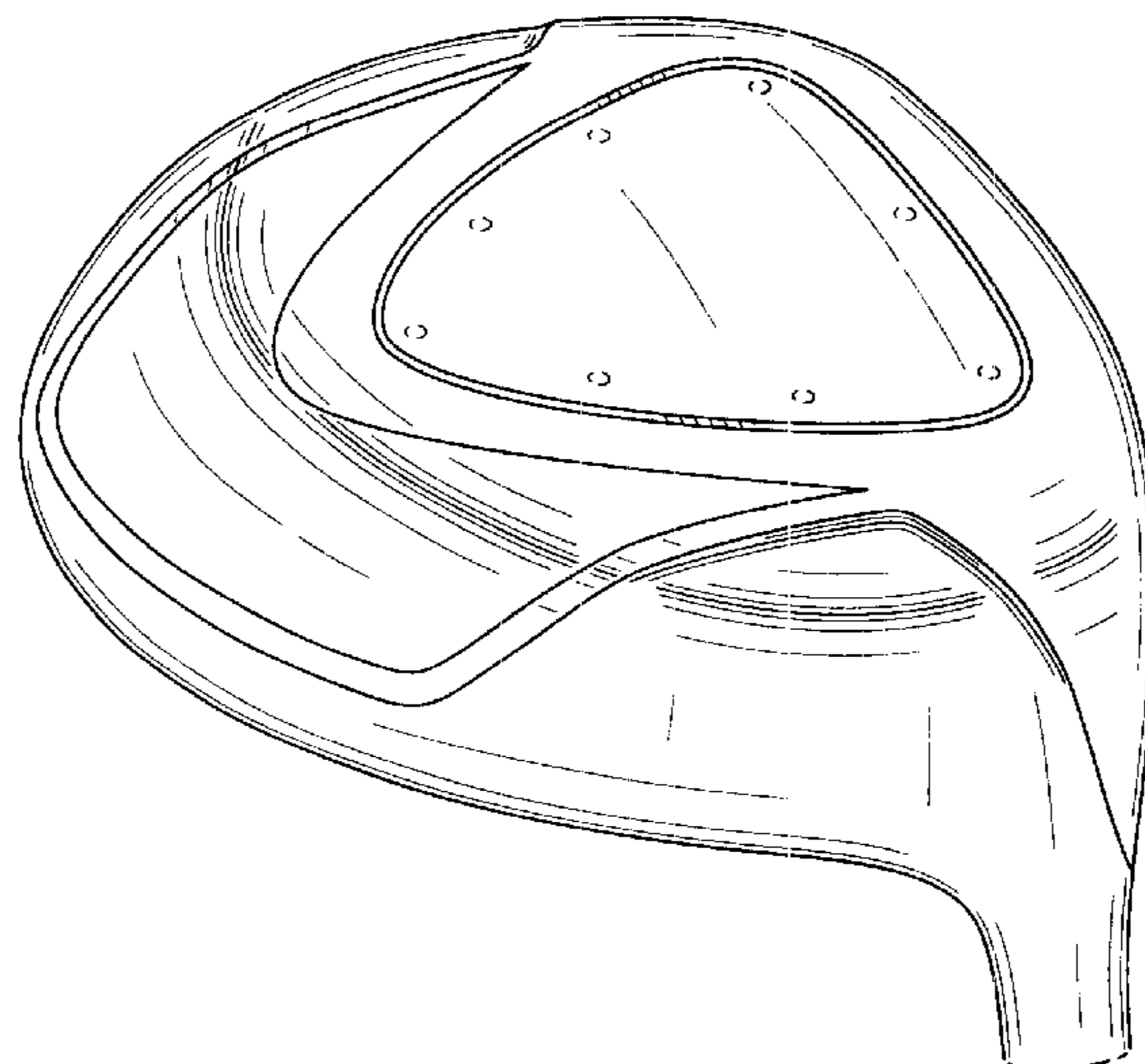
FIG. 6 is a heel view thereof;

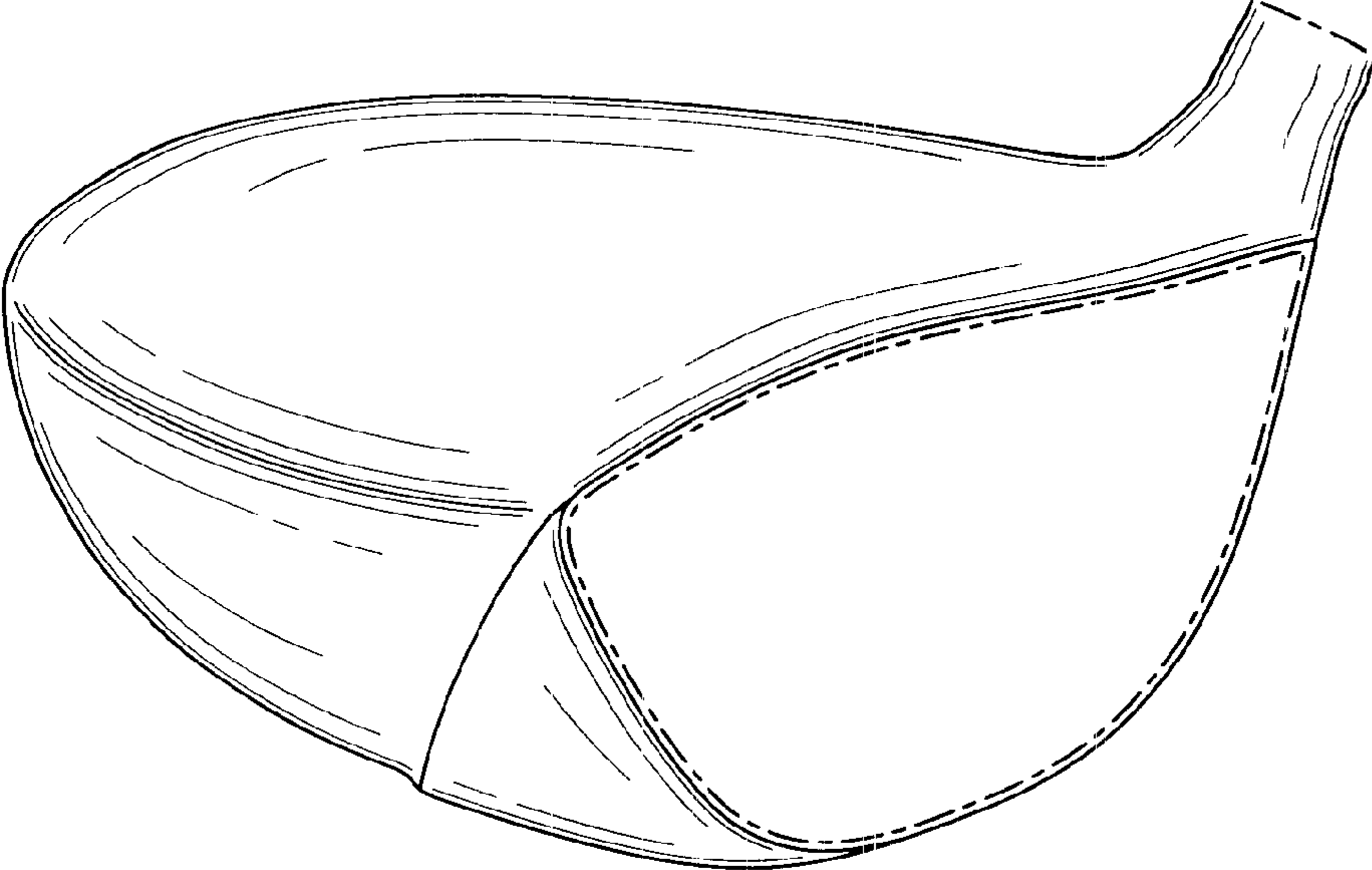

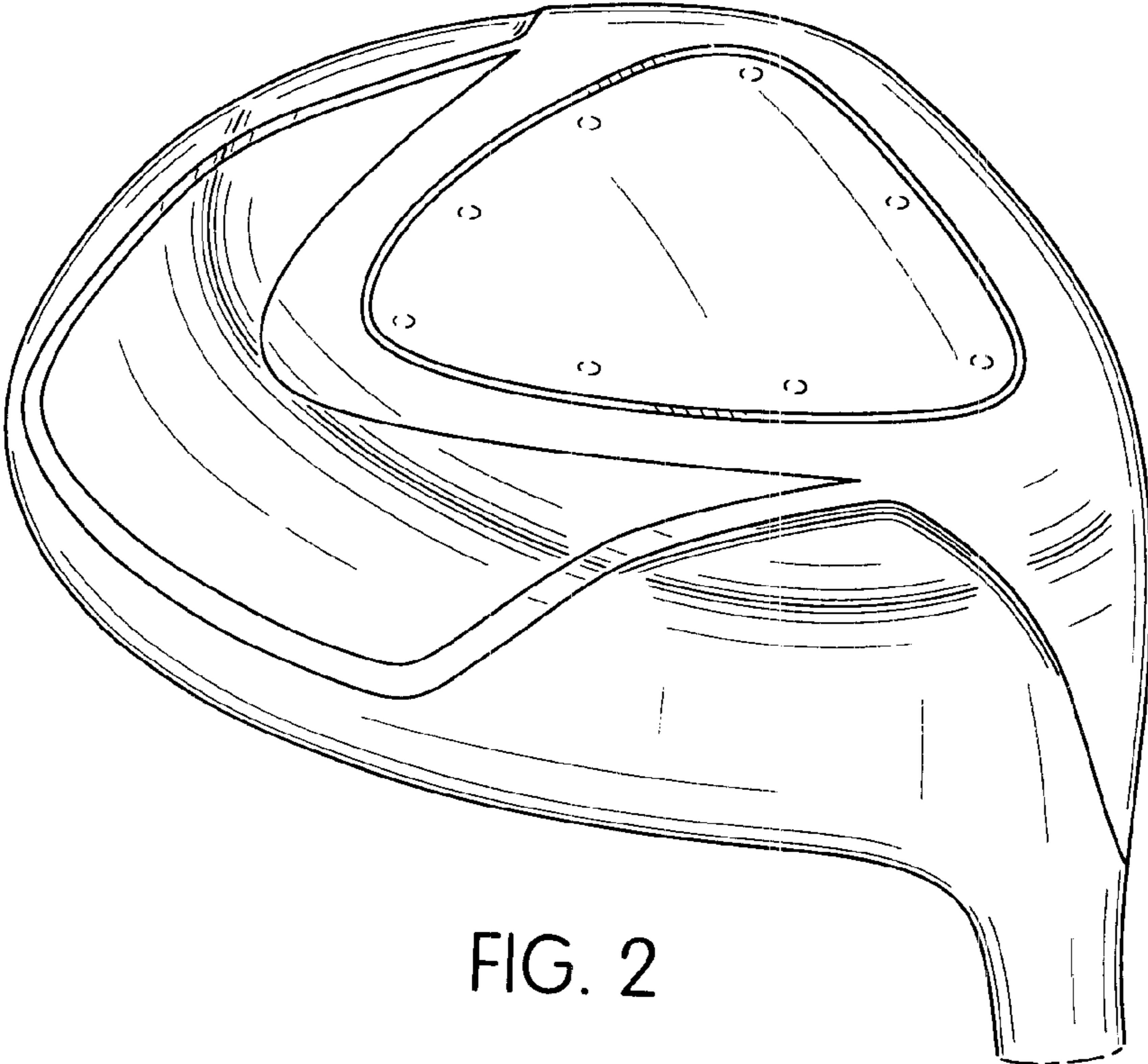

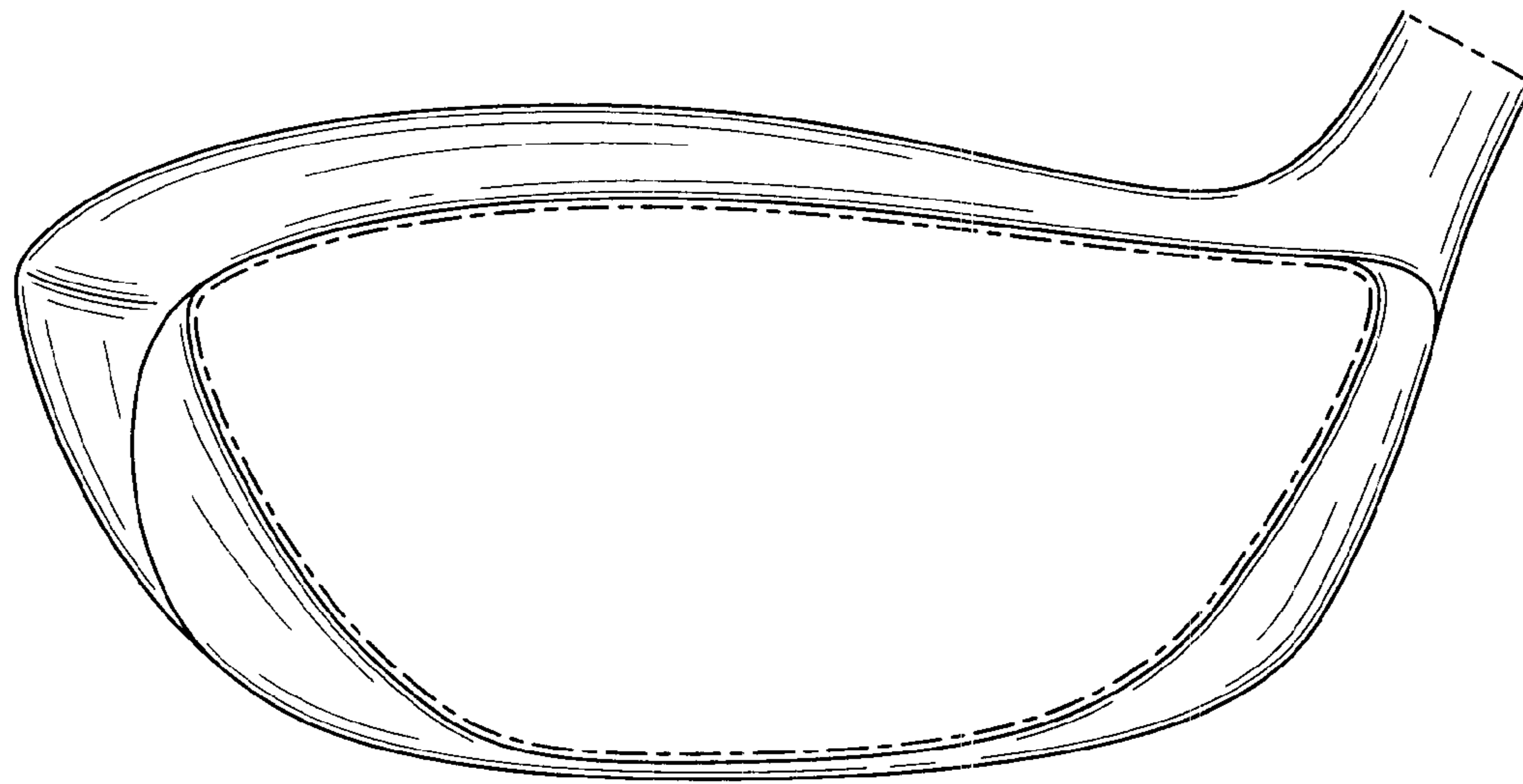

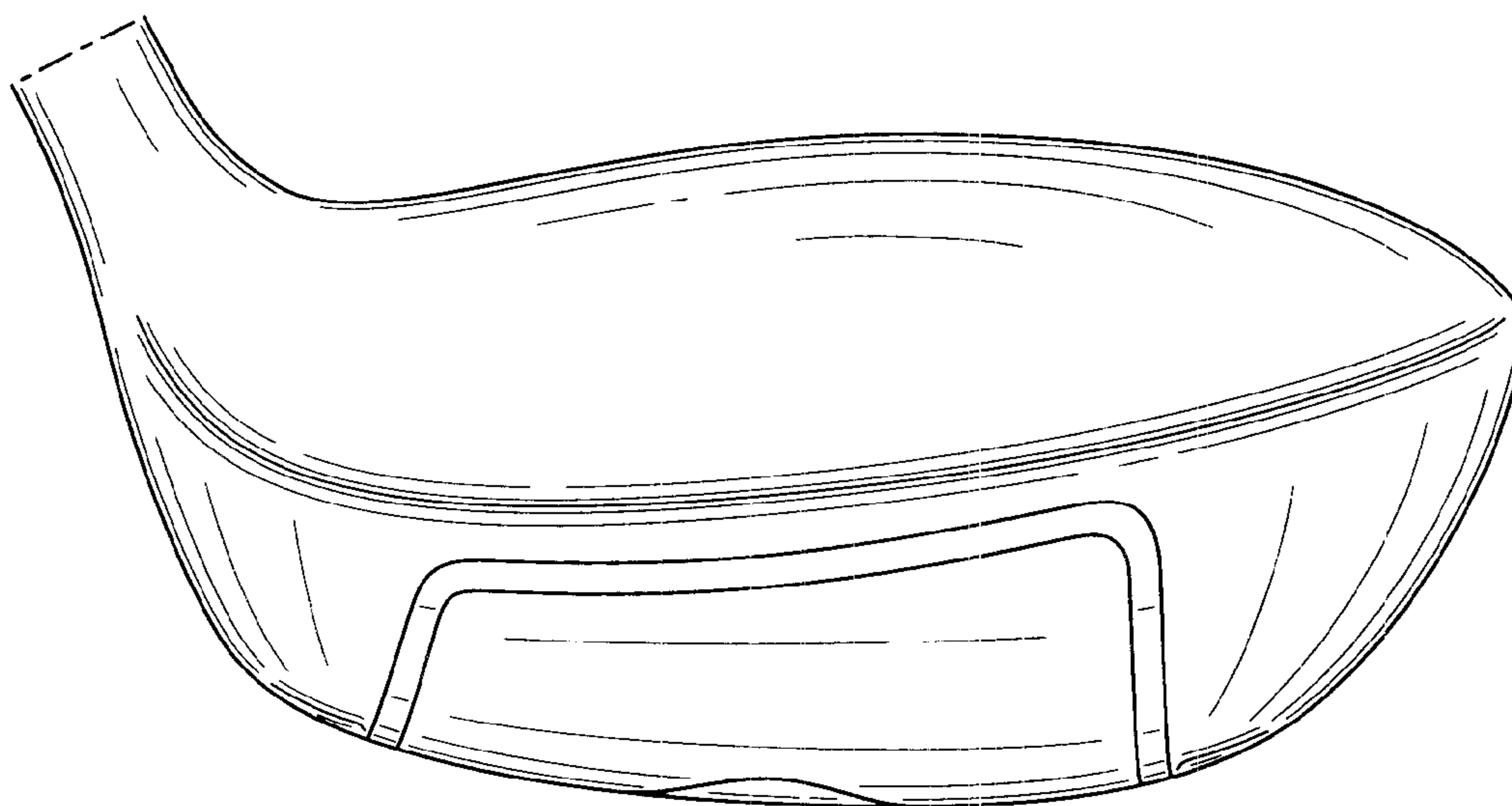

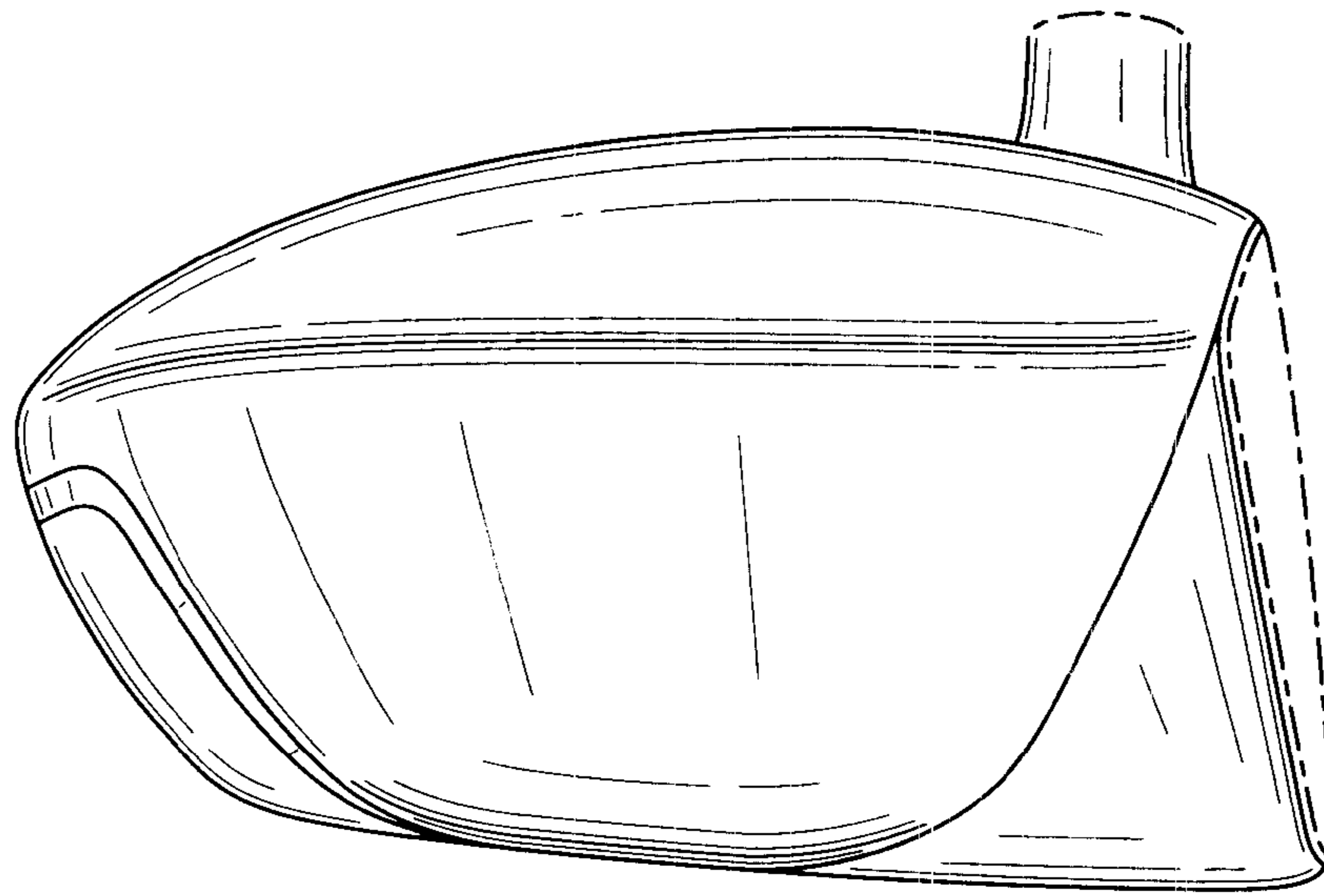

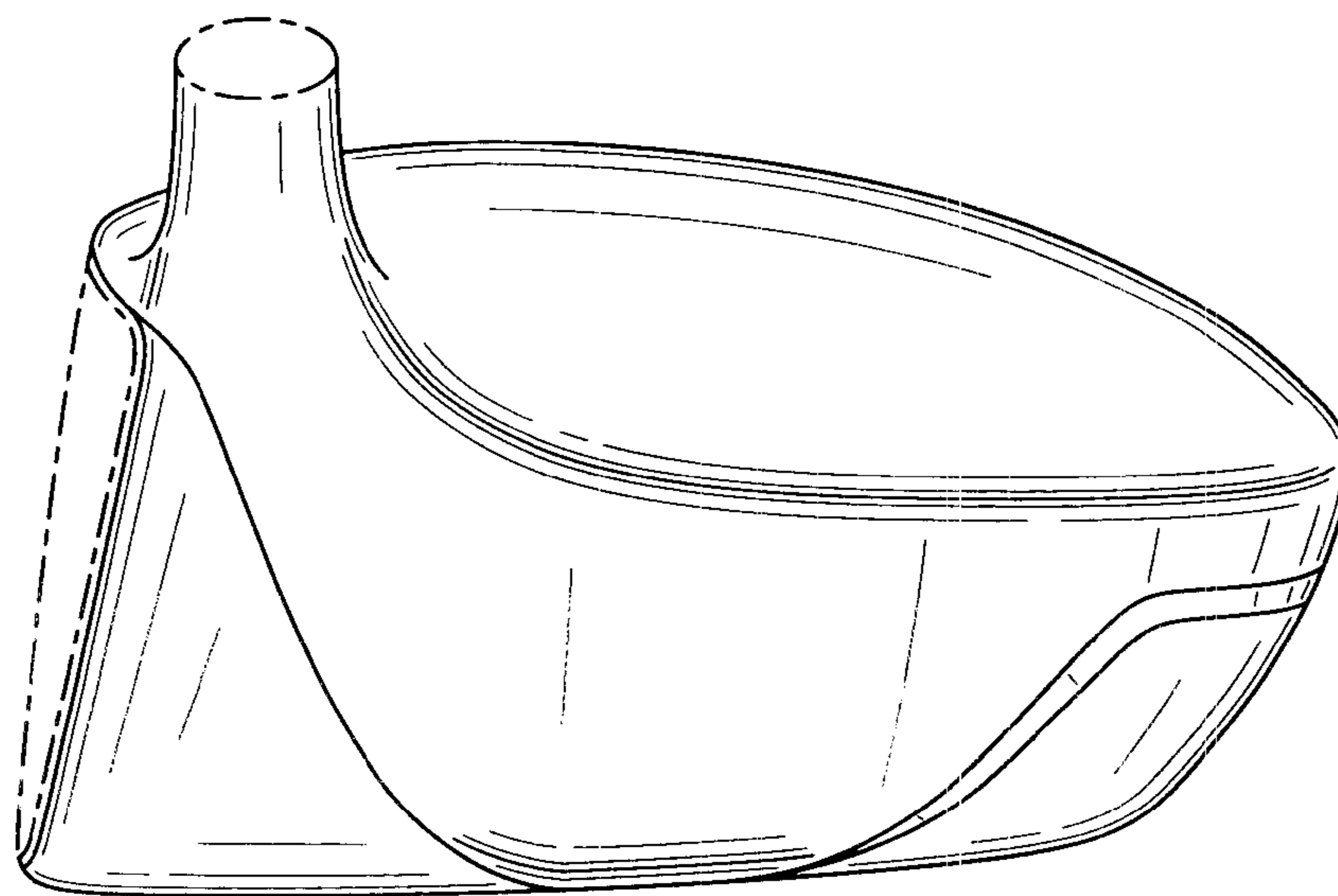

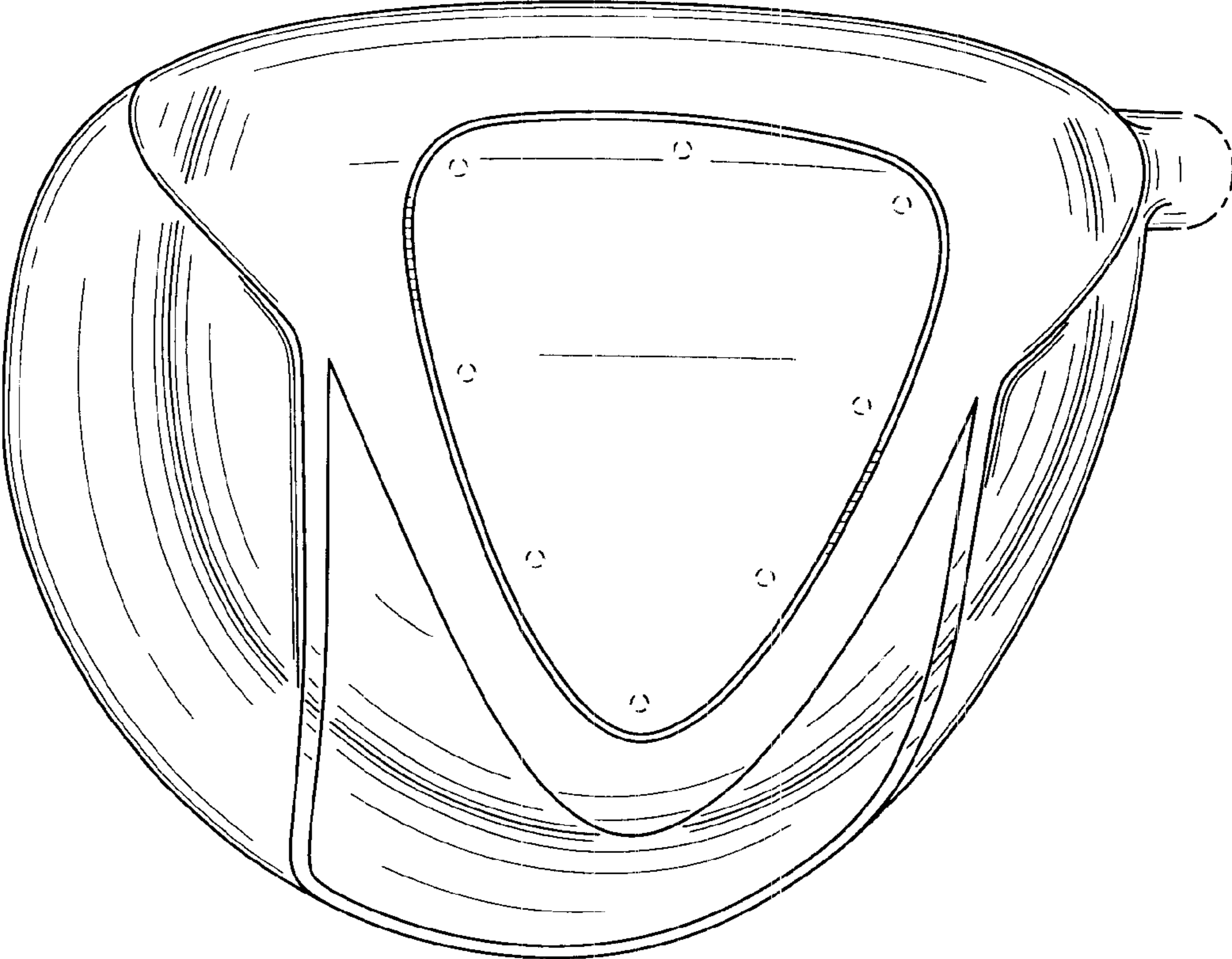

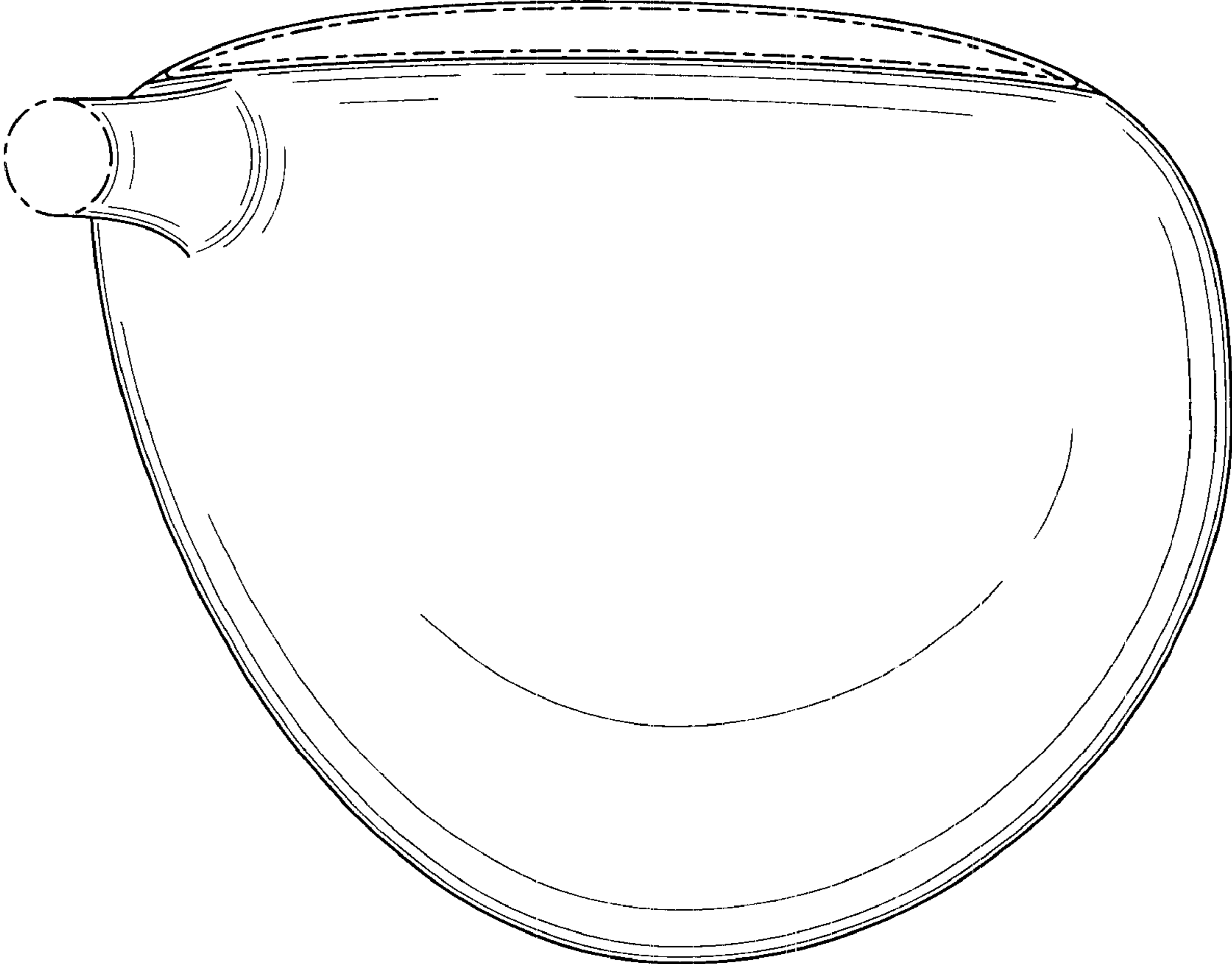
