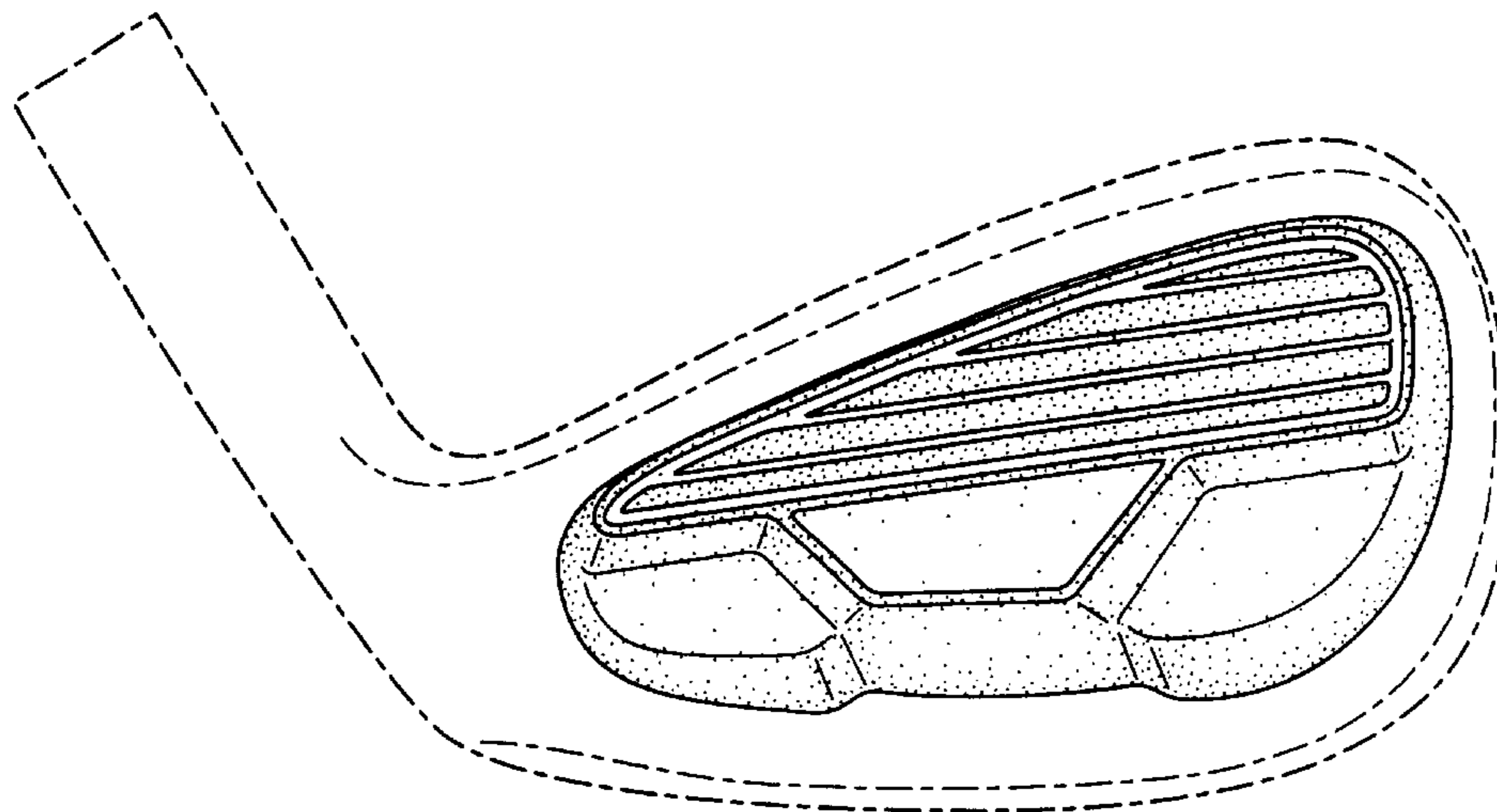
(57) **CLAIM**

The ornamental design for a portion of a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a portion of a golf club head showing my new design;

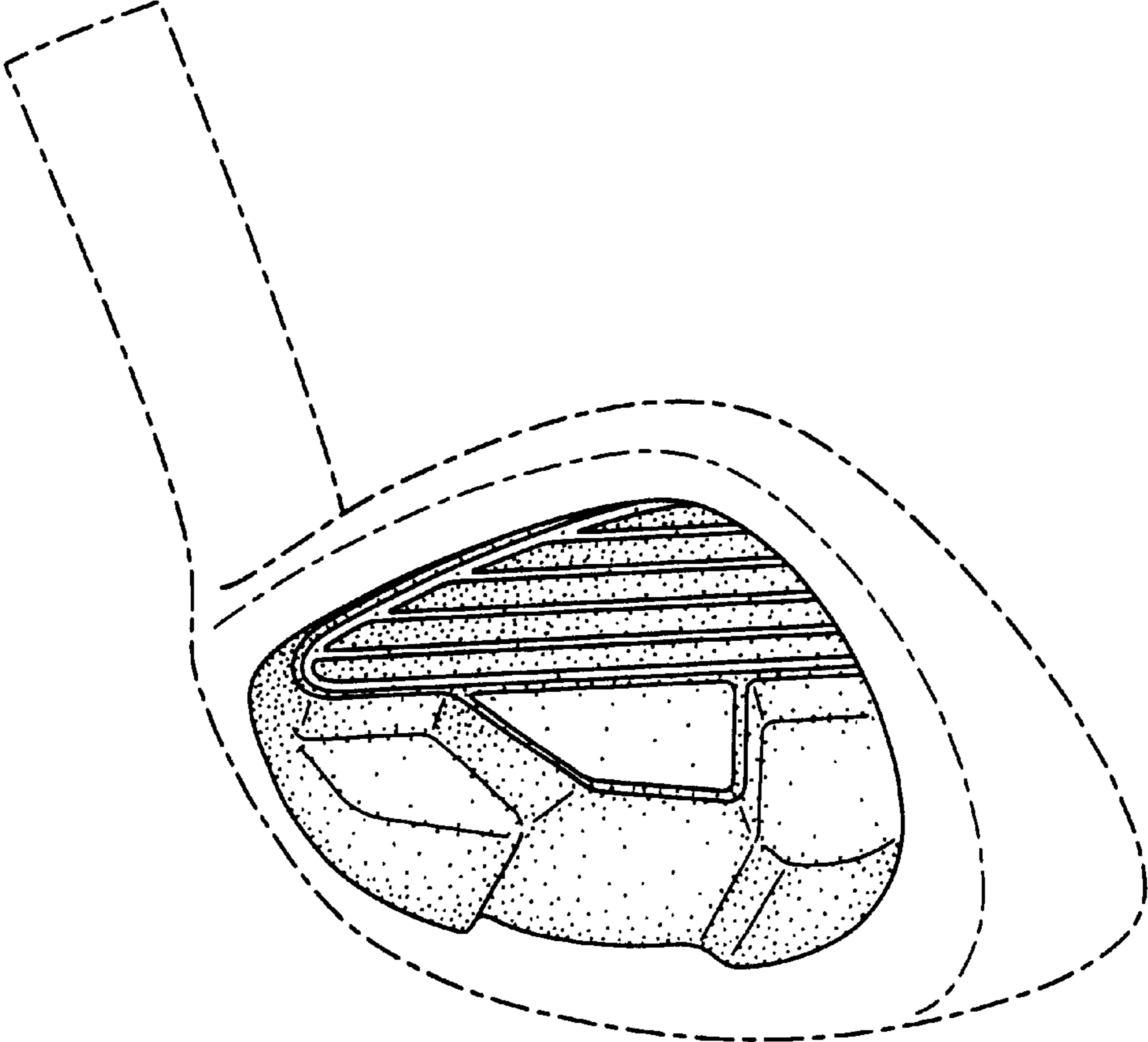

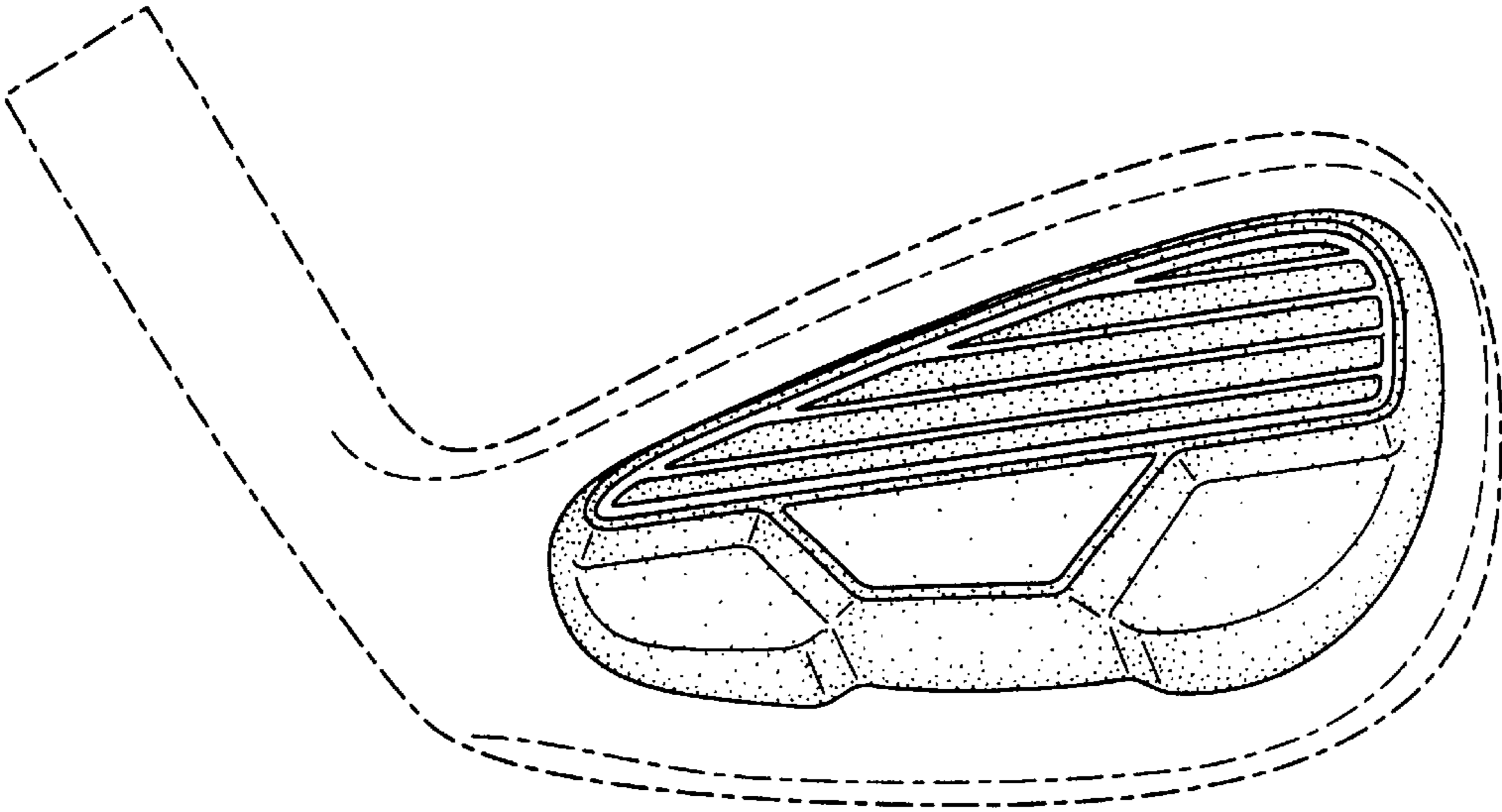

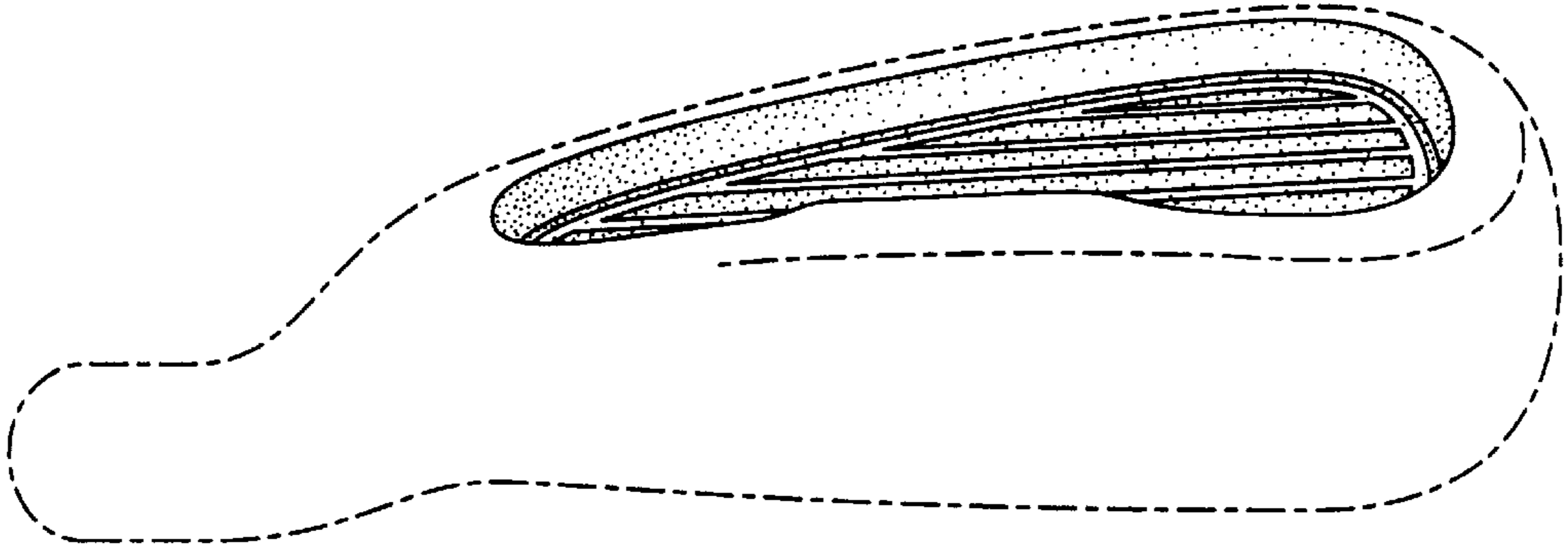
