(57) **CLAIM**

I claim the ornamental design for a pattern for absorbent garments, as shown and described.

**DESCRIPTION**

The FIGURE is a plan view of a pattern for absorbent garments showing my new design, the area within the broken lines representing a portion of the design that is repeated.
