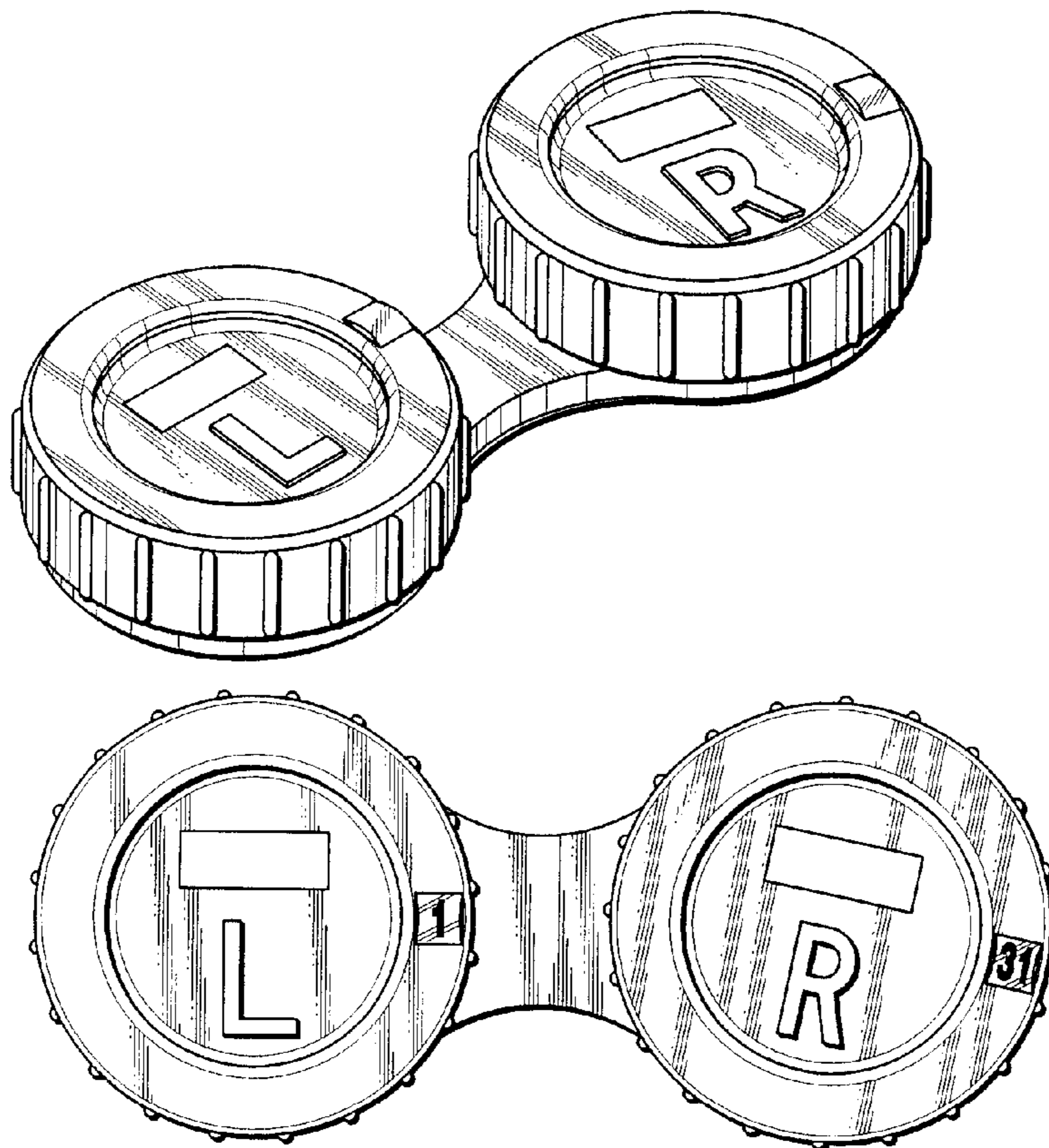

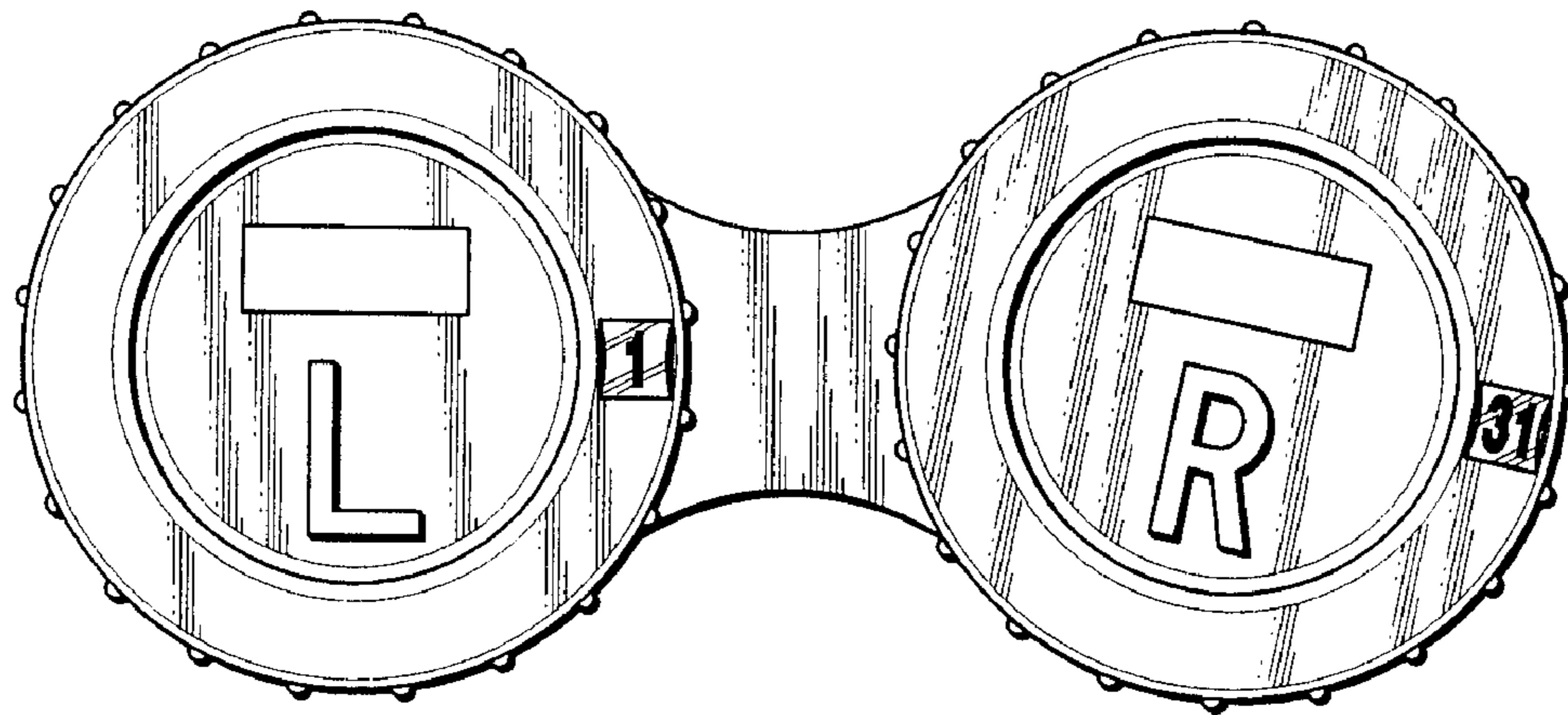
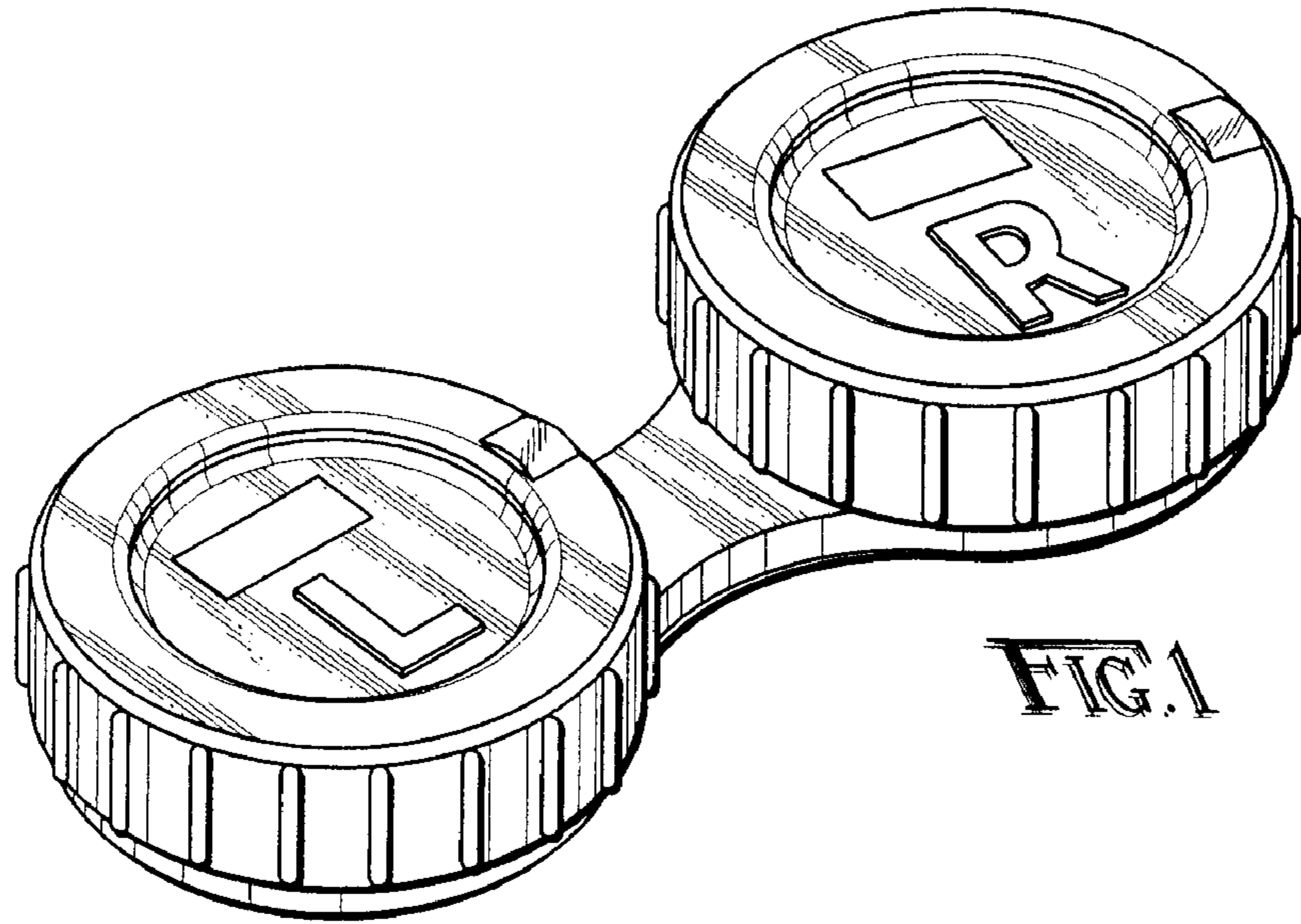
I claim the ornamental design for a contact lens holder having rotating caps with viewing lenses and number indicia for tracking days of usage, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a contact lens holder having rotating caps with viewing lenses and number indicia for tracking days of usage, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof, the rear being a mirror image;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof; and,
FIG. 6 is a bottom plan view thereof.

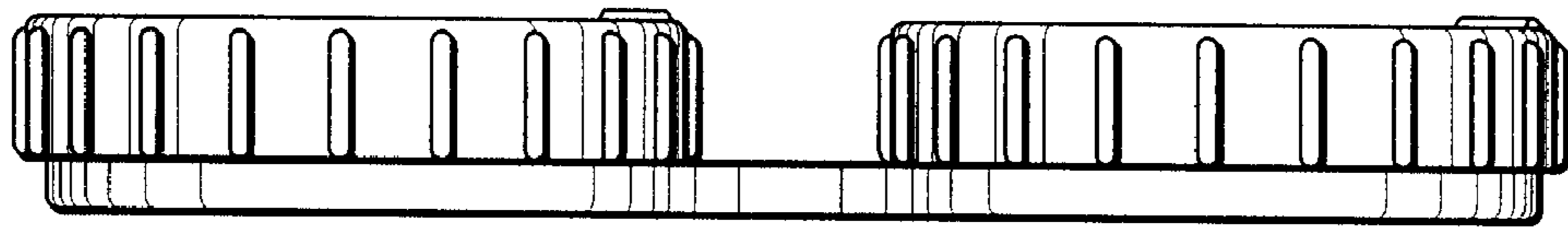

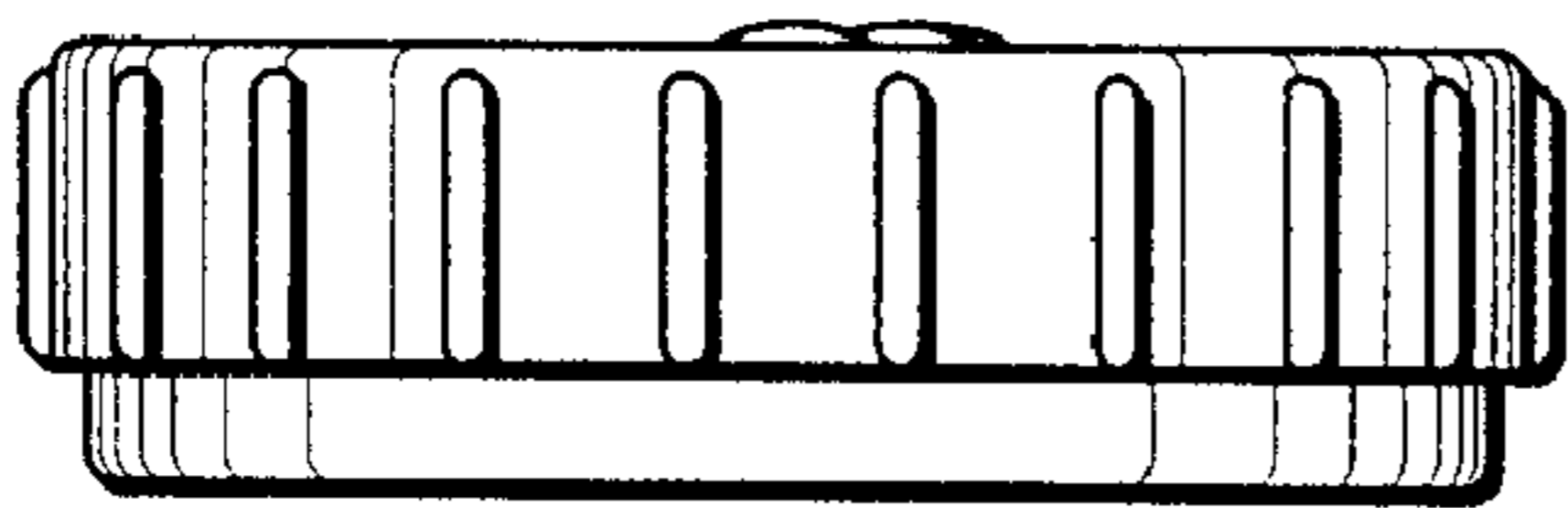

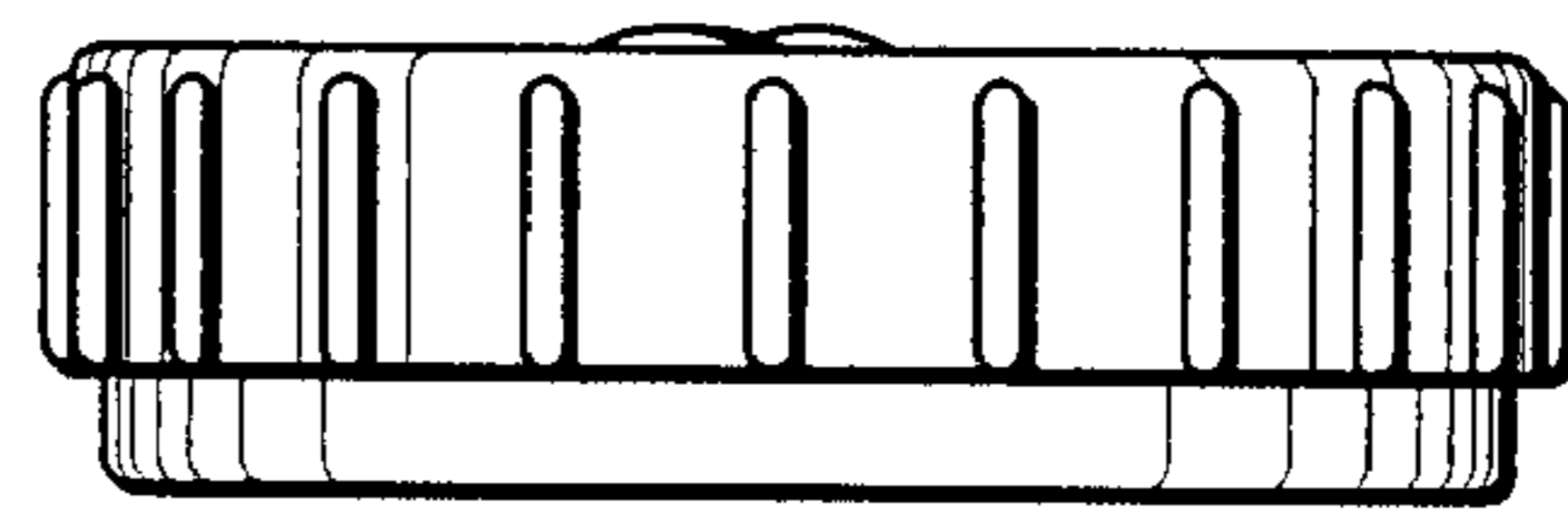

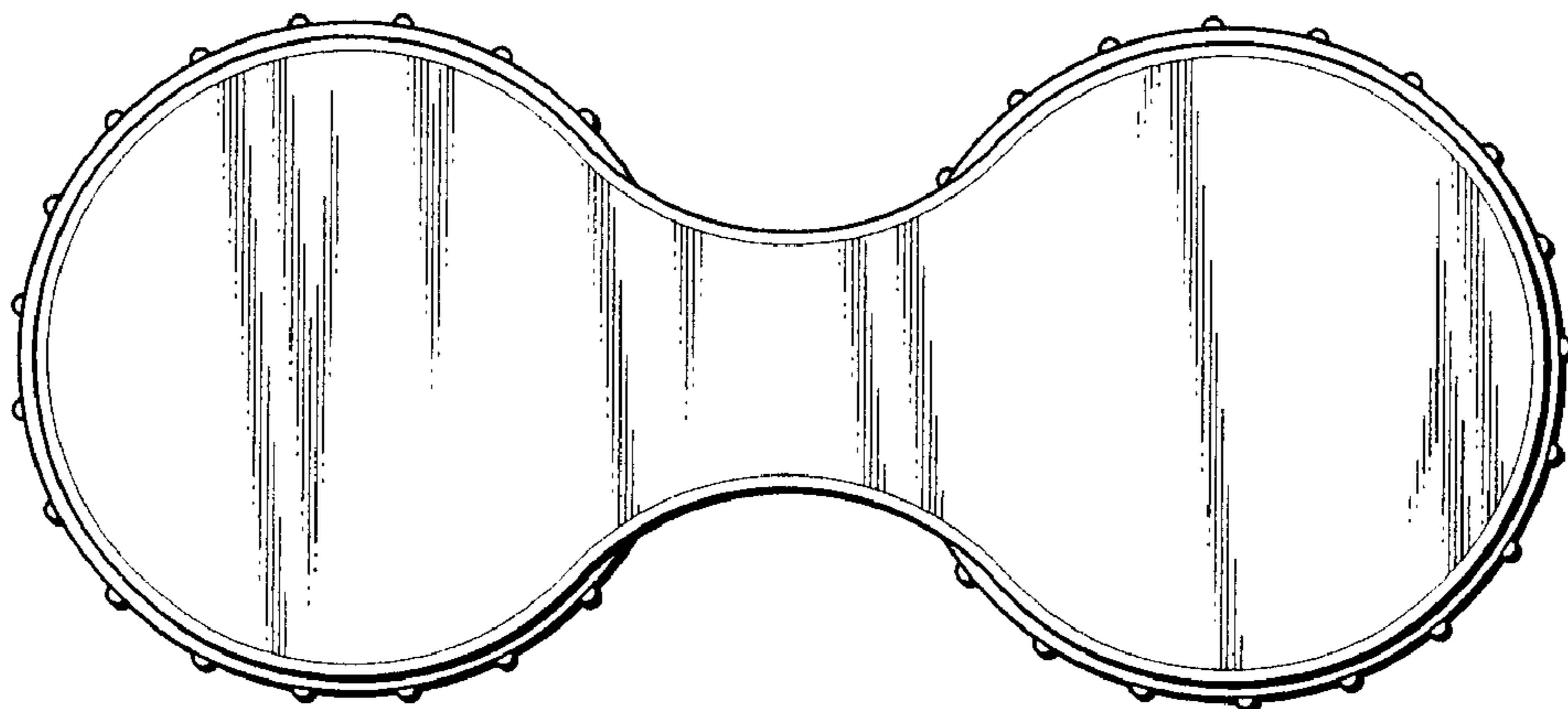
