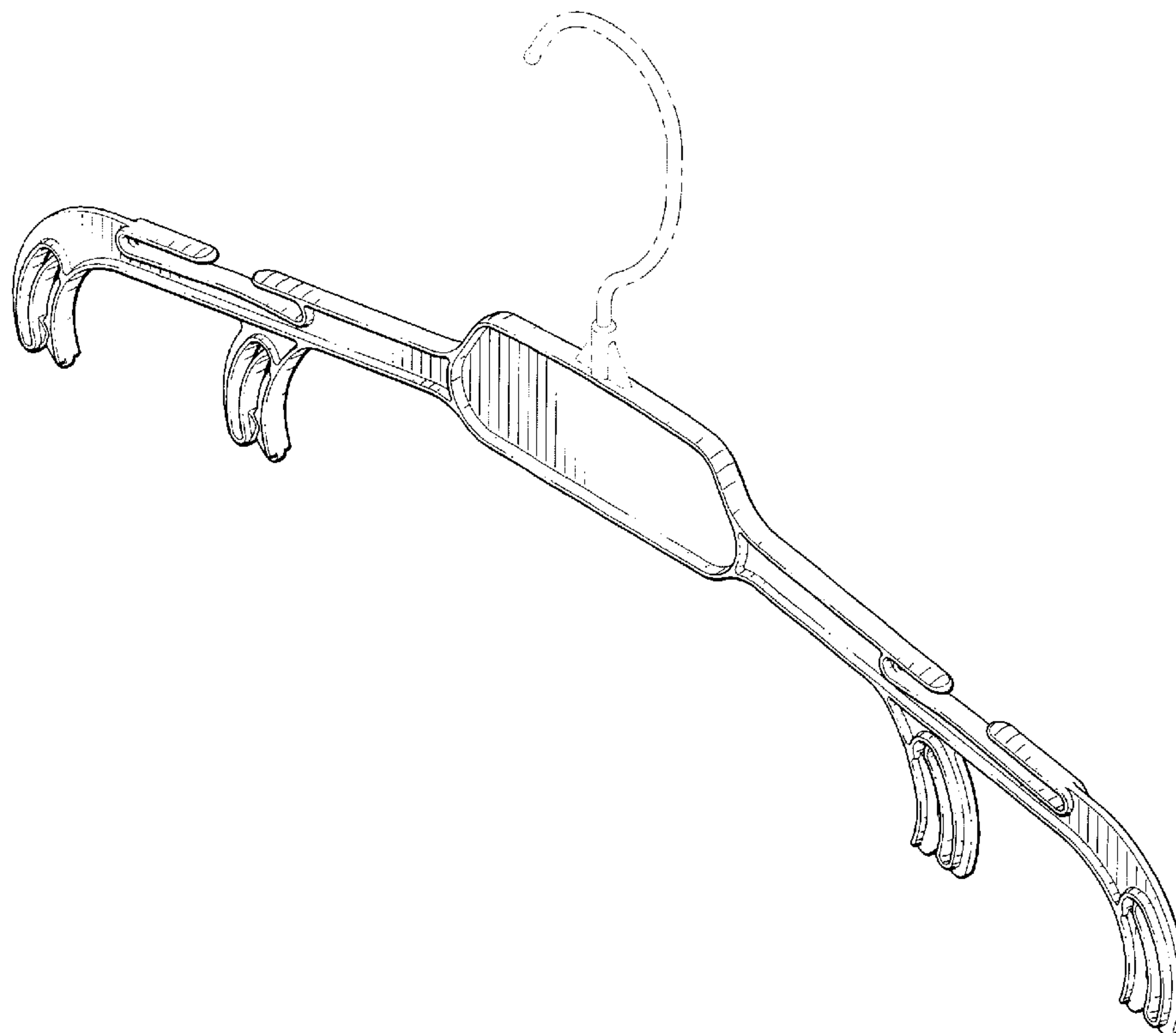

DESCRIPTION

FIG. 1 is a perspective view of a swimwear hanger, the opposite view being a mirror image thereof; and, FIG. 2 is a front elevation view of the swimwear hanger, the rear elevation view being a mirror image thereof. The broken lines shown in FIGS. 1 and 2 are for illustrative purposes only and form no part of the claimed design.

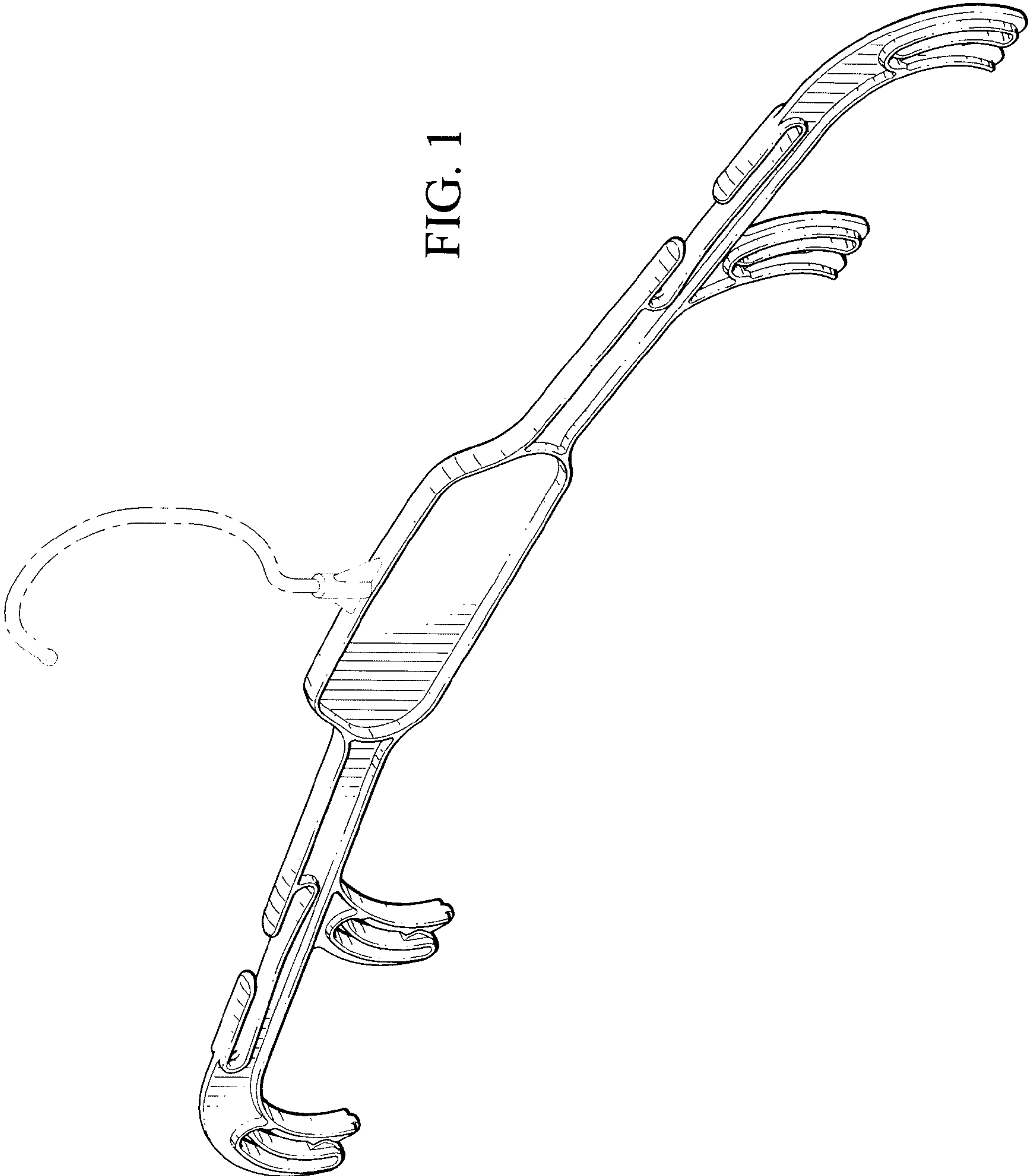

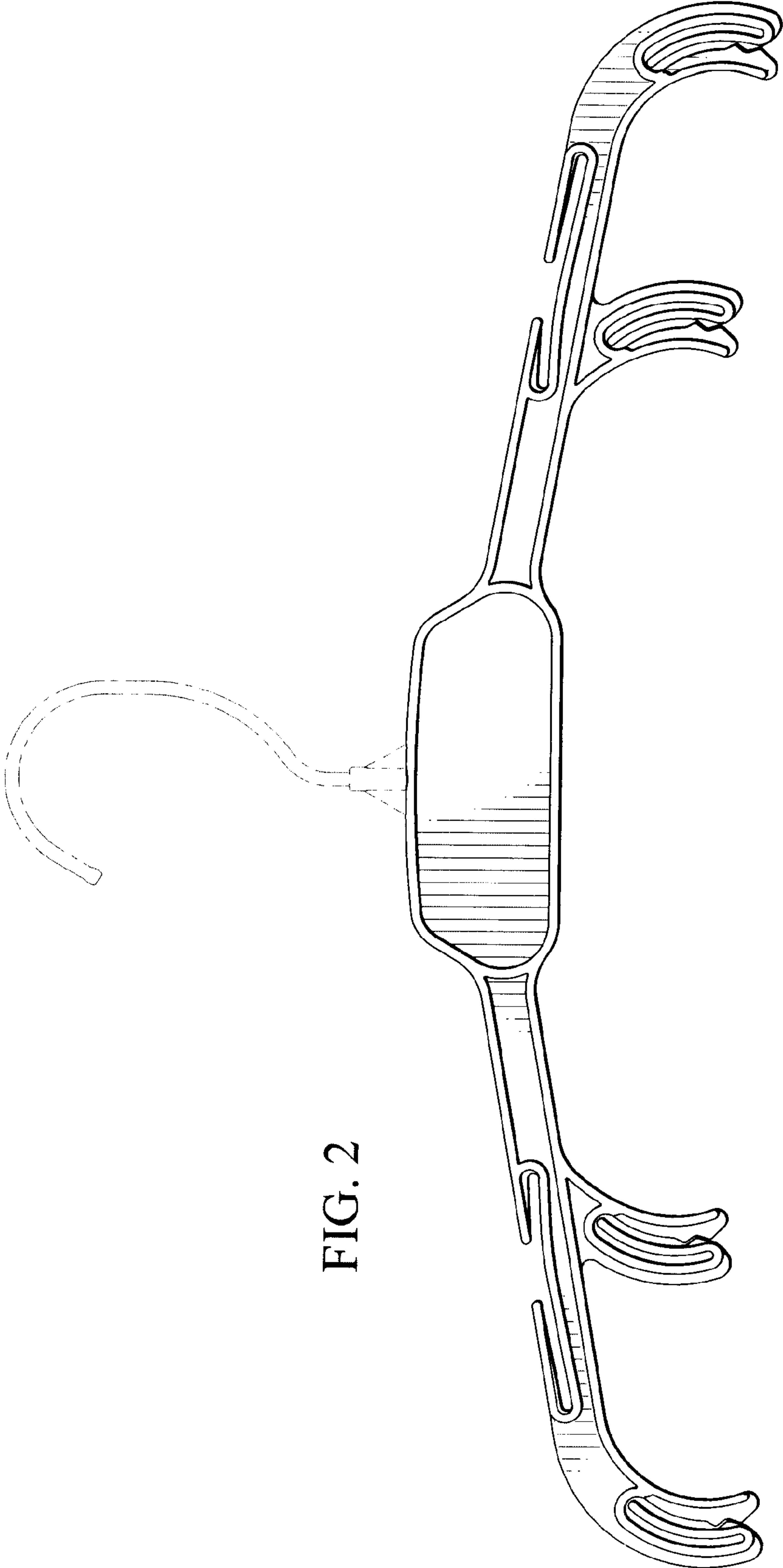
