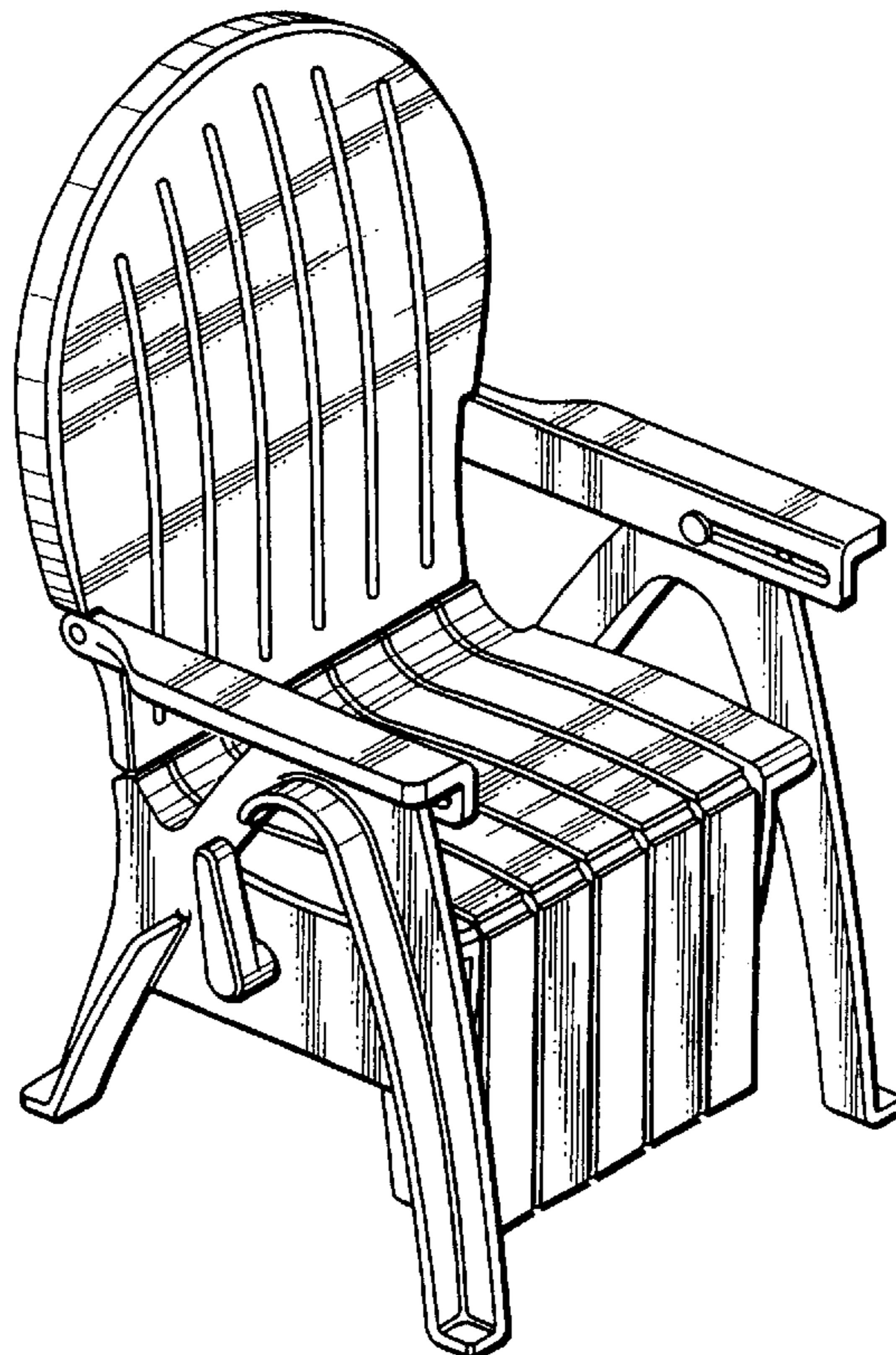
(57) **CLAIM**

We claim the ornamental design for a reclinable patio chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a reclinable patio chair showing our new design;
 FIG. 2 is a right side elevational view thereof; the left side elevational view, absent the handle, being a mirror image thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a rear elevational view thereof; and,
 FIG. 6 is a bottom plan view thereof.

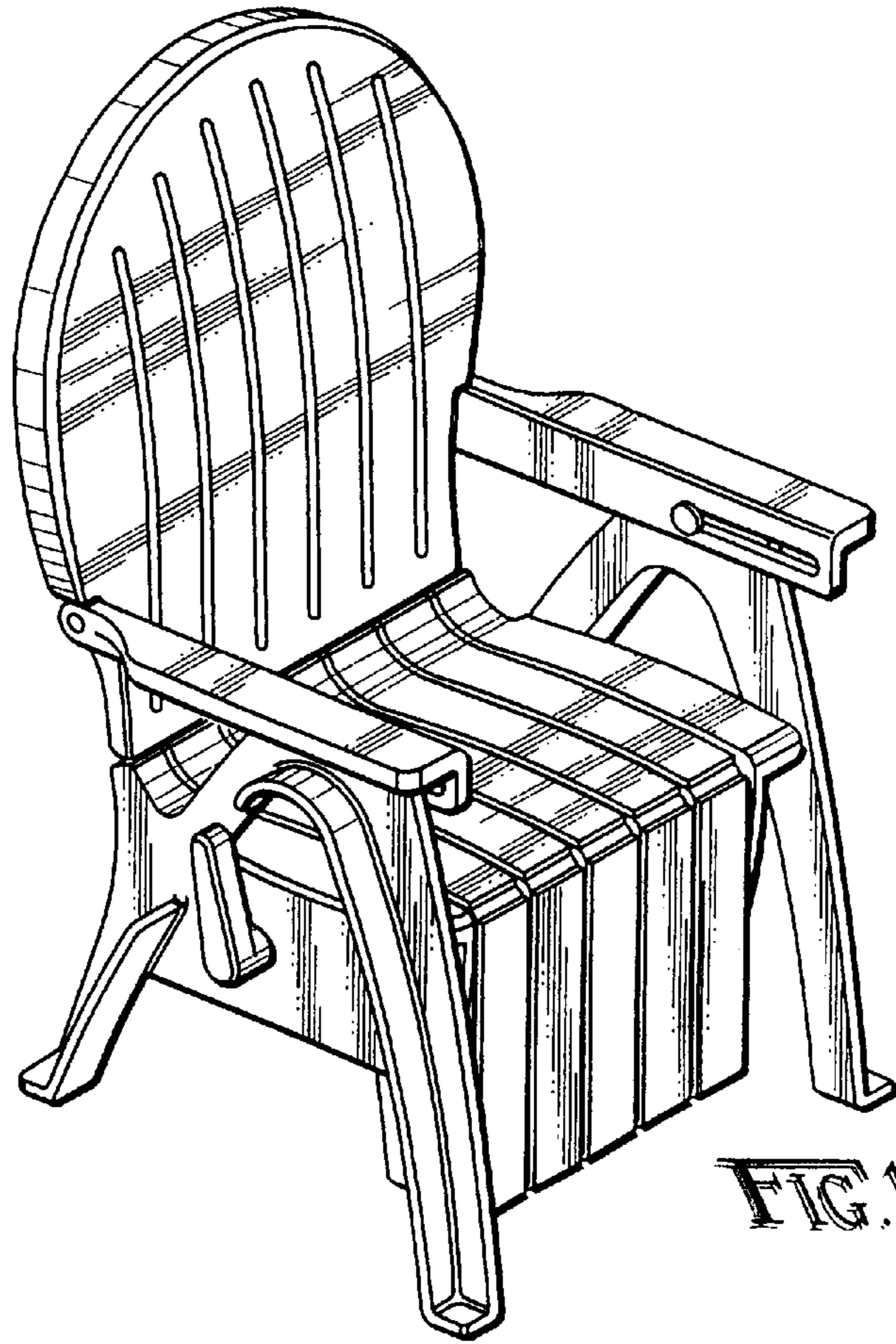

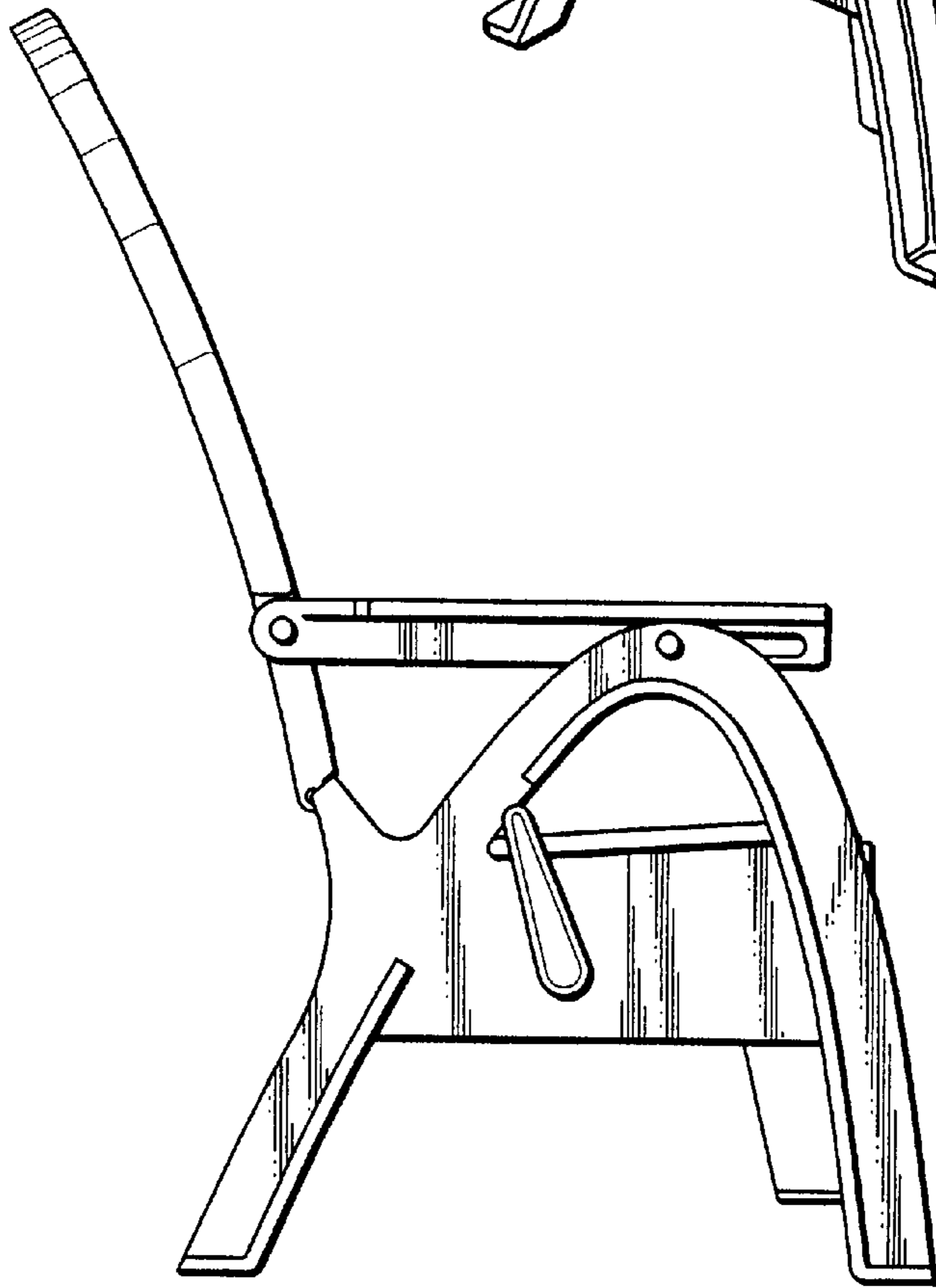

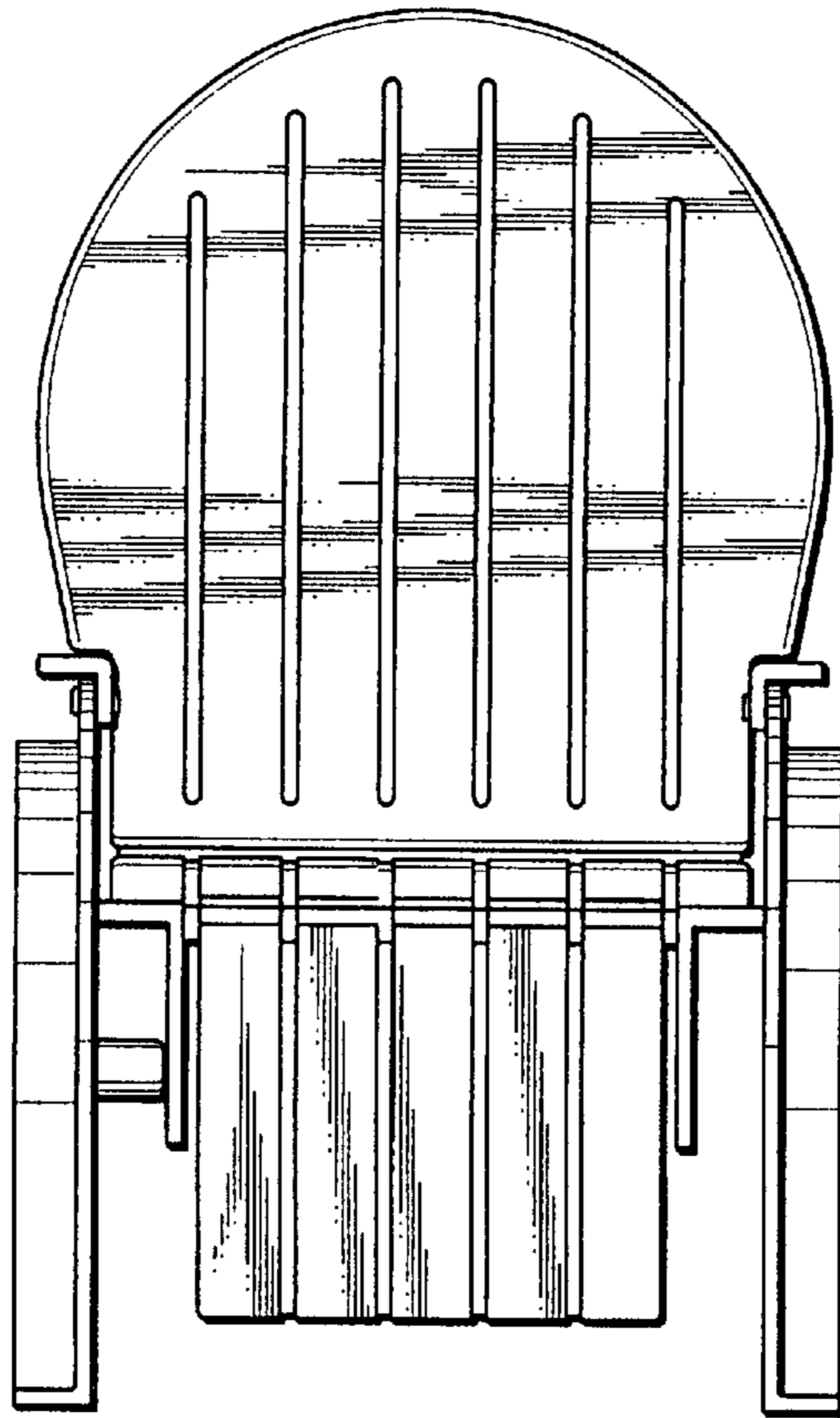

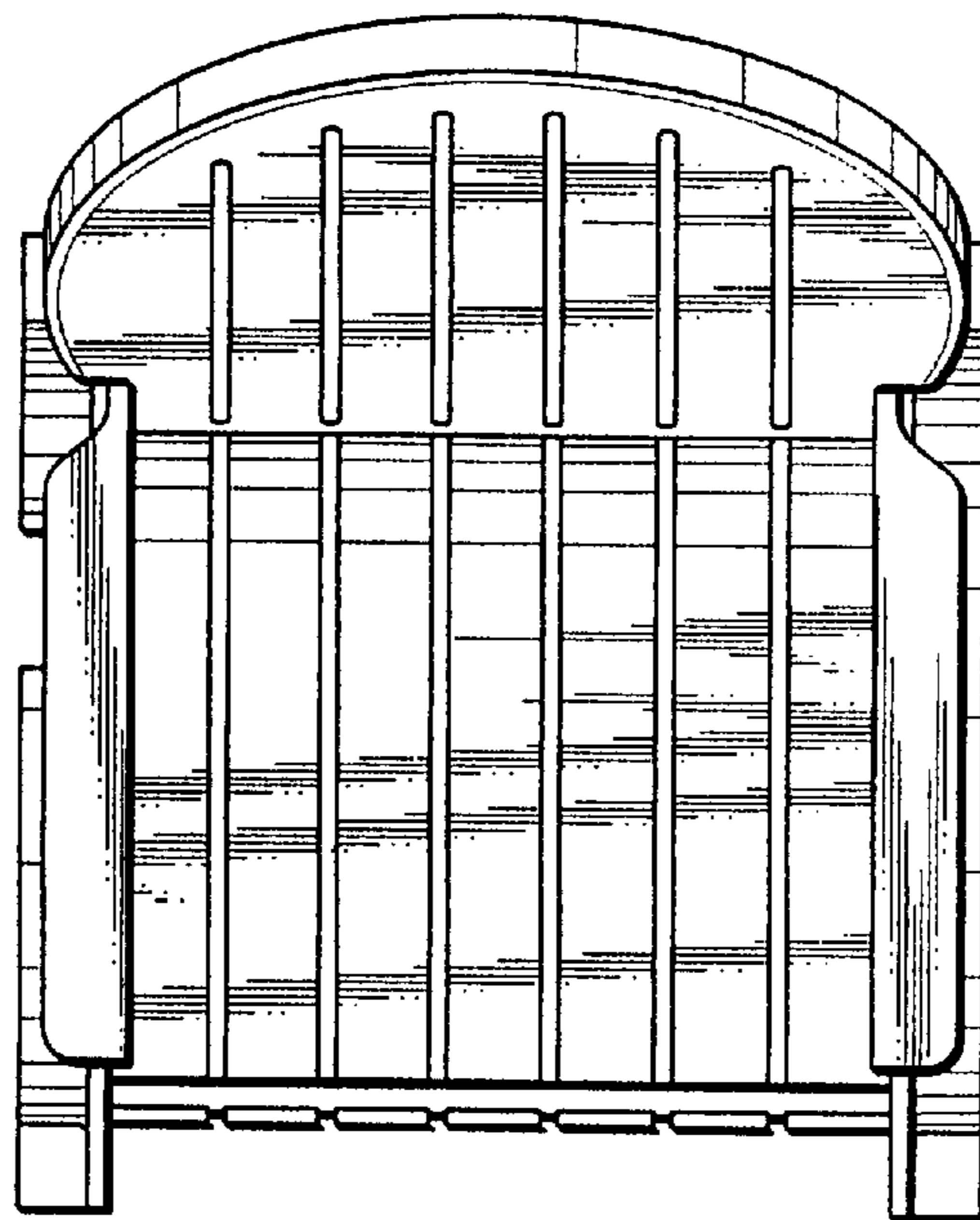

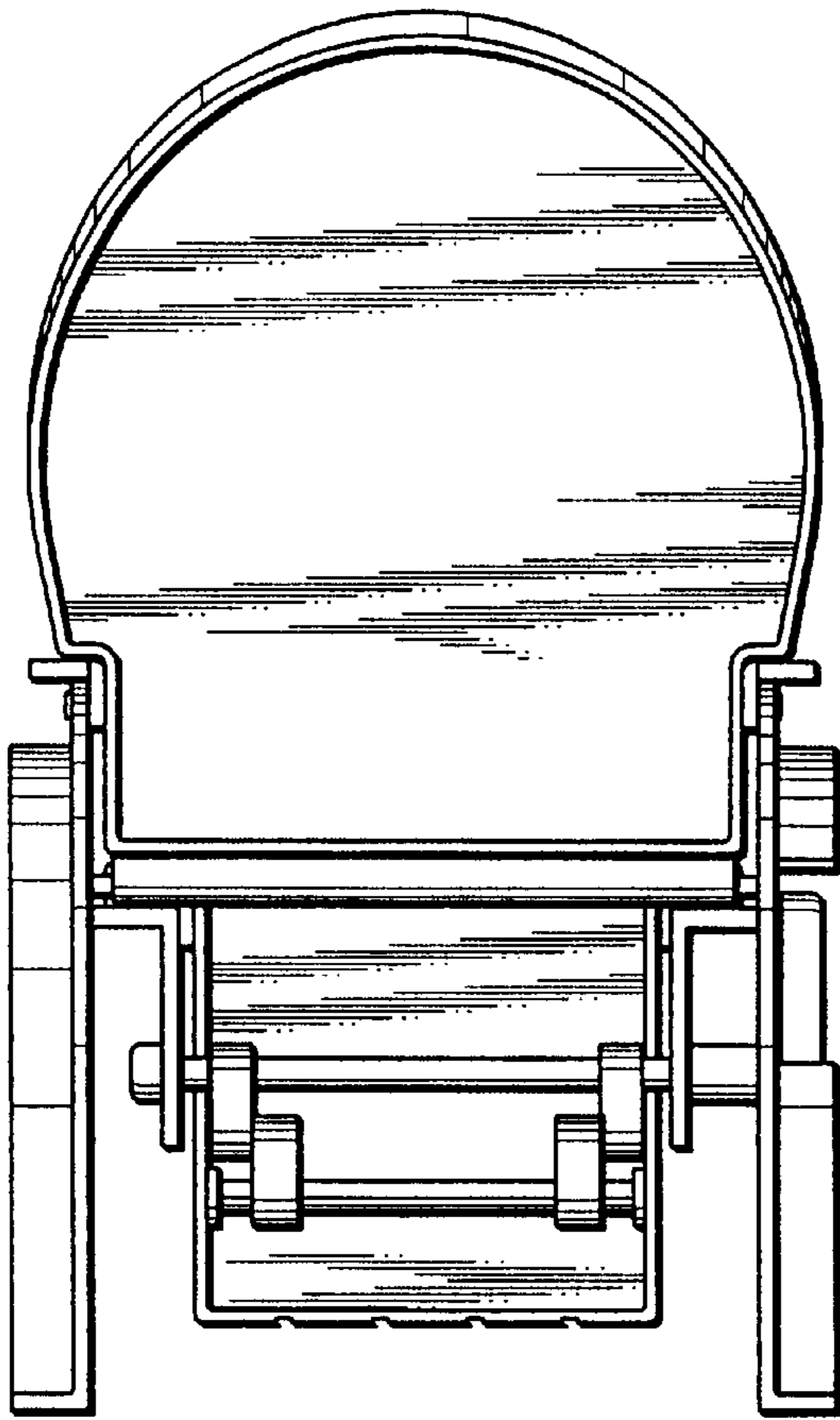

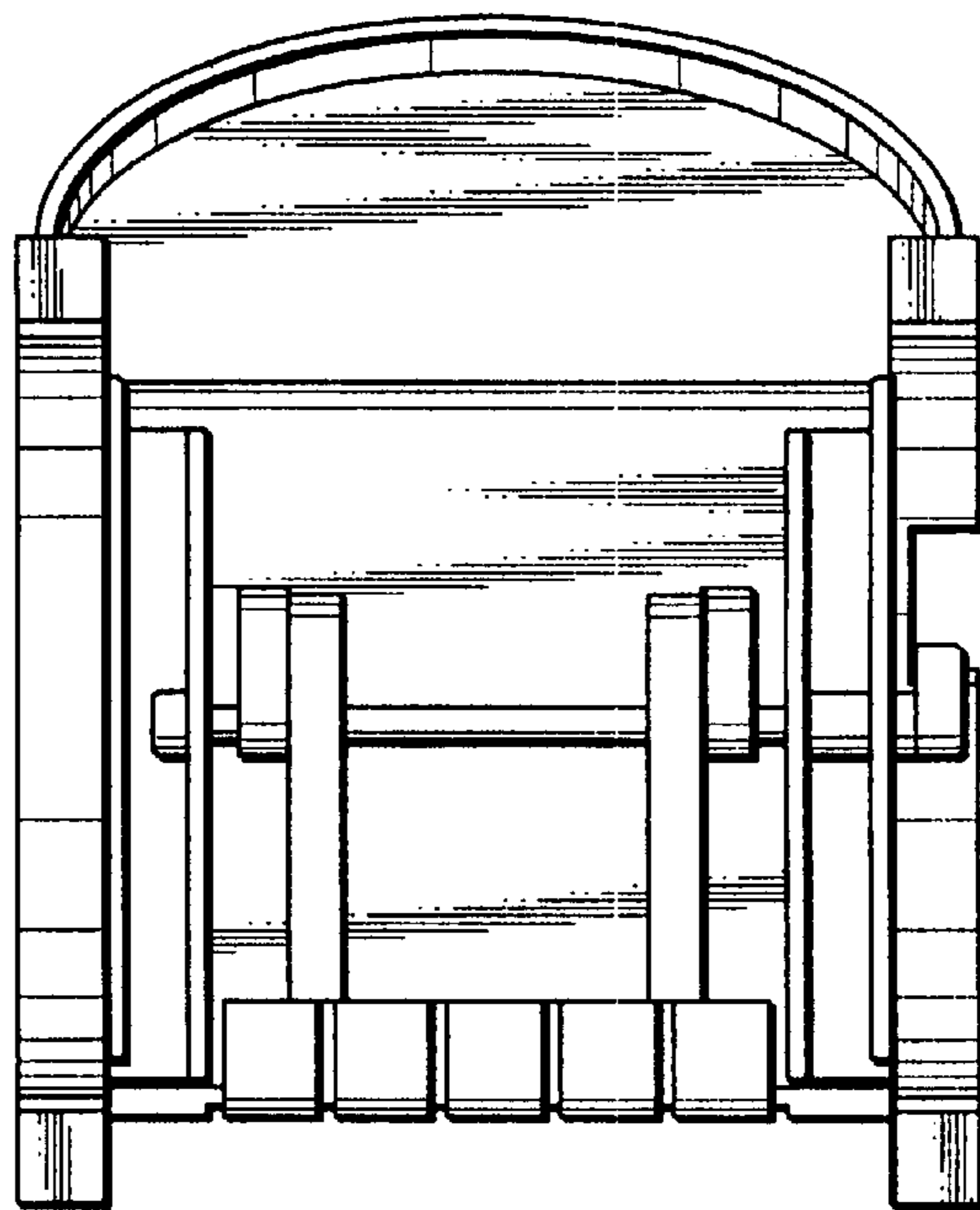
