(57) **CLAIM**

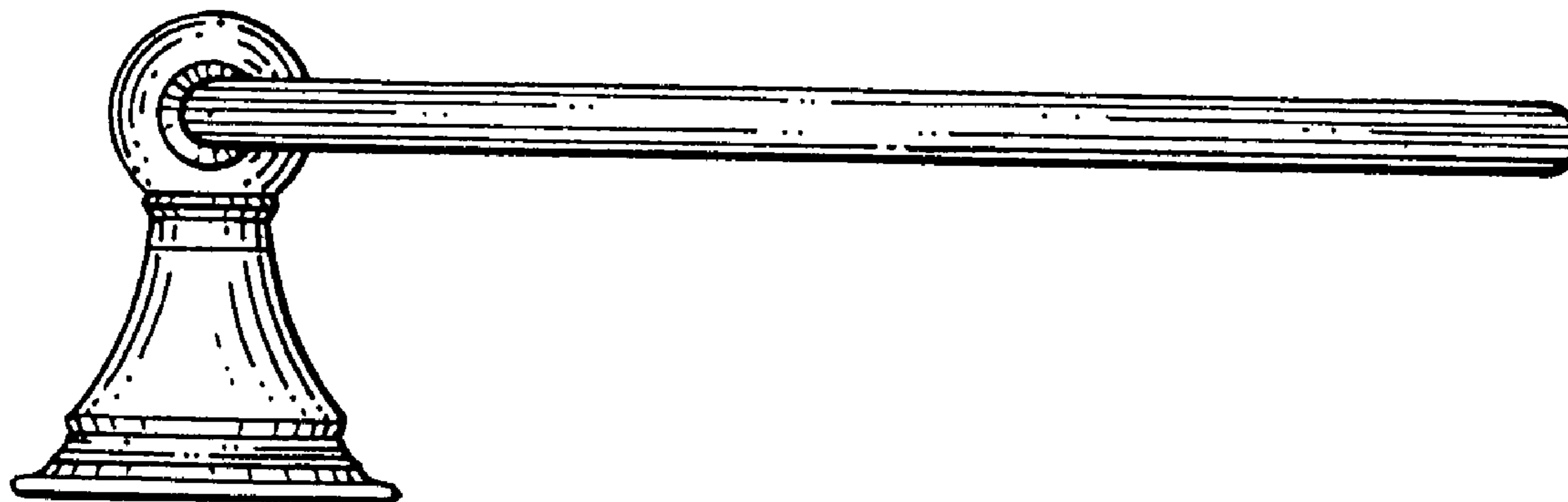
The ornamental design for the towel rail for bathroom, as shown and described.

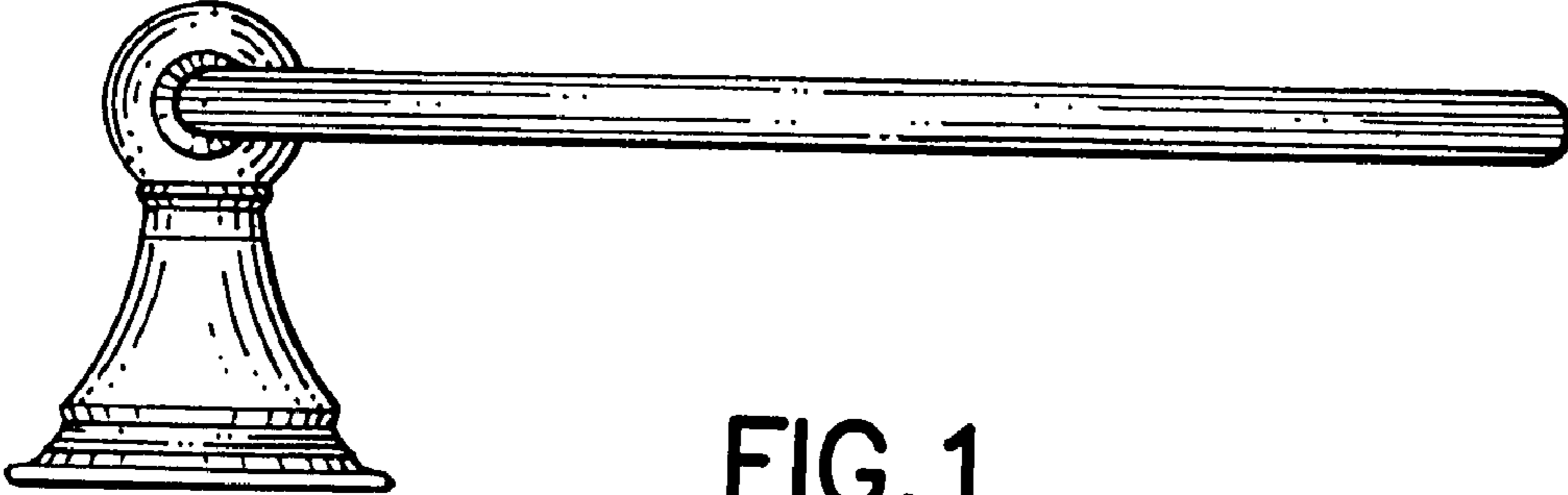

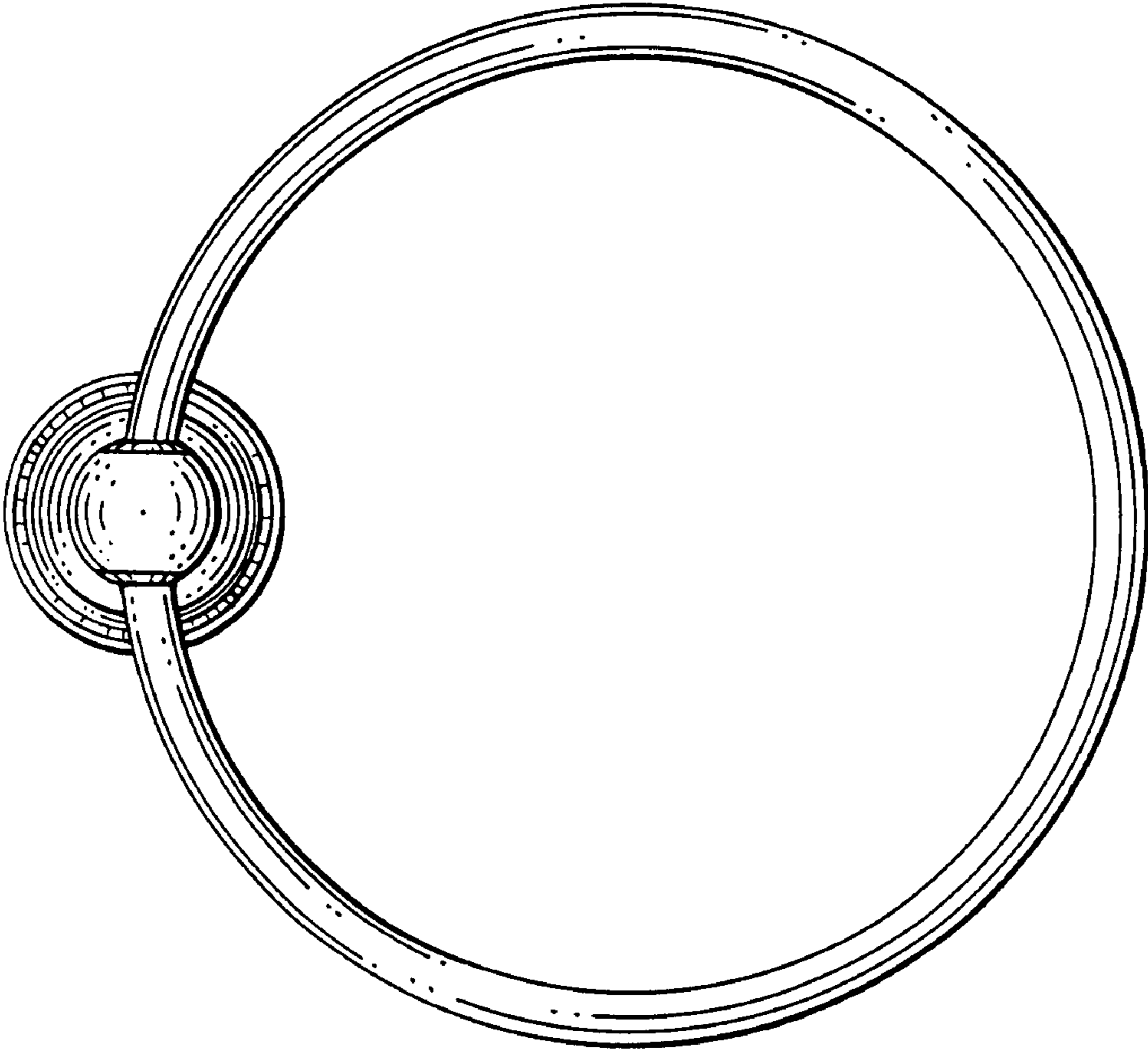

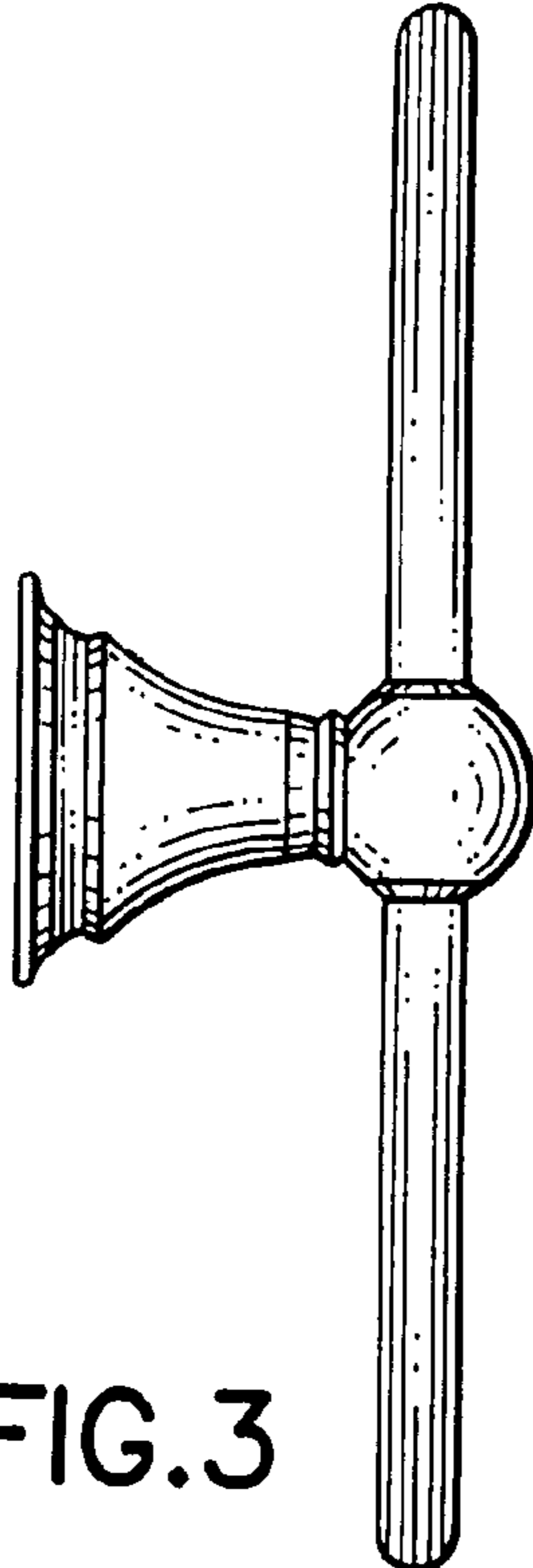

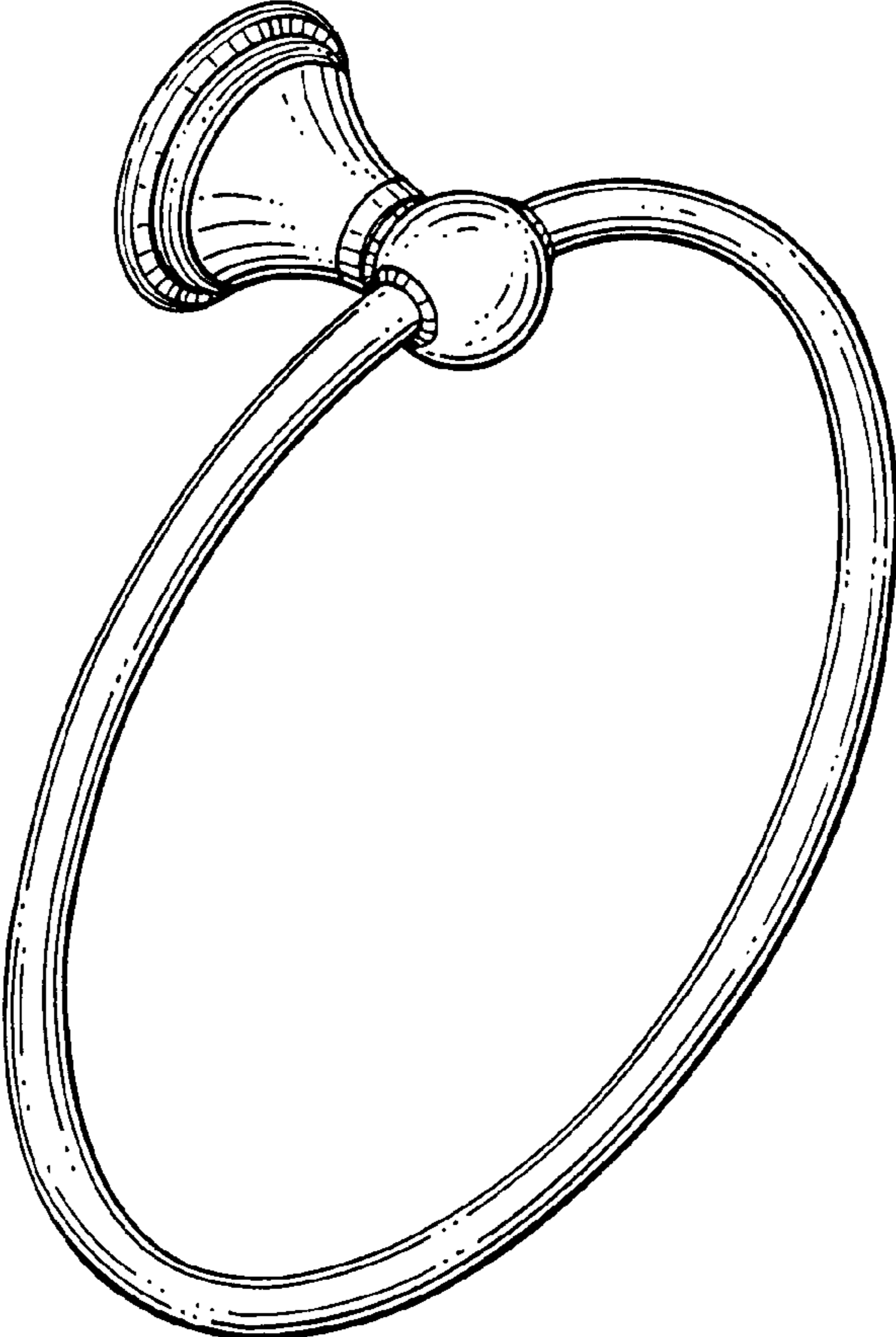
