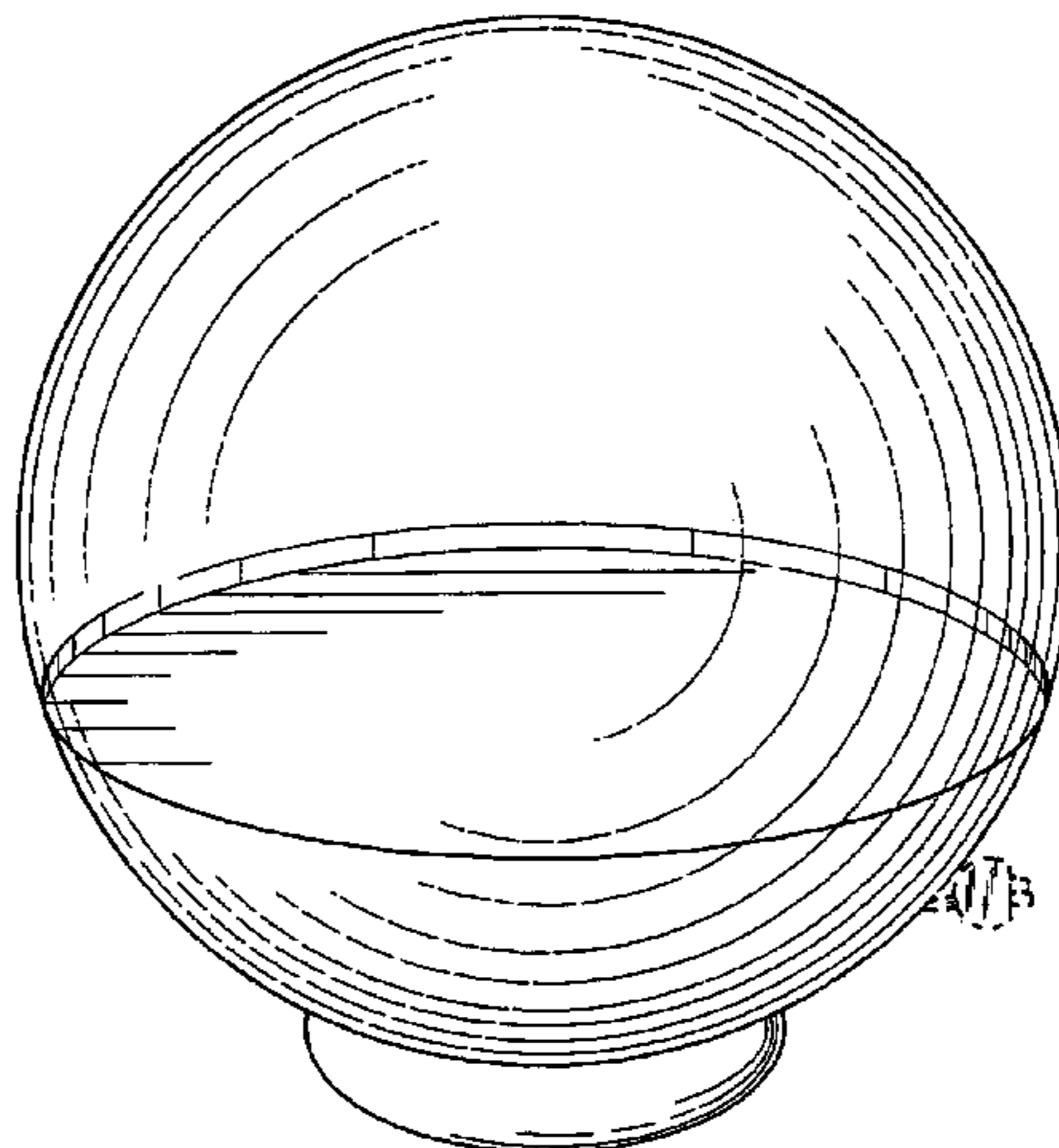
(57) **CLAIM**

I claim the ornamental design for a popcorn popper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a popcorn popper, showing my design;
FIG. 2 is a front side elevation view thereof;
FIG. 3 is a back side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The top portion of the popcorn popper is transparent.
The broken line showing the receptacle plug attached in FIGS. 1-4 and 7 is for illustrative purposes only and forms no part of the claimed design.

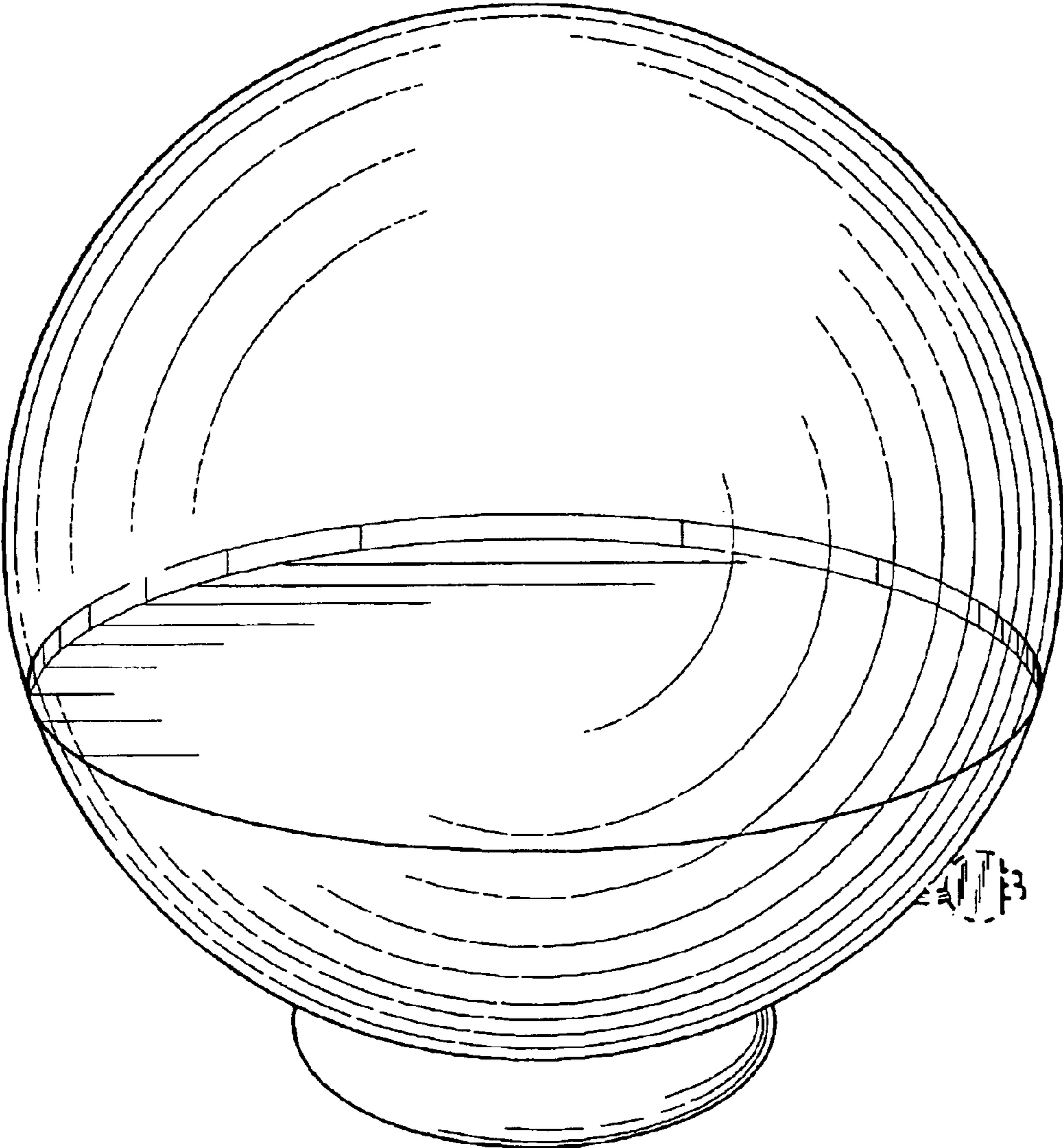

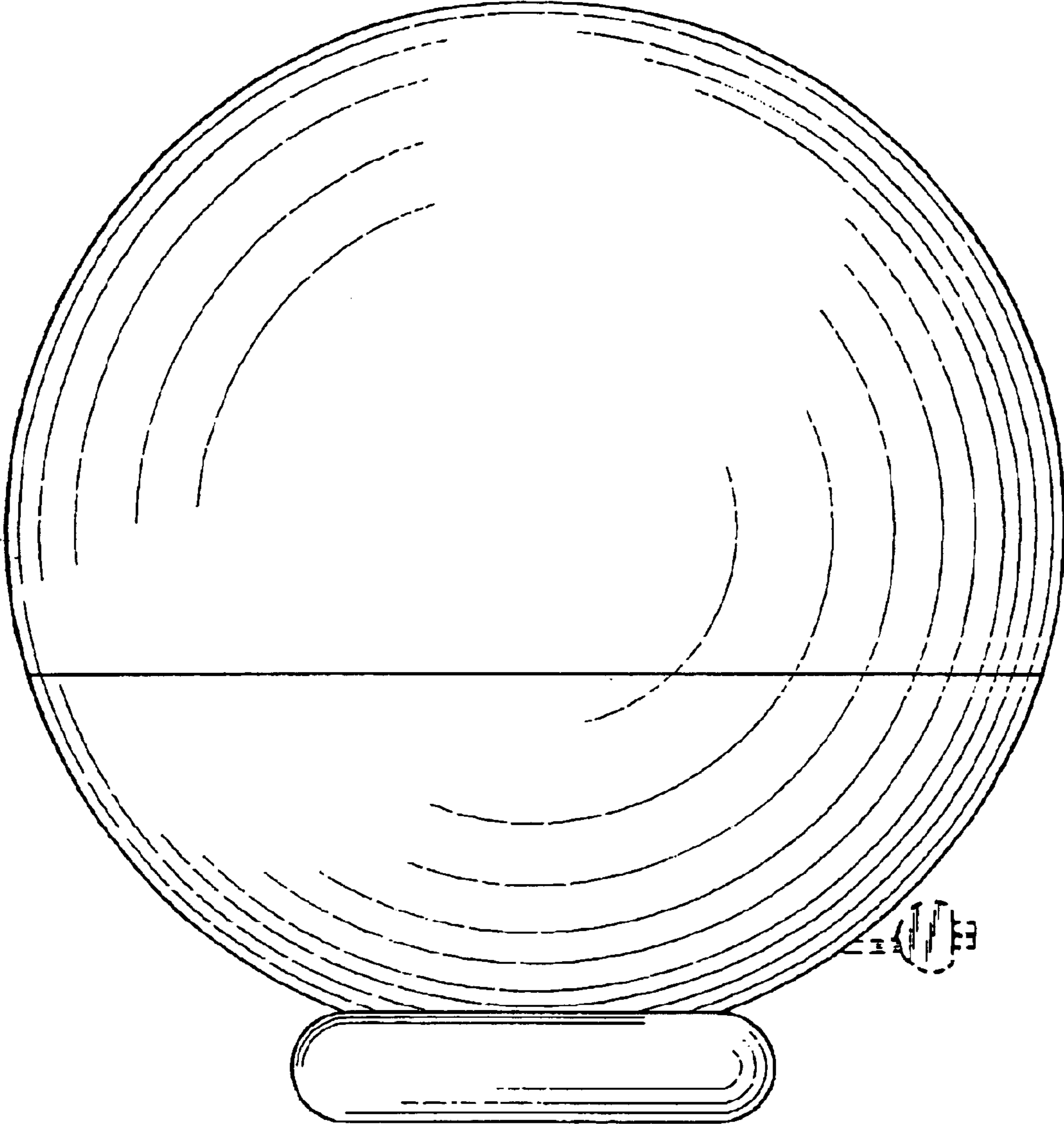

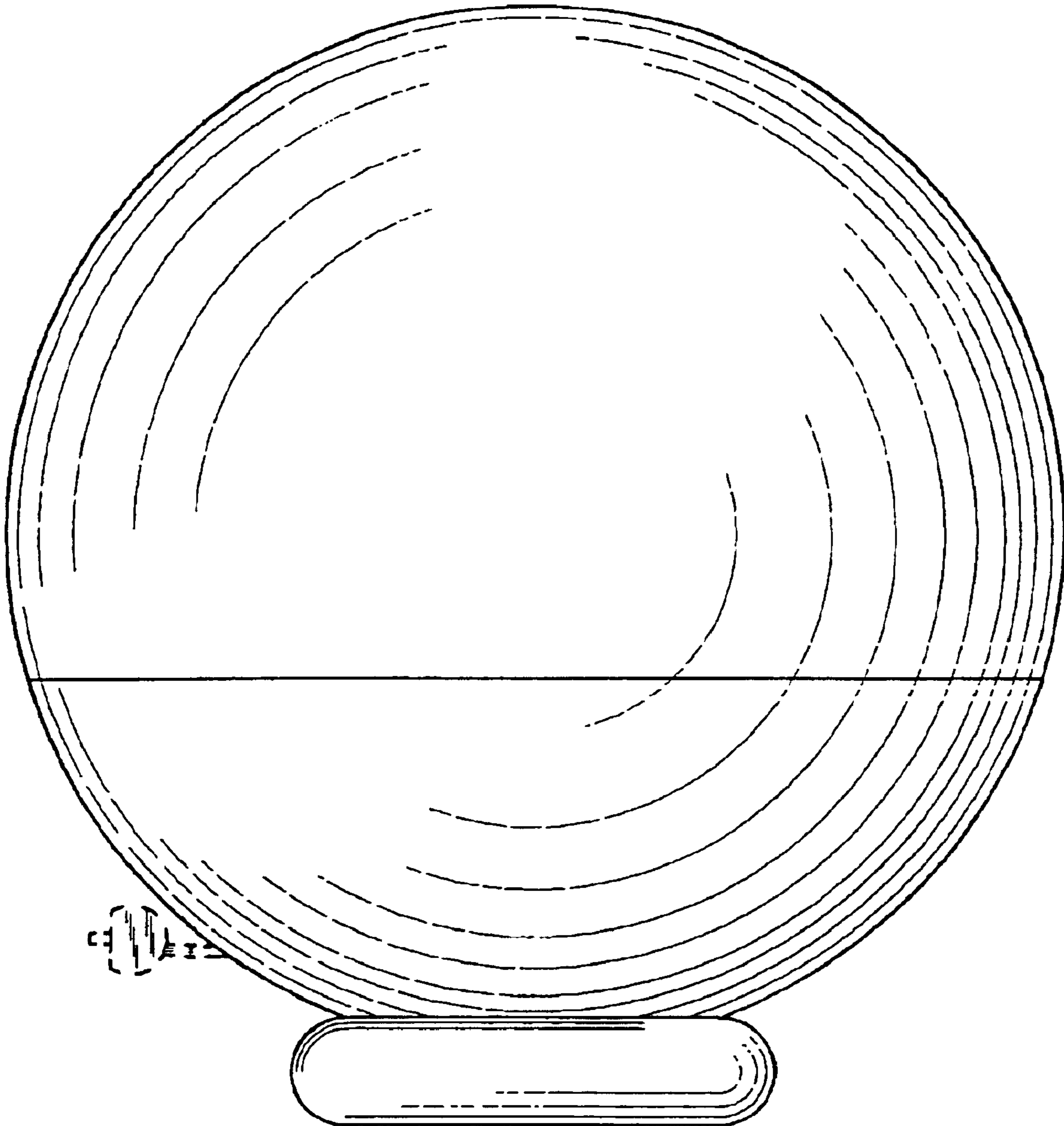

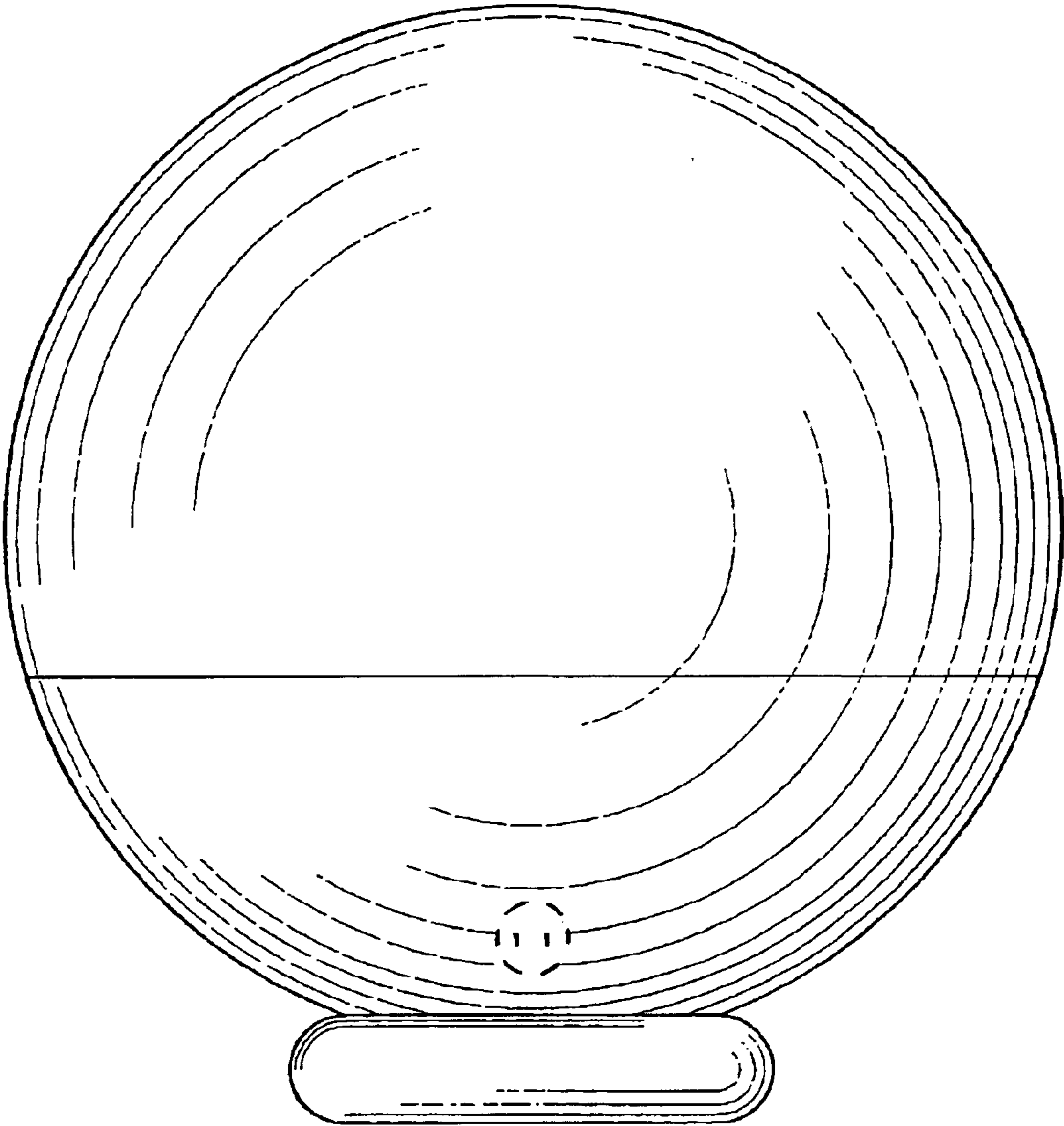

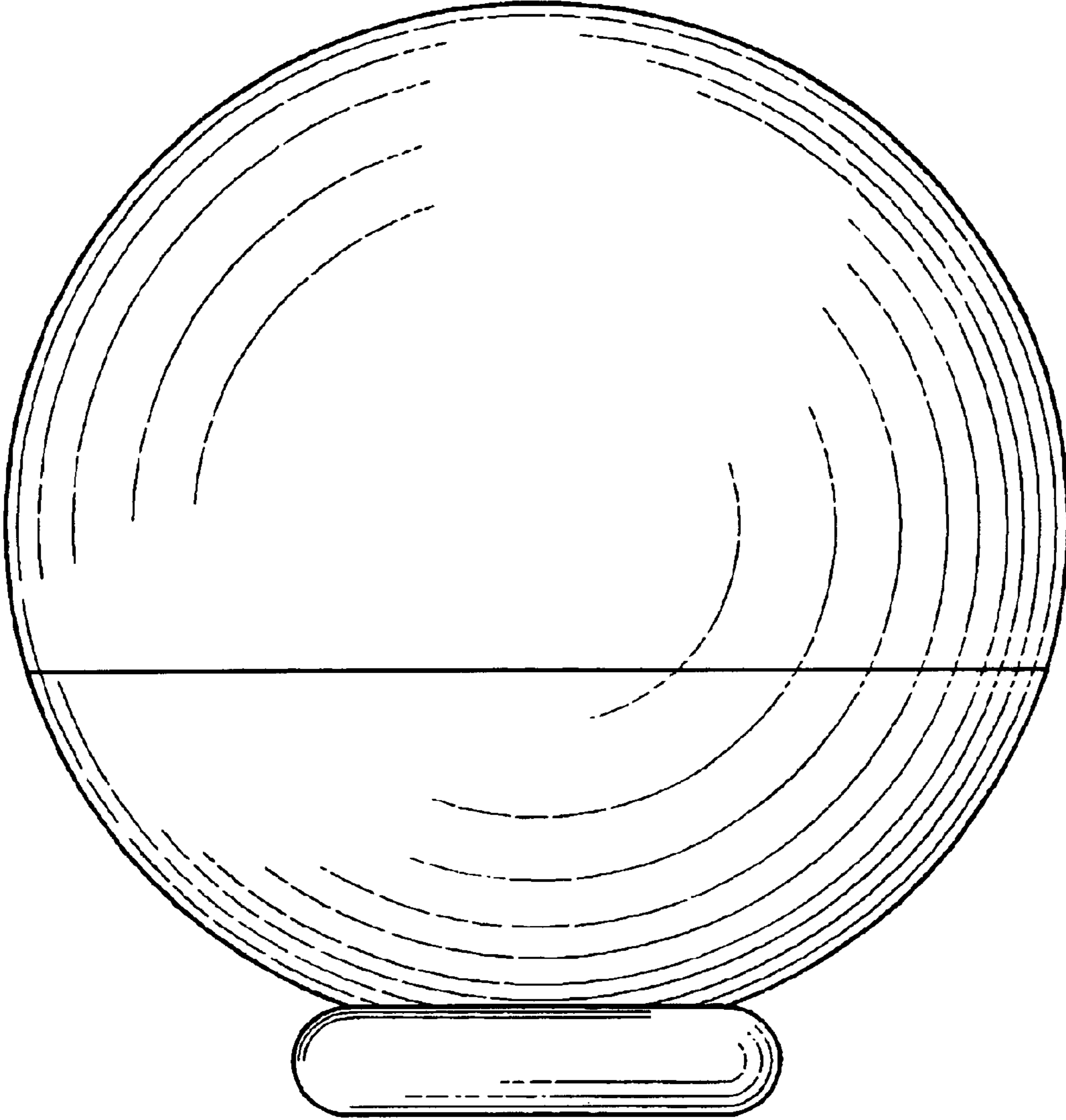

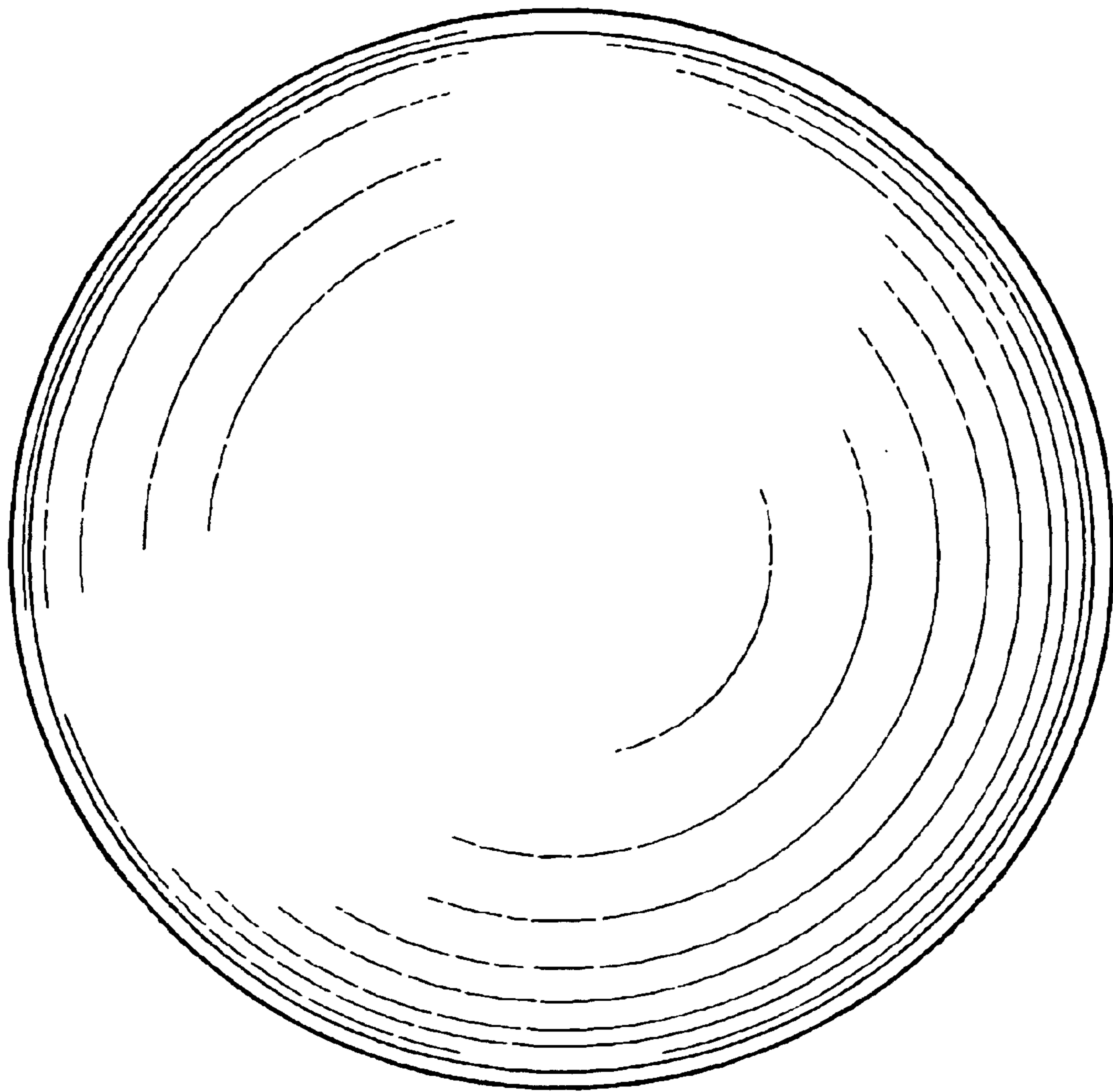

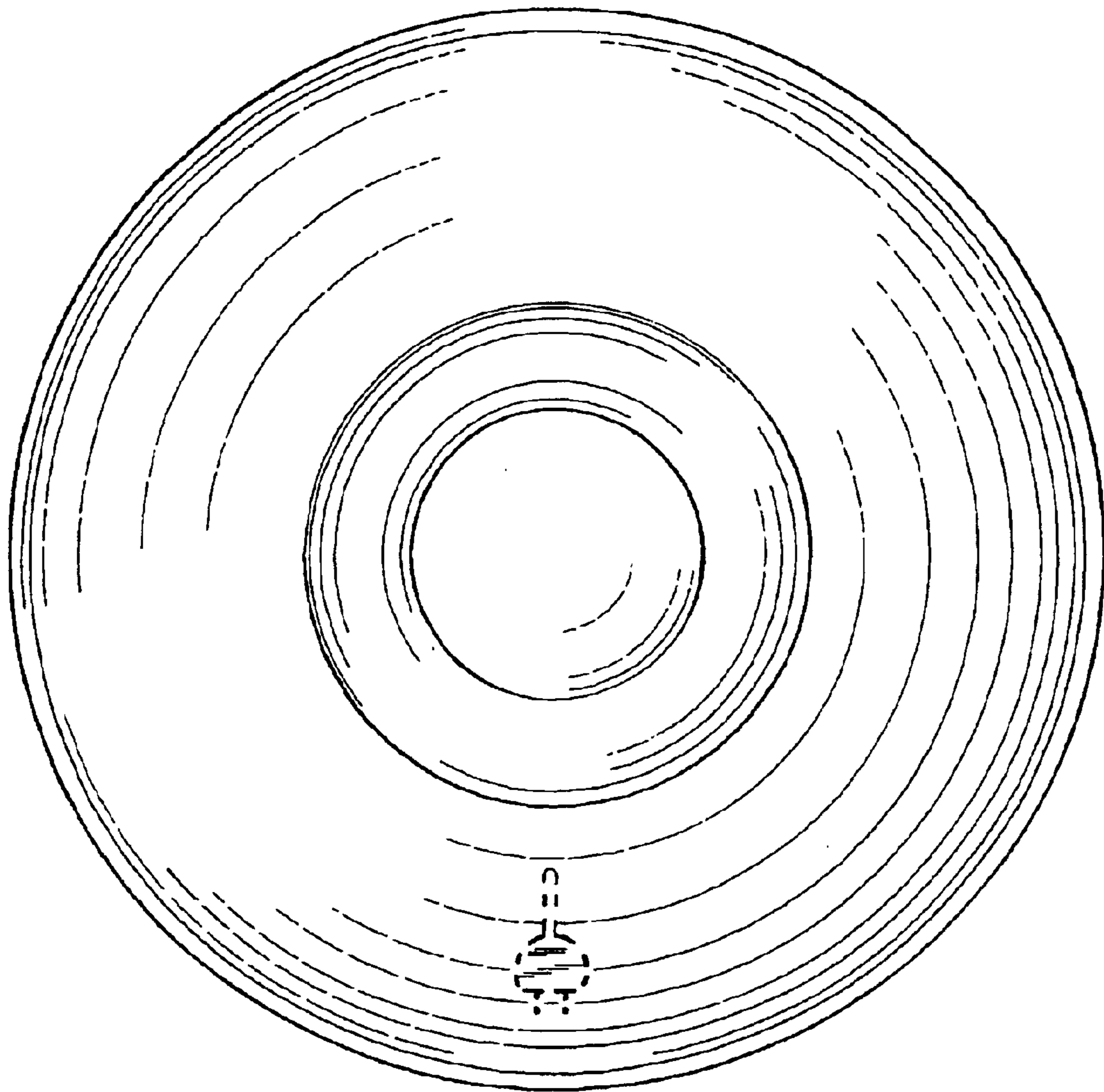
