FIG. 2 is a front view of same;

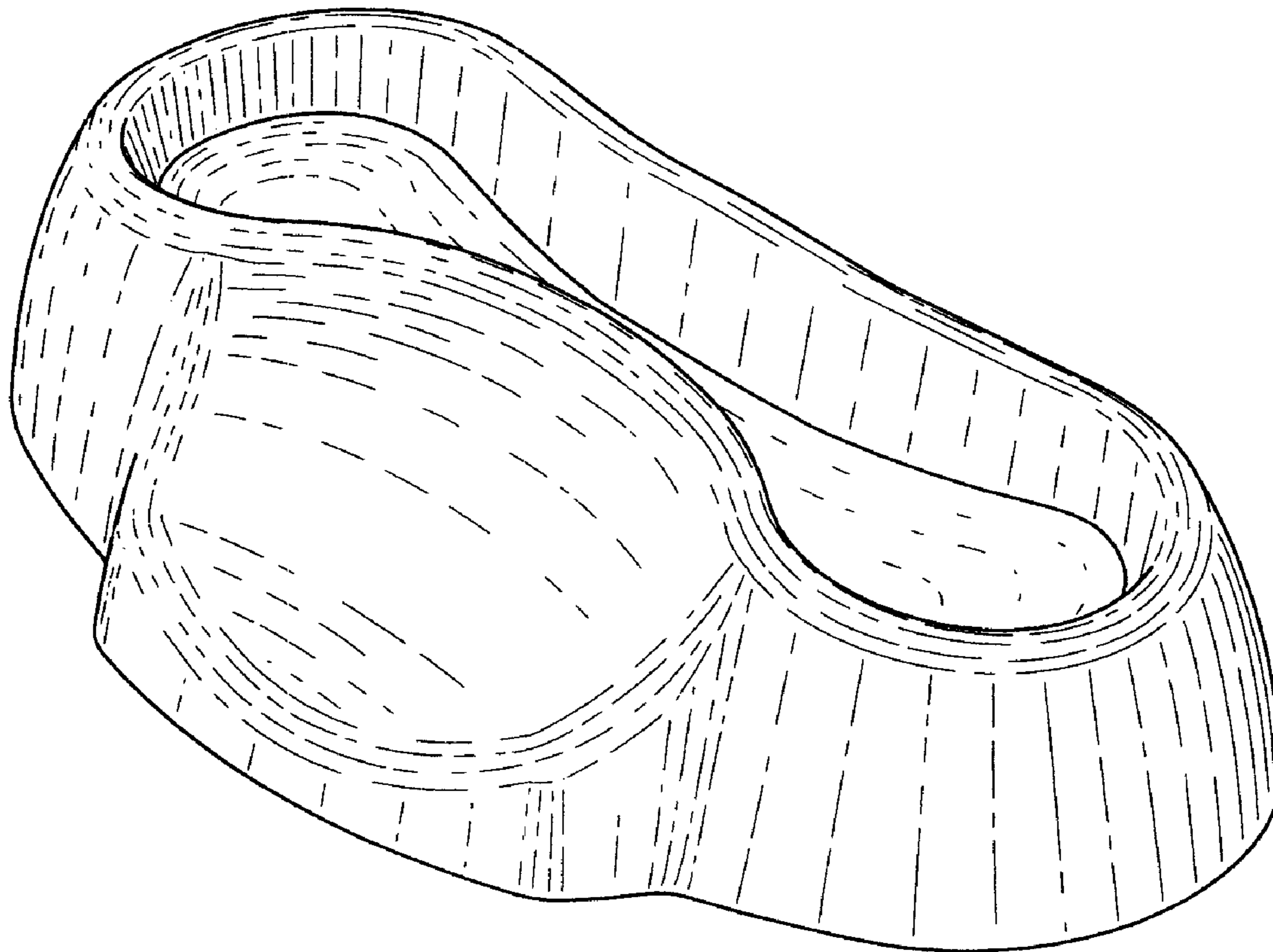
FIG. 3 is a right side view of the stand of FIG. 1, both sides being mirror images of each other;

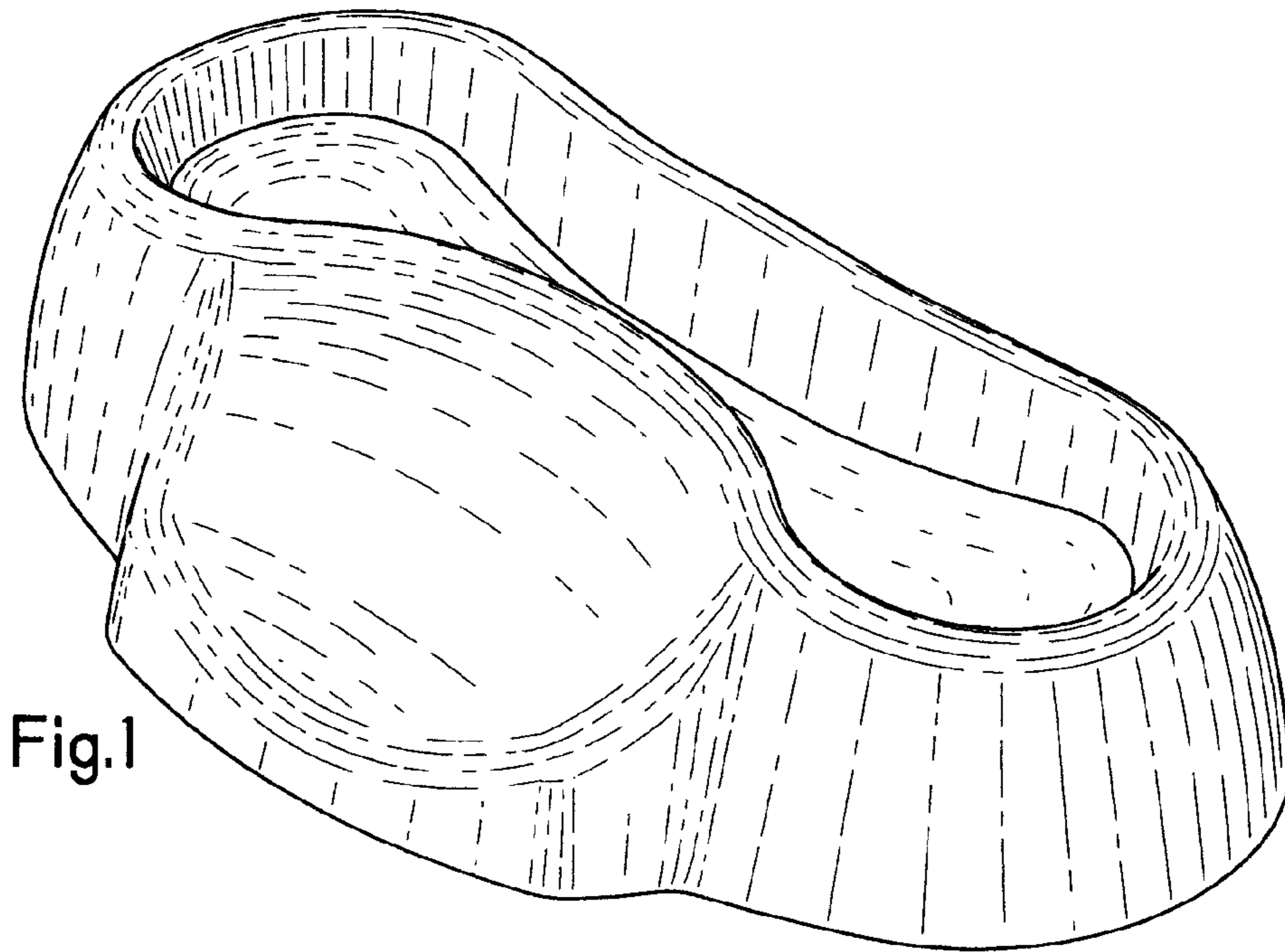

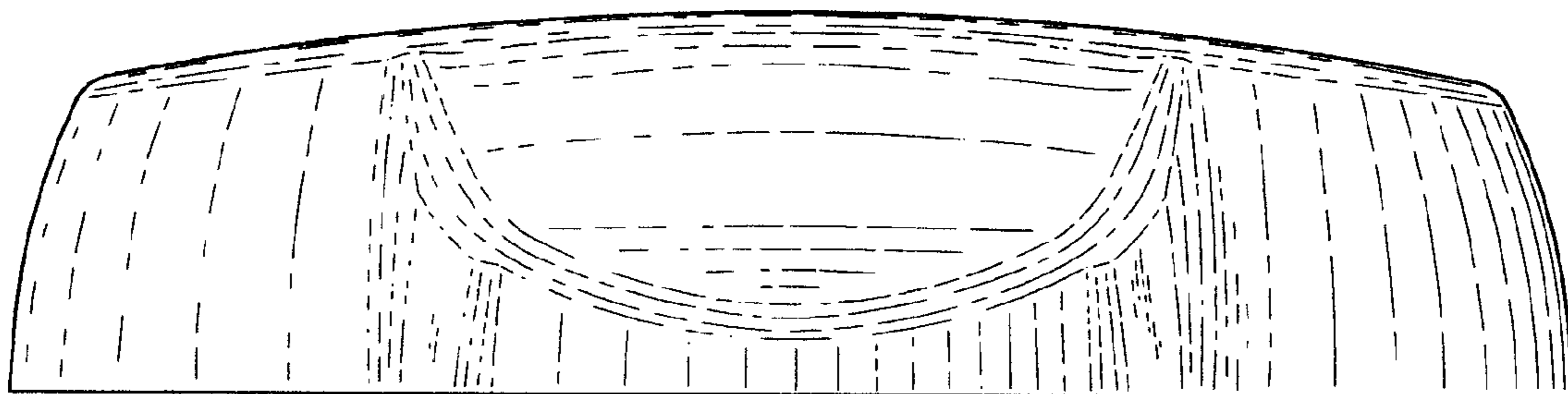

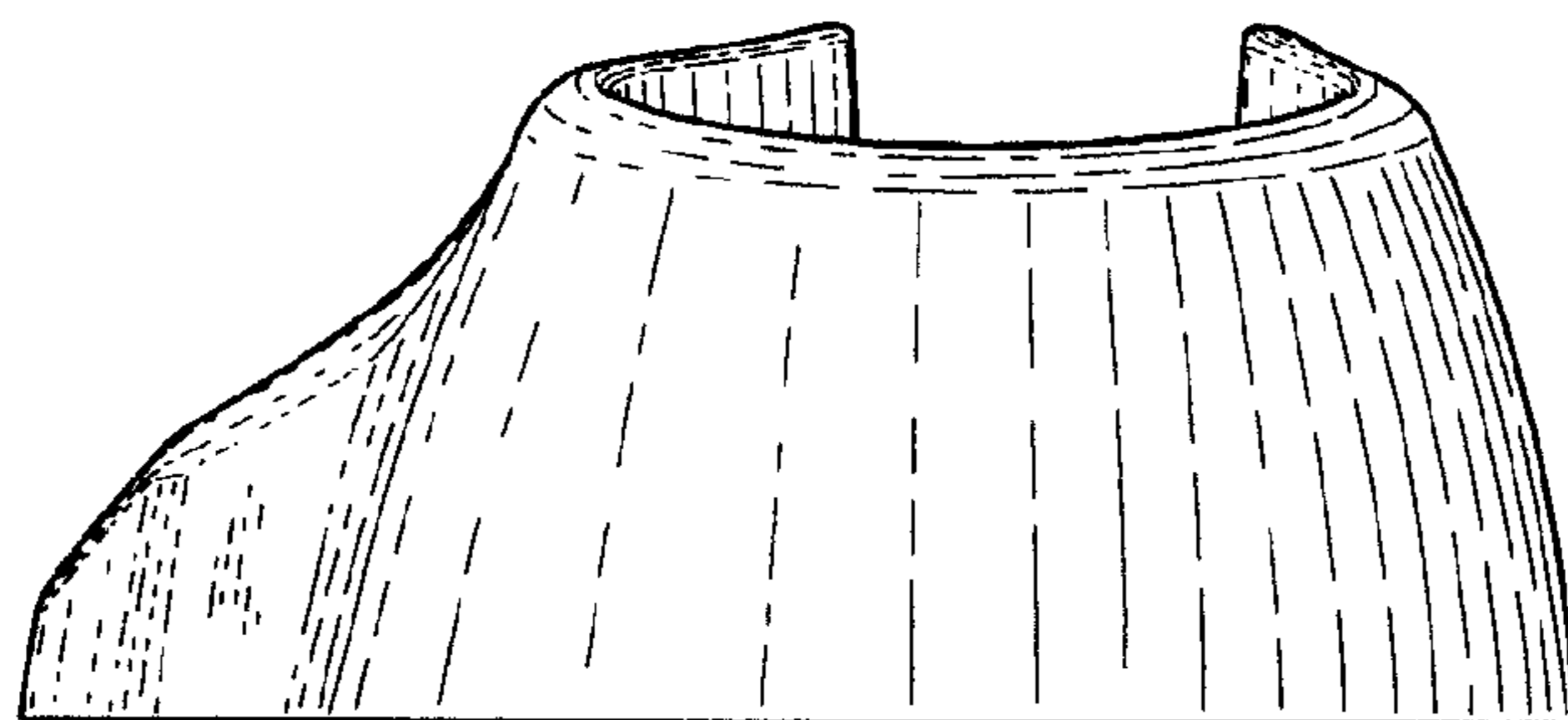

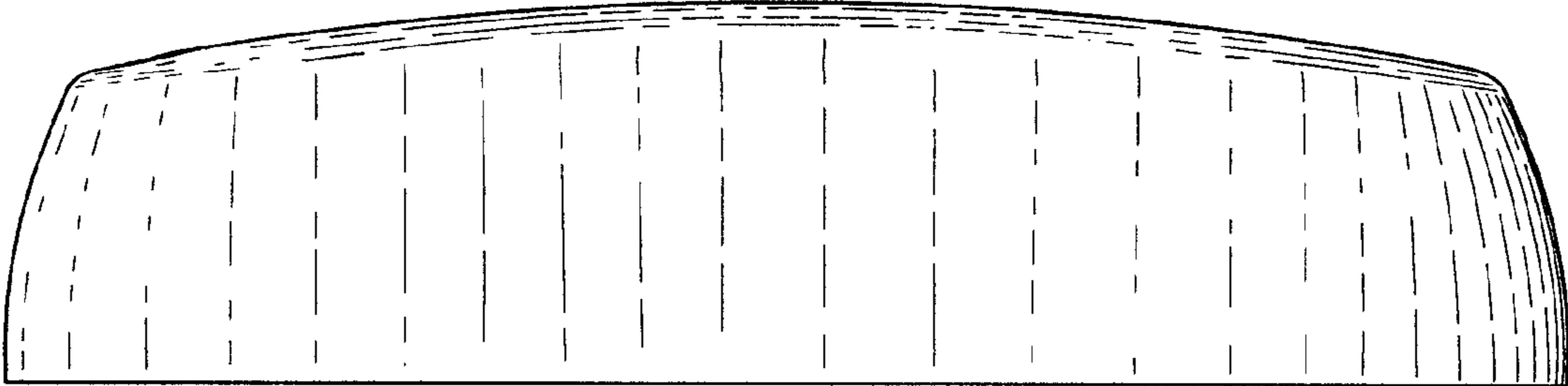

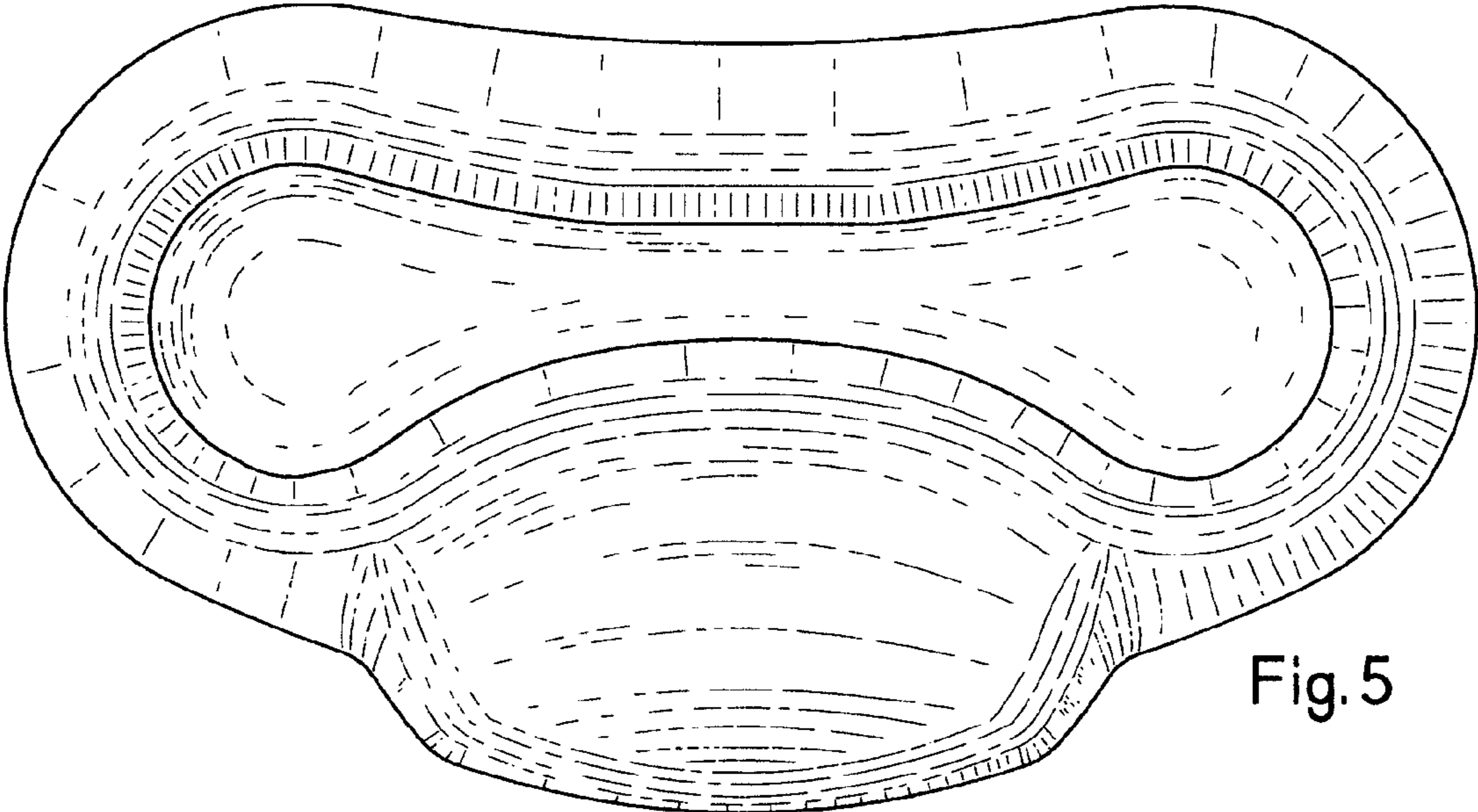

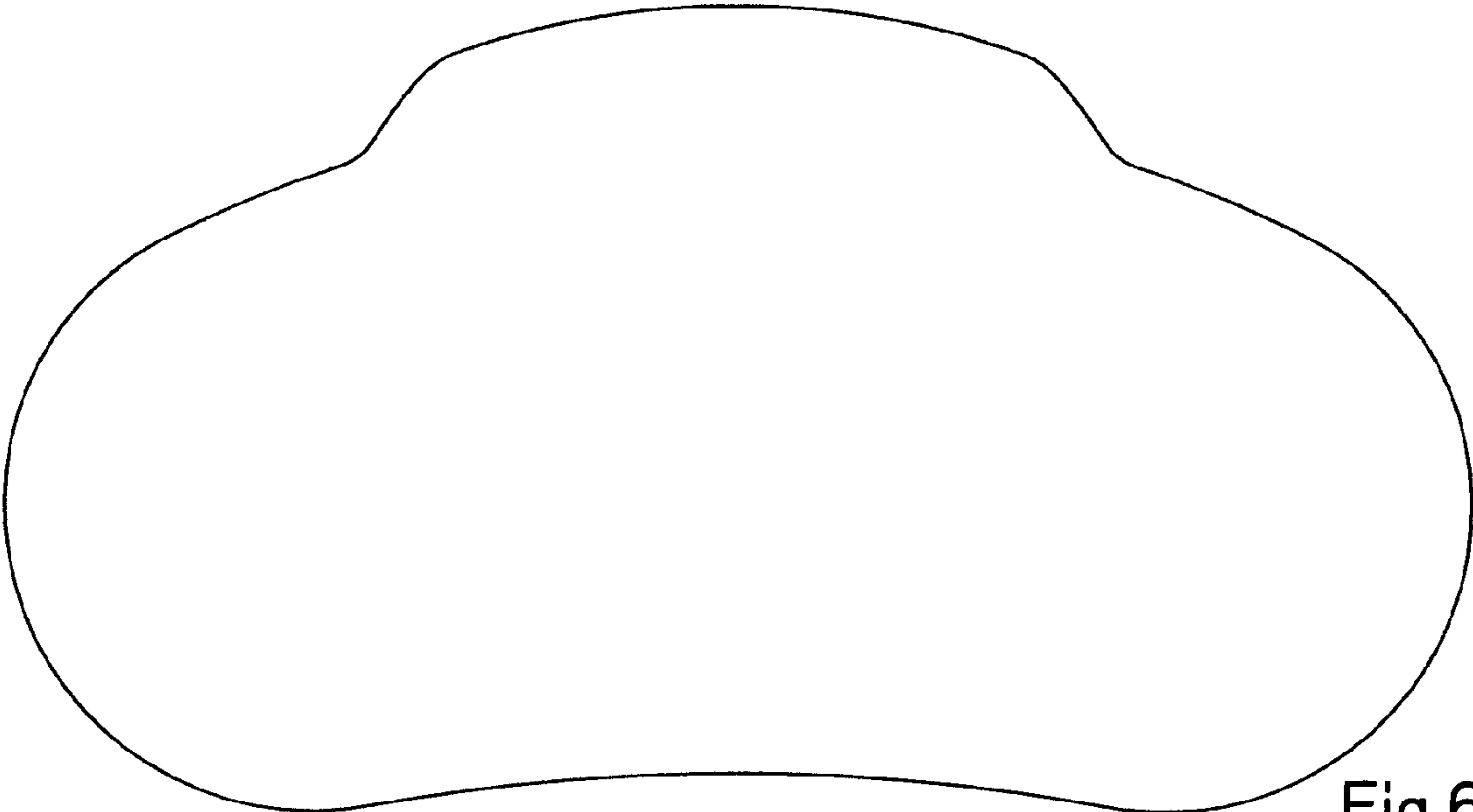
