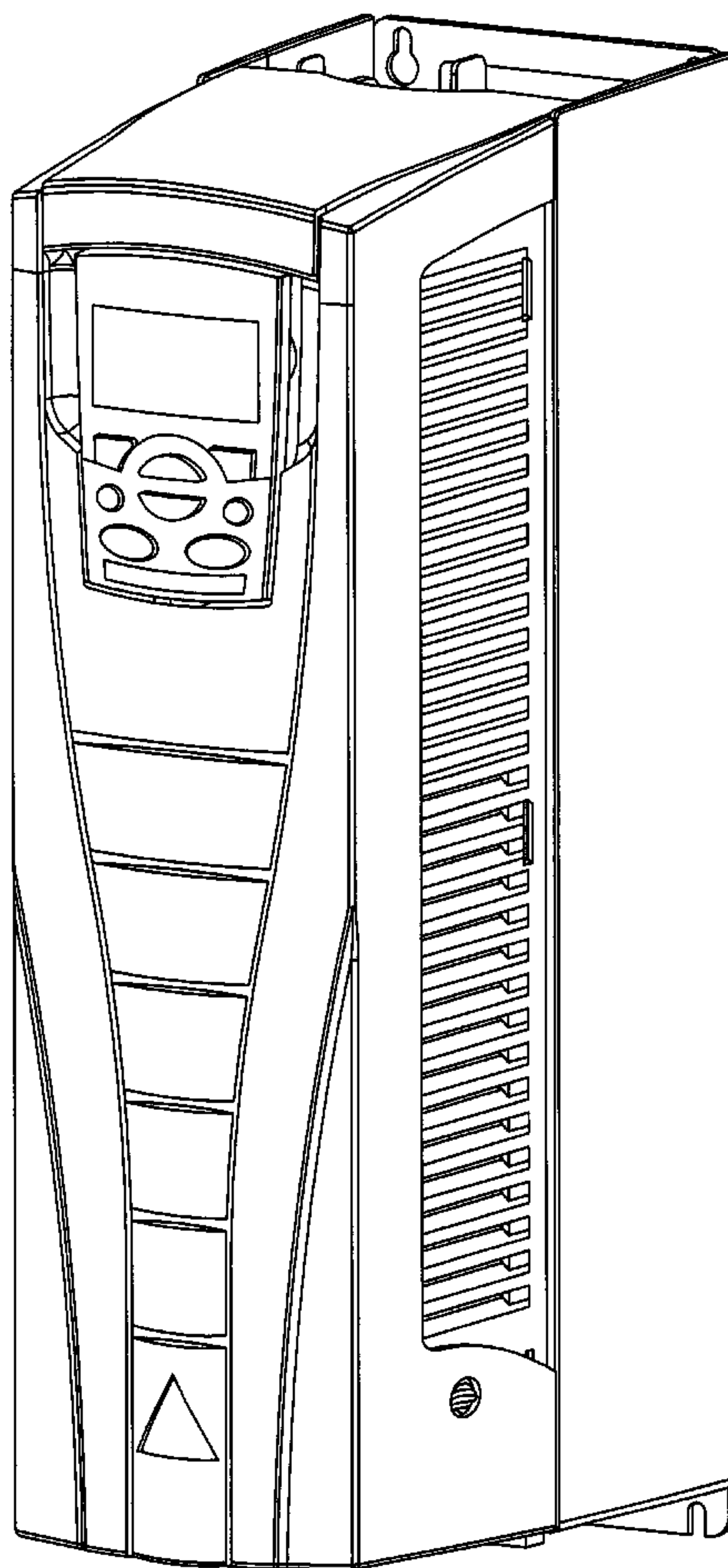
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, right, top perspective view of an casing for an electronic unit showing our new design;  
FIG. 2 is a back, left bottom perspective view thereof;

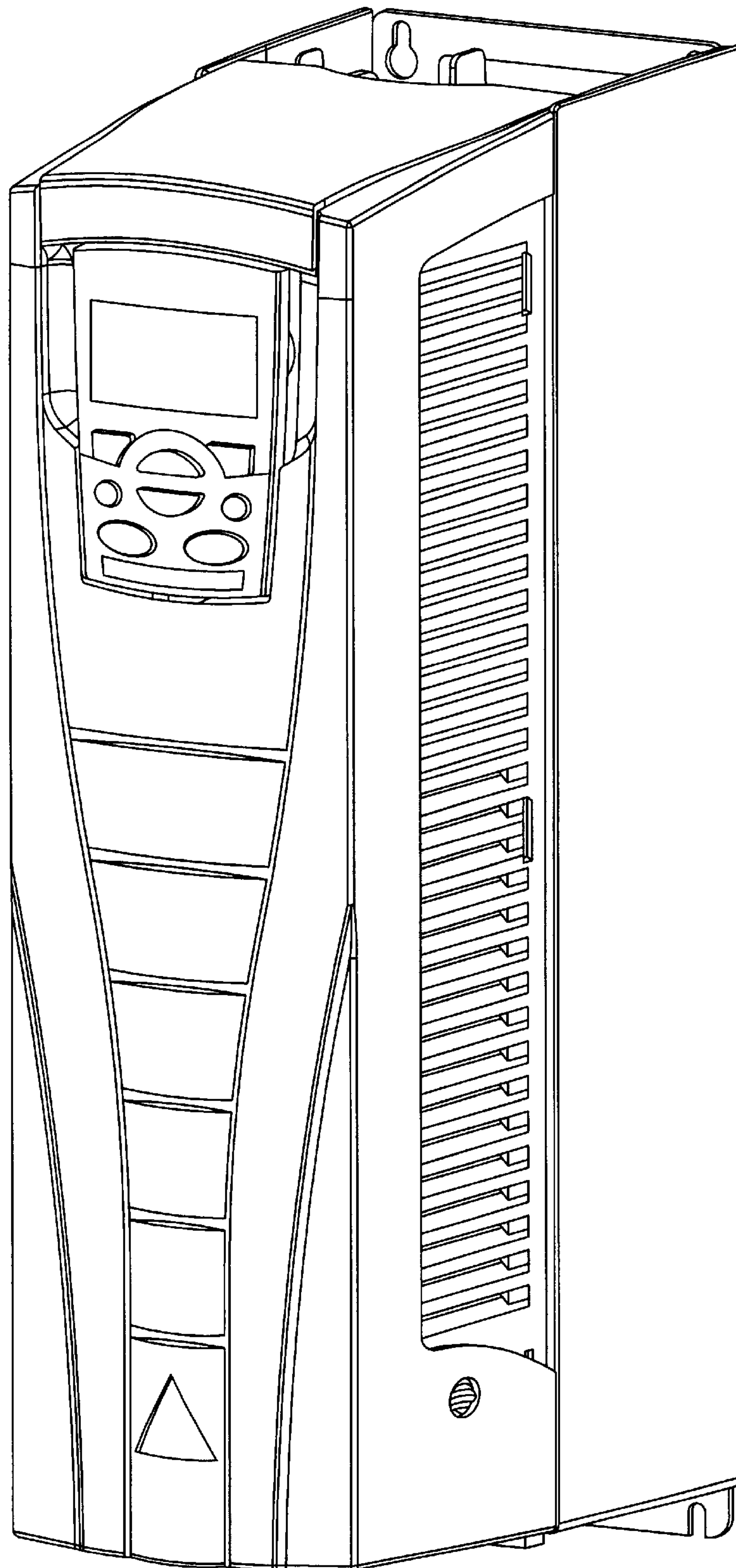

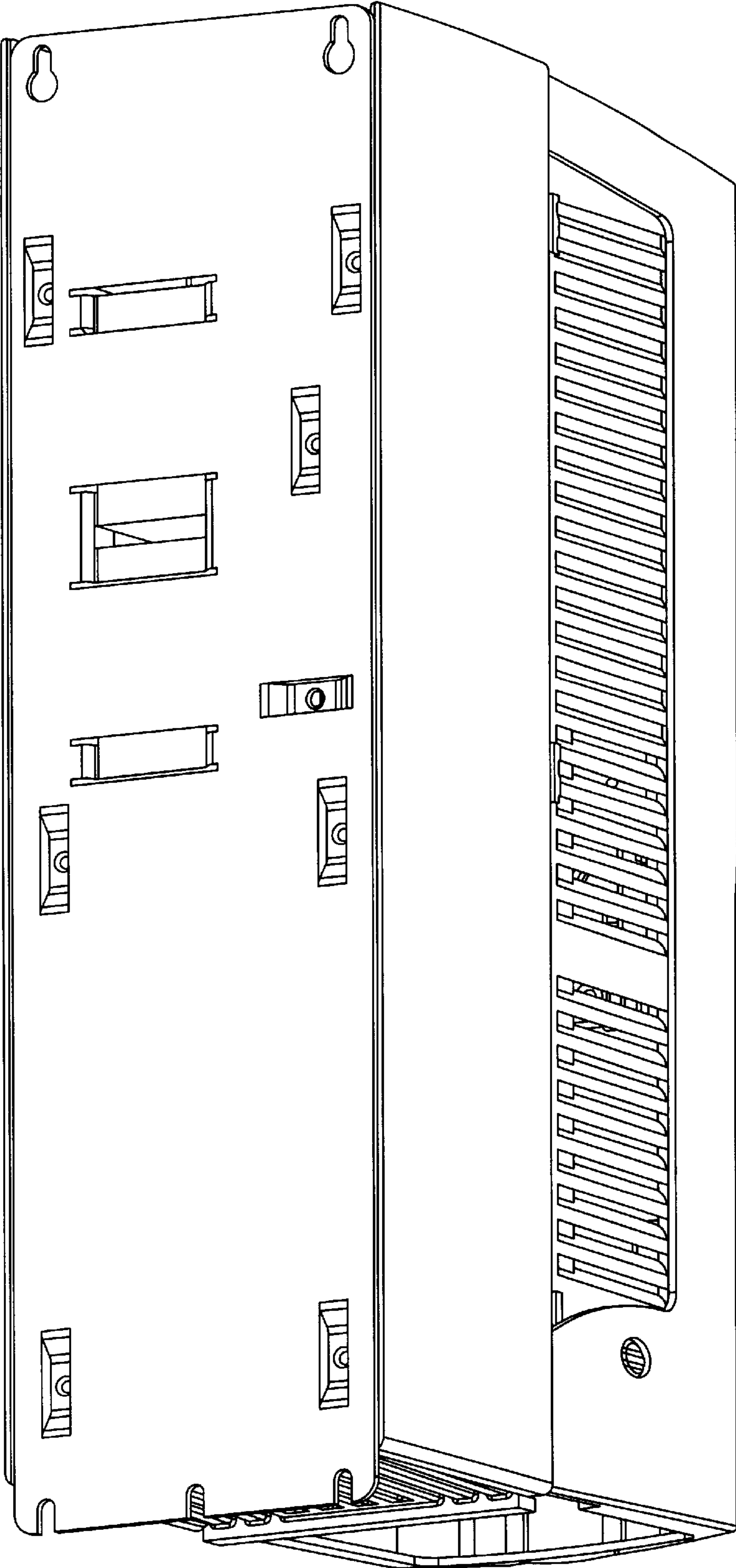

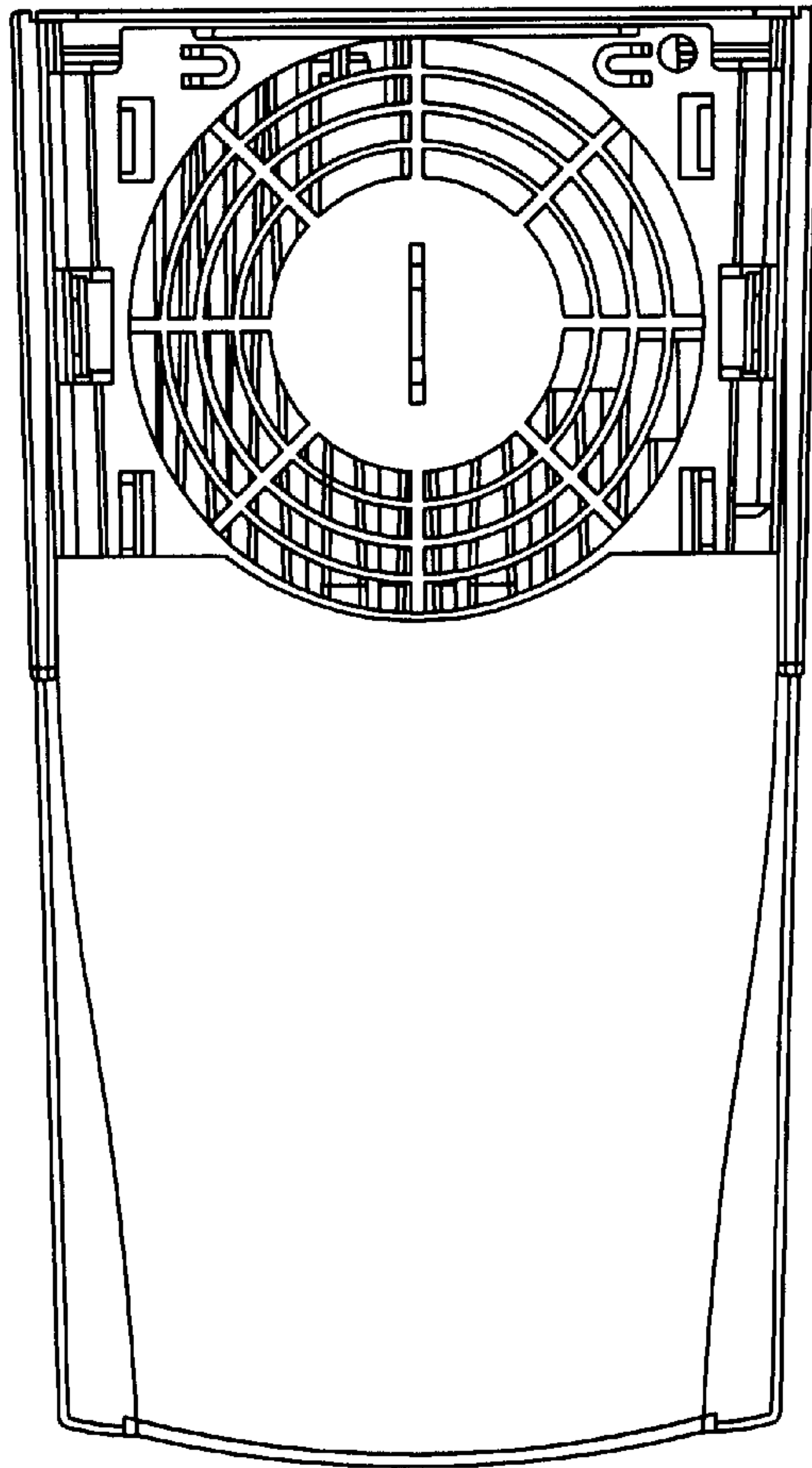

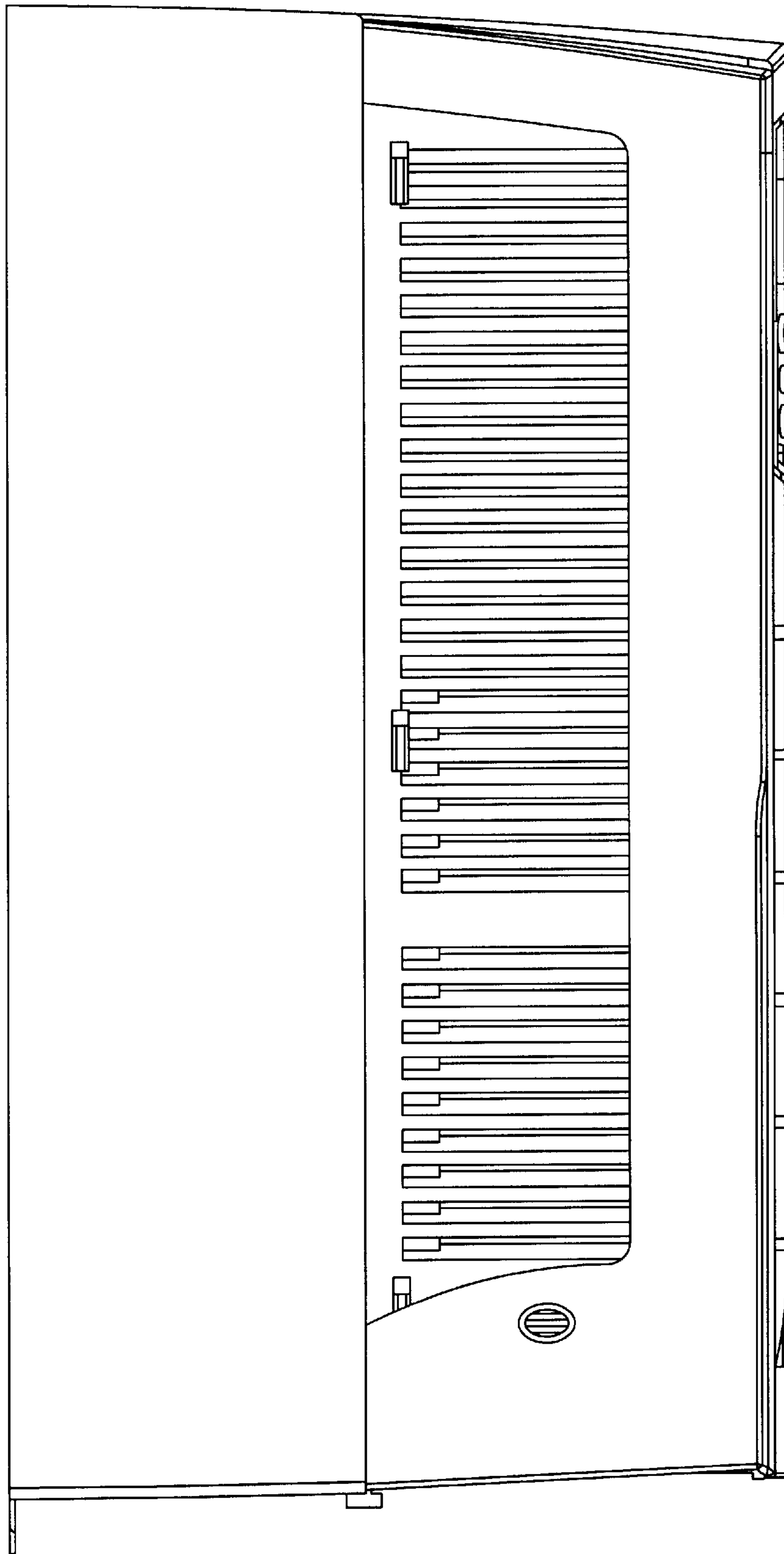

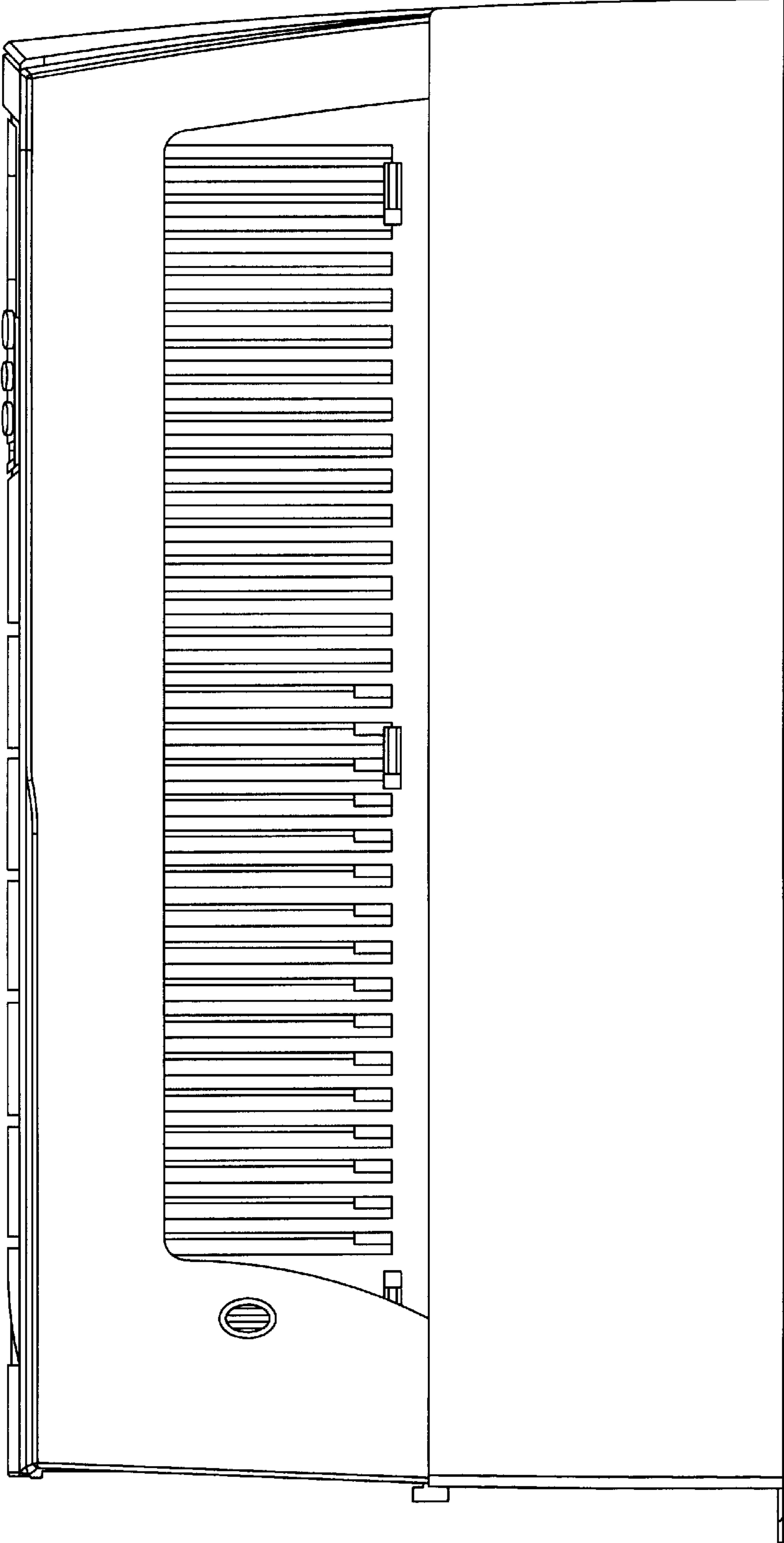

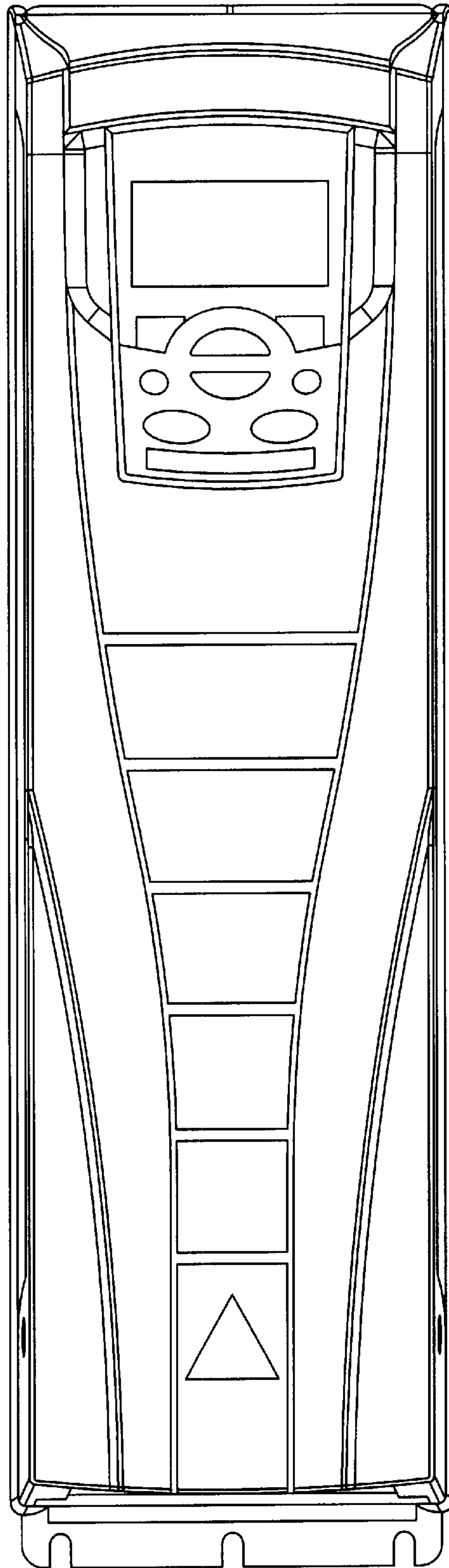

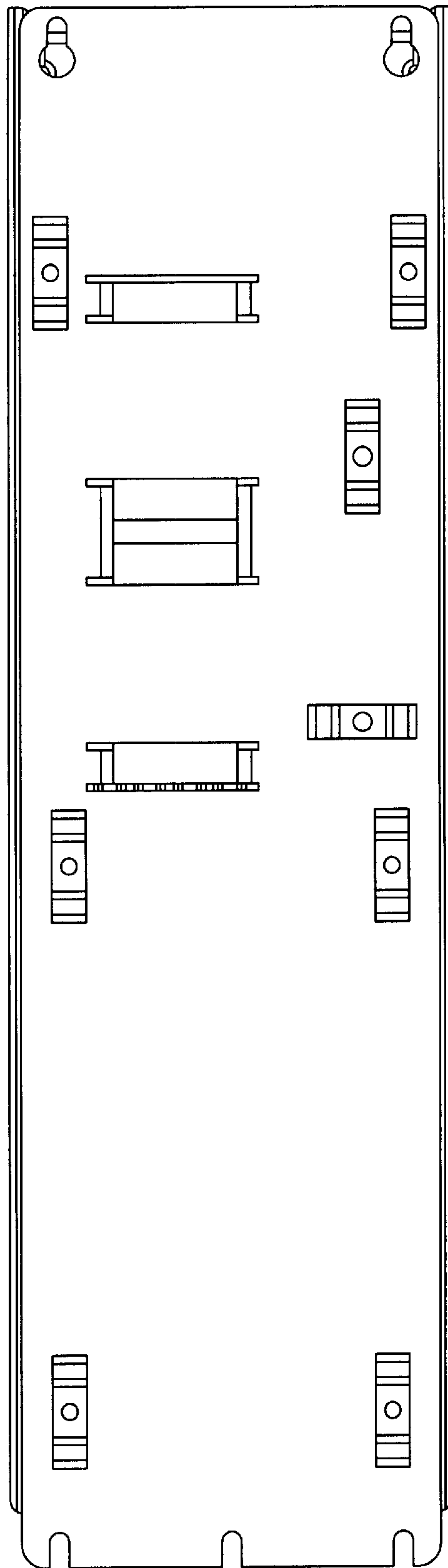
