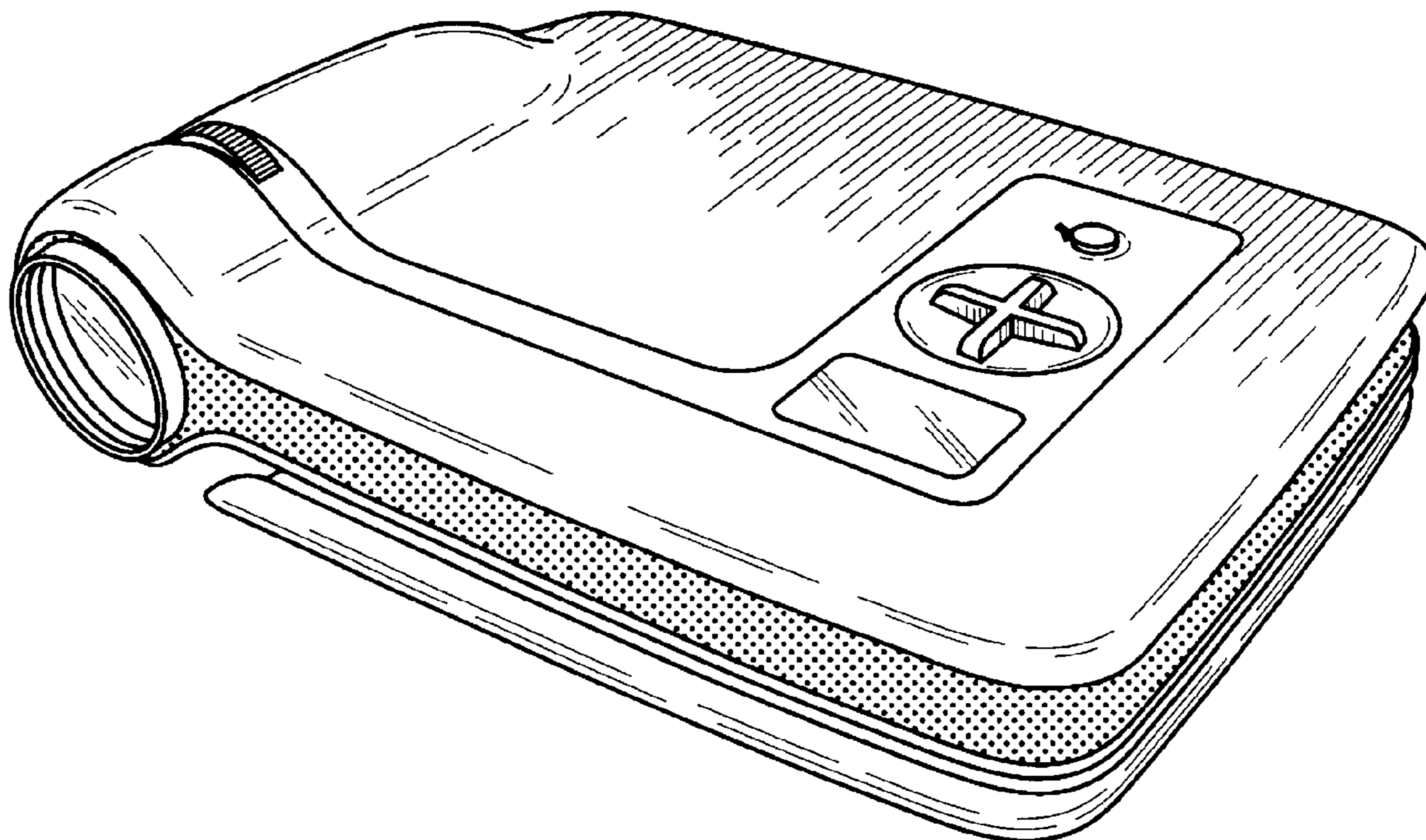

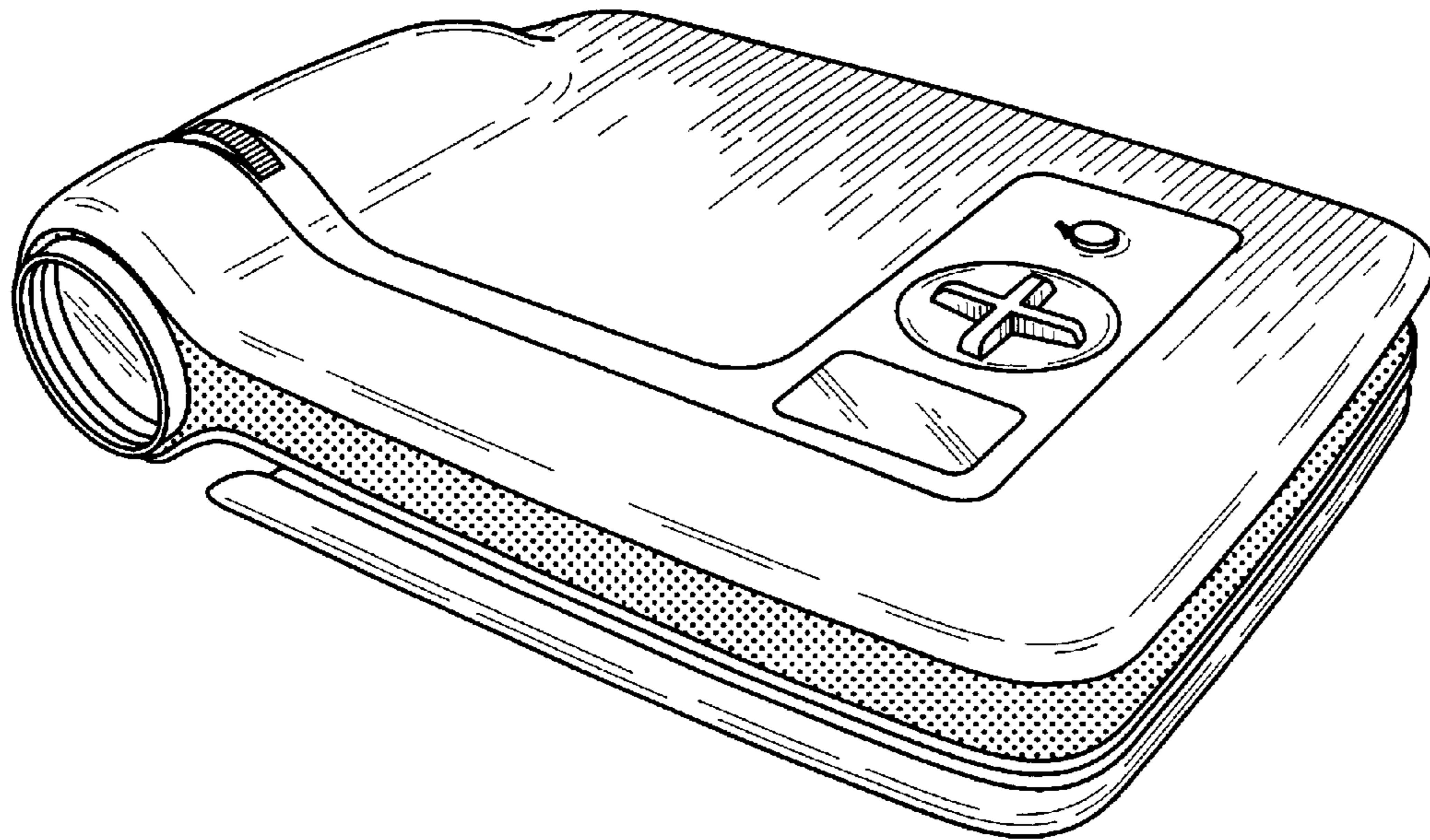
The ornamental design for a projector, as shown and described.

**DESCRIPTION**

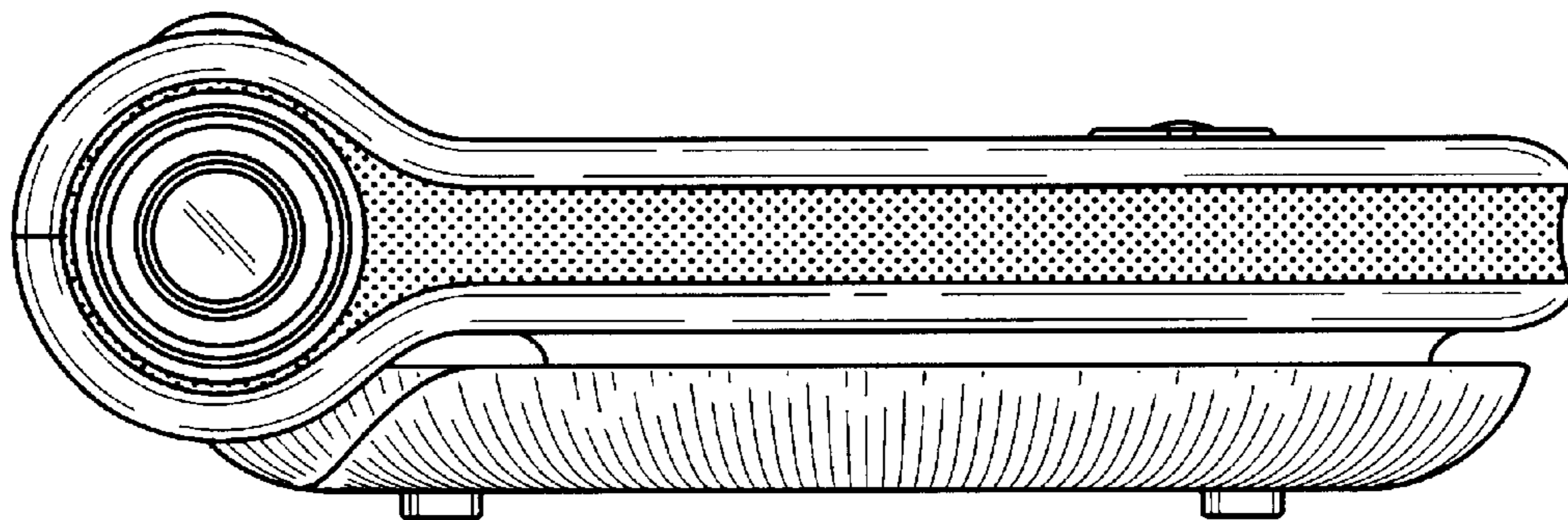
FIG. 1 is a perspective view of a projector showing the new design;

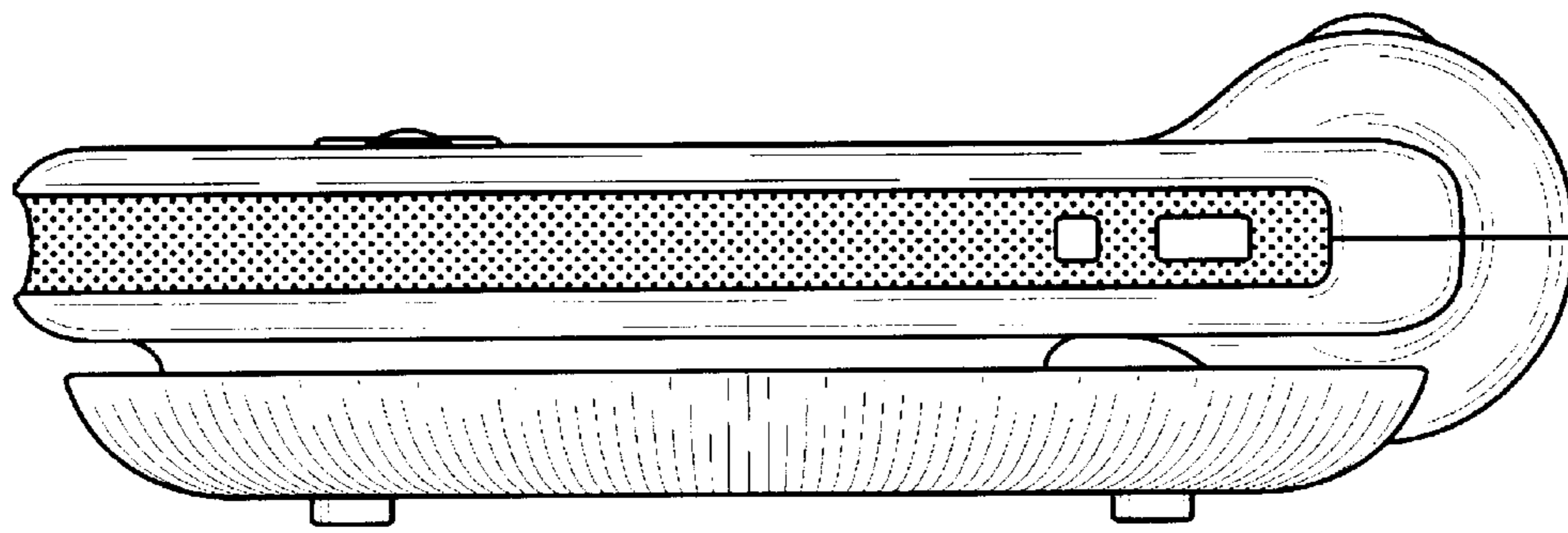




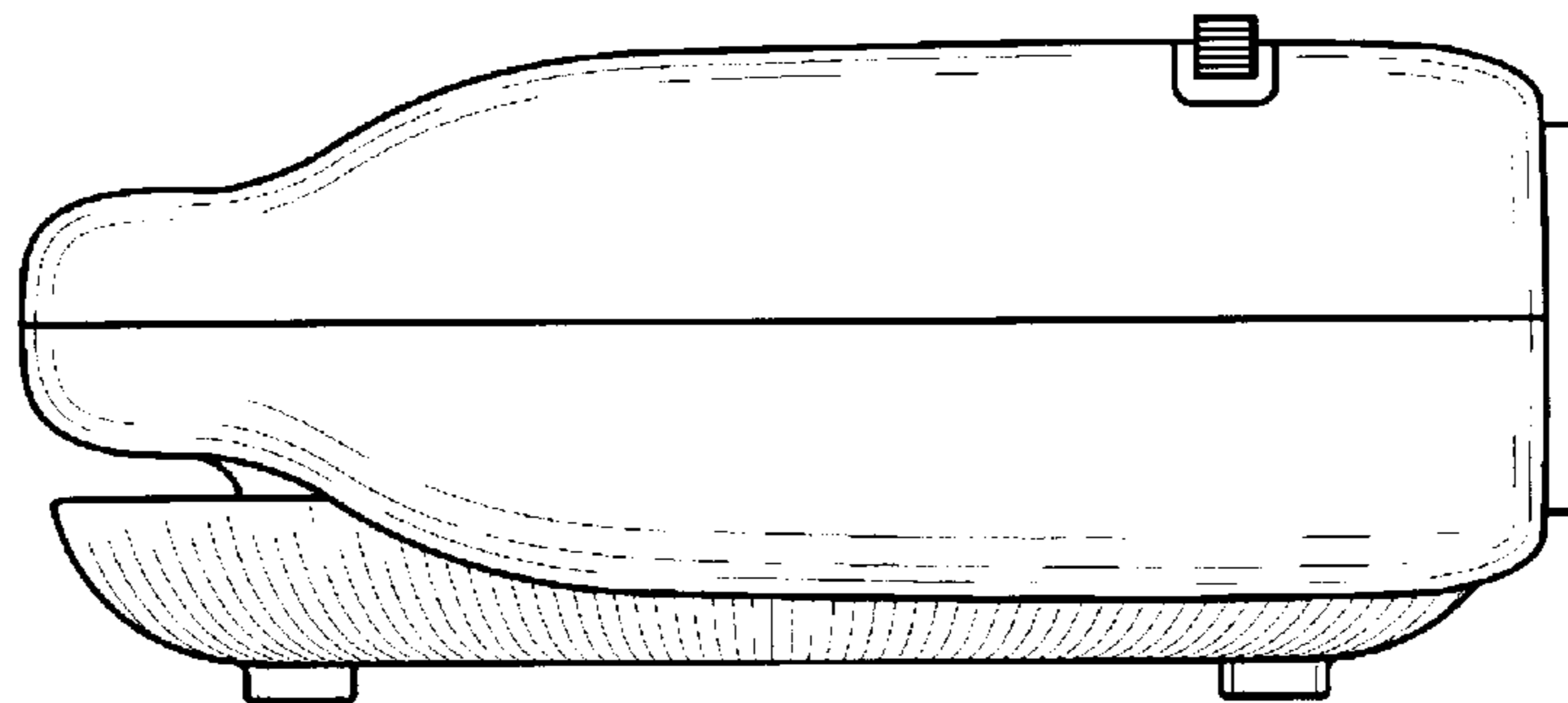

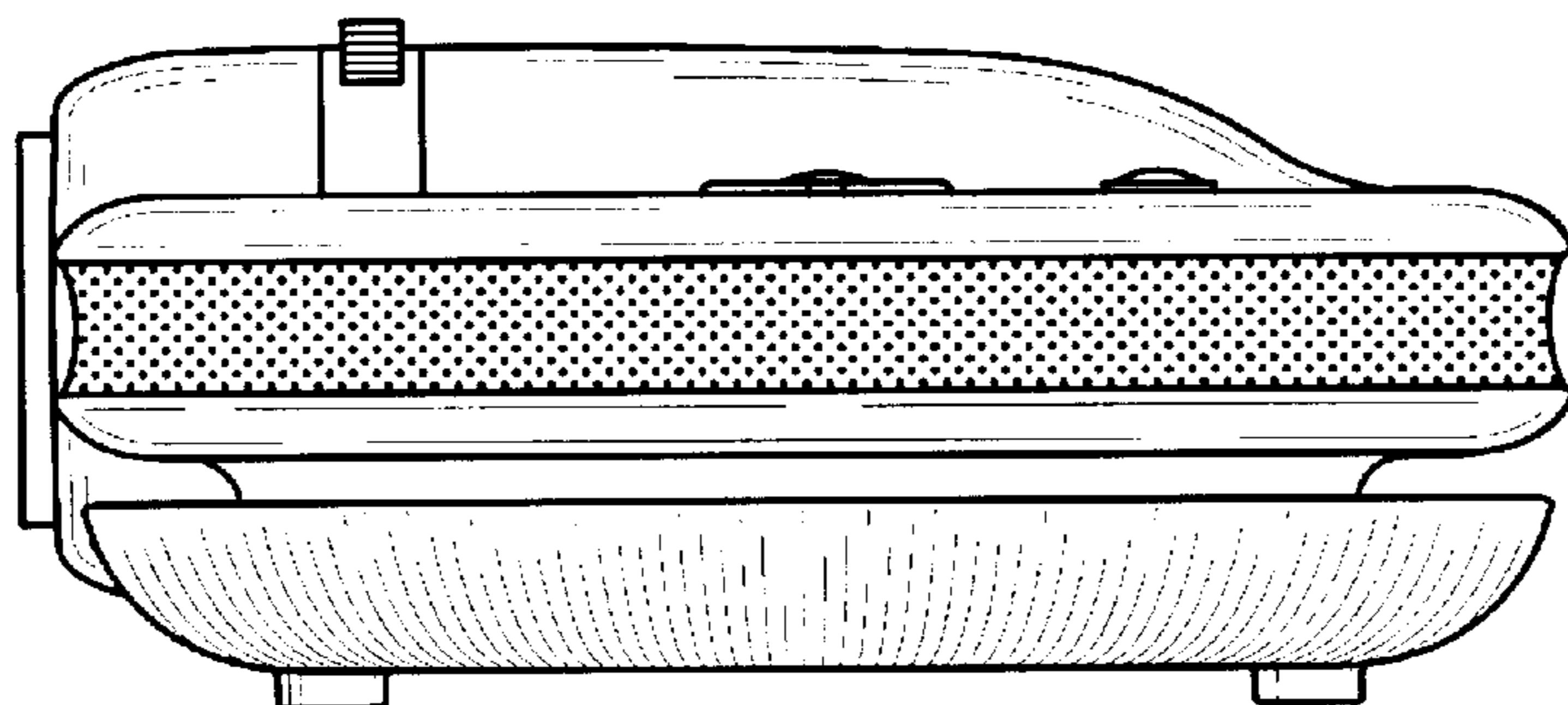

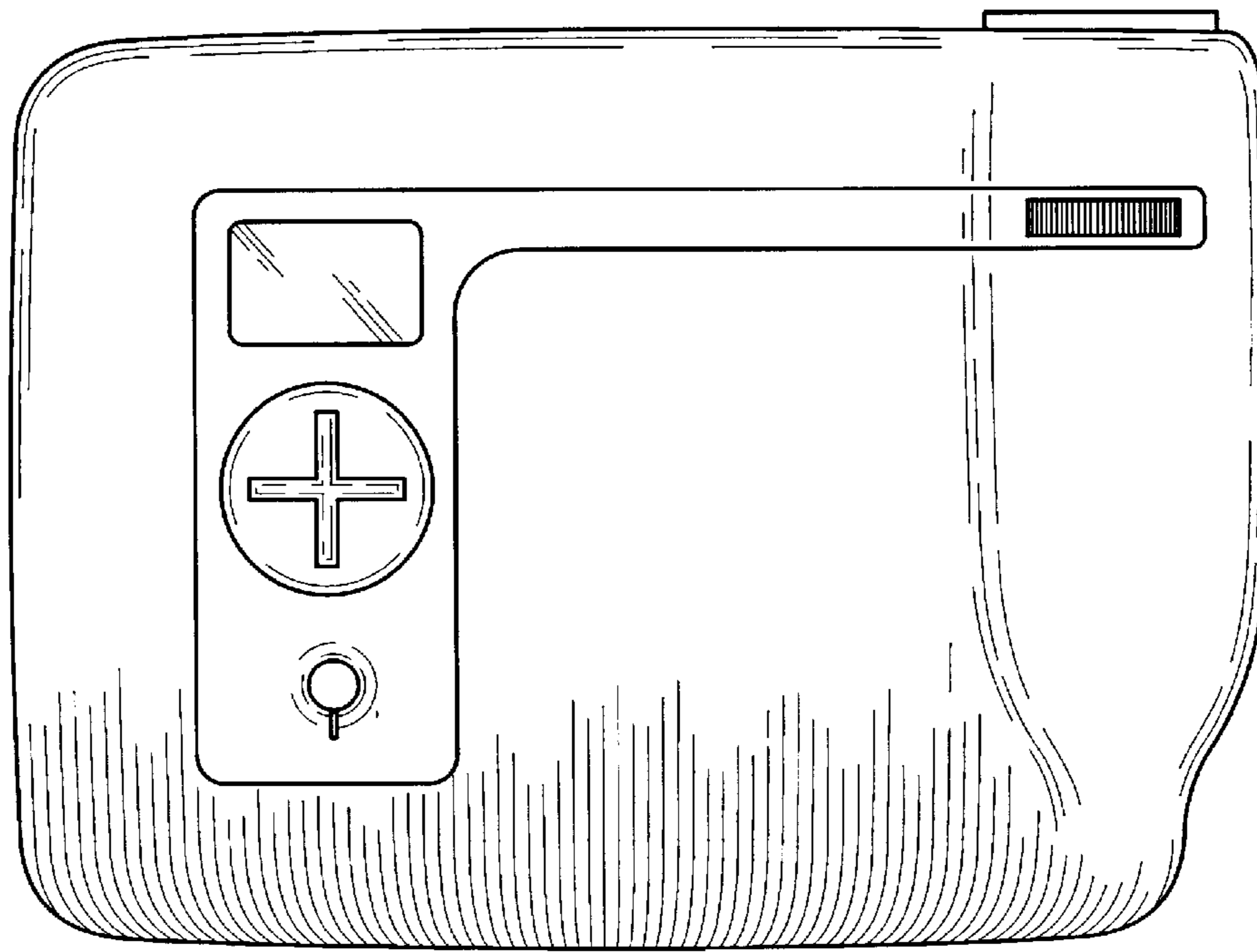

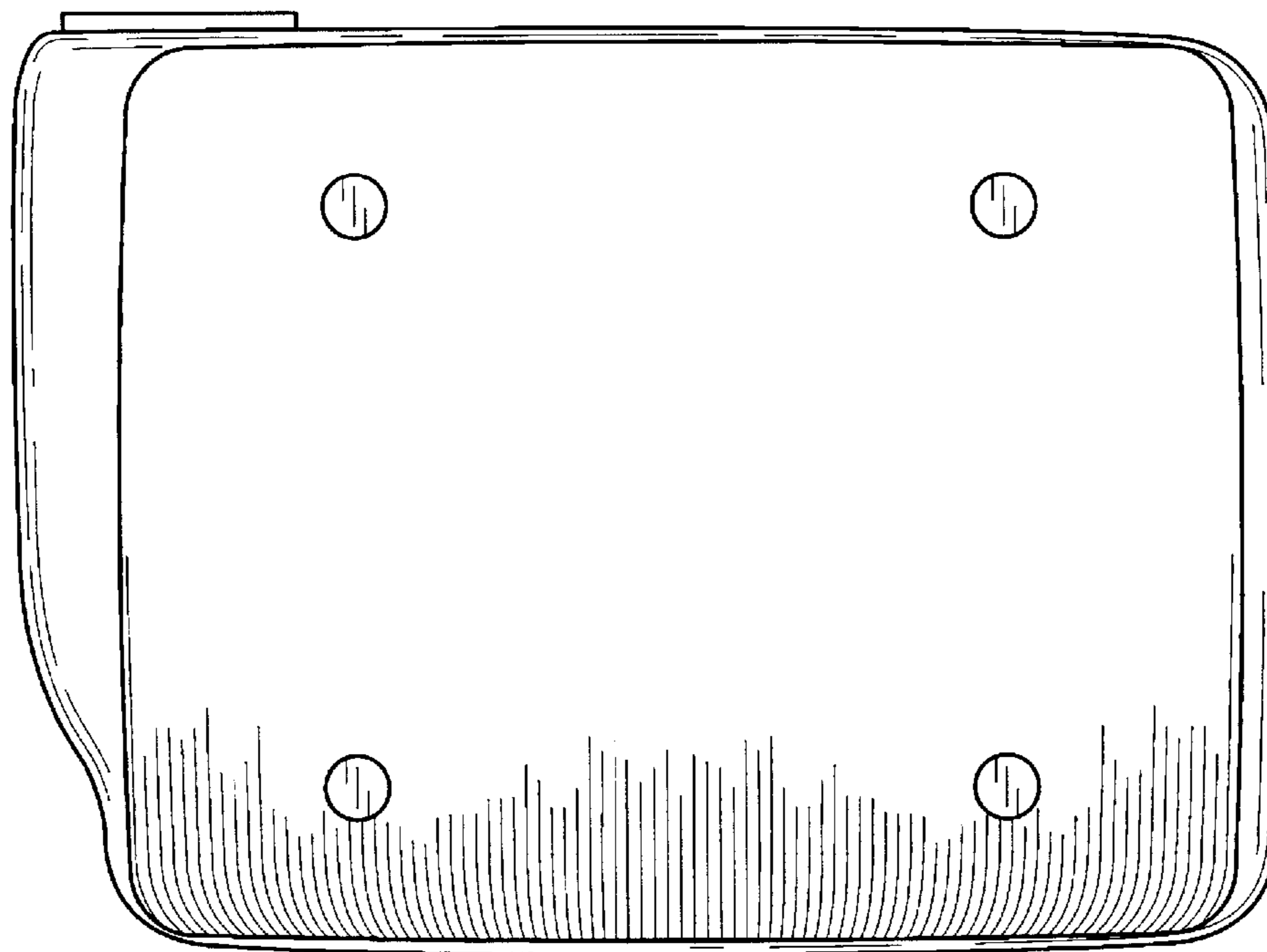
