puppet.

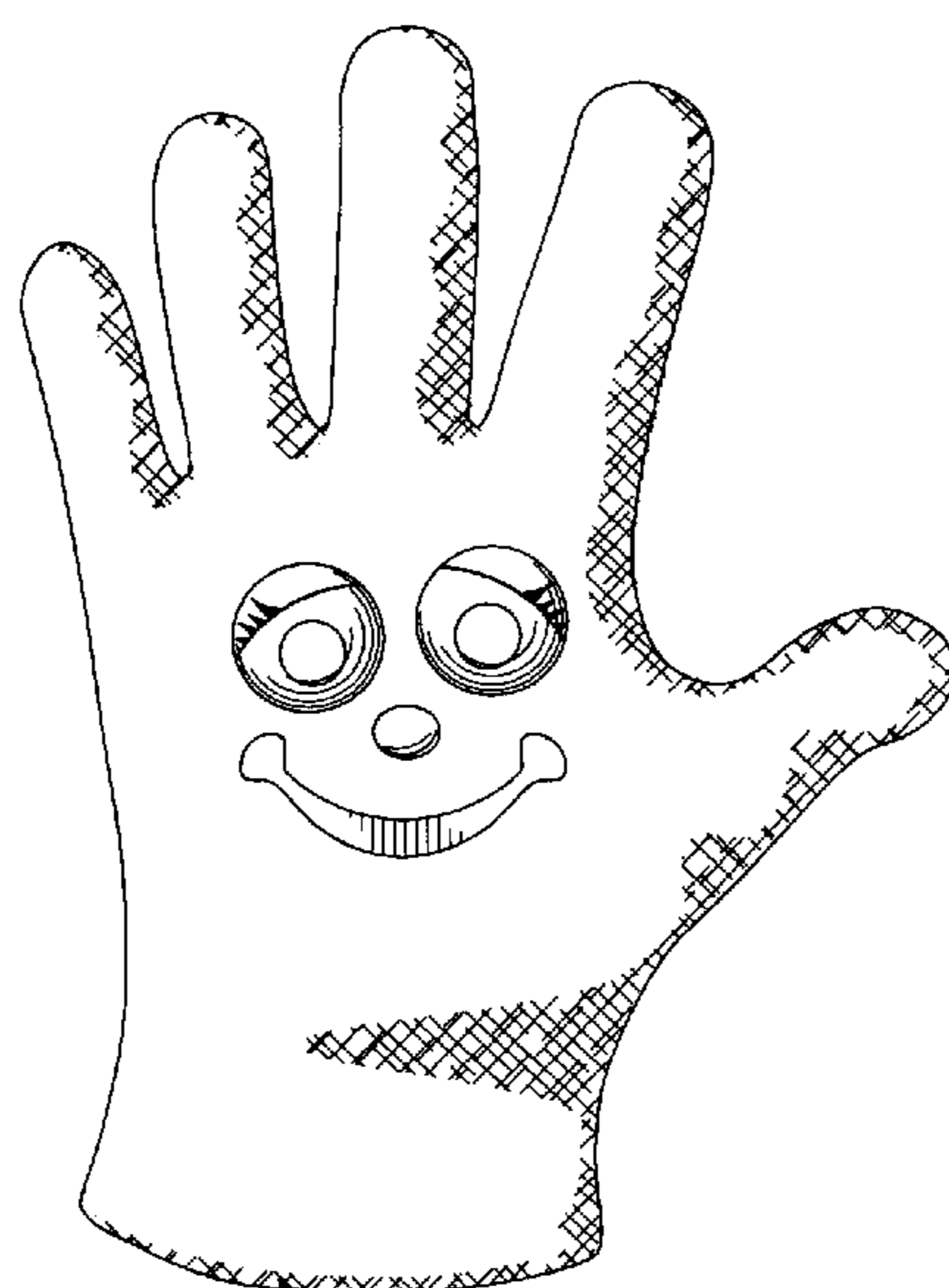
FIG. 4 is a front view of the fourth embodiment of the glove

puppet.

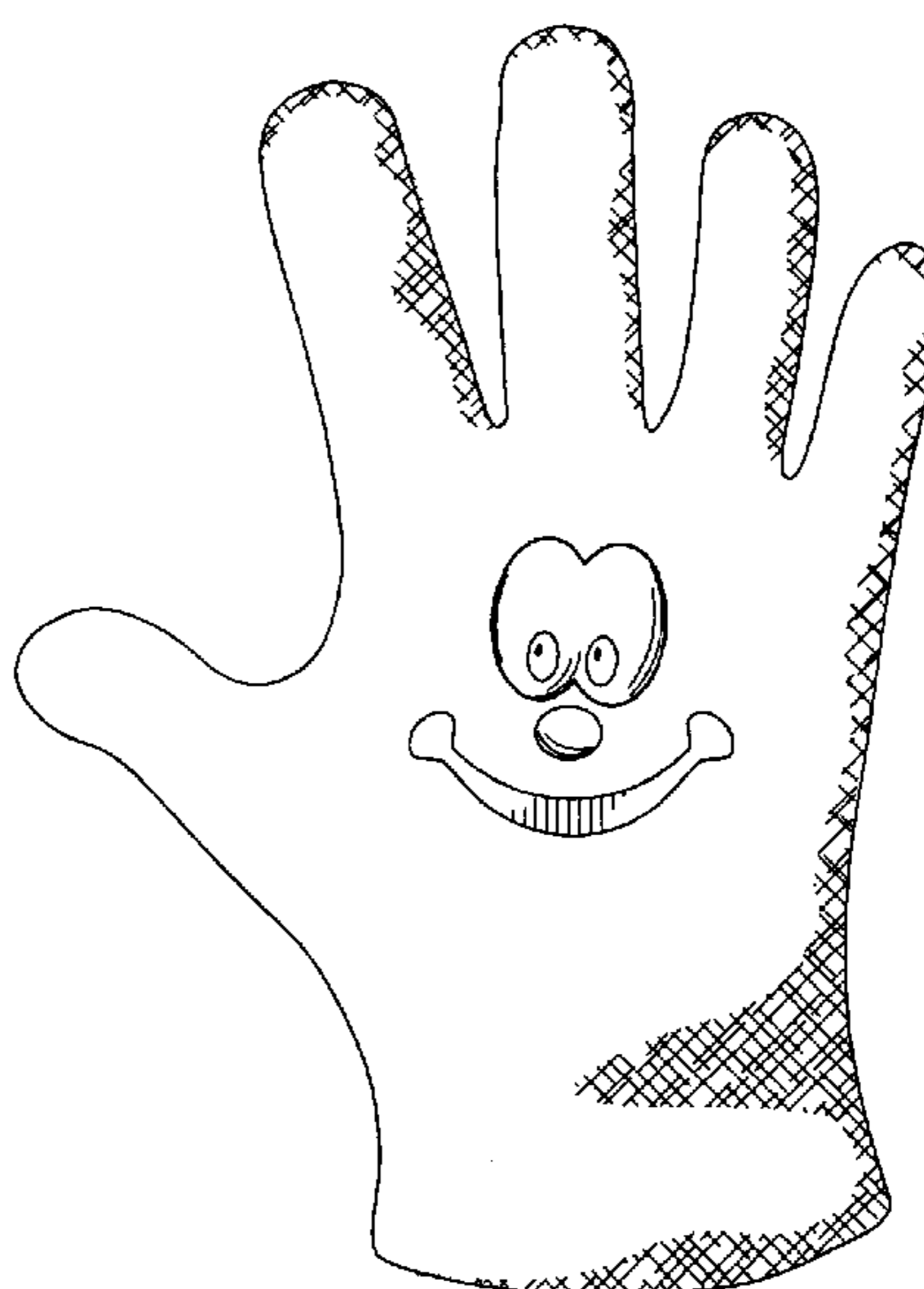
FIG. 6 is a front view of the sixth embodiment of the glove

glove puppet.

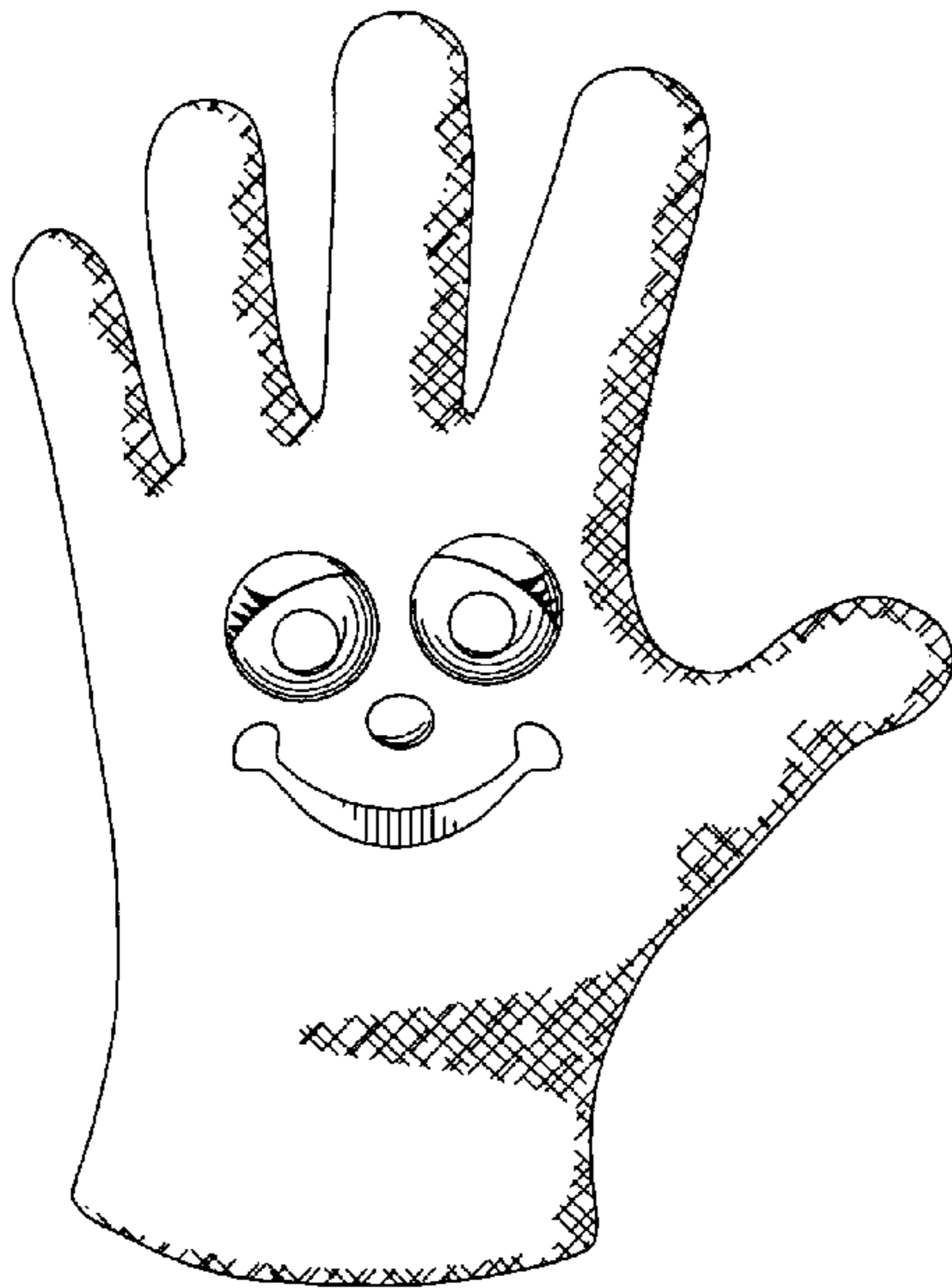

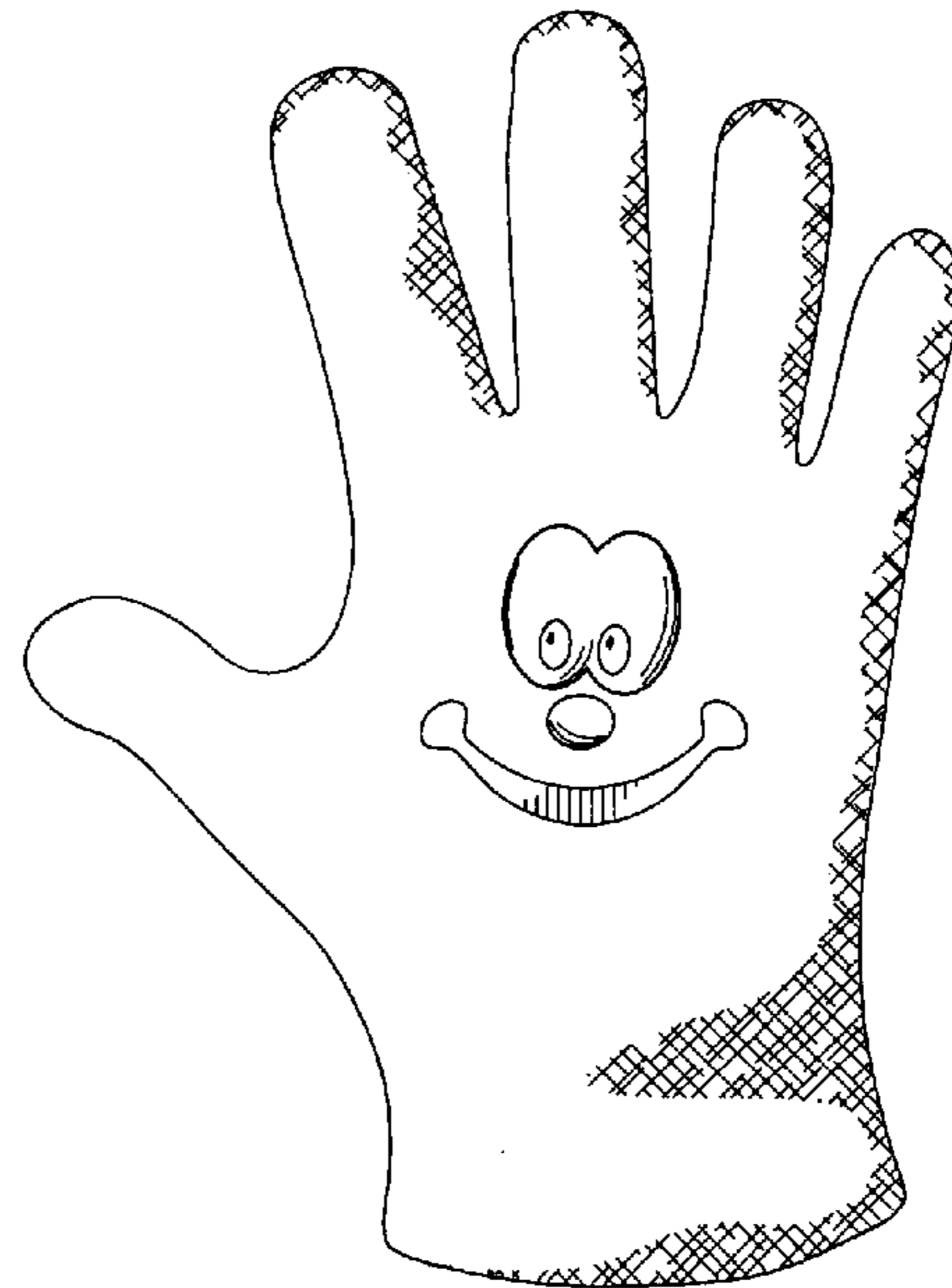

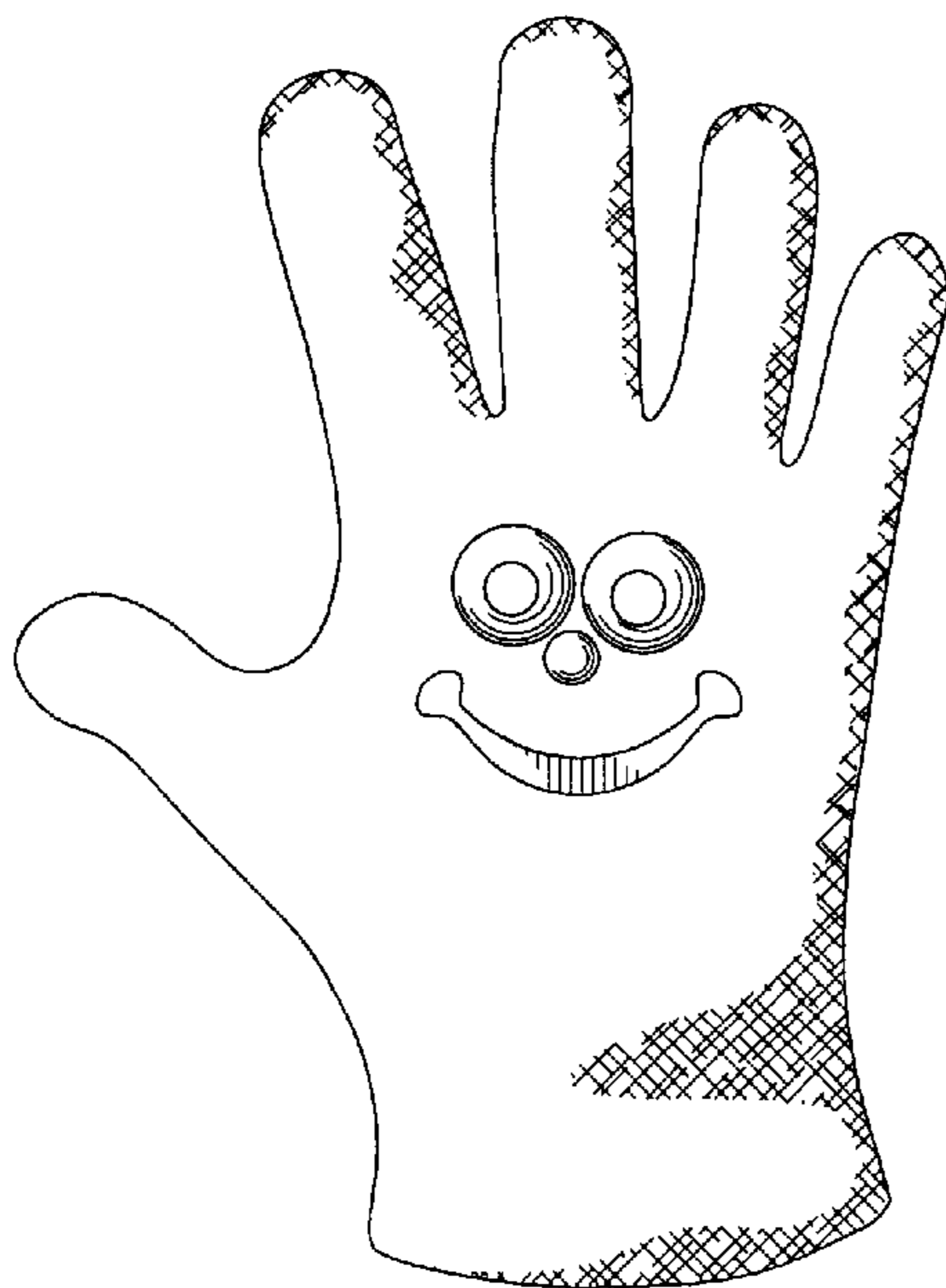

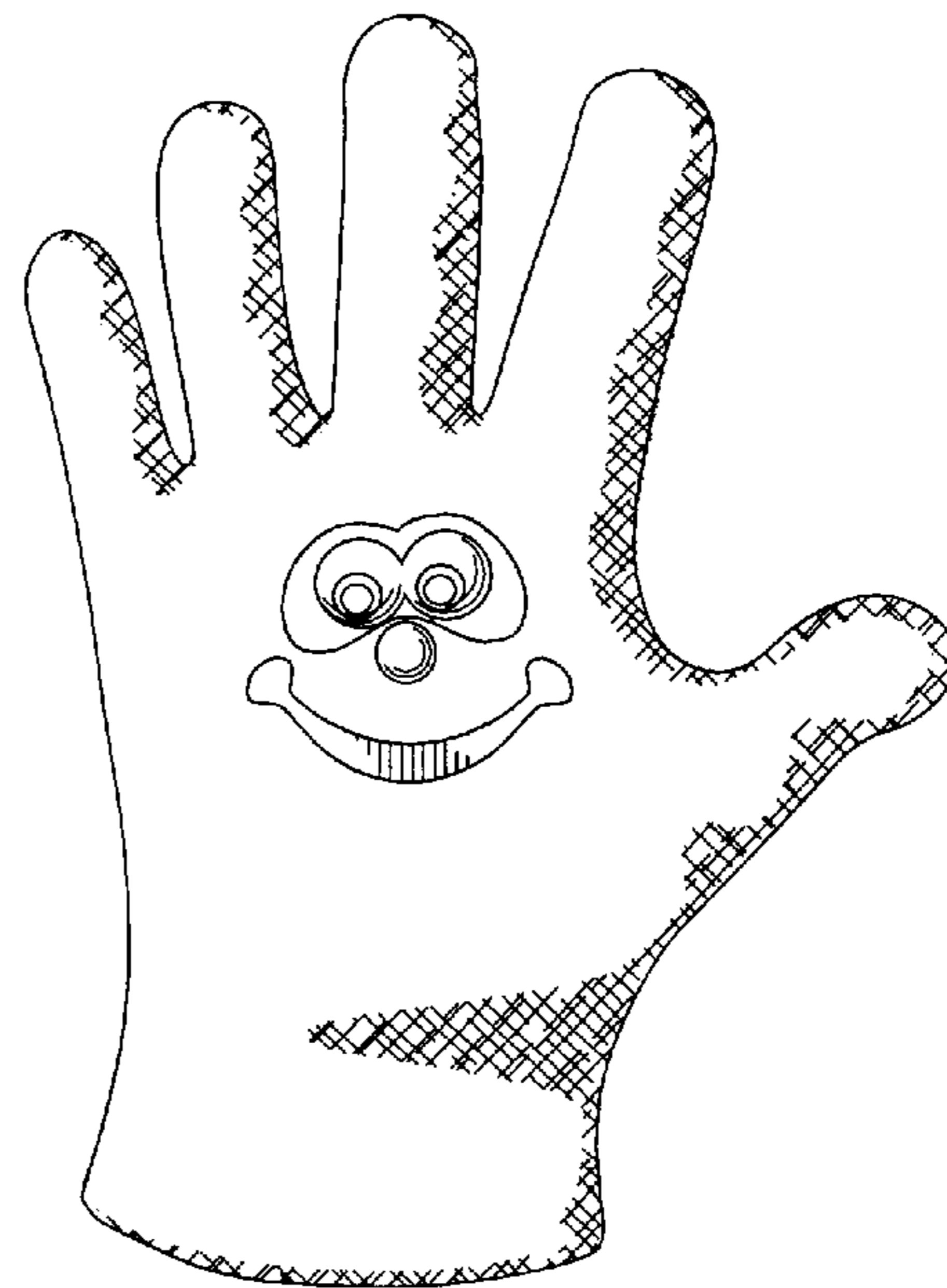

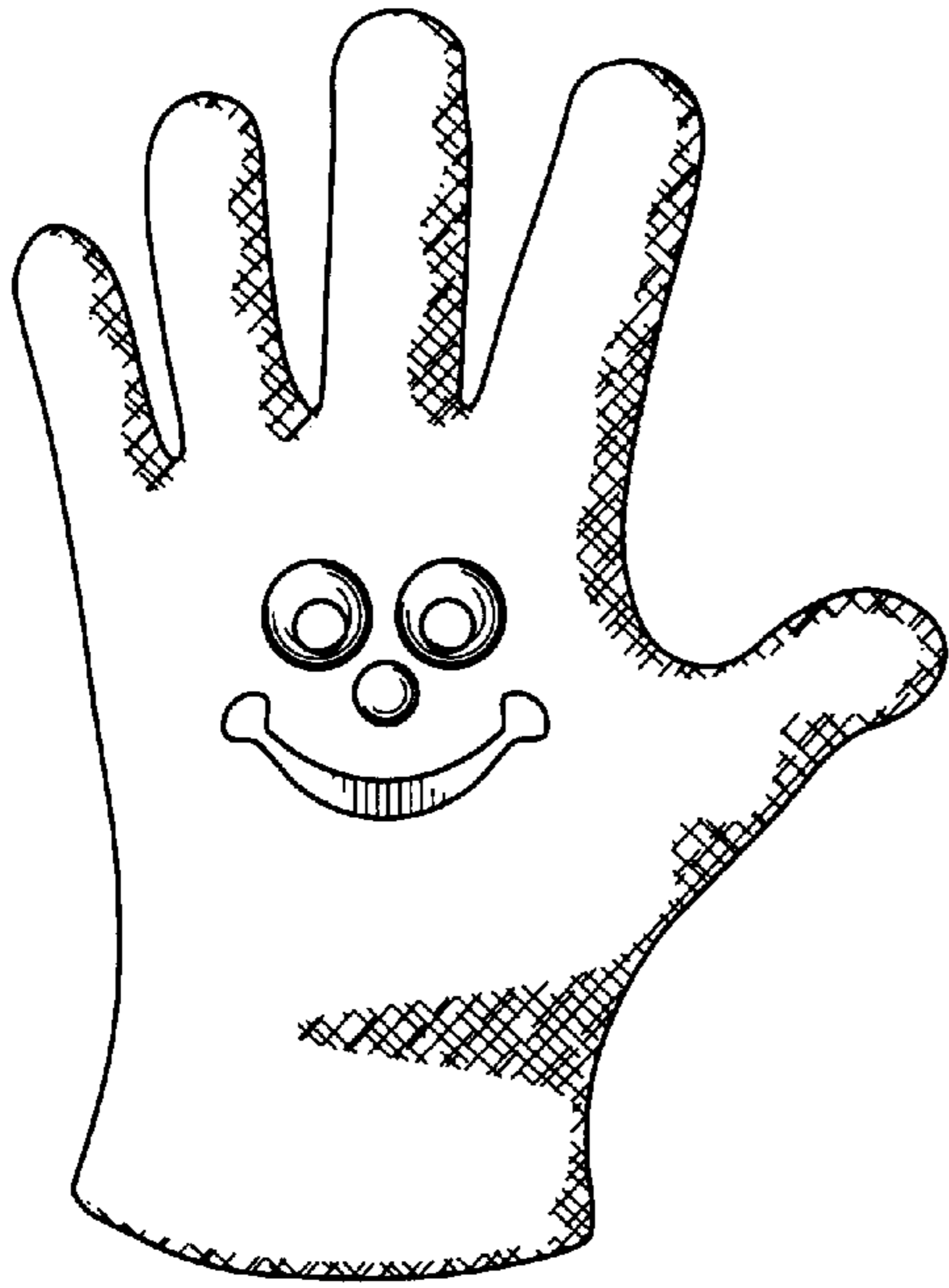

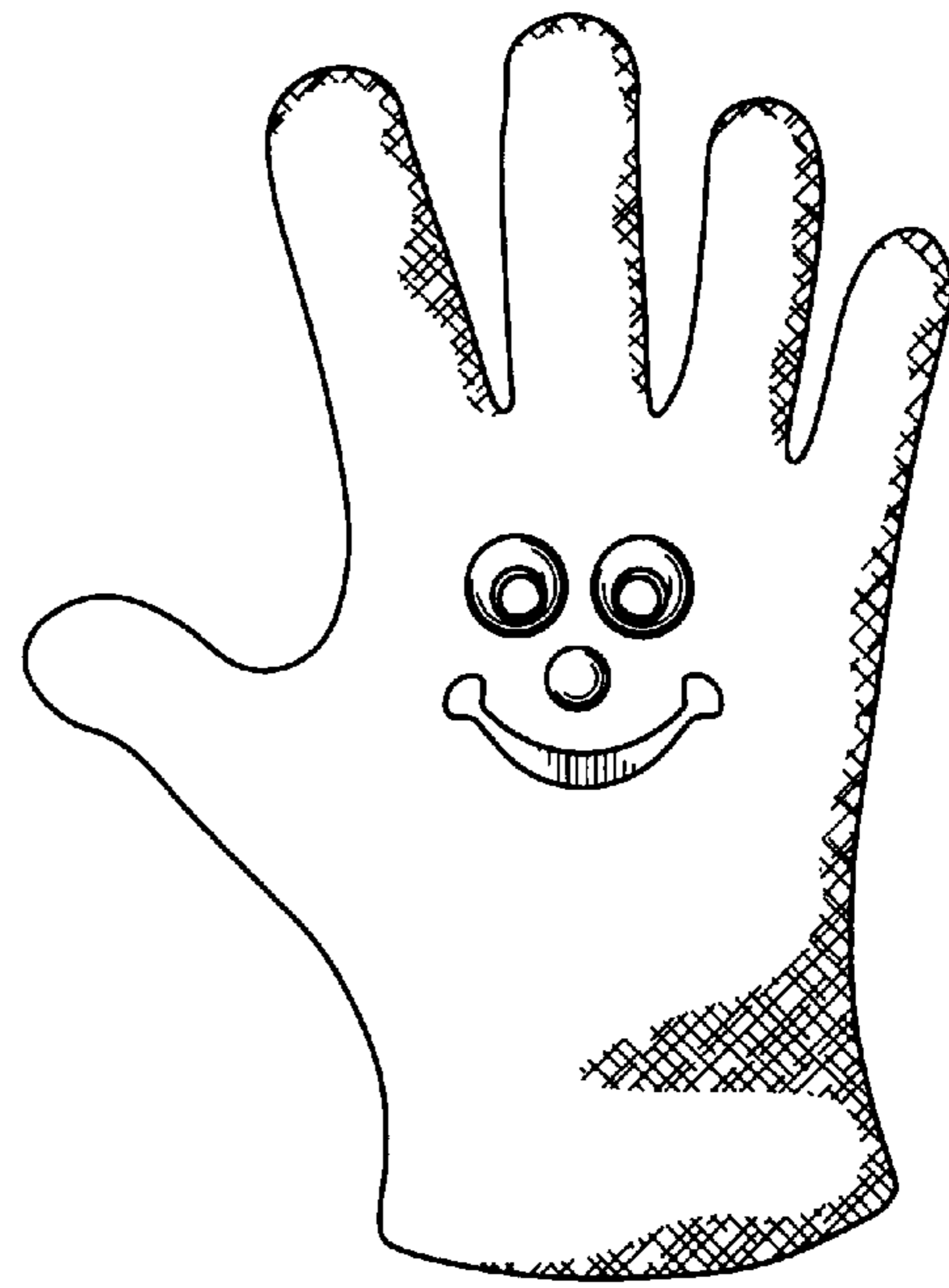

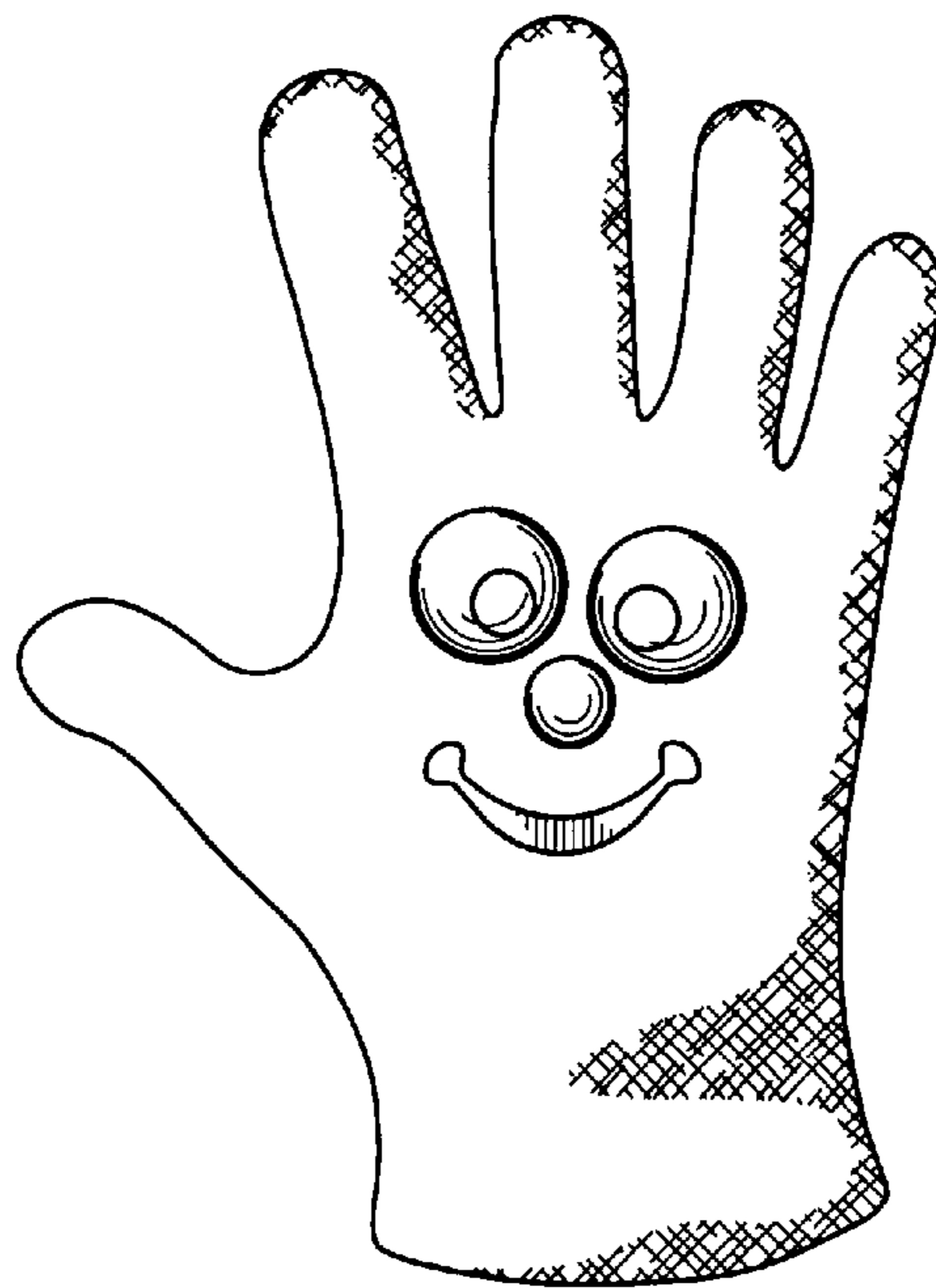
