DESCRIPTION

FIG. 1 is a perspective view of an upper body of float gauge head, showing my new design;

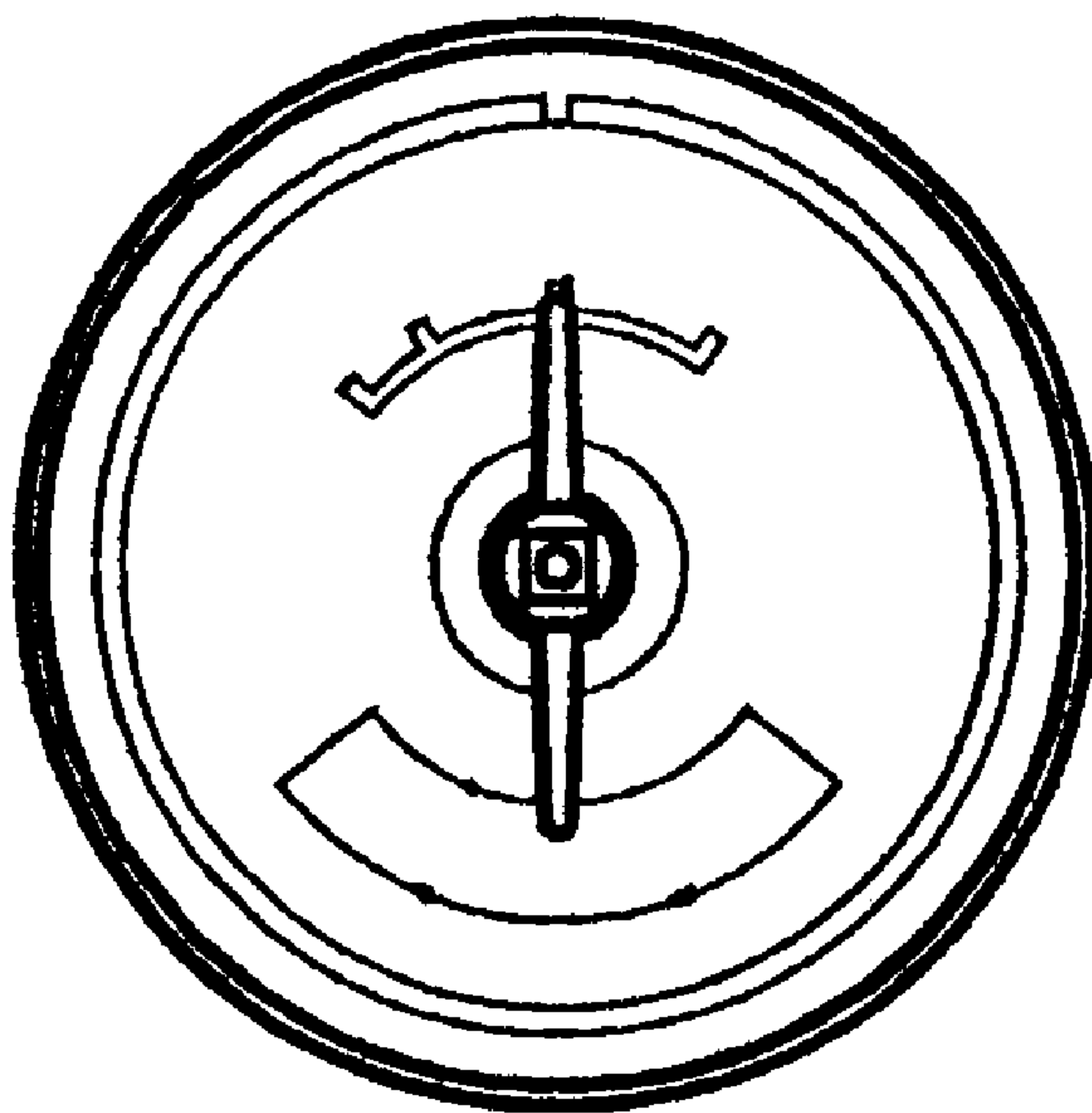

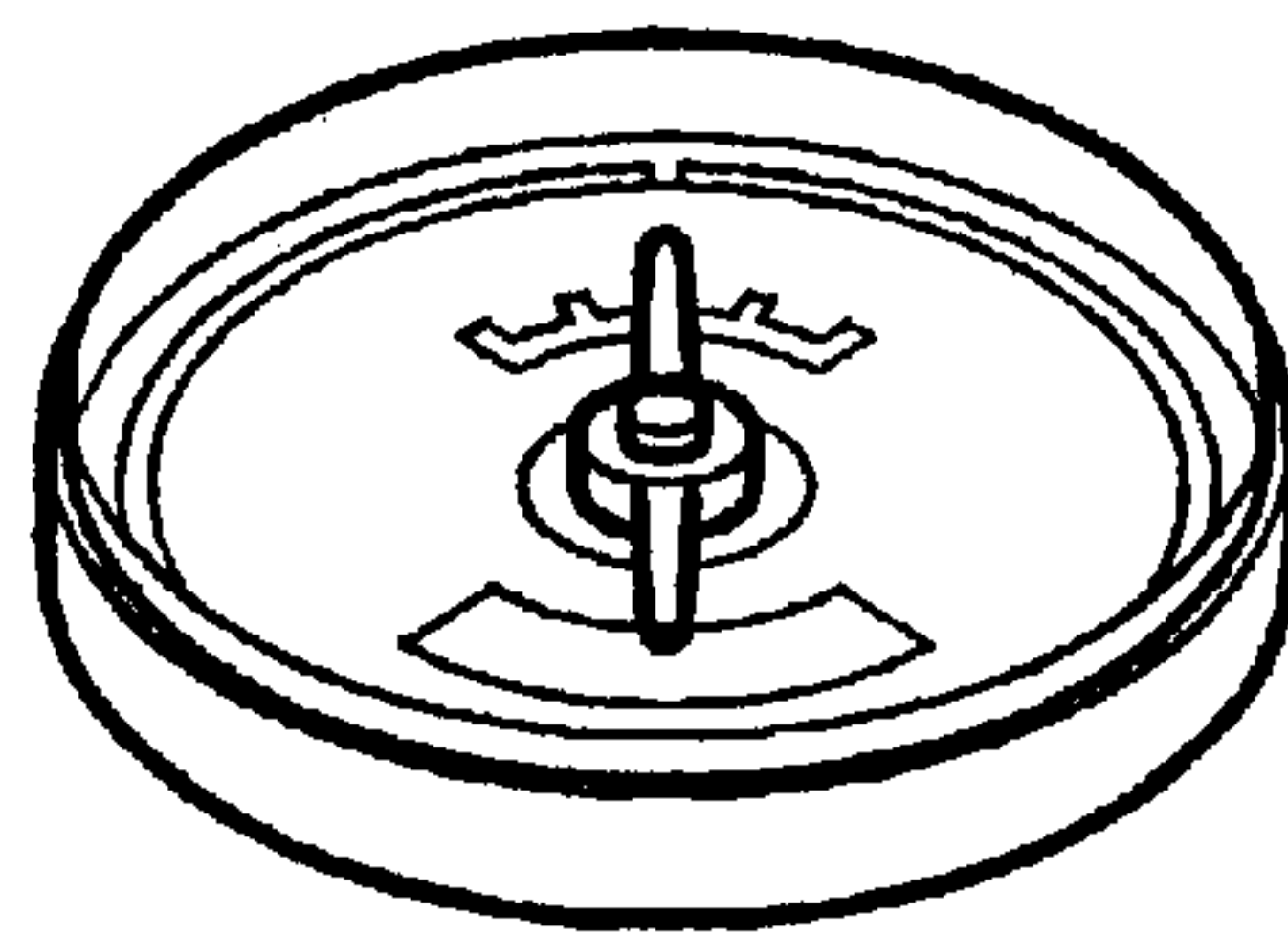

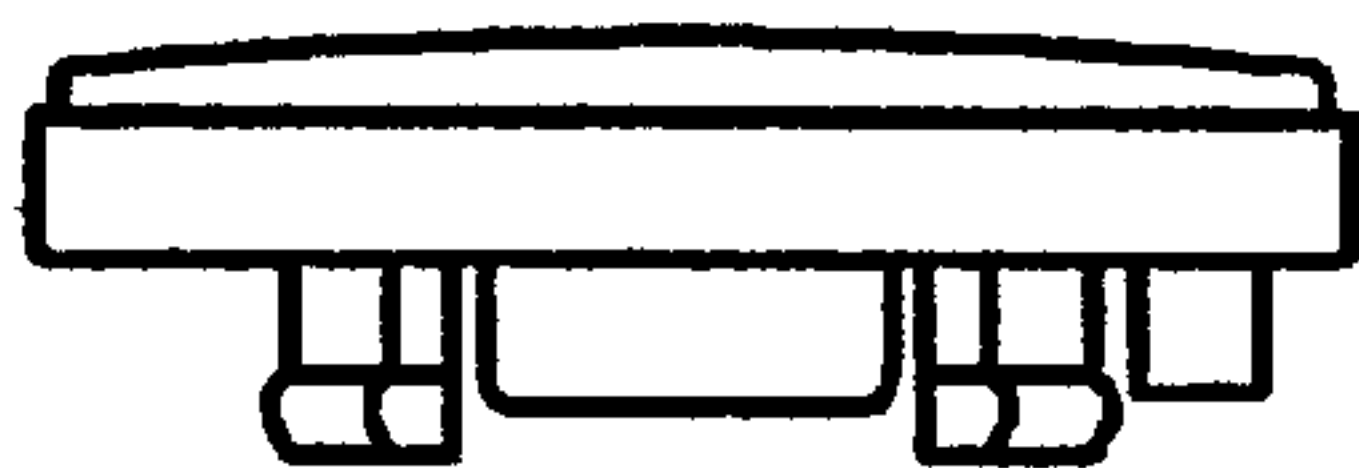

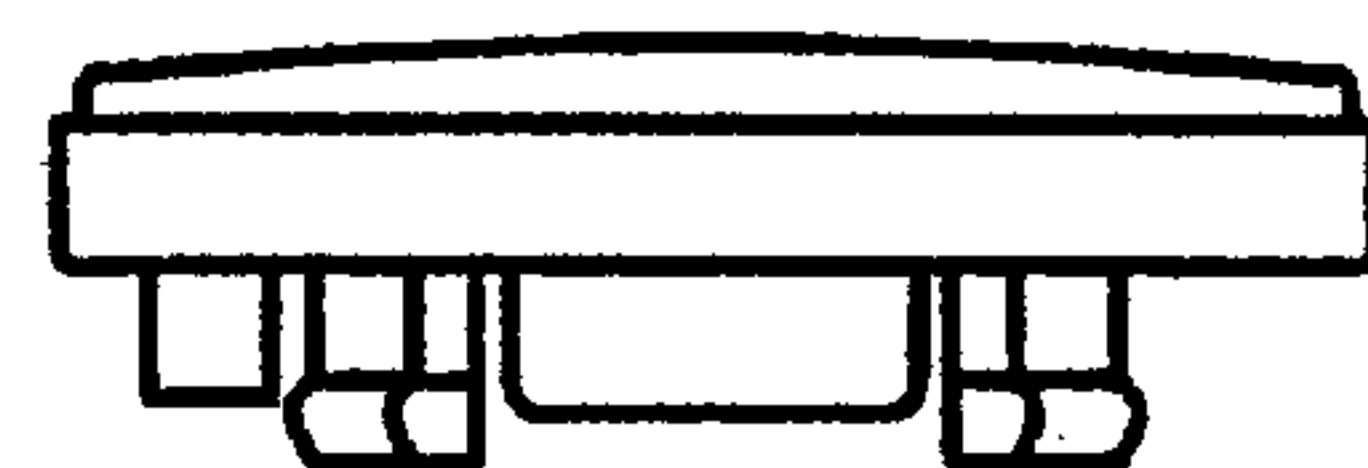

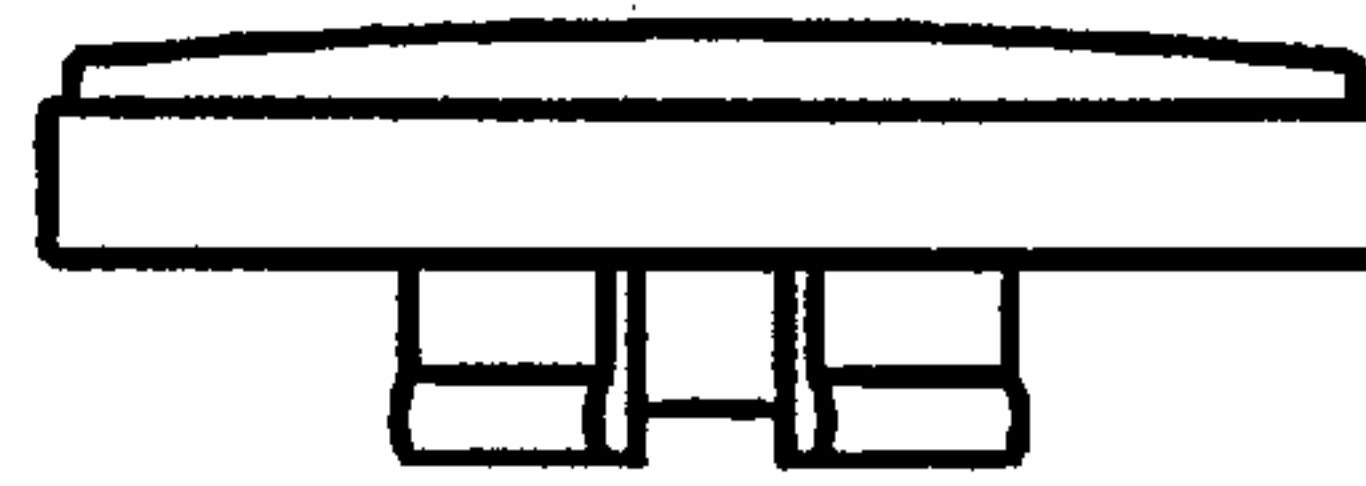

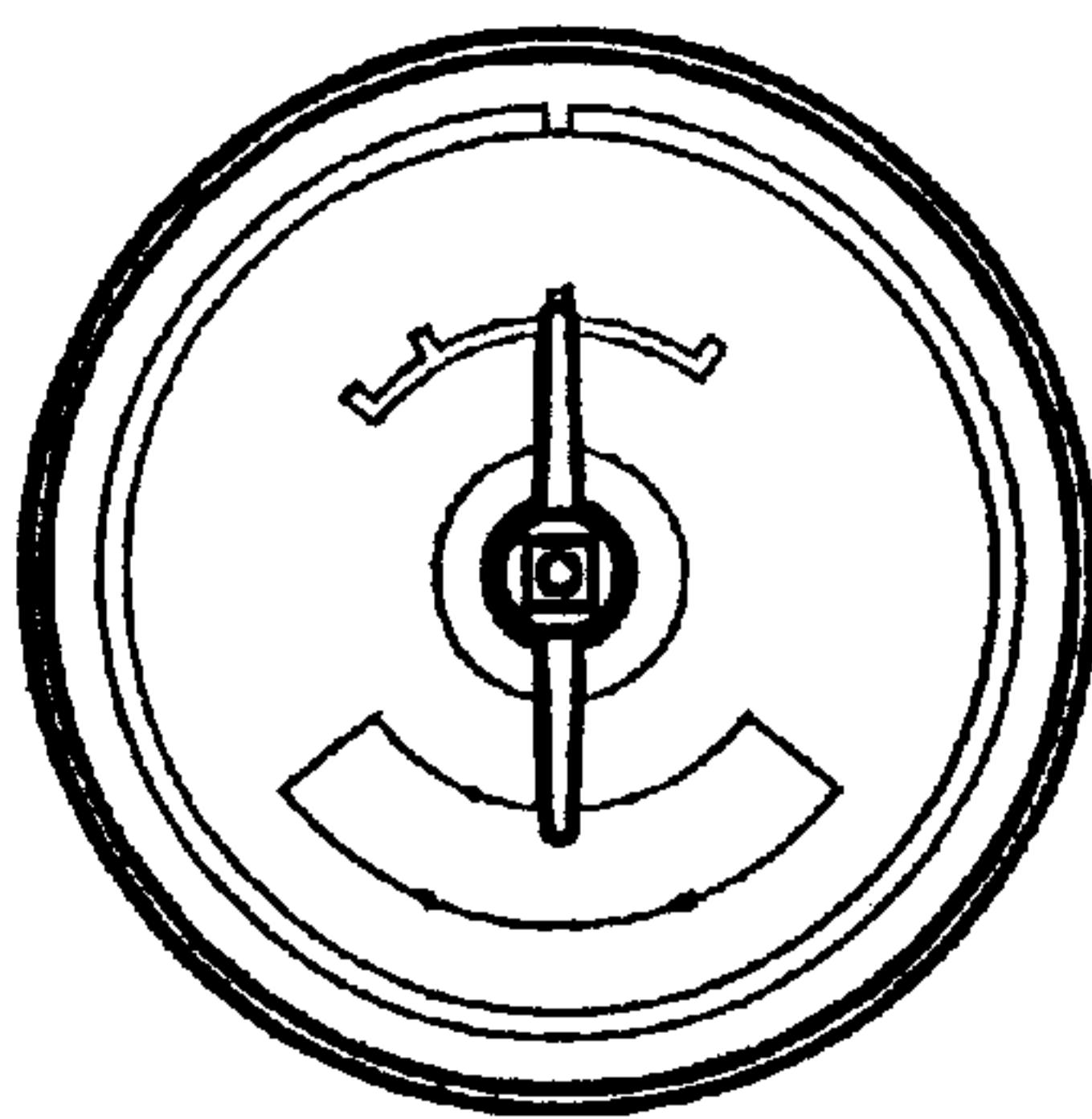
