(57) **CLAIM**

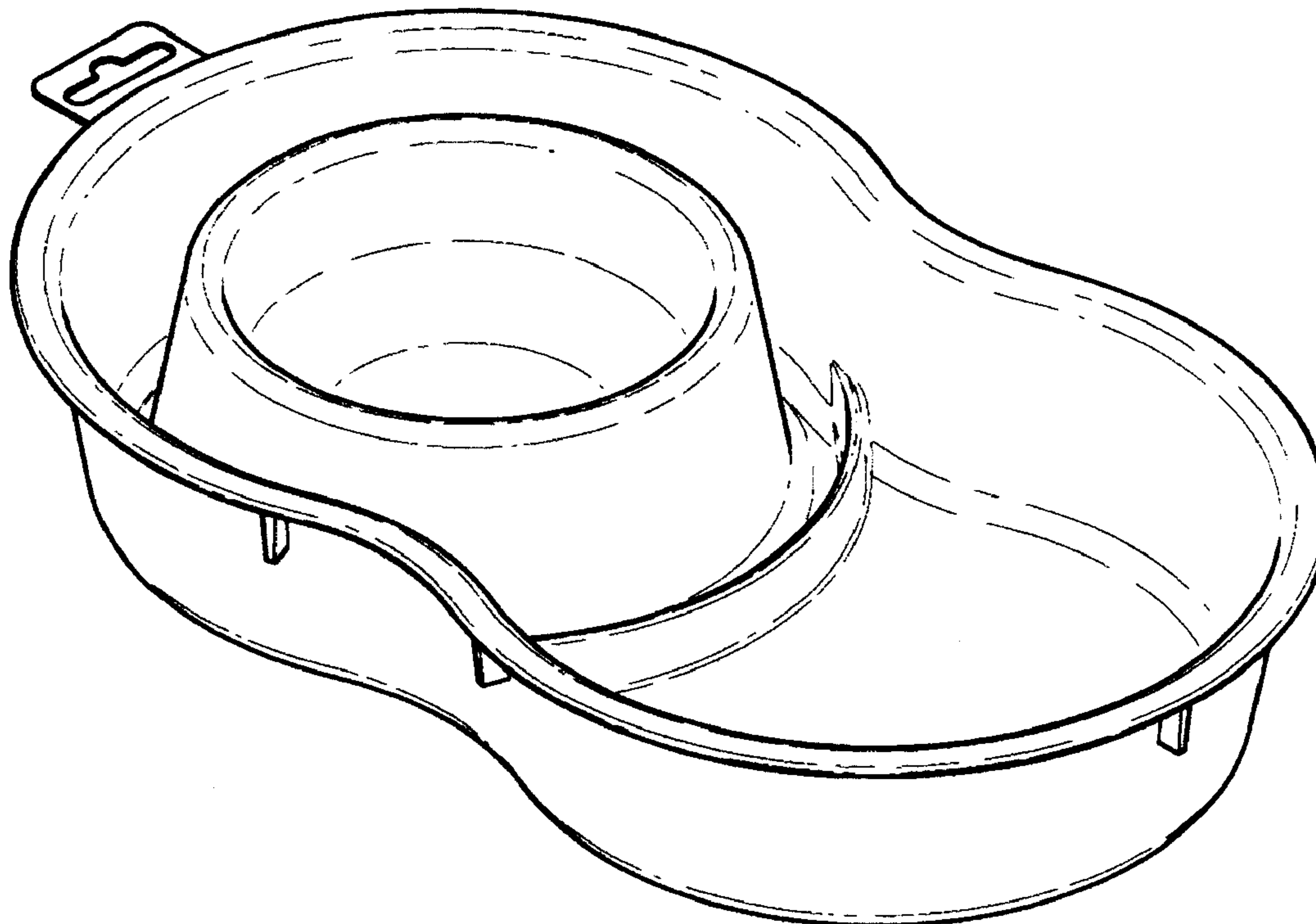
The ornamental design for a moated pet-food bowl, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a pet-food bowl showing our new design;
 FIG. 2 is a bottom perspective view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a cross-sectional view thereof, taken along line 6—6 in FIG. 3;
 FIG. 7 is a front elevational view thereof; and,
 FIG. 8 is a cross-sectional view thereof, taken along line 8—8 in FIG. 3.

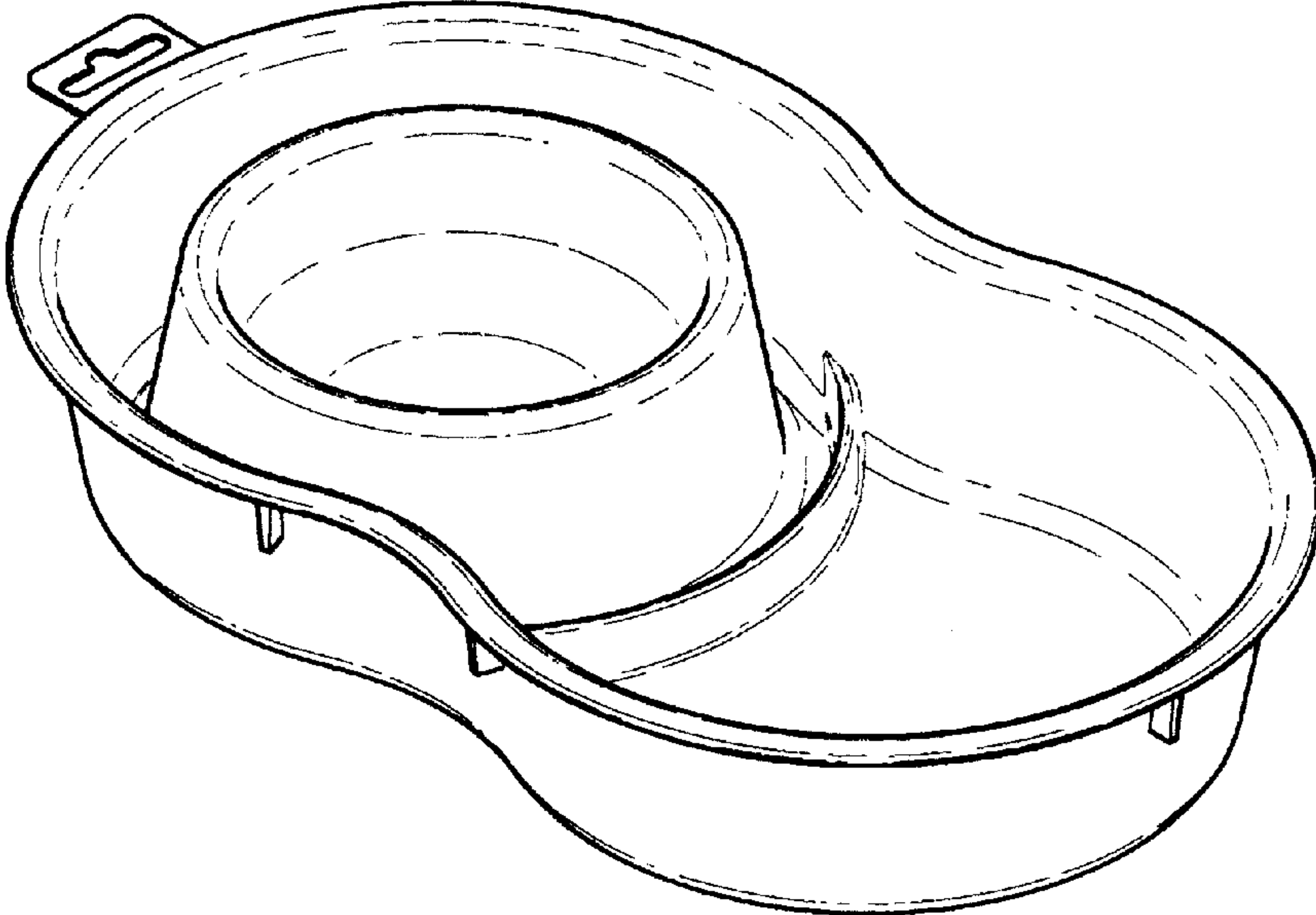

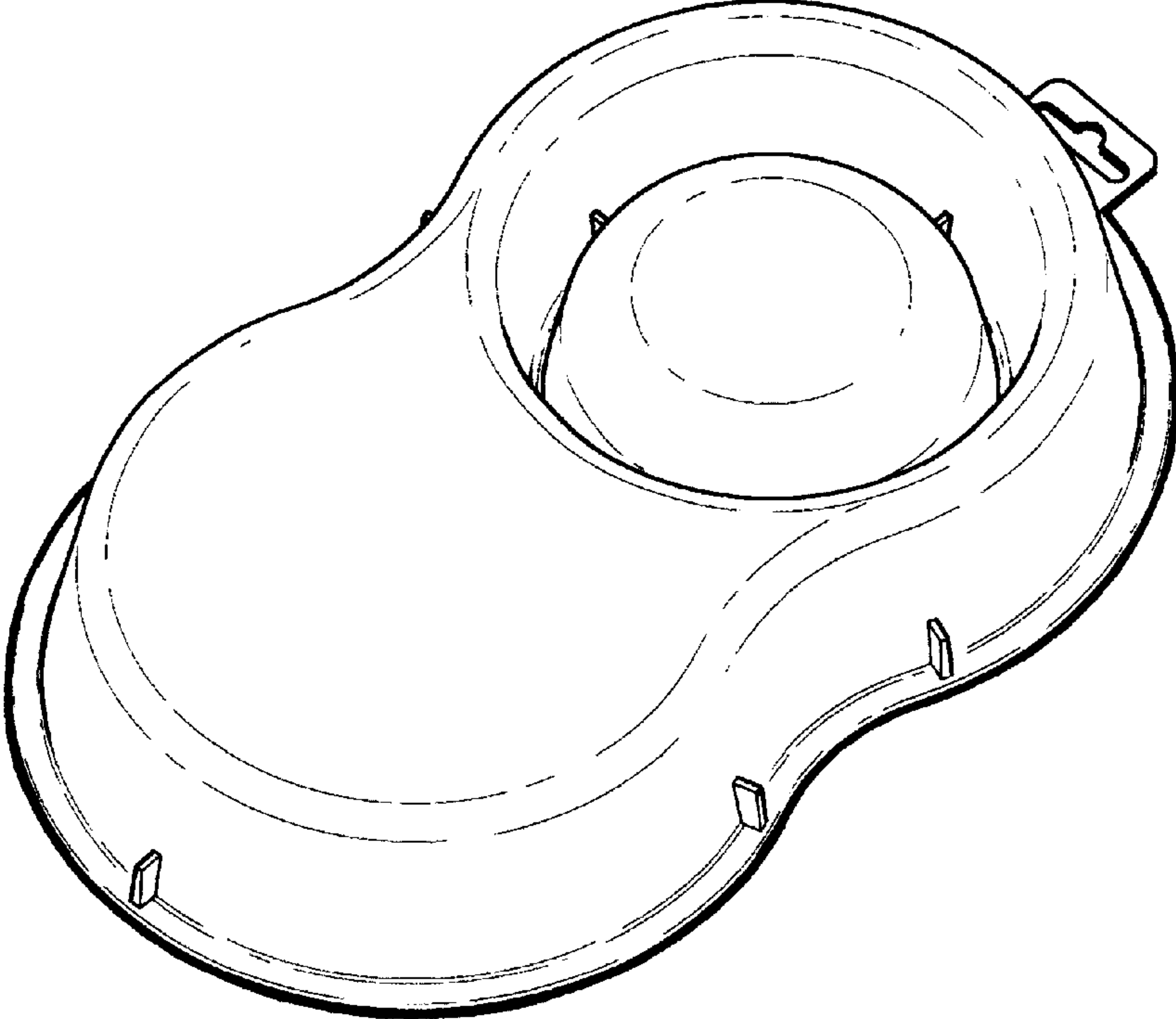

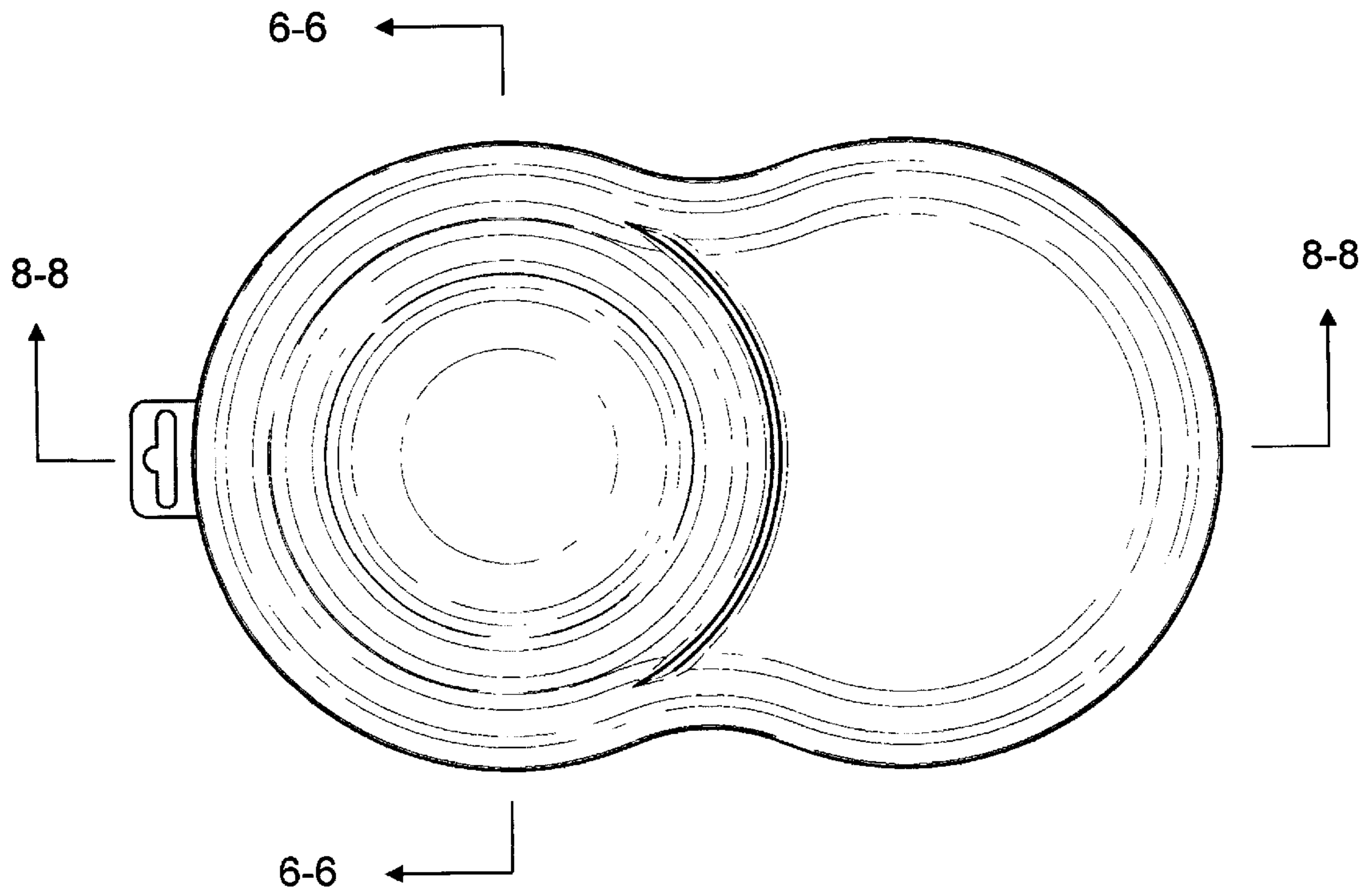

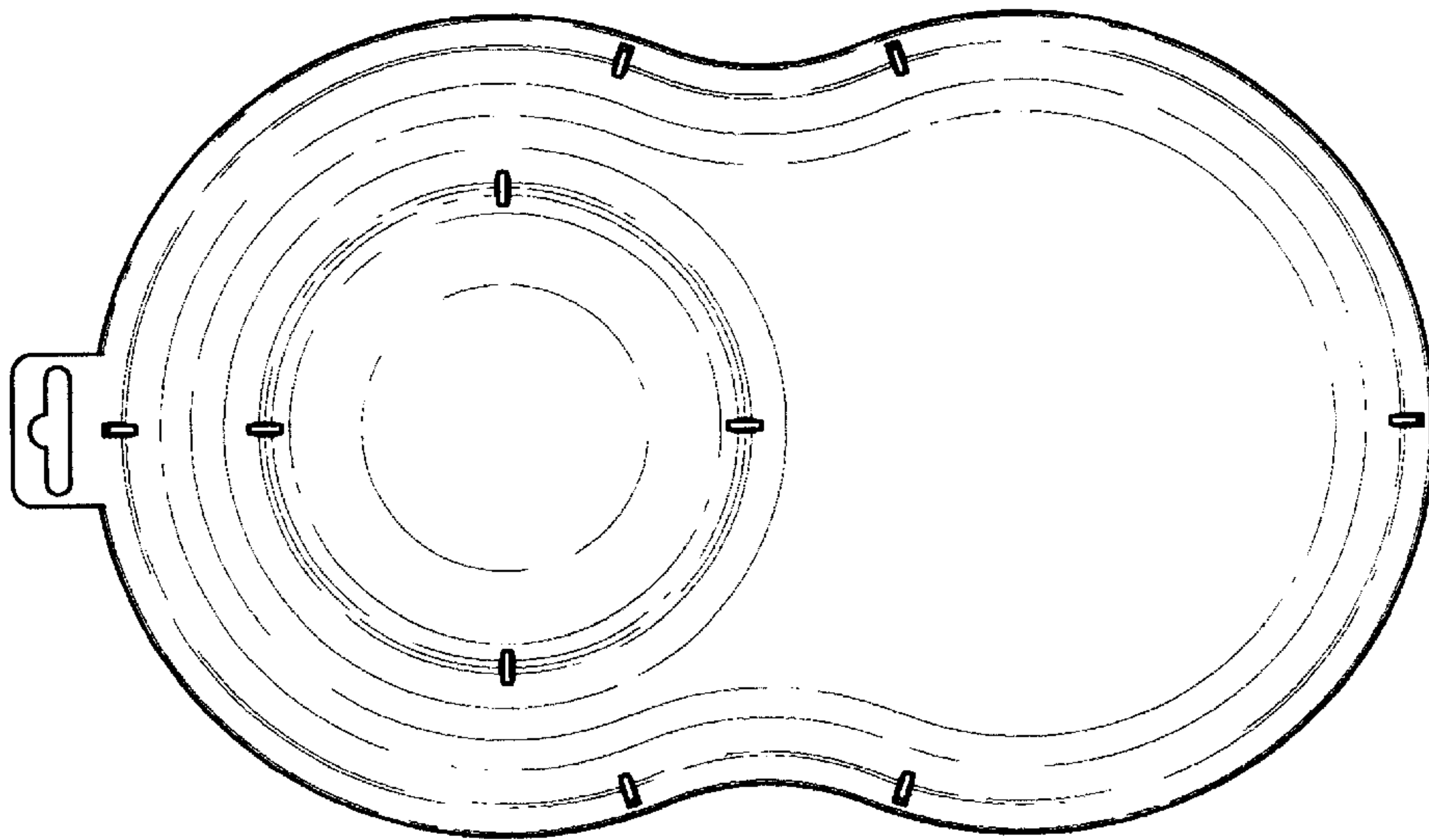

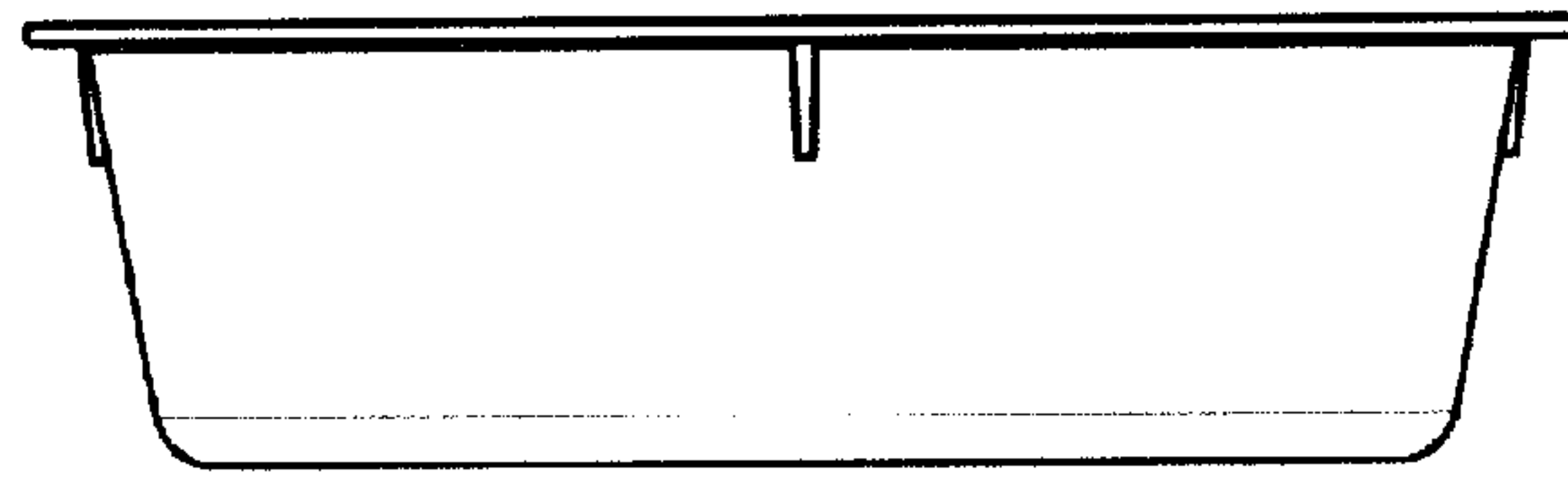

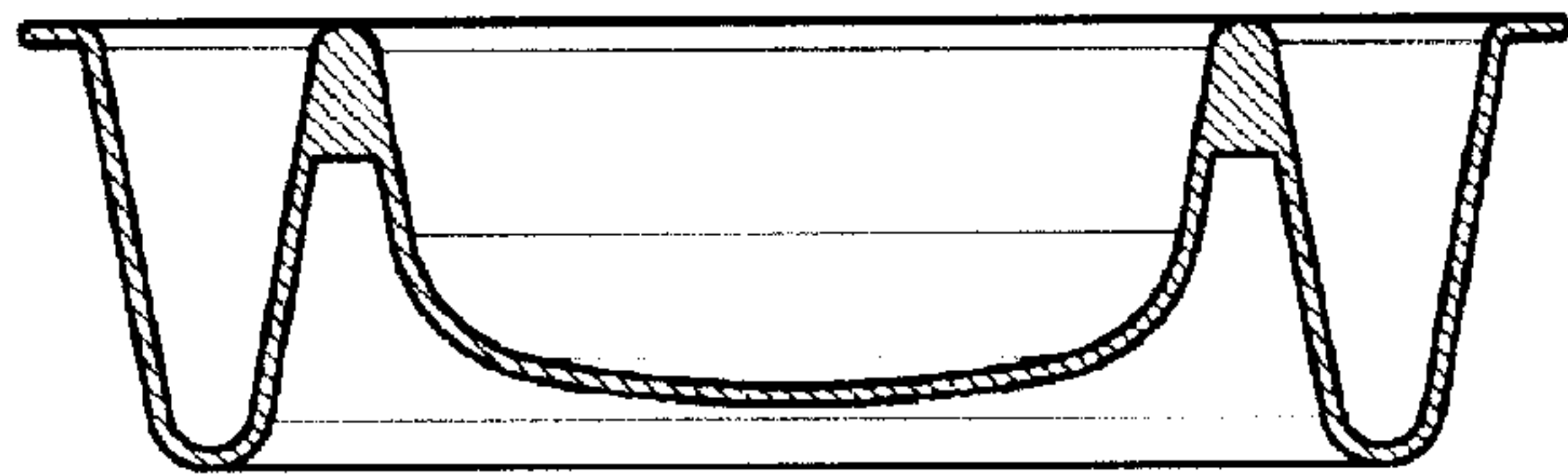

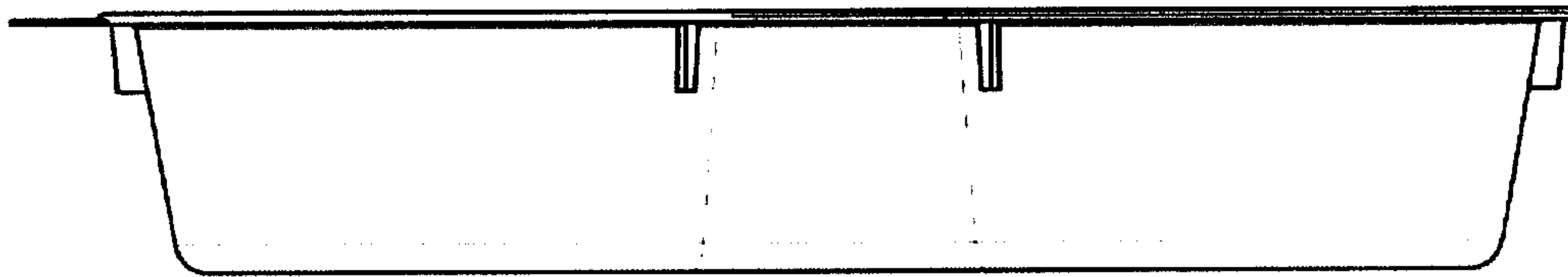

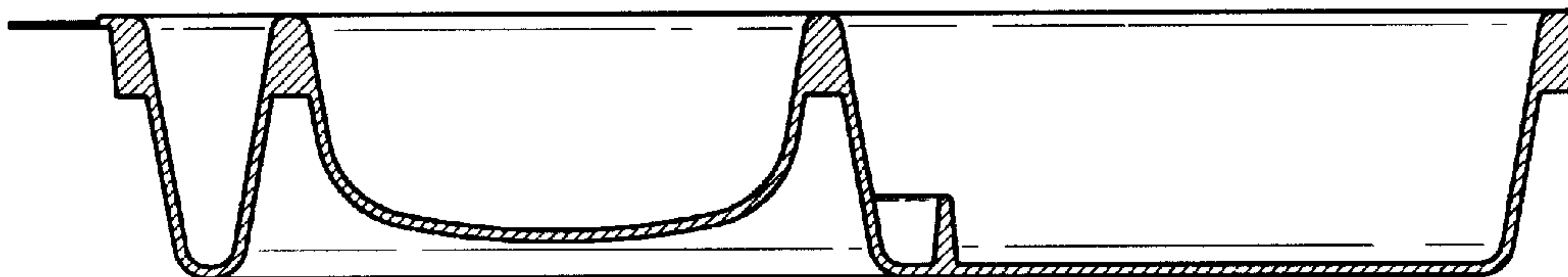
