FIG. 3 is a right side elevational view of a pair of shoe outsoles of this invention;

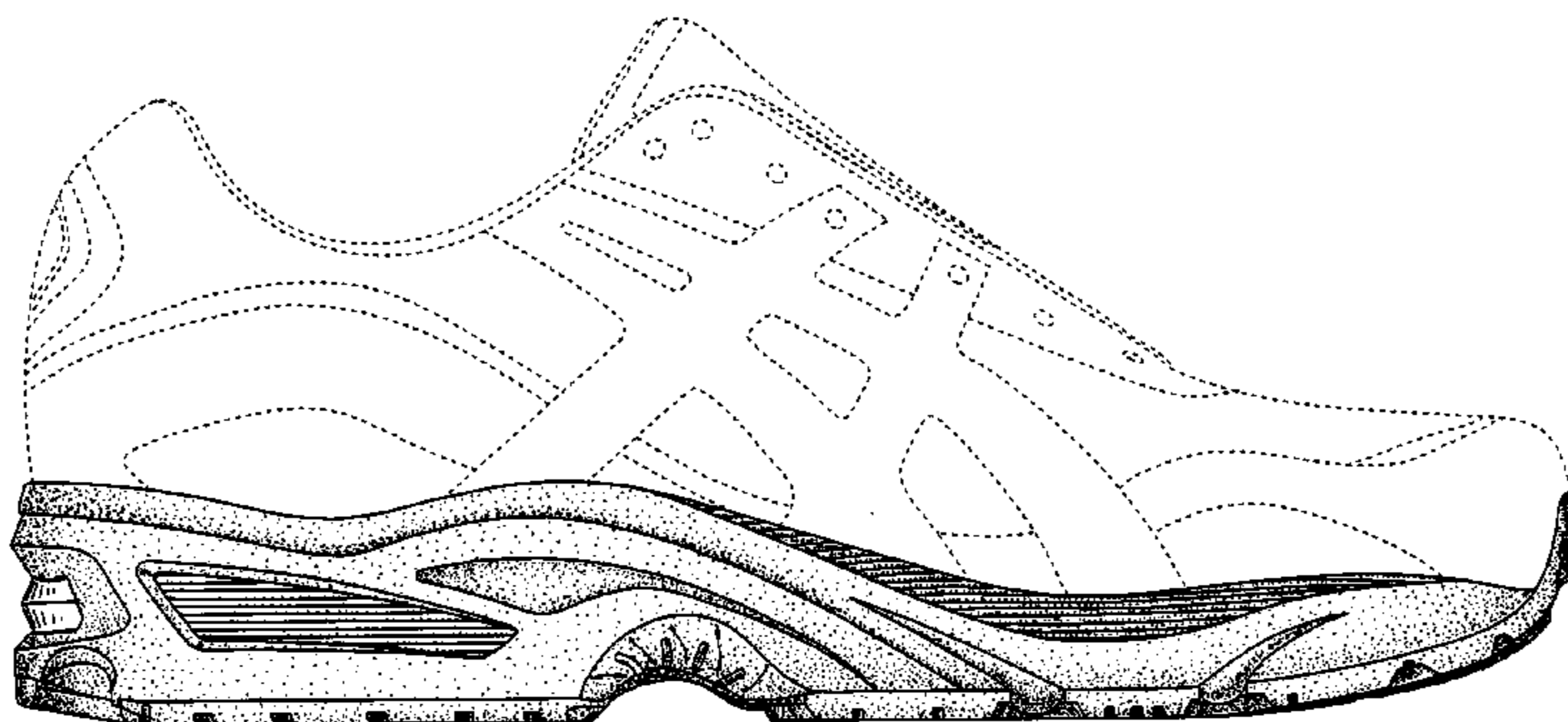
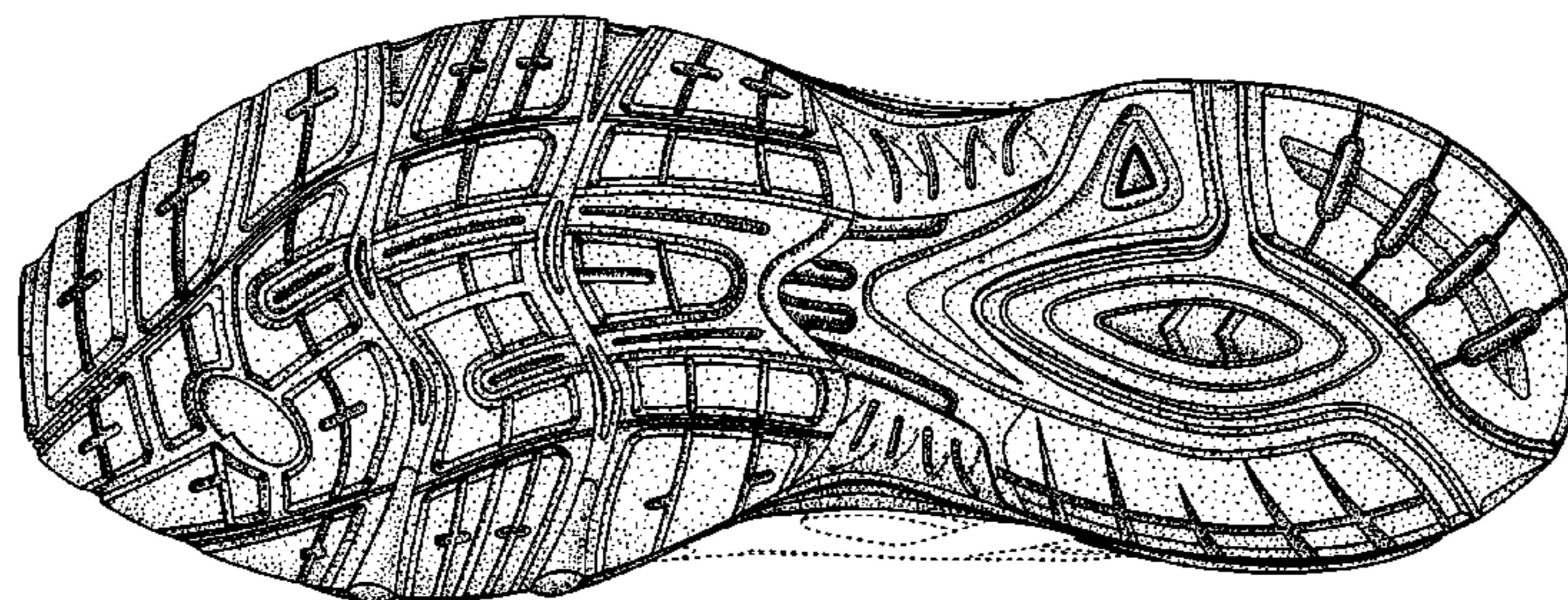
FIG. 4 is a left side elevational view of a pair of shoe outsoles of this invention;

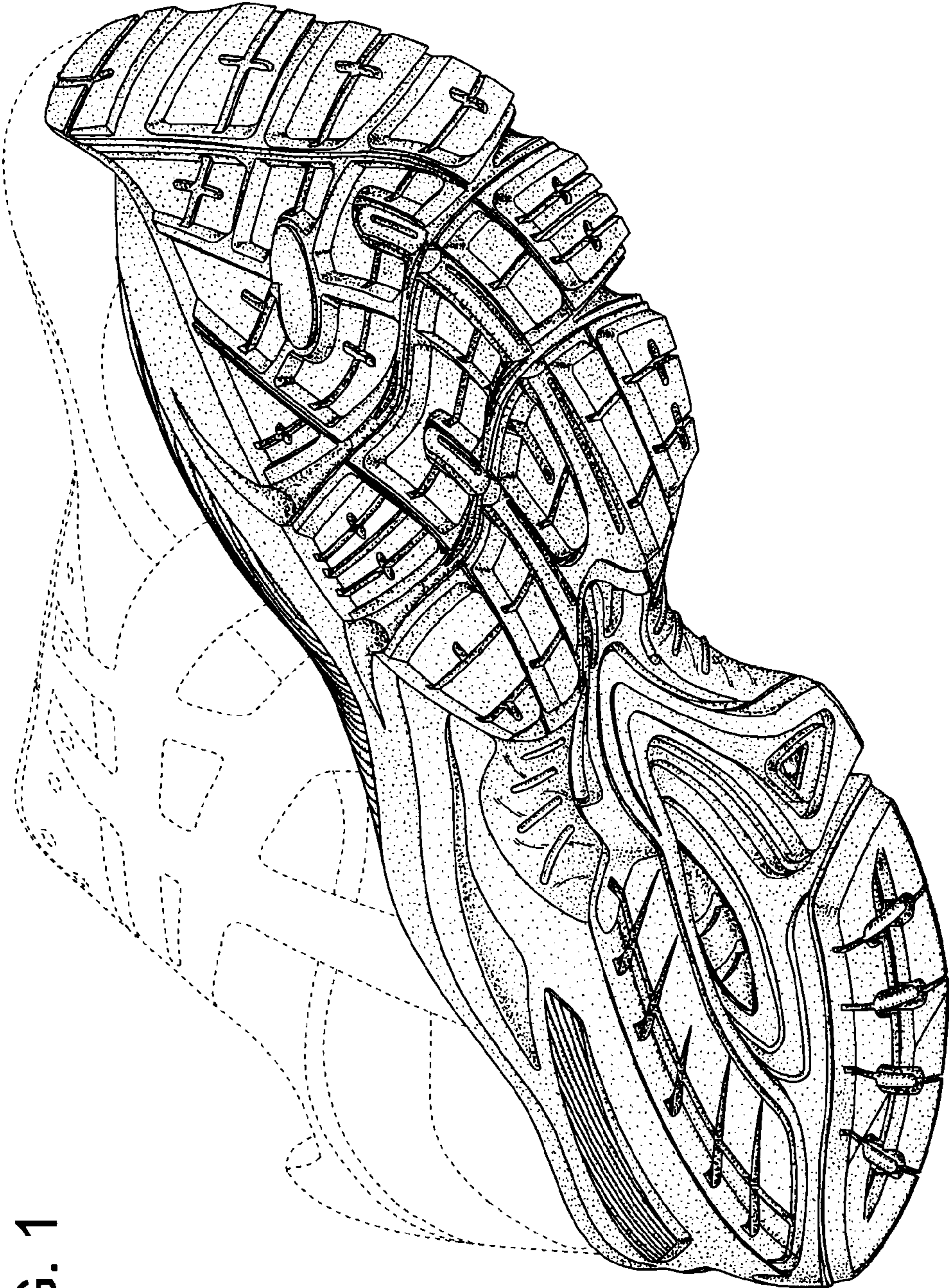

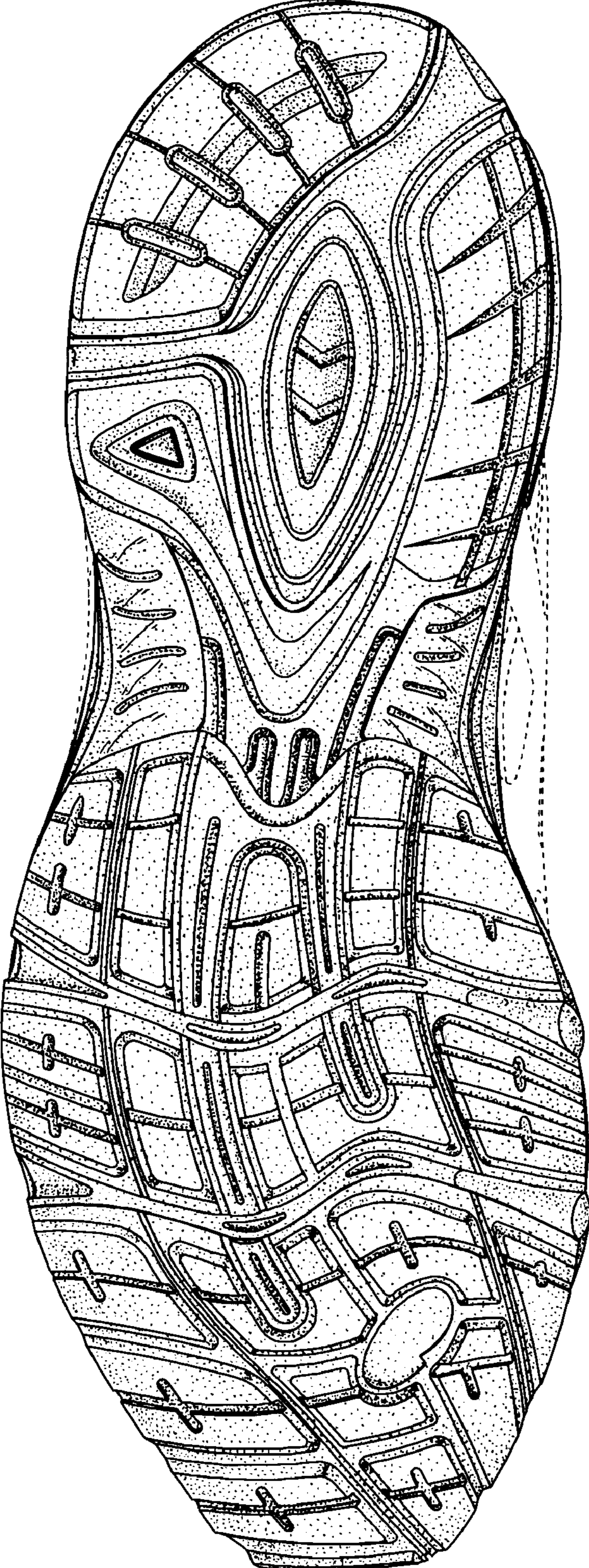

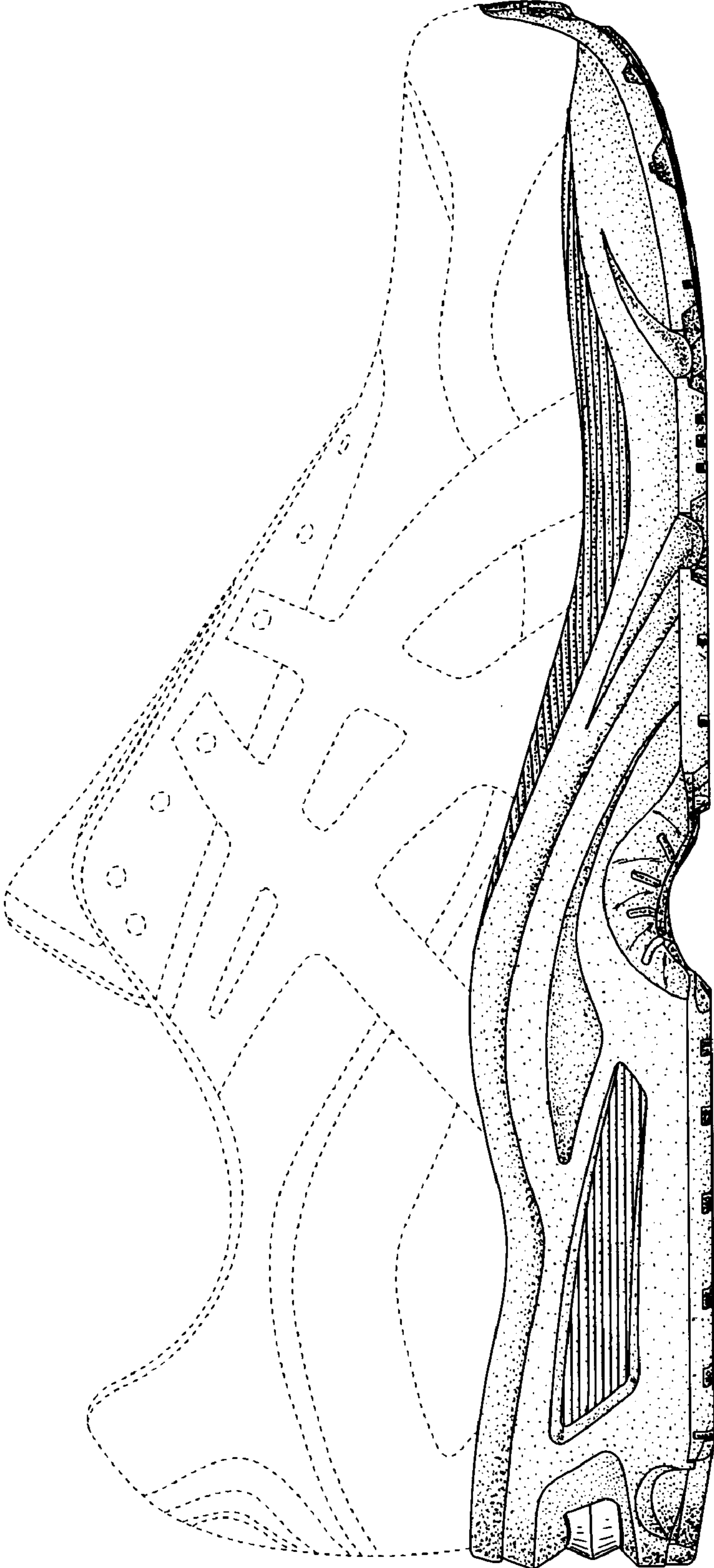

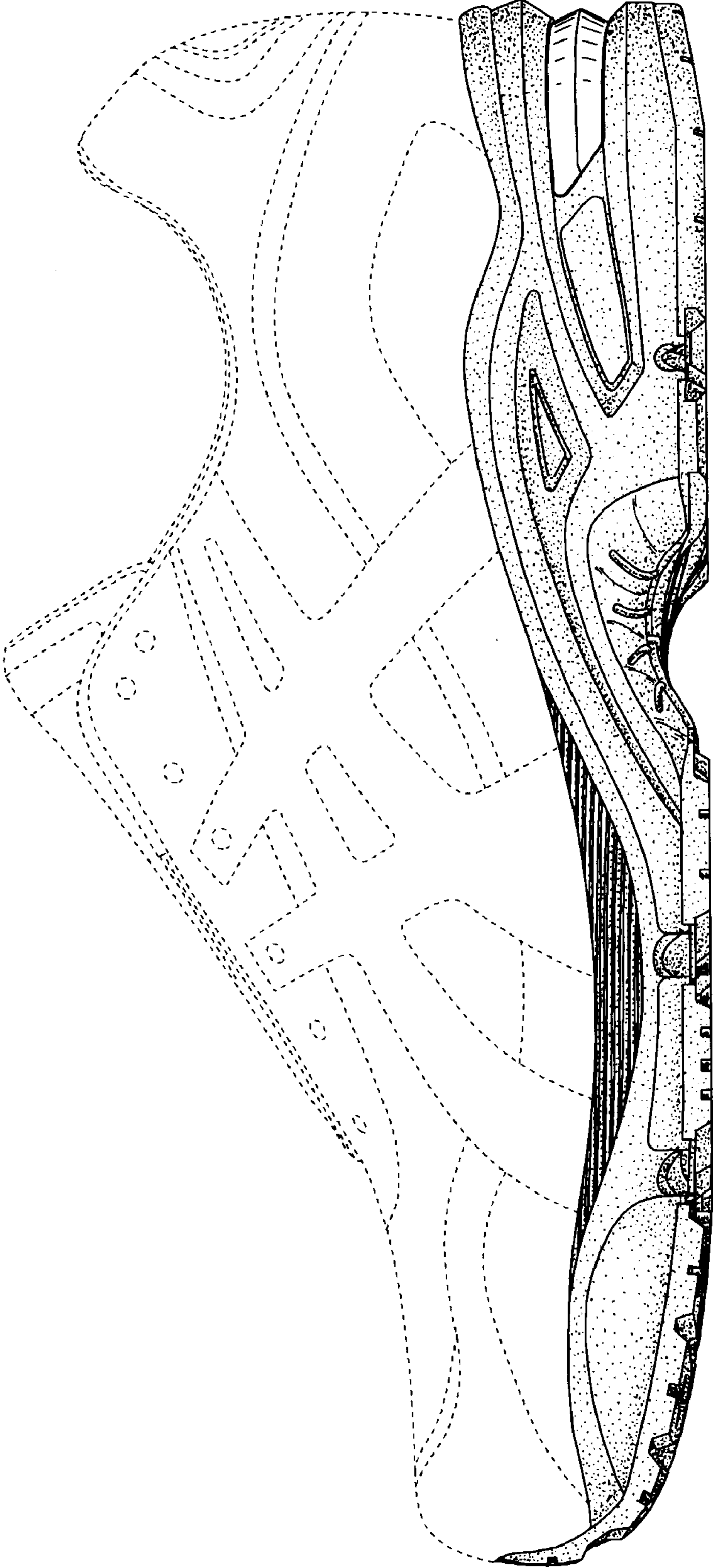

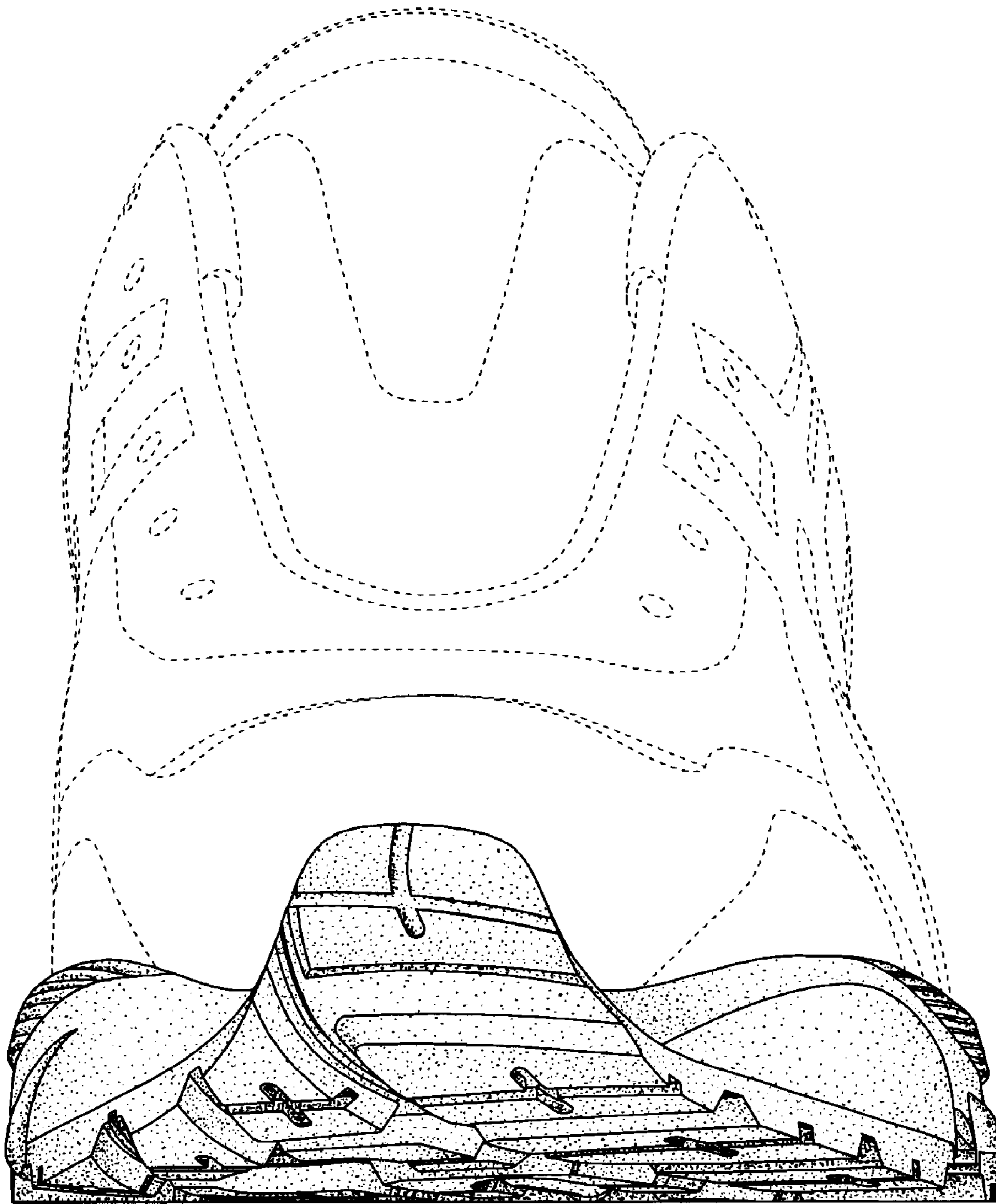
