The ornamental design for a beverage bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a beverage bottle showing our new design;

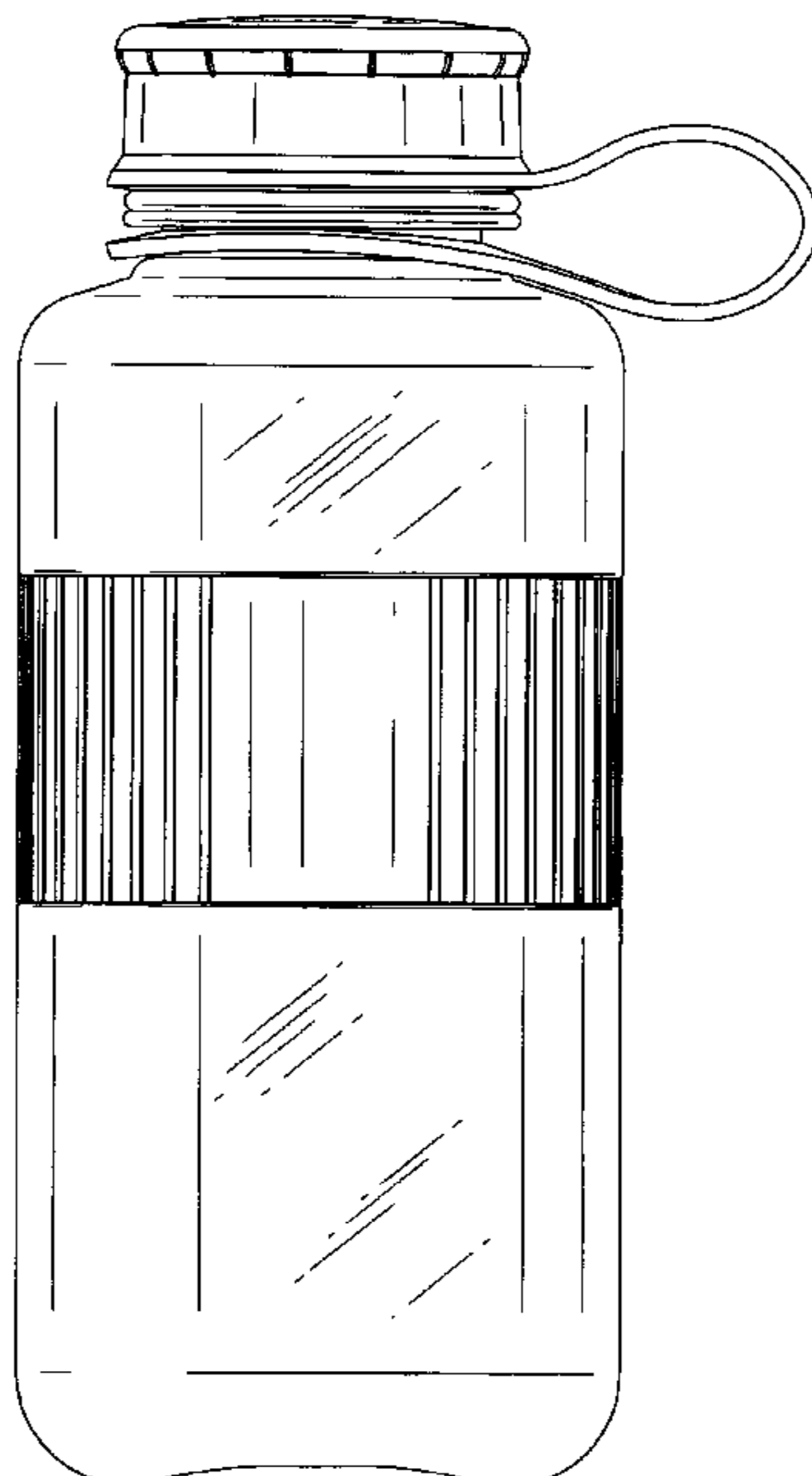

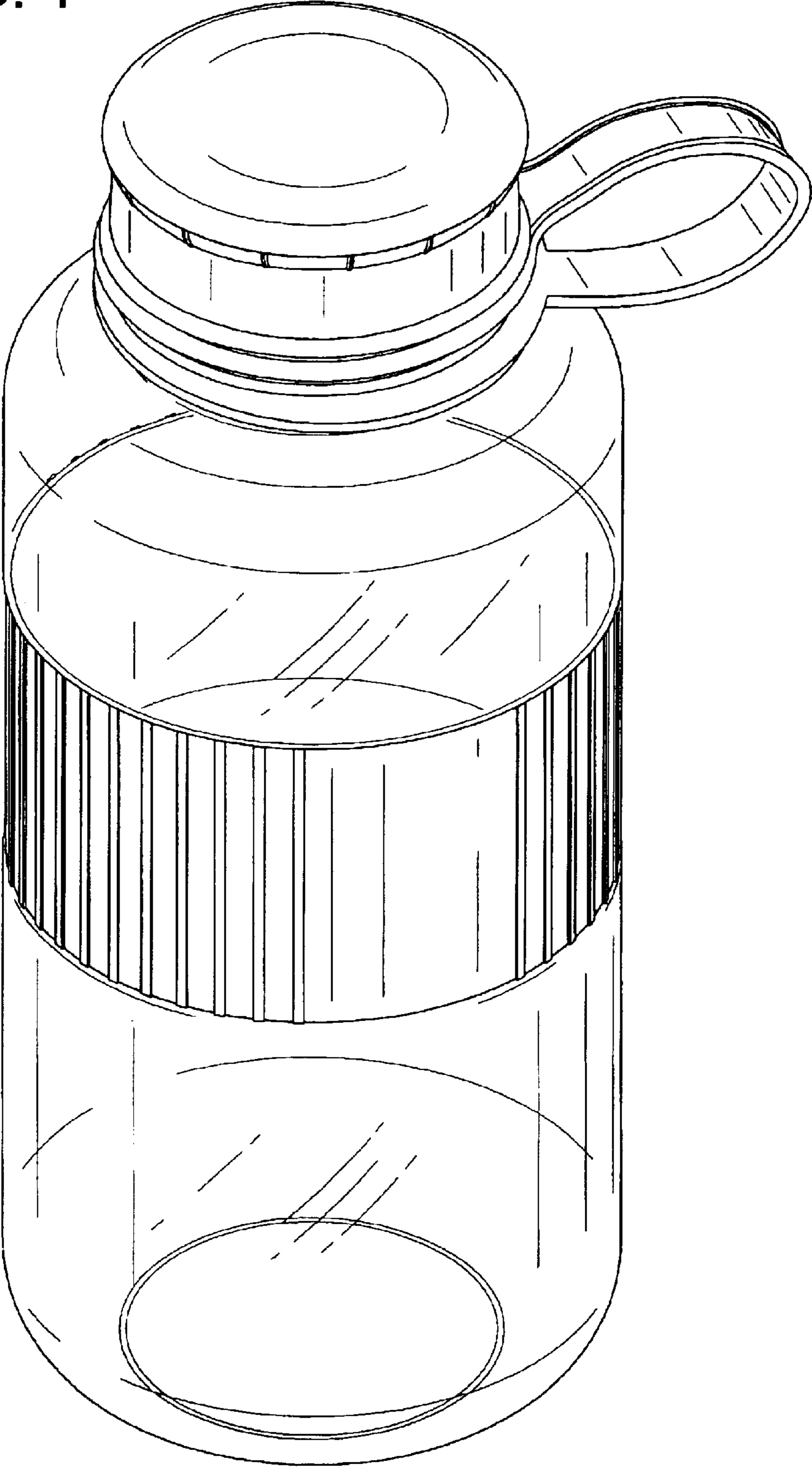

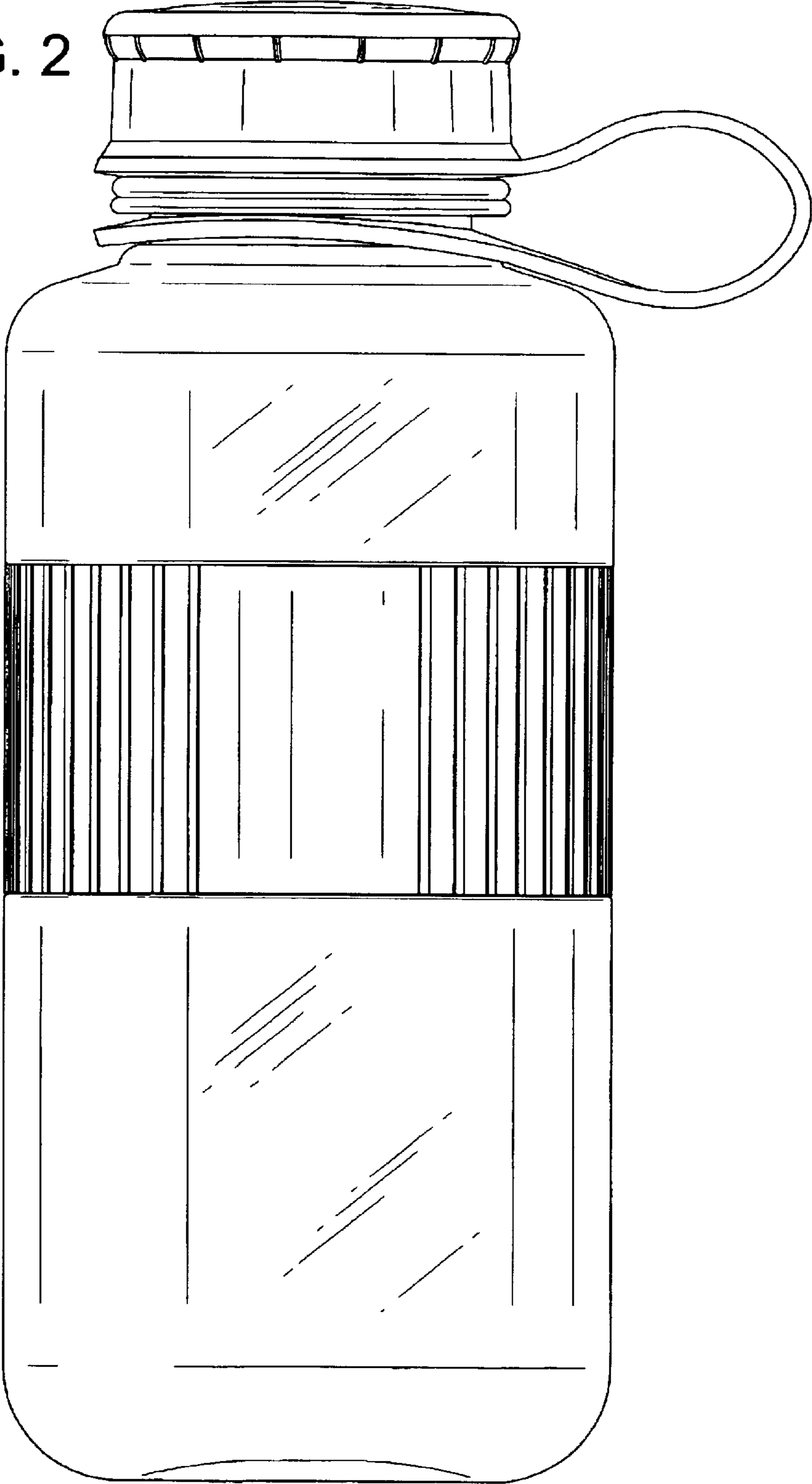

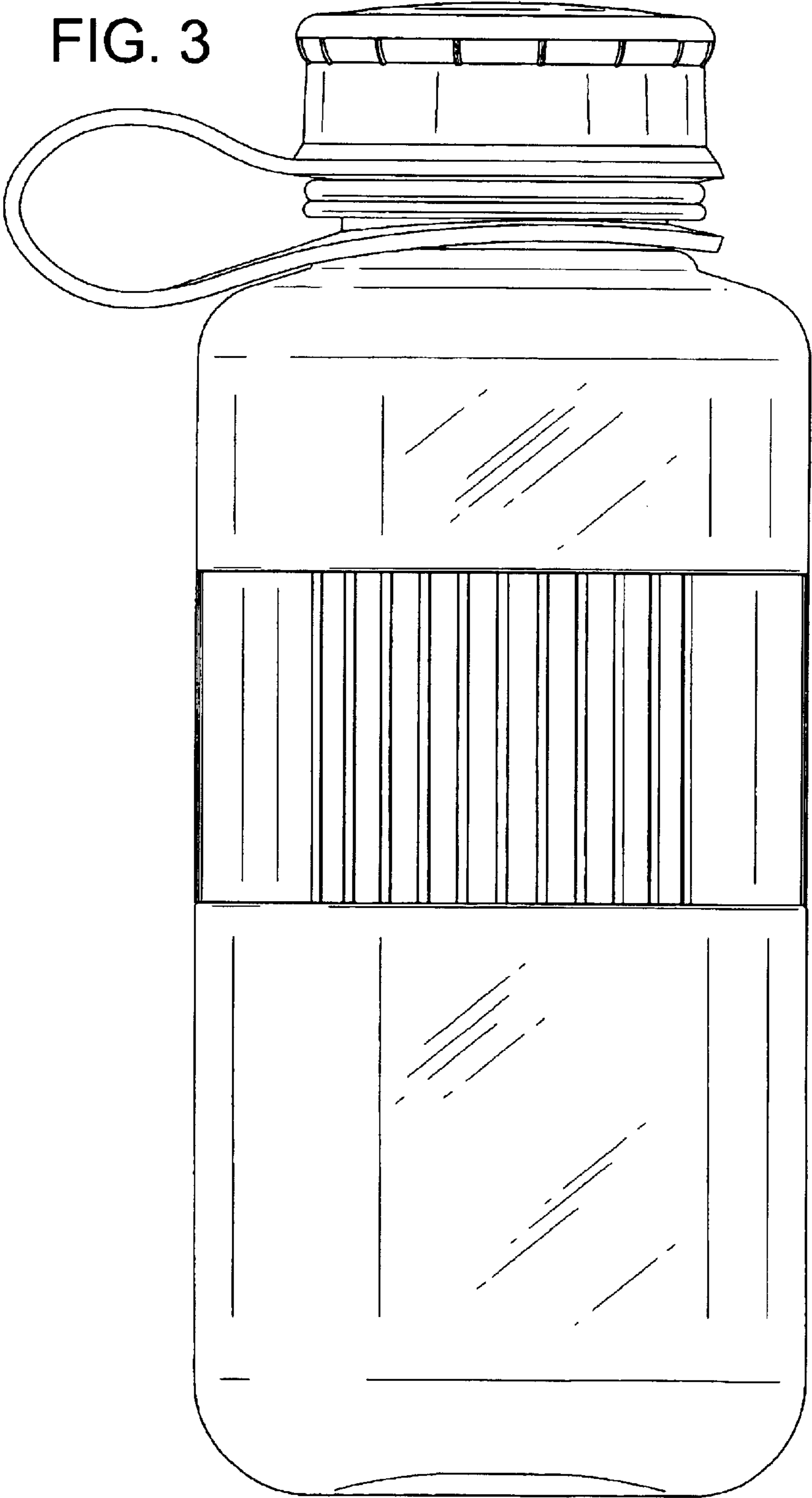

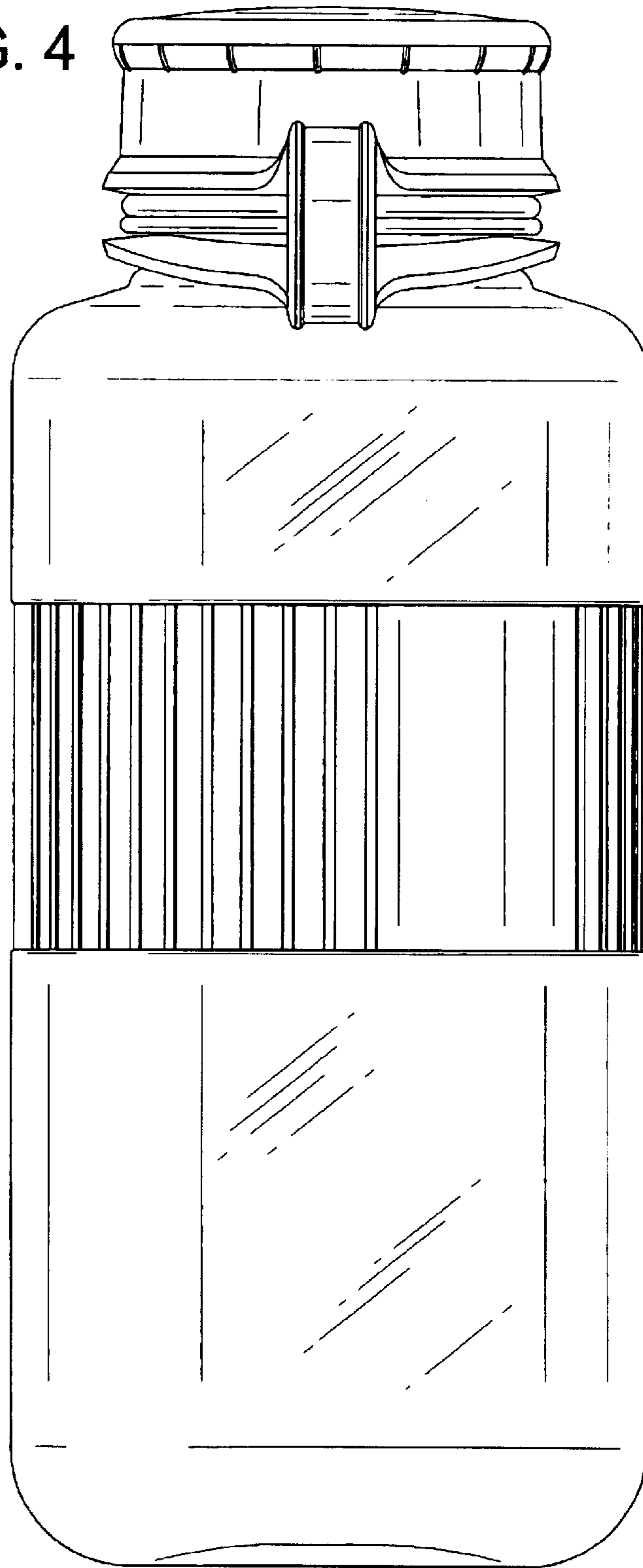

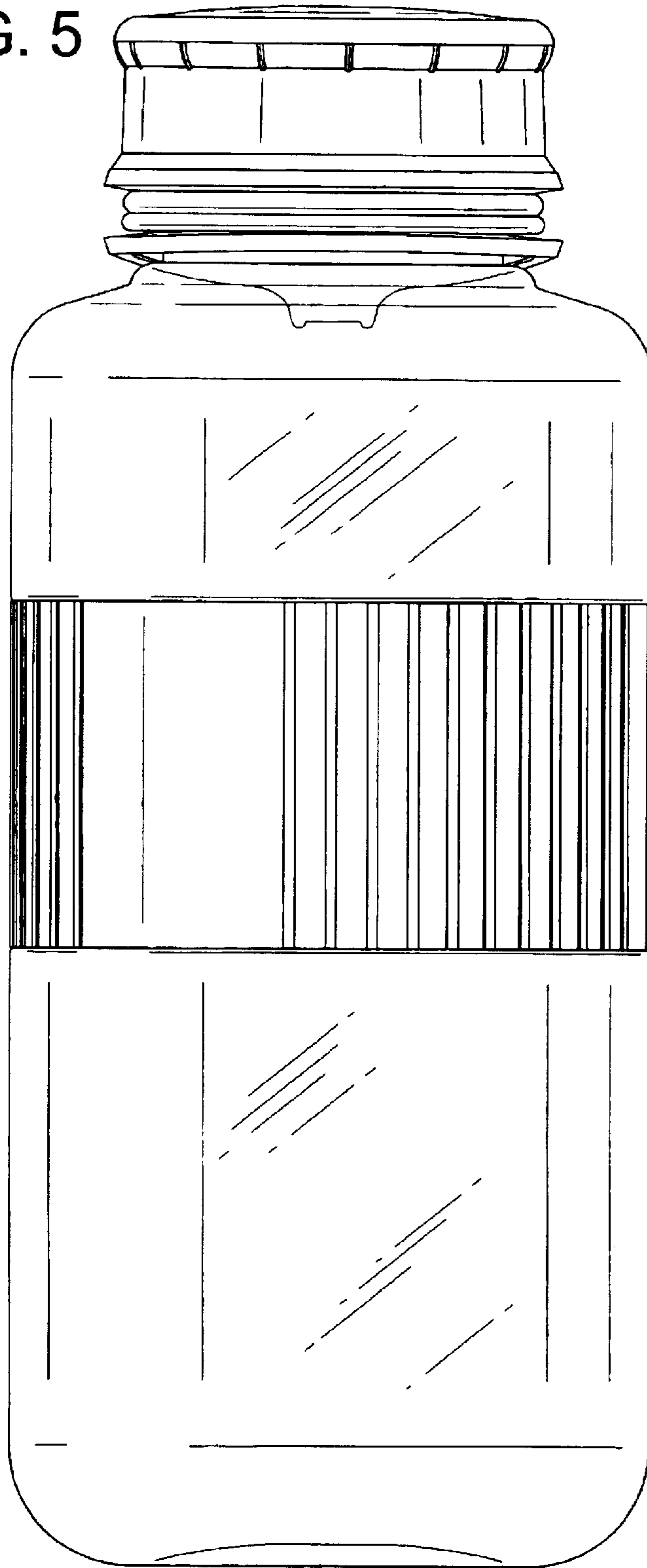

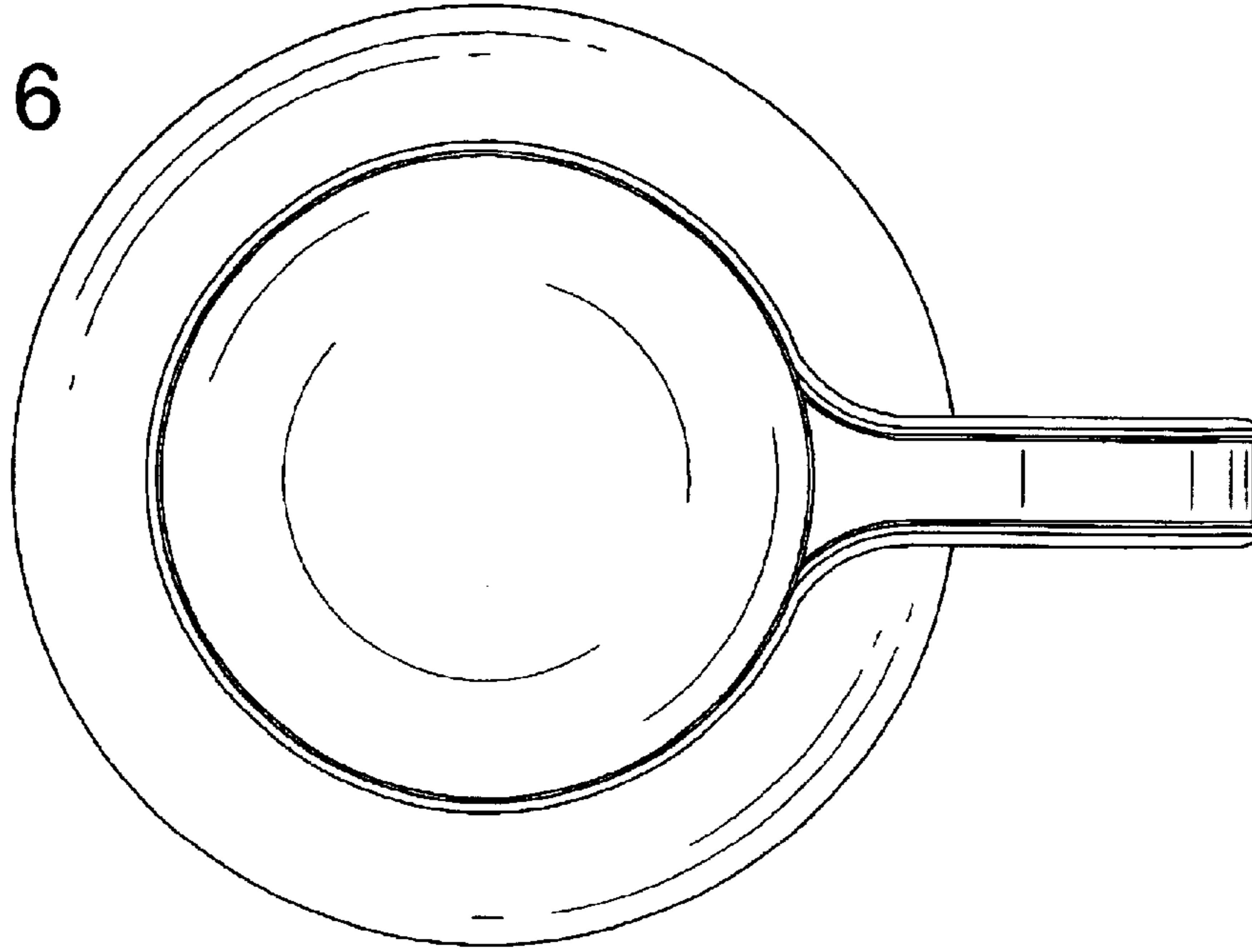
