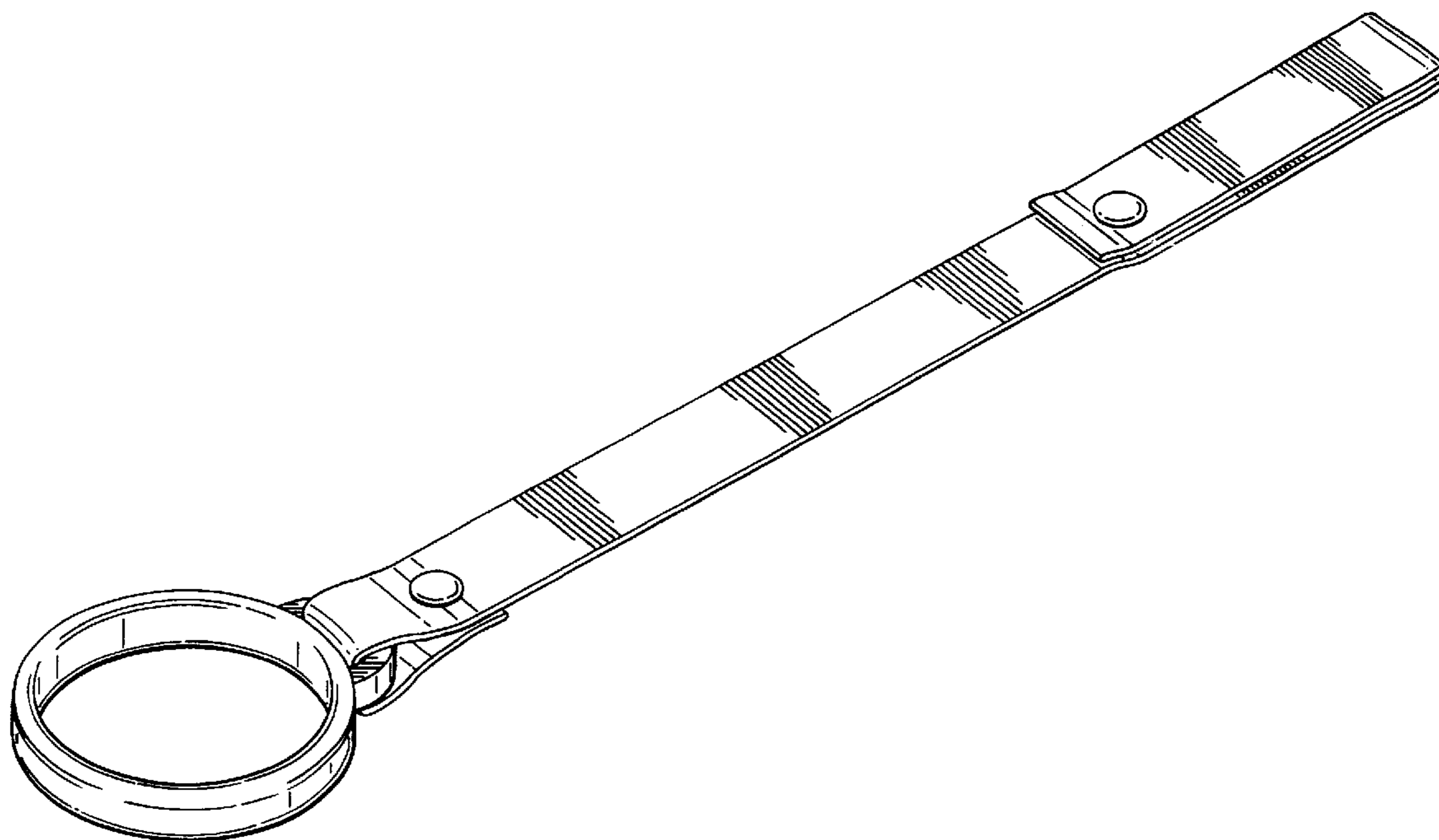
(57) **CLAIM**

I claim the ornamental design for a retention strap for bottles, as shown and described.

DESCRIPTION

FIG. 1—is a top first side perspective view of a retention strap for bottles showing my design;
FIG. 2—is a top view thereof;
FIG. 3—is a first side elevational view thereof;
FIG. 4—is a bottom elevational view thereof;
FIG. 5—is a second side elevational view thereof;
FIG. 6—is a front elevational view thereof; and,

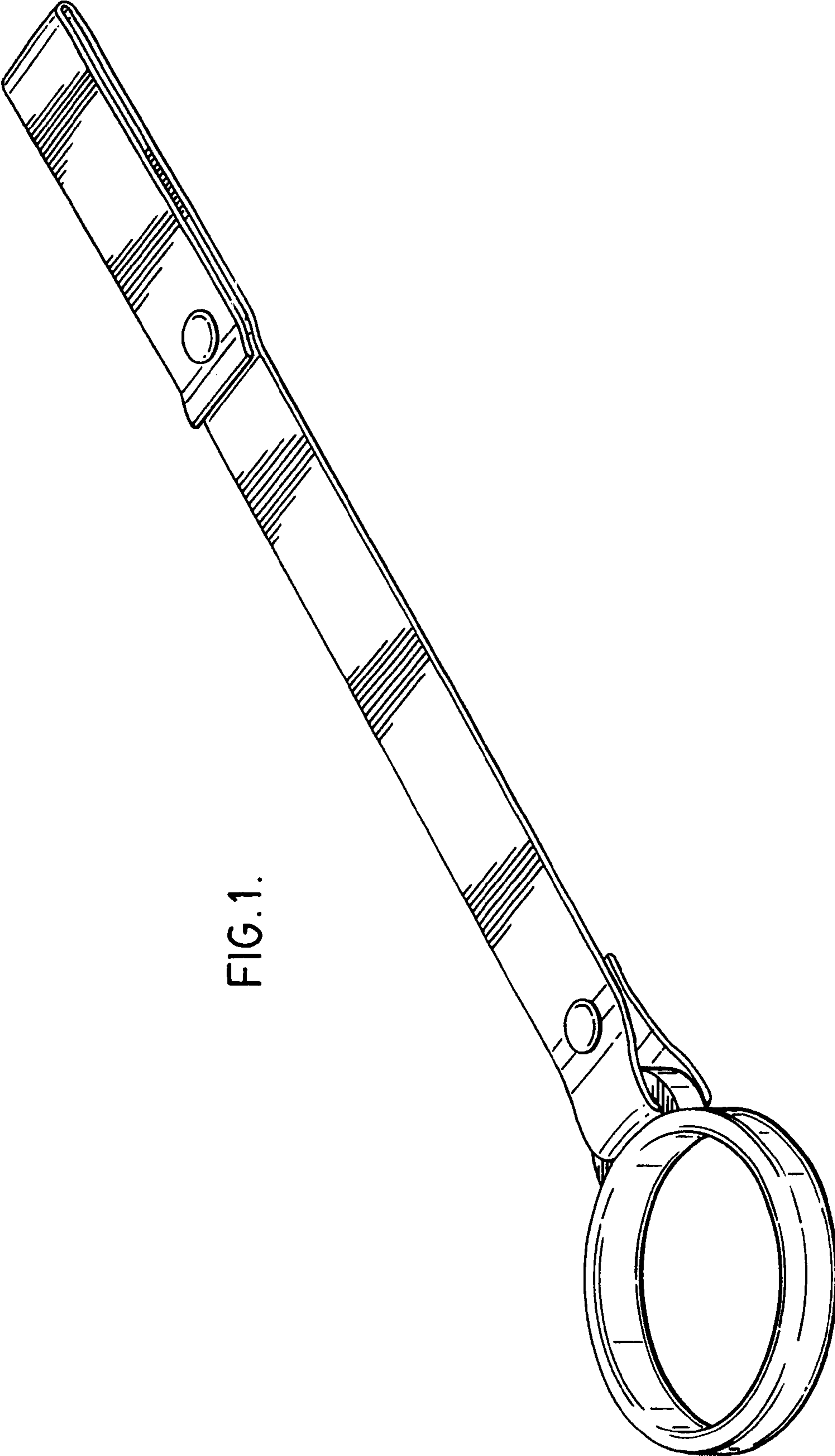
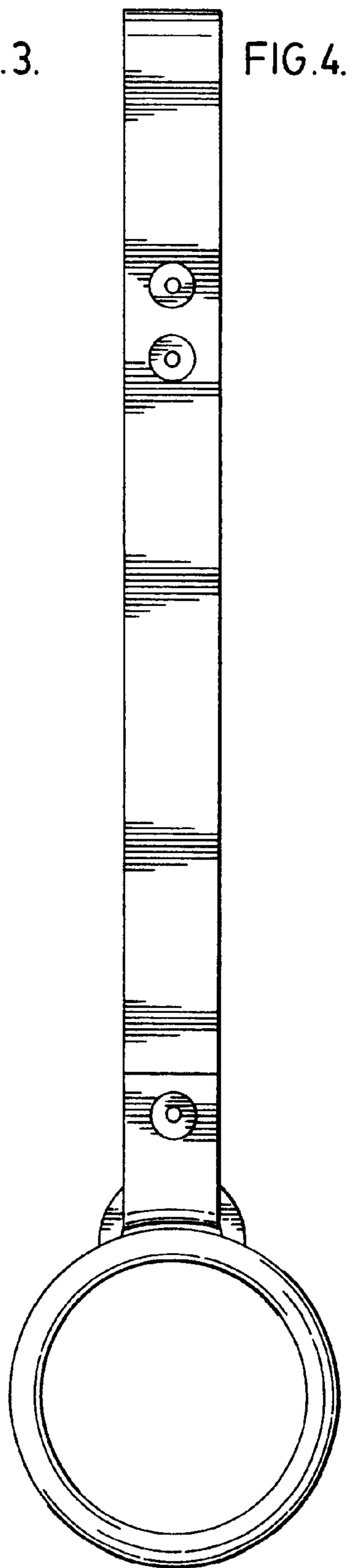
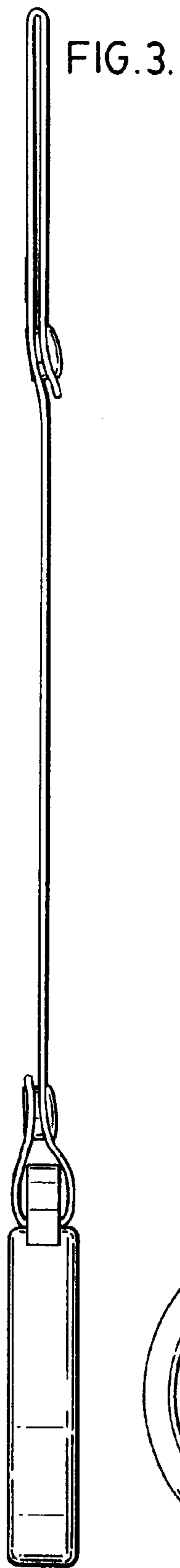
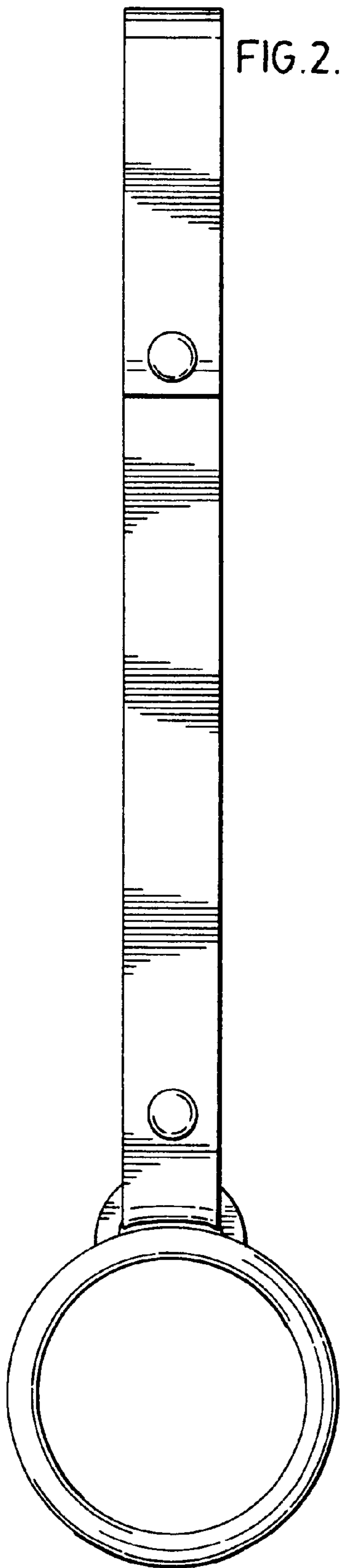

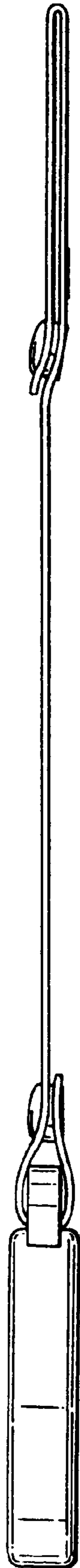

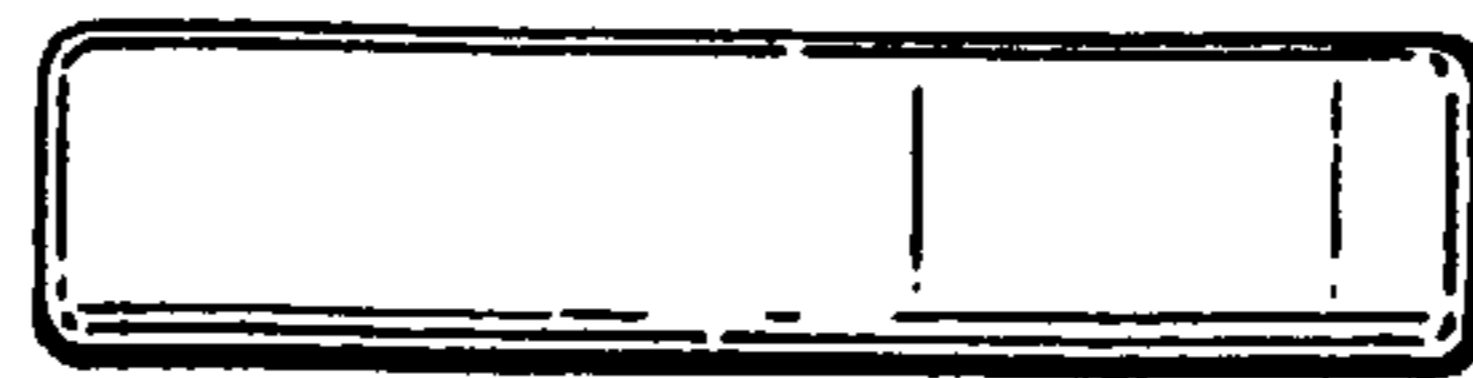
