I claim the ornamental design for the battery dispenser refill, as shown and described.

DESCRIPTION

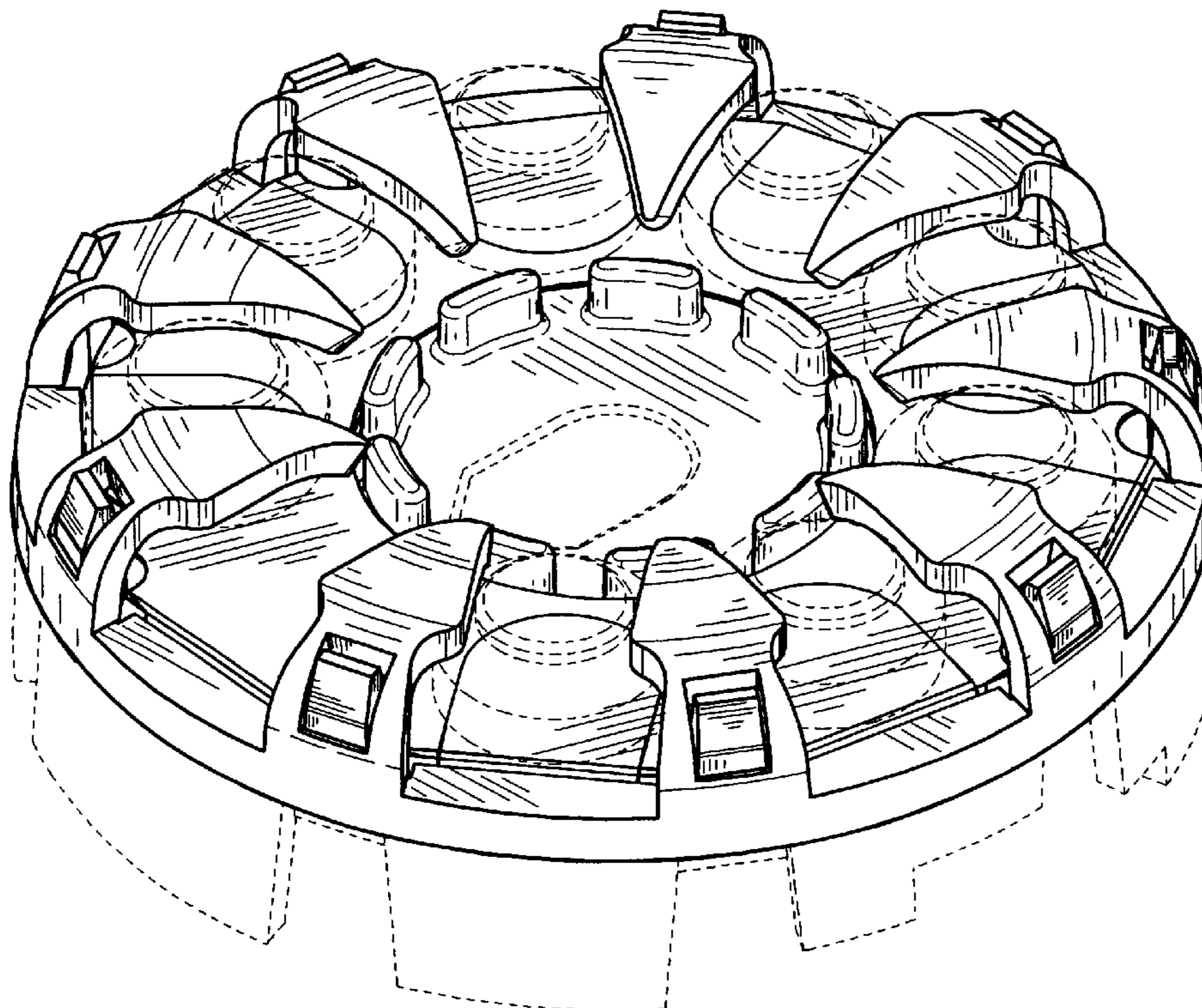
FIG. 1 is a top right perspective view of the battery dispenser refill; FIG. 2 is a rear elevational view of the battery dispenser refill; FIG. 3 is a front elevational view of the battery dispenser refill; FIG. 4 is a right side elevational view of the battery dispenser refill; the left side elevational view (not shown) is a mirror image of the right side elevational view; FIG. 5 is a top plan view of the battery dispenser refill; and, FIG. 6 is a bottom plan view of the battery dispenser refill. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

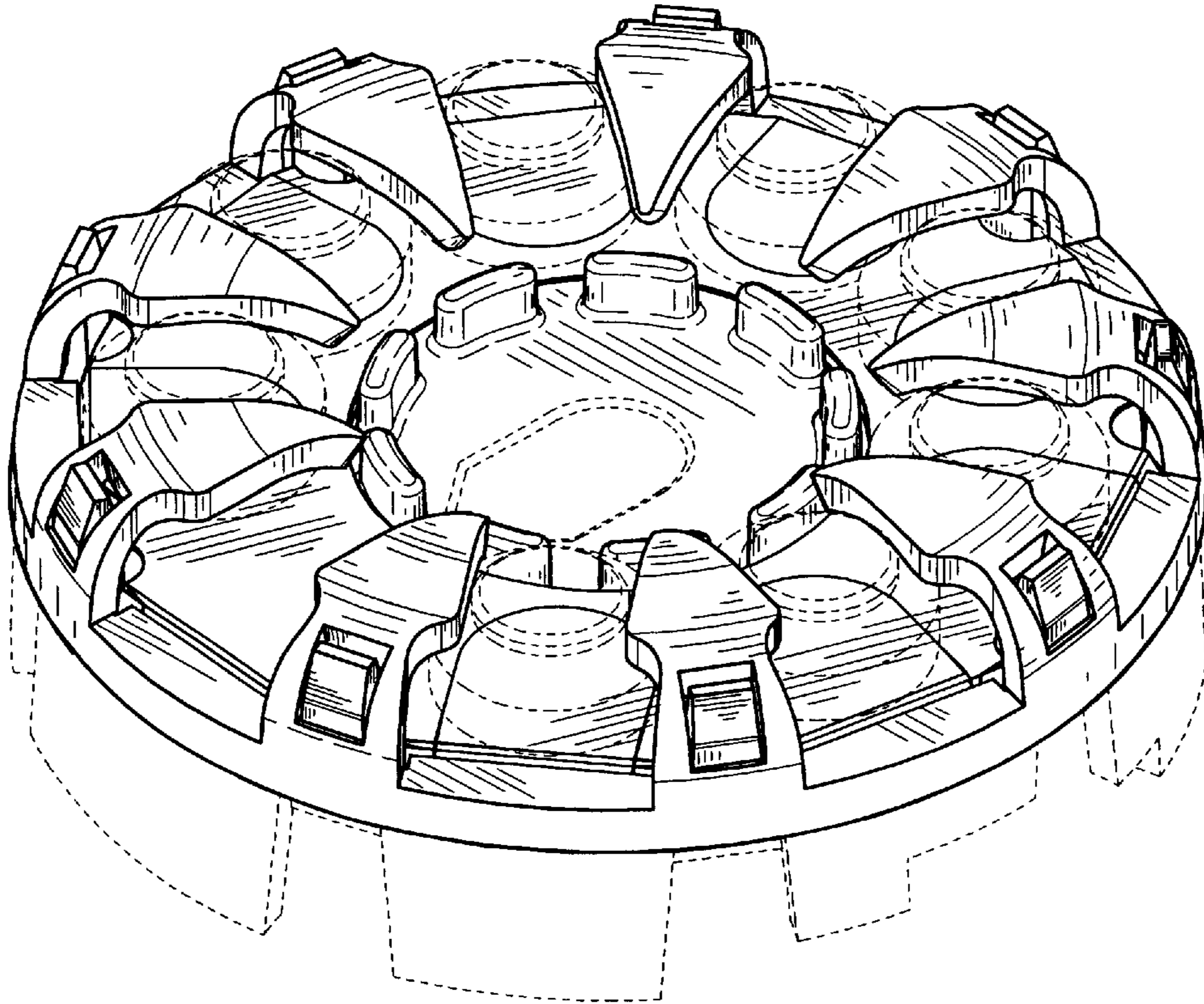

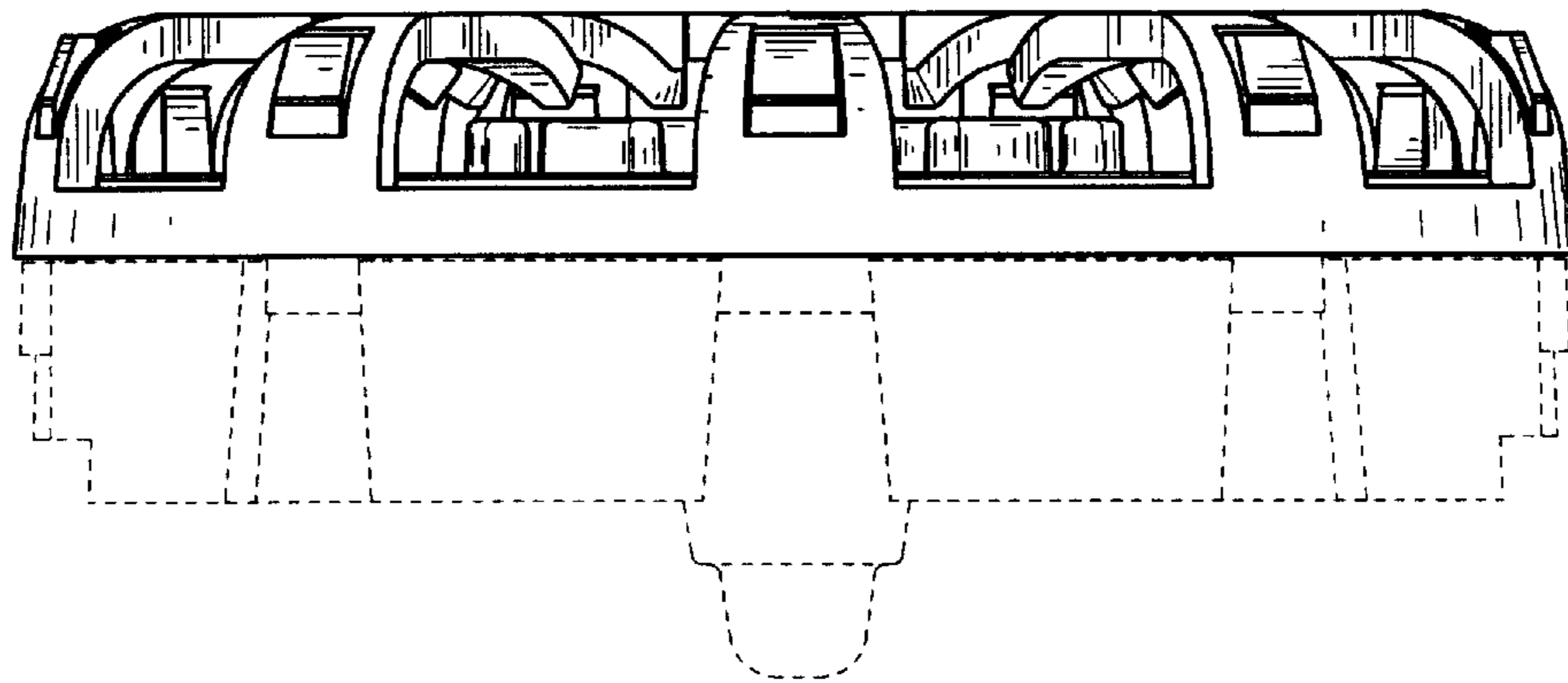

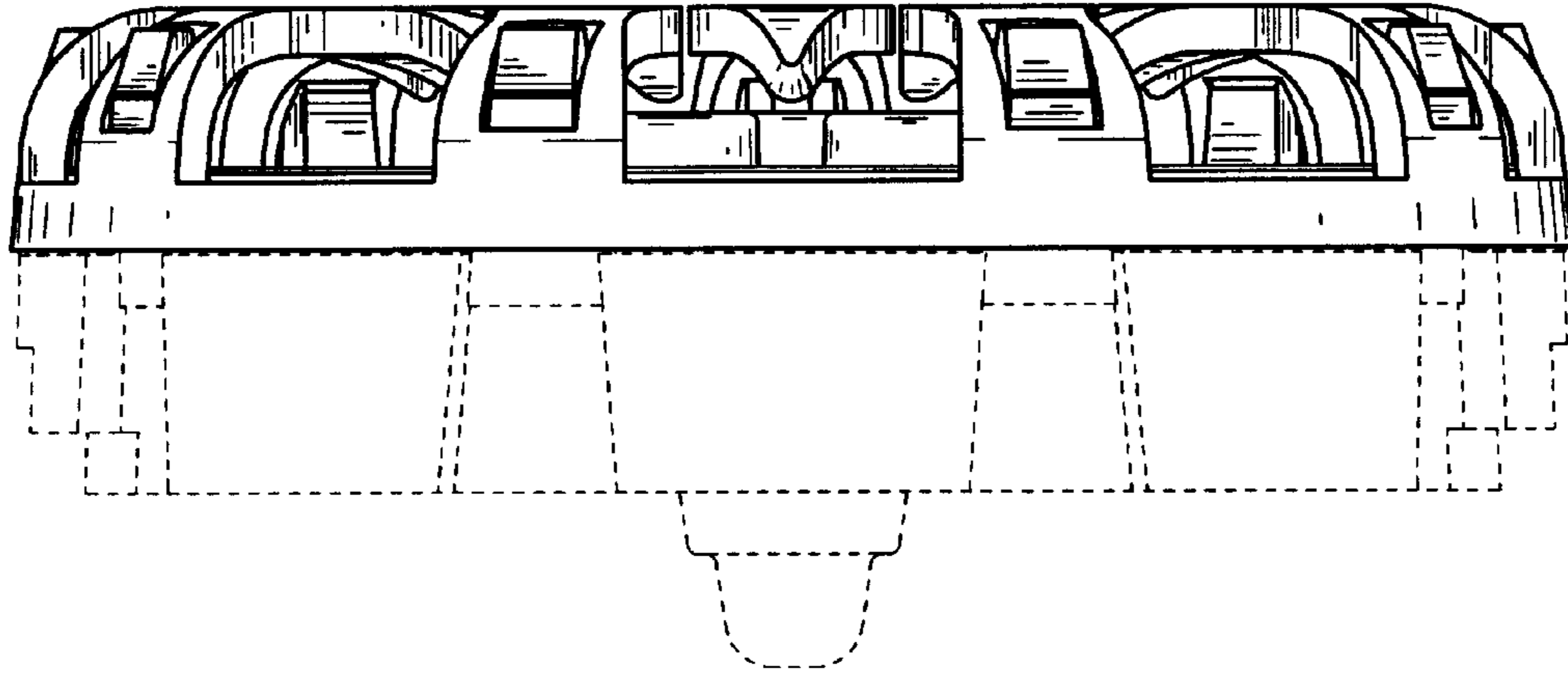

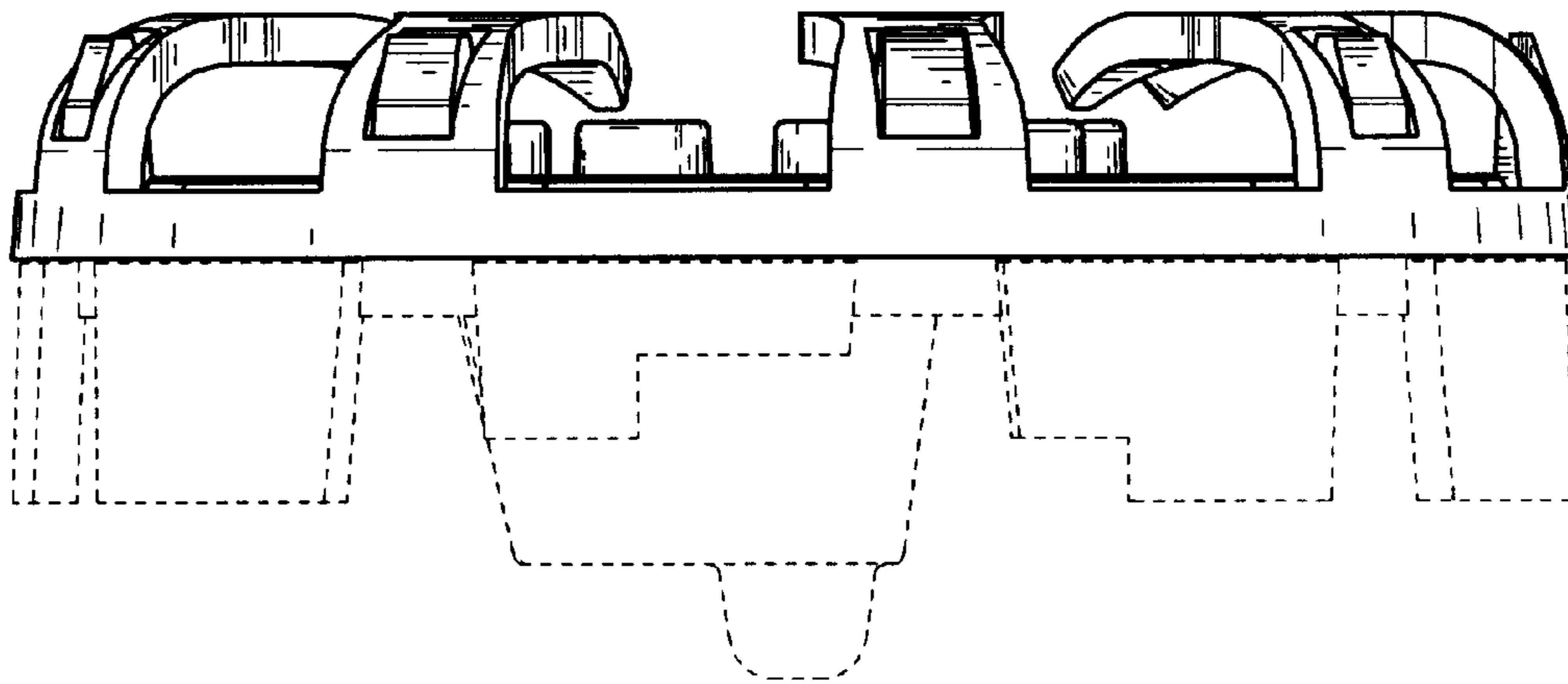

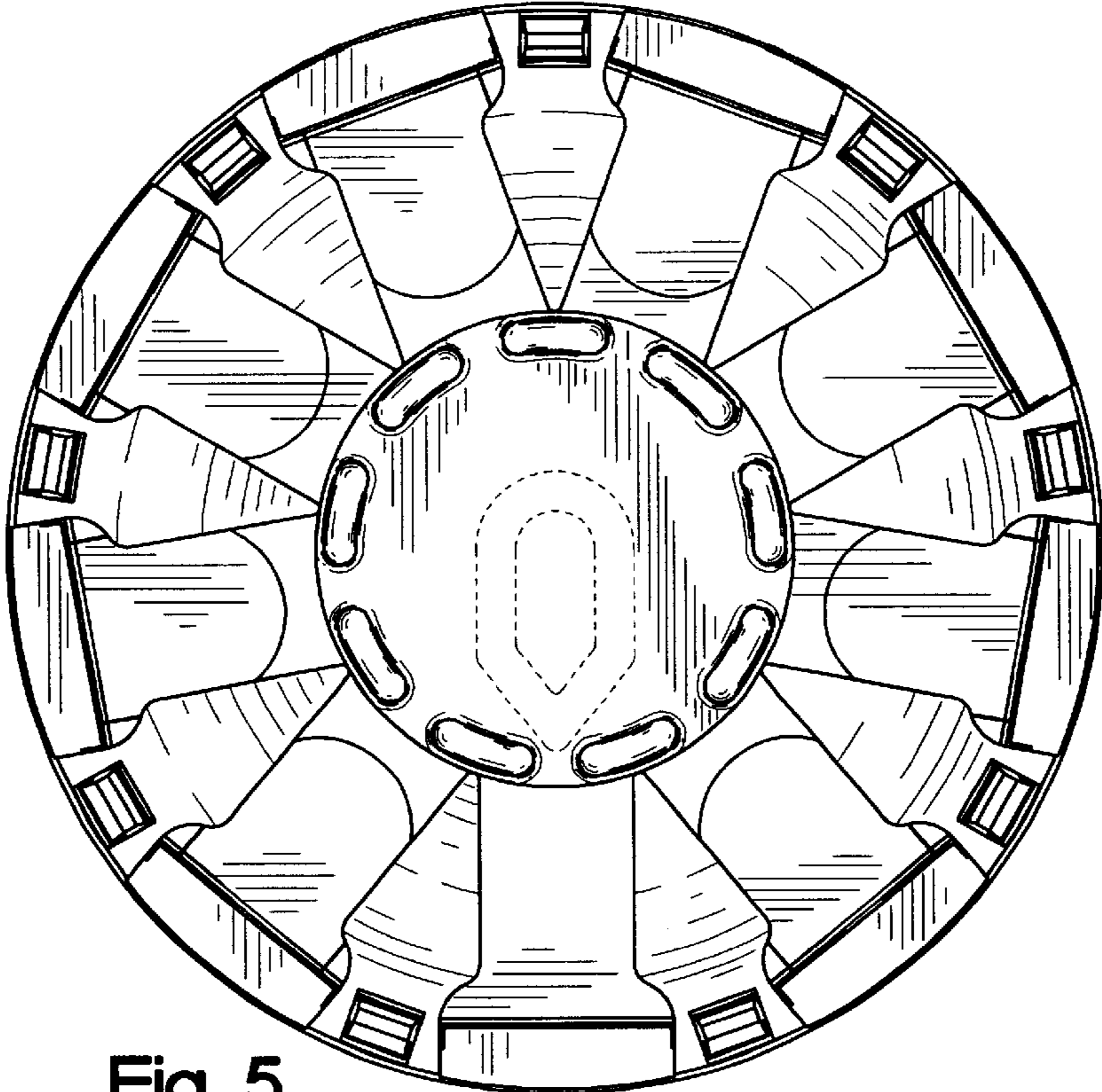

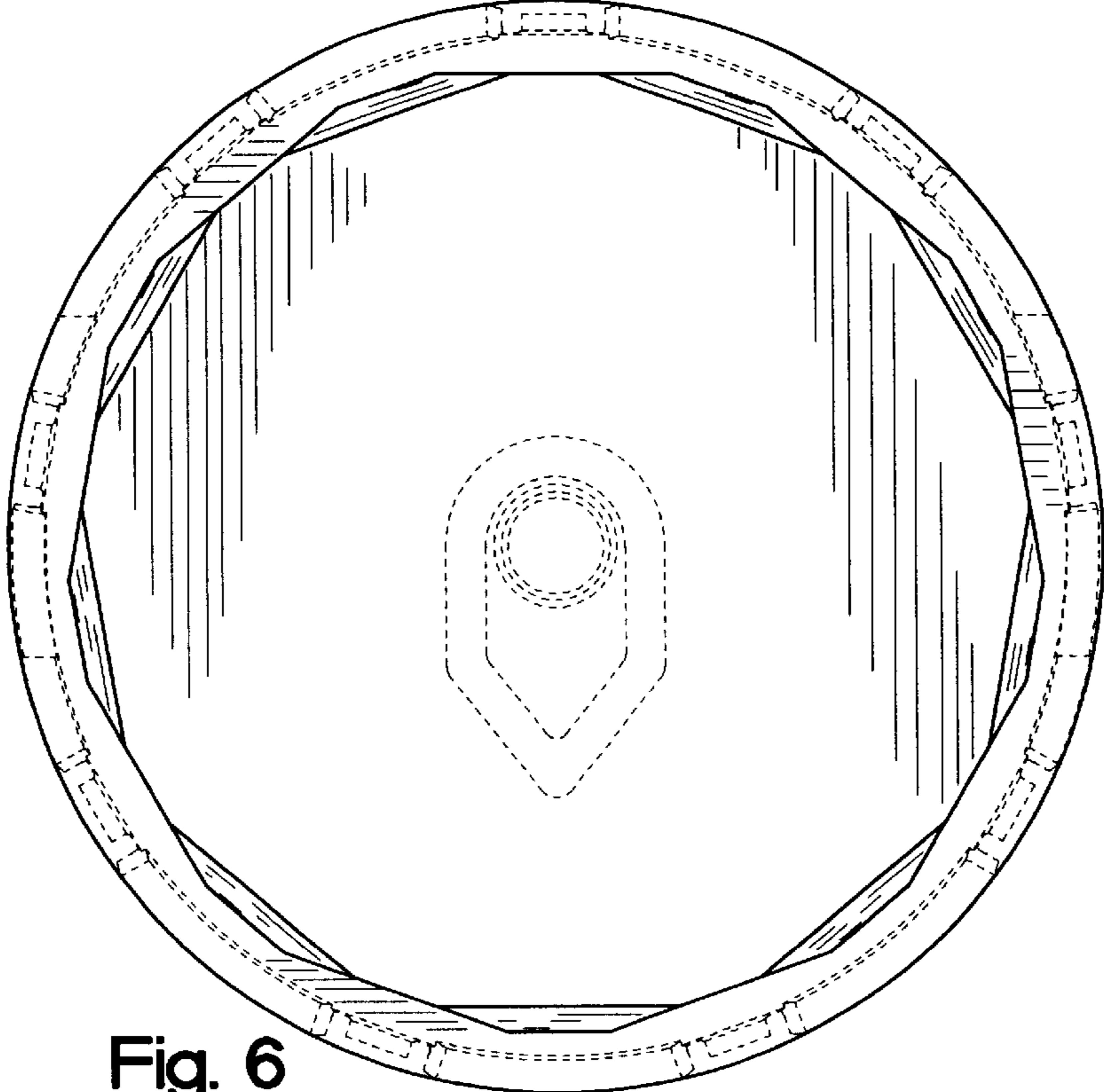
