DESCRIPTION

FIG. 1 is a perspective view of an award trophy showing the new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof
FIG. 6 is a top plan view thereof; and,

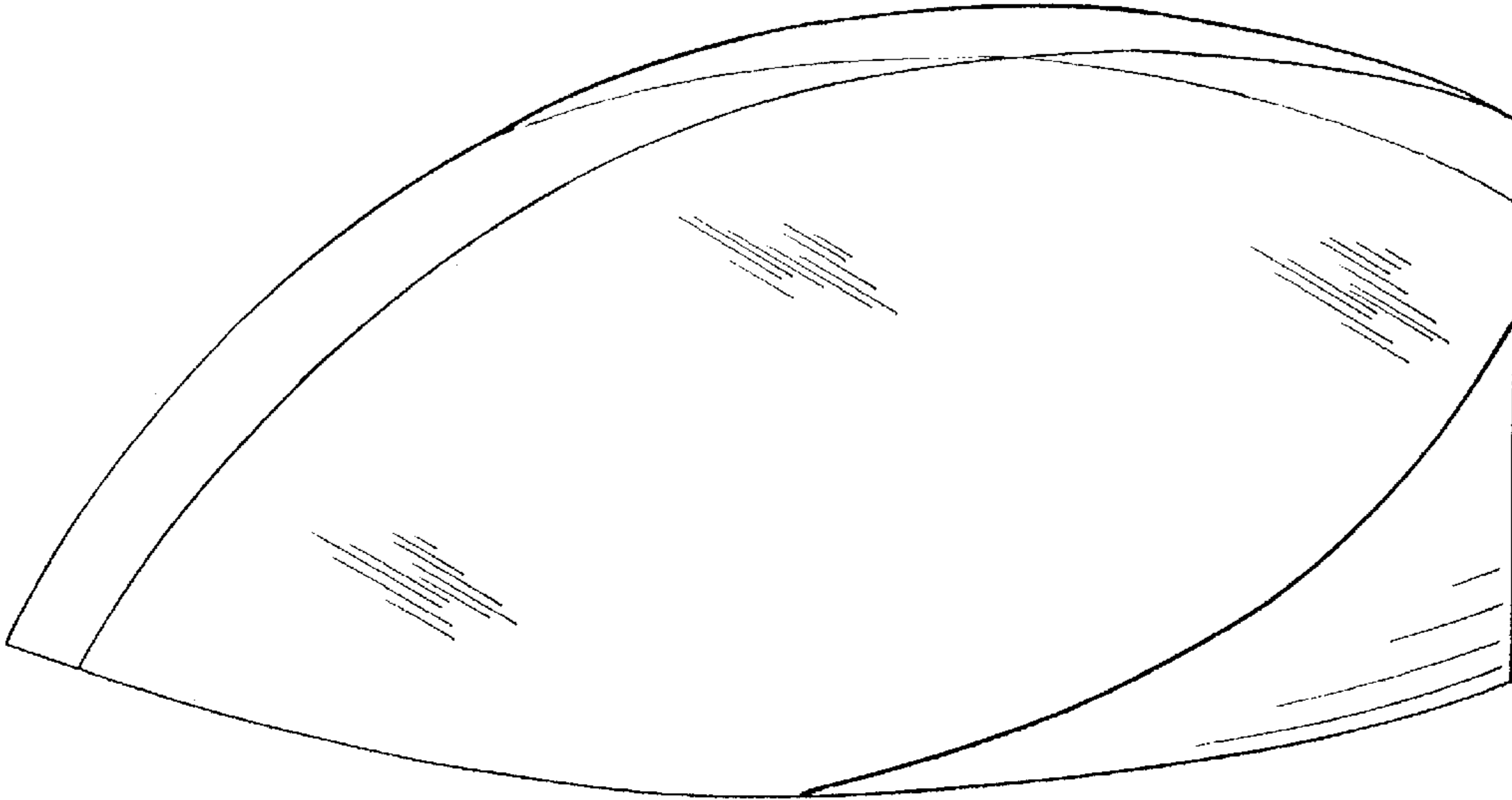

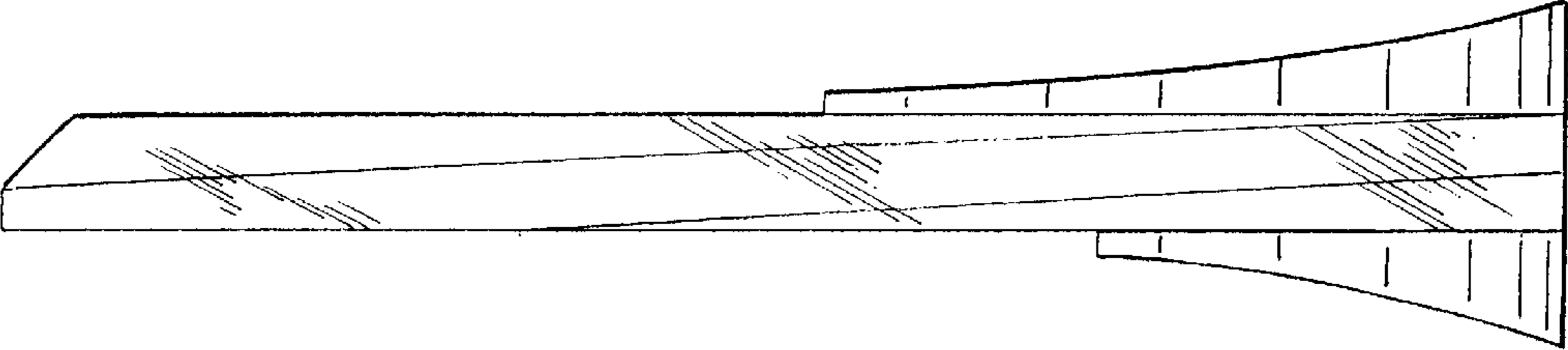

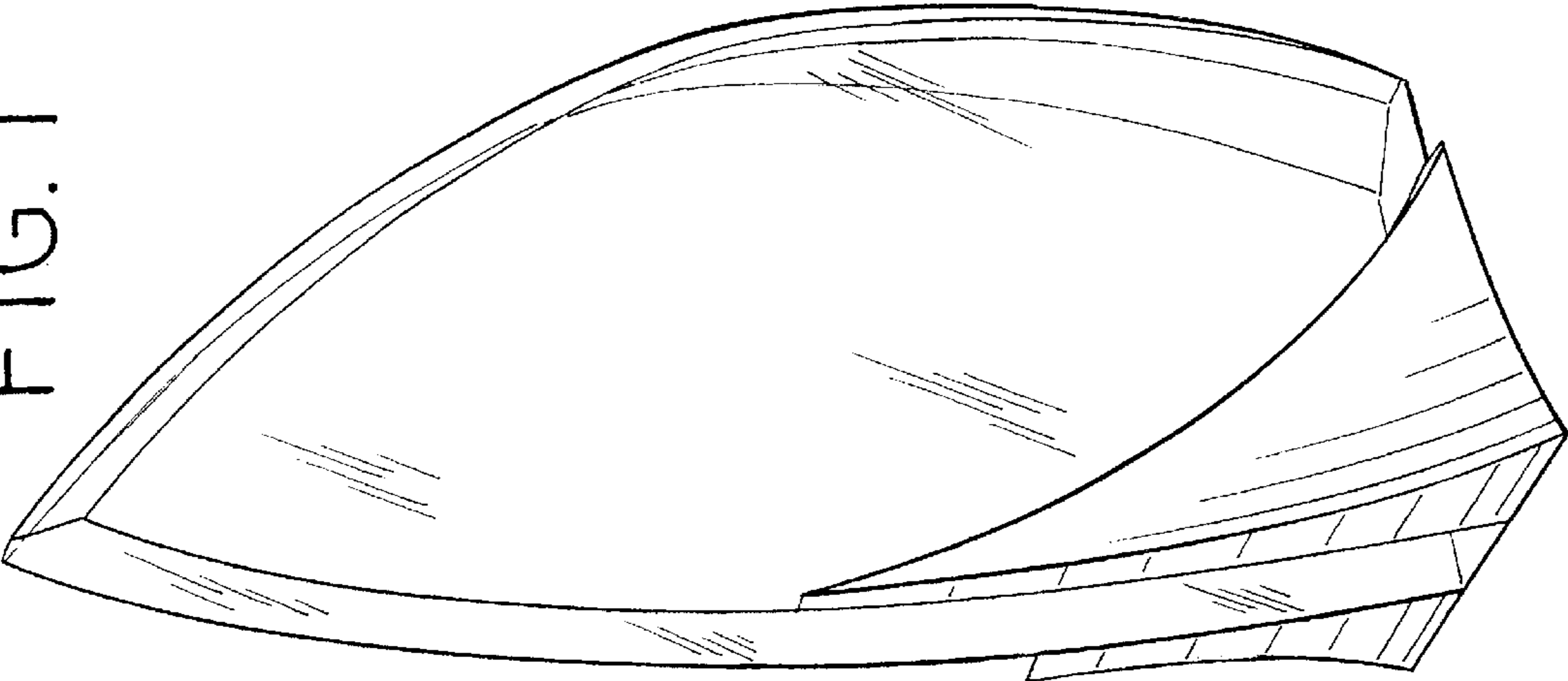

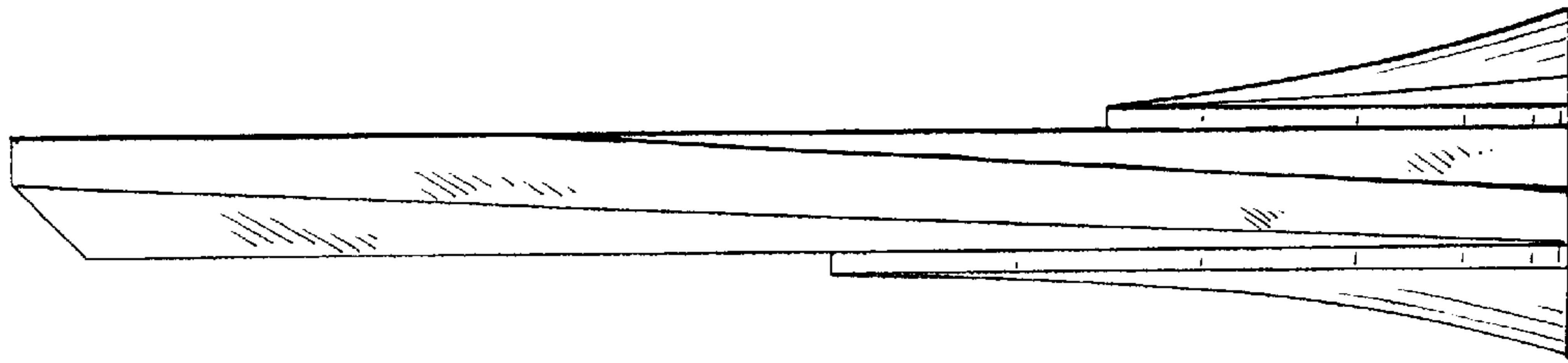

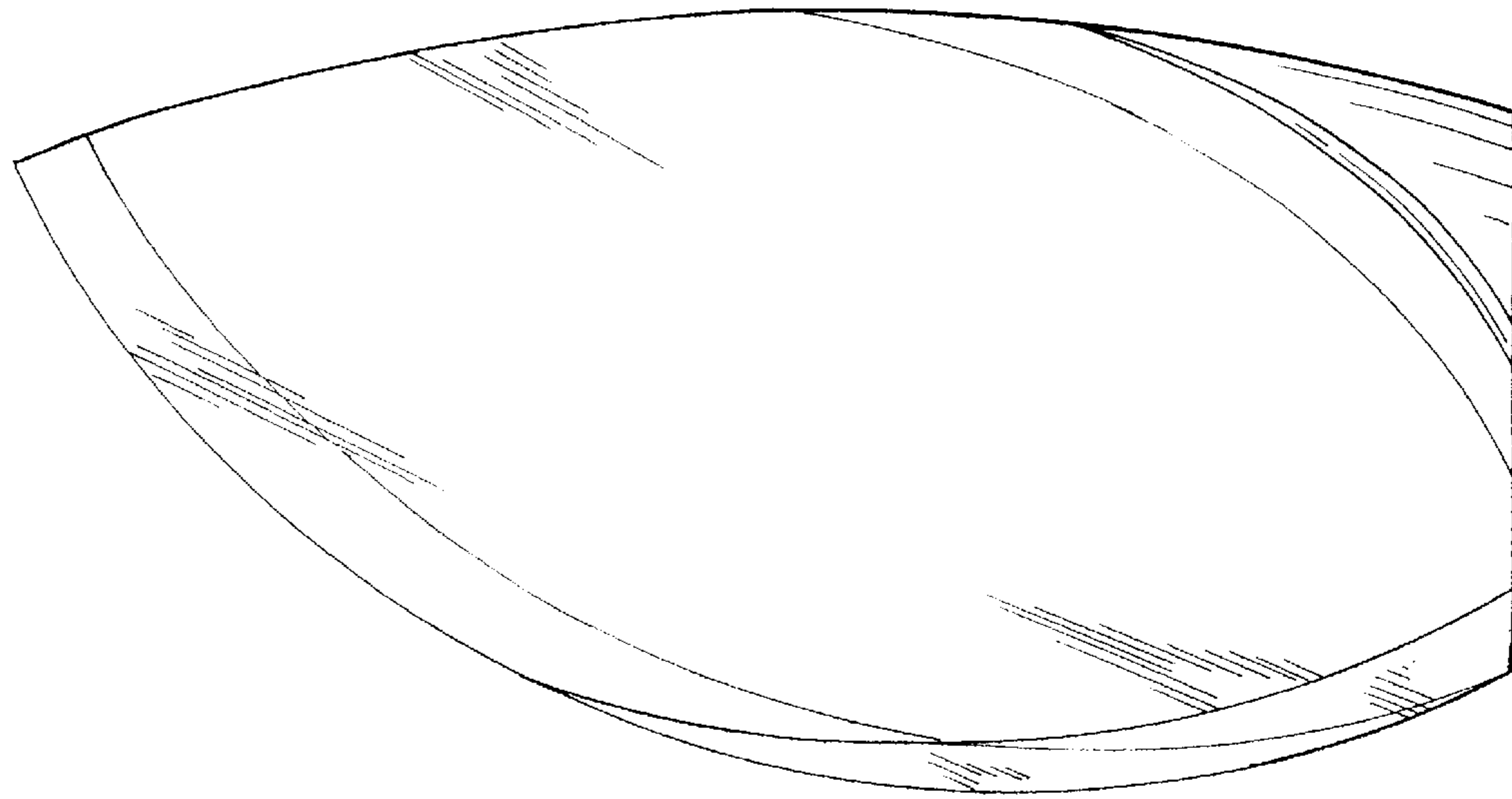

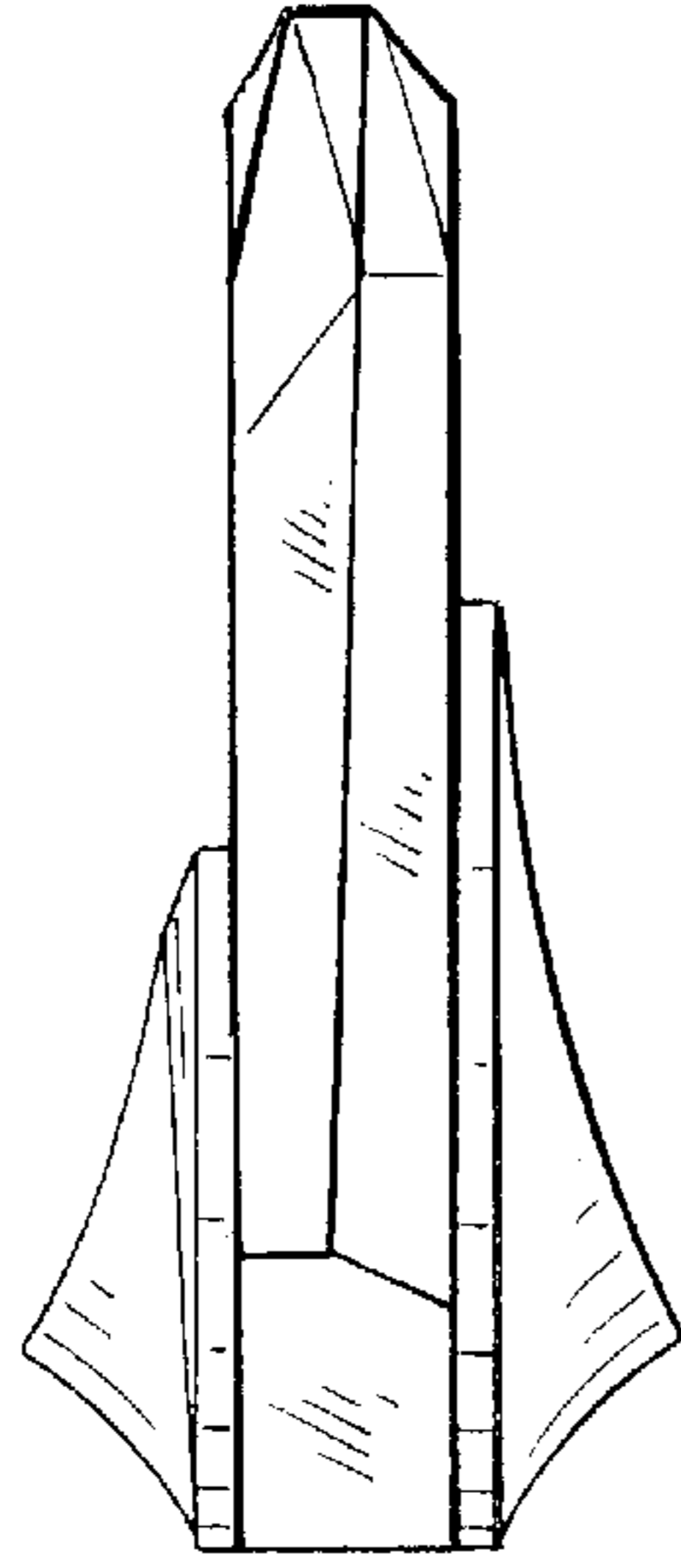
