(57) **CLAIM**

The ornamental design for a front bezel for a consumer electronic product, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, from the front and above, of a front bezel for a consumer electronic product showing our new design; The portions drawn in broken lines on FIG. 1 do not form part of the claimed design.

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof;

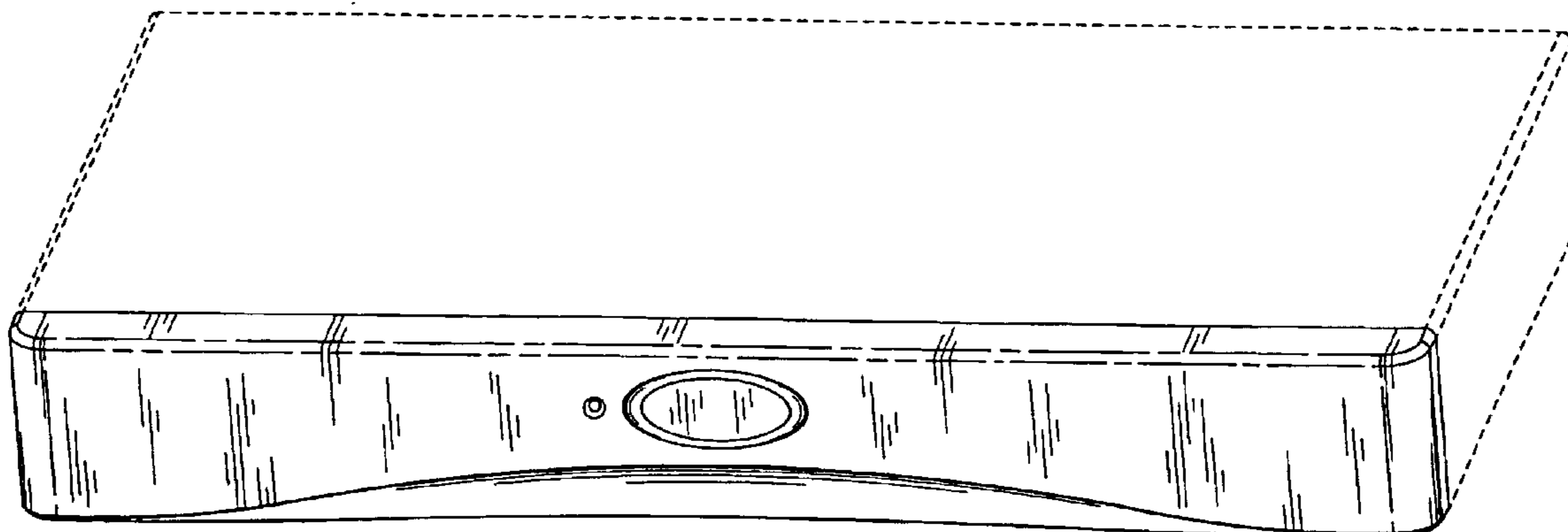
FIG. 4 is a left side view thereof;

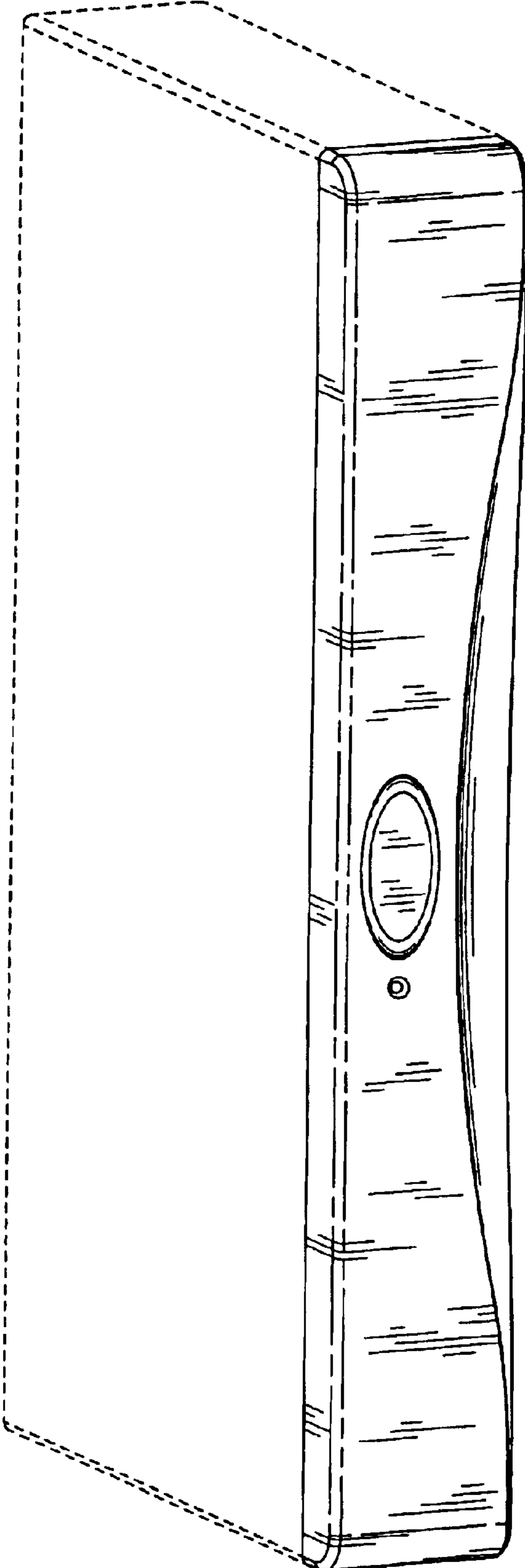

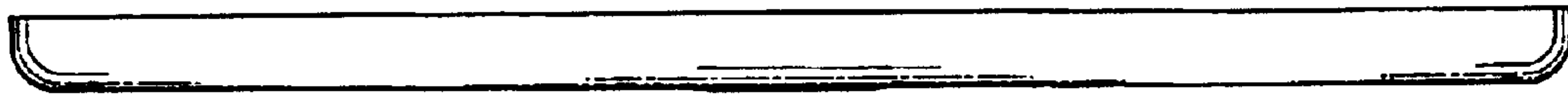

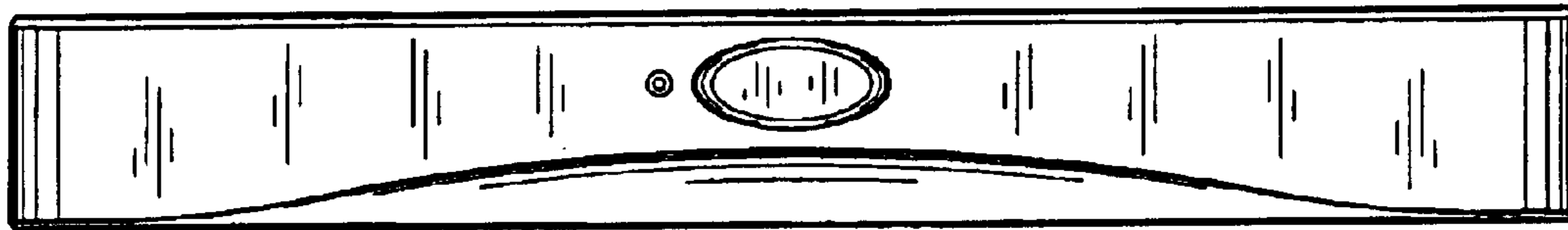
