DESCRIPTION

FIG. 1 is a top rear perspective view of a golf club head according to the present invention.

FIG. 2 is a top plan view of the golf club head.

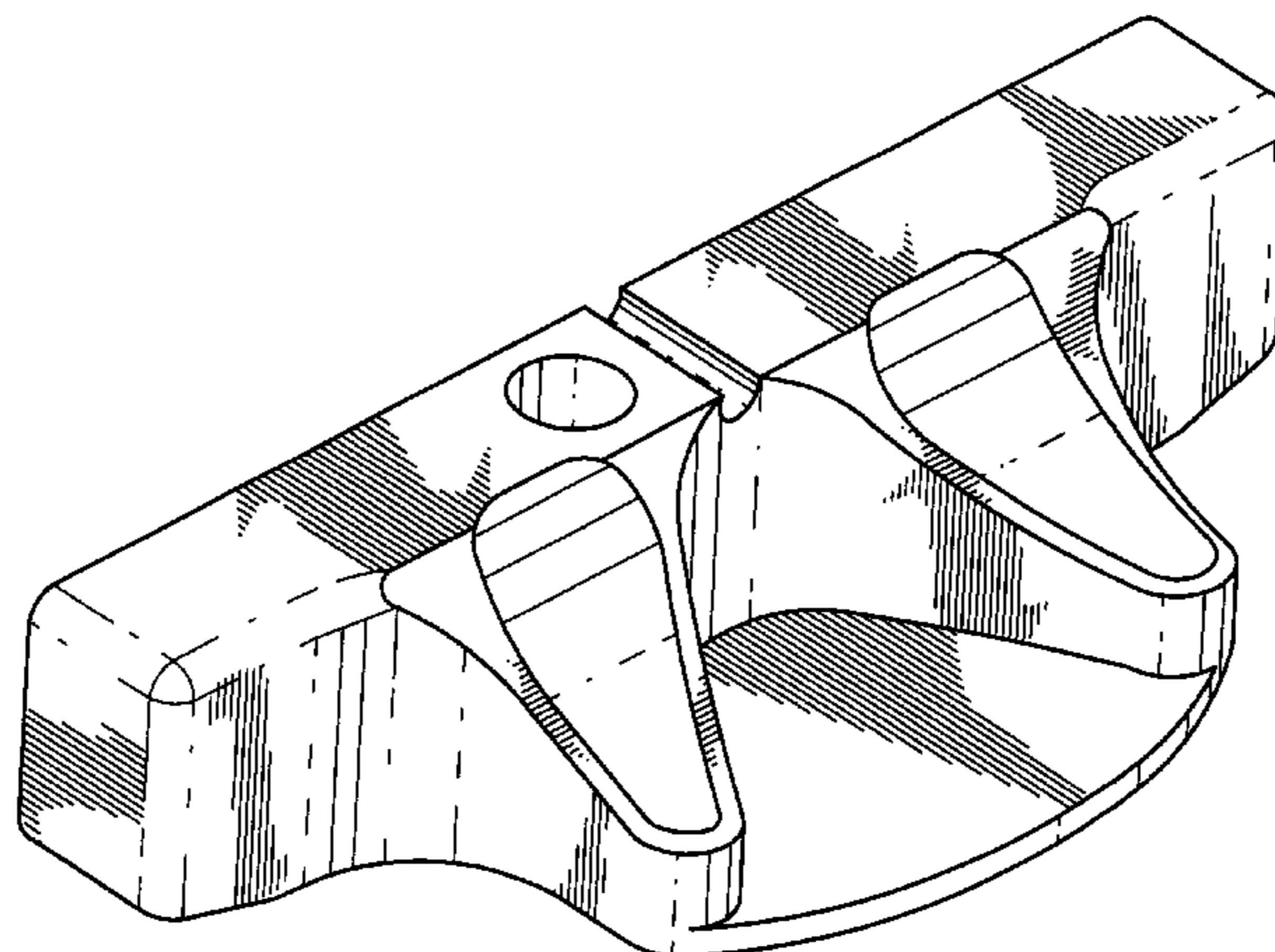
FIG. 3 is a bottom plan view of the golf club head.

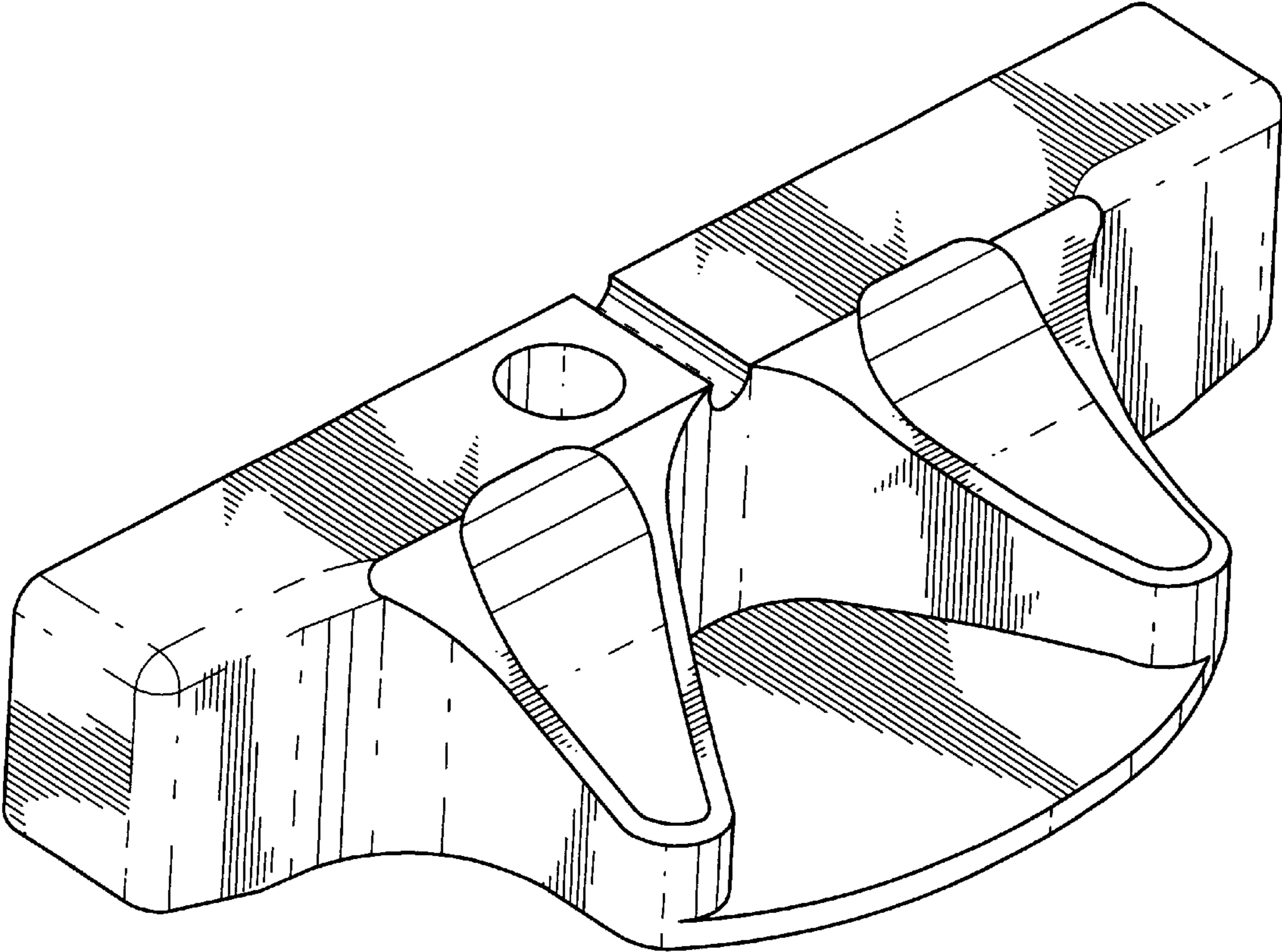

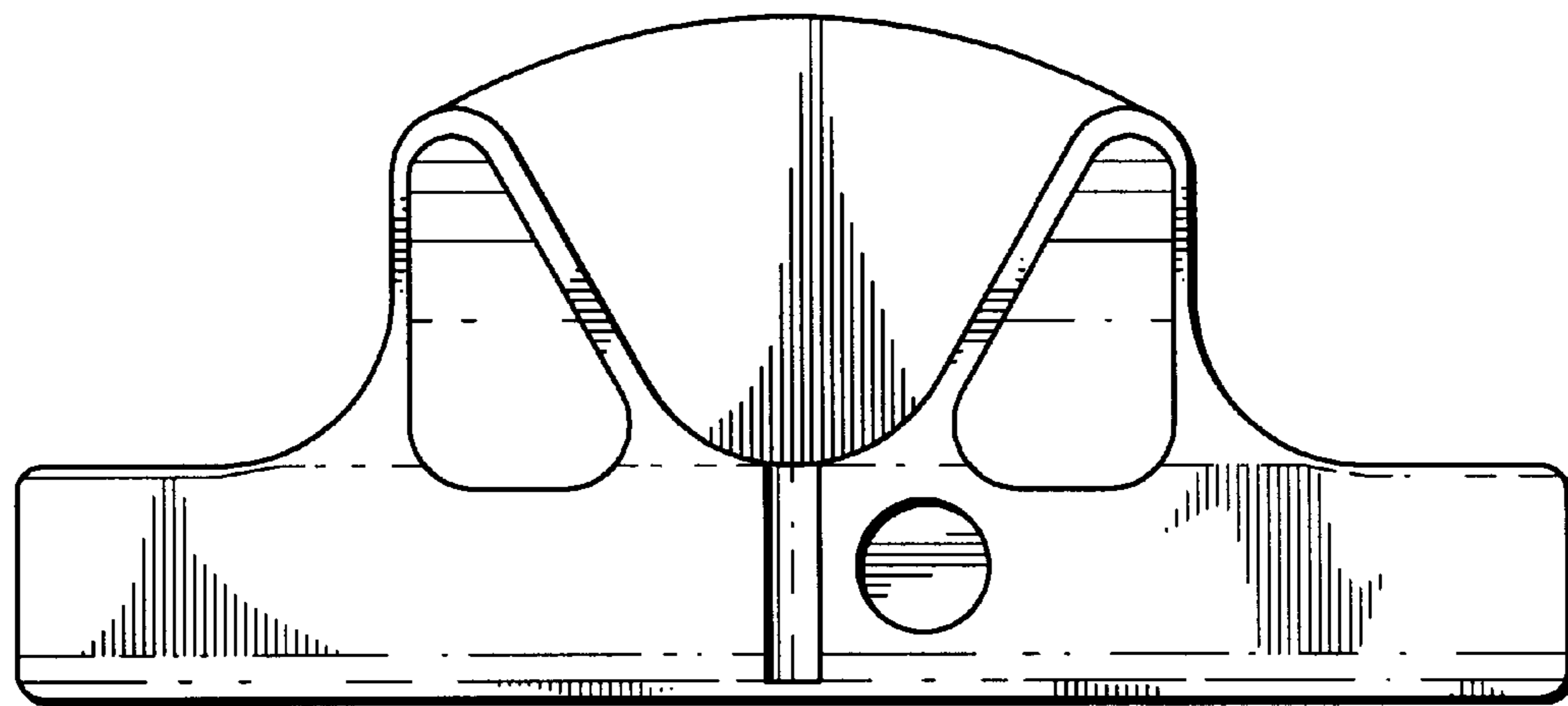

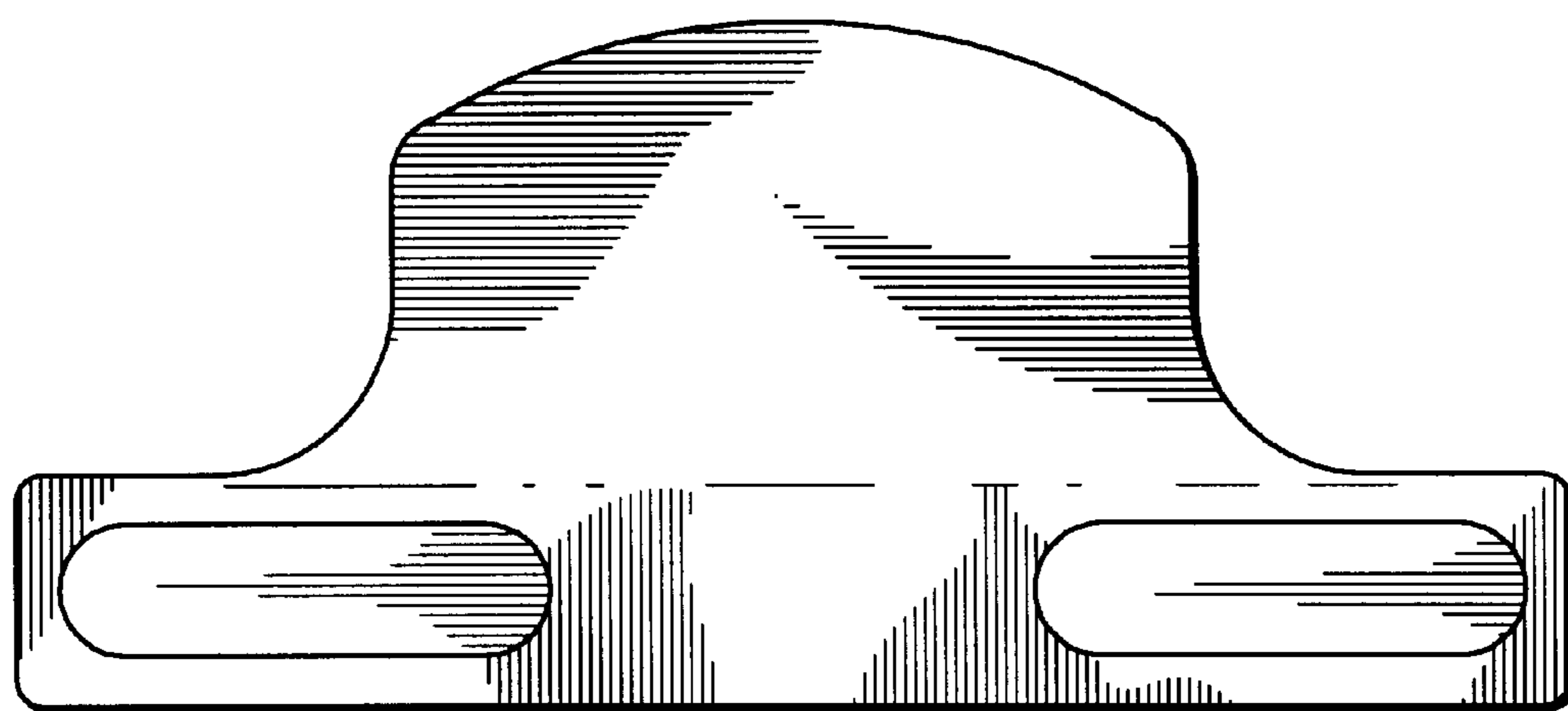

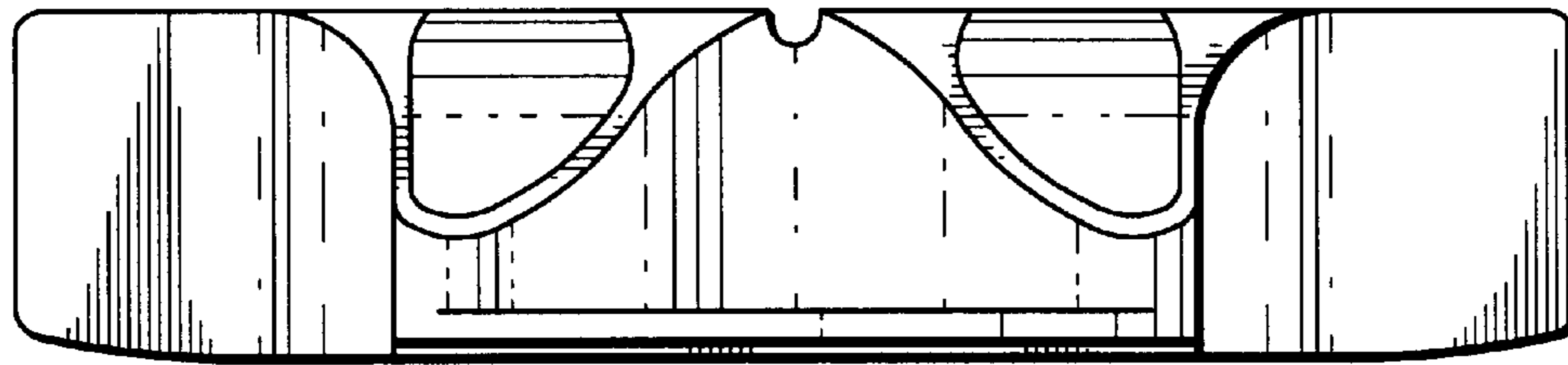

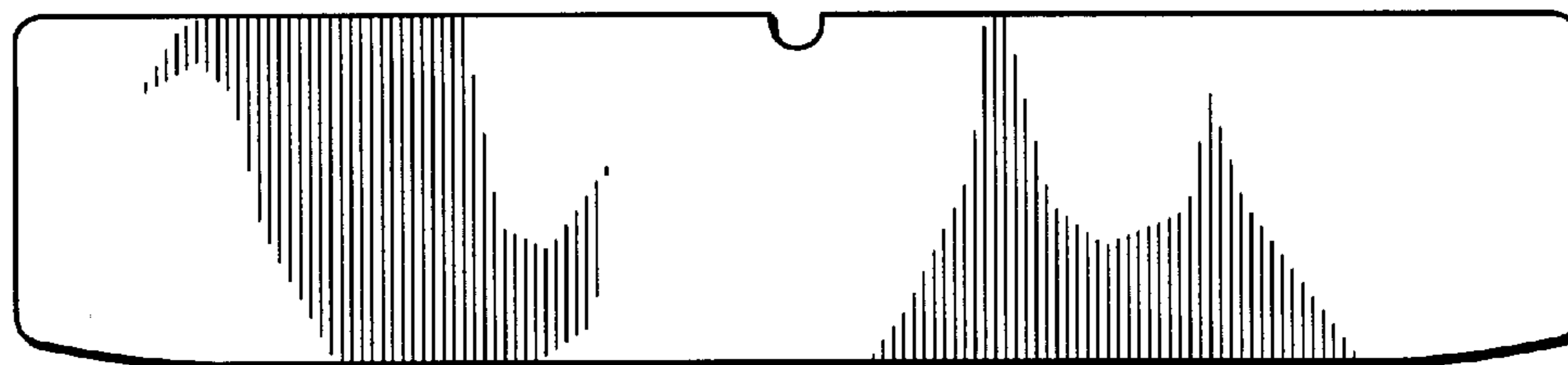

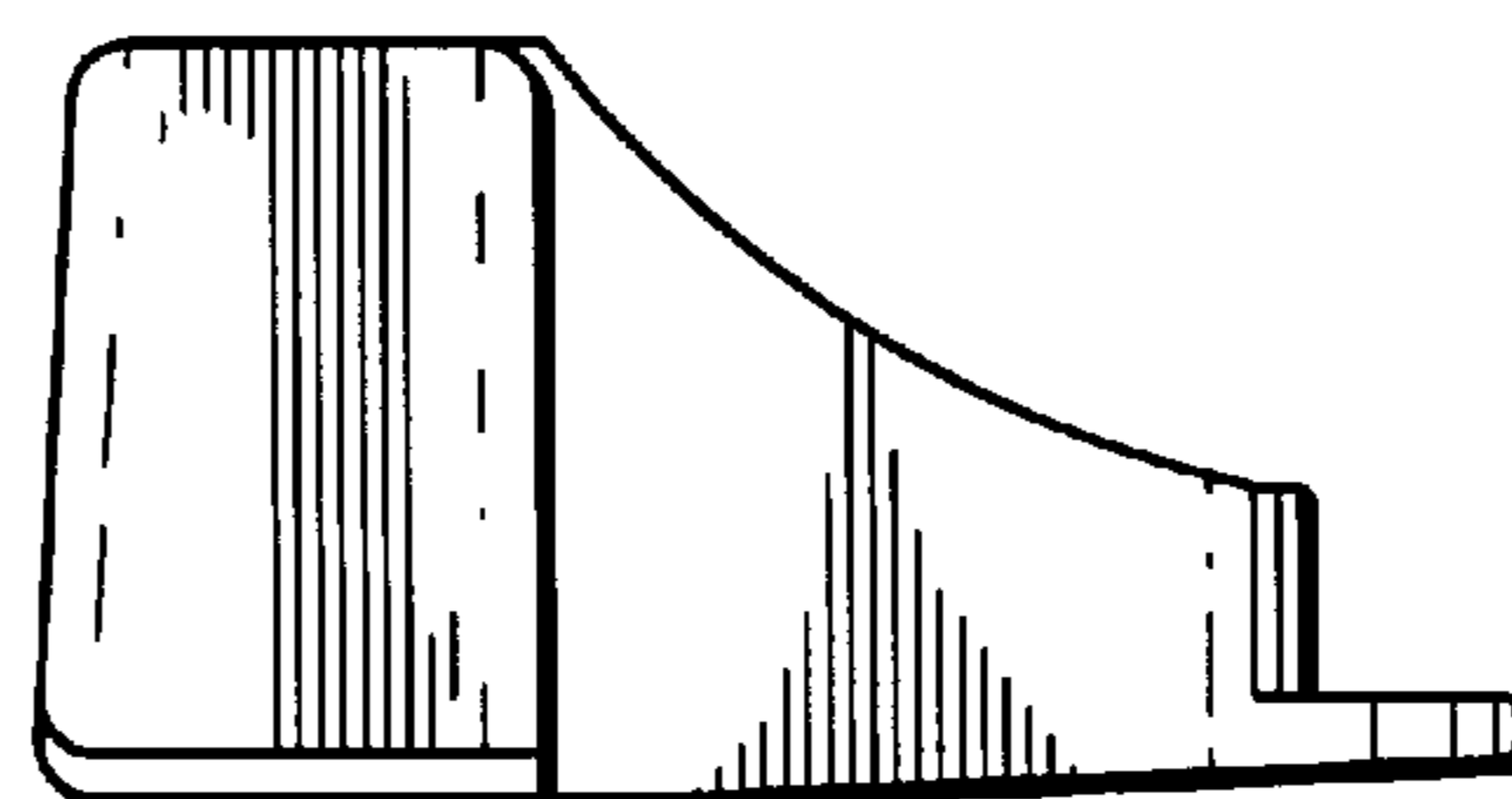
