(57) **CLAIM**

The ornamental design for the smokeless ashtray, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of the smokeless ashtray design according to the invention, FIG. 2 is a front elevational view of the smokeless ashtray as shown in FIG. 1,

FIG. 3 is a top view of the smokeless ashtray as shown in FIG. 1,

FIG. 4 is a side elevational view of the smokeless ashtray as shown in FIG. 1, with the opposing side being a mirror image thereof, and wherein the rear side and bottom of the smokeless ashtray as shown in FIG. 1 are disclaimed, and do not comprise a portion of the ornamental design;

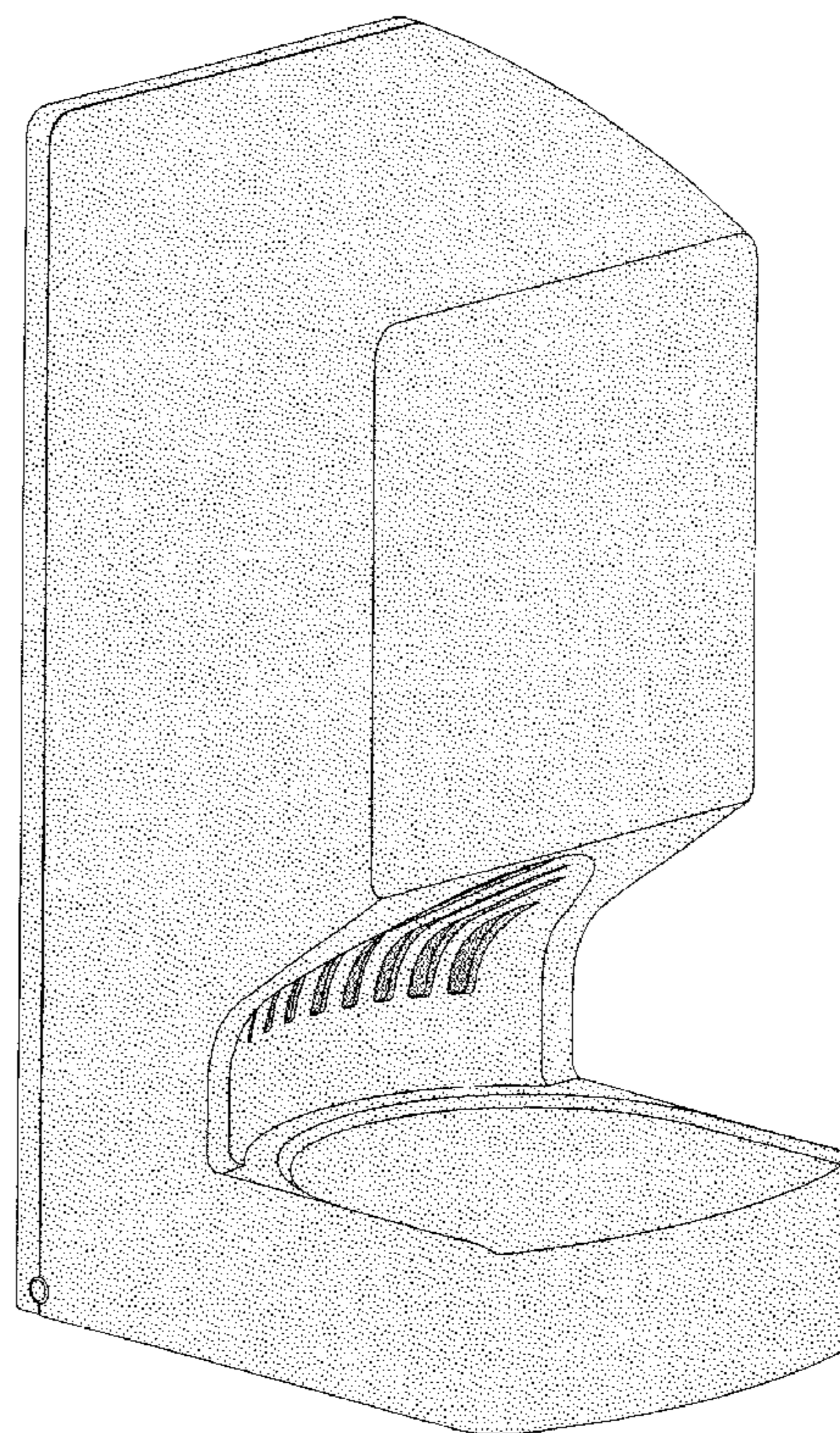
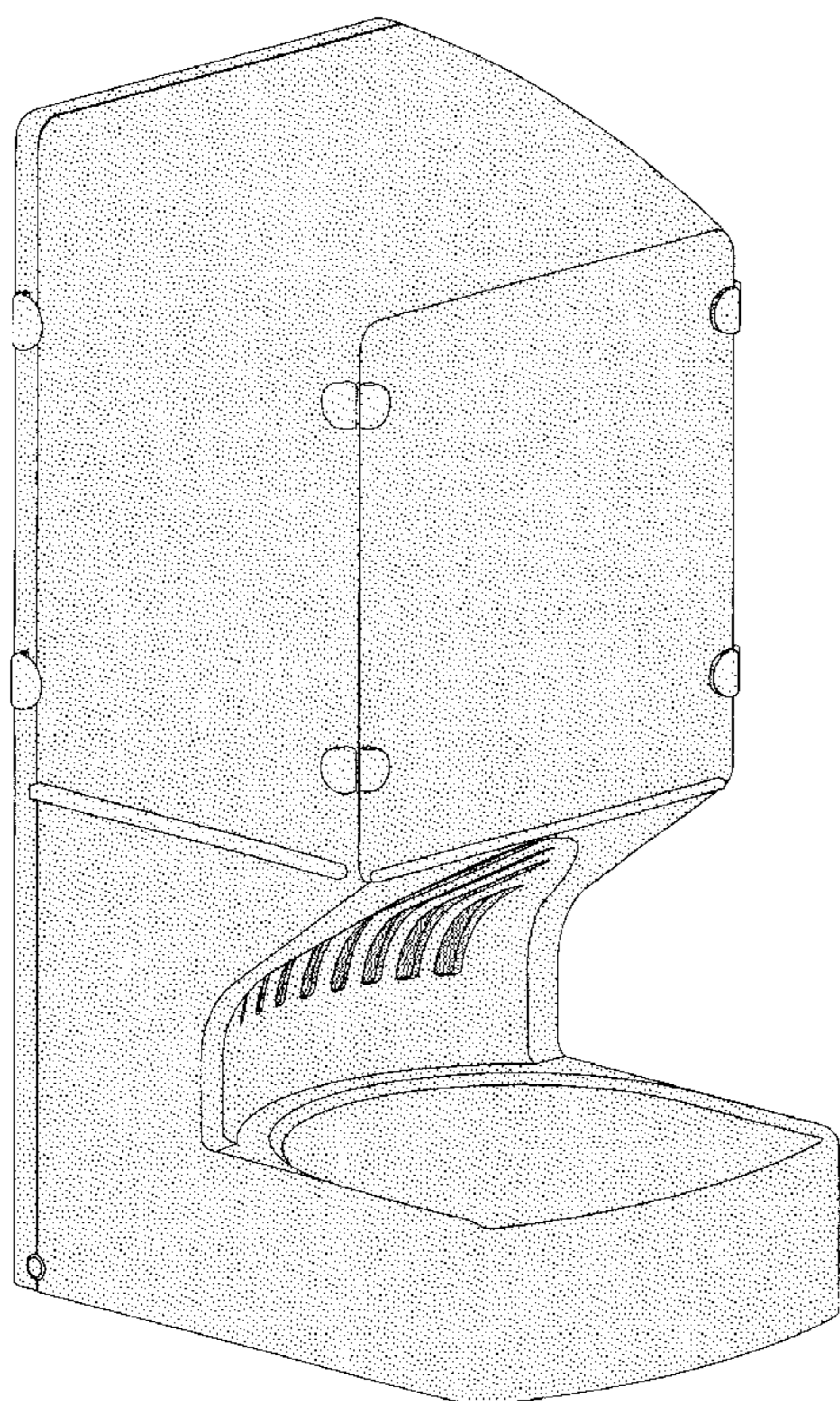
FIG. 5 is a perspective view of another embodiment of the smokeless ashtray design according to the invention,

FIG. 6 is a front elevational view of the smokeless ashtray as shown in FIG. 5;

FIG. 7 is a top view of the smokeless ashtray as shown in FIG. 5; and,

FIG. 8 is a side elevational view of the smokeless ashtray as shown in FIG. 5, with the opposing side being a mirror image thereof, and wherein the rear side and bottom of the smokeless ashtray as shown in FIG. 5 are disclaimed, and do not comprise a portion of the ornamental design.

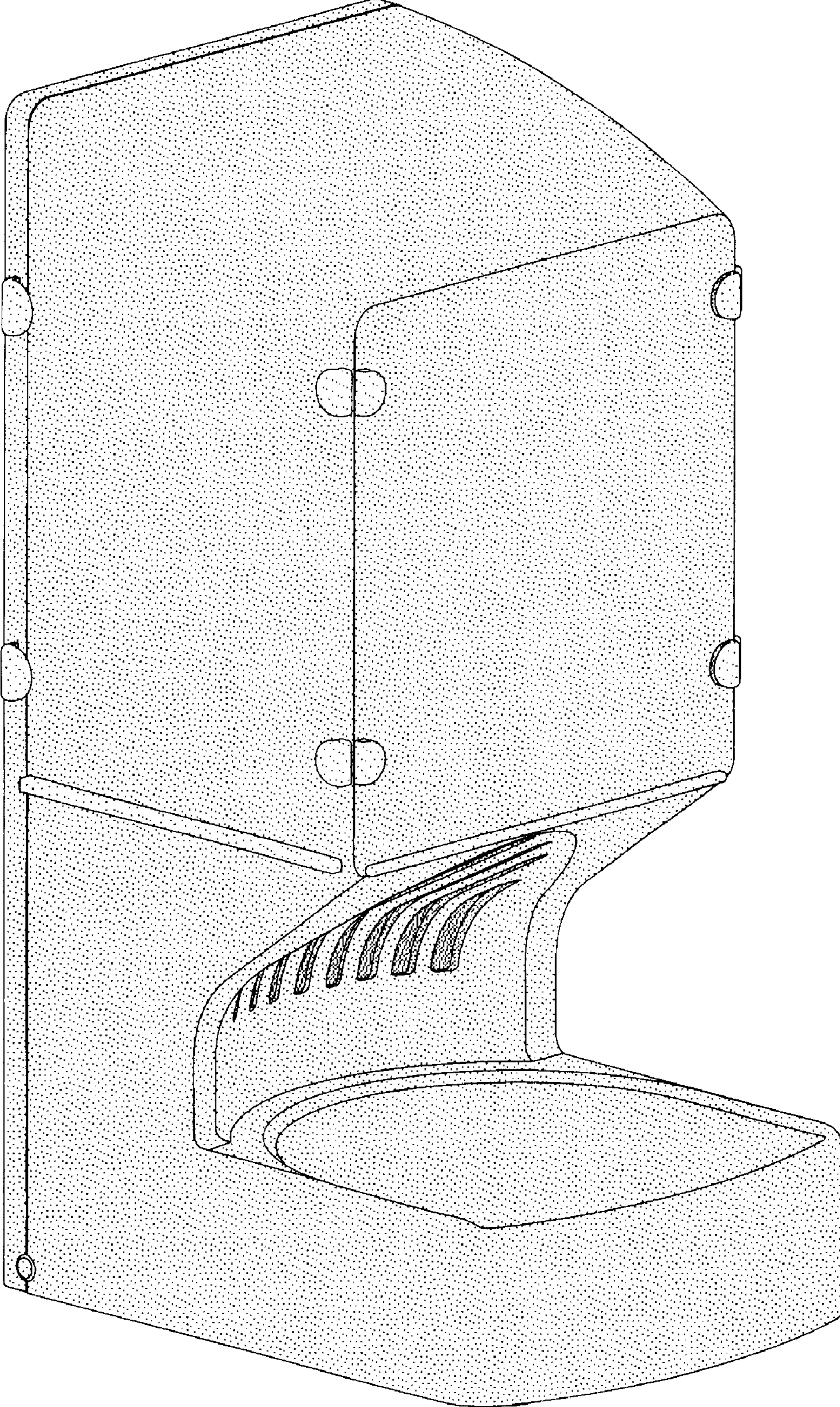

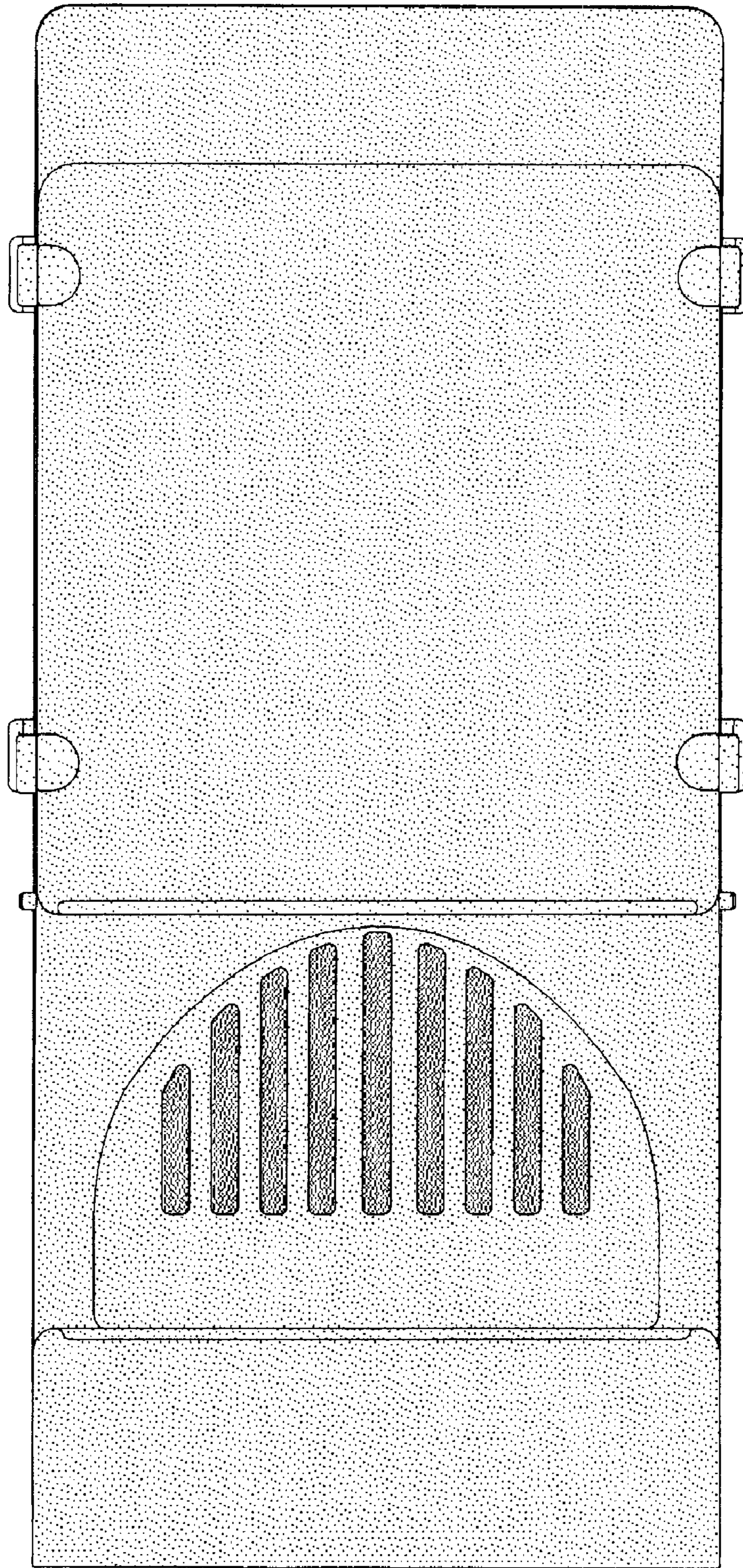

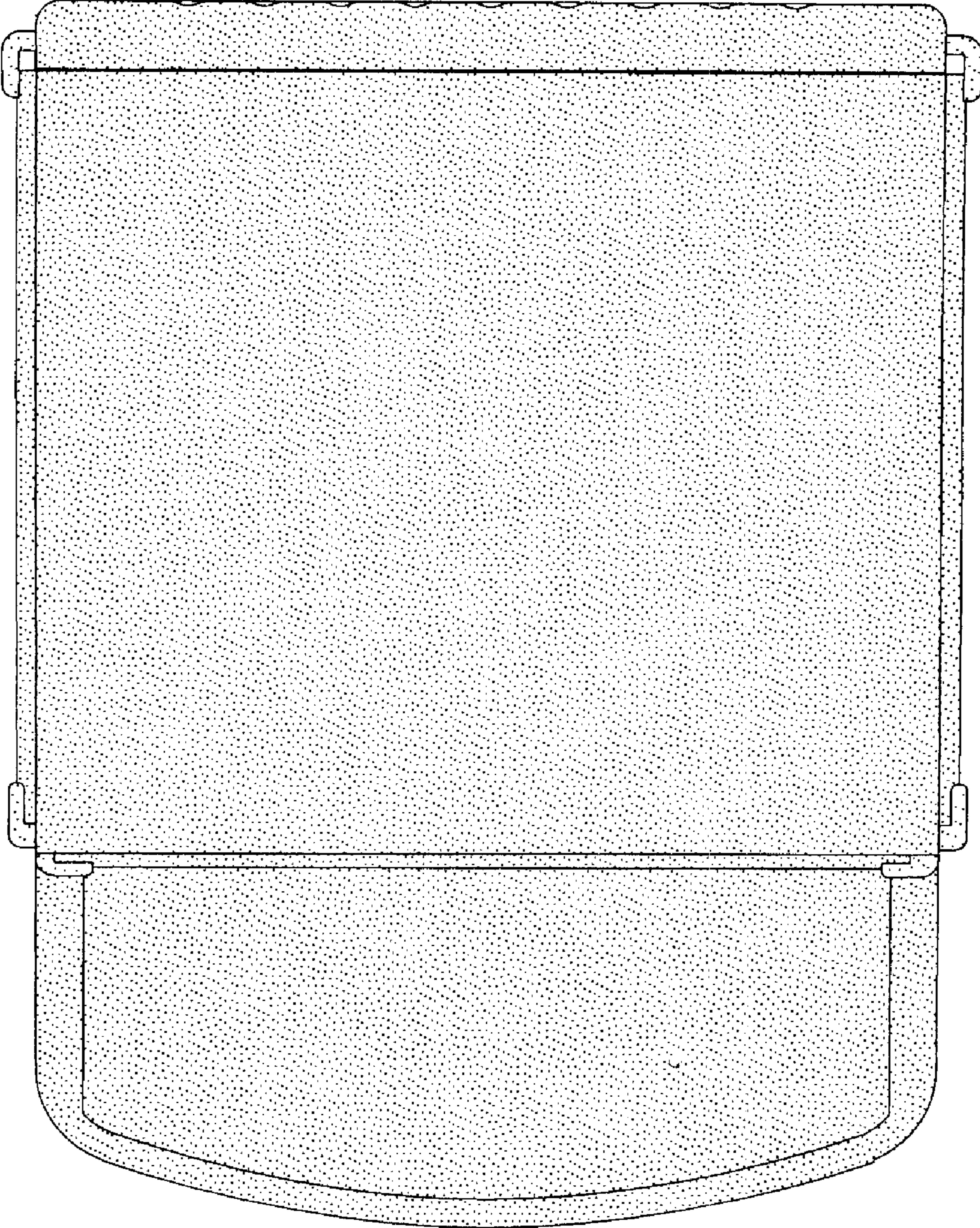

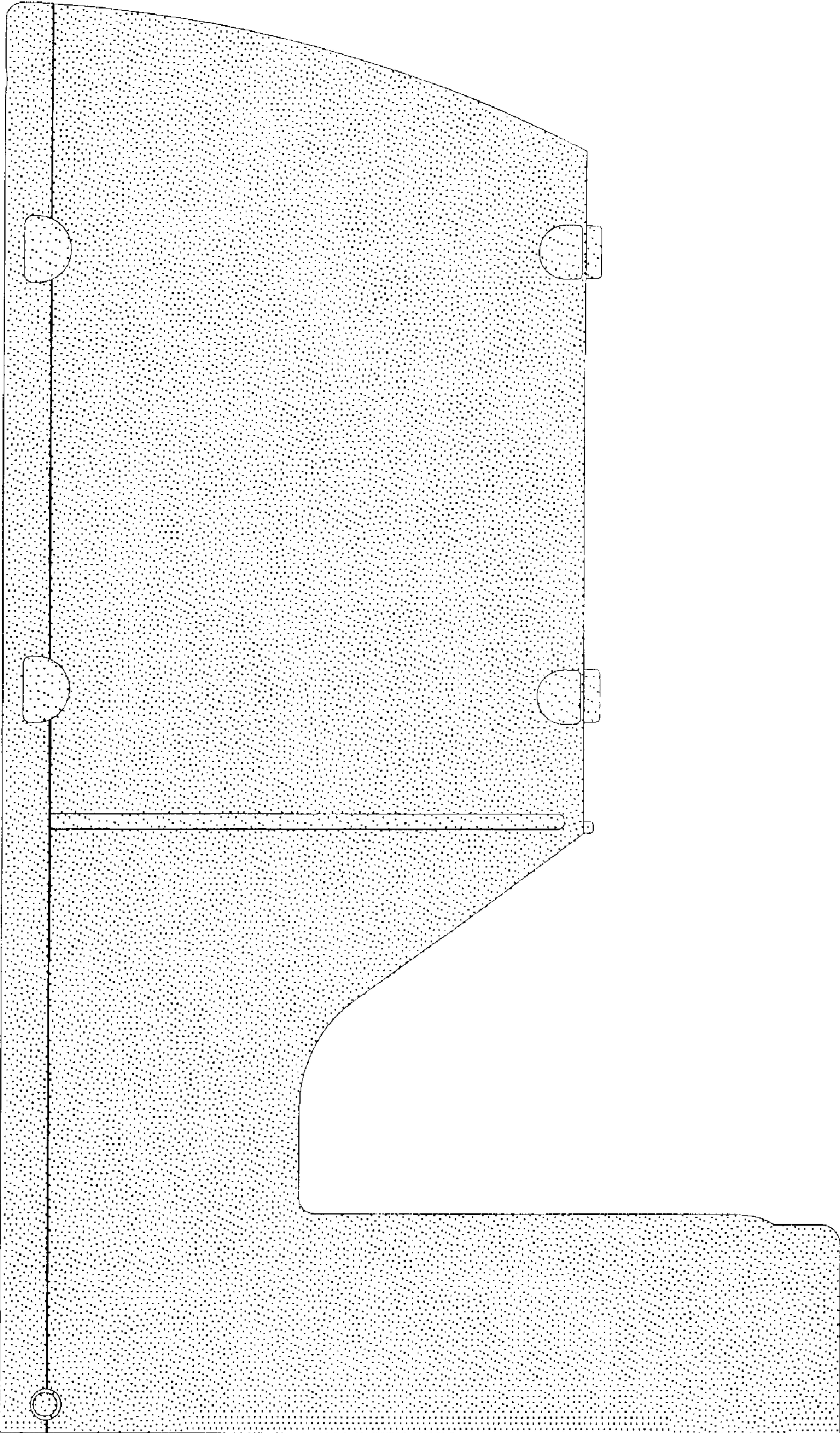

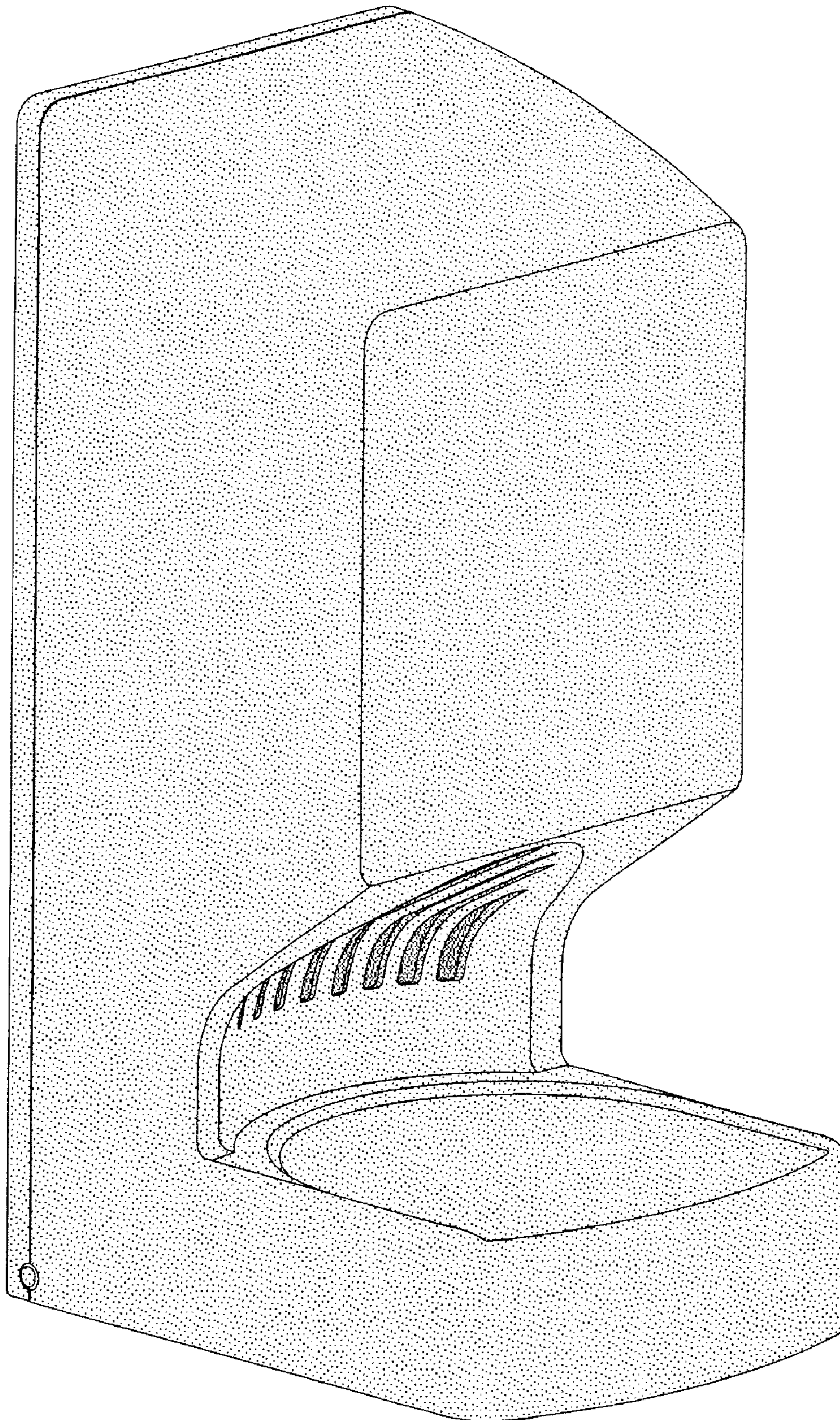

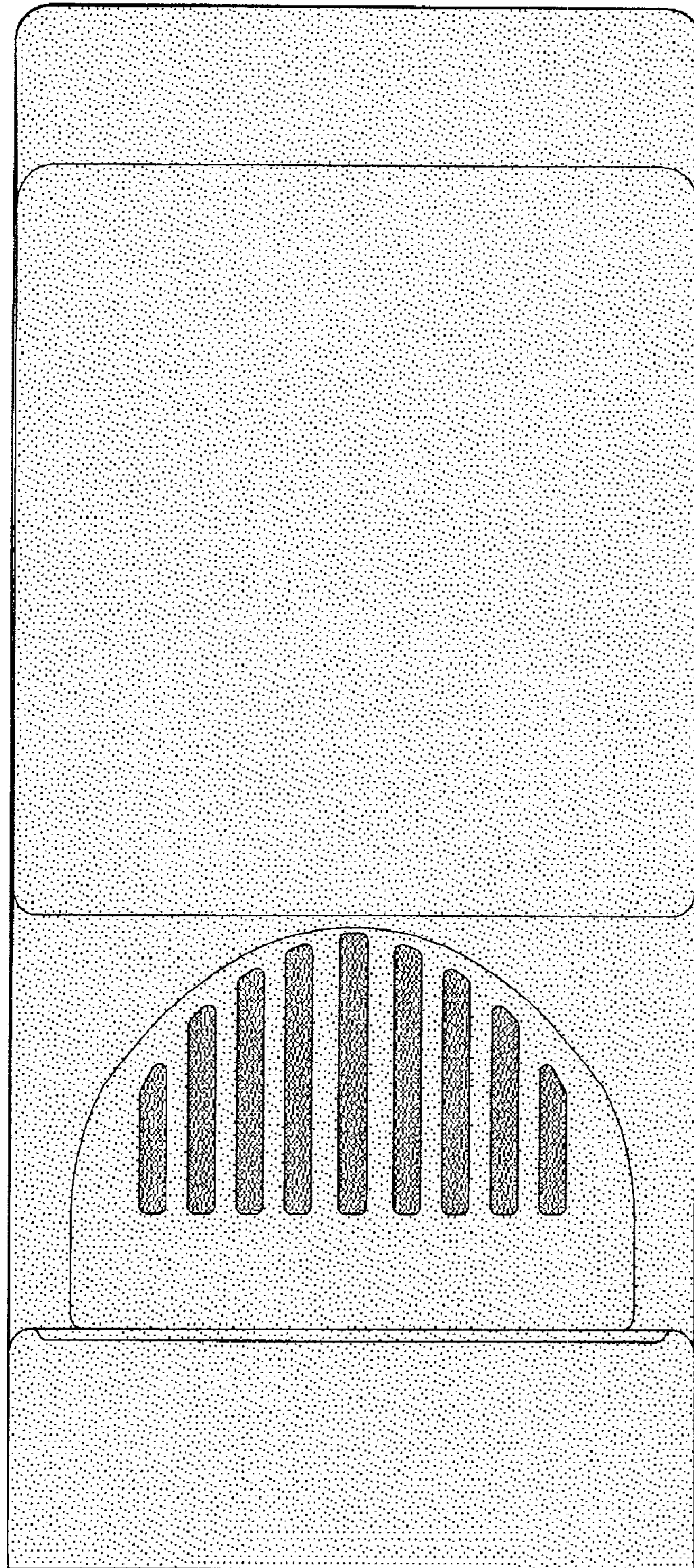

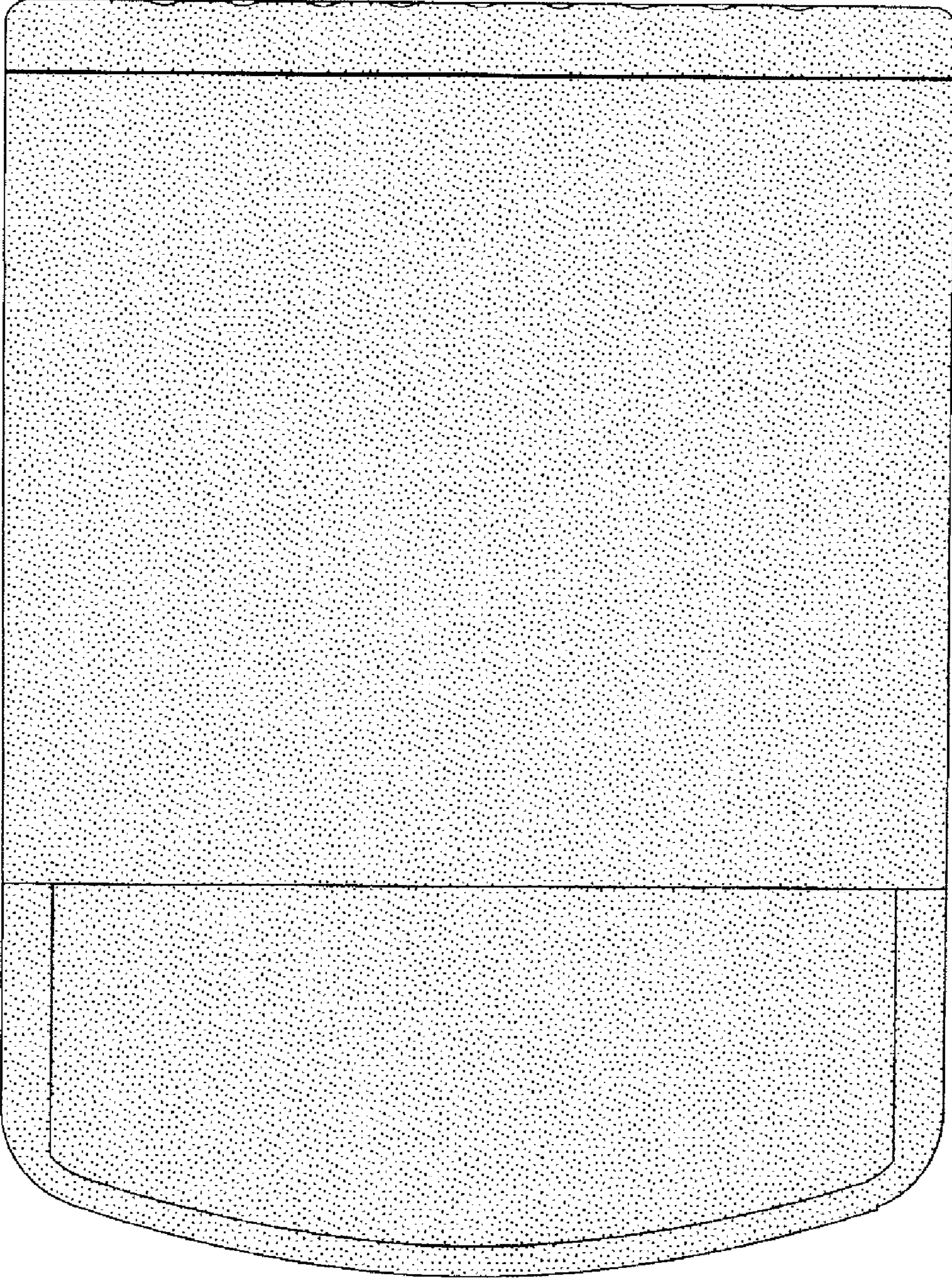

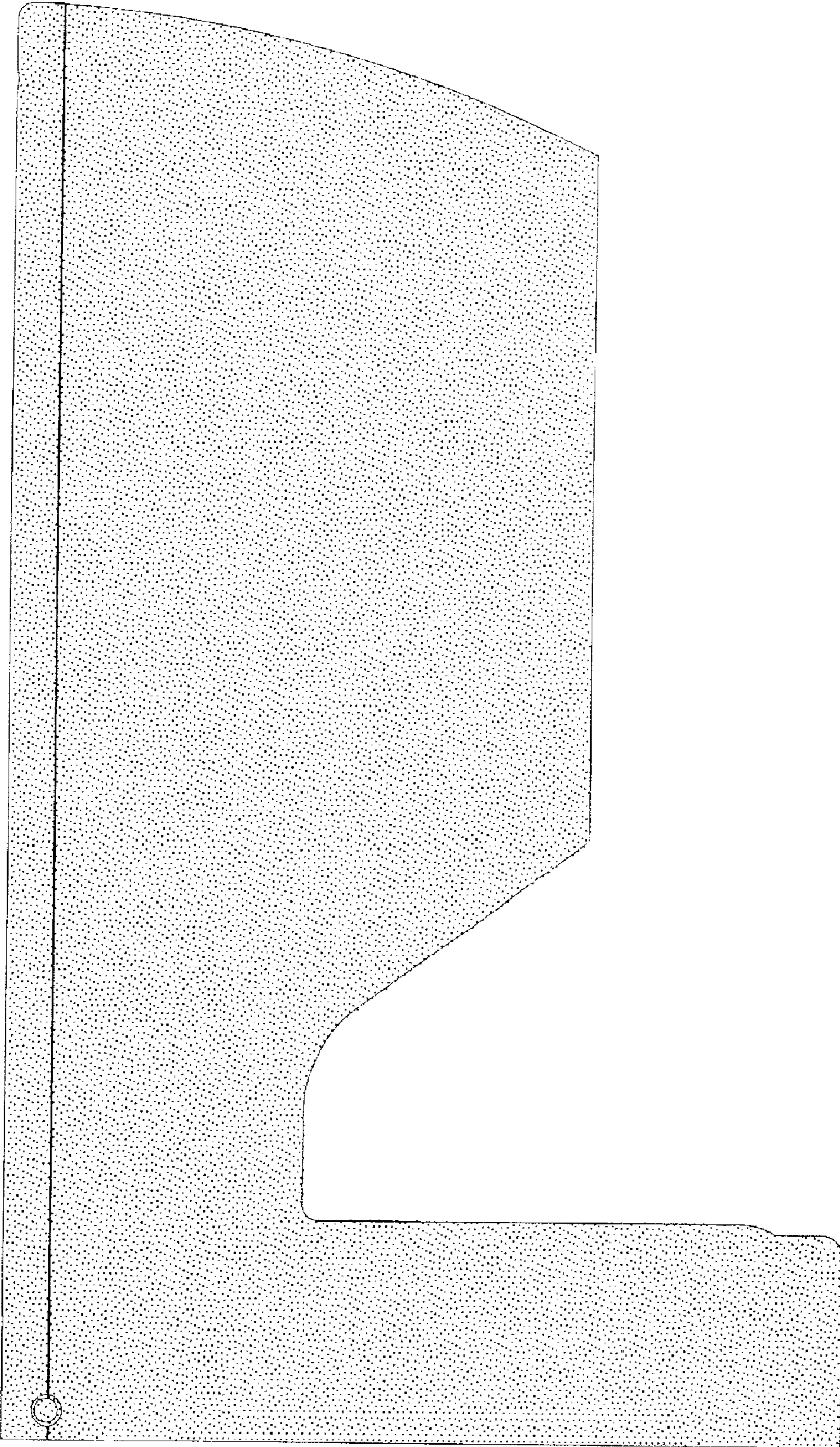
