FIG. 5 is a top view of the cabin frame of FIG. 1.

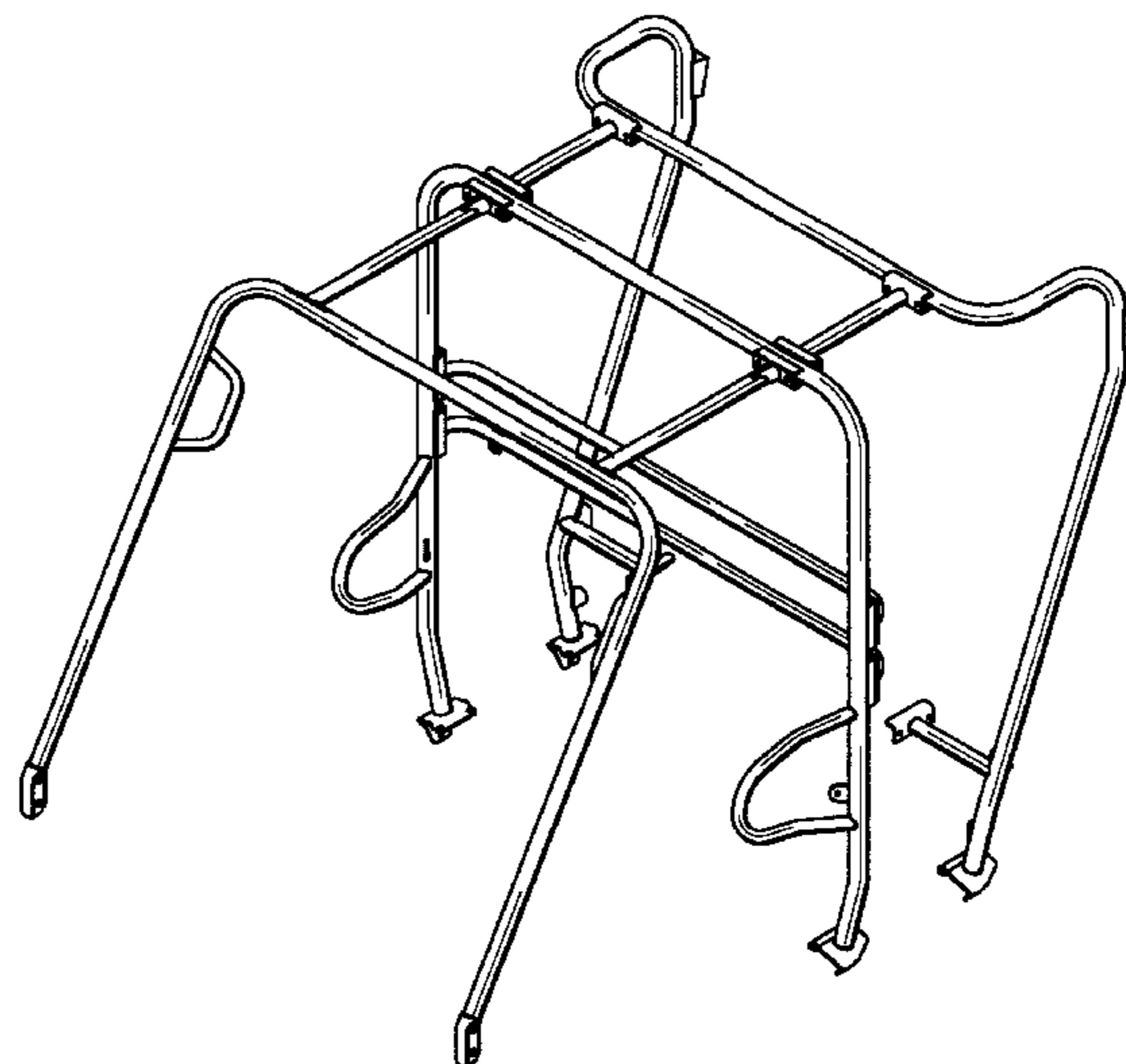
FIG. 6 is a bottom view of the cabin frame of FIG. 1.

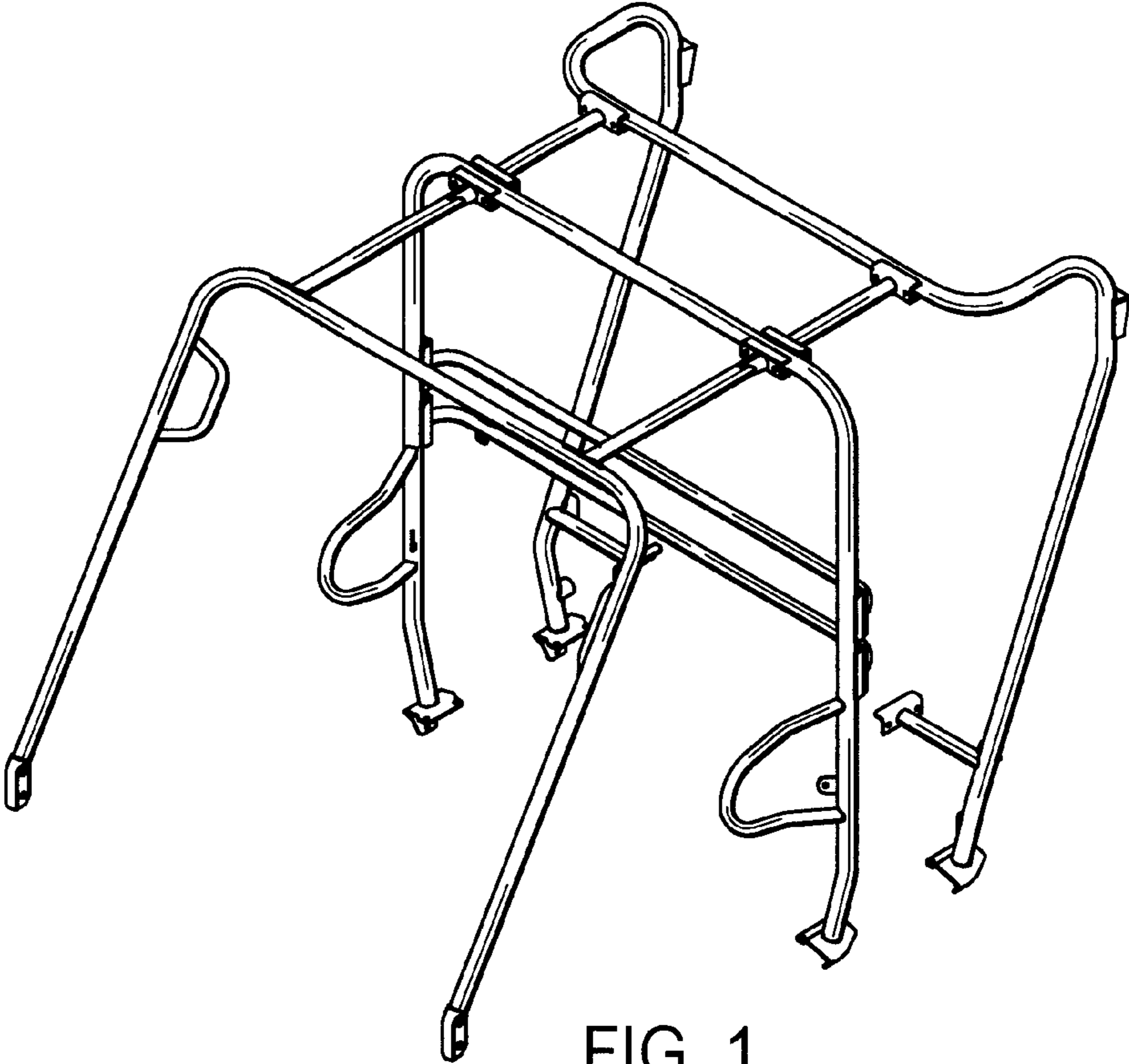

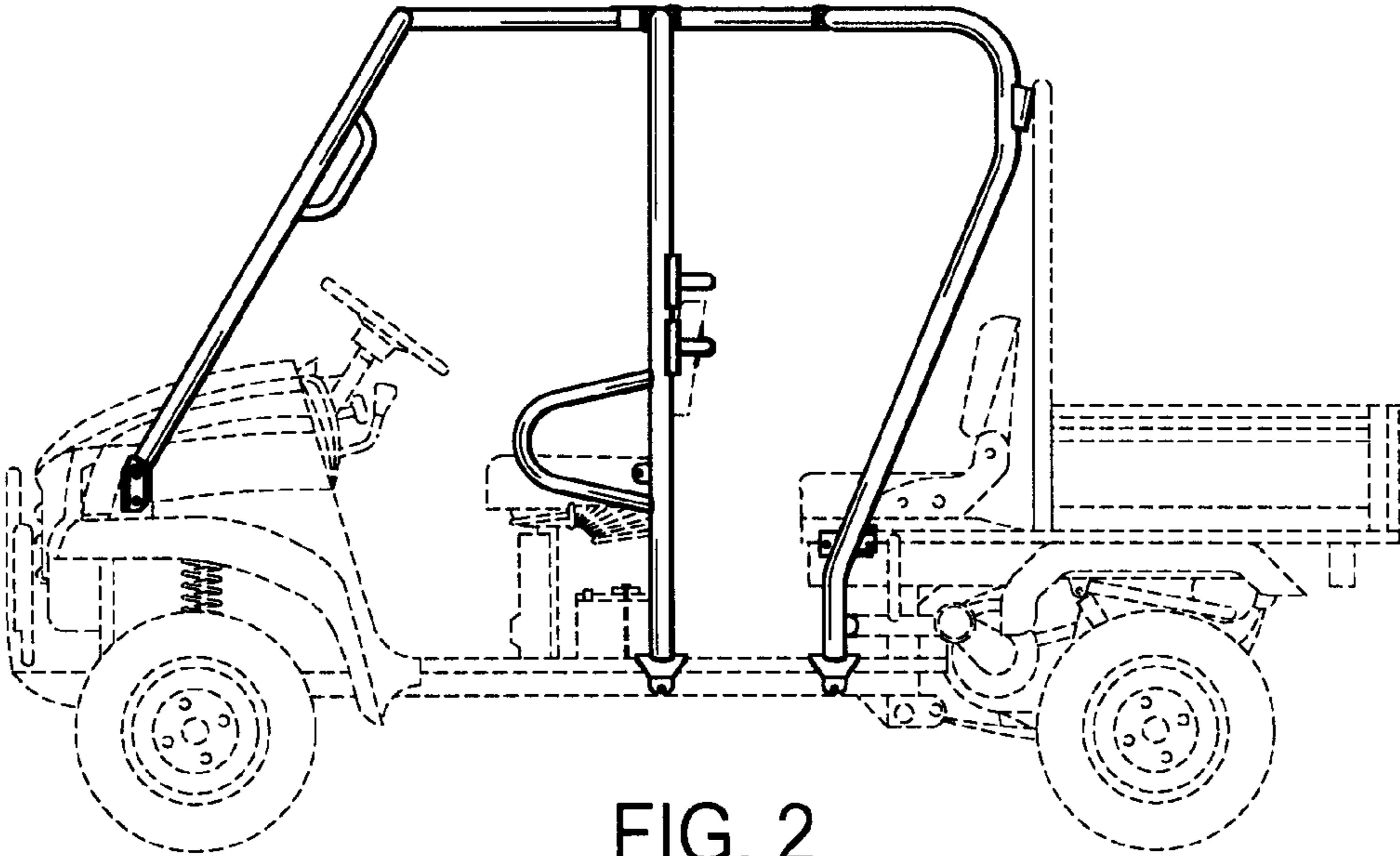

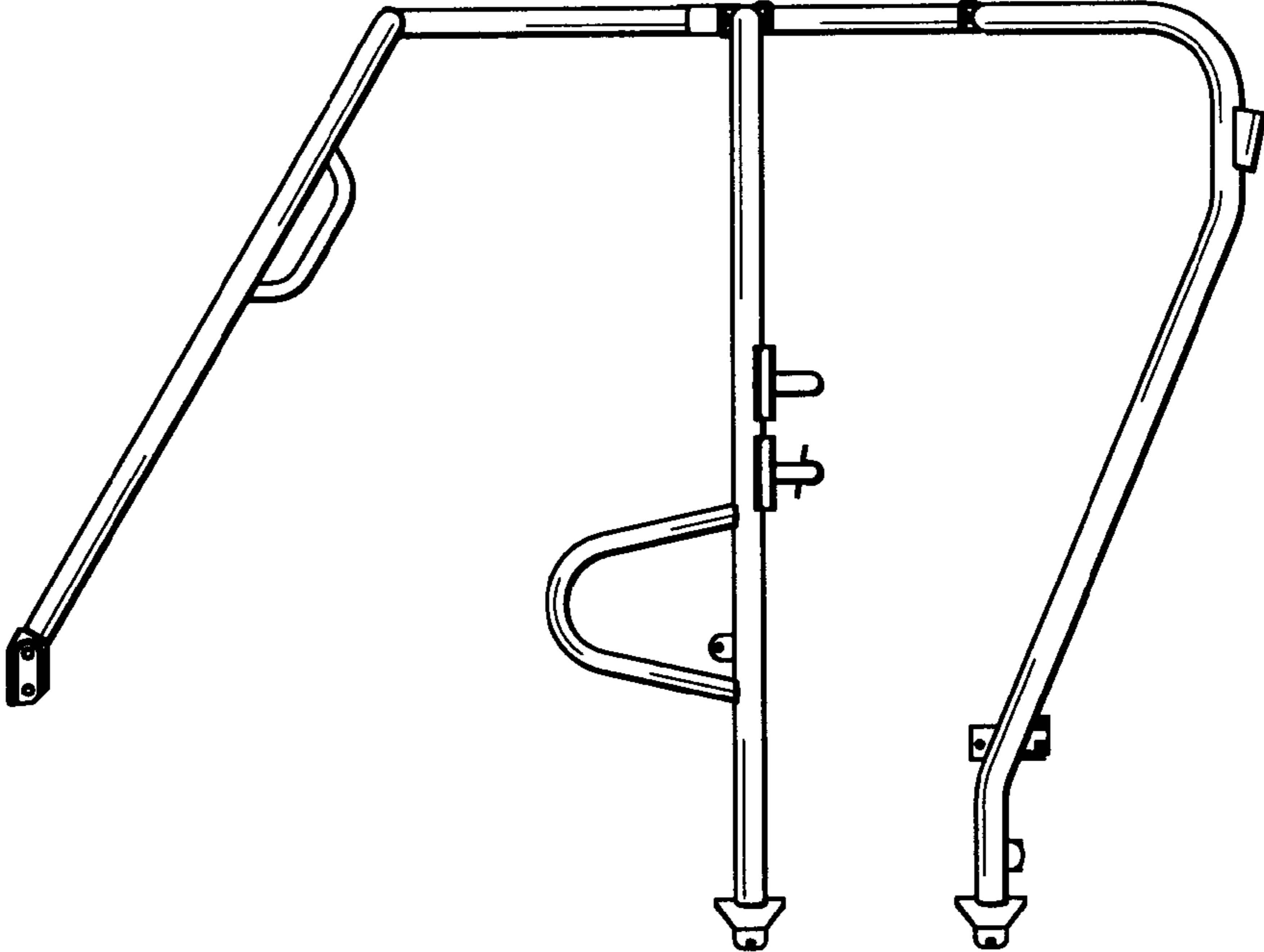

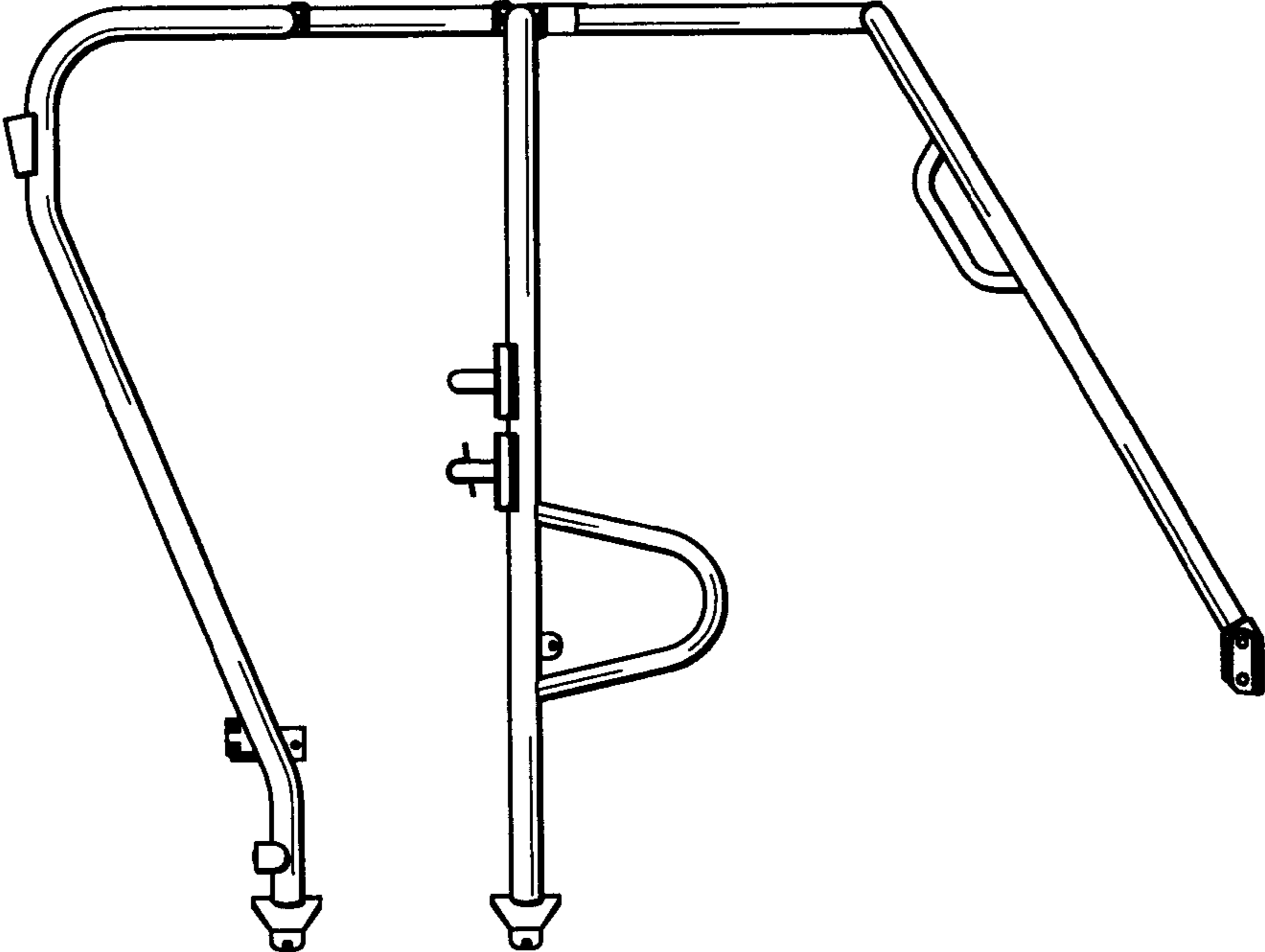

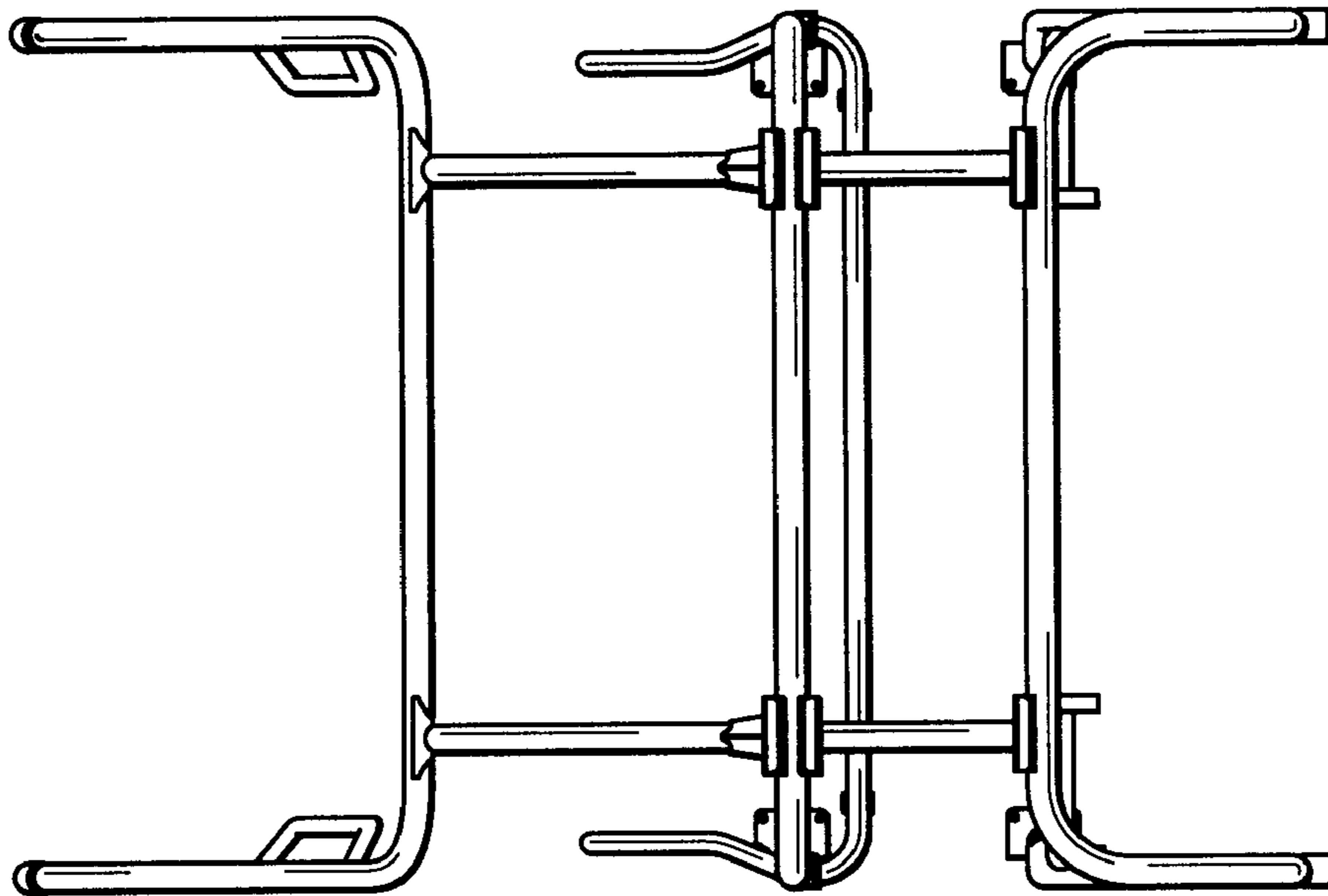

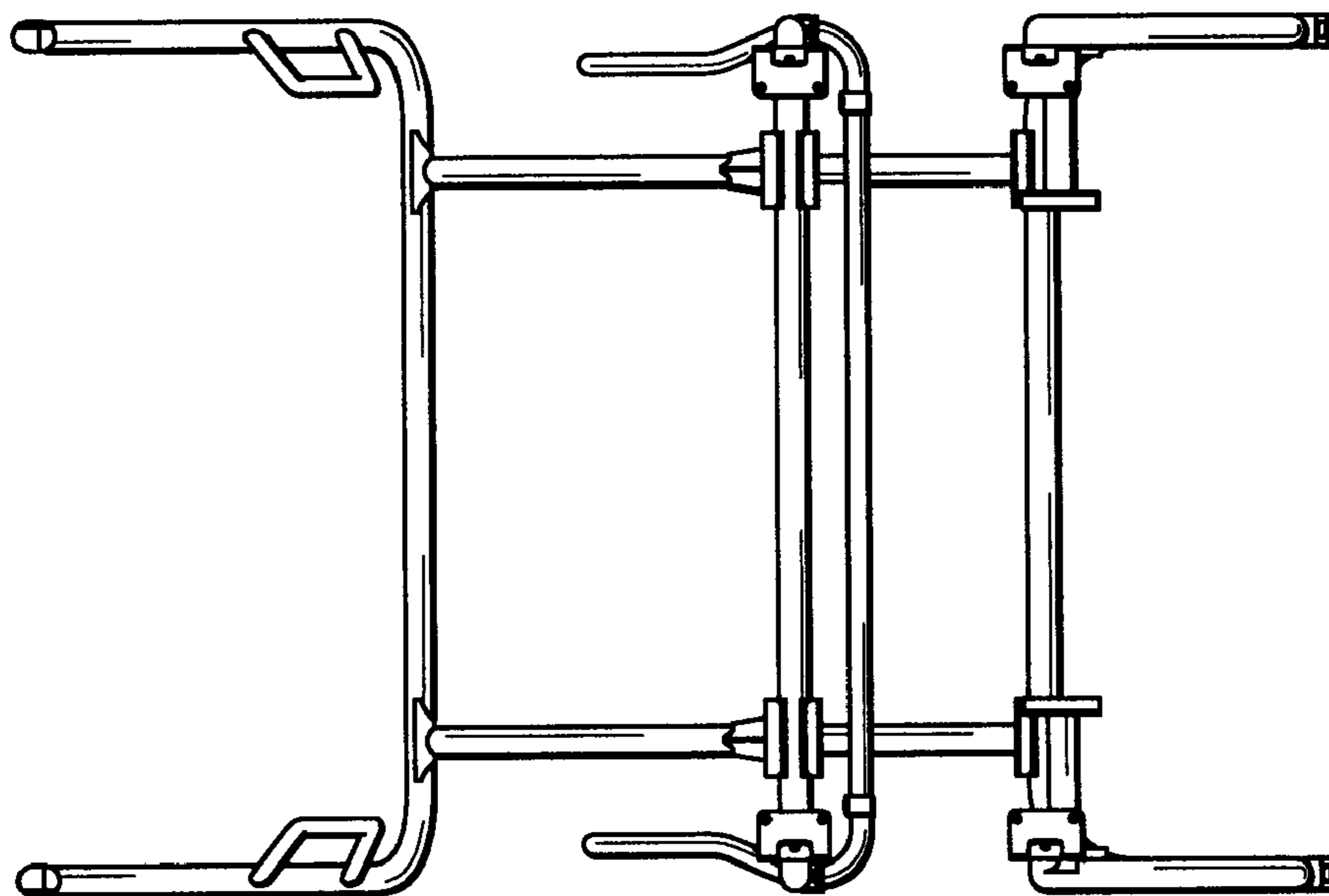

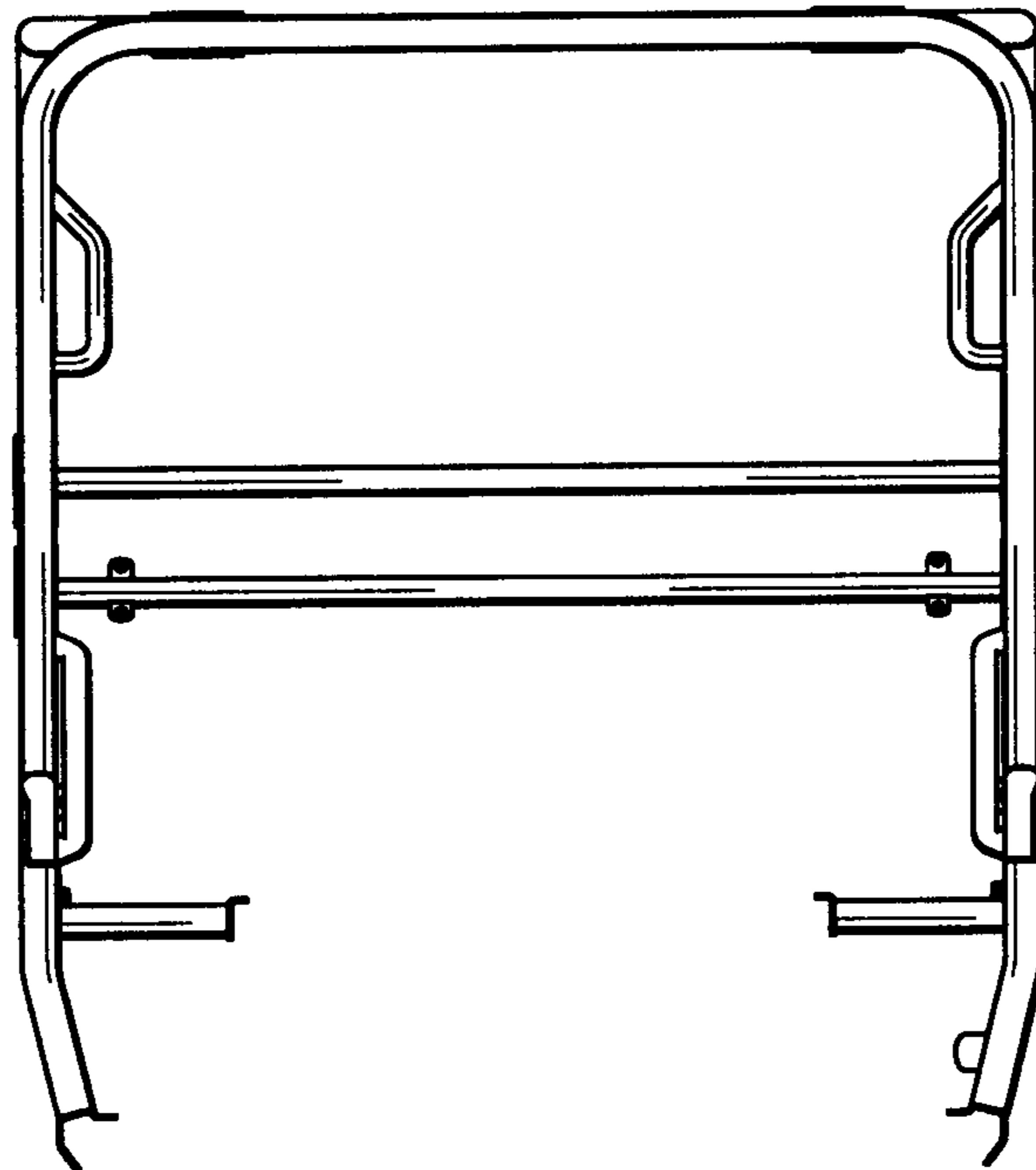

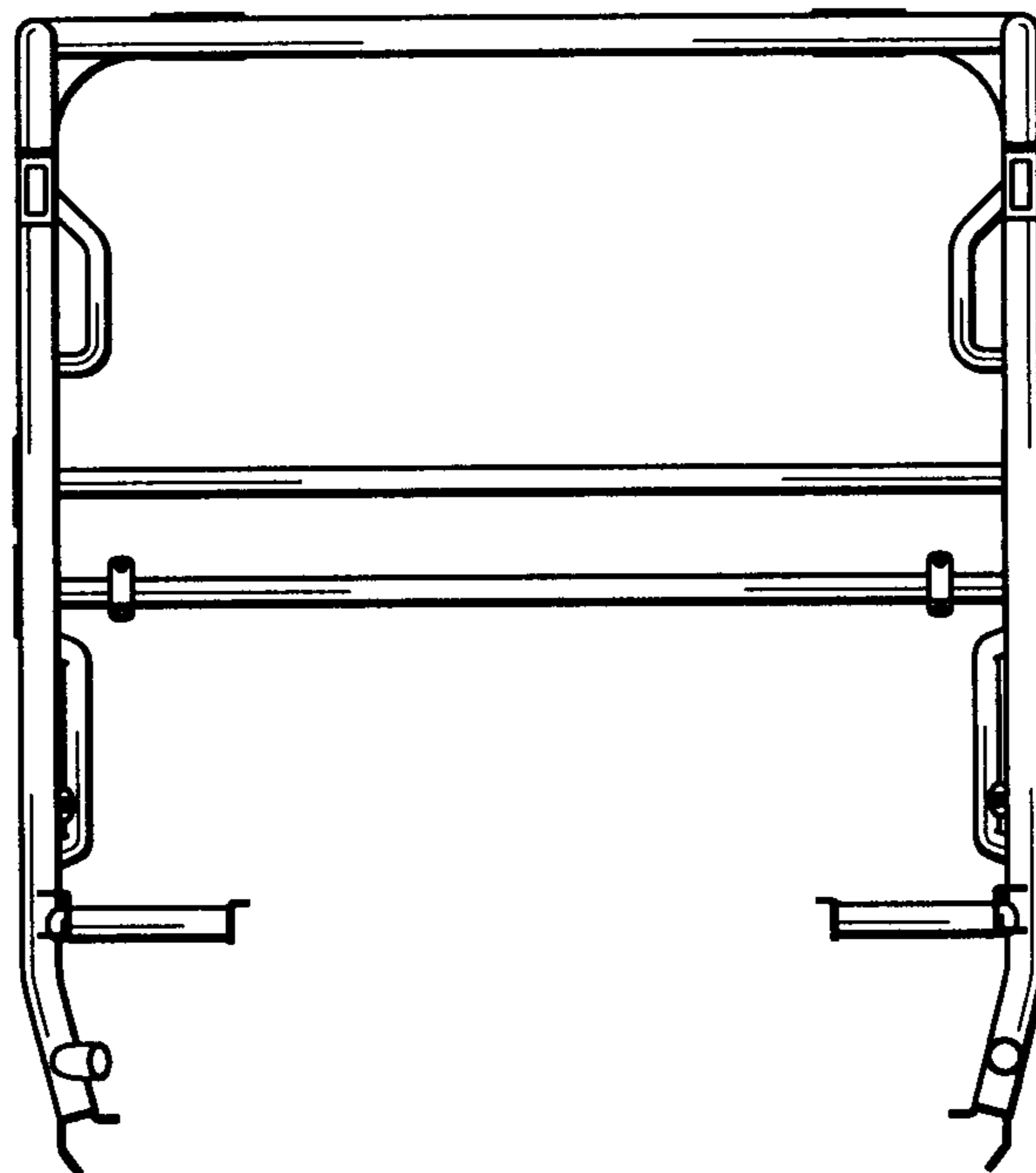
