(57) **CLAIM**

The ornamental design for a traveling working machine, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a traveling working machine;
 FIG. 2 is a rear elevational view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan thereof;
 FIG. 7 is a top, rear and left side plan view thereof showing the cabin thereof in a transversely moved state;
 FIG. 8 is a front elevational view thereof showing the state wherein the cabin is laterally extended;
 FIG. 9 is a front elevational view thereof with the boom protruded forwardly;
 FIG. 10 is an enlarged end view taken along line A—A of FIG. 1 with the internal mechanisms thereof omitted;
 FIG. 11 is a front elevational view thereof showing the transparent members thereof in cross-sectional lines;
 FIG. 12 is a rear elevational view thereof;
 FIG. 13 is a left side elevational view thereof;
 FIG. 14 is a right side elevational view thereof; and,
 FIG. 15 is a top plan view thereof.

The phantom lines shown, as well as the bucket attachable to the end of the boom, form no part of the claimed invention.

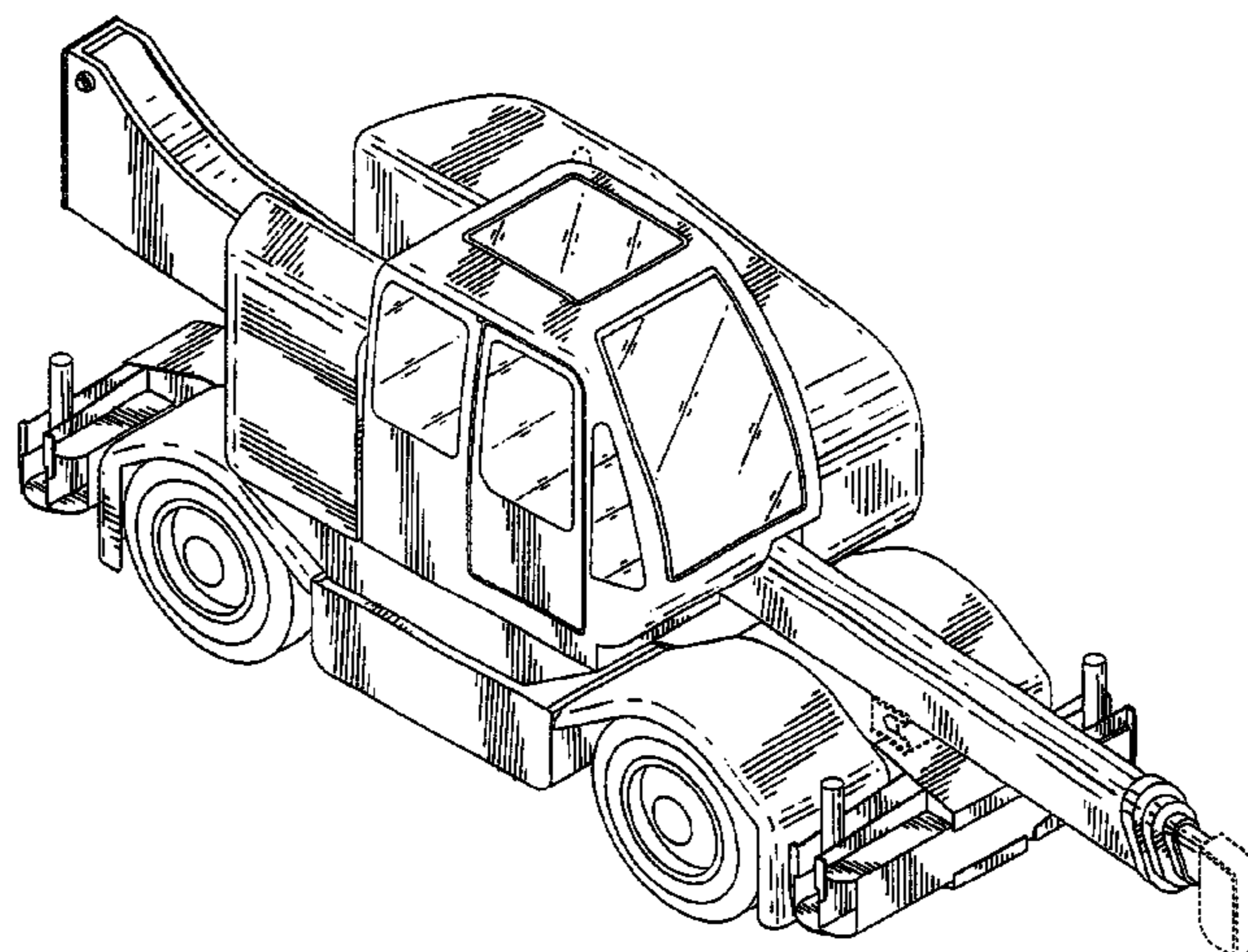

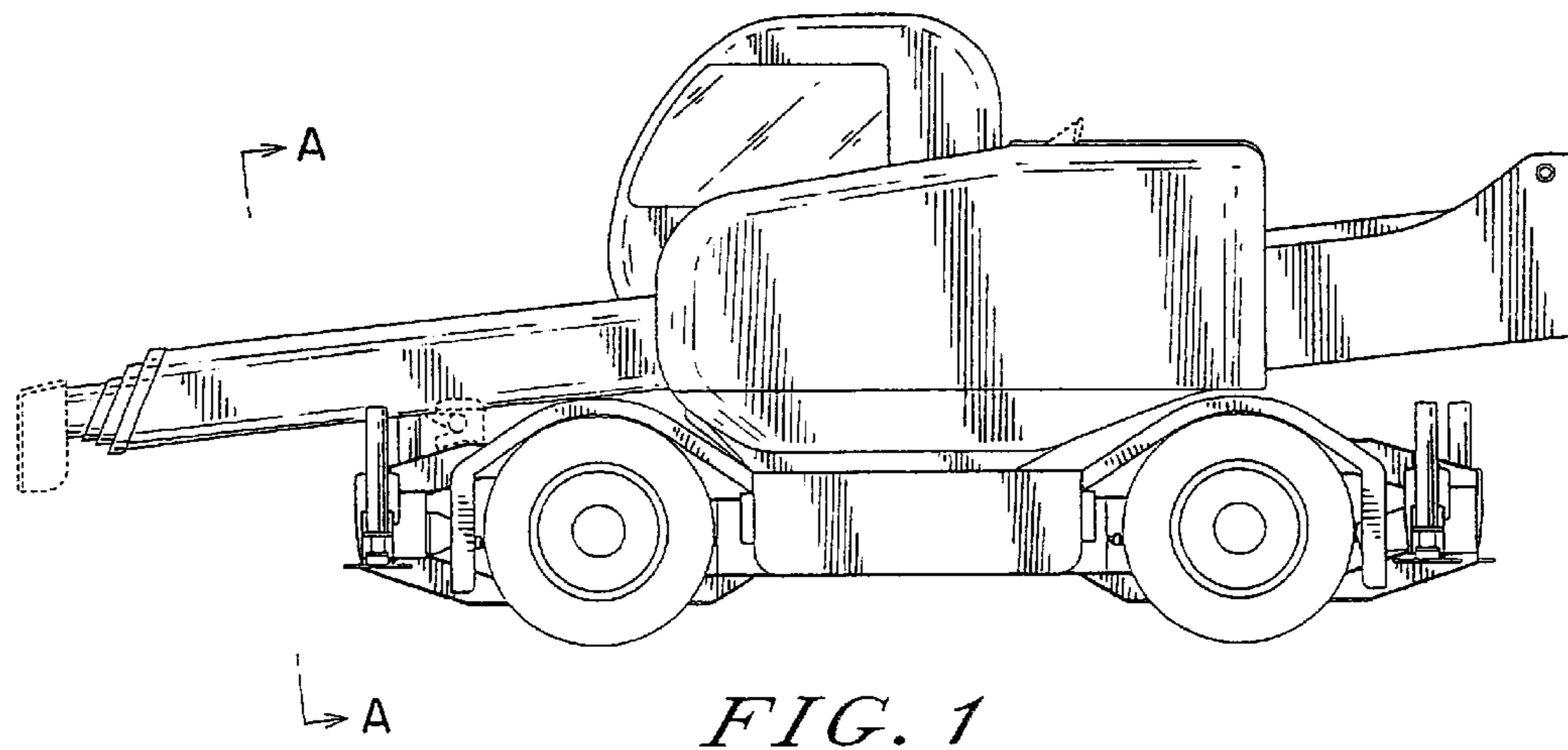
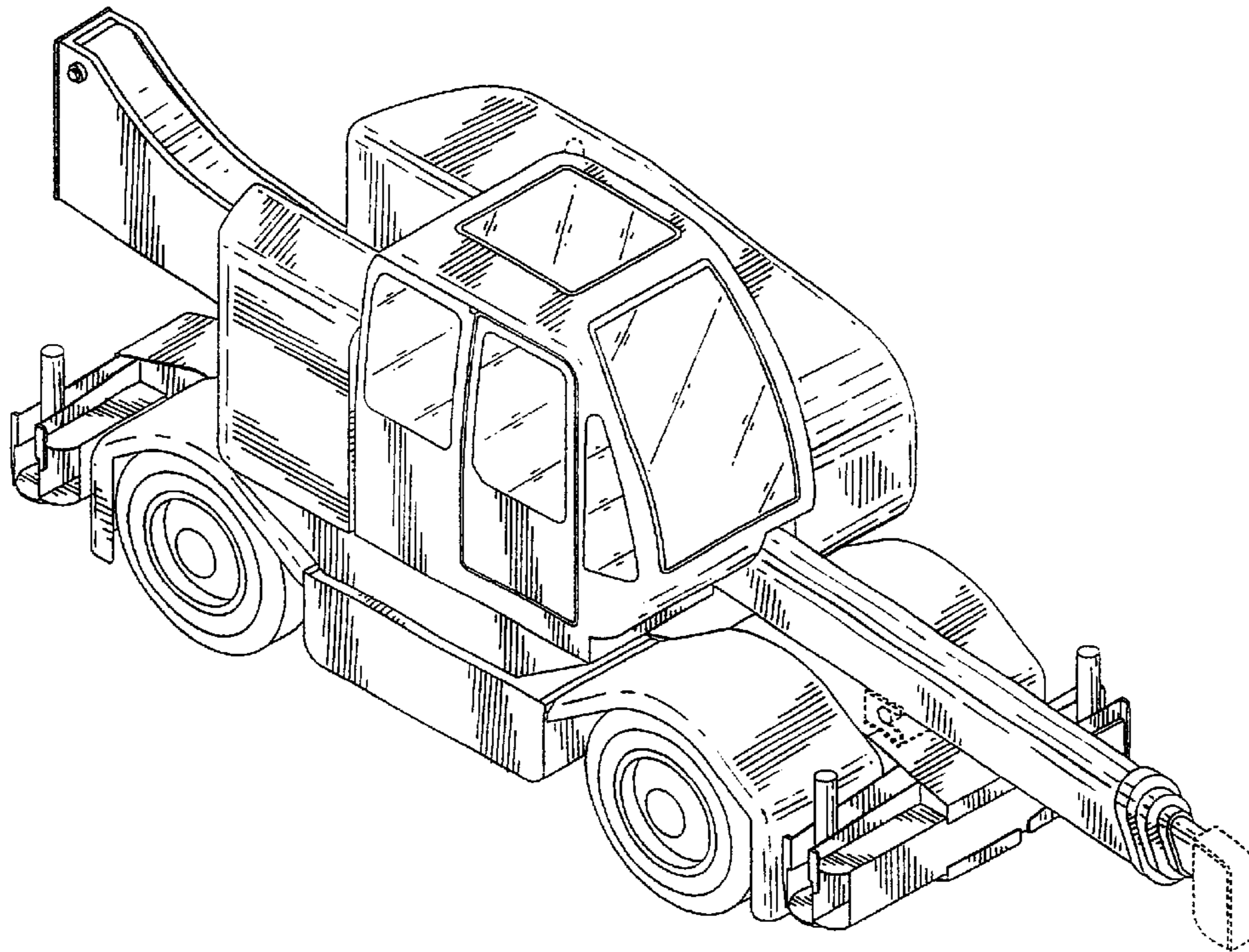

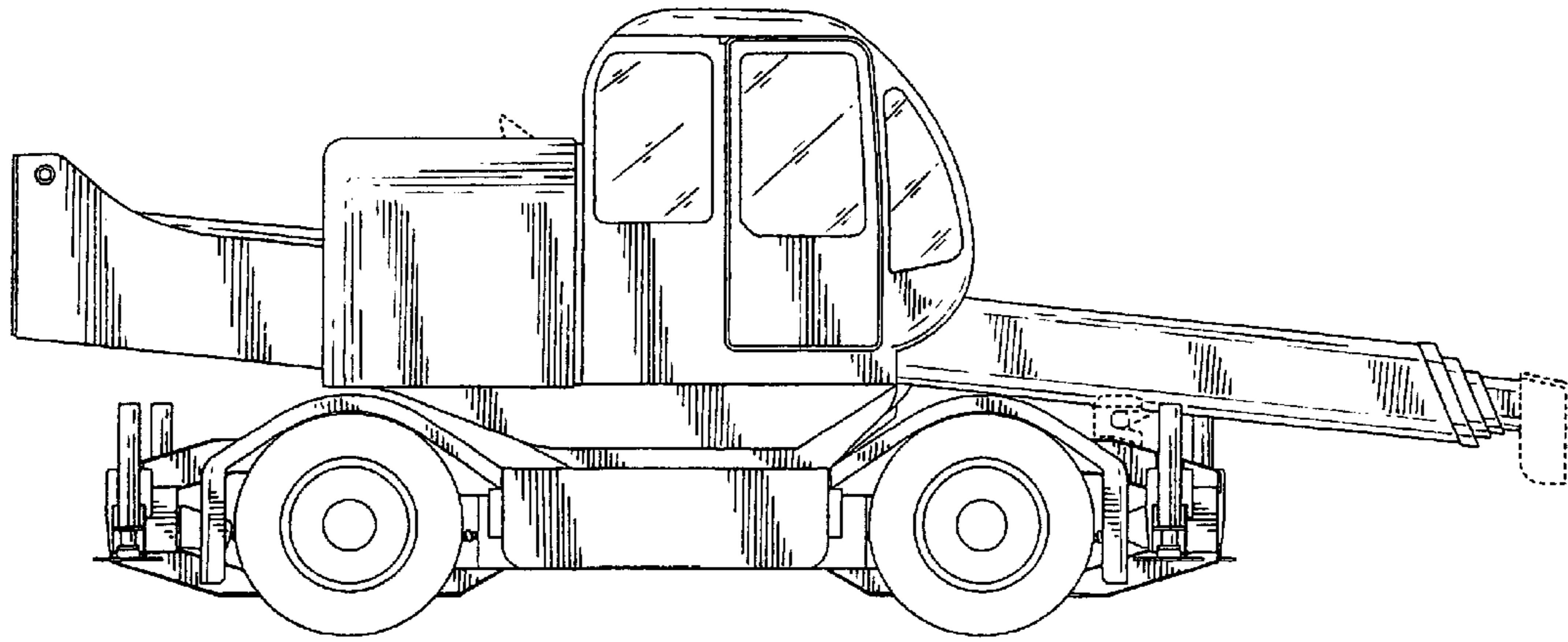

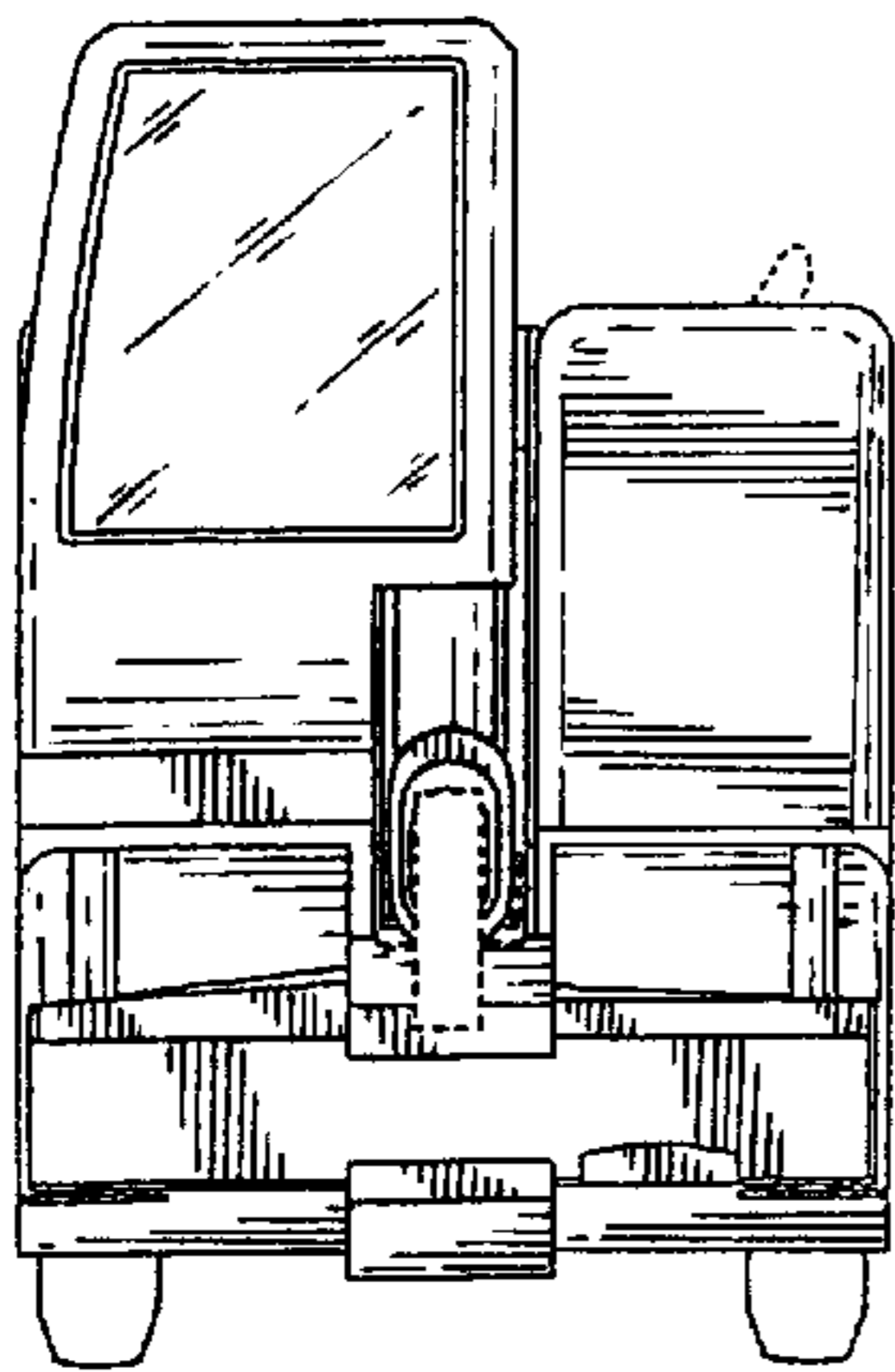

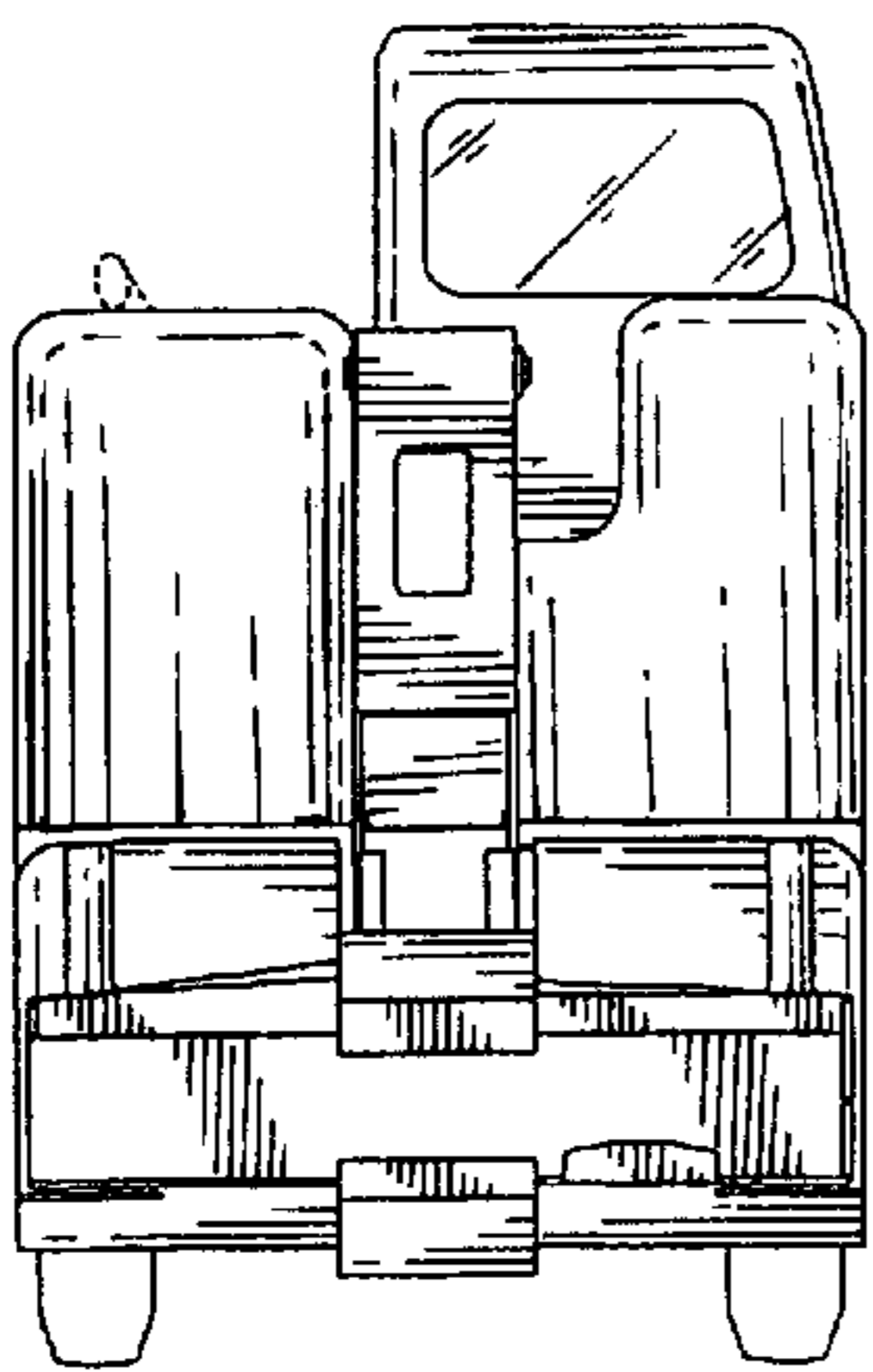

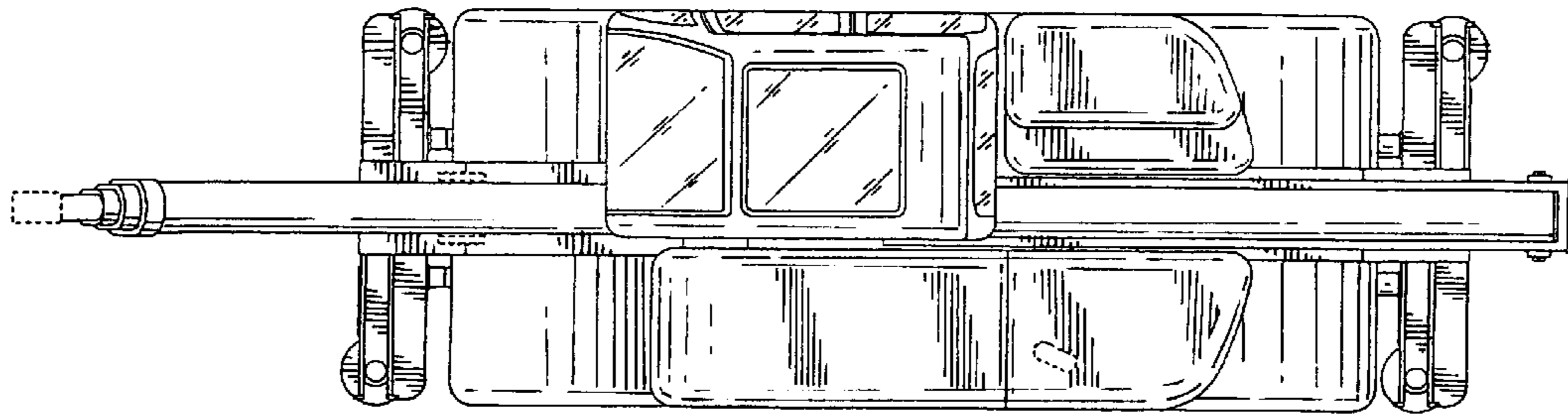

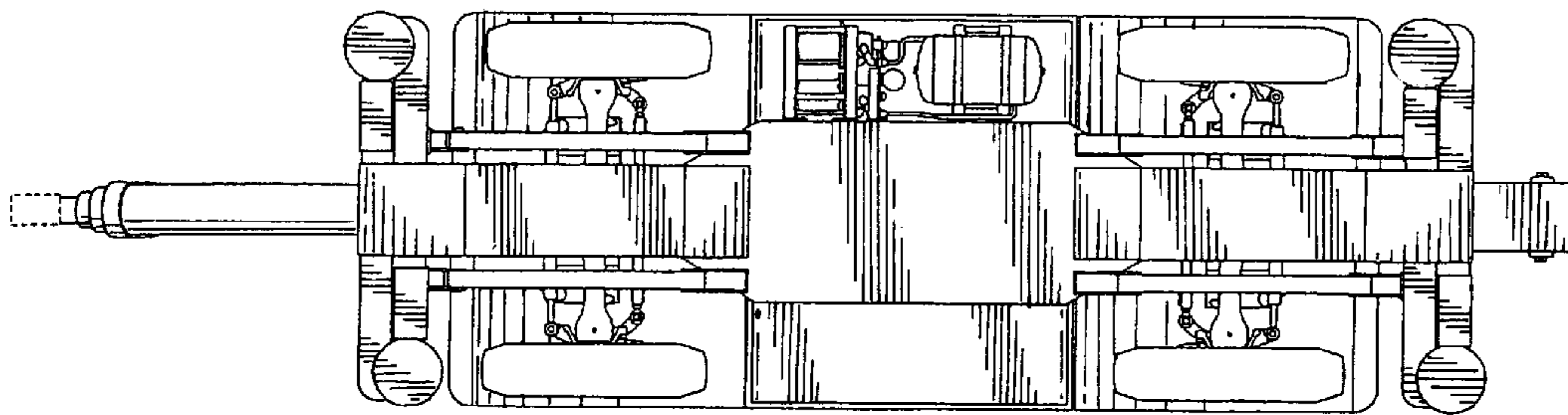

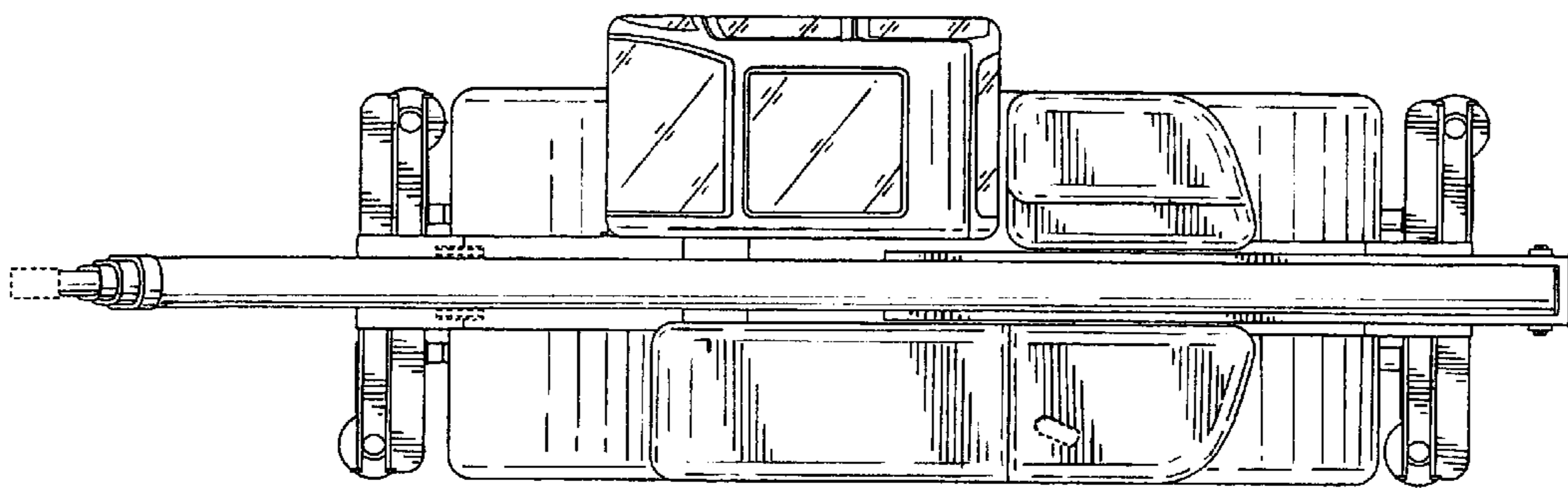

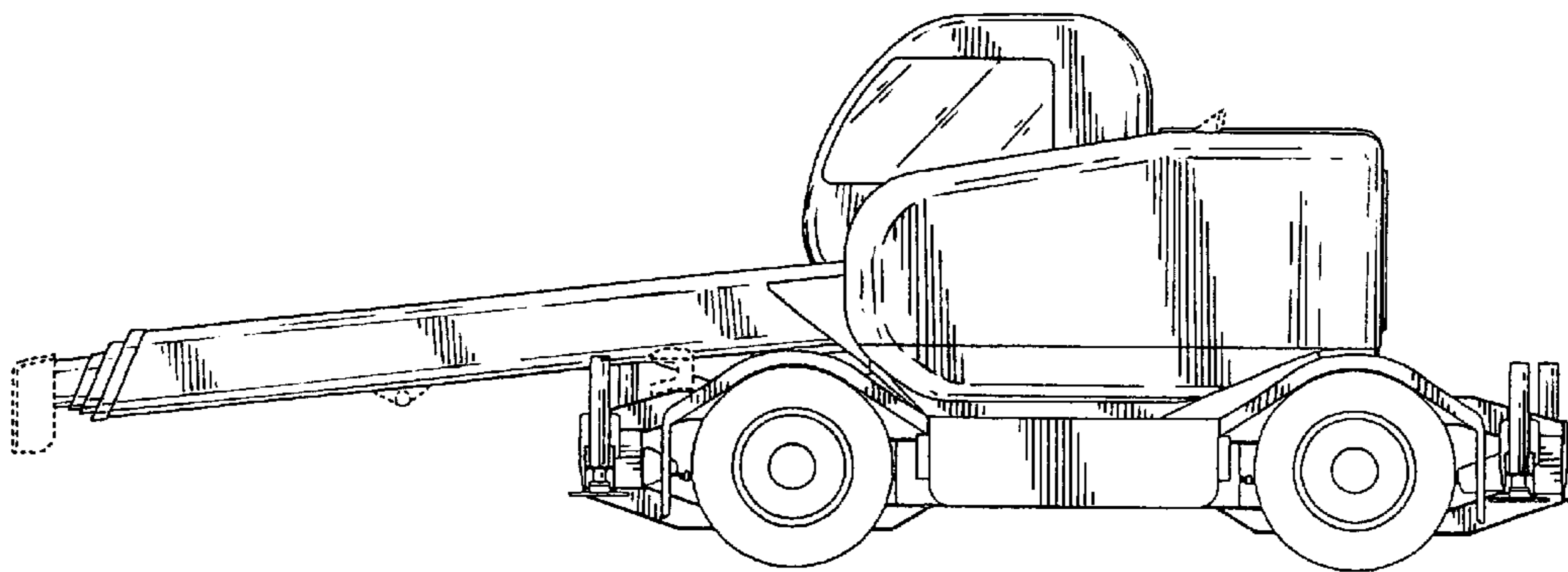

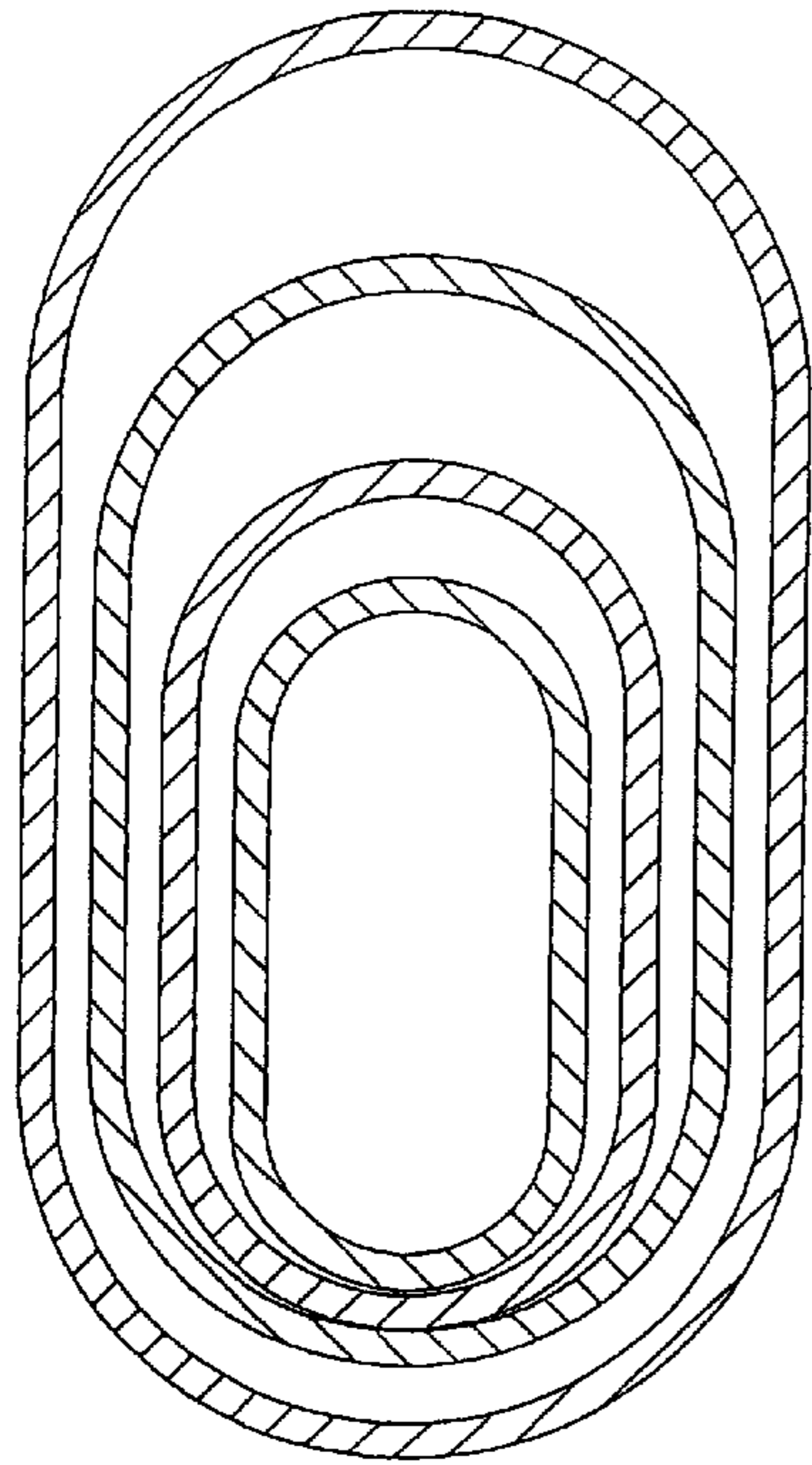

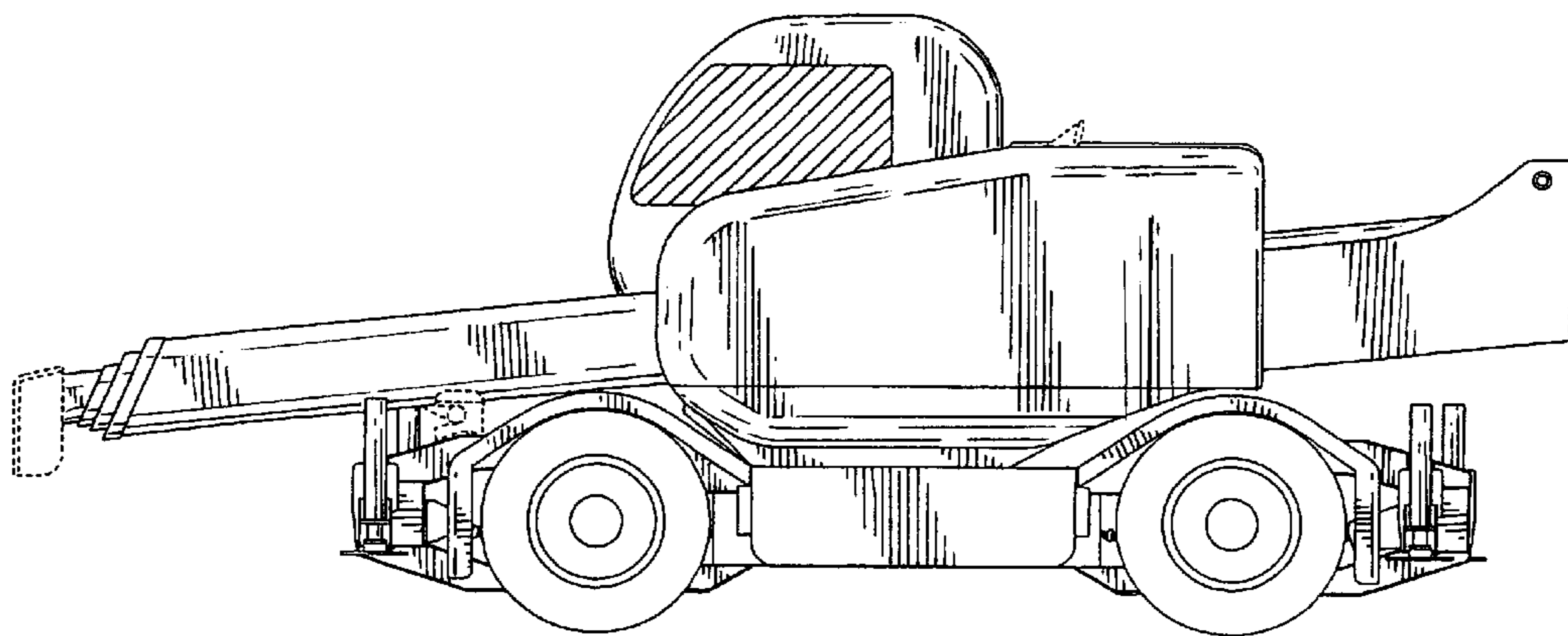

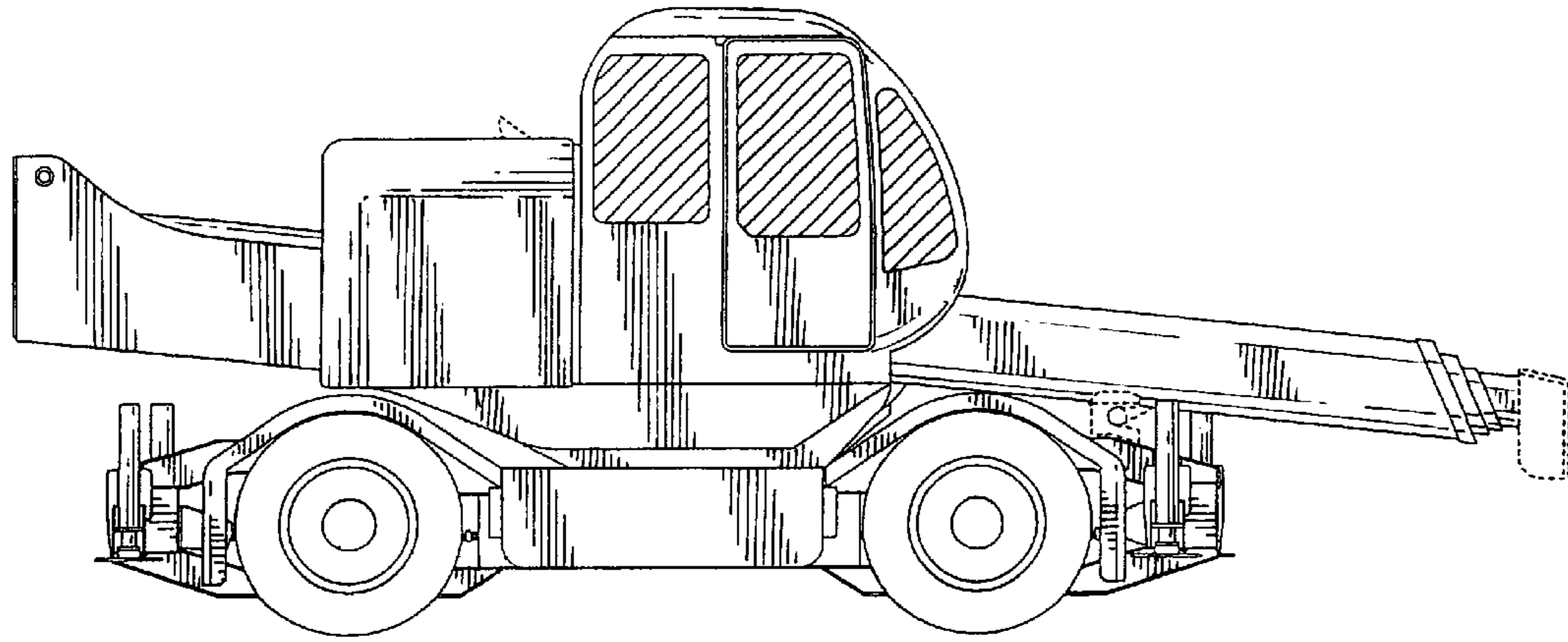

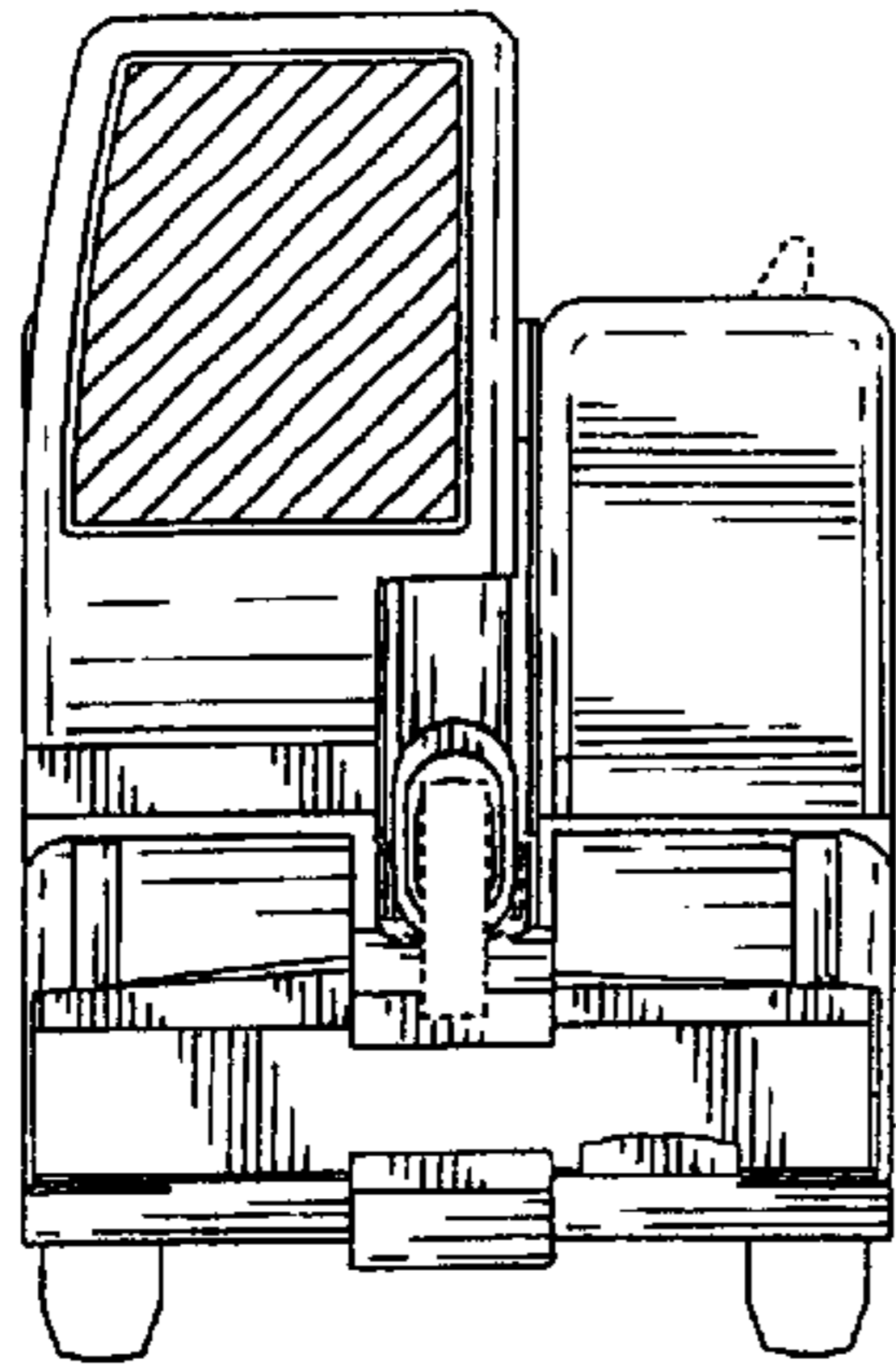

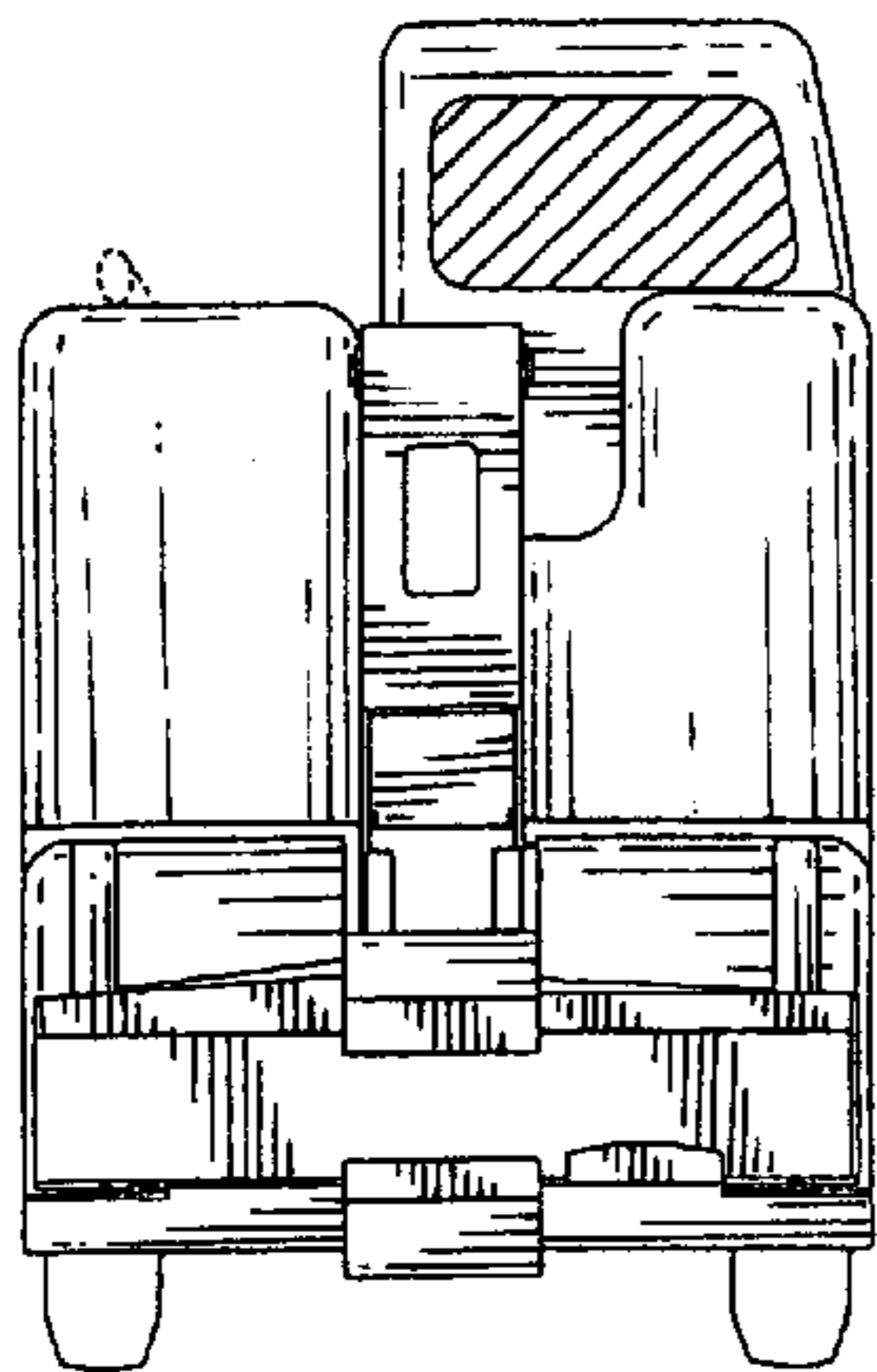

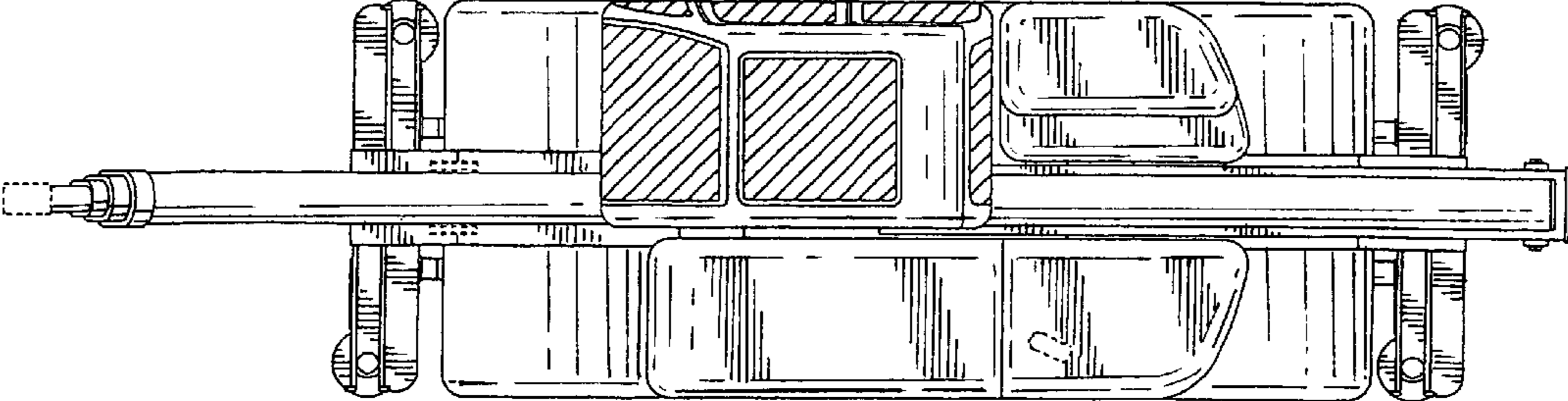
