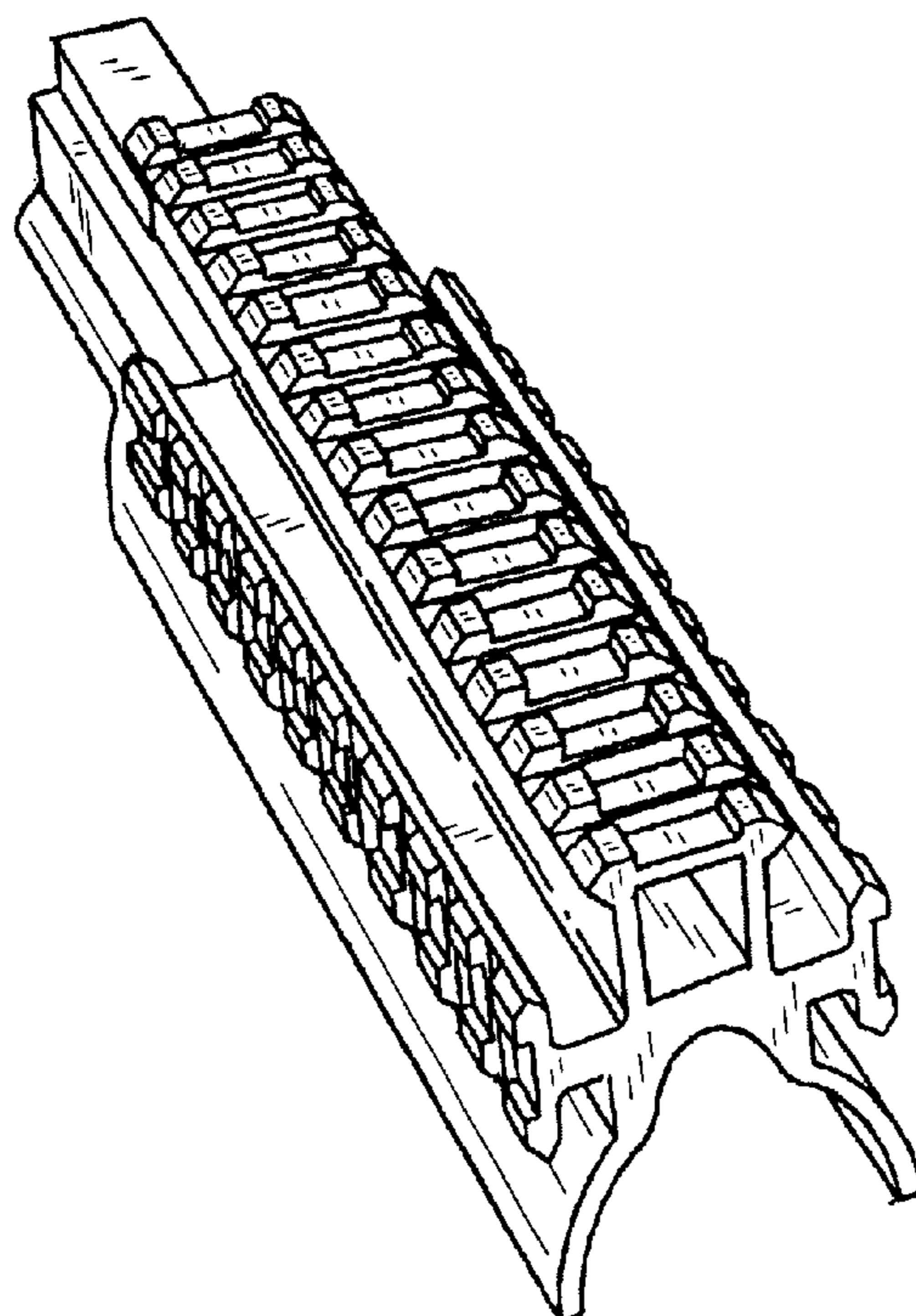
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top isometric perspective view of a multi-rail firearm accessory mount according to the present invention; FIG. 2 is a right side elevational view of FIG. 1; FIG. 3 is a left side elevational view of FIG. 1; FIG. 4 is a rear end elevational view of FIG. 1; FIG. 5 is a front and elevational view of FIG. 1; FIG. 6 is a top view of FIG. 1; and, FIG. 7 is a bottom view of FIG. 1.

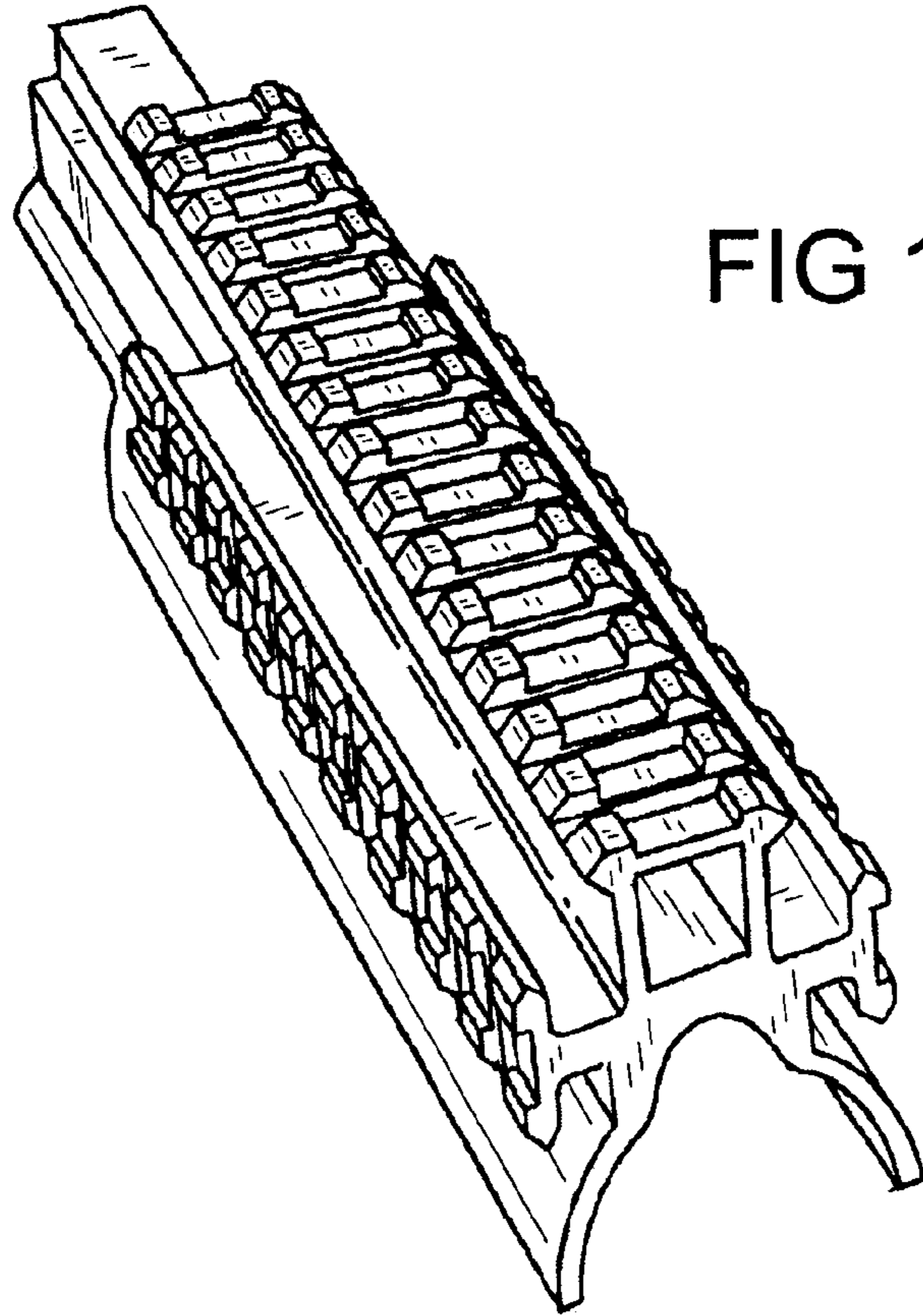

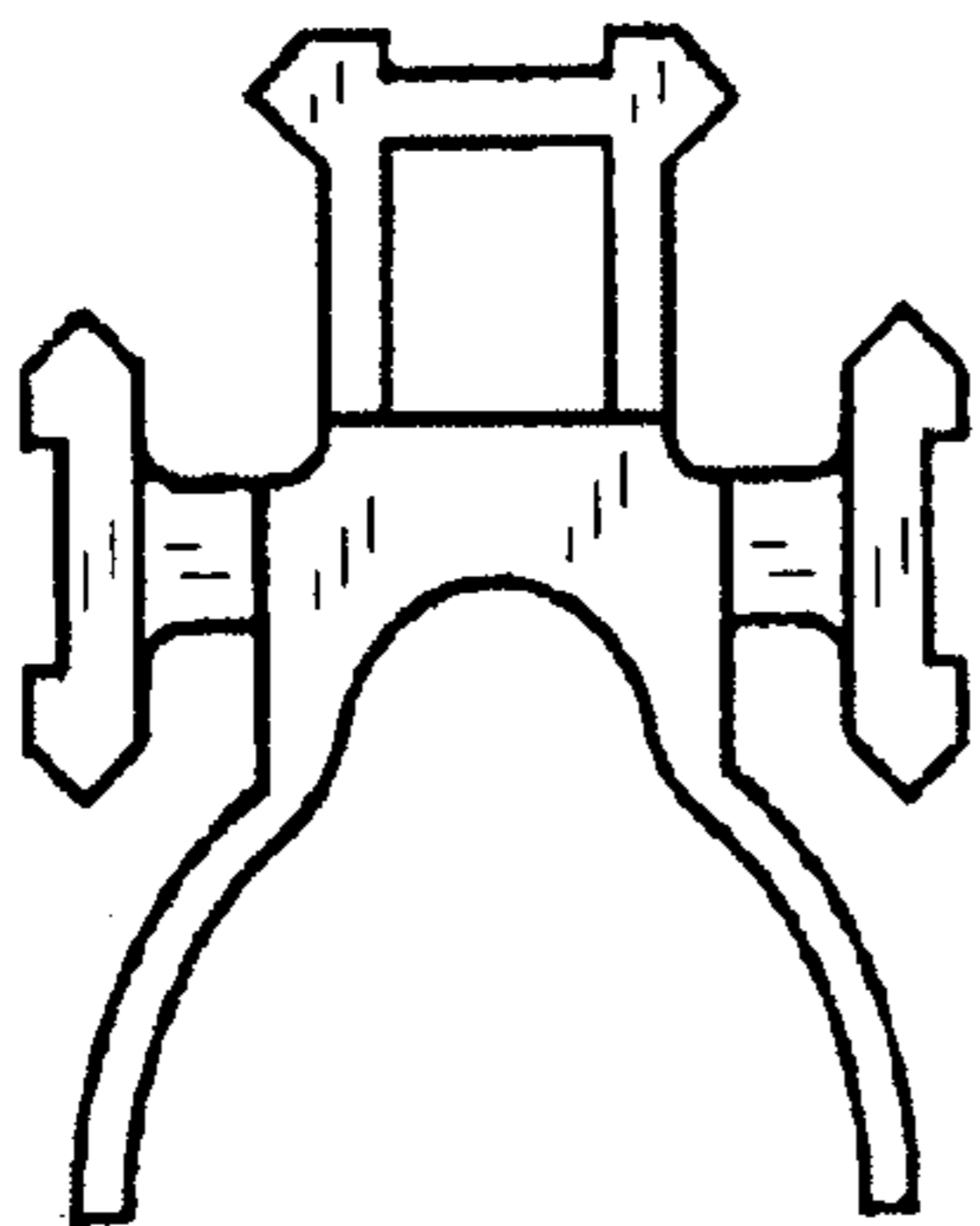

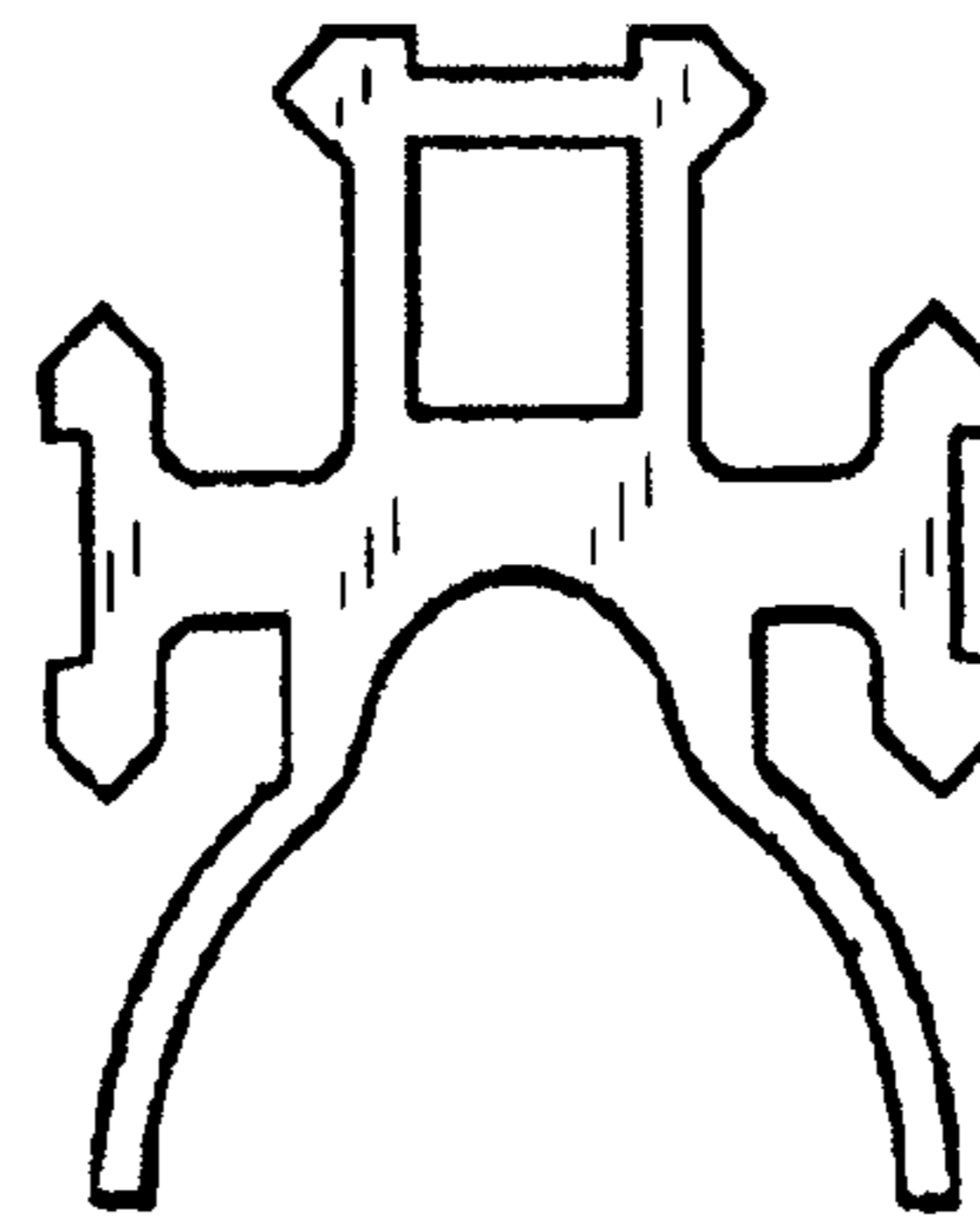

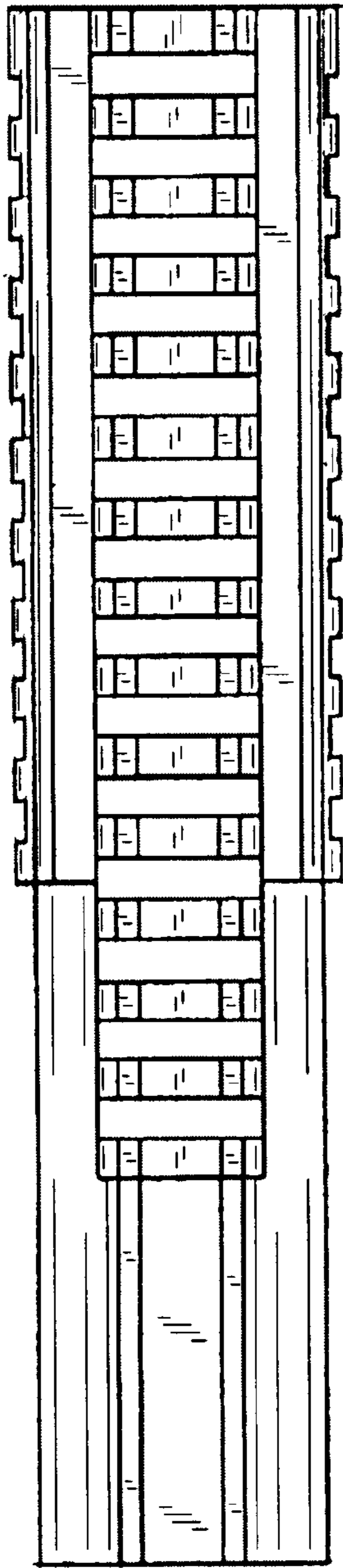

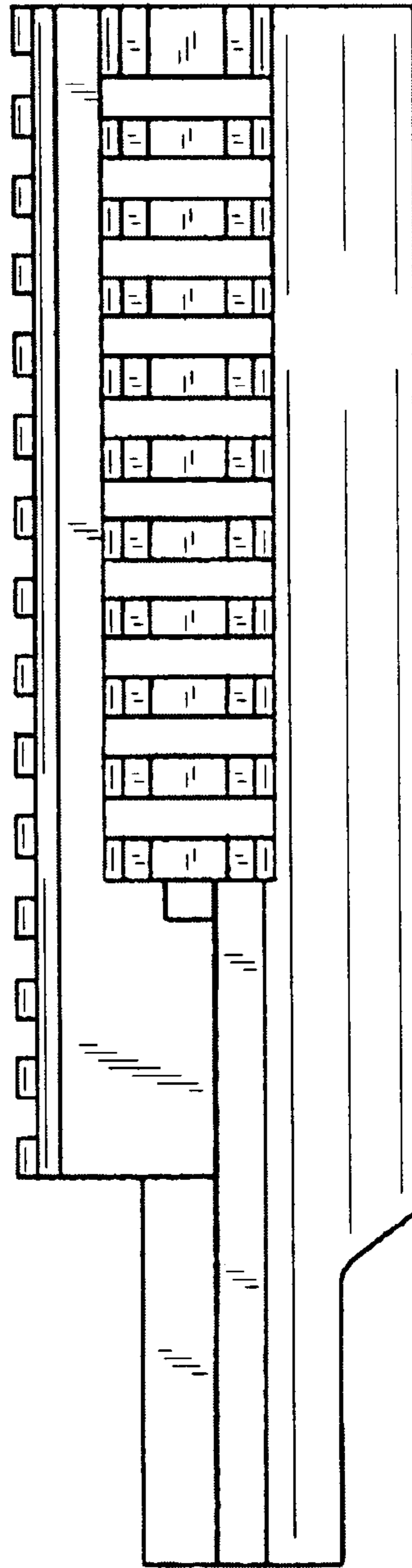

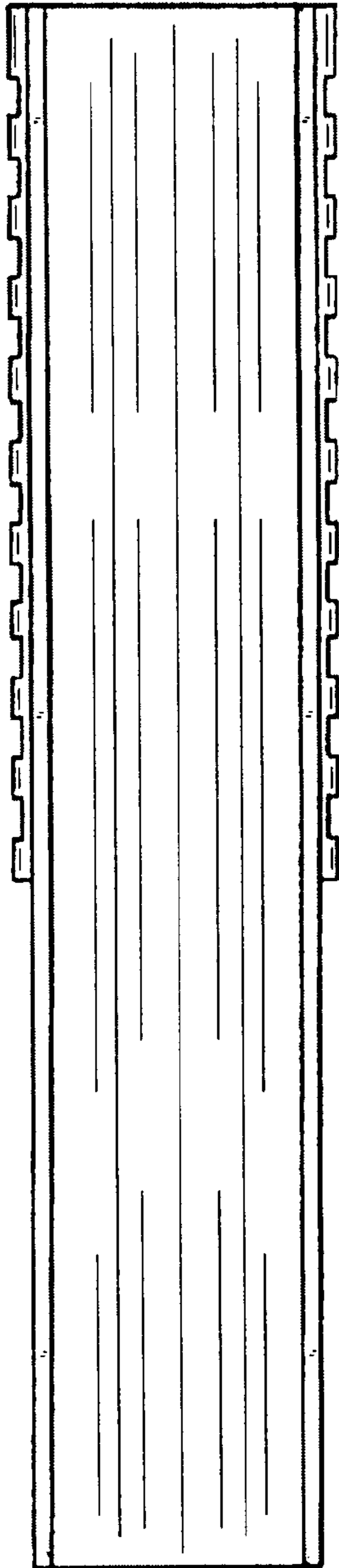

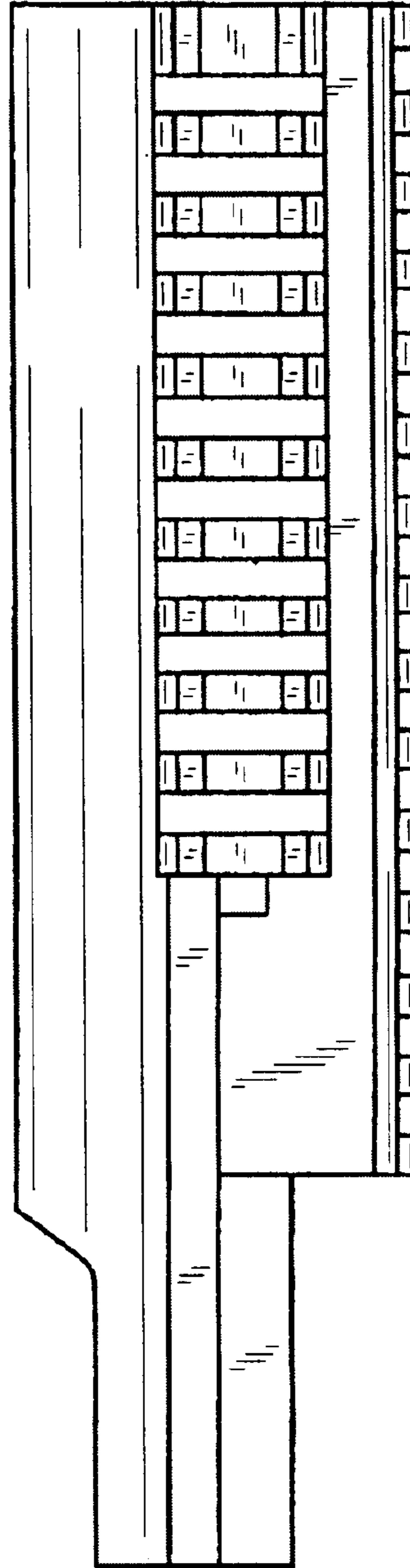
