(57) **CLAIM**

I claim the ornamental design for the hair trimmer stand with accessory tray, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of a hair trimmer stand of the present invention, shown with an accessory tray;

FIG. 2 is a front view of the hair trimmer stand with accessory tray of FIG. 1;

FIG. 3 is a right side view of the hair trimmer stand with accessory tray of FIG. 1;

FIG. 4 is a left side view of the hair trimmer stand with accessory tray of FIG. 1;

FIG. 5 is a rear view of the hair trimmer stand with accessory tray of FIG. 1;

FIG. 6 is a top view of the hair trimmer stand with accessory tray of FIG. 1;

FIG. 7 is a bottom view of the hair trimmer stand with accessory tray of FIG. 1;

FIG. 8 is a perspective view of an alternate embodiment of the hair trimmer stand with accessory tray of the present invention;

FIG. 9 is a front view of the hair trimmer stand with accessory tray of FIG. 8;

FIG. 10 is a right side view of the hair trimmer stand with accessory tray of FIG. 8;

FIG. 11 is a left side view of the hair trimmer stand with accessory tray of FIG. 8;

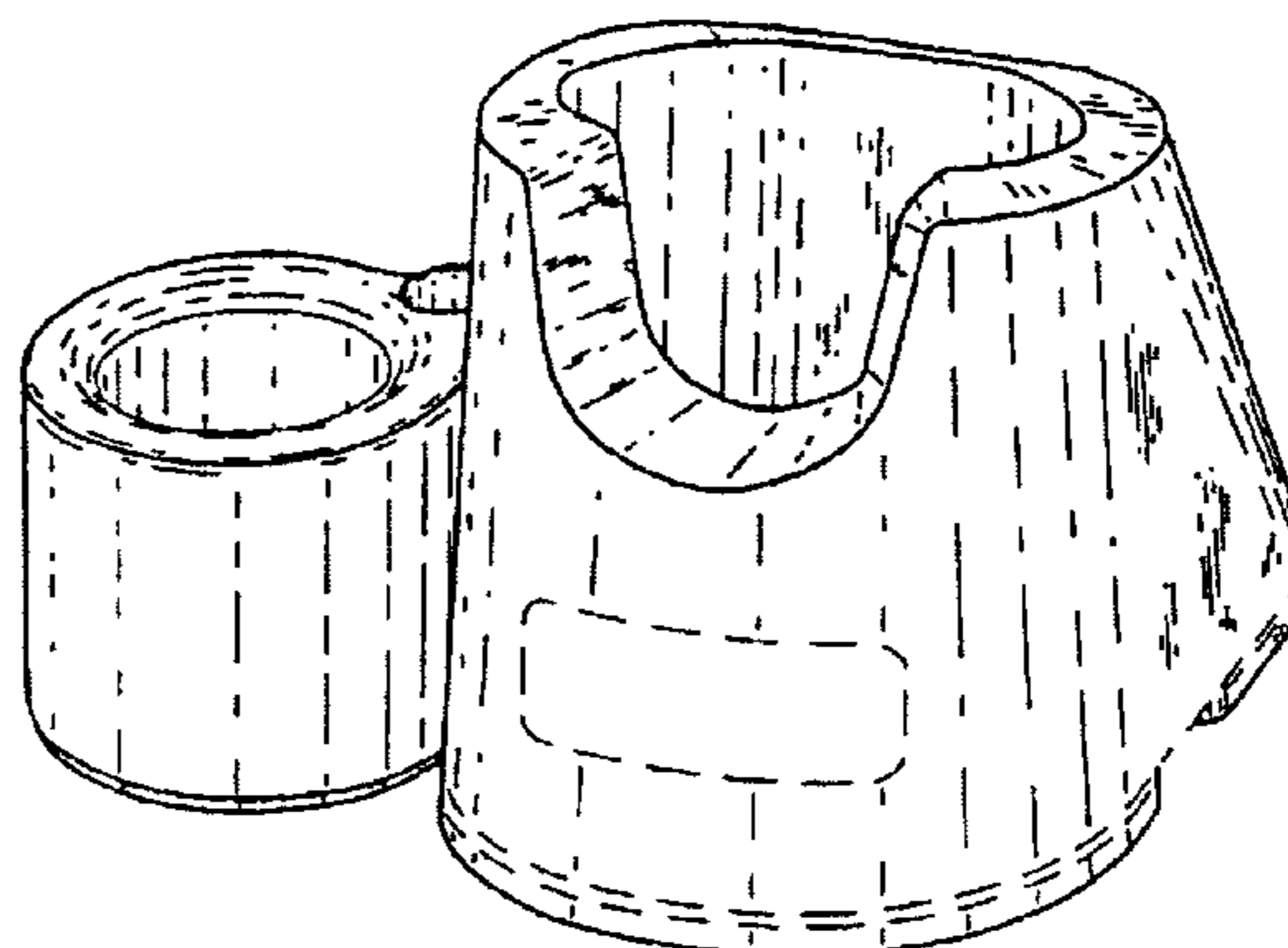
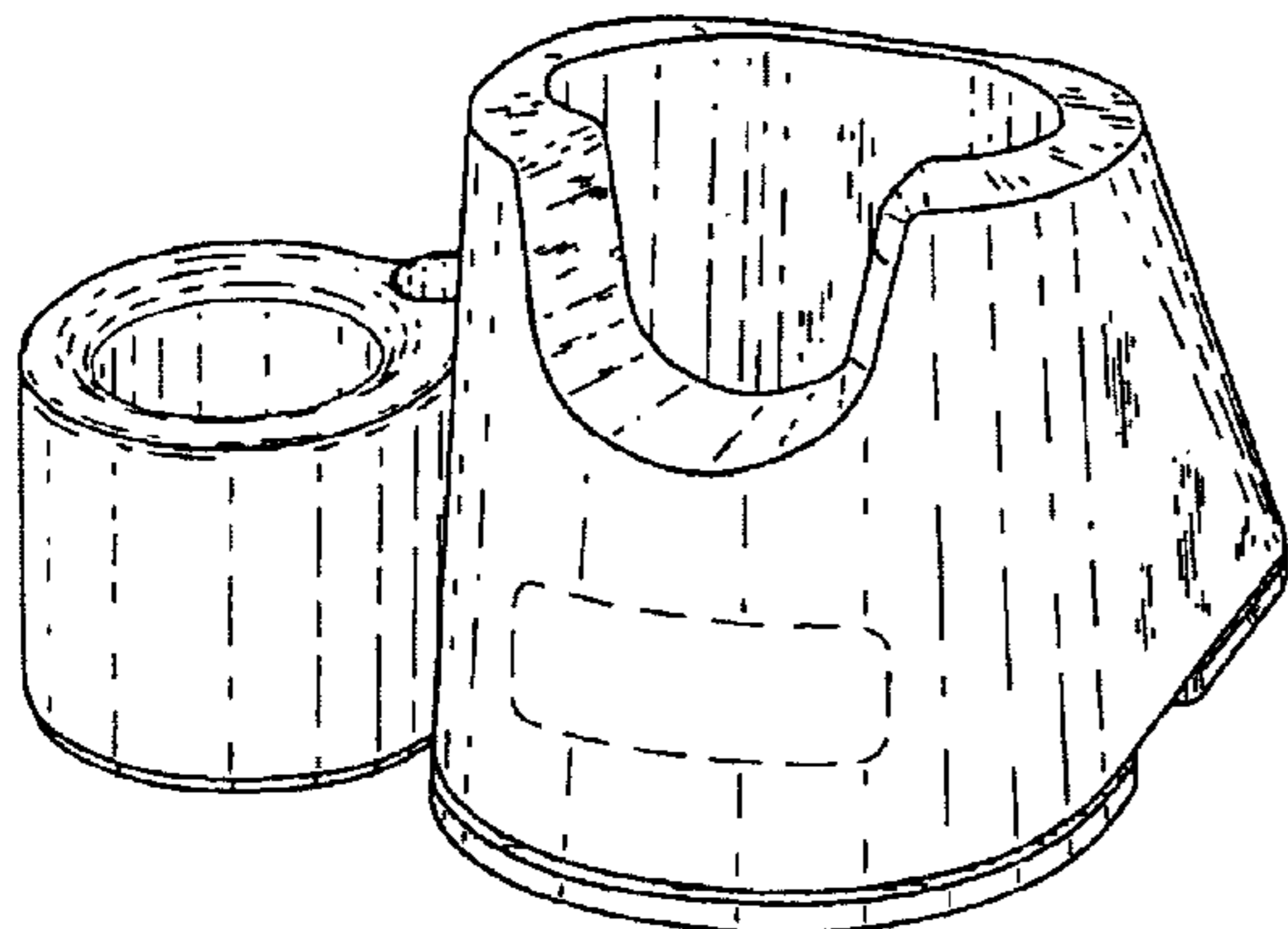
FIG. 12 is a rear view of the hair trimmer stand with accessory tray of FIG. 8;

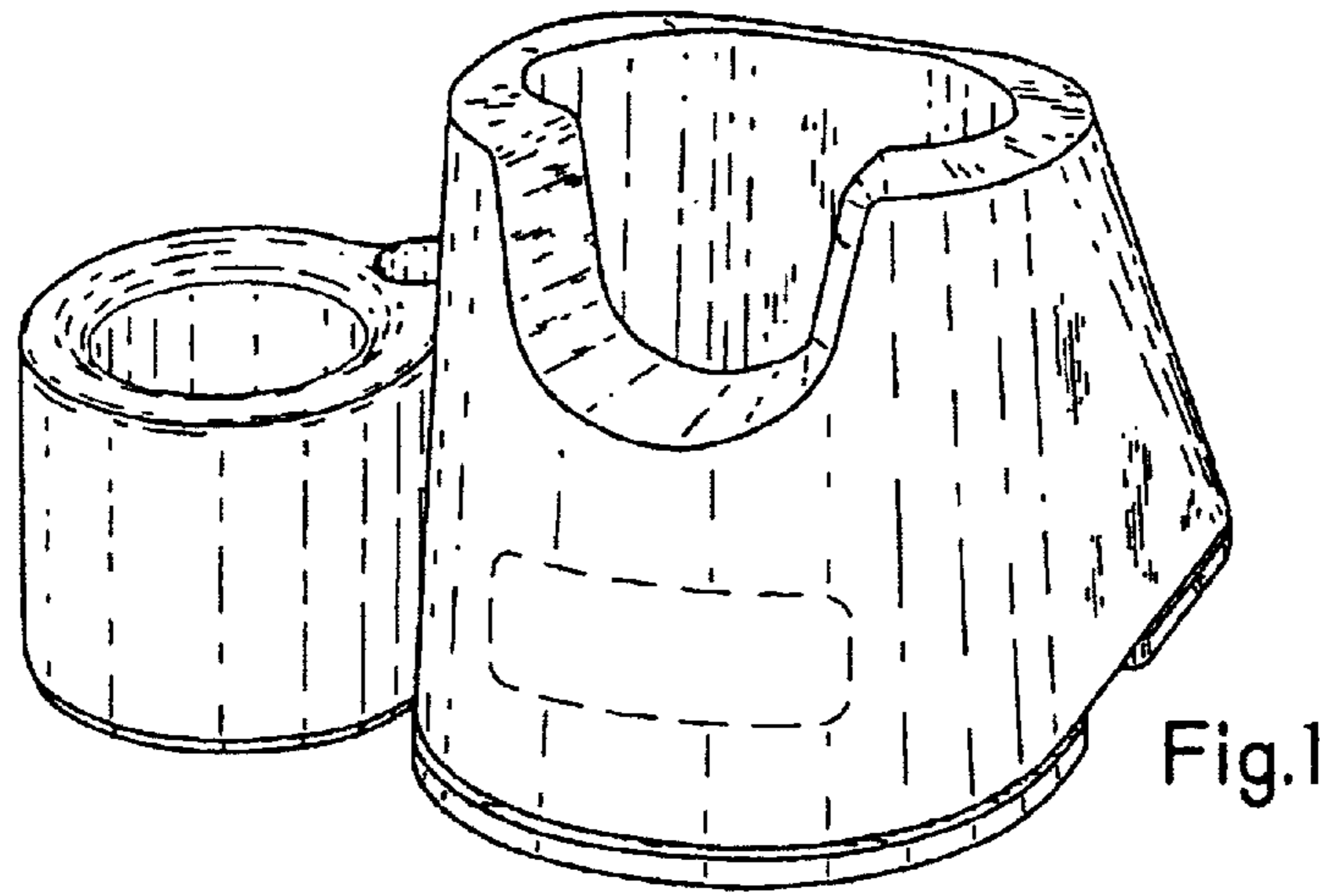

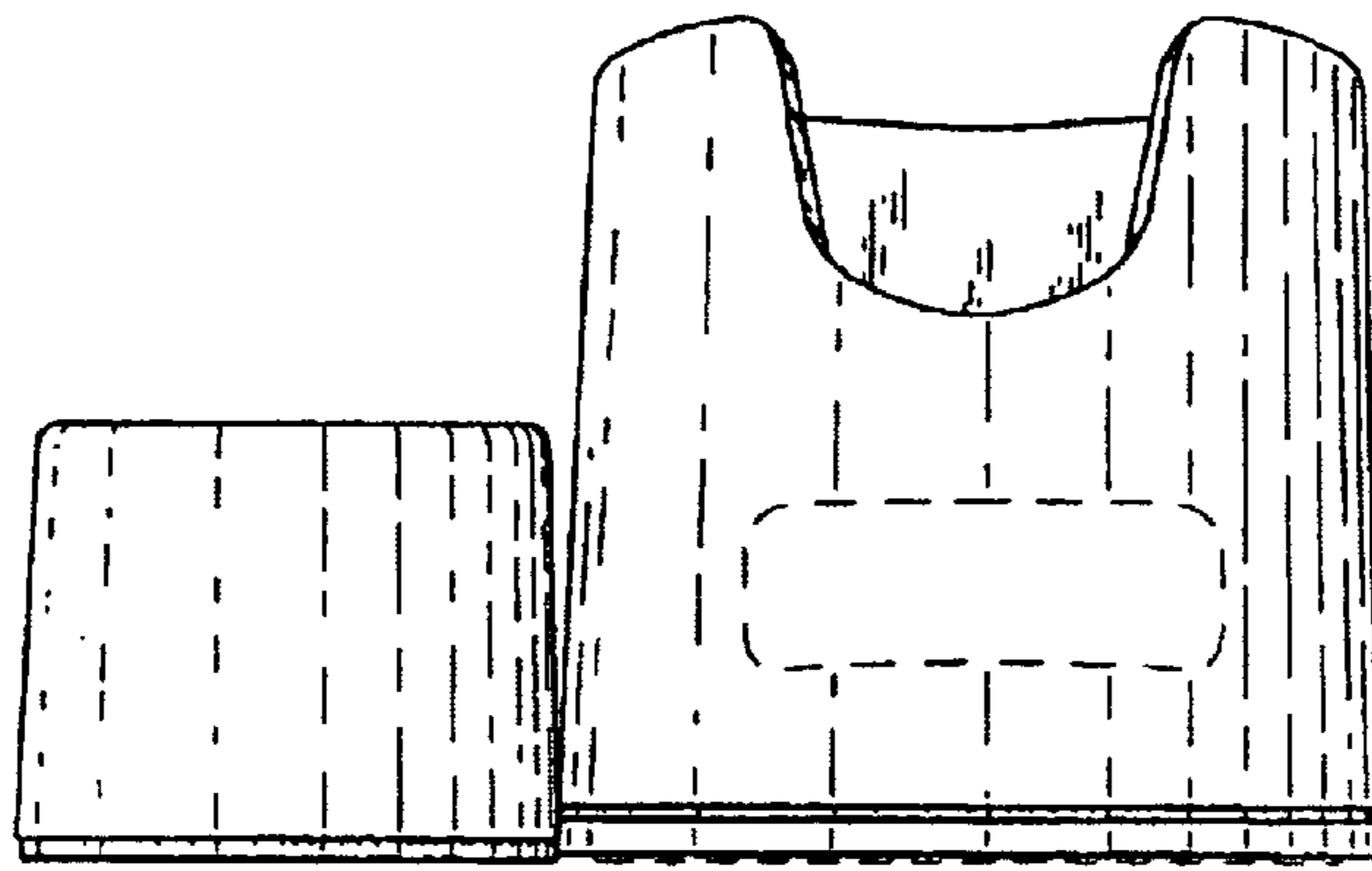

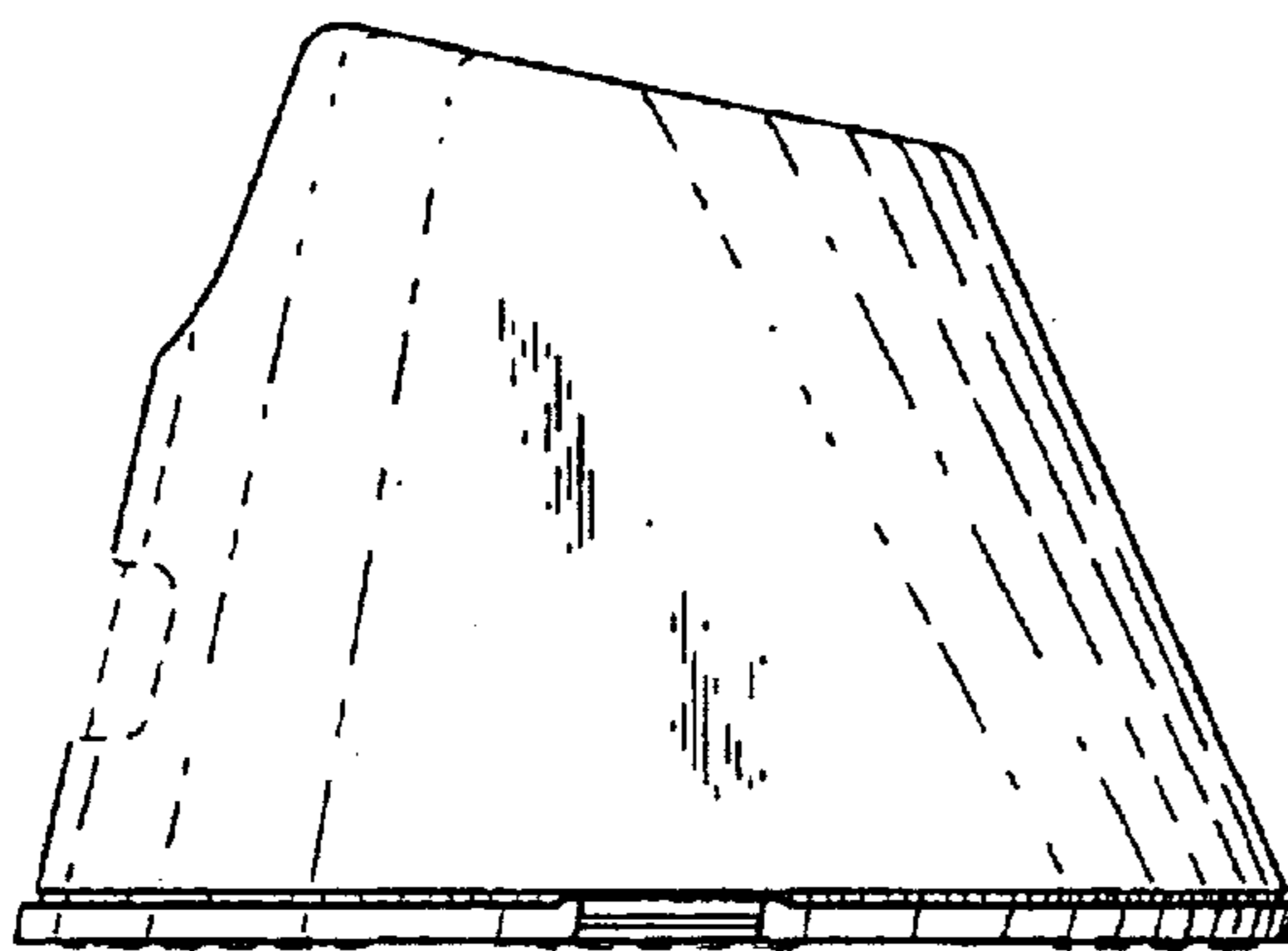

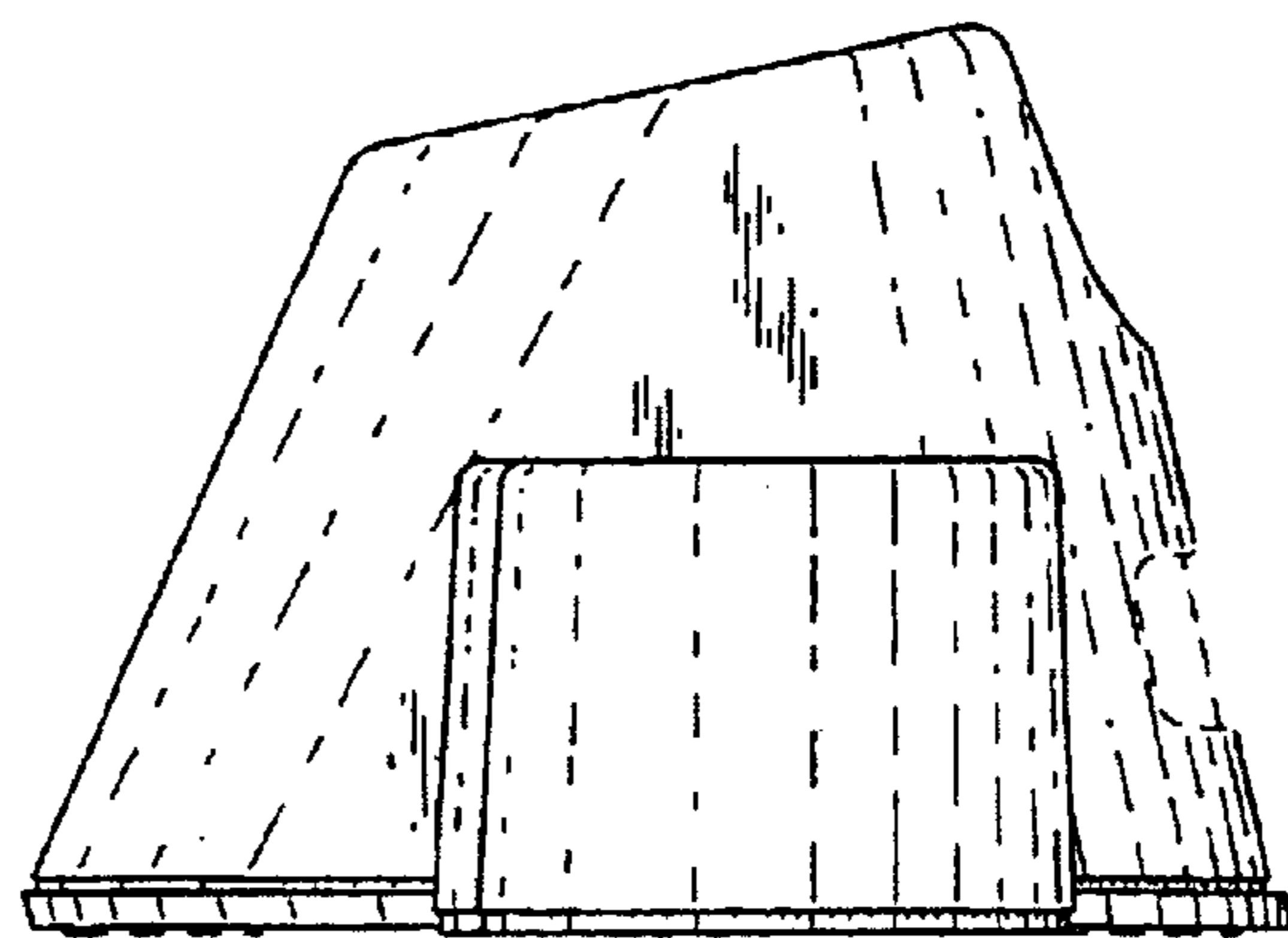

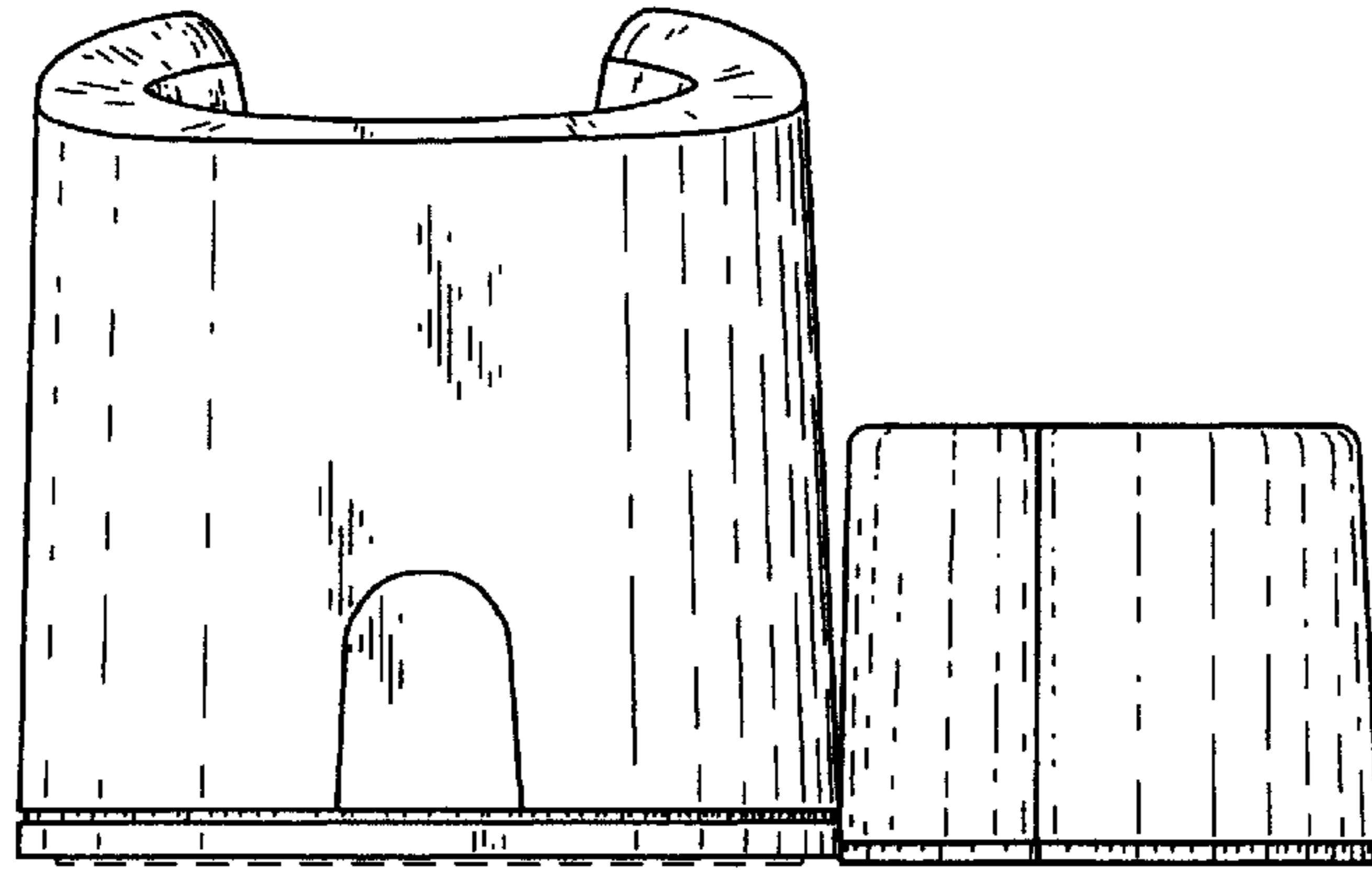

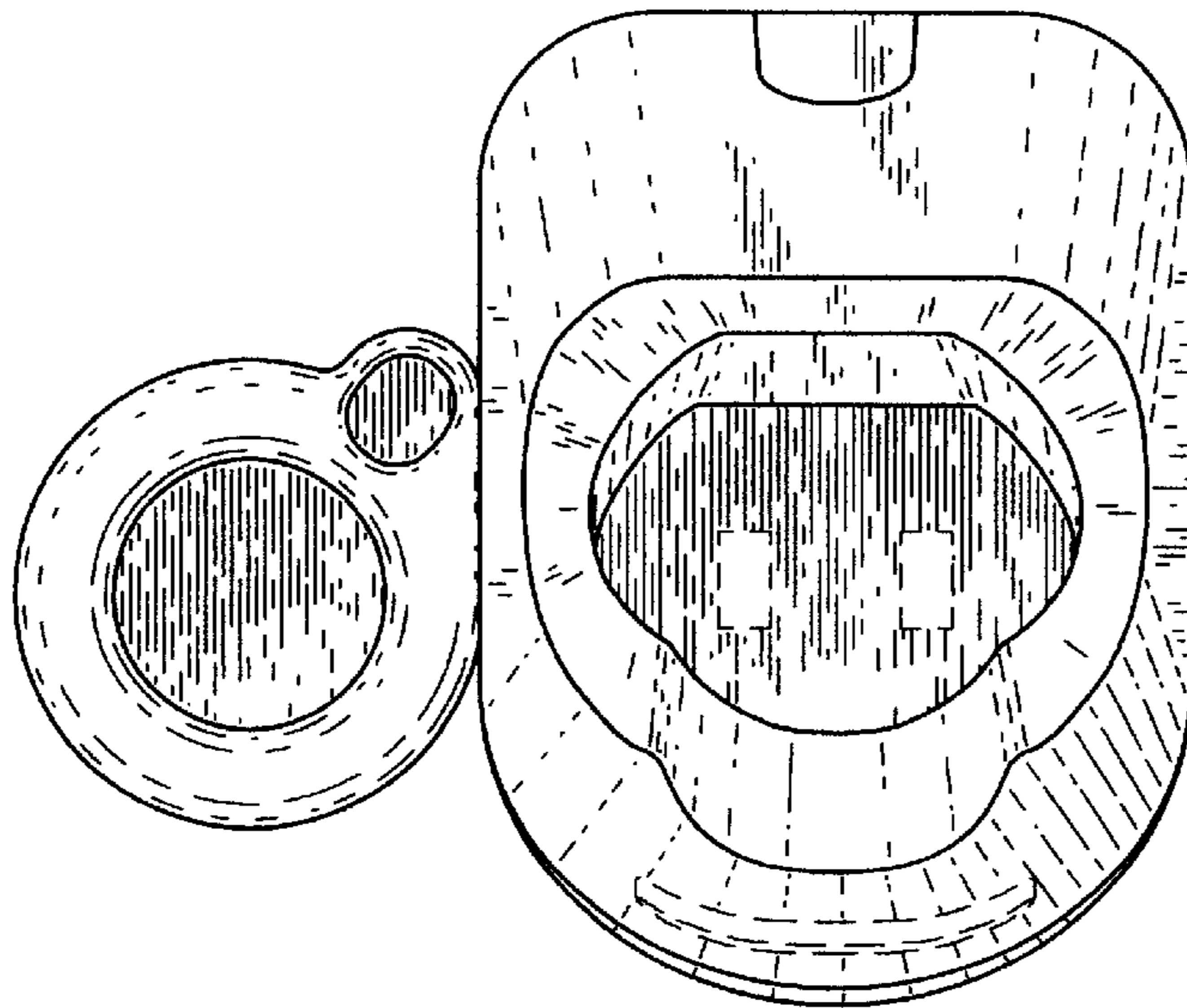

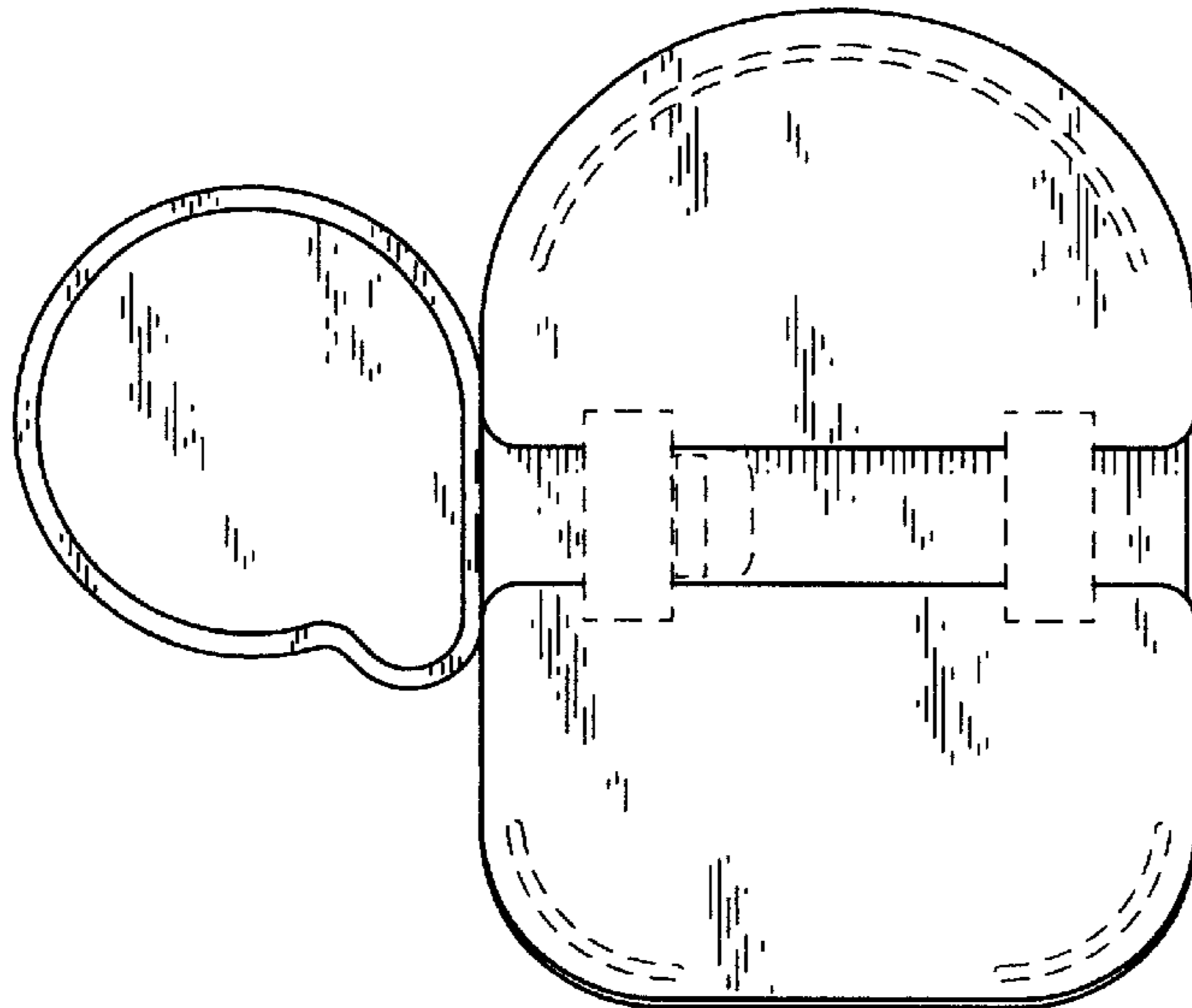
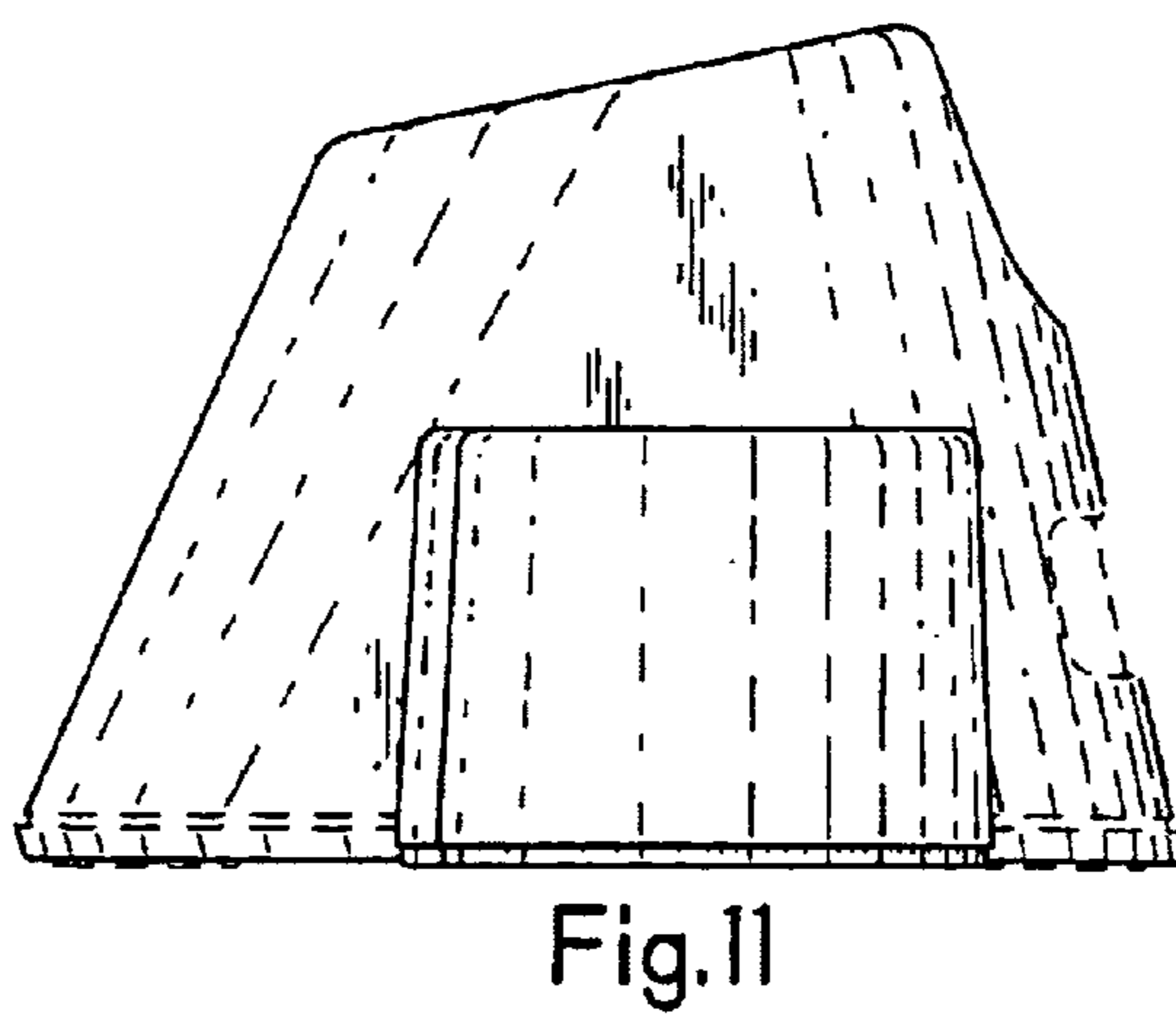
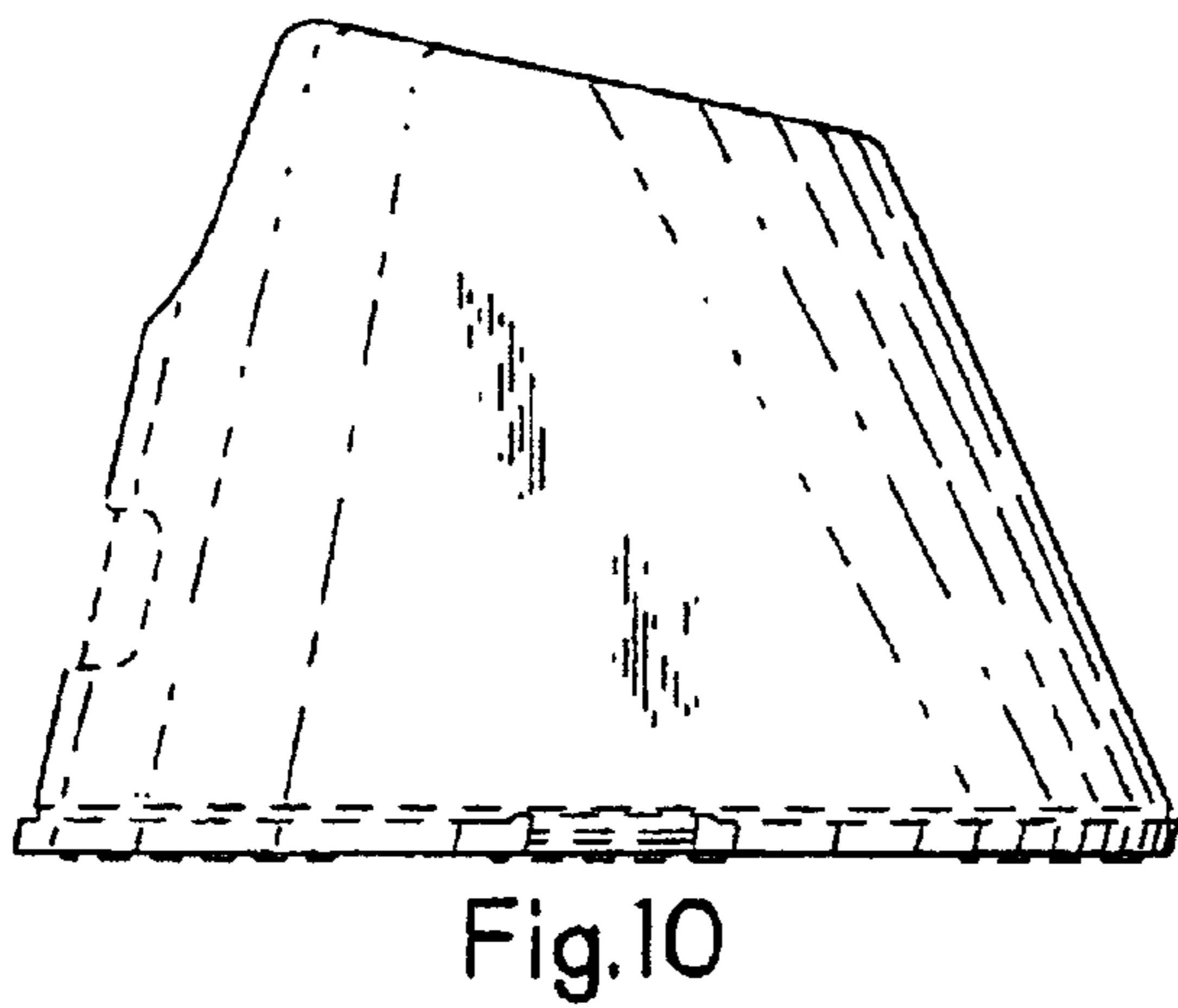
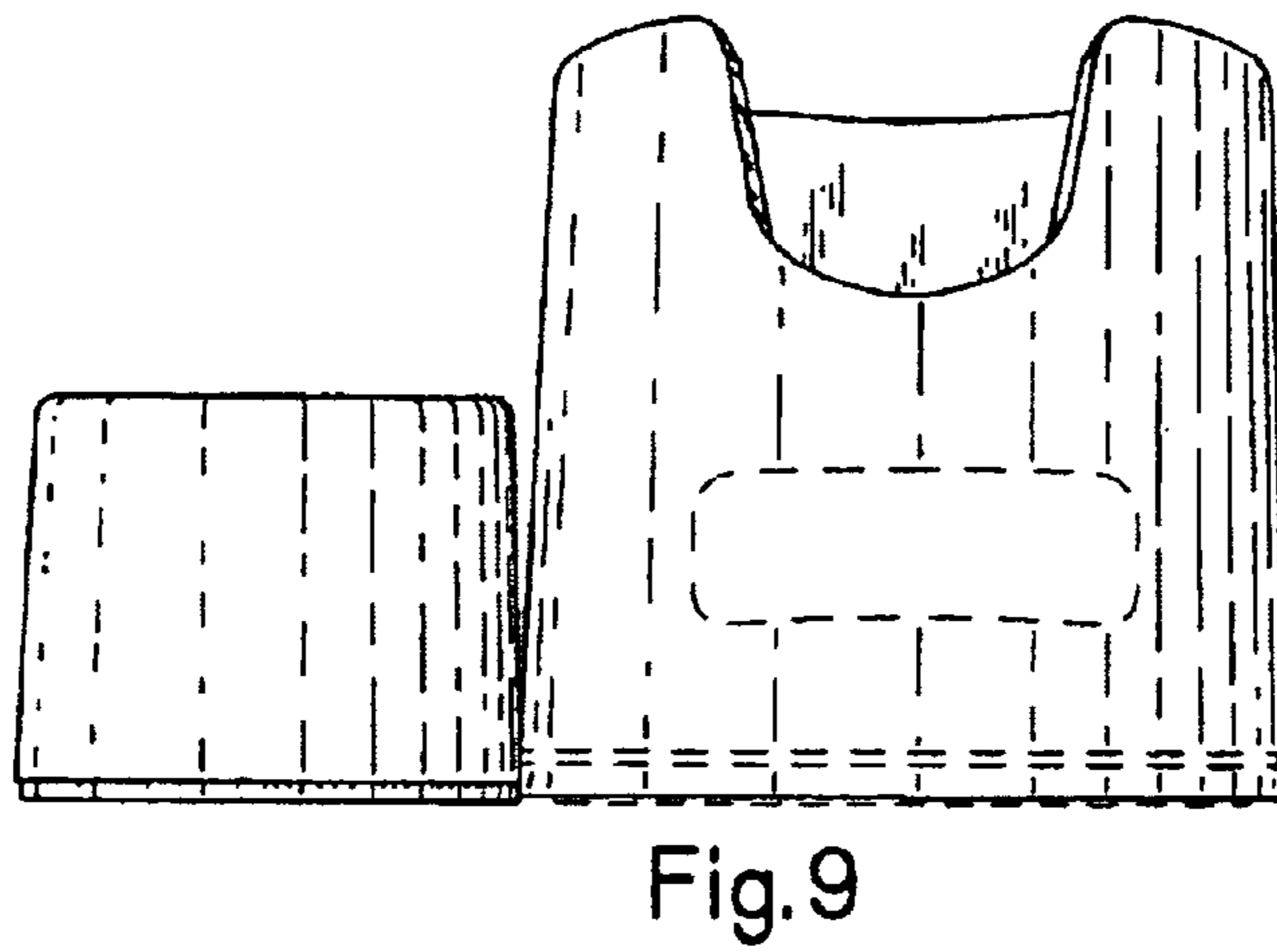
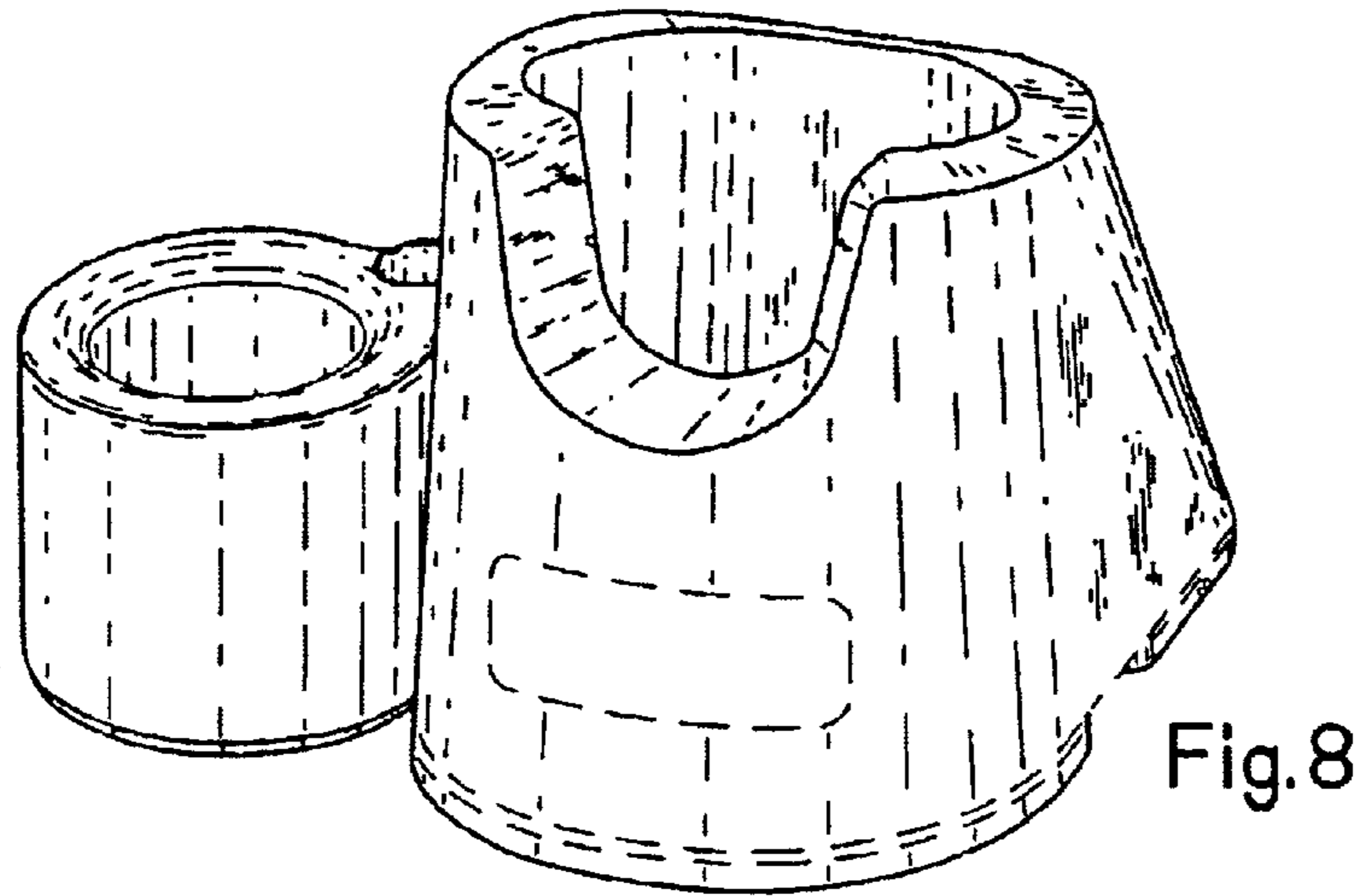

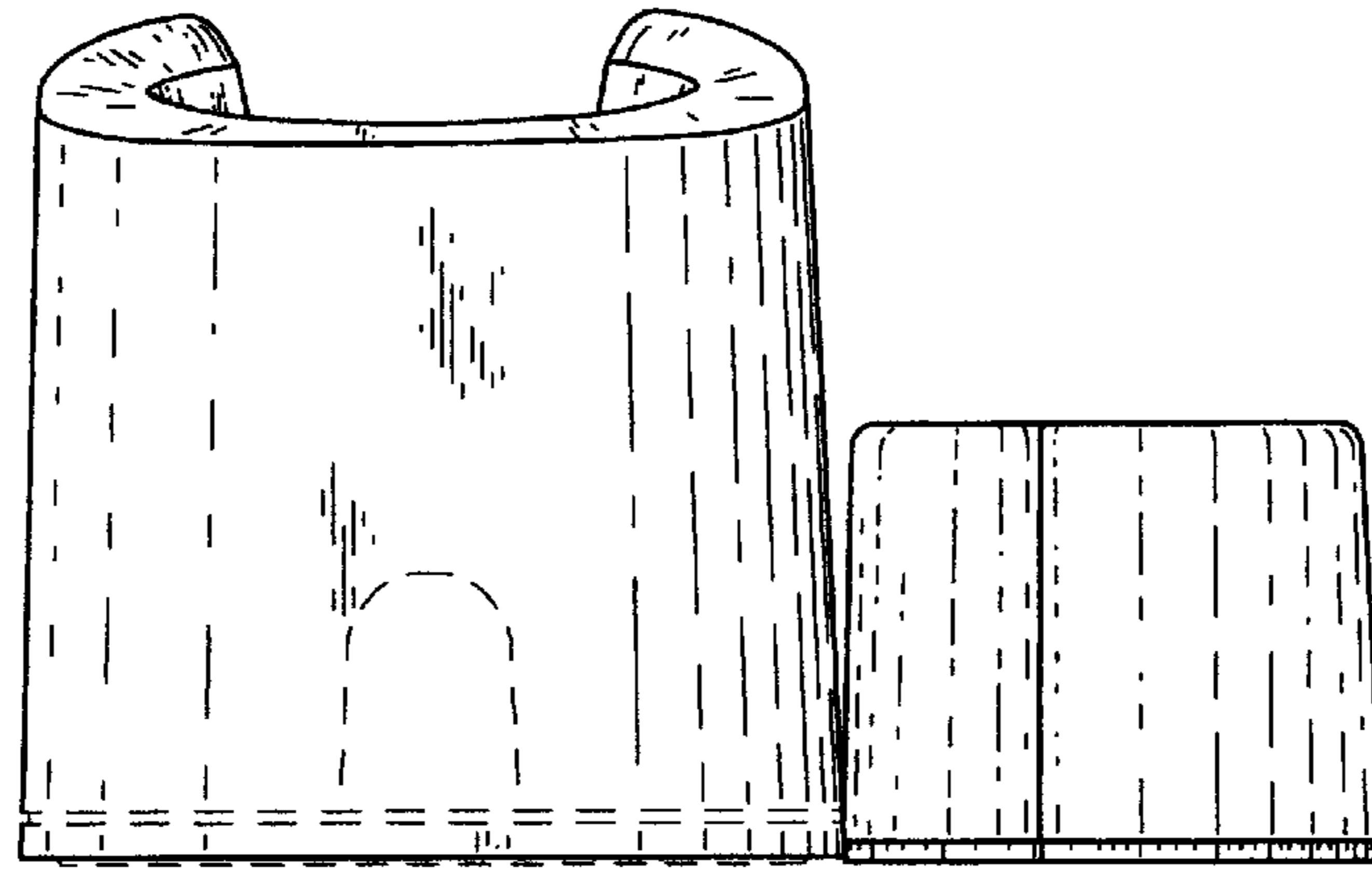

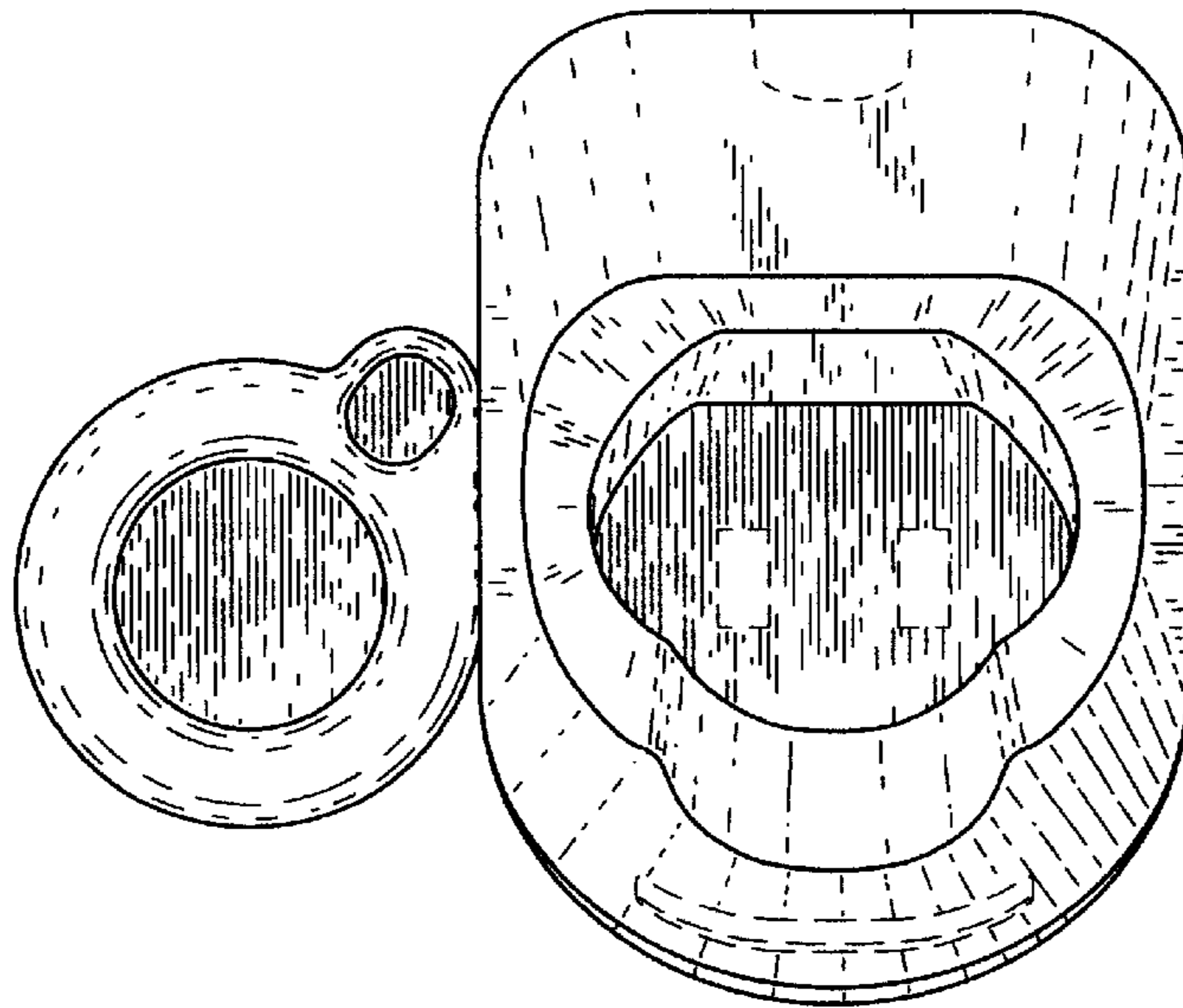

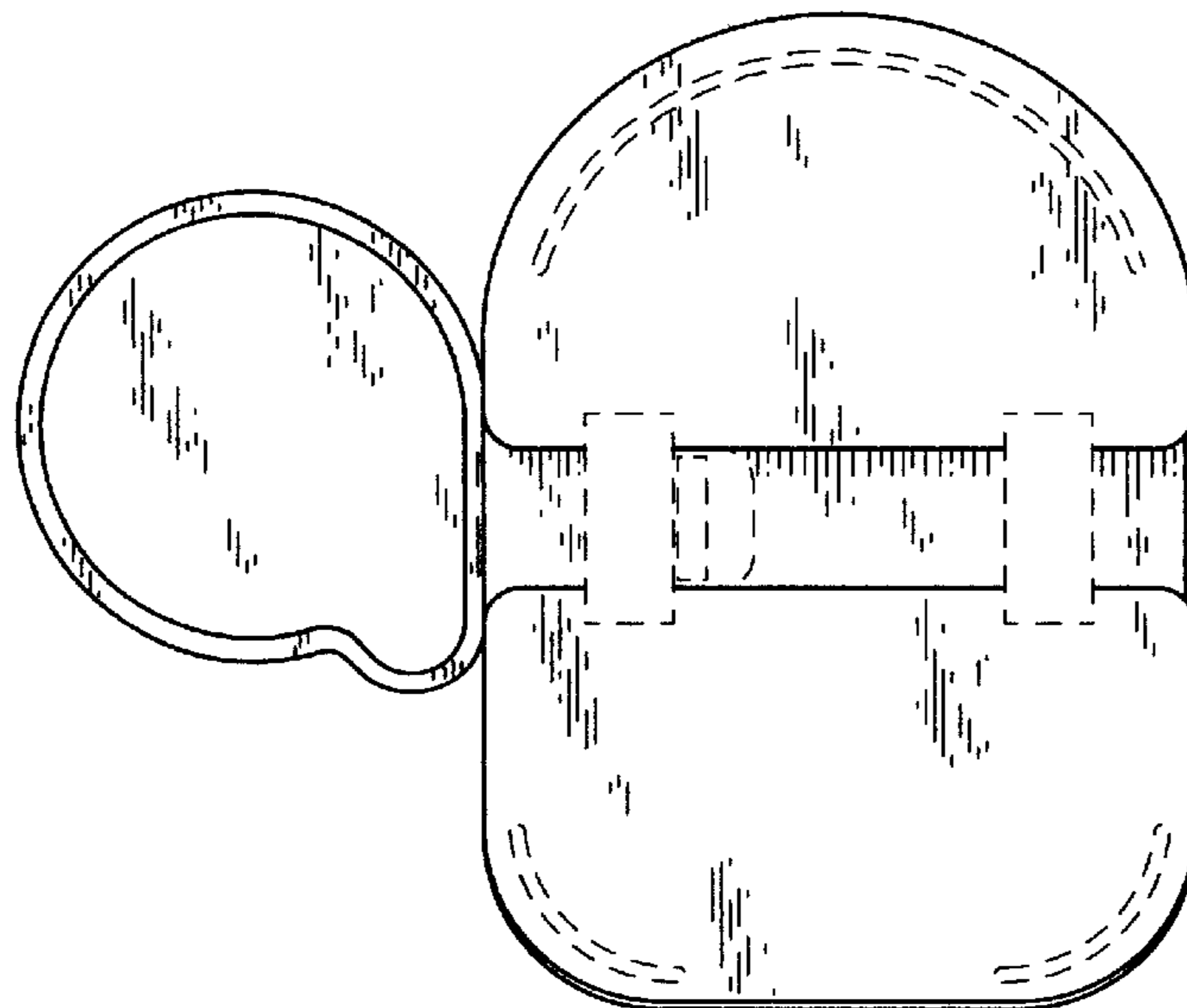
