## **DESCRIPTION**

FIG. 1 is a perspective view showing our new handle for pet combs;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a second embodiment showing a perspective view of our new handle for pet combs;

FIG. 9 is a third embodiment showing a perspective view of our new handle for pet combs;

FIG. 10 is a fourth embodiment showing a perspective view of our new handle for pet combs;


FIG. 11 is a fifth embodiment showing a perspective view of our new handle for pet combs; and,
























