(57) **CLAIM**

The ornamental design for an ink pack, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom and left side perspective view of an ink pack showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof; and, FIG. 7 is a right side view thereof.

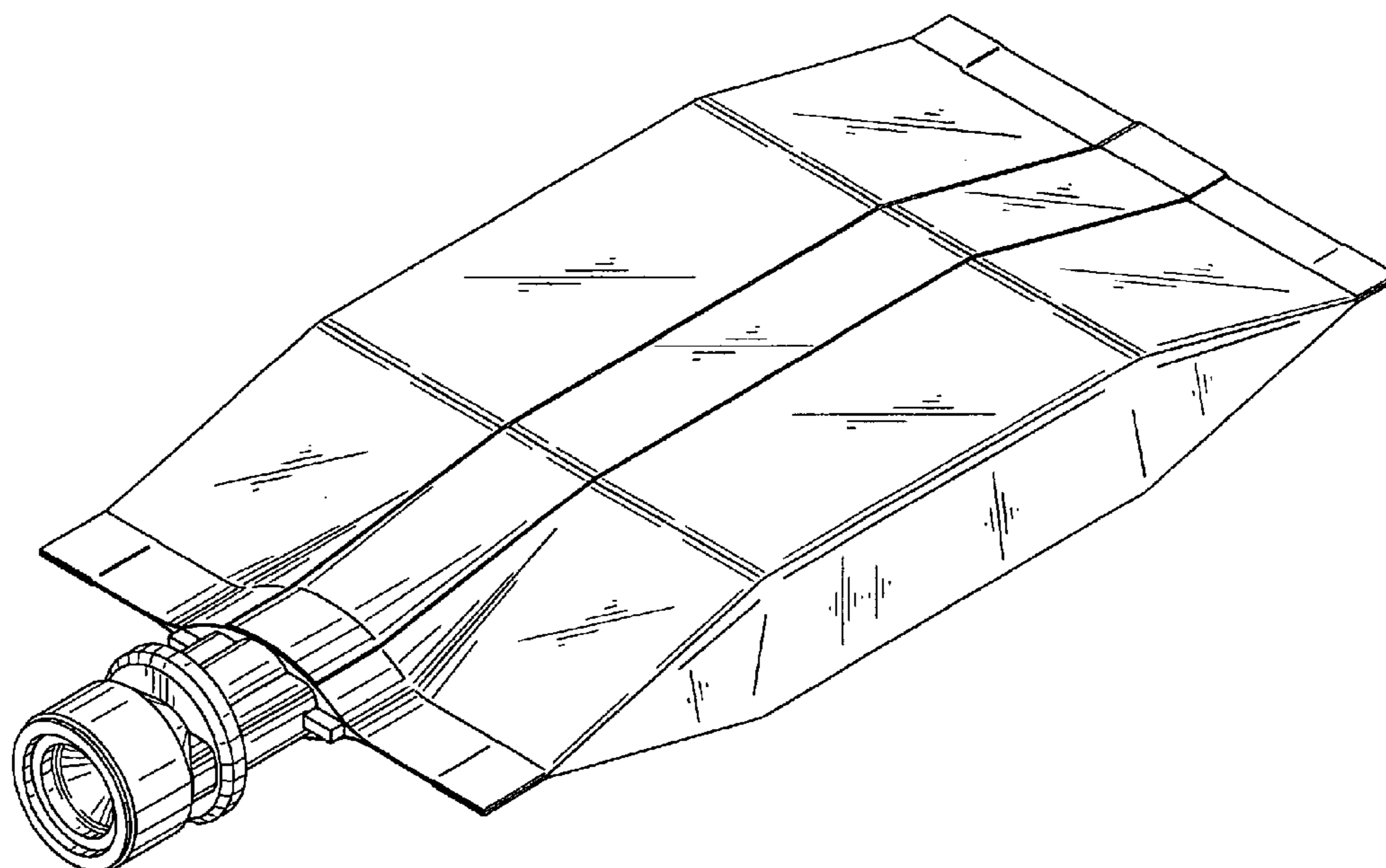

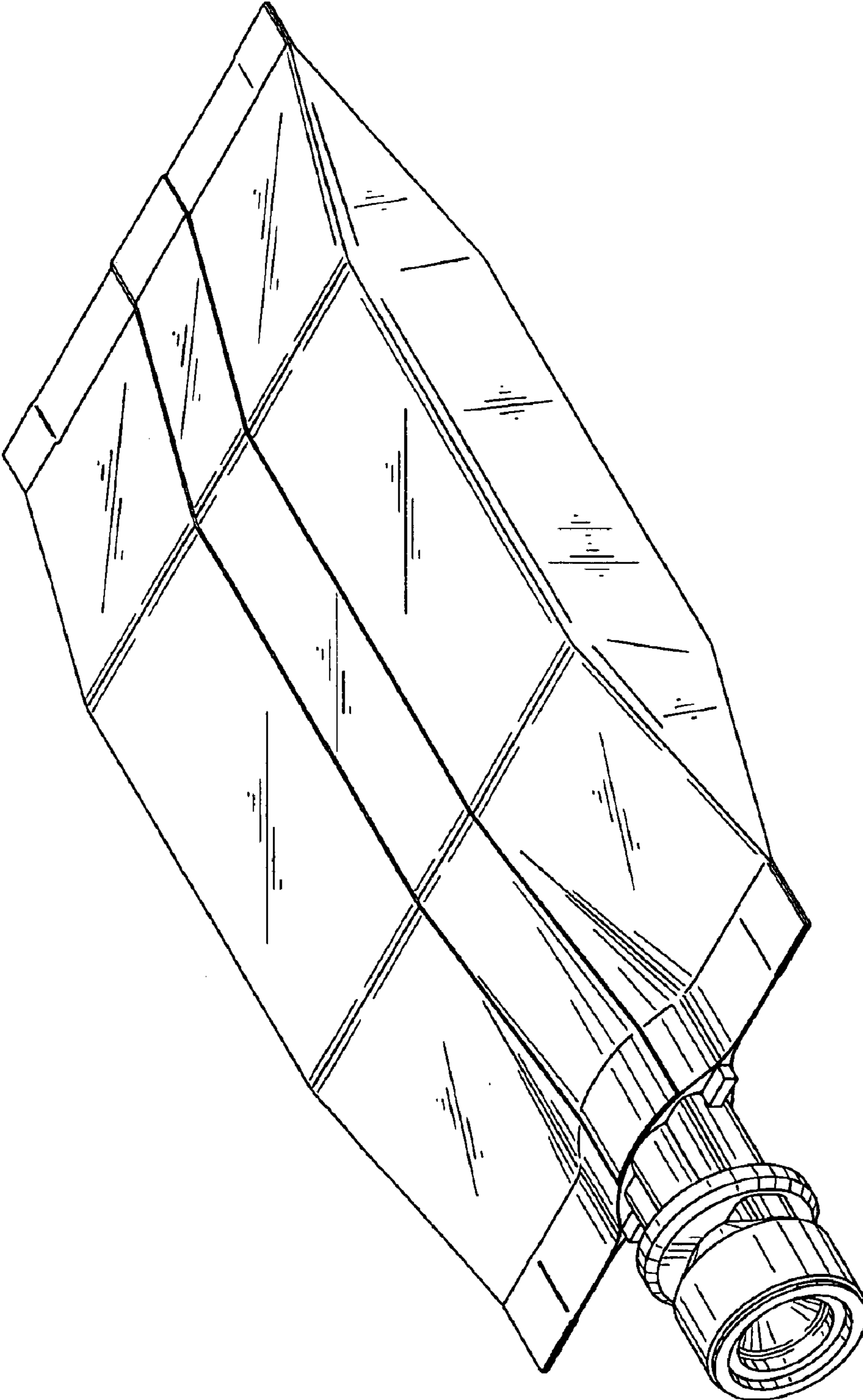

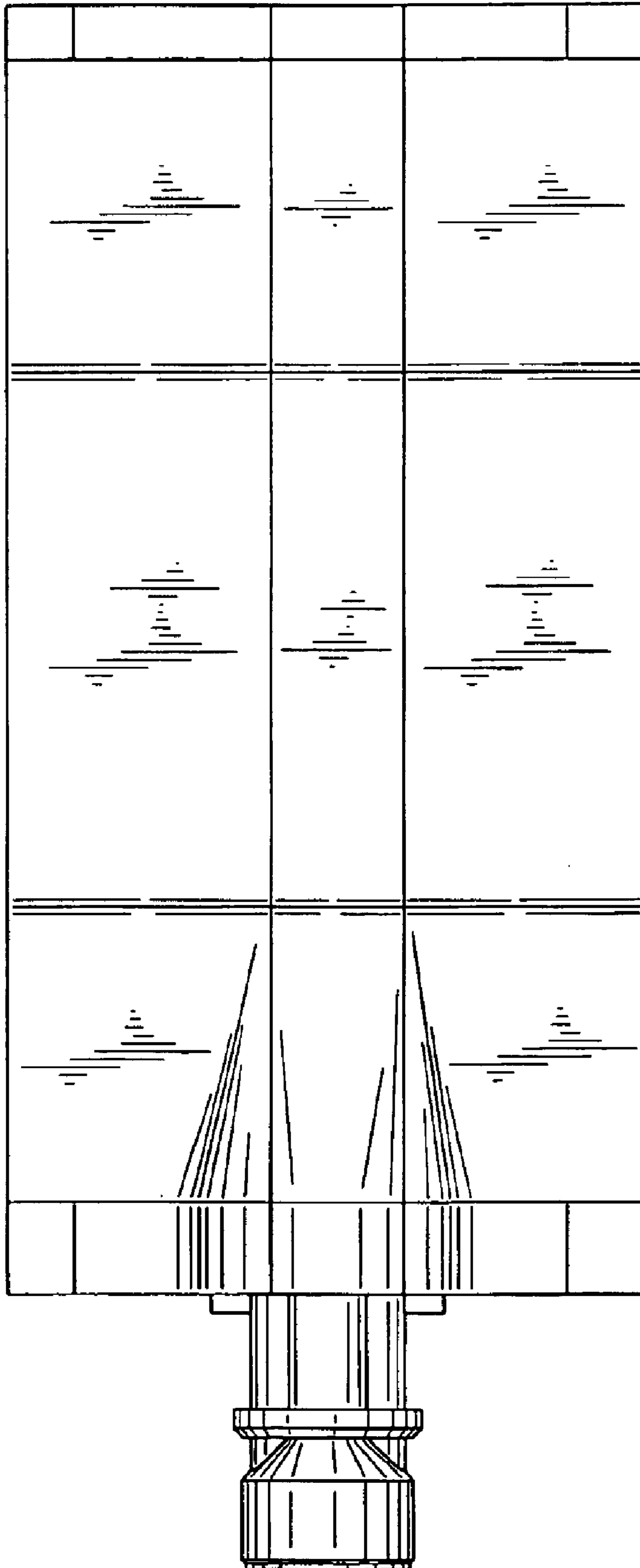

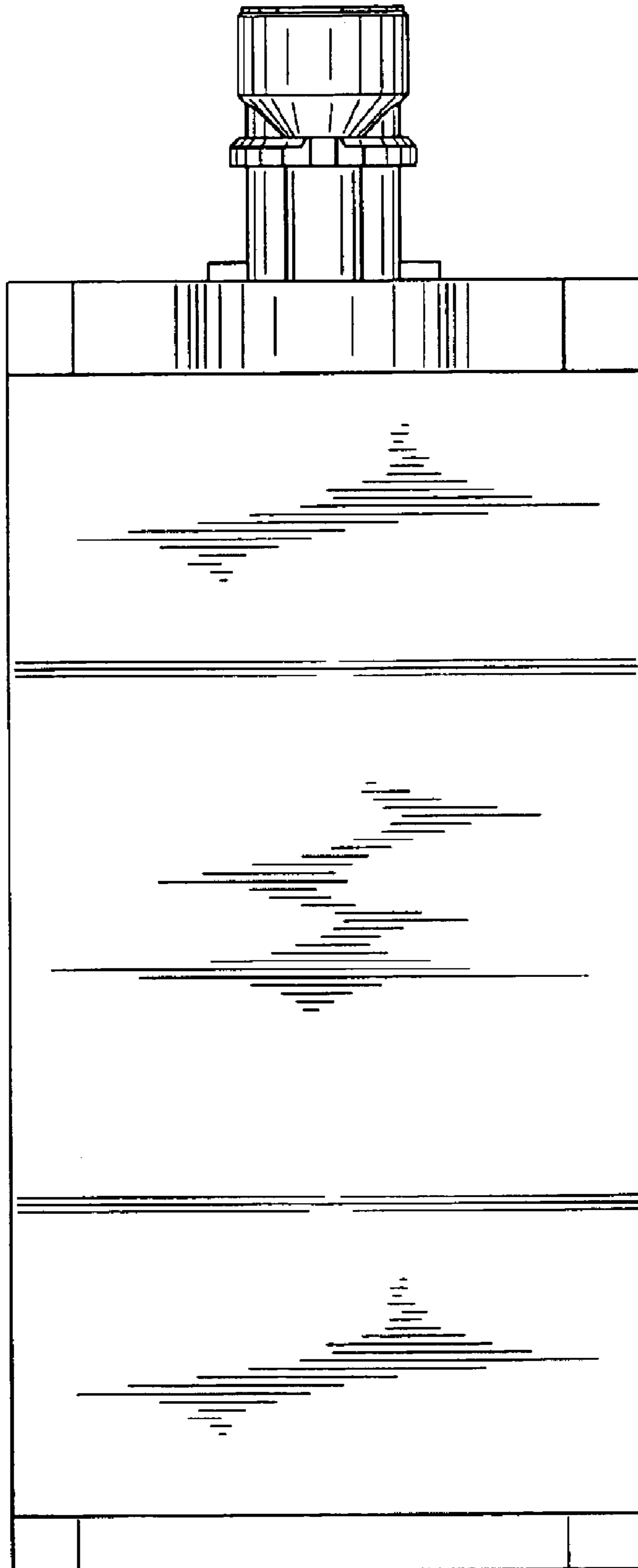

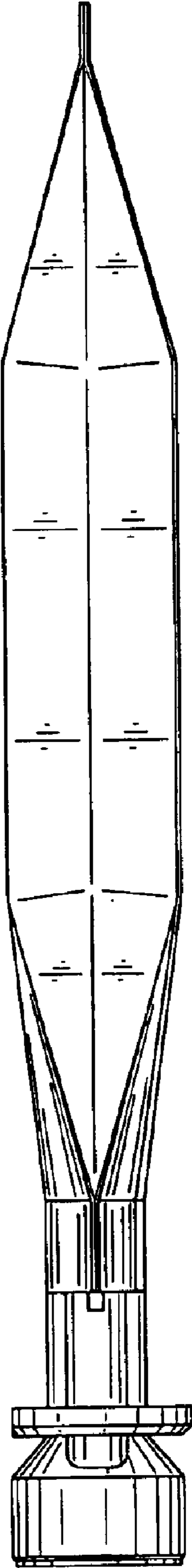
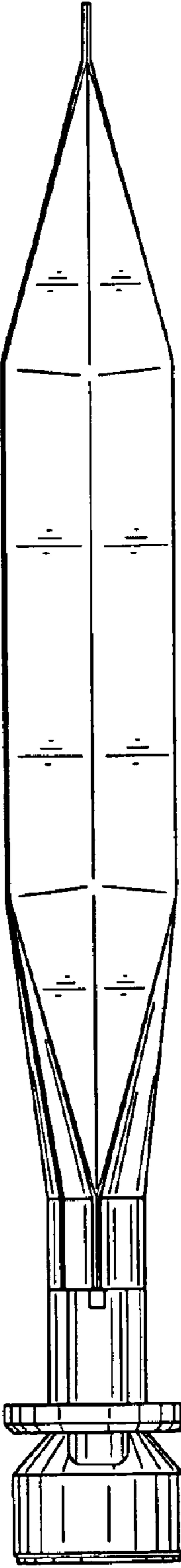
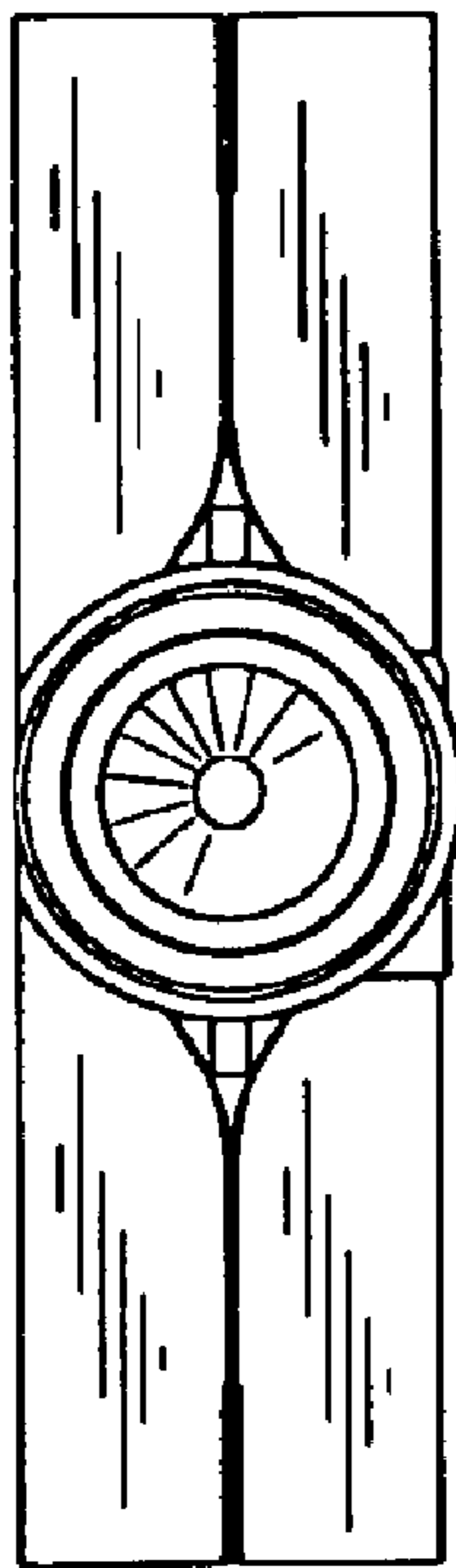
