We claim the ornamental design for a universal mounting system, as shown and described.

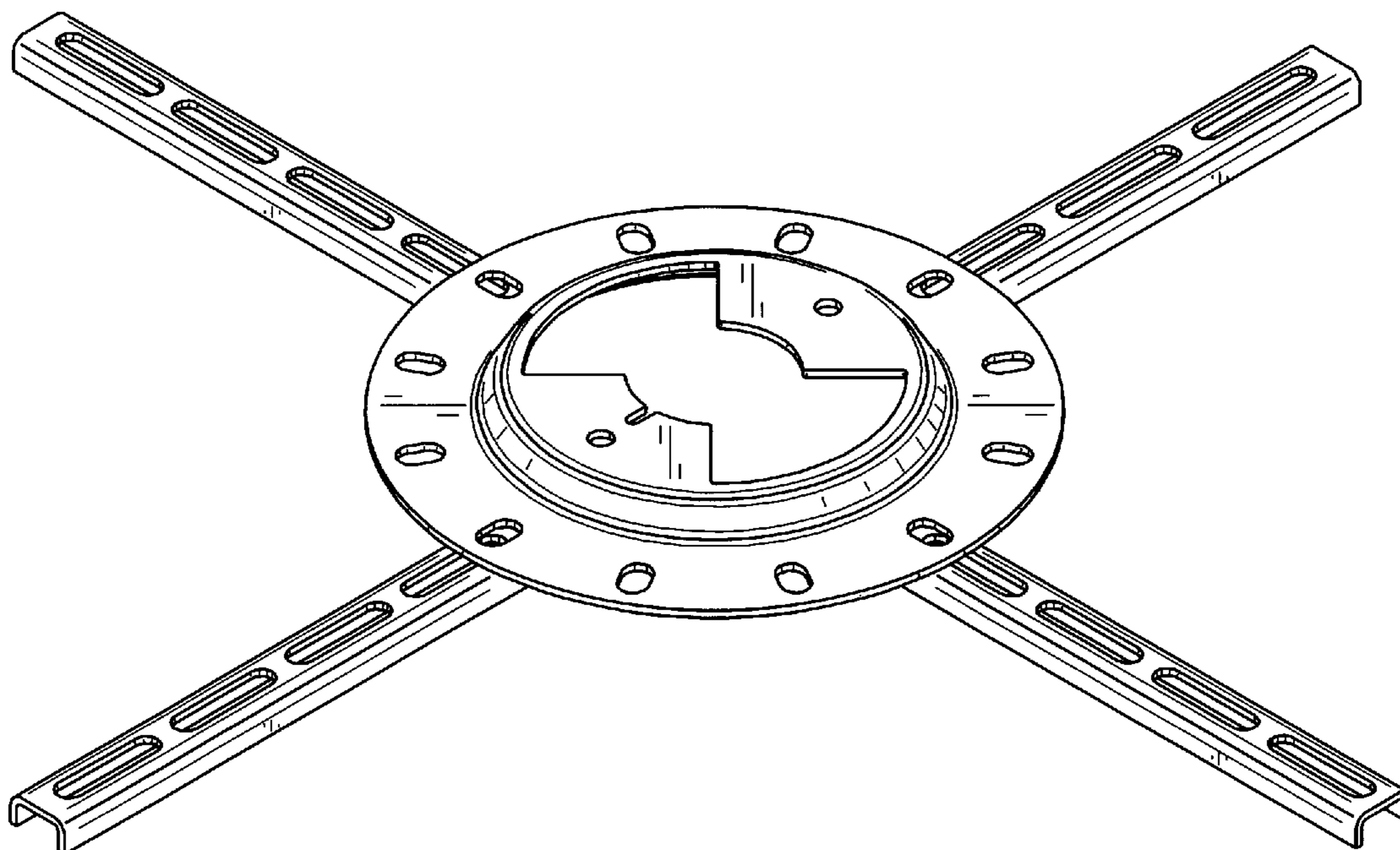
DESCRIPTION

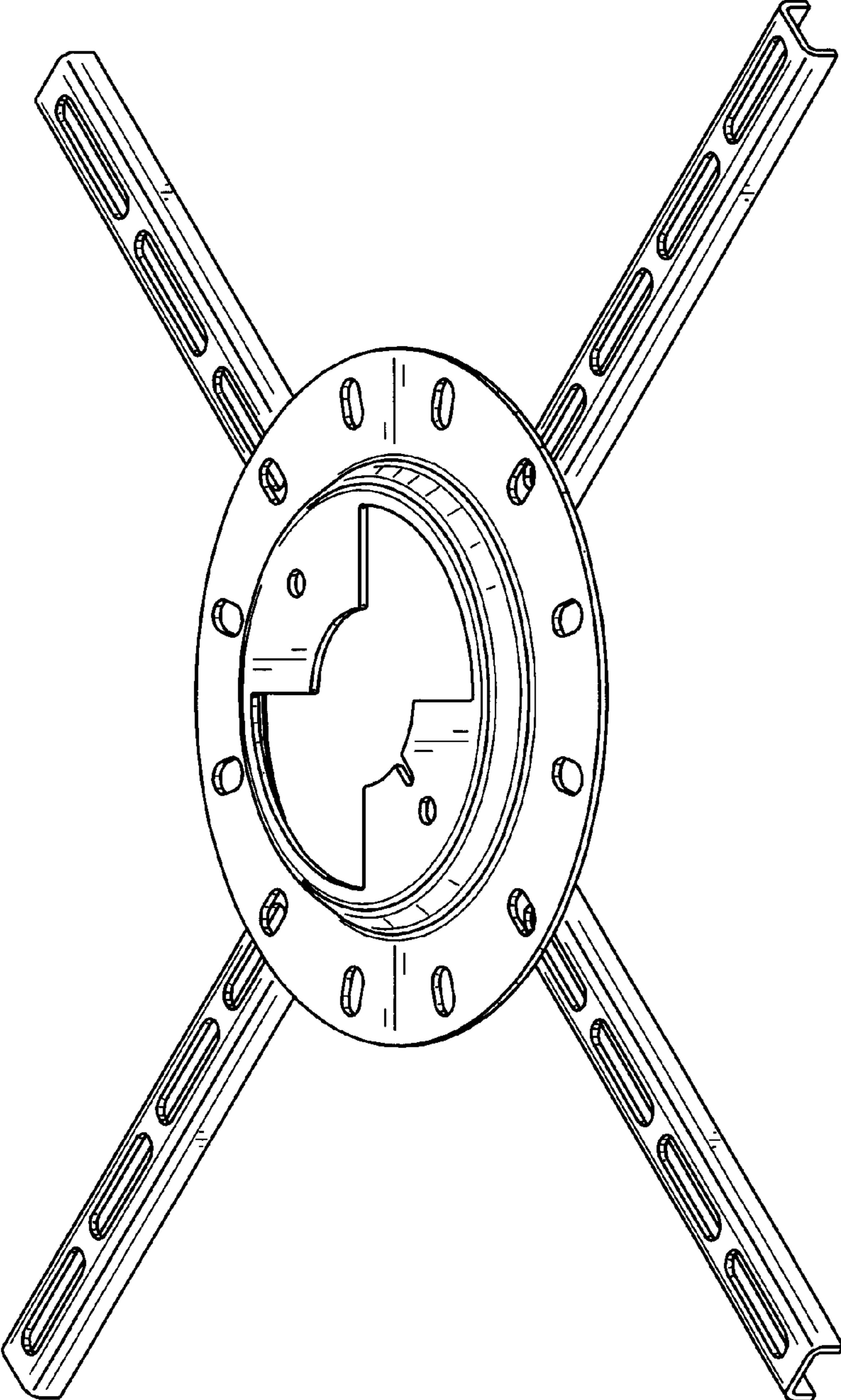

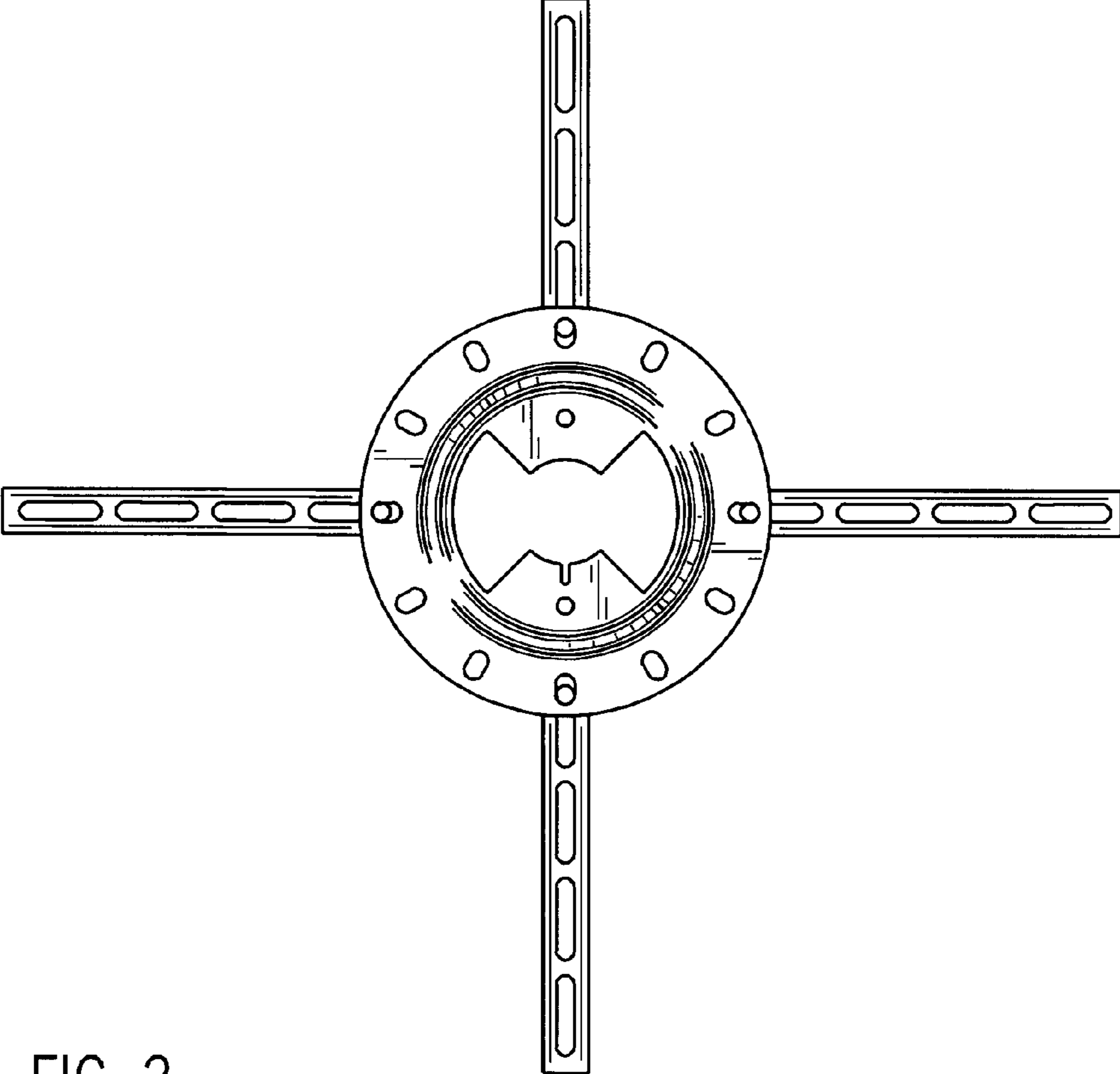
