(57) **CLAIM**

The ornamental design for an elastic member of an elastic coupler, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an elastic member showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a back view thereof;

FIG. 4 is a right side view thereof, a left side view, top view and bottom view being identical to the right side view;

FIG. 5 is a cross-sectional view thereof taken along the lines A-A' in FIG. 2;

FIG. 6 is a cross-sectional view thereof taken along the lines B-B' in FIG. 2;

FIG. 7 is a cross-sectional view thereof taken along the lines C-C' in FIG. 2; and,

FIG. 8 is a cross-sectional view thereof taken along the lines D-D' in FIG. 4.

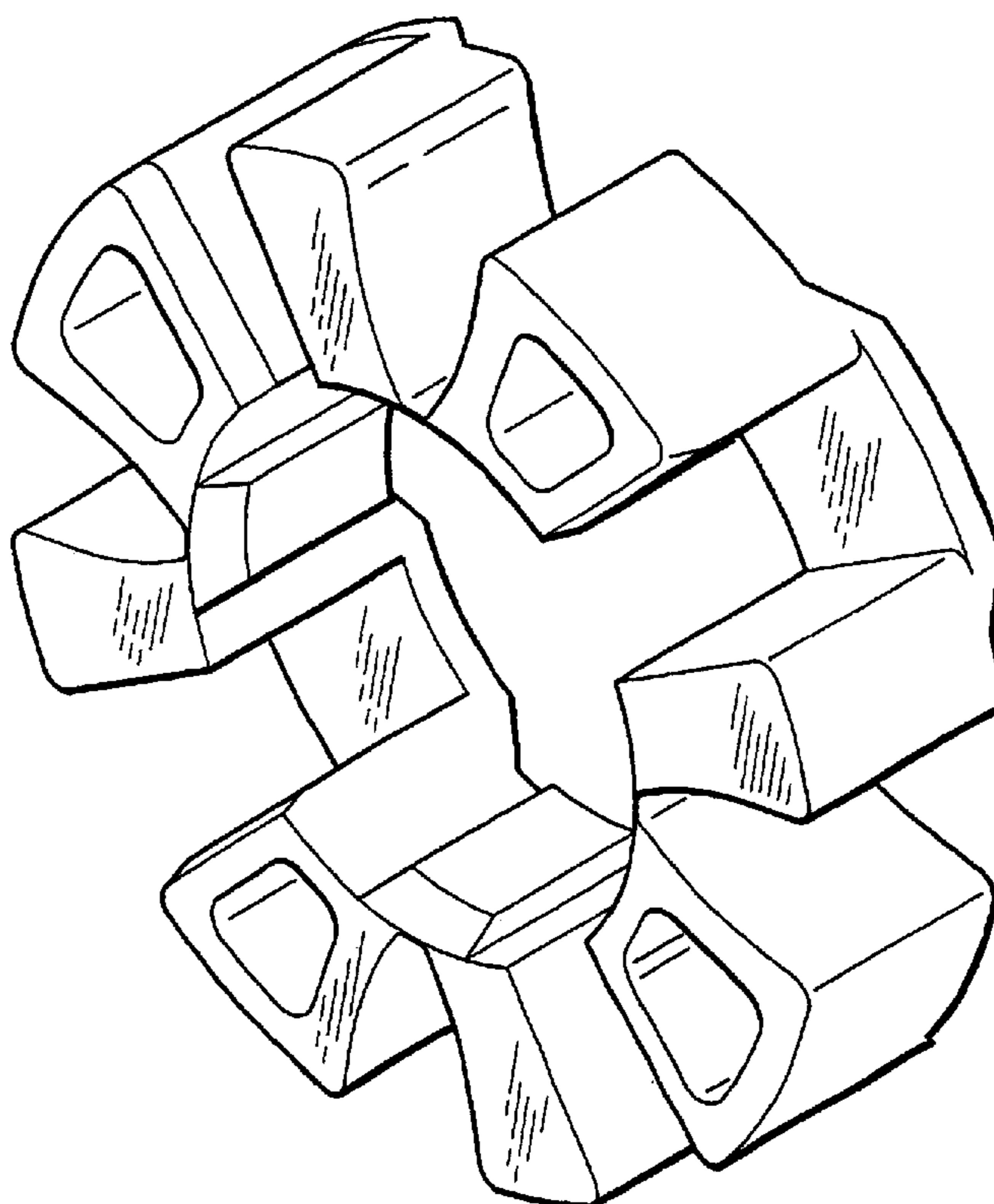

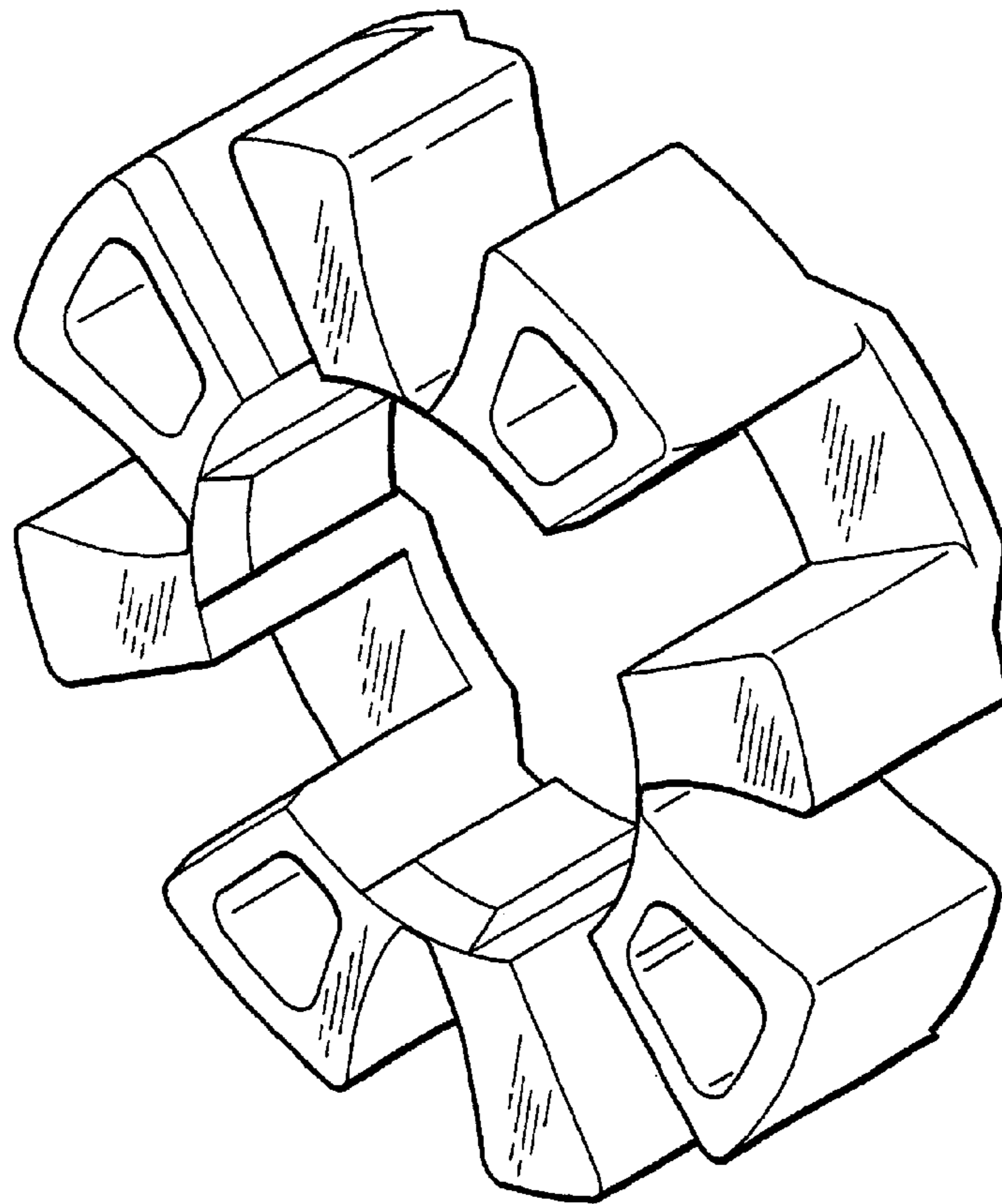

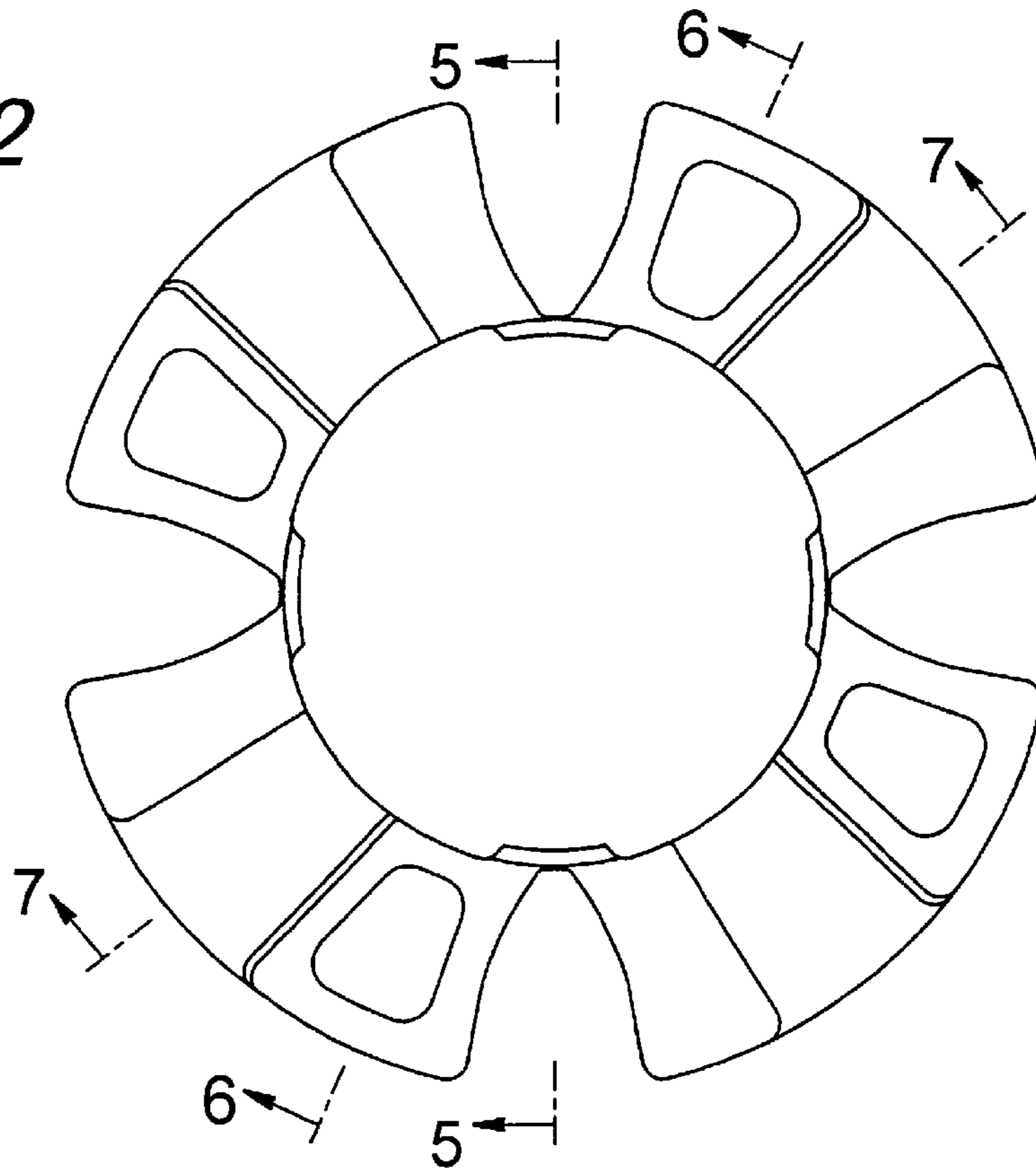

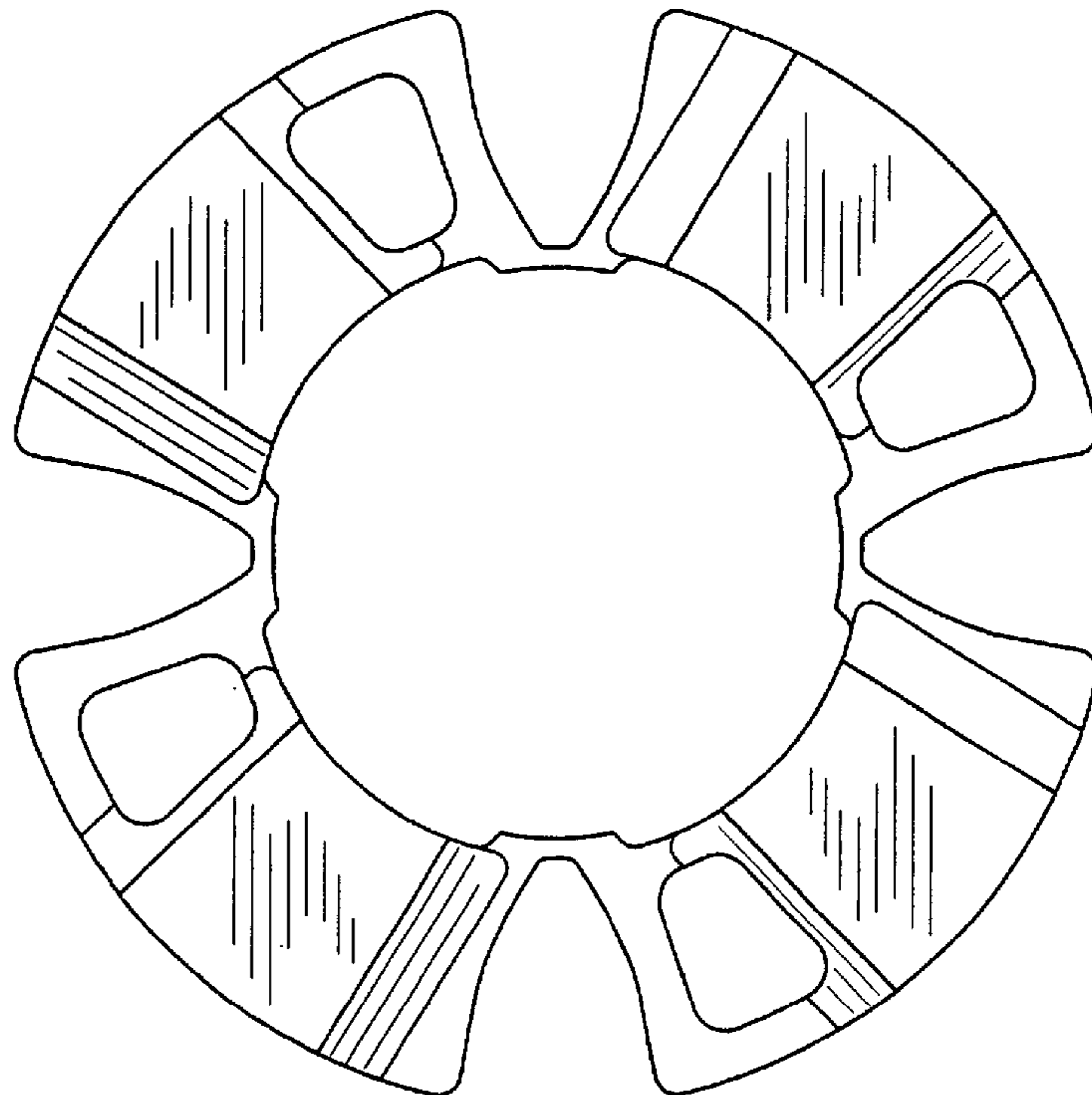

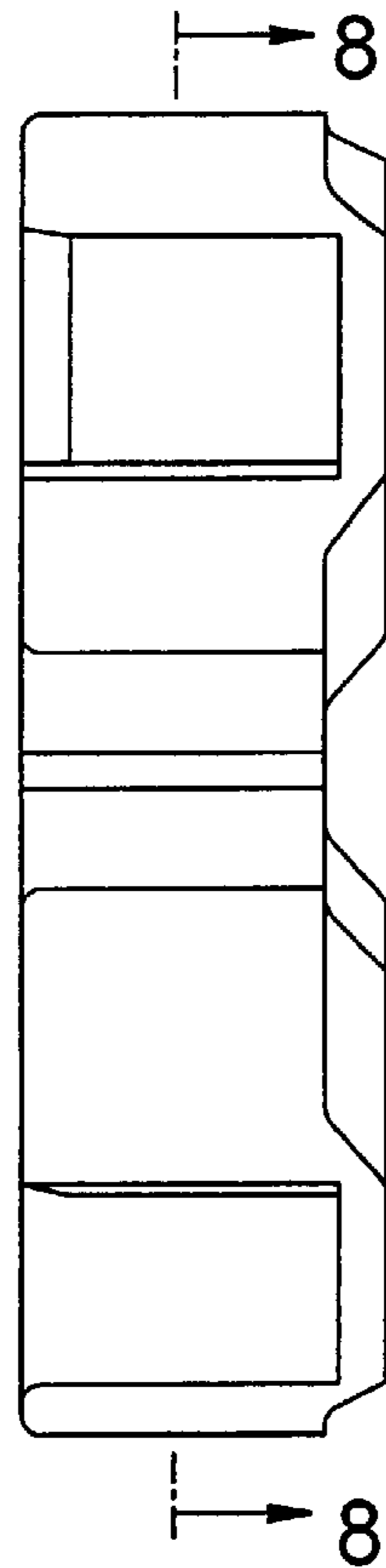

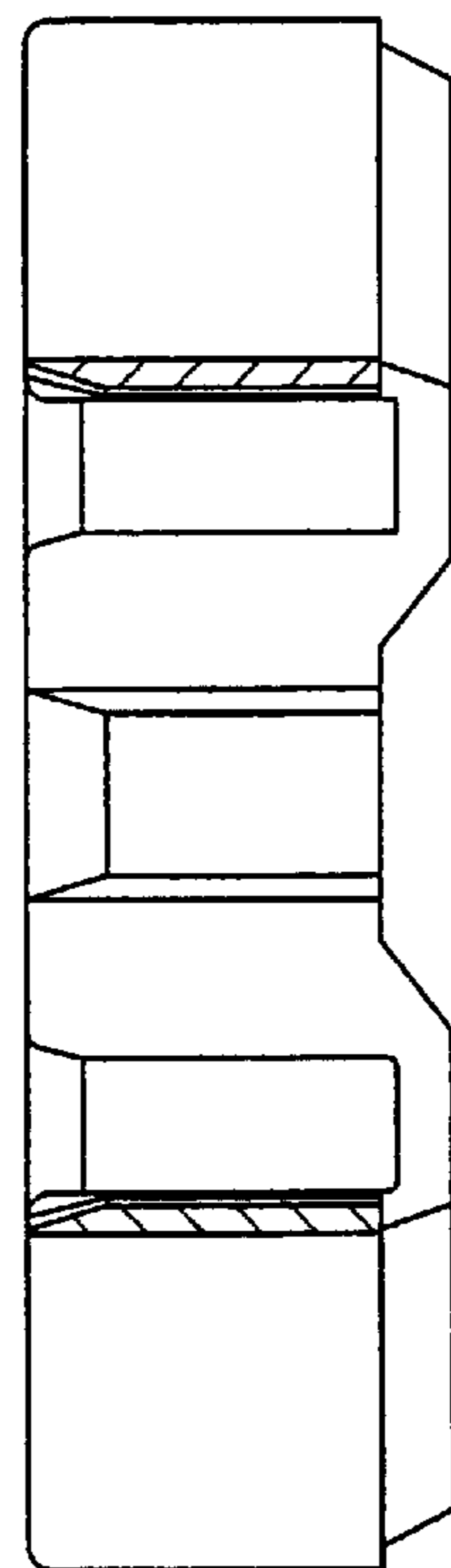

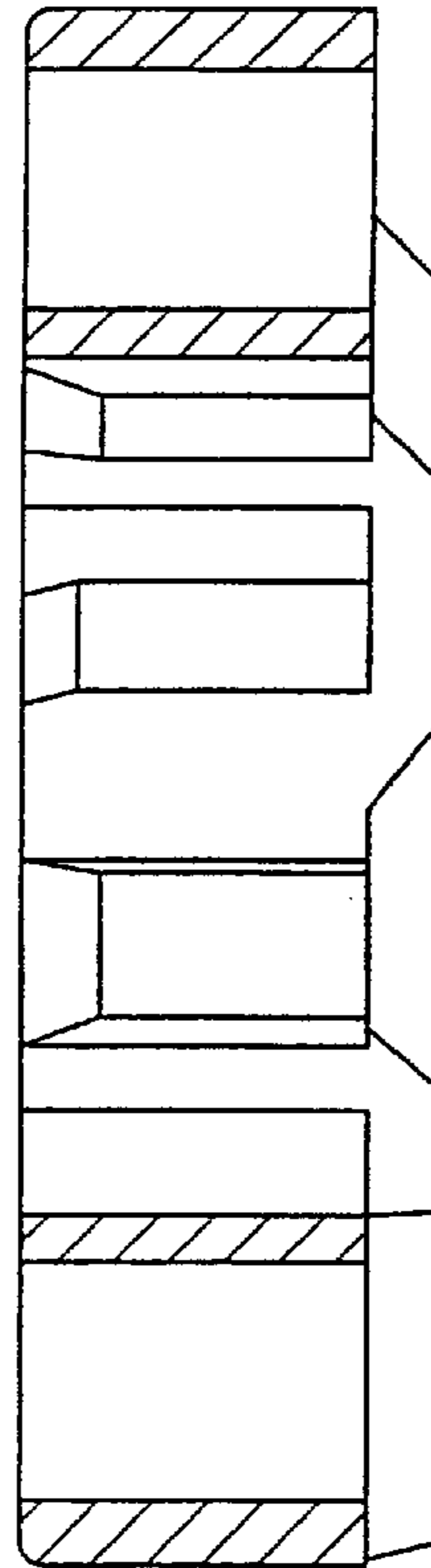

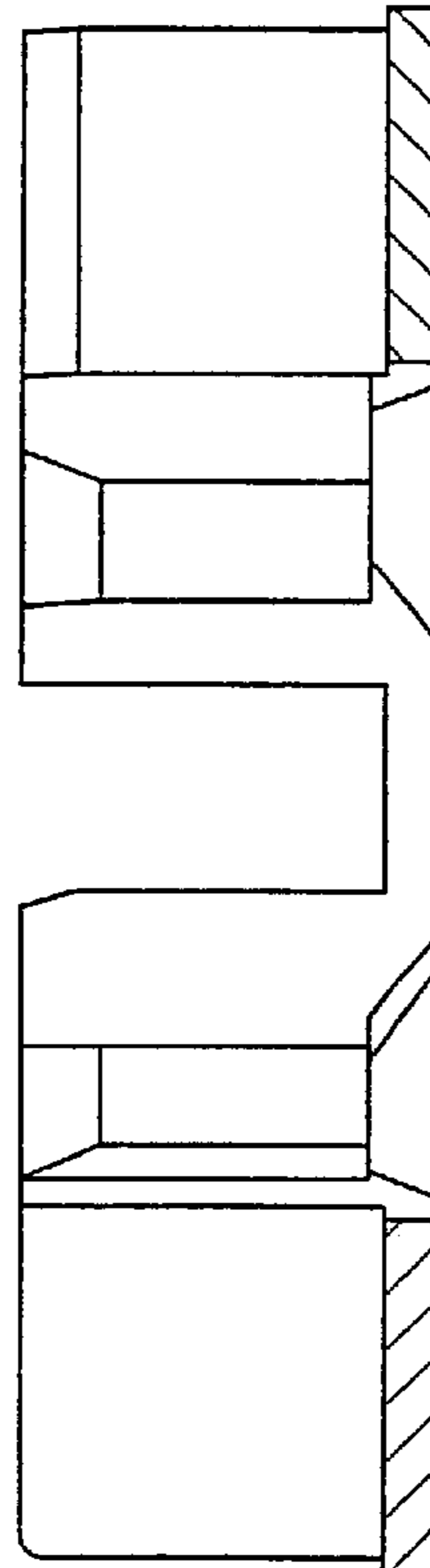
