FIG. 1 is a perspective view of a remote control showing a new design;

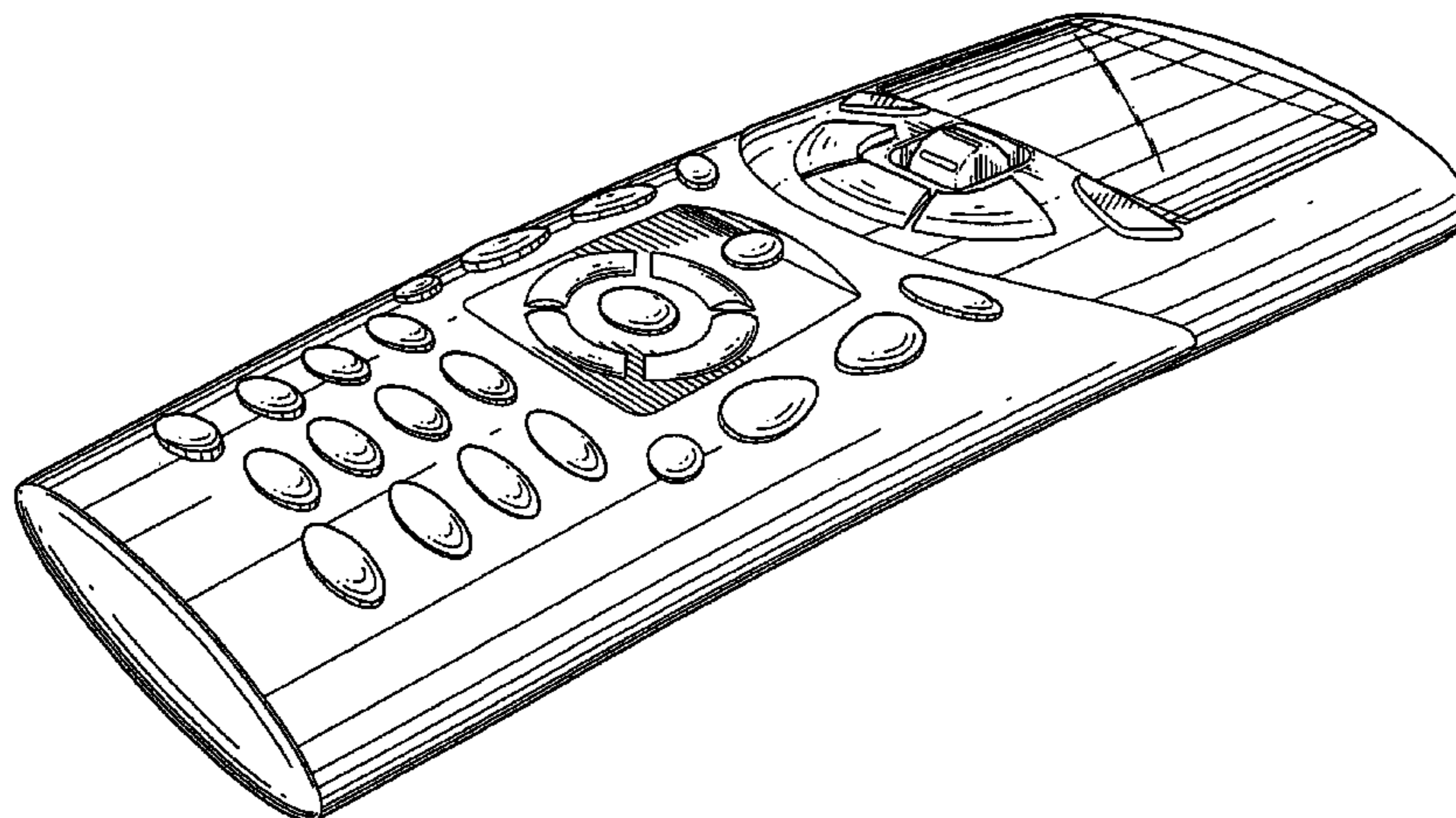
FIG. 2 is a top plan view thereof;

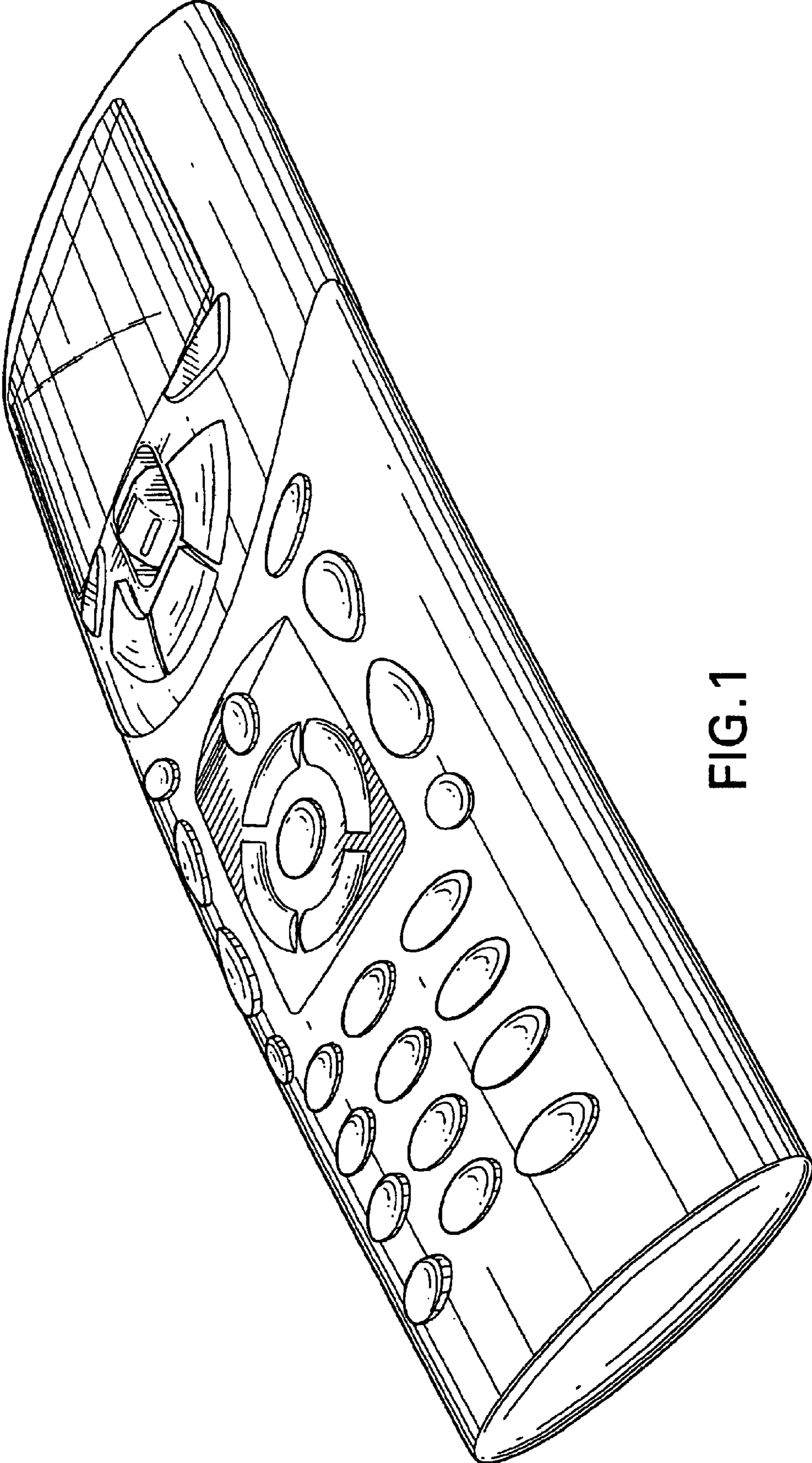

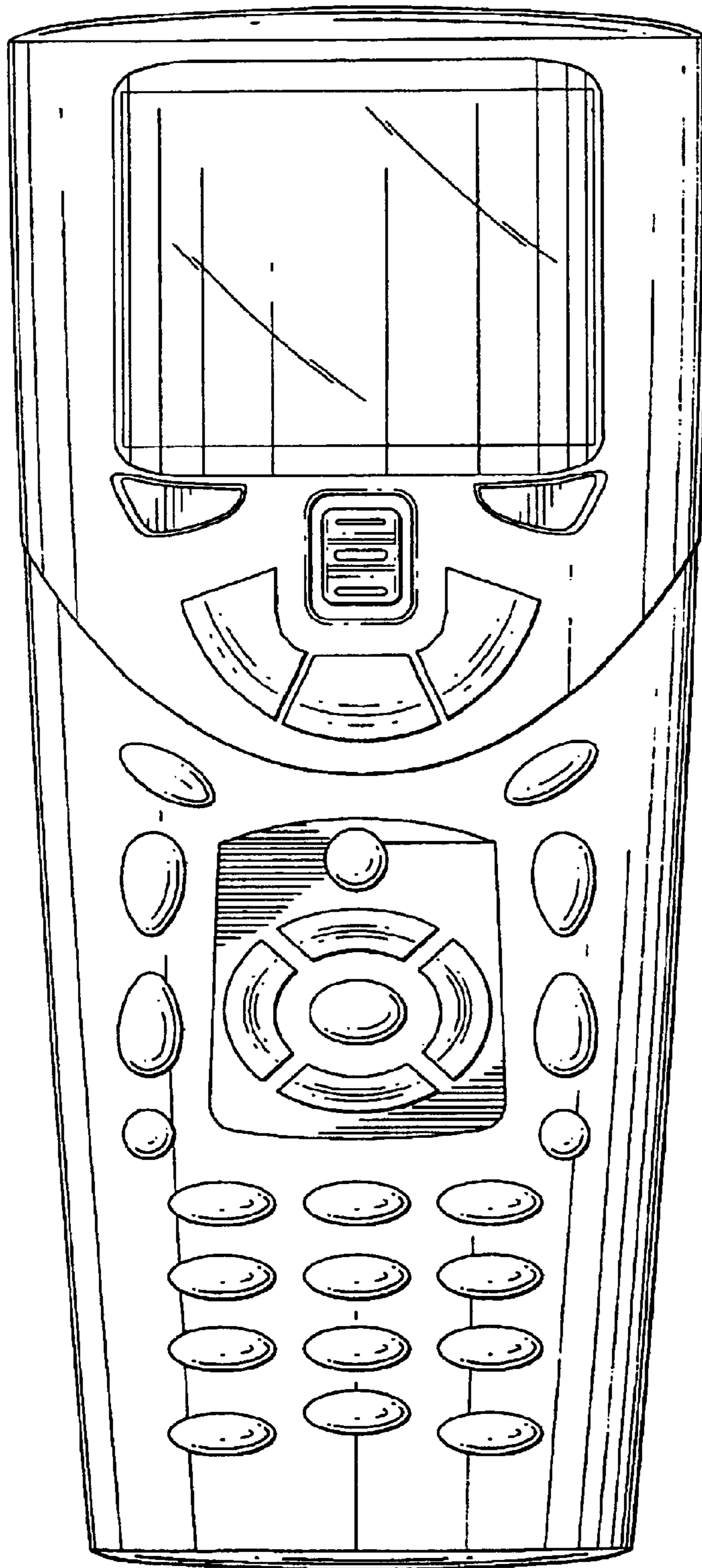

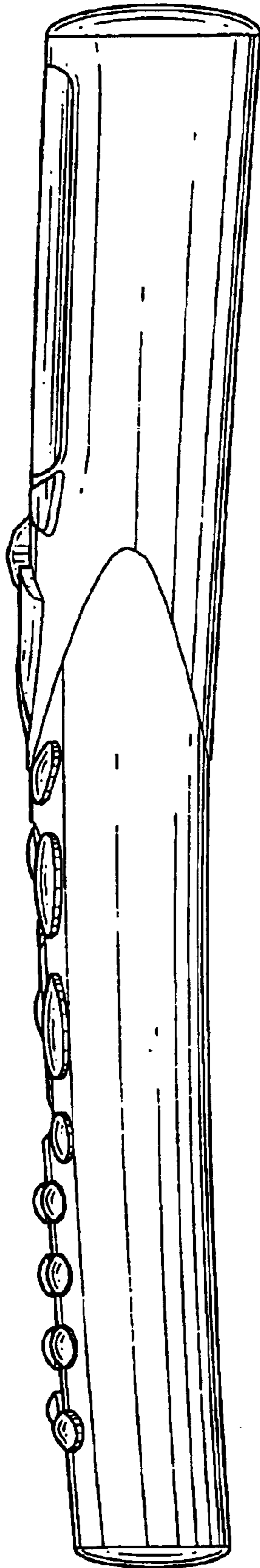

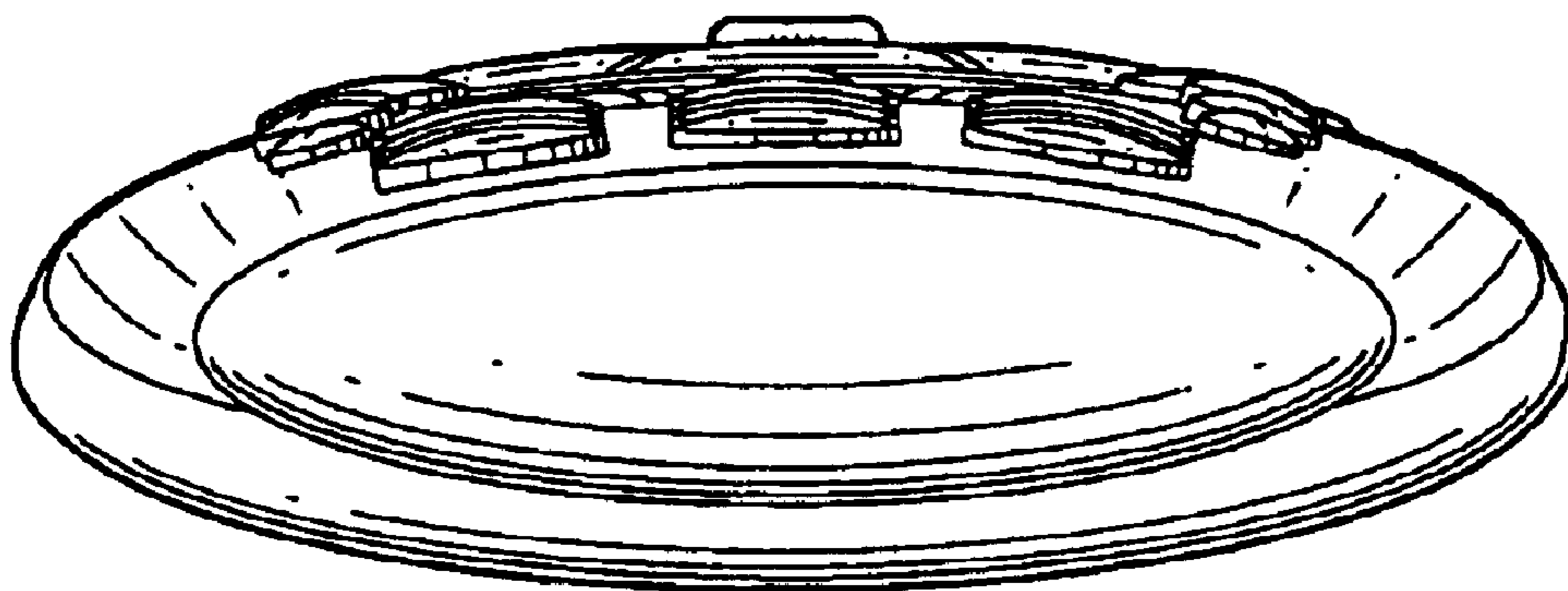

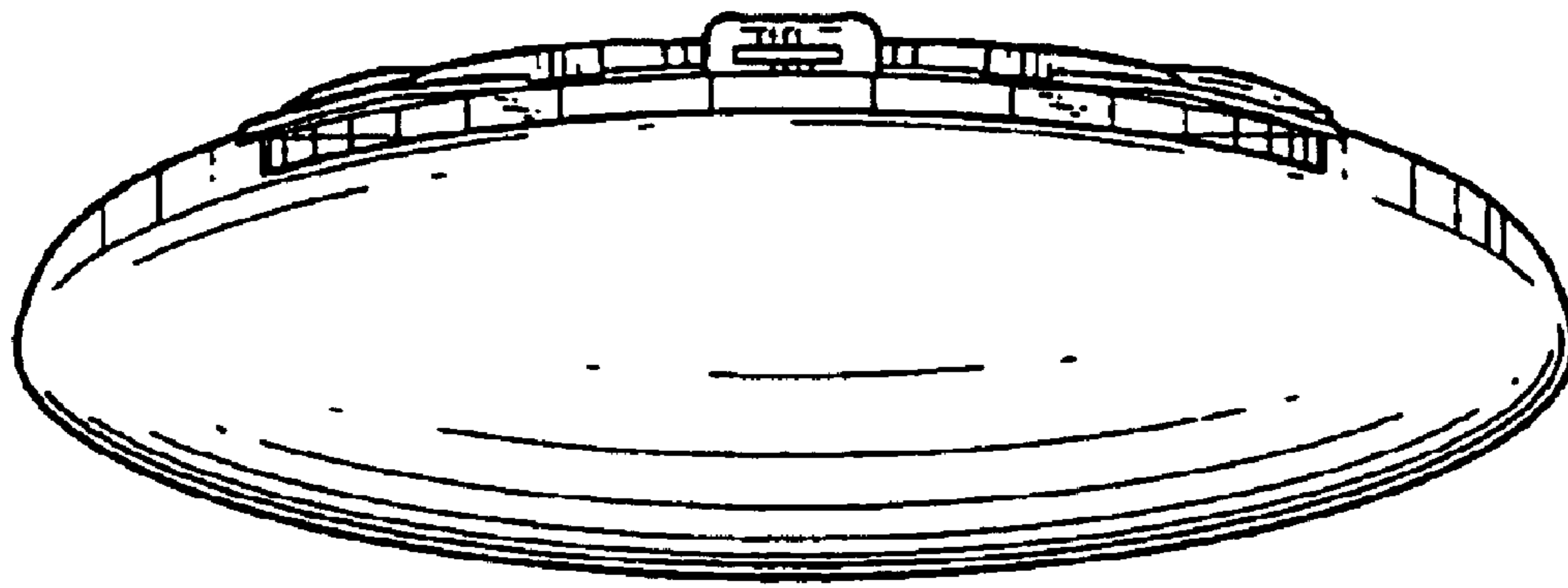
