The ornamental design for a graphical information interface for a display, as shown and described.

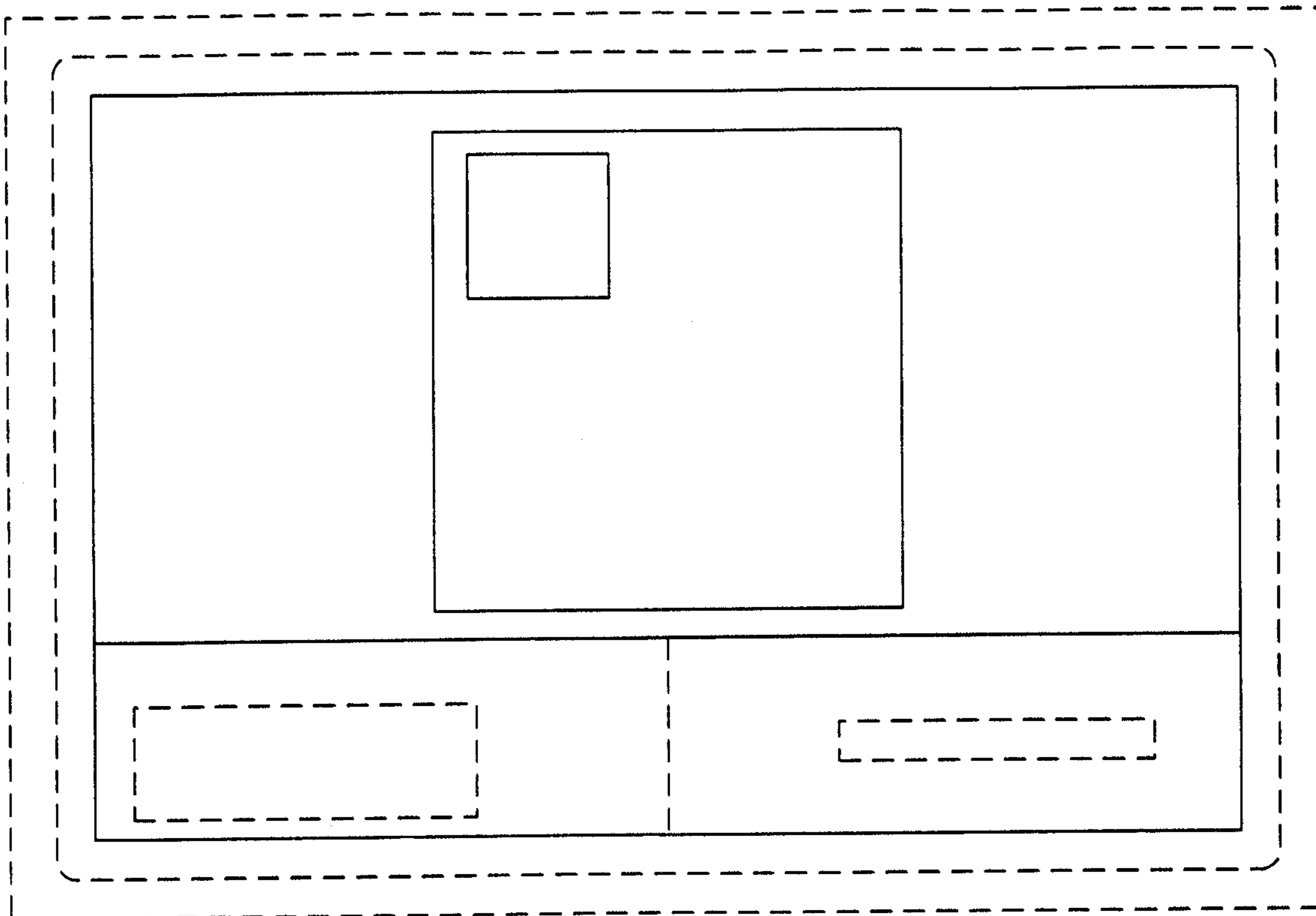
**DESCRIPTION**

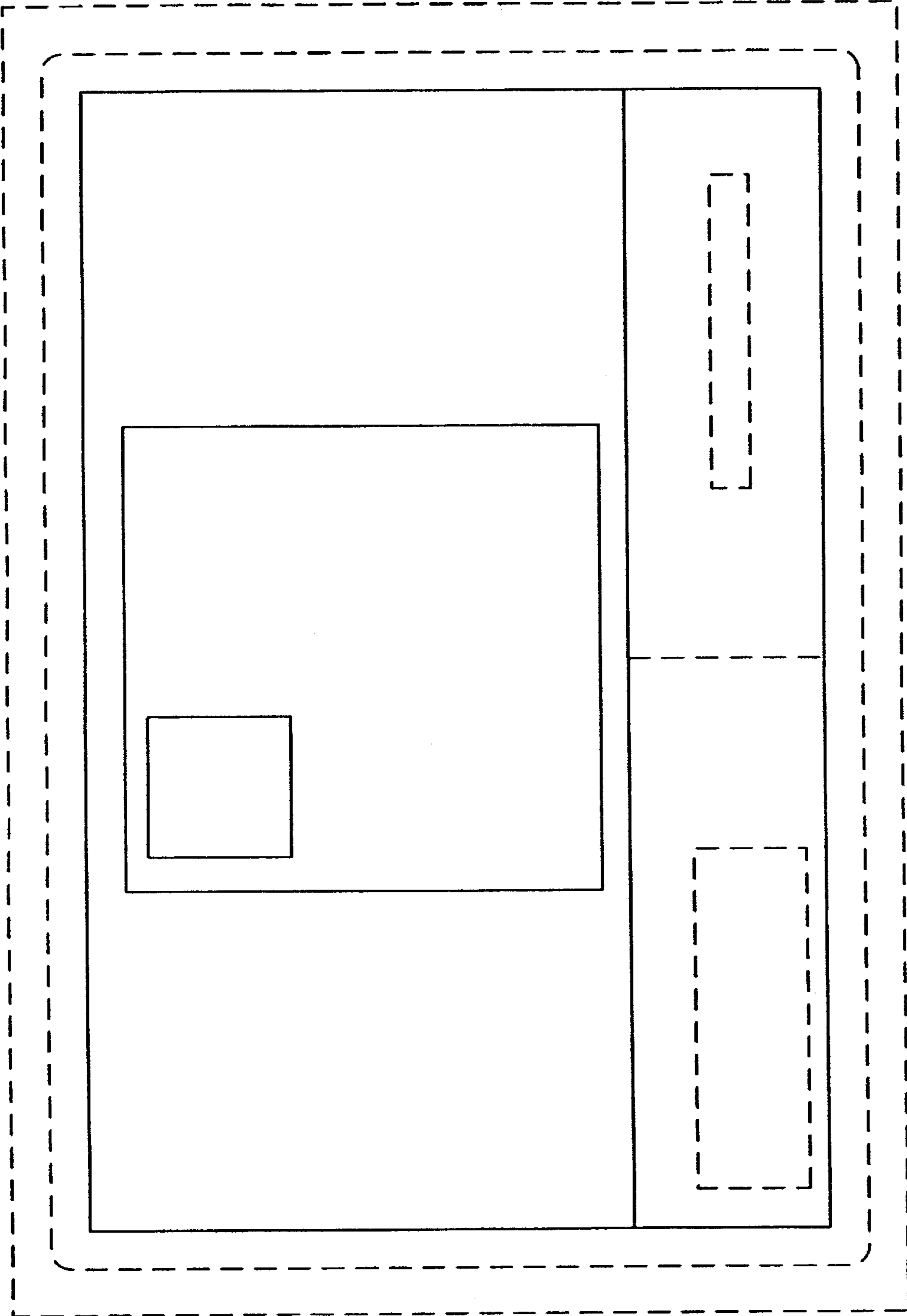

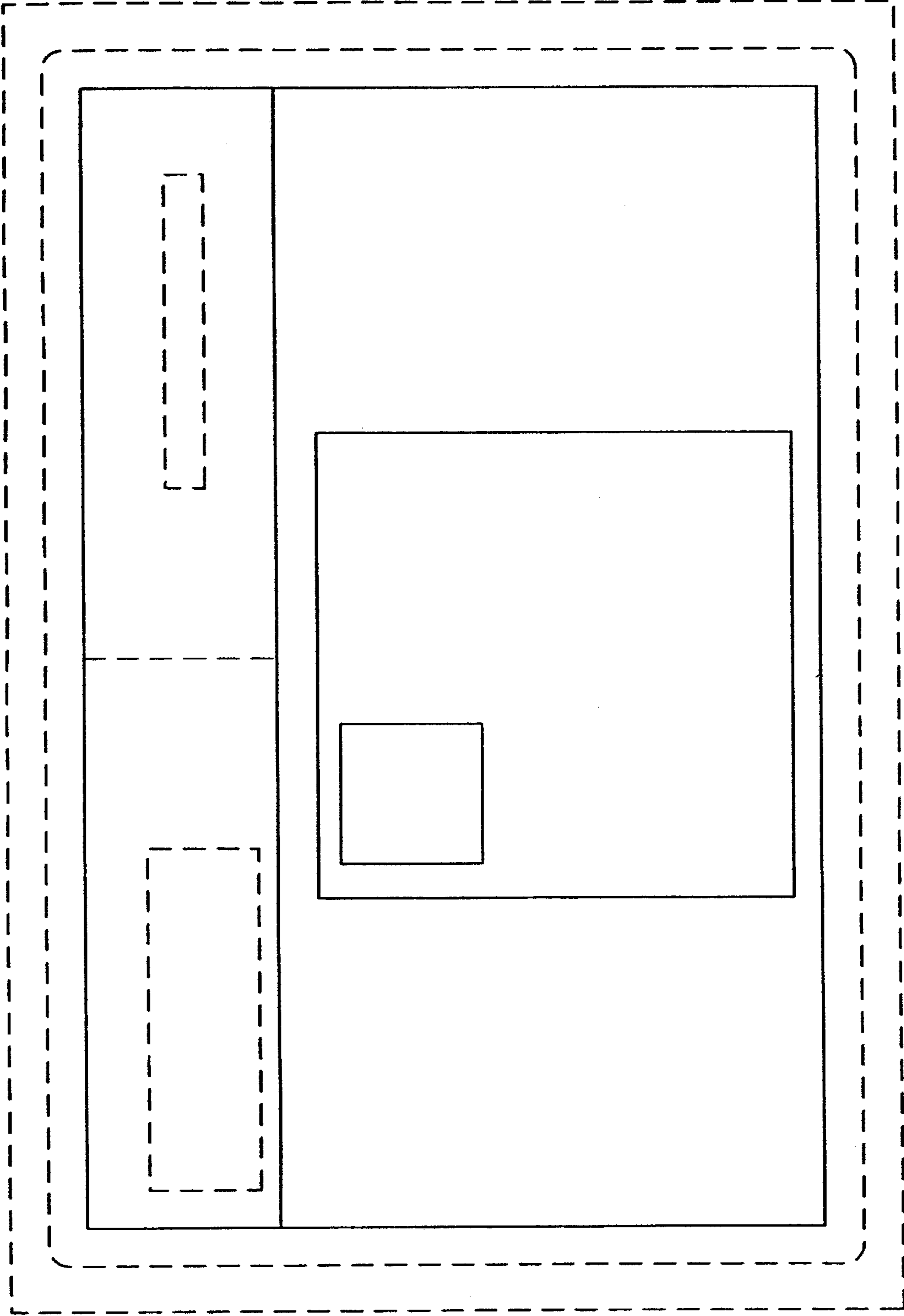
