DESCRIPTION

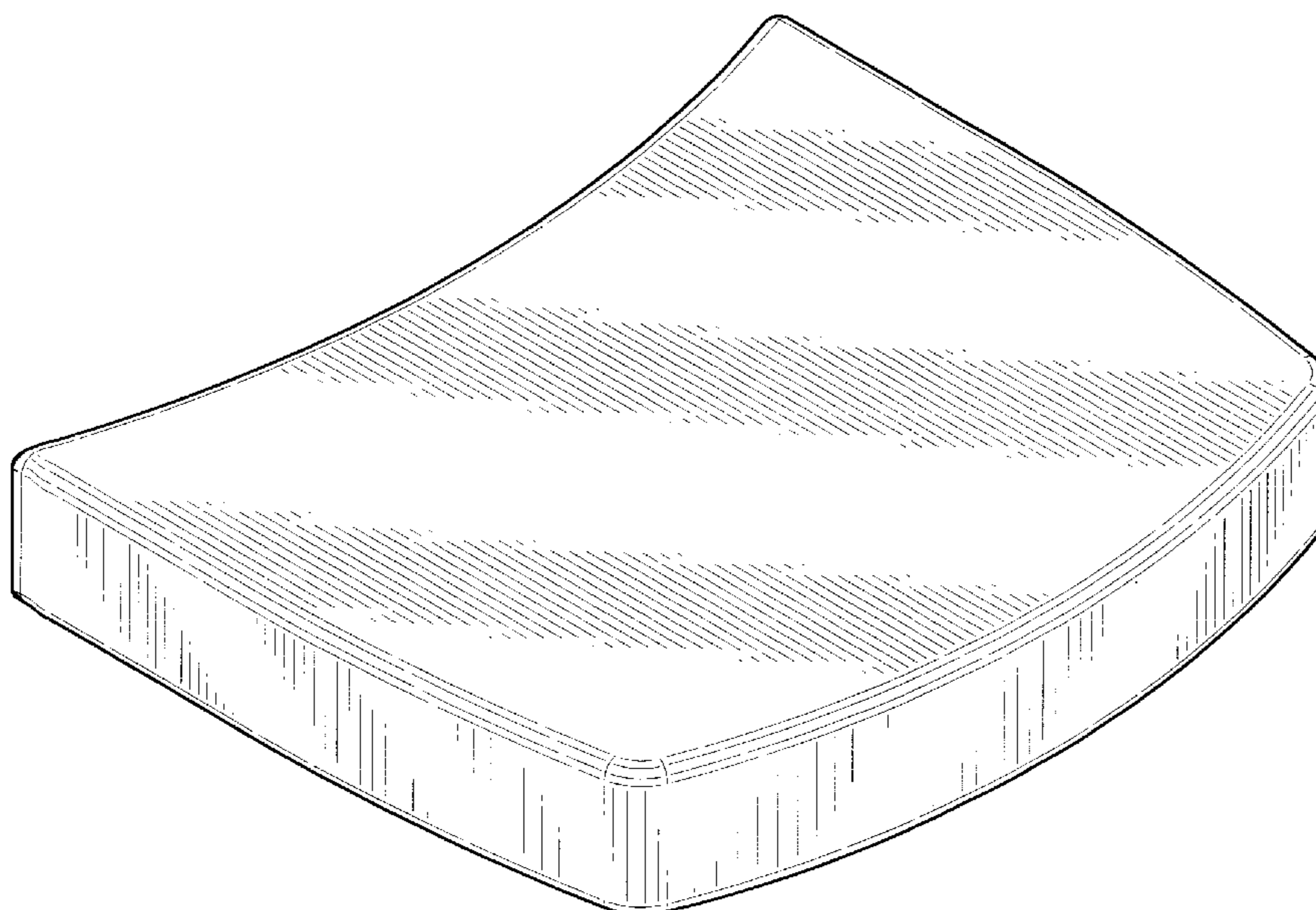

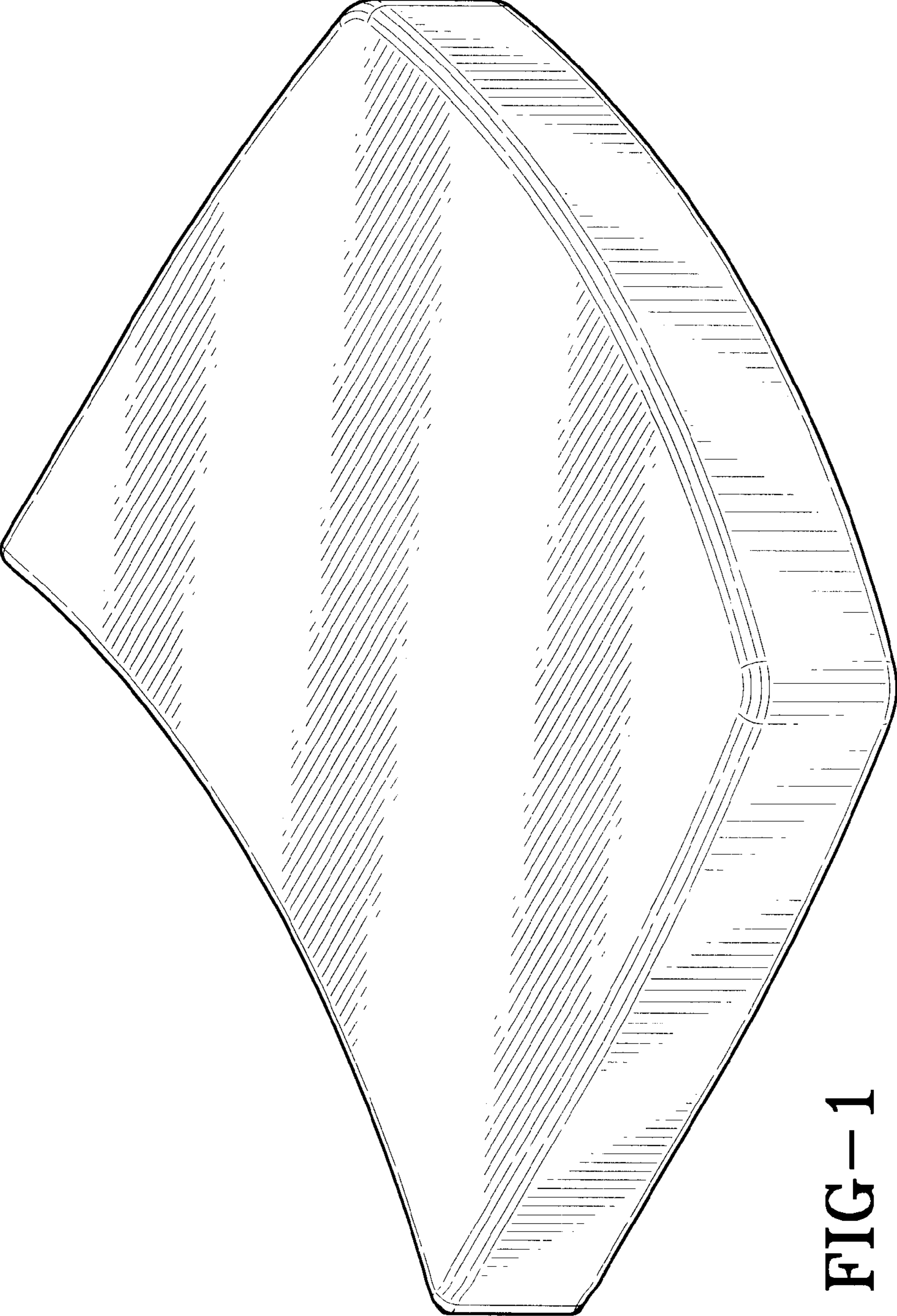

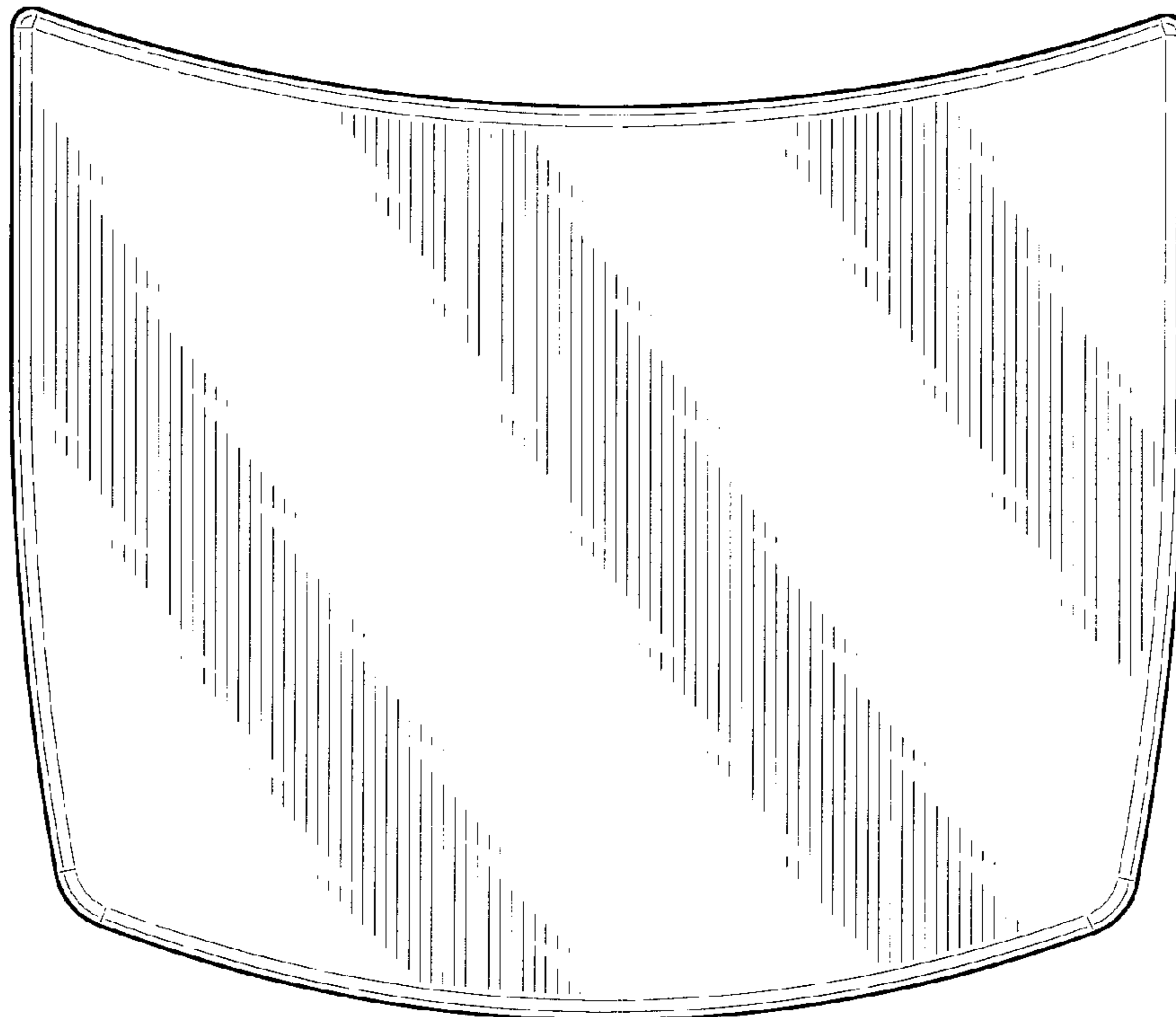

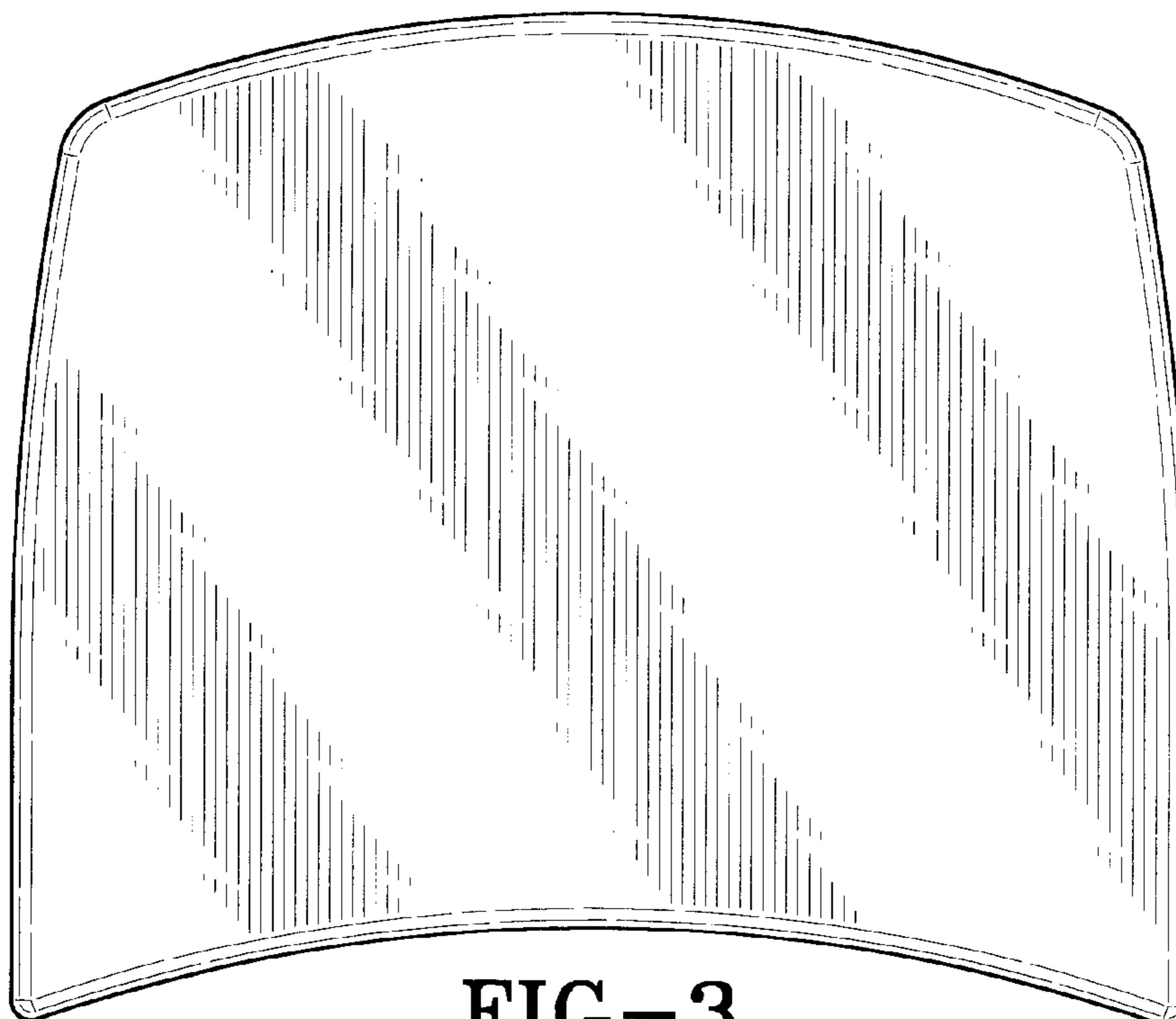

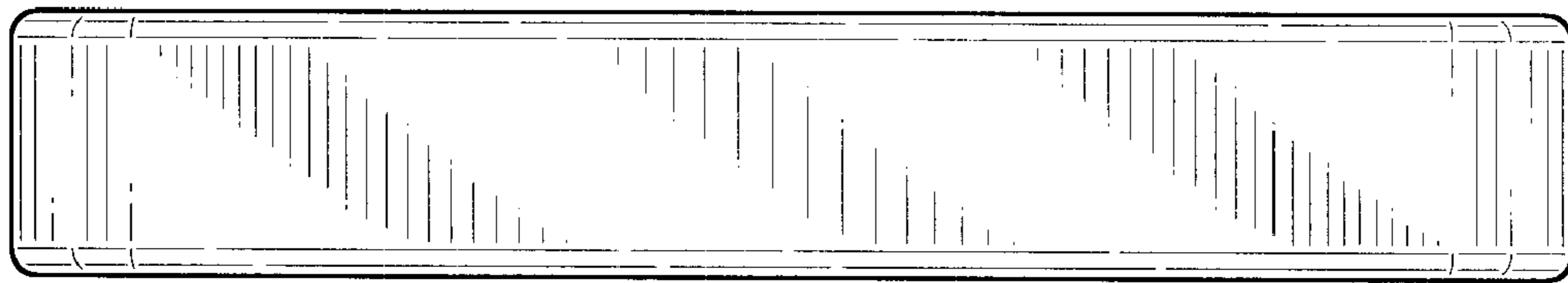

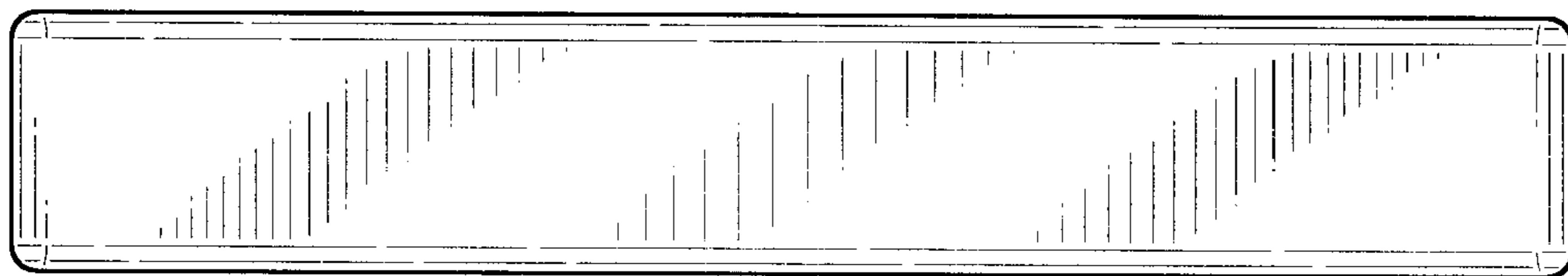

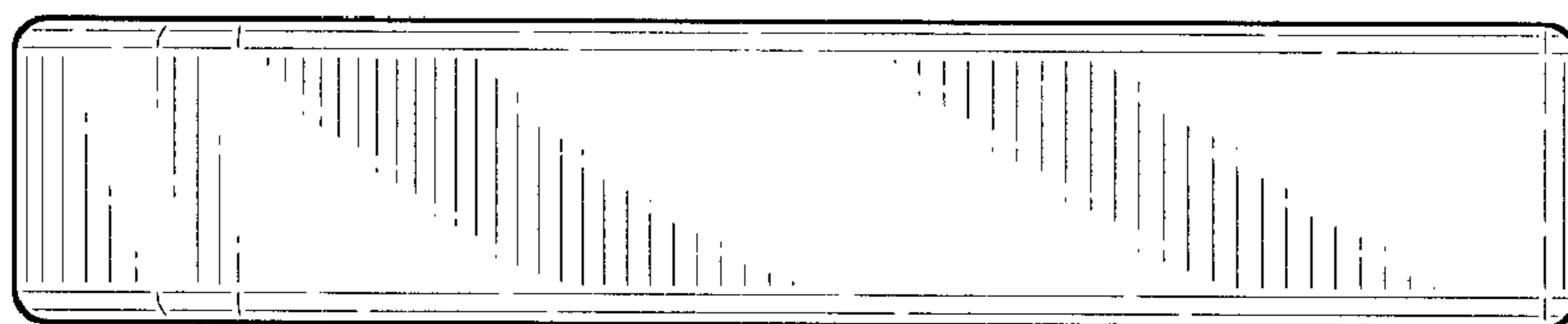

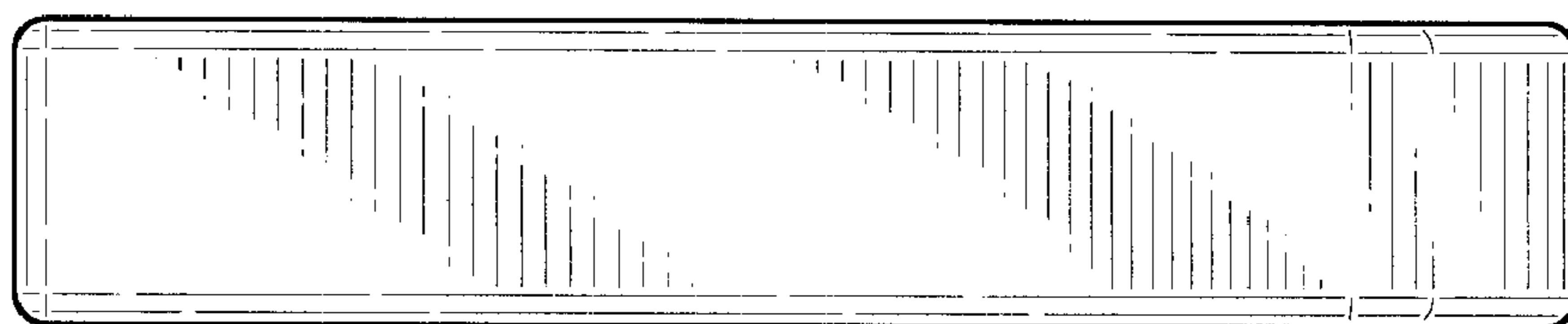

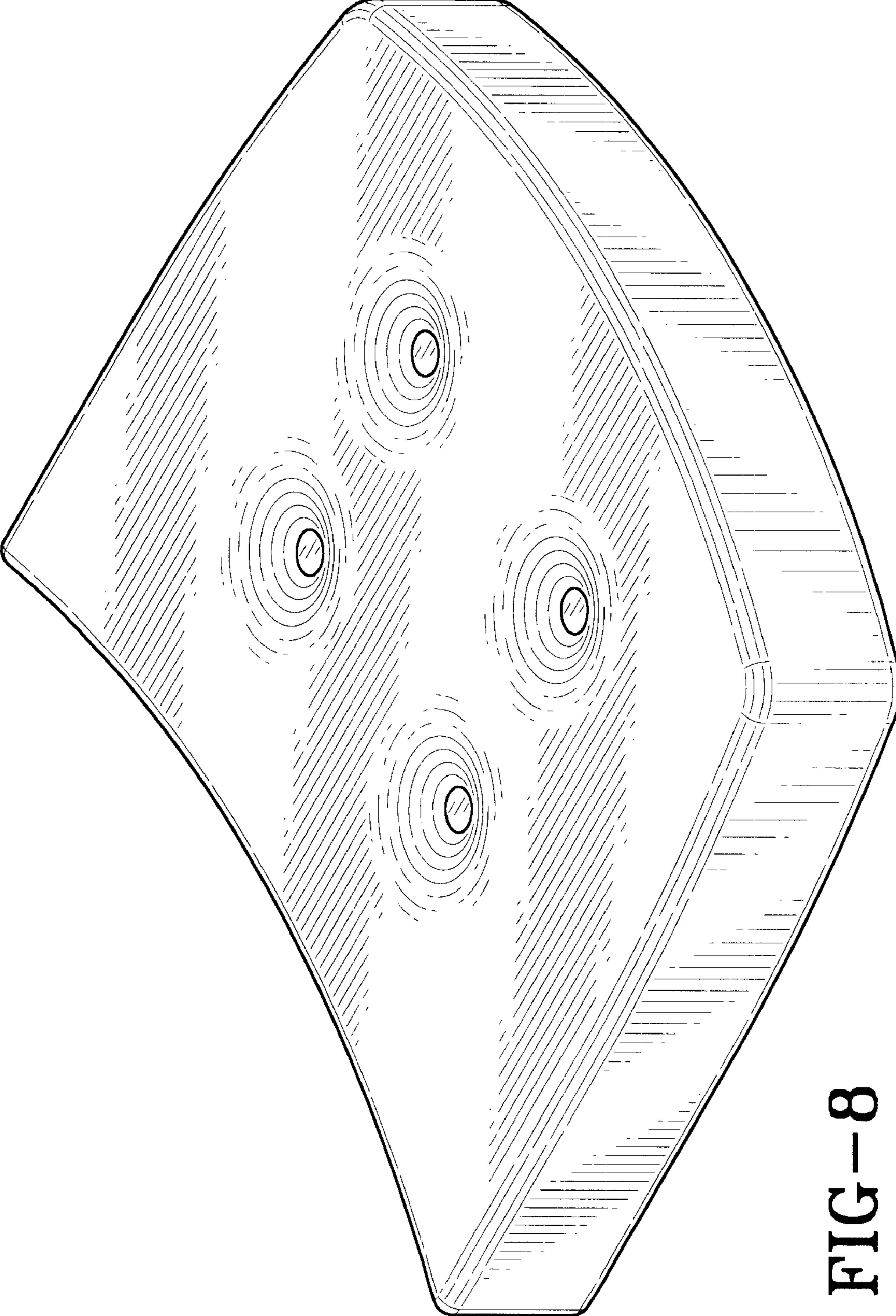

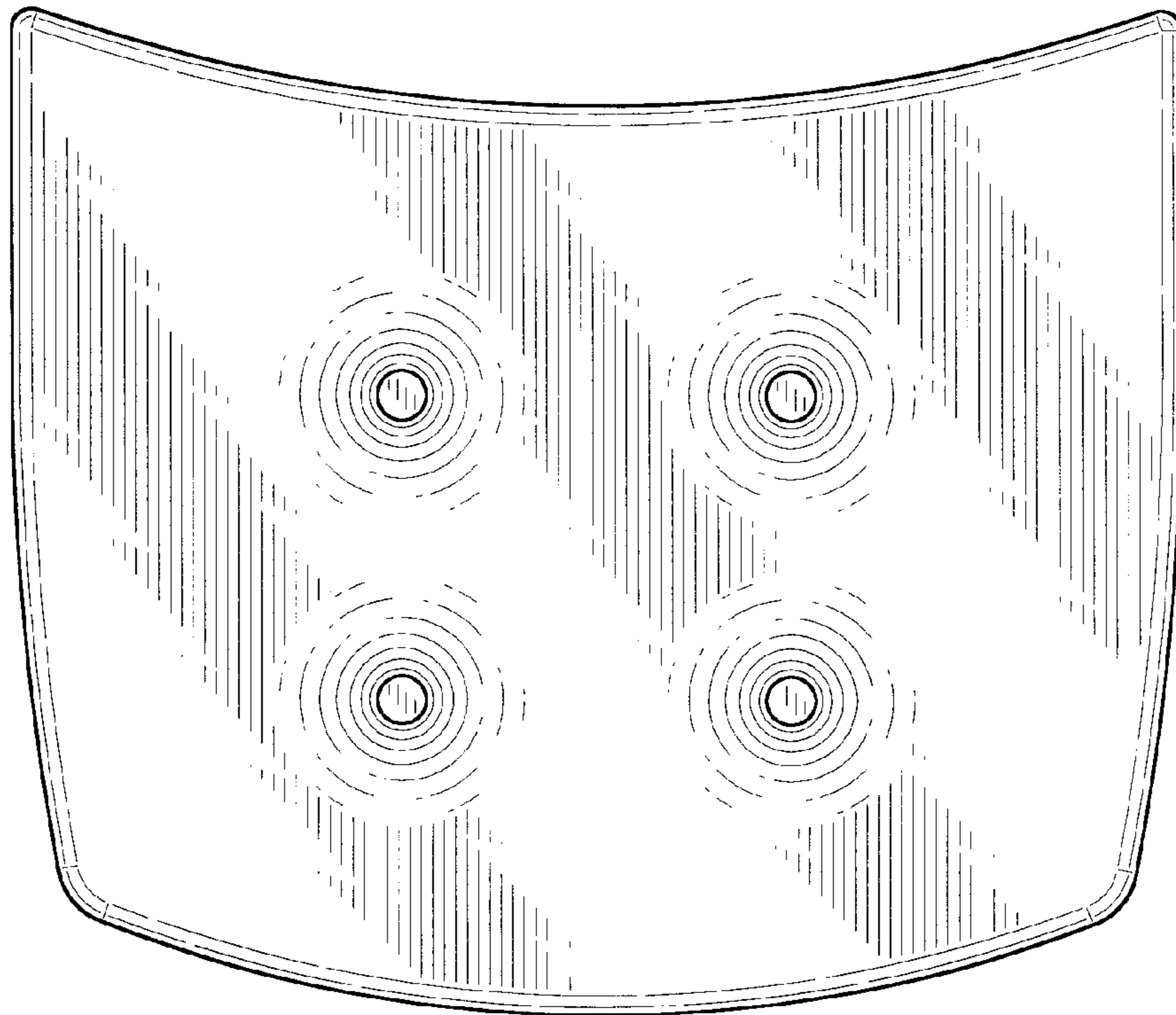

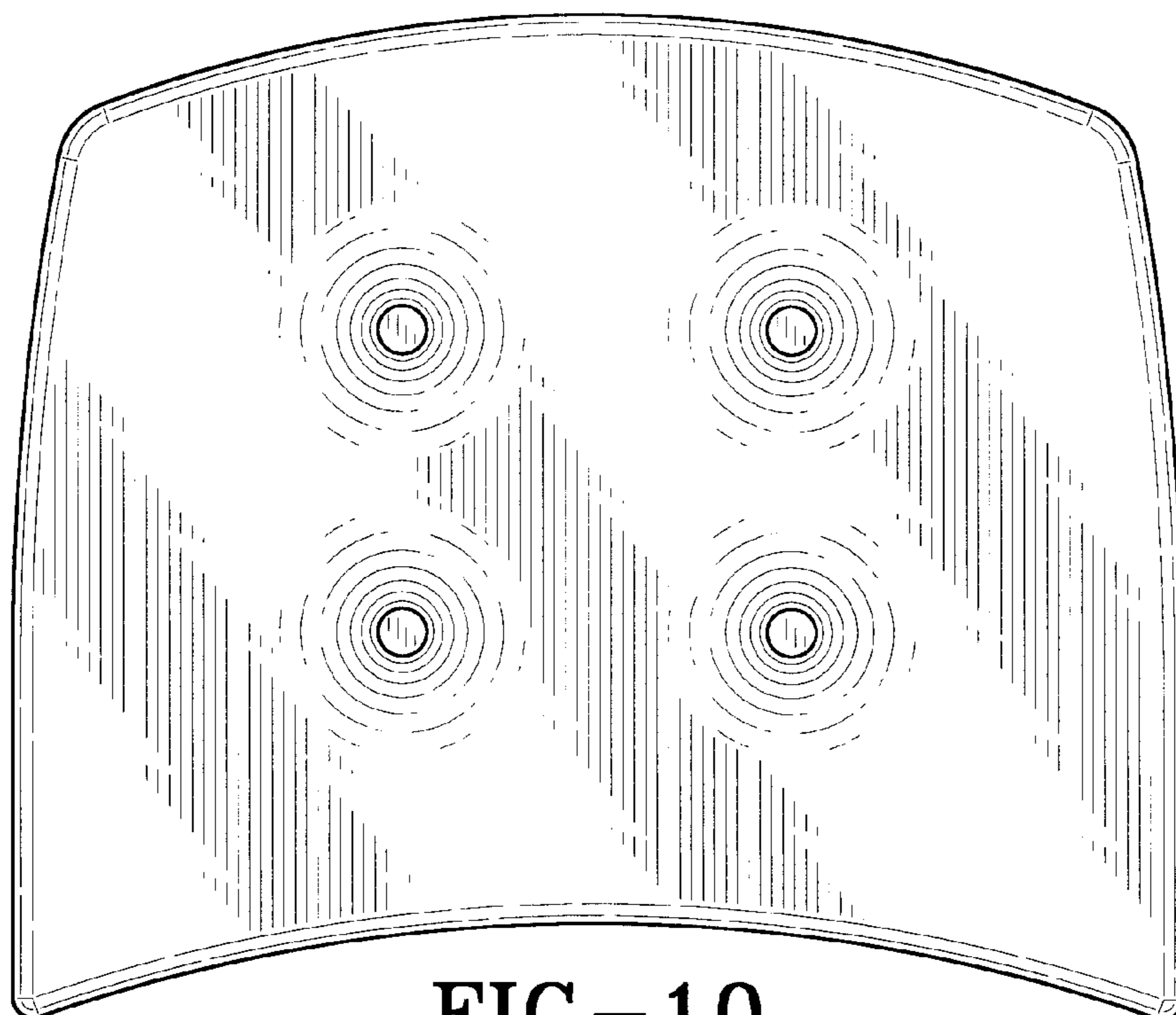

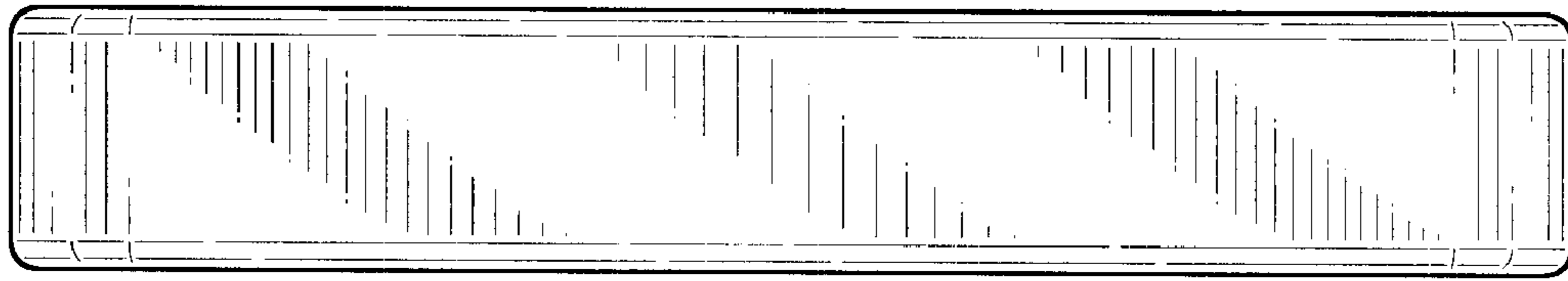

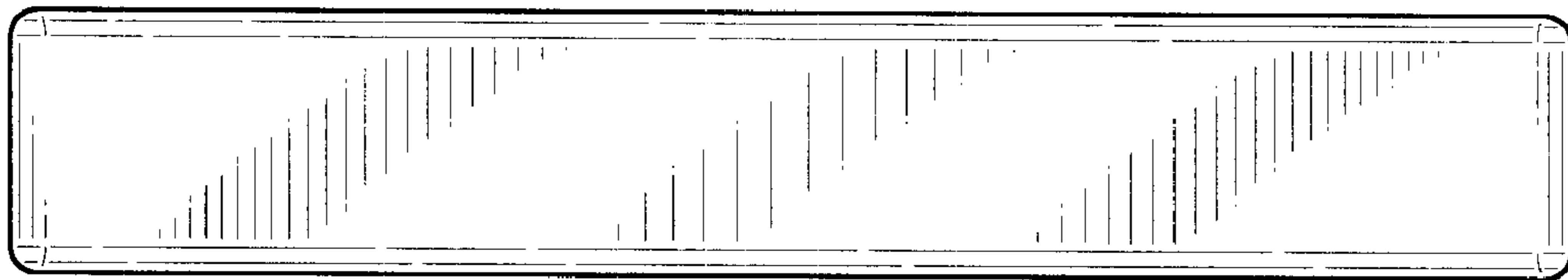

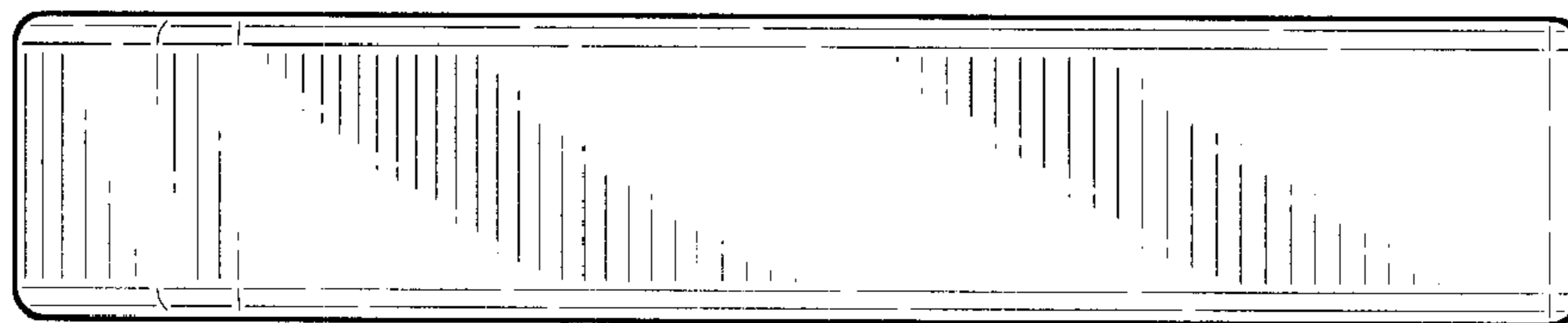

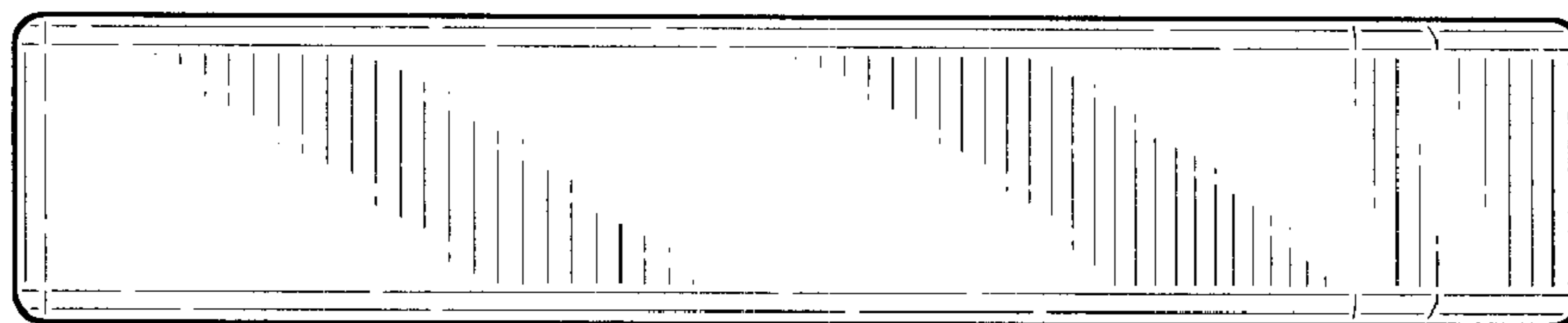
