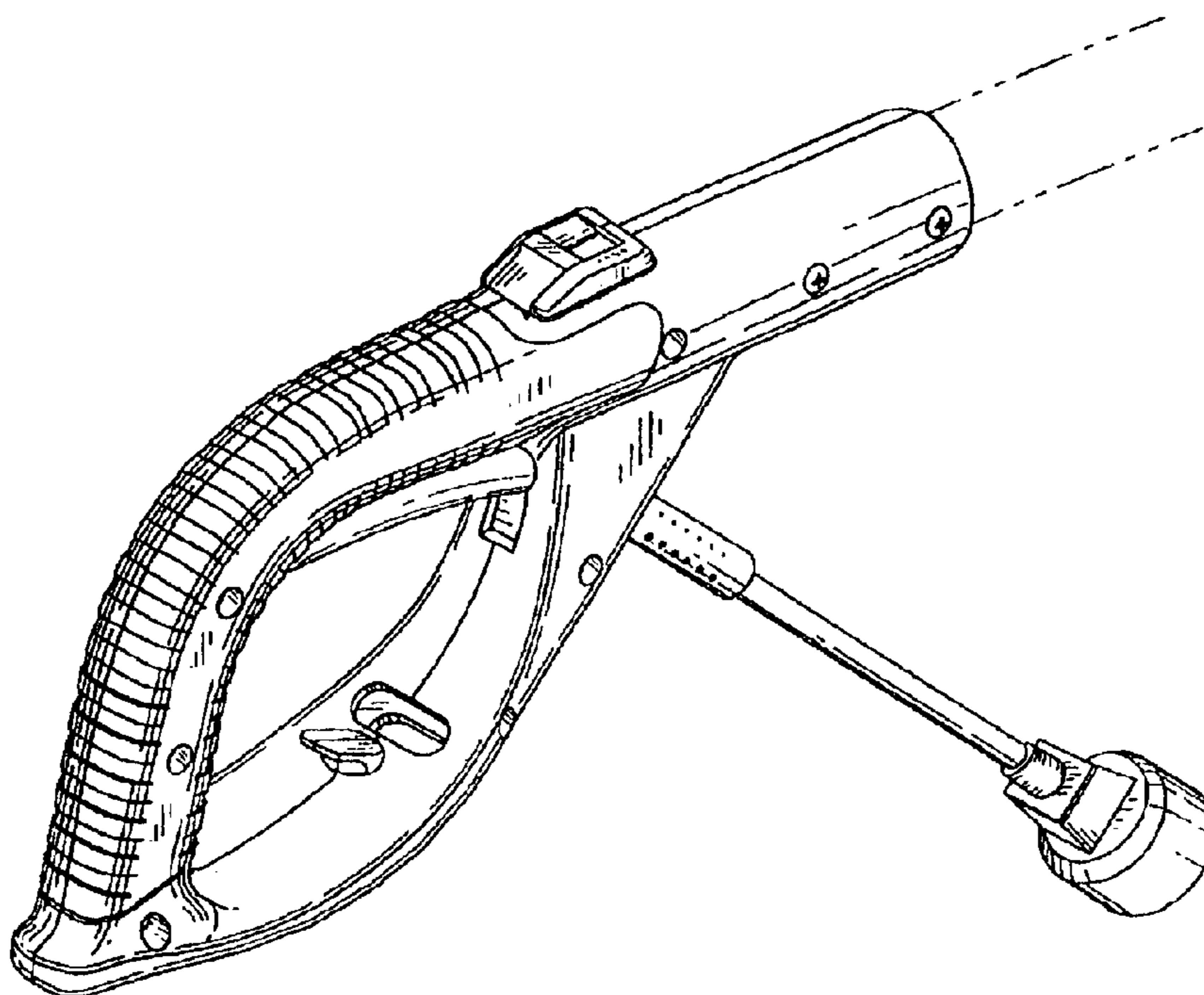
(57) **CLAIM**

I claim the ornamental design of an extended reach hedge trimmer handle, as shown.

DESCRIPTION

FIG. 1 is a perspective view of an extended reach hedge trimmer handle embodying the present design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is rear elevational view thereof; FIG. 6 is a top perspective view thereof; and, FIG. 7 is a bottom perspective view thereof. The broken line showing of a partial shaft is for illustrative purposes only and forms no part of the claimed design.

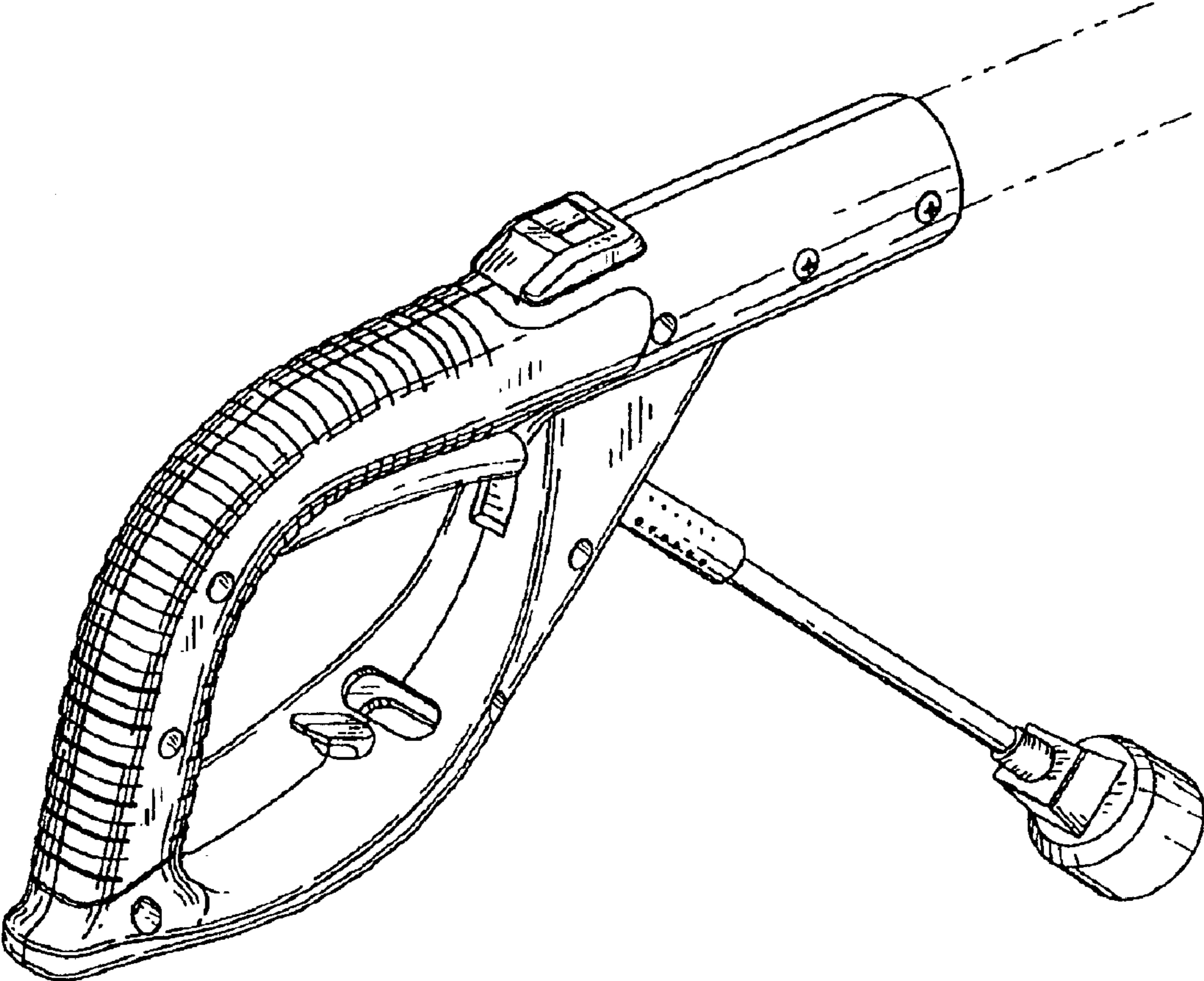

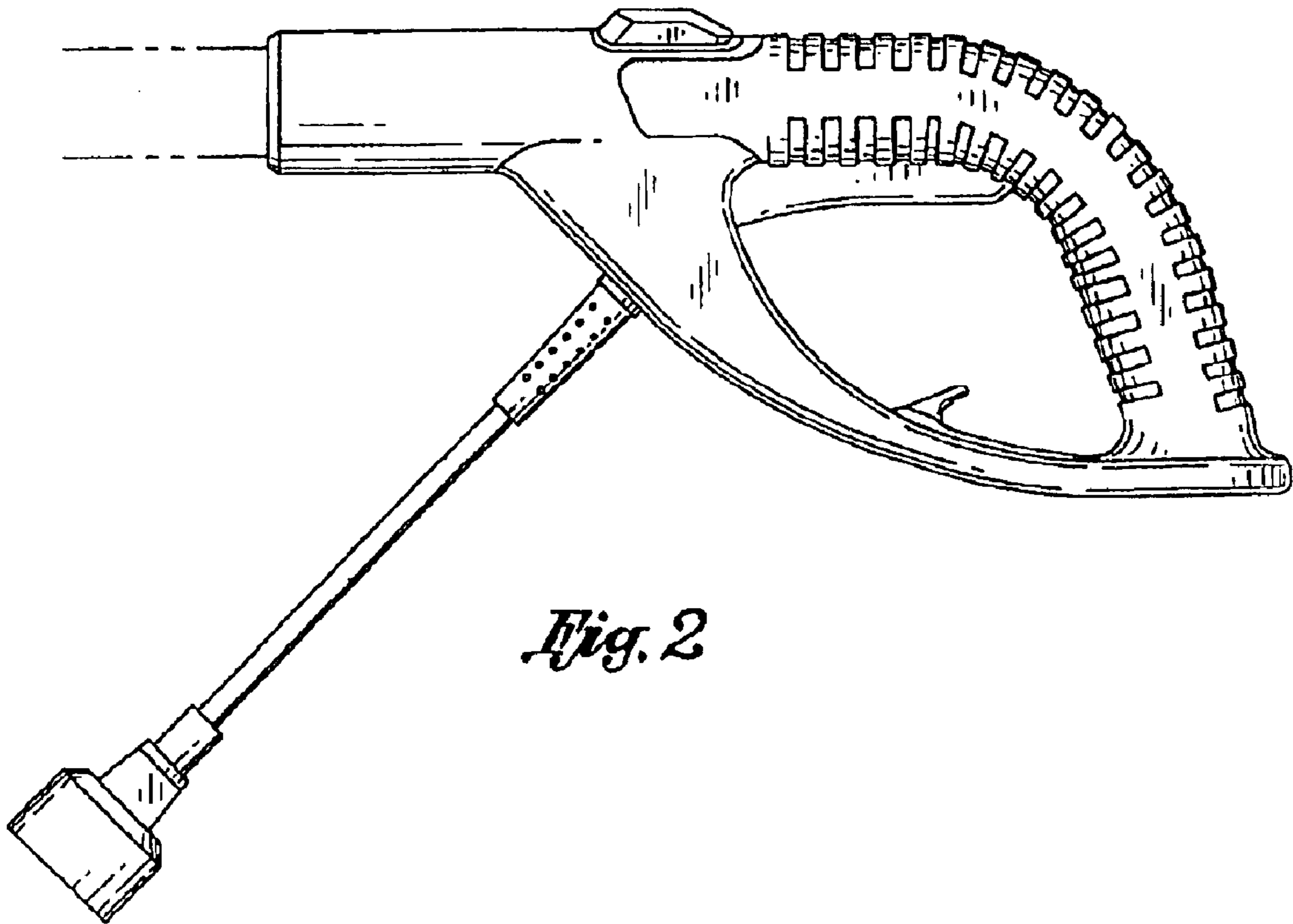

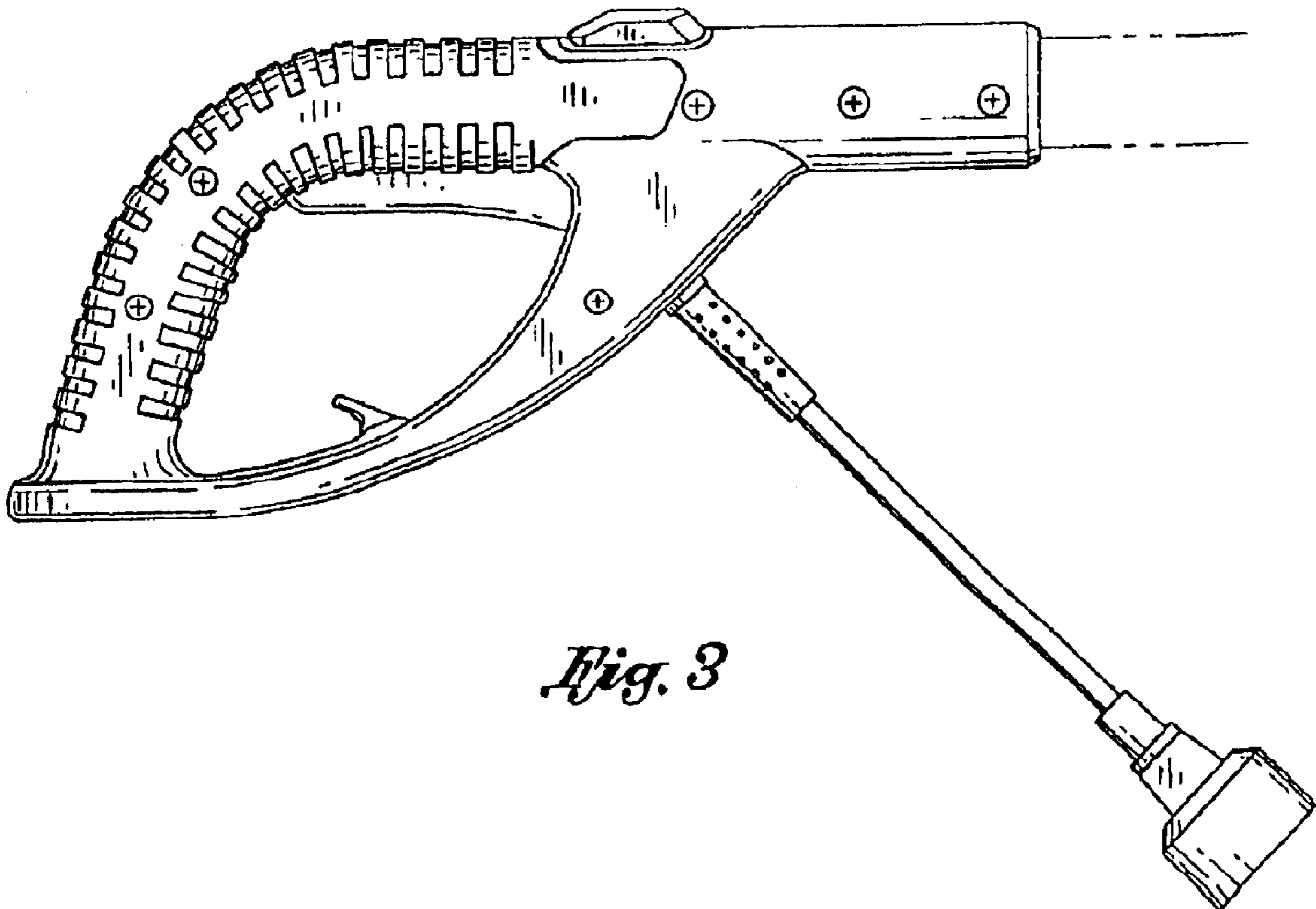

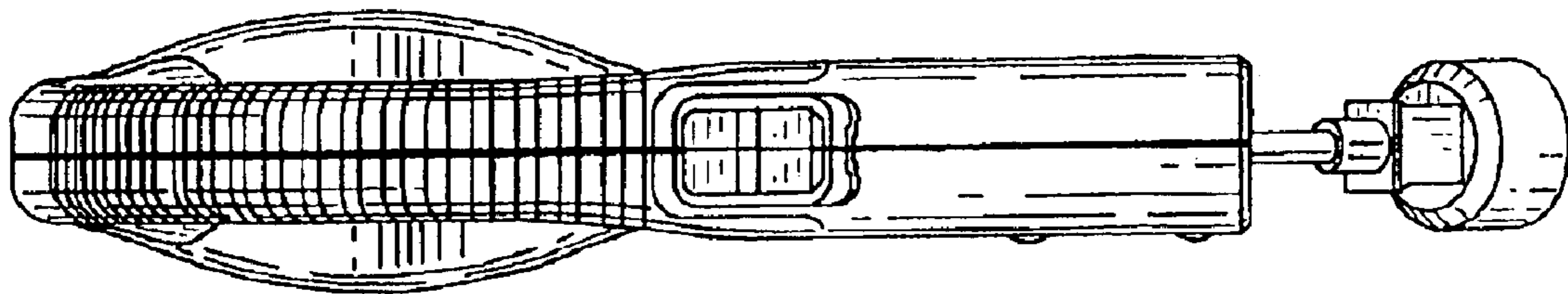
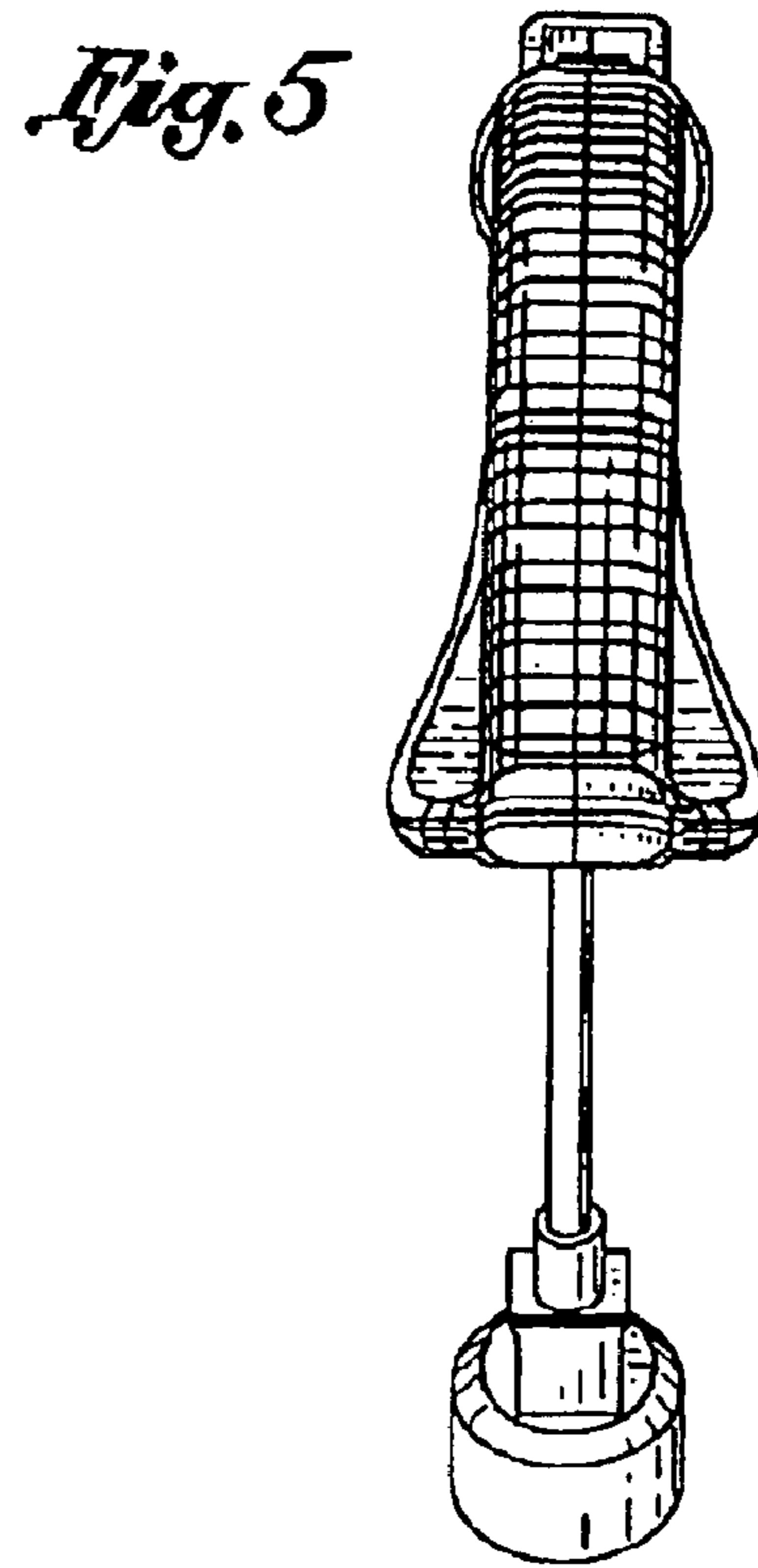
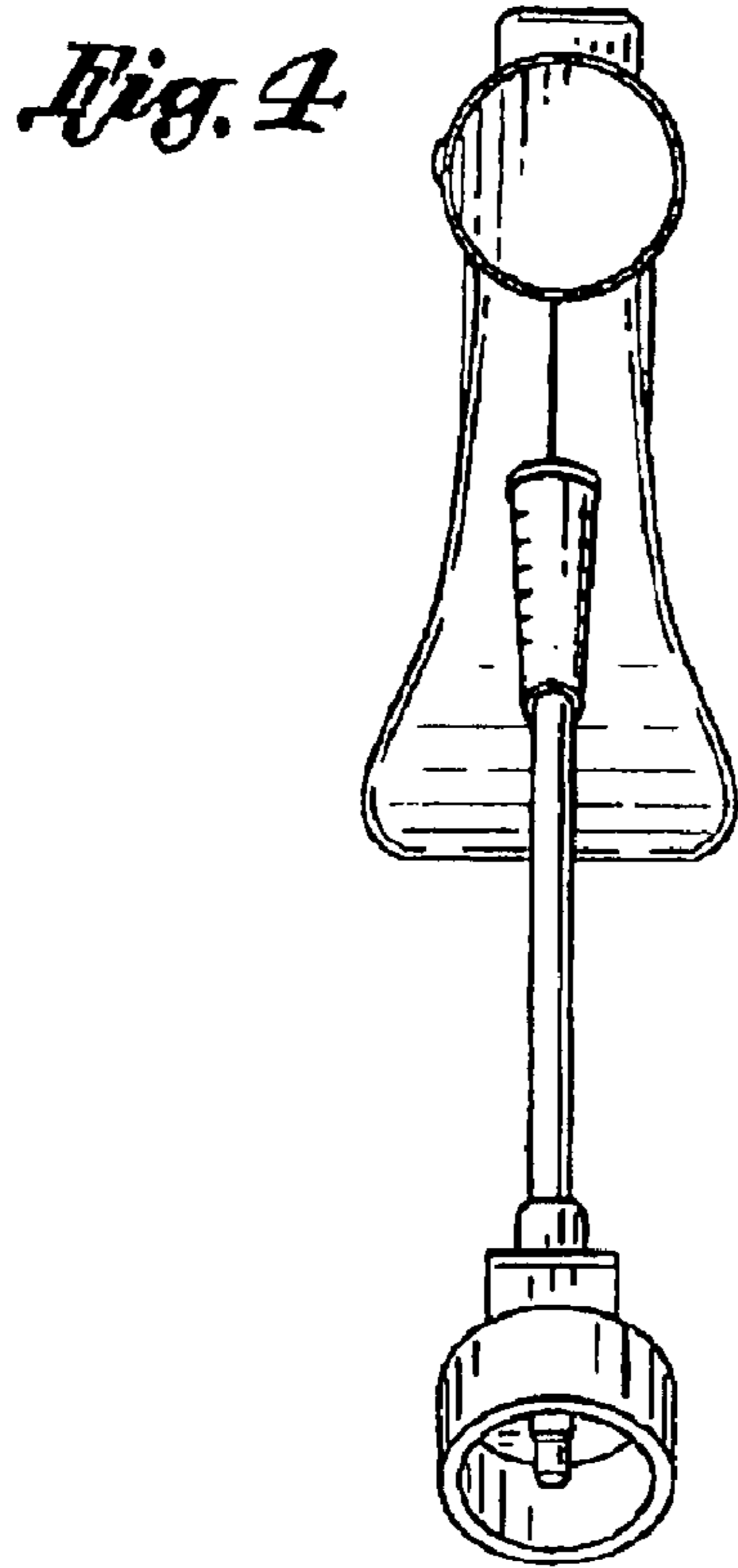

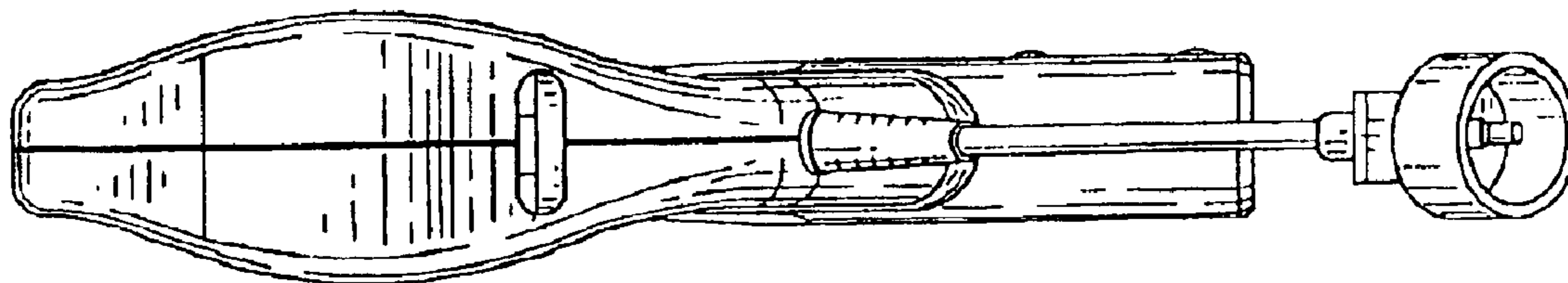
