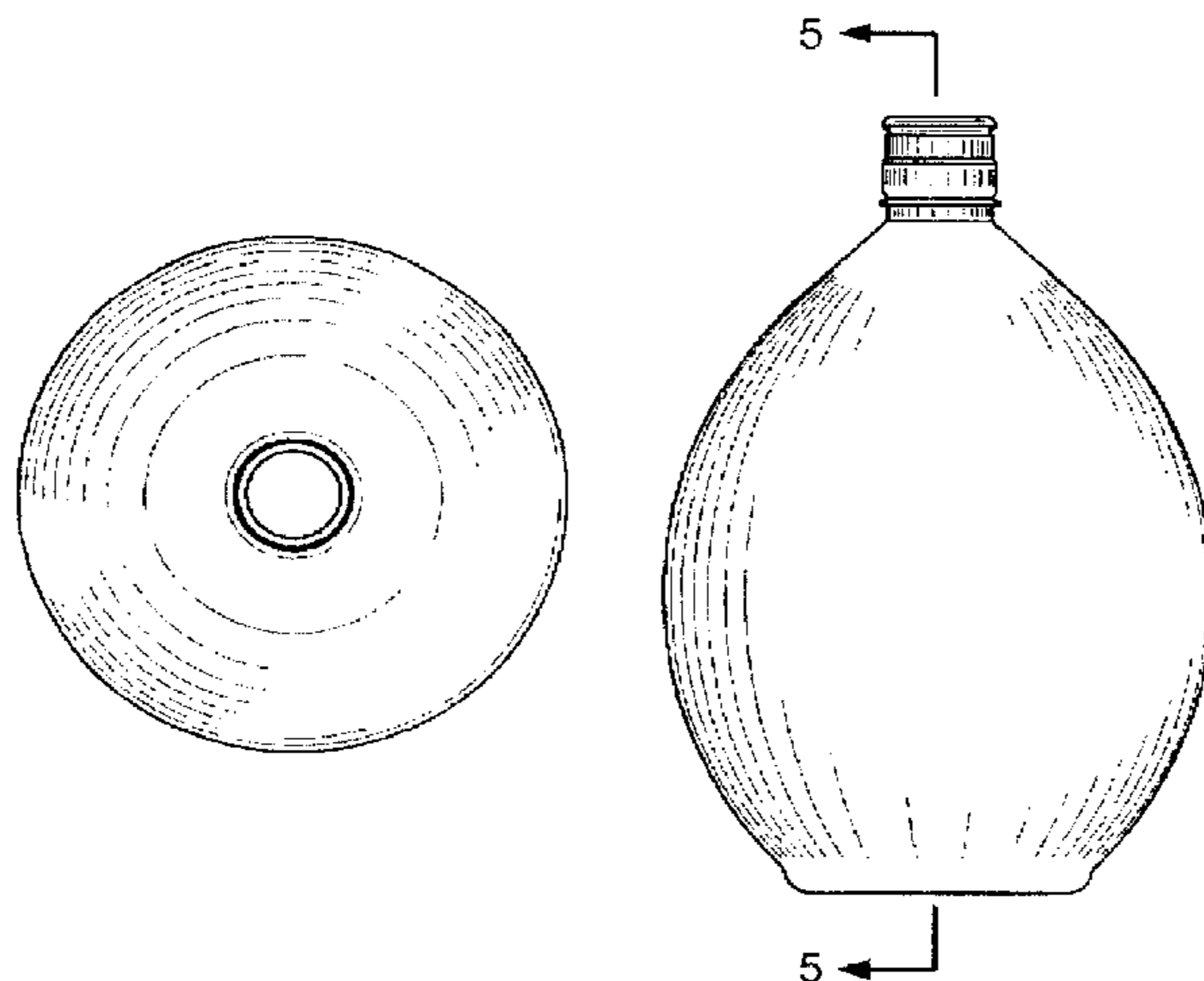
(57) **CLAIM**

The ornamental design for a water container for a dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a water container for a dispenser embodying my new design;  
FIG. 2 is a side view thereof, the opposite side being a mirror image thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a perspective view thereof; and,  
FIG. 5 is a section view along the line 5—5 of FIG. 2.

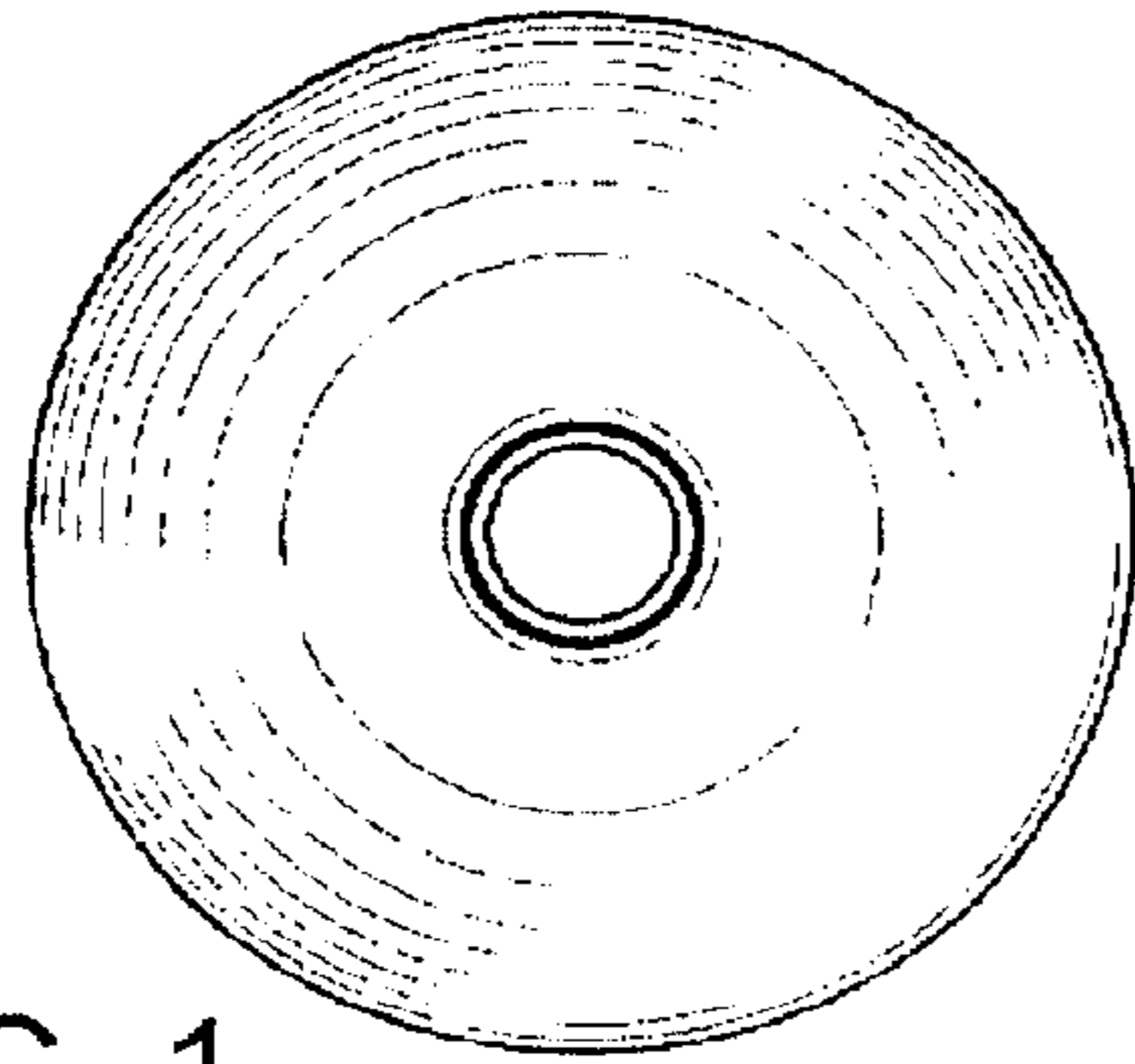

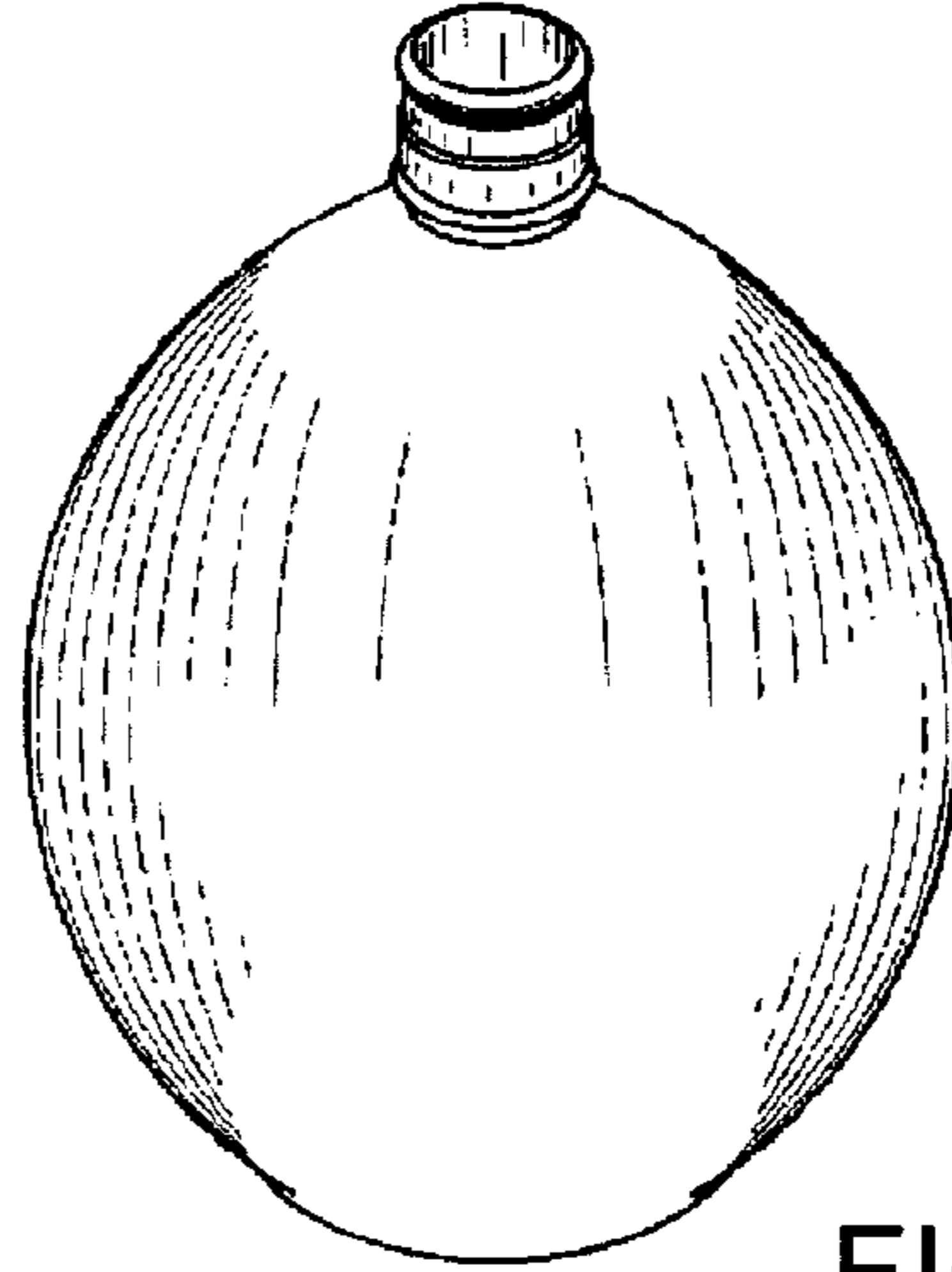

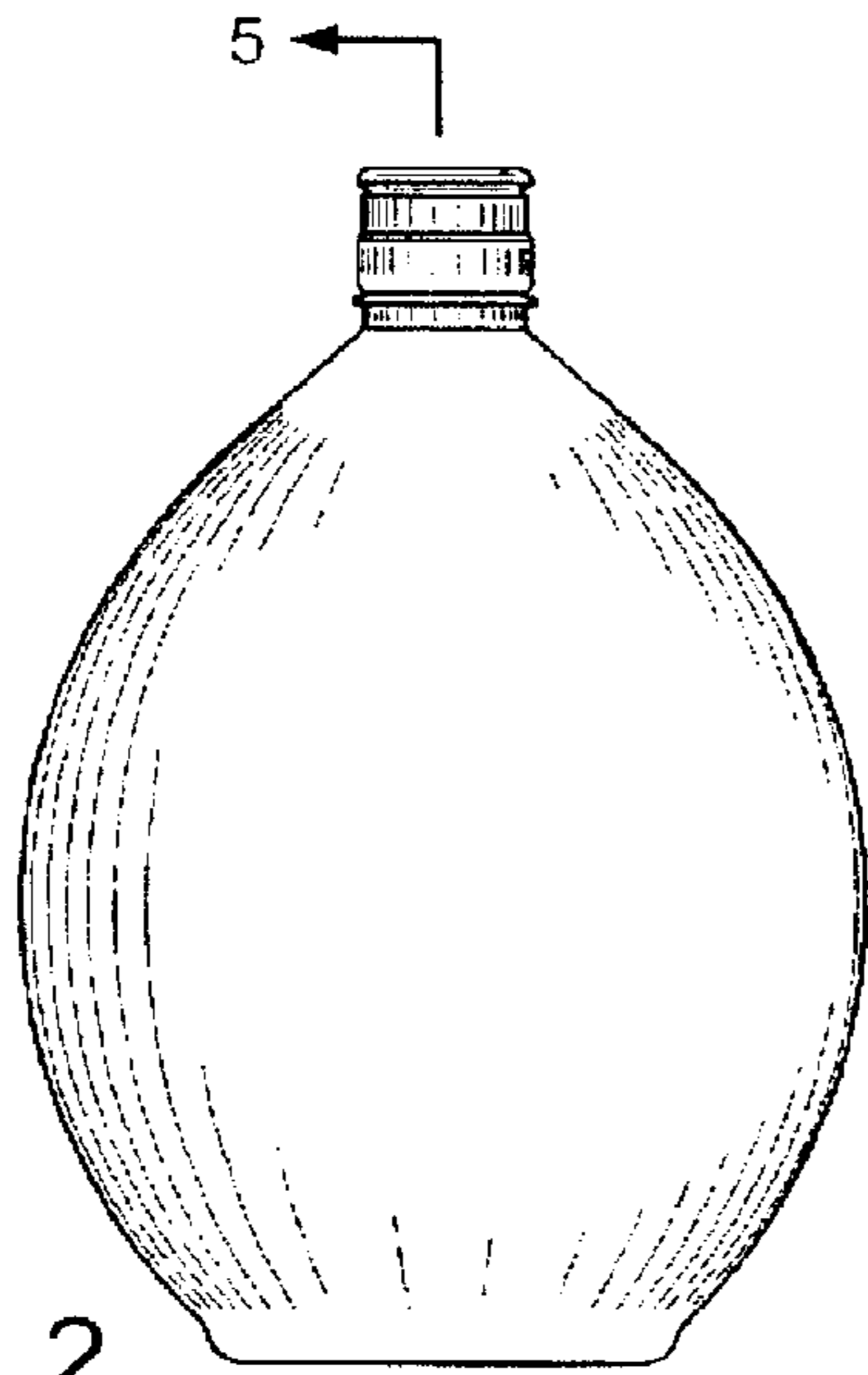

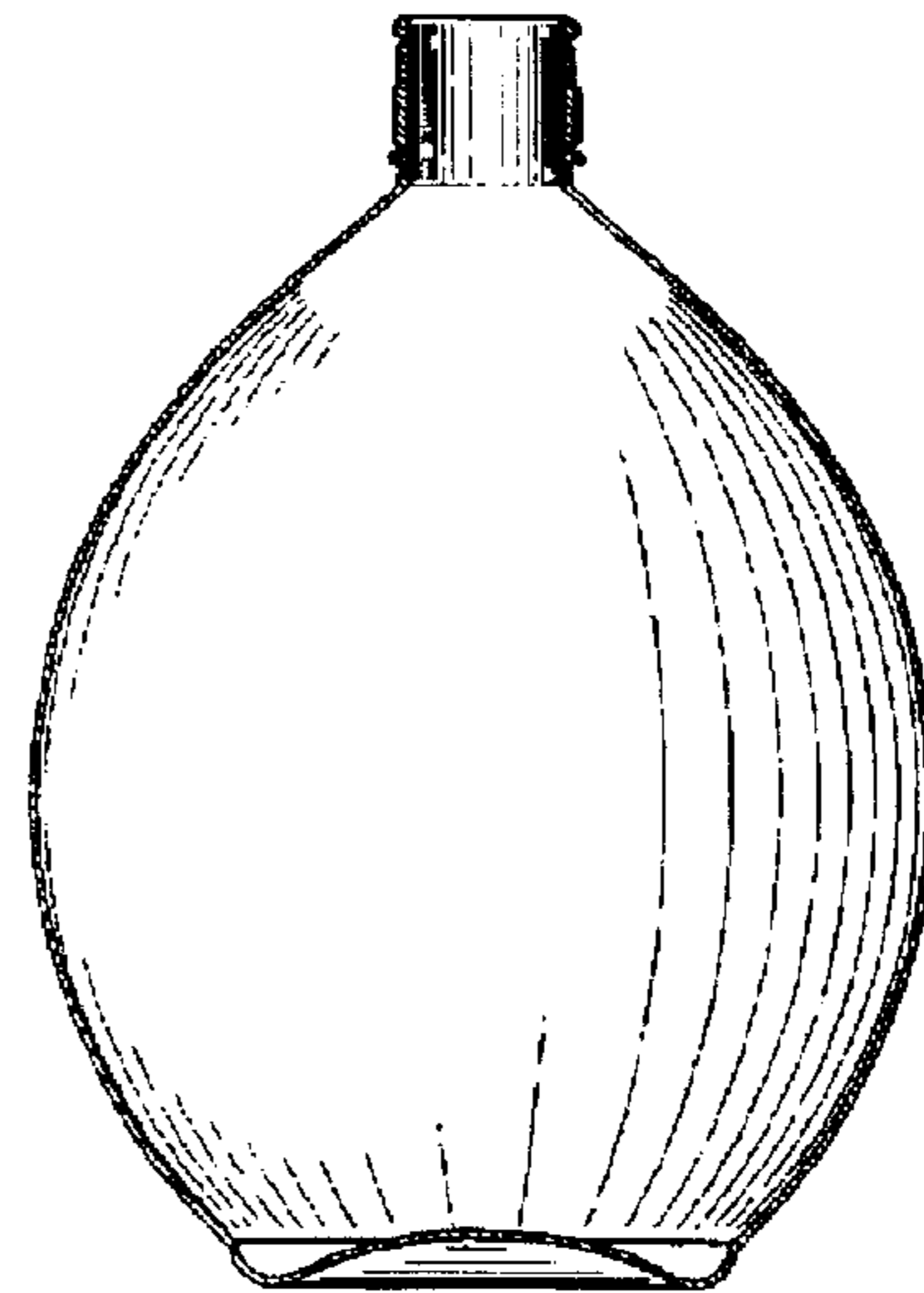

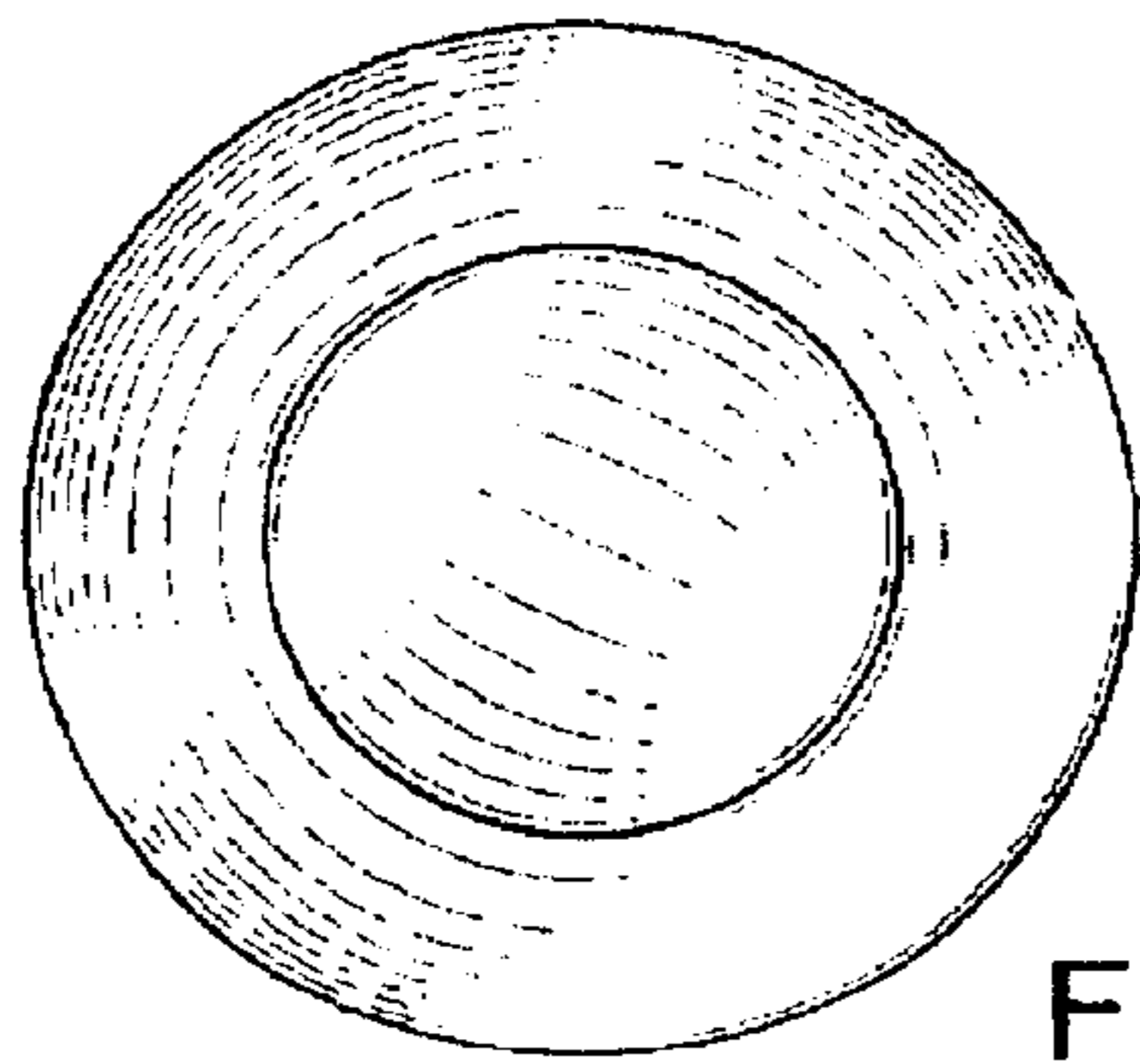
