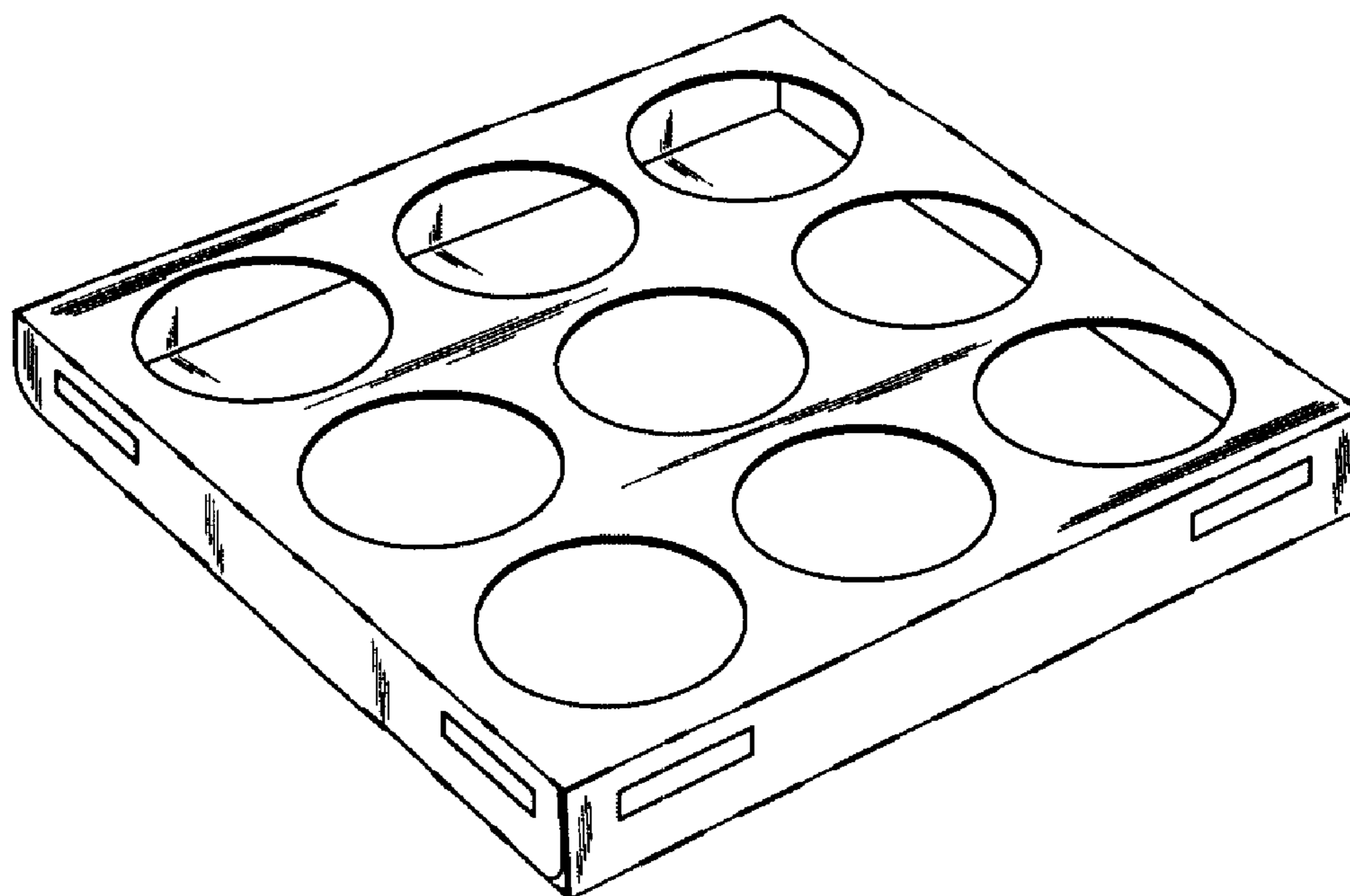
(57) **CLAIM**

The ornamental design for a muffin tray, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a muffin tray in assembled condition showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a side elevation view, the opposite side being a mirror image thereof;
FIG. 5 is an end elevation view, the opposite end being a mirror image thereof;
FIG. 6 is a side elevation view in collapsed condition, the opposite side being a mirror image thereof;
FIG. 7 is an end plan view, the opposite end being a mirror image thereof;
FIG. 8 is a top plan view thereof;
FIG. 9 is a bottom plan view thereof; and,
FIG. 10 is a plan view in unassembled condition.

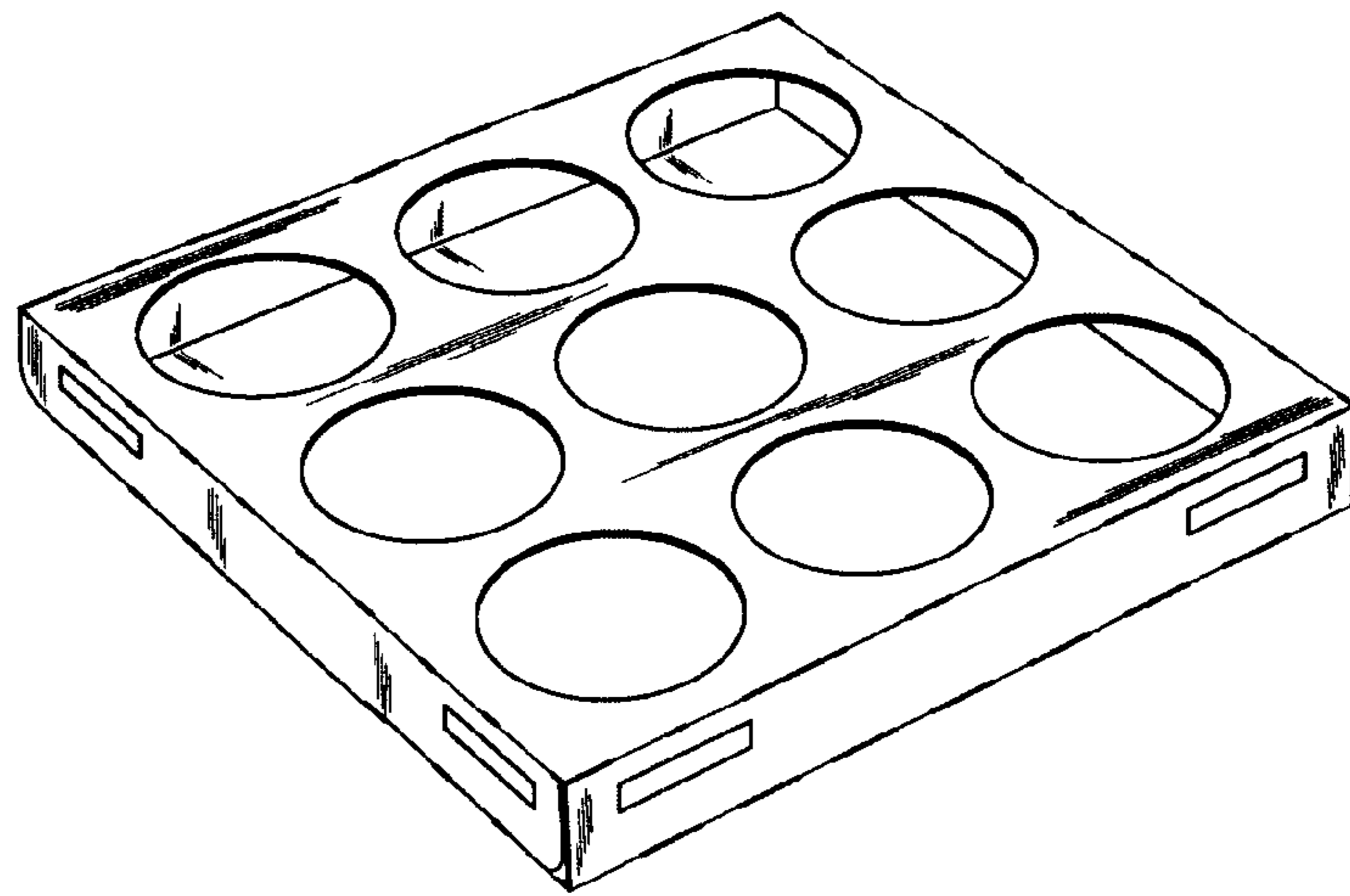

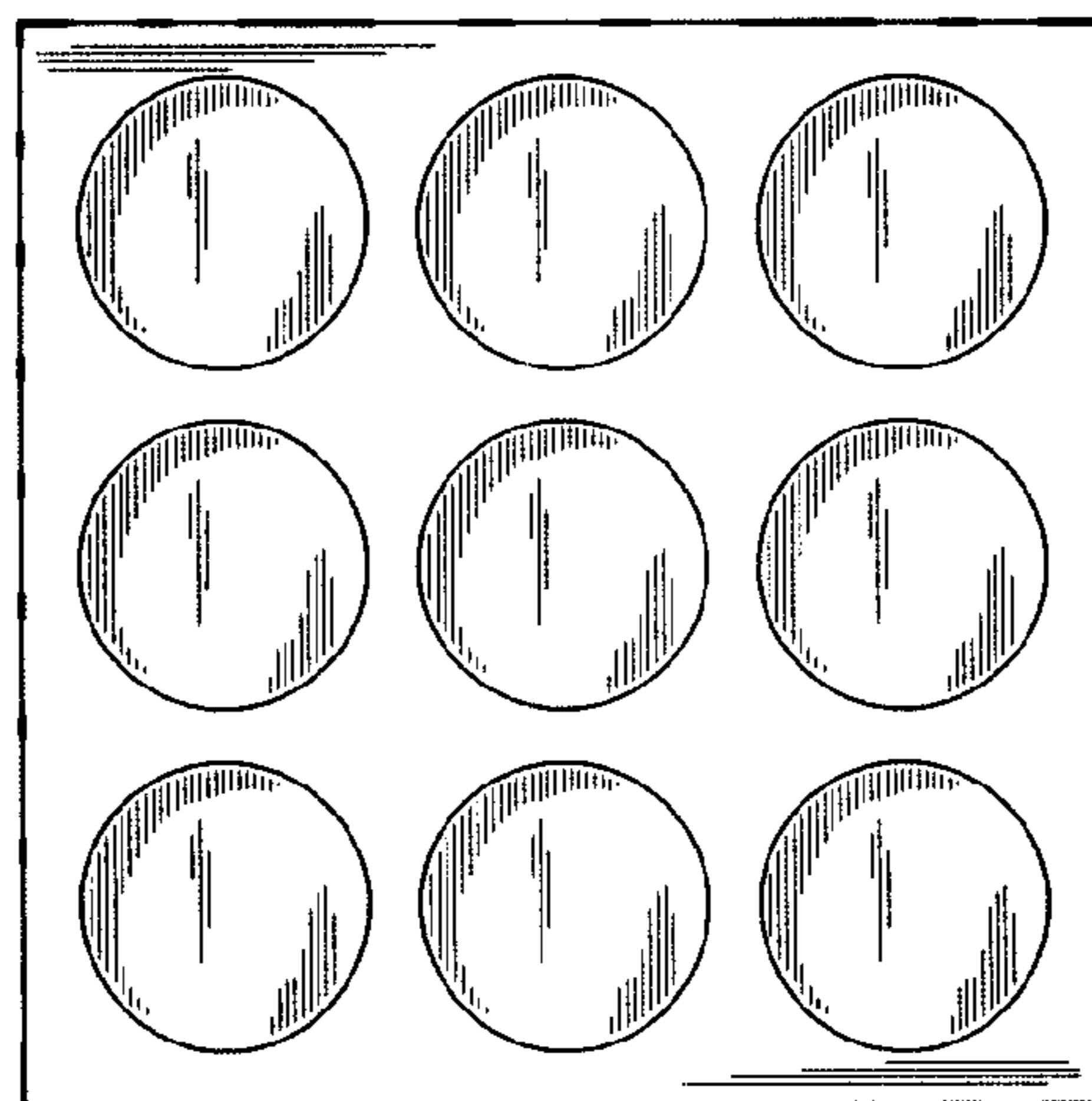

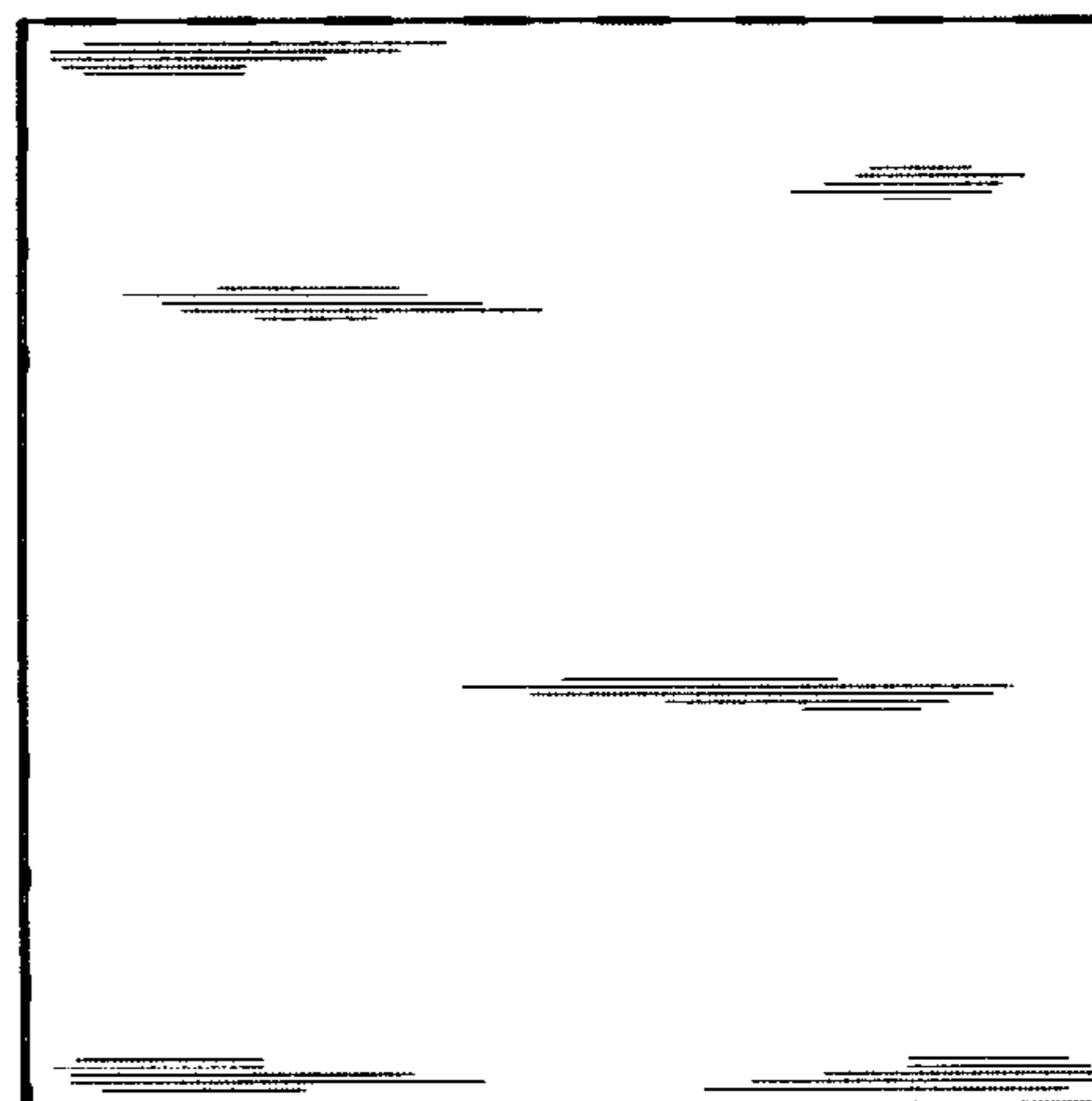

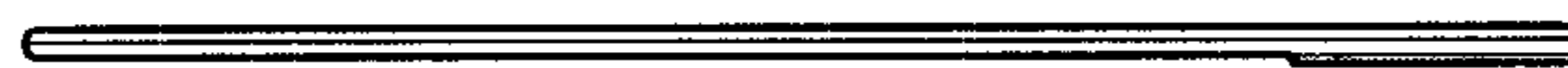

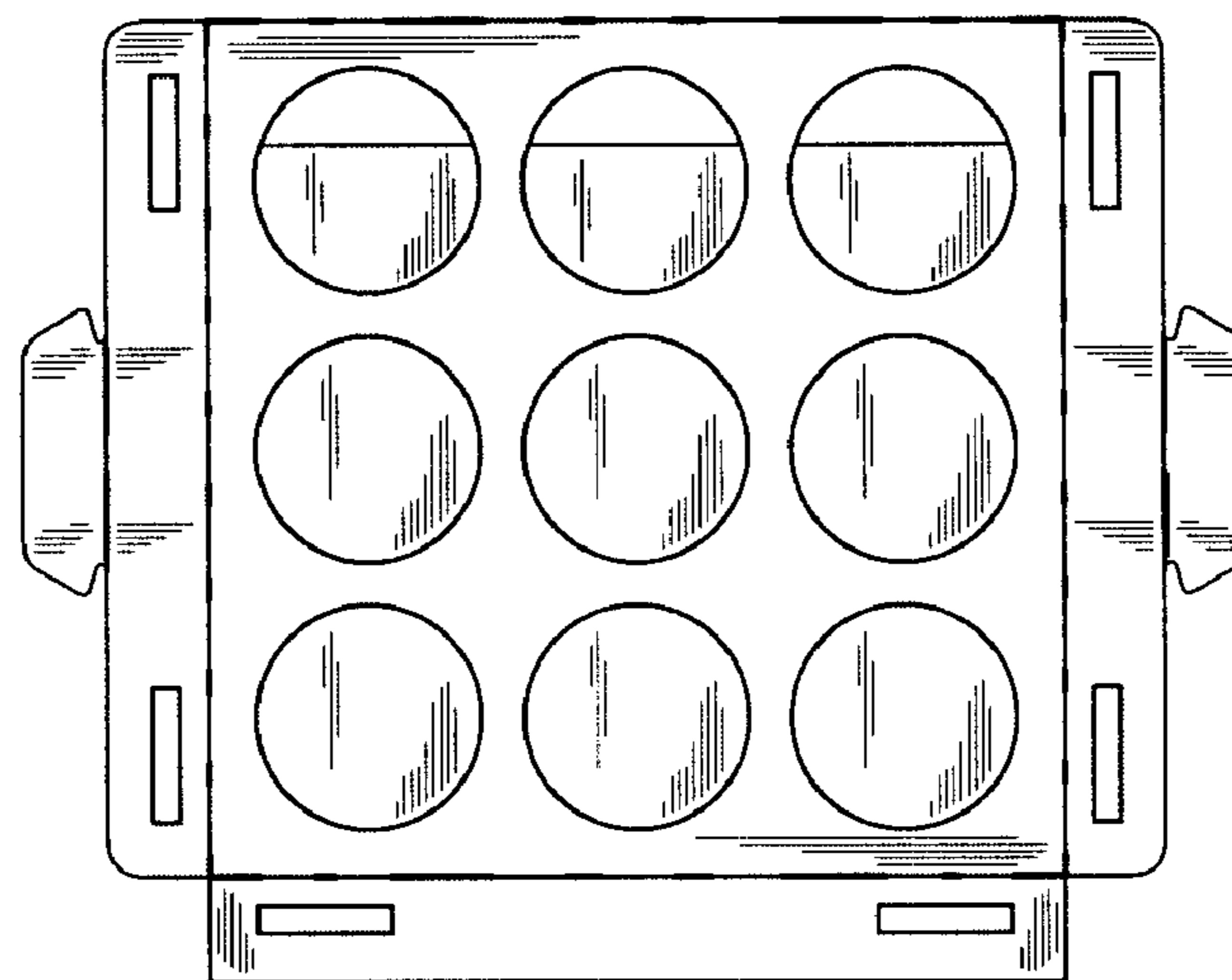

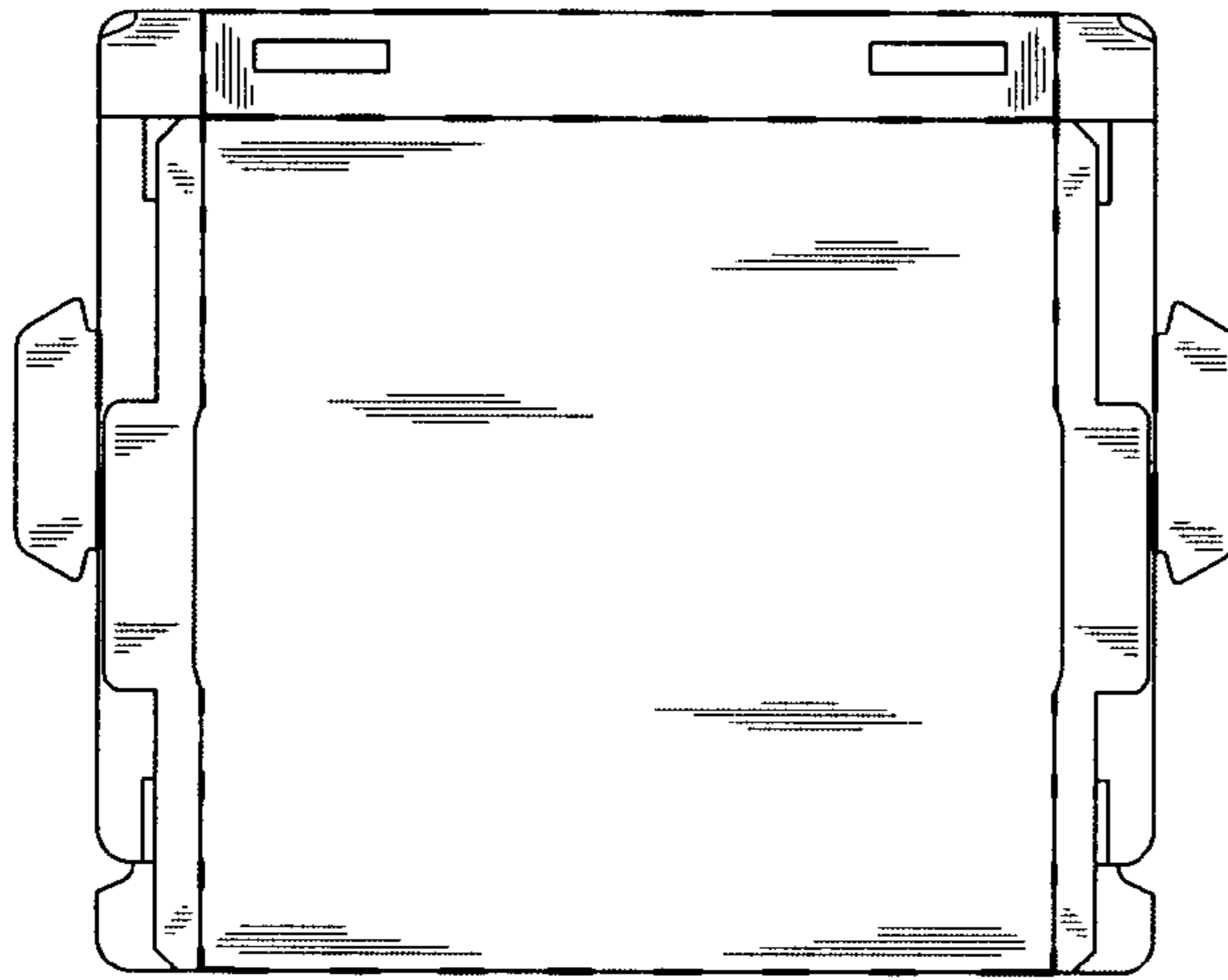

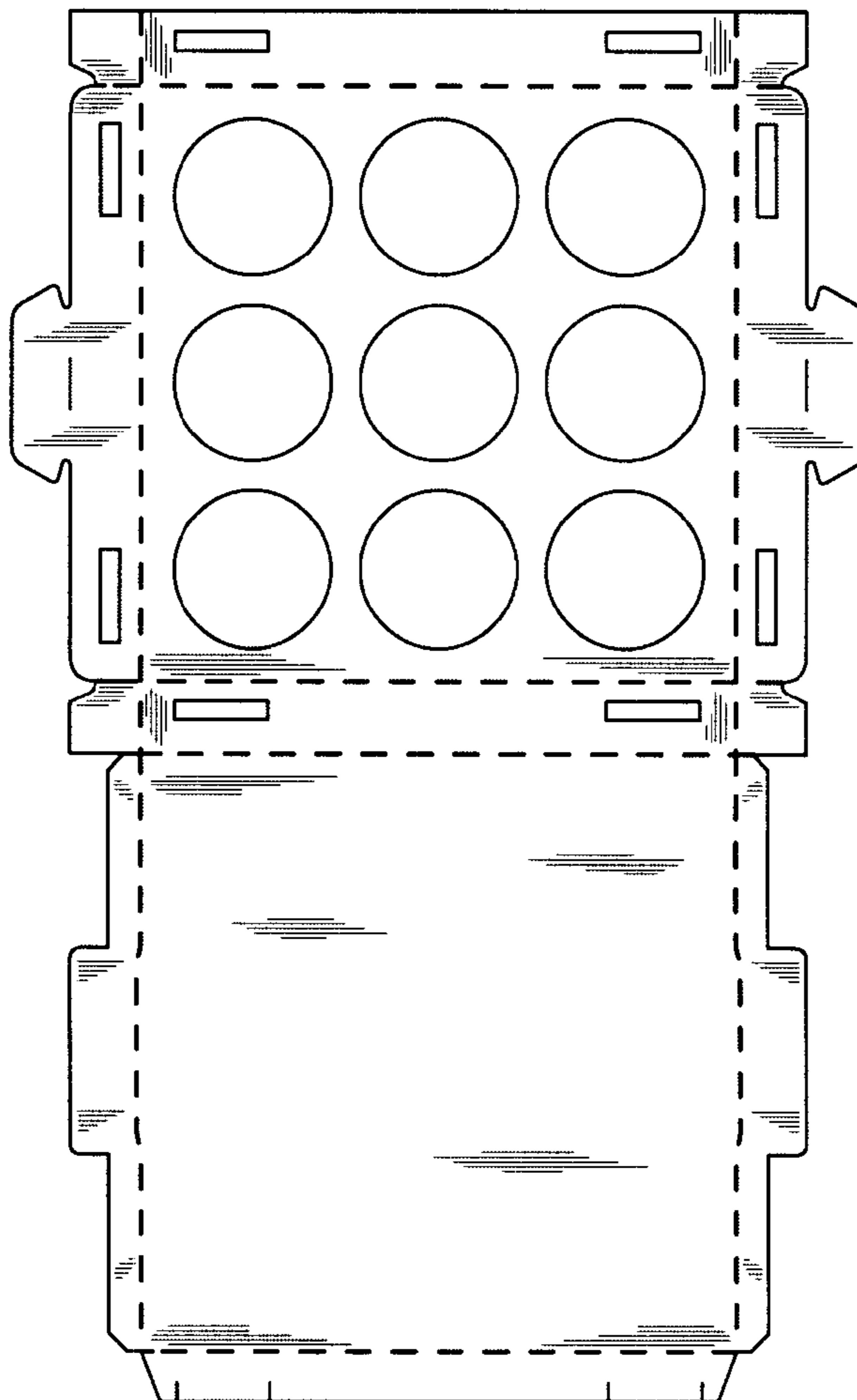
