(57) **CLAIM**

An ornamental design for the player tracking display vertical mount, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of our player tracking display vertical mount showing our new design. A portion of the electronic gaming device, pair of speaker grills, and player-card slot is shown in dashed lines, and are not part of the claimed design;

FIG. 2 is a front elevational view of the view thereof;

FIG. 3 is a front elevational view of the view thereof;

FIG. 4 is a side view elevation of the view FIG. 1;

FIG. 5 is a back elevational view of the view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view of the view thereof;

FIG. 8 is an enlarged partial view of the indicia of FIG. 1 depicting a welcome screen, shown separately for ease of illustration;

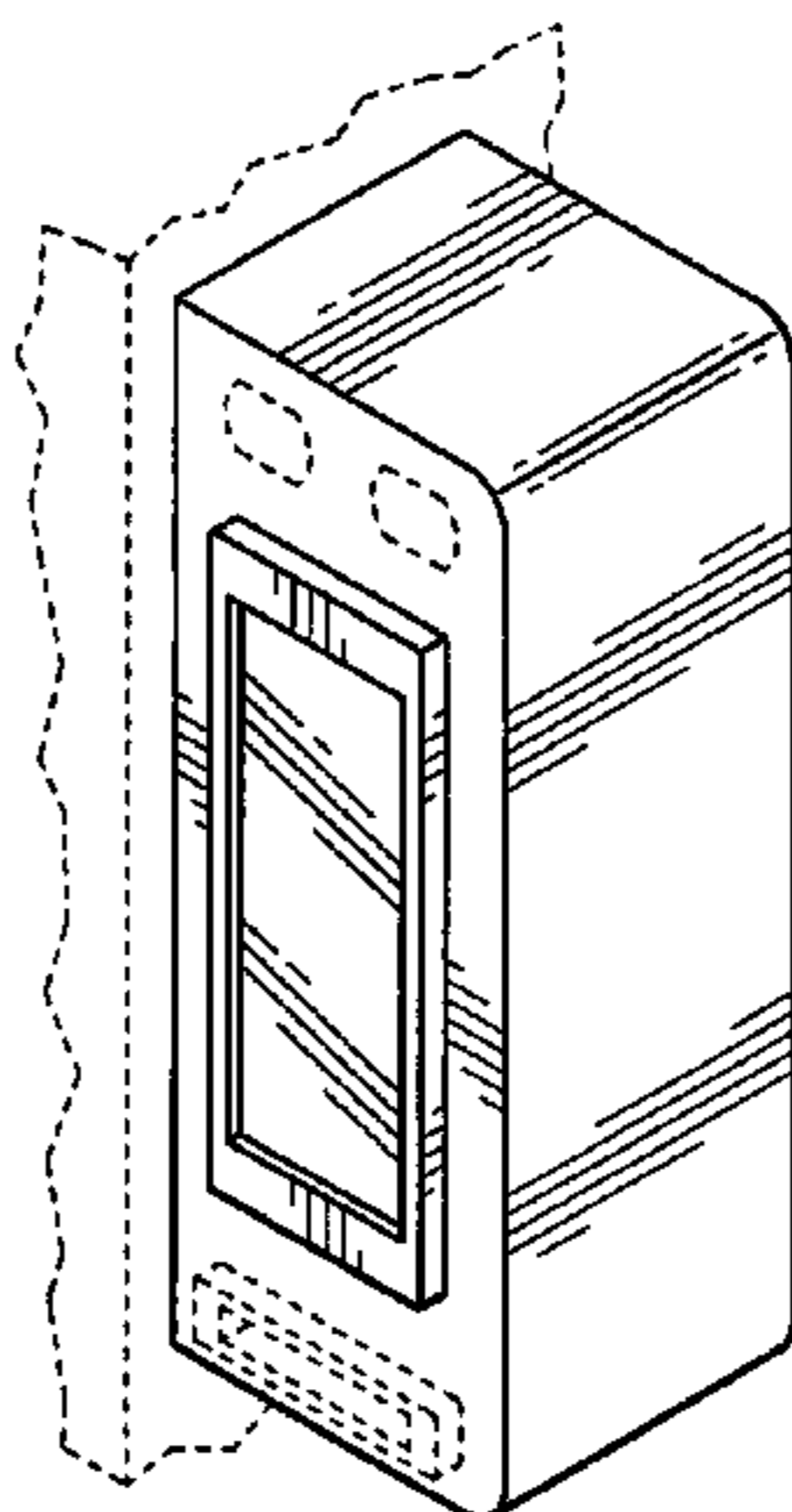
FIG. 9 is an enlarged partial view of the indicia of FIG. 1 depicting a display for entering a personal identification number (PIN);

FIG. 10 is an enlarged partial view of the indicia of FIG. 1 depicting a display for communicating Return Play ® awards; and,

FIG. 11 is an enlarged partial view of the indicia of FIG. 1 depicting the touch screen.

The Return Play indicia forming part of the claimed design is a registered trademark of IGT Corporation.

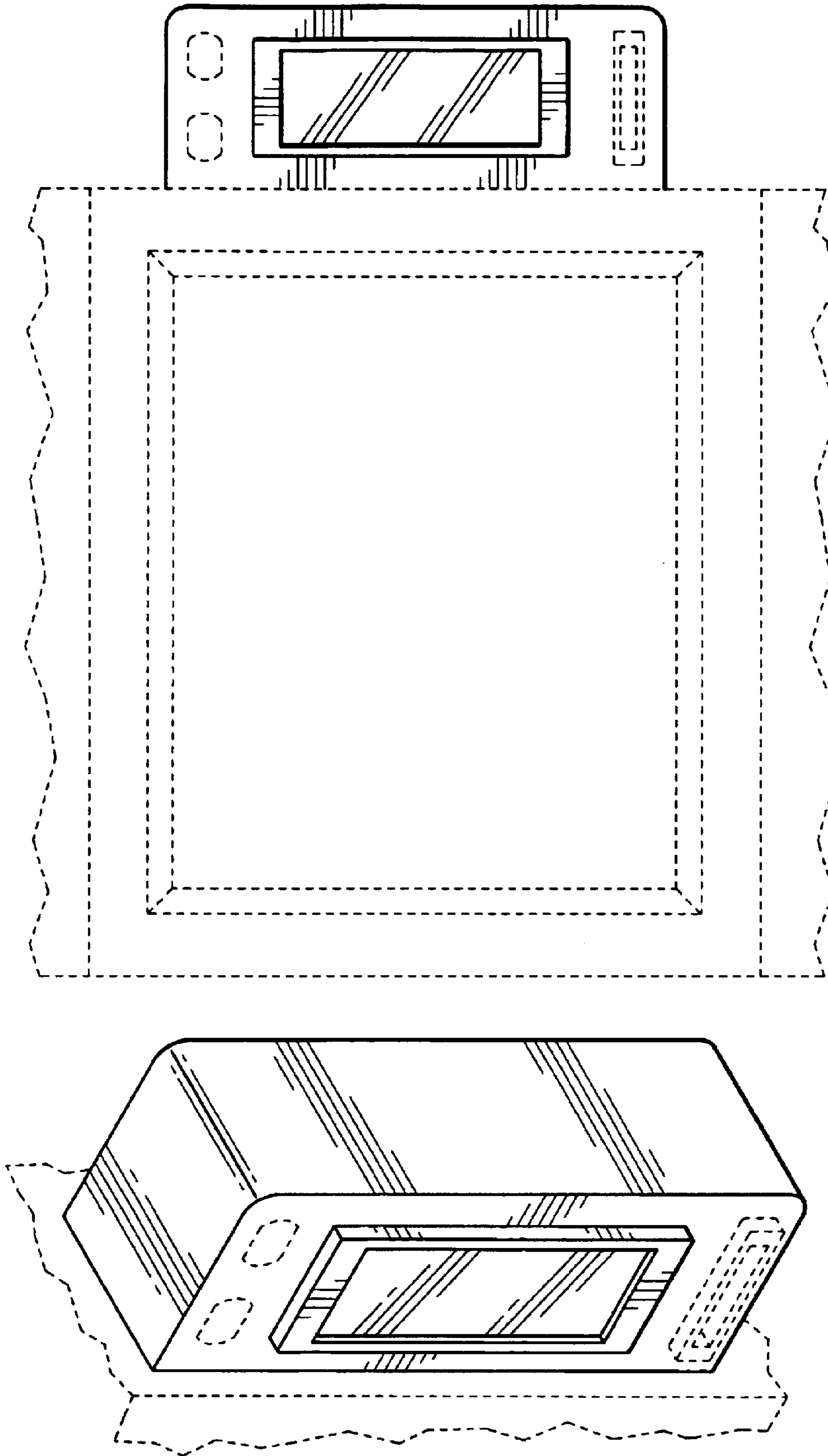
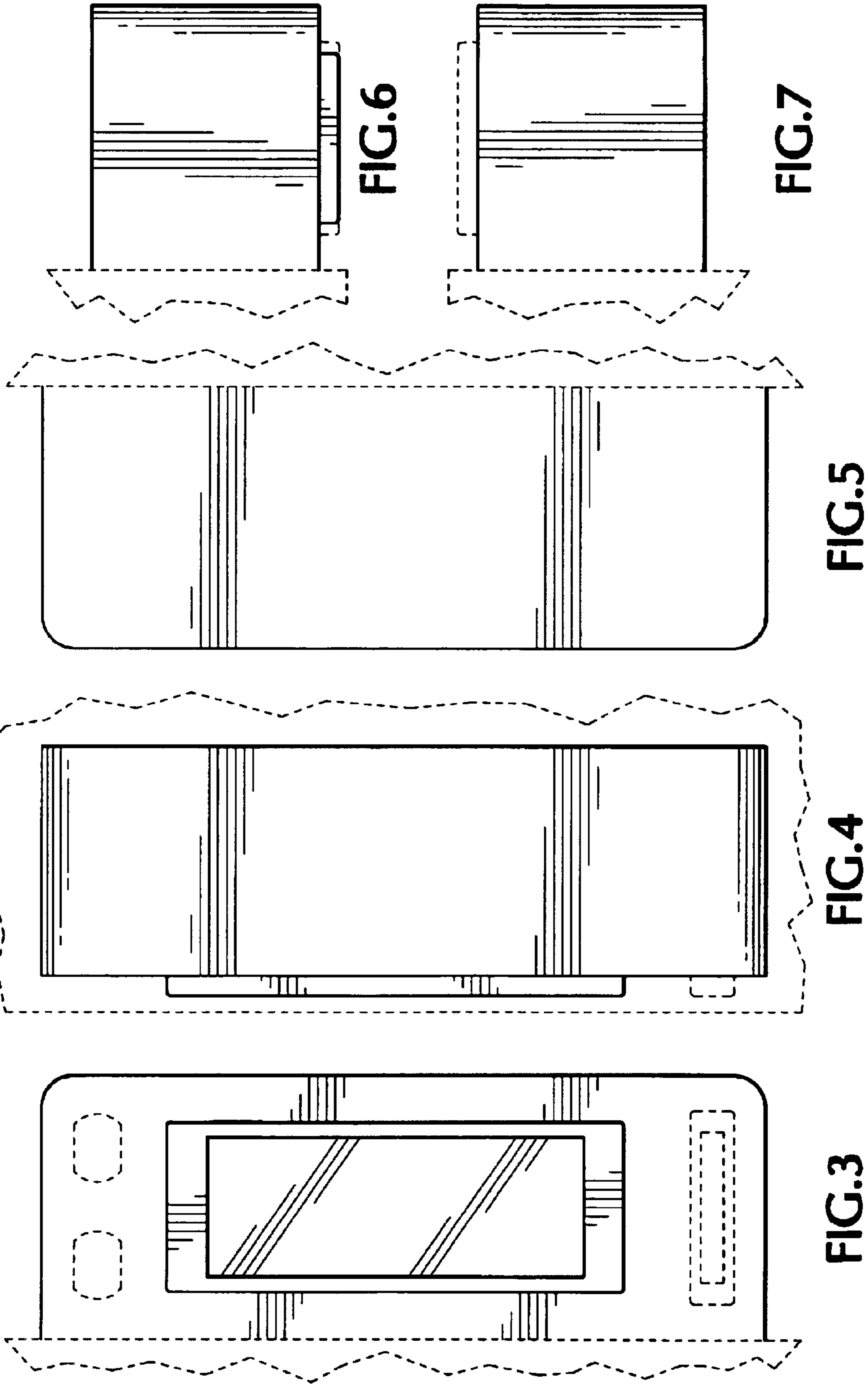

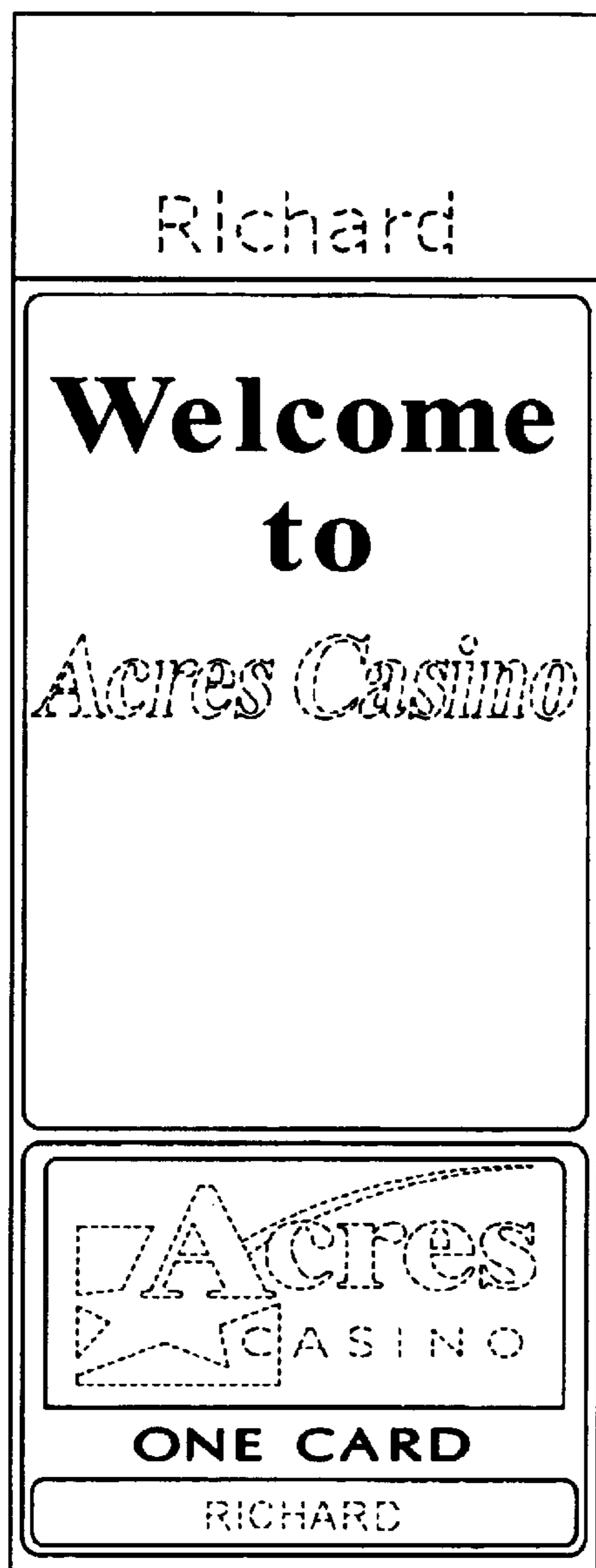

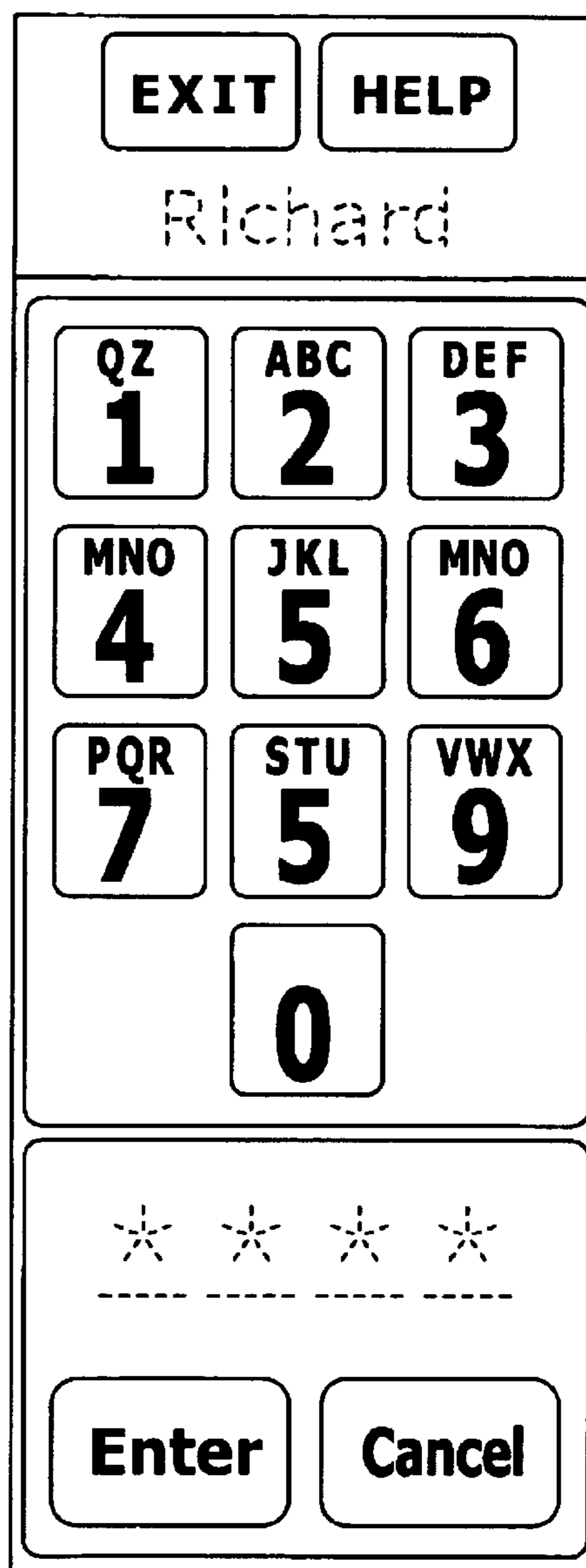

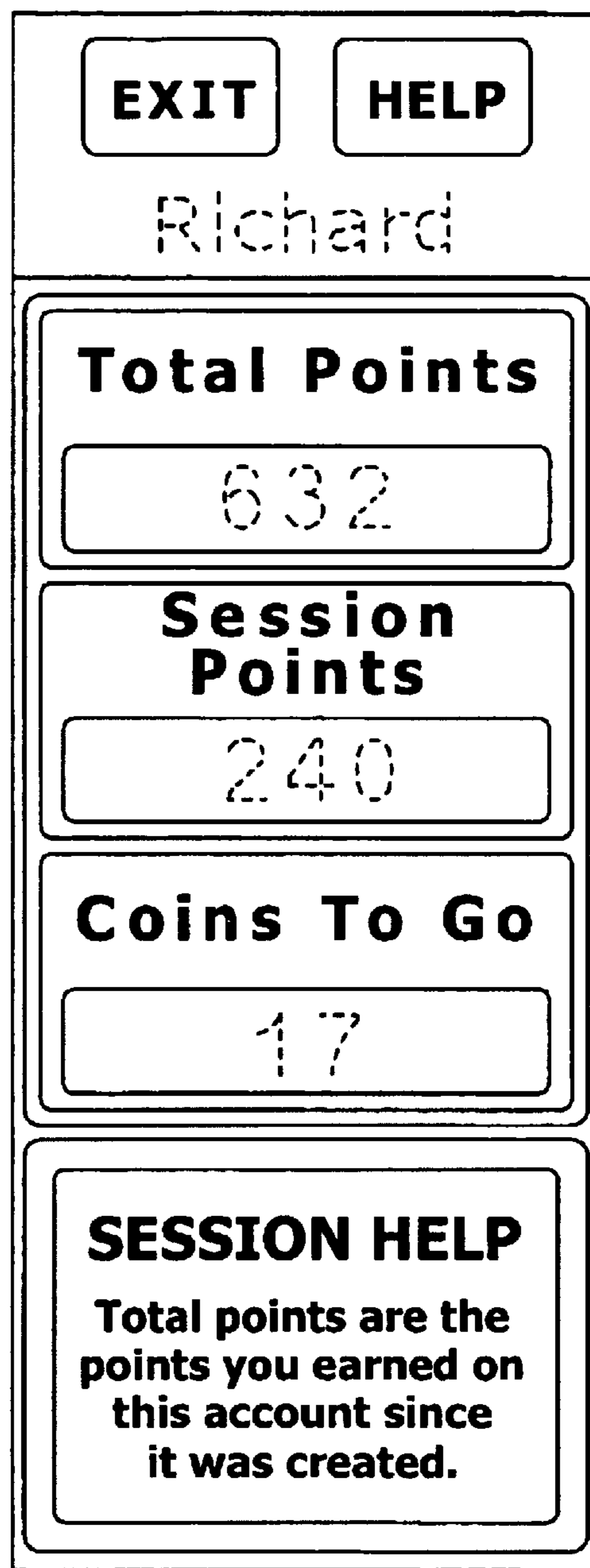
