FIG. 3 is a rear view of the cabinet;

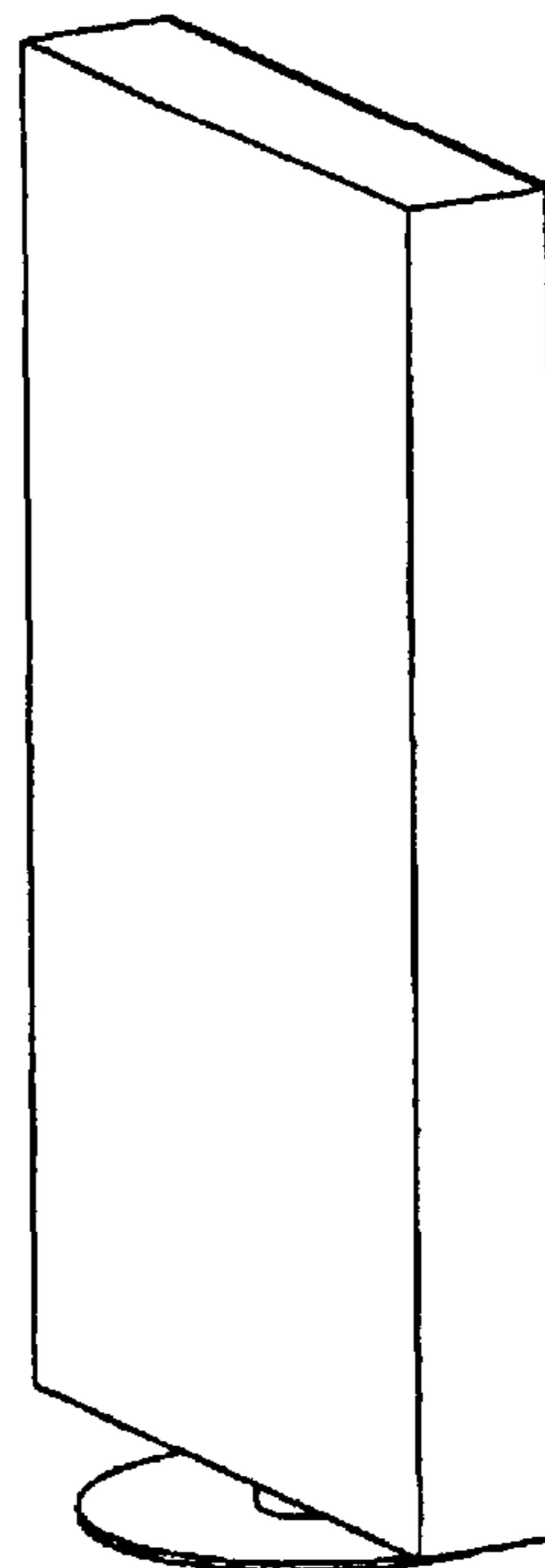
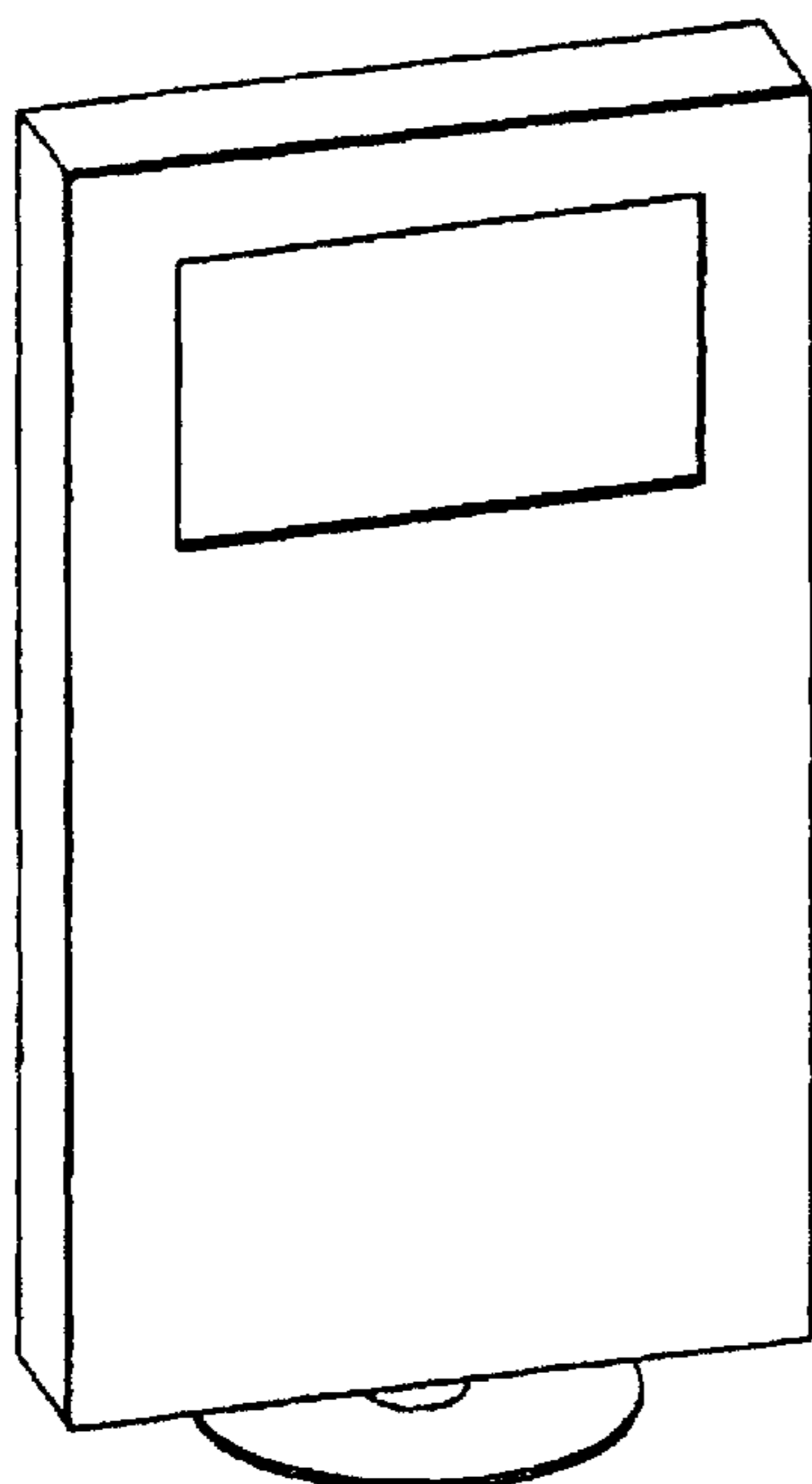
FIG. 4 is a bottom view of the cabinet;

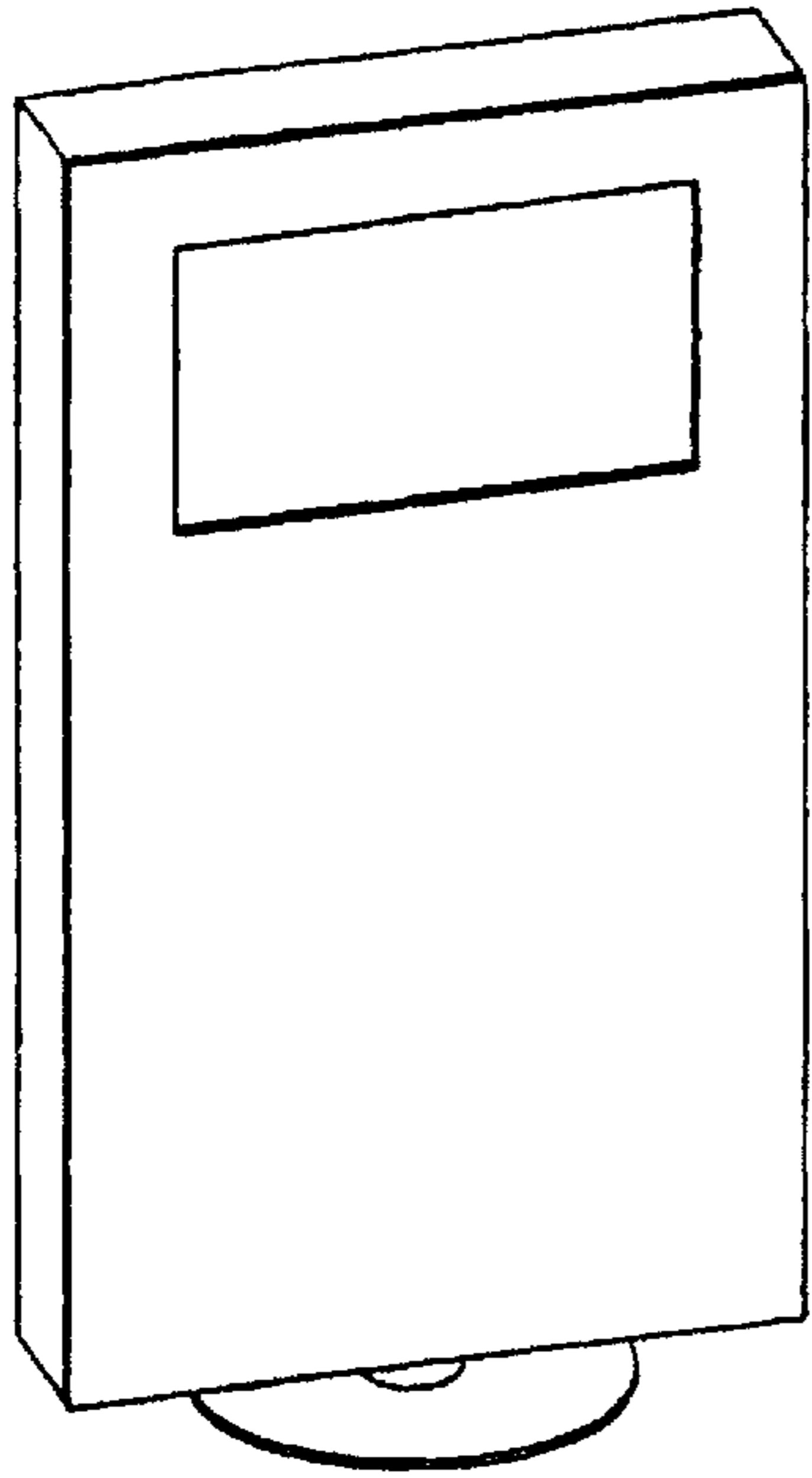

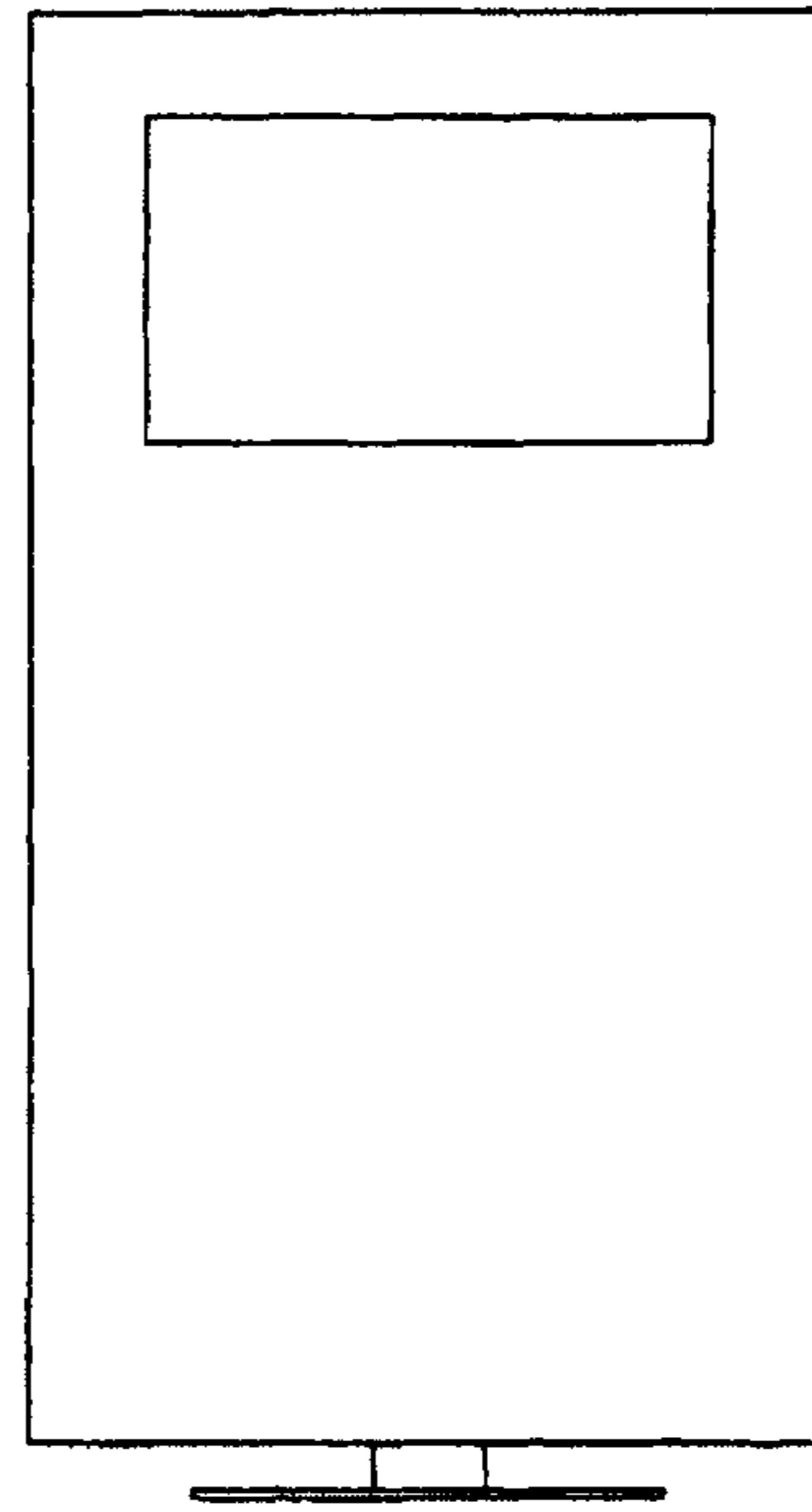

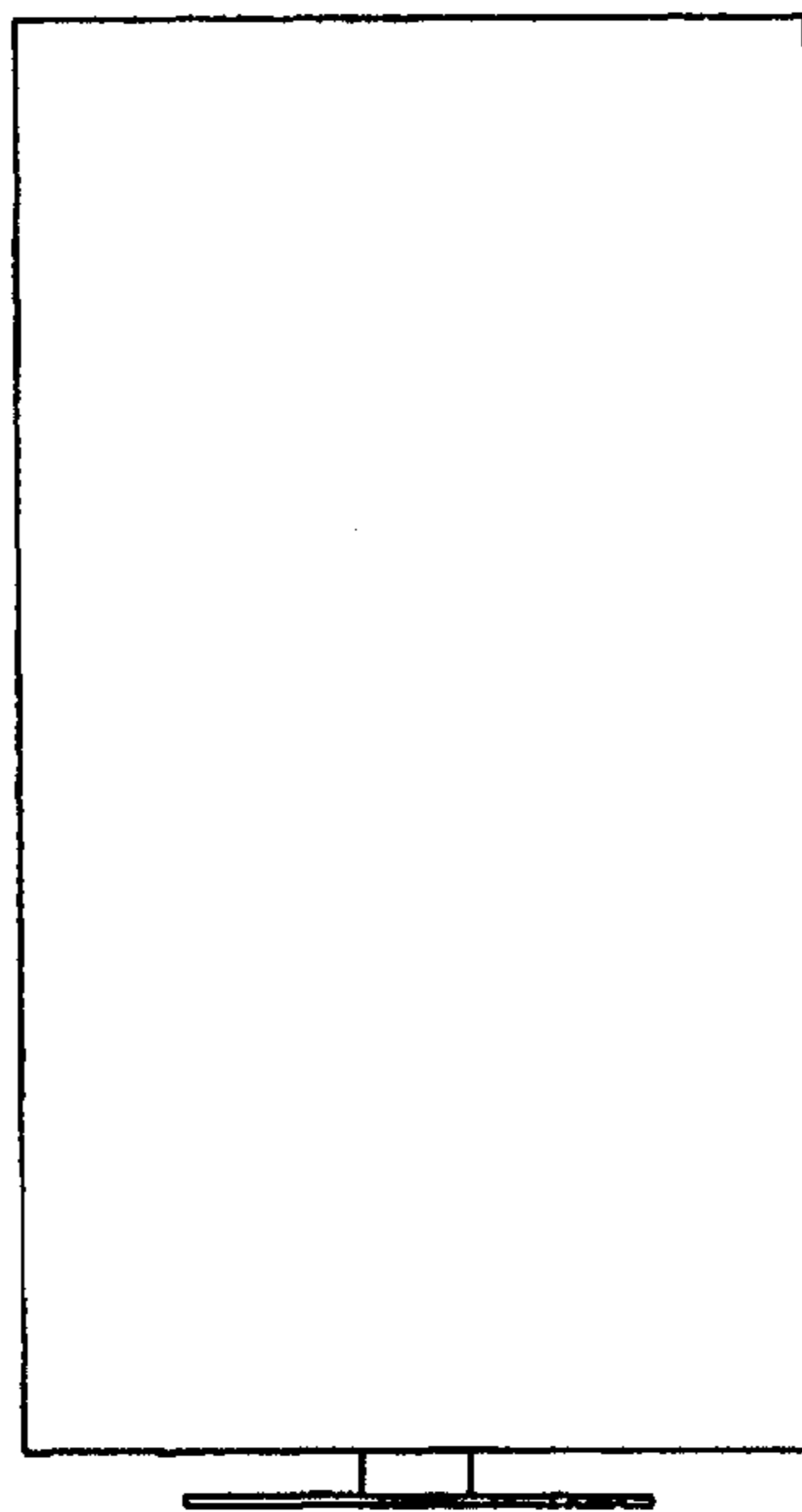

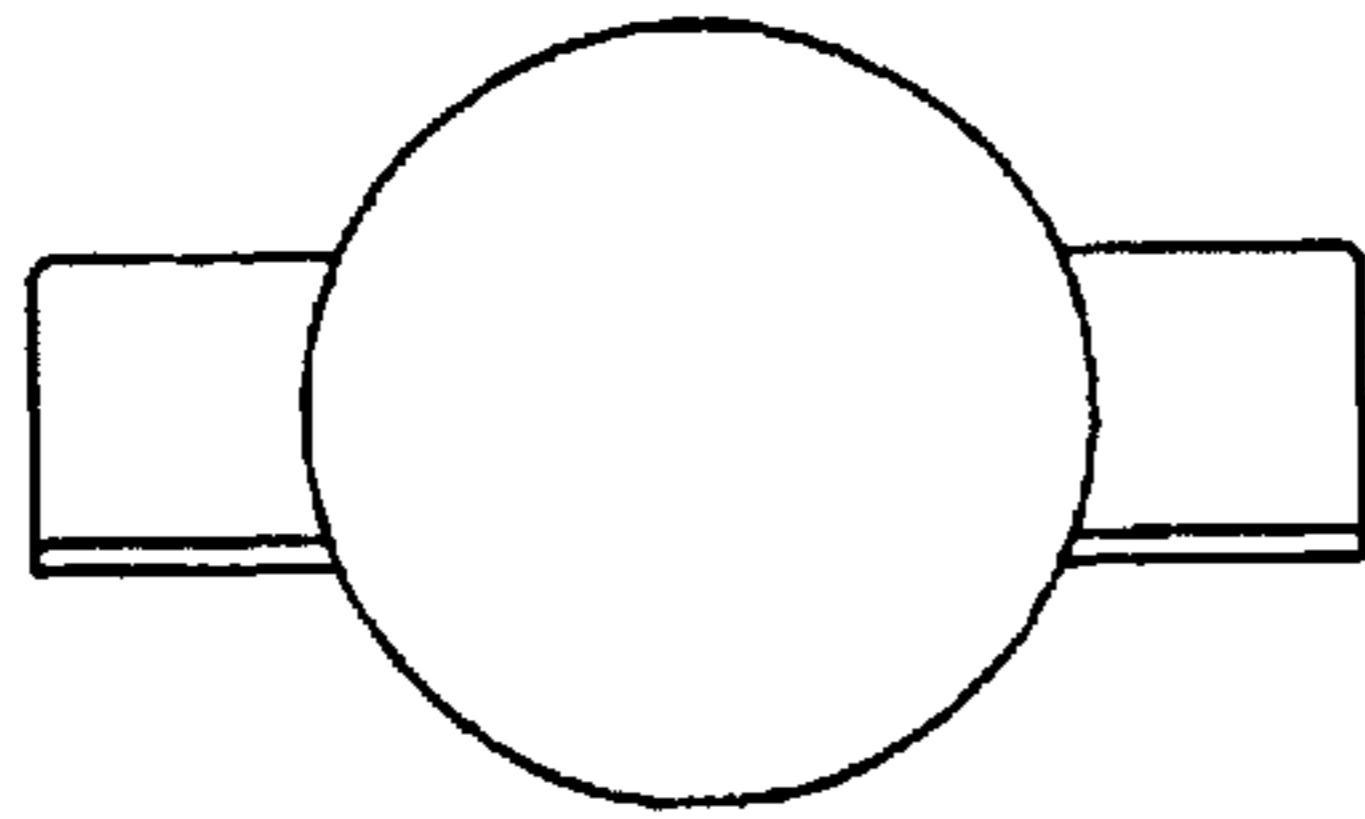

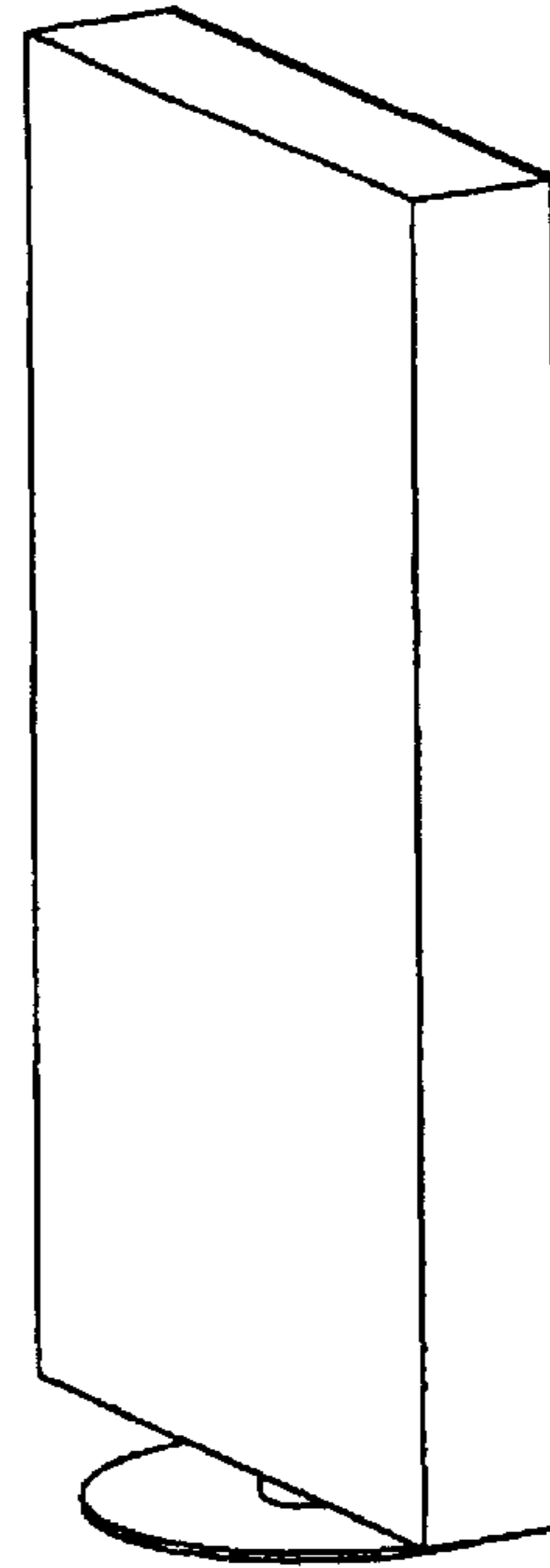

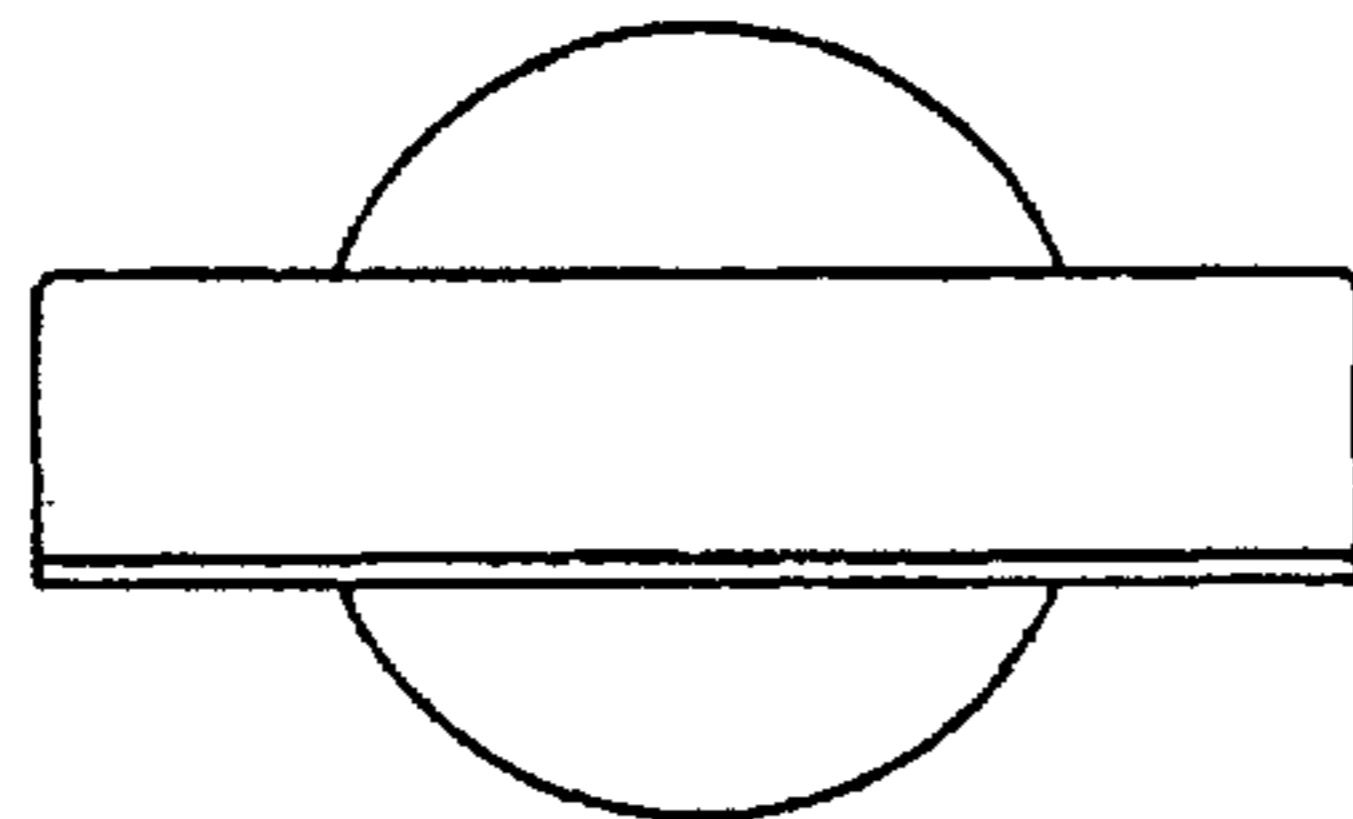

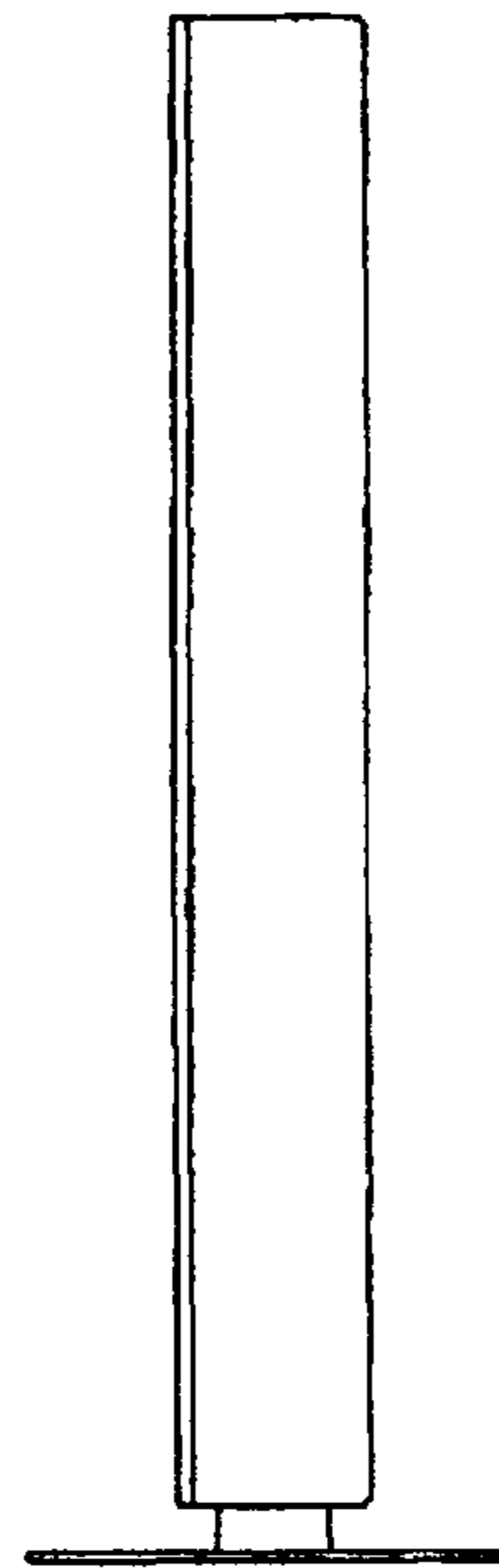
