(57) **CLAIM**

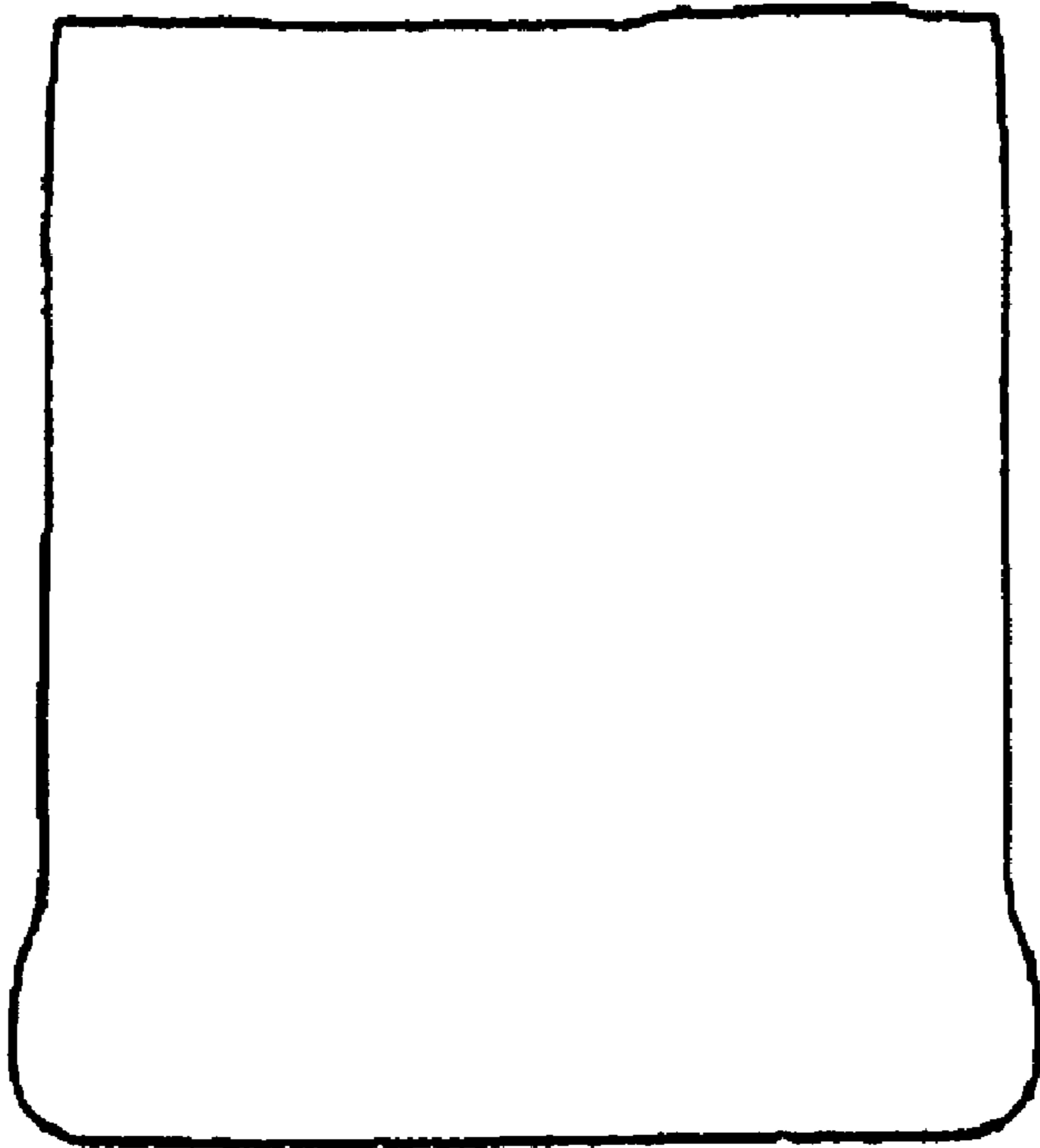
The ornamental design for a chocolate cup, as shown.

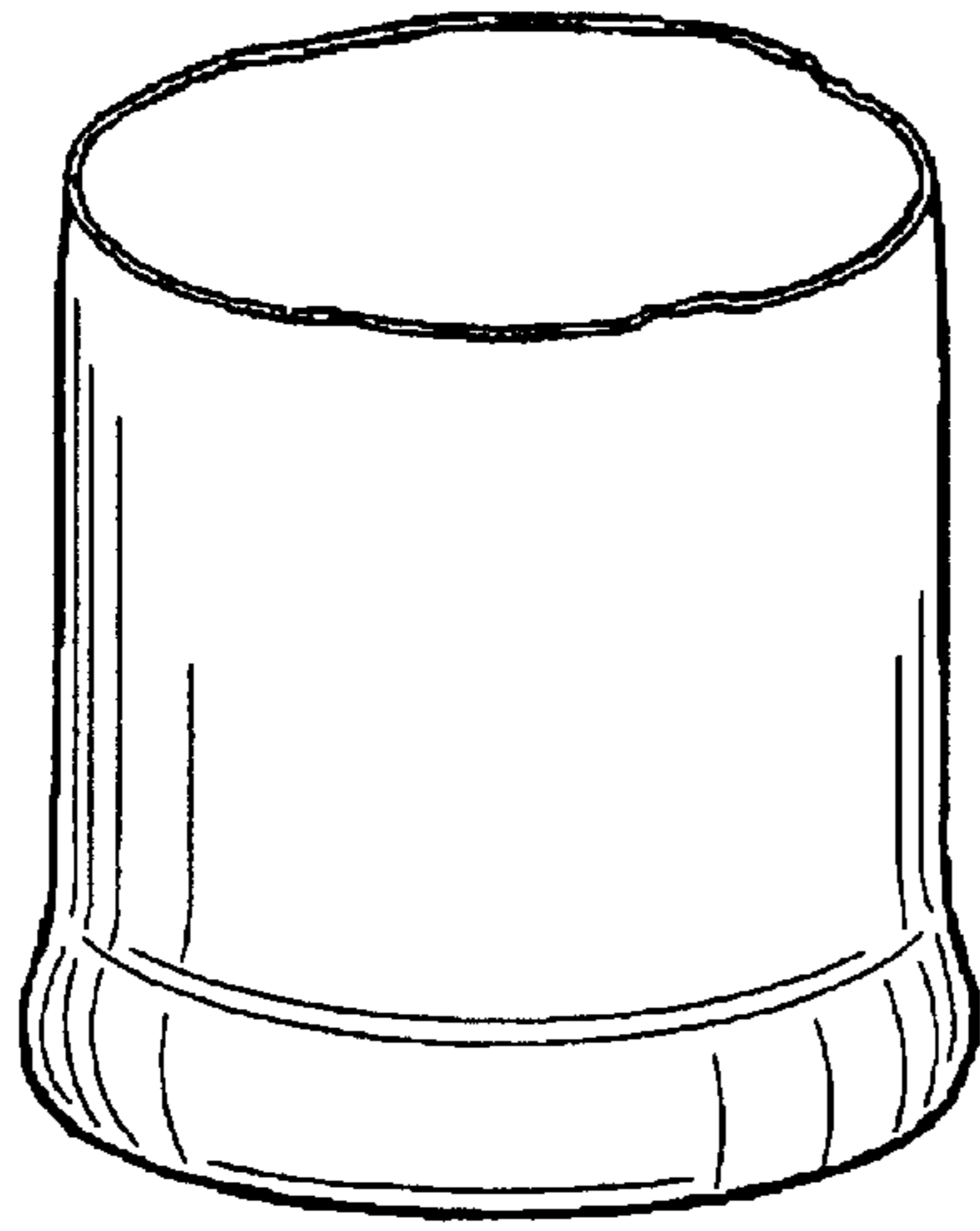

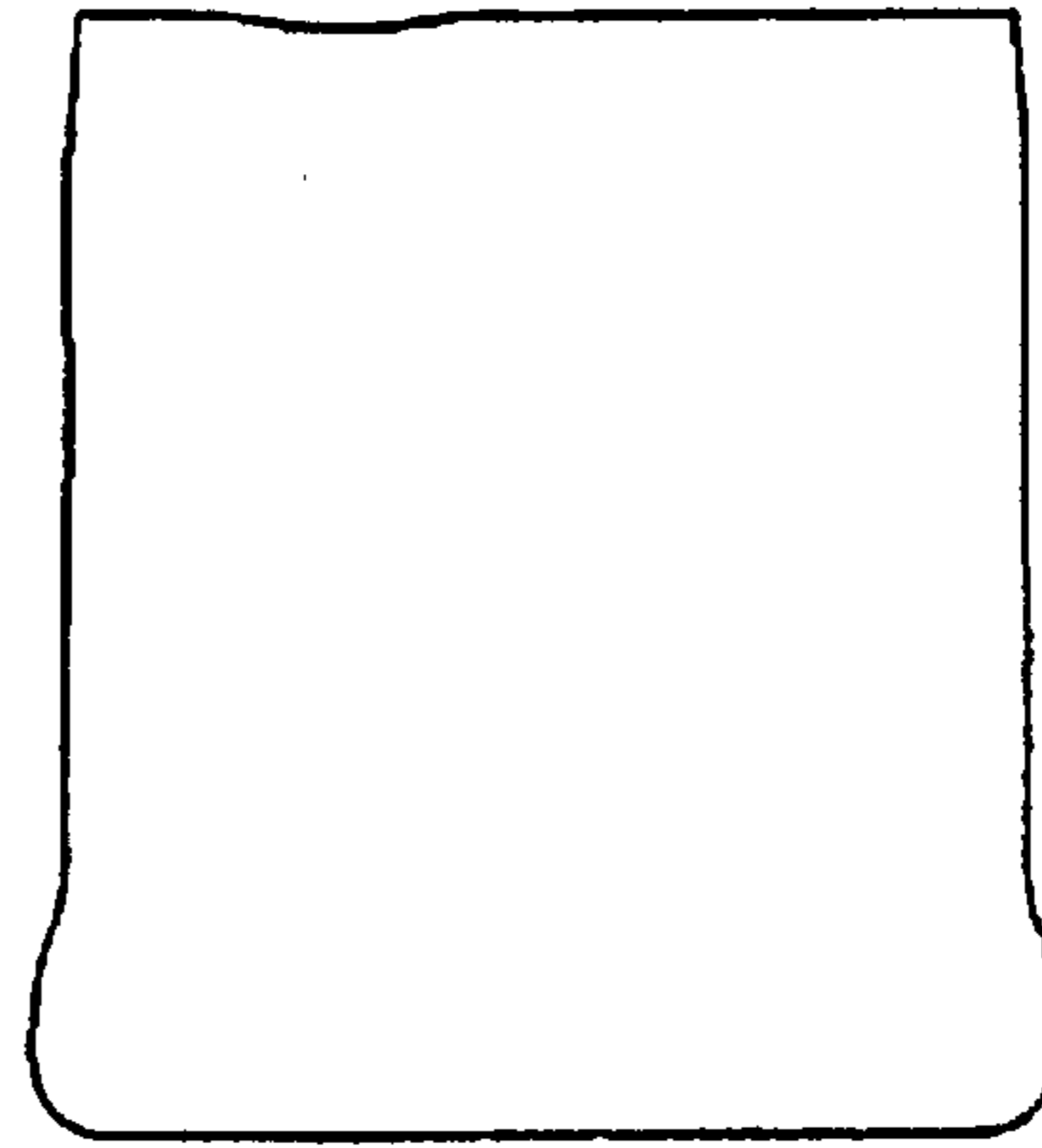

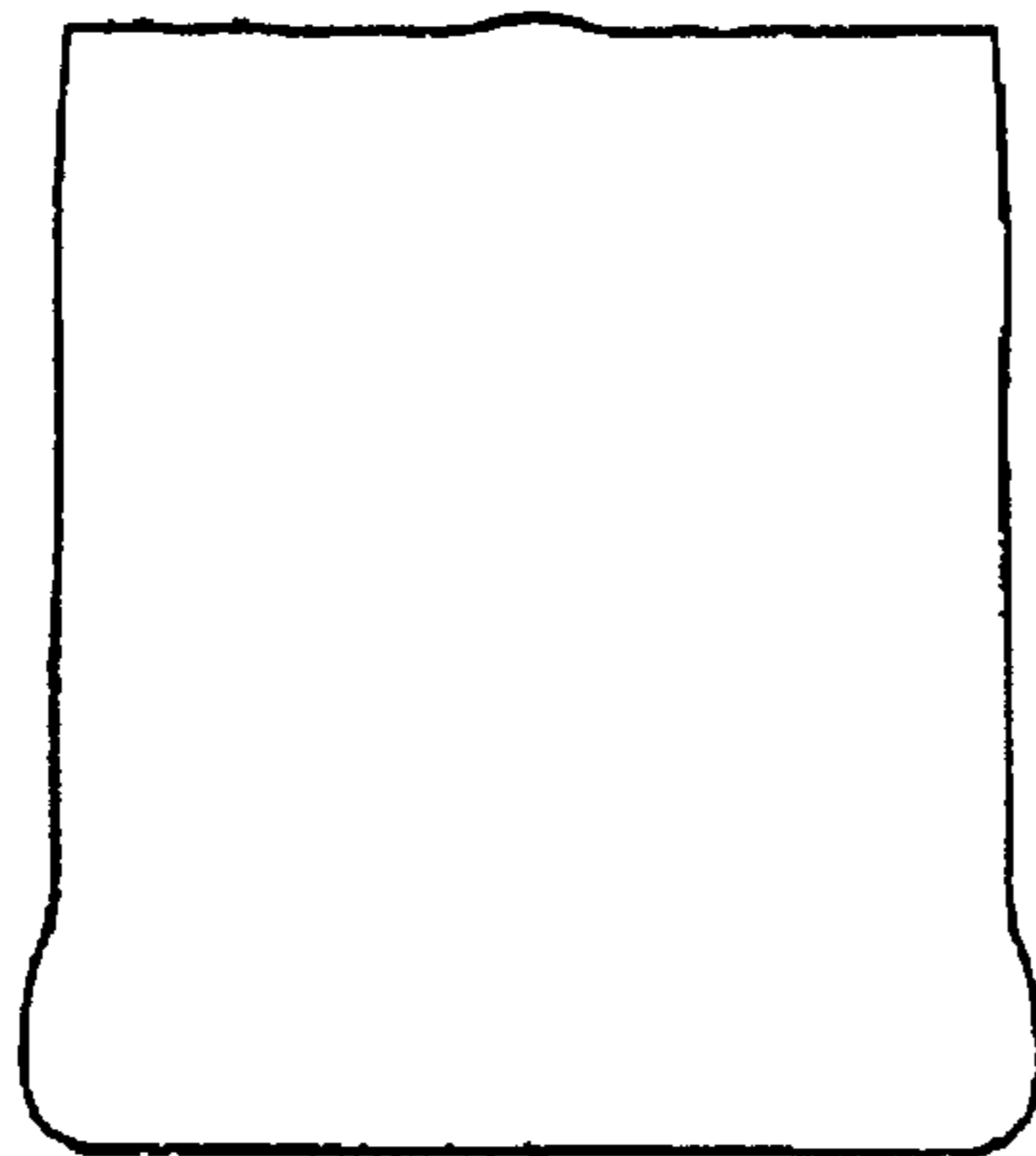

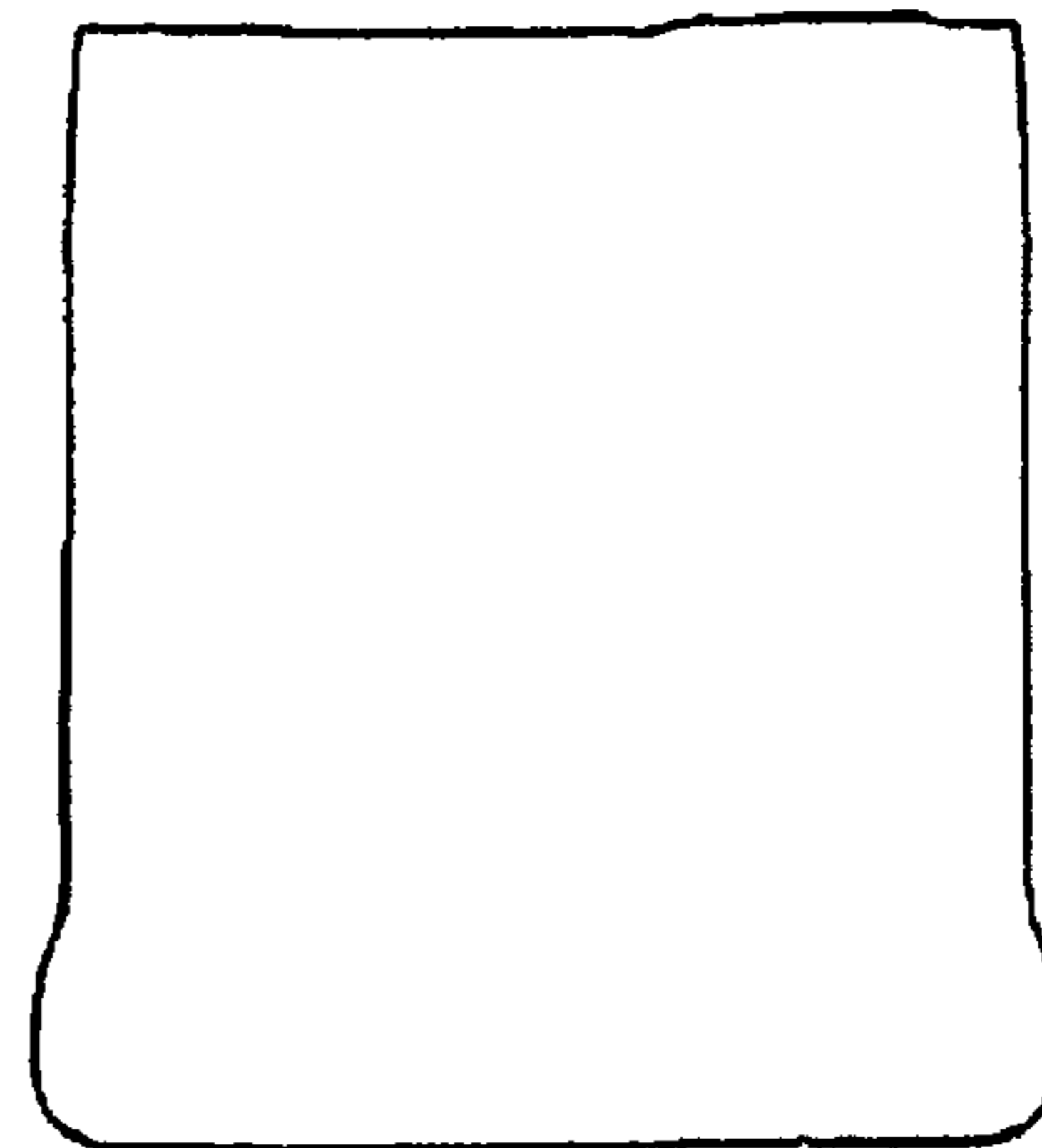

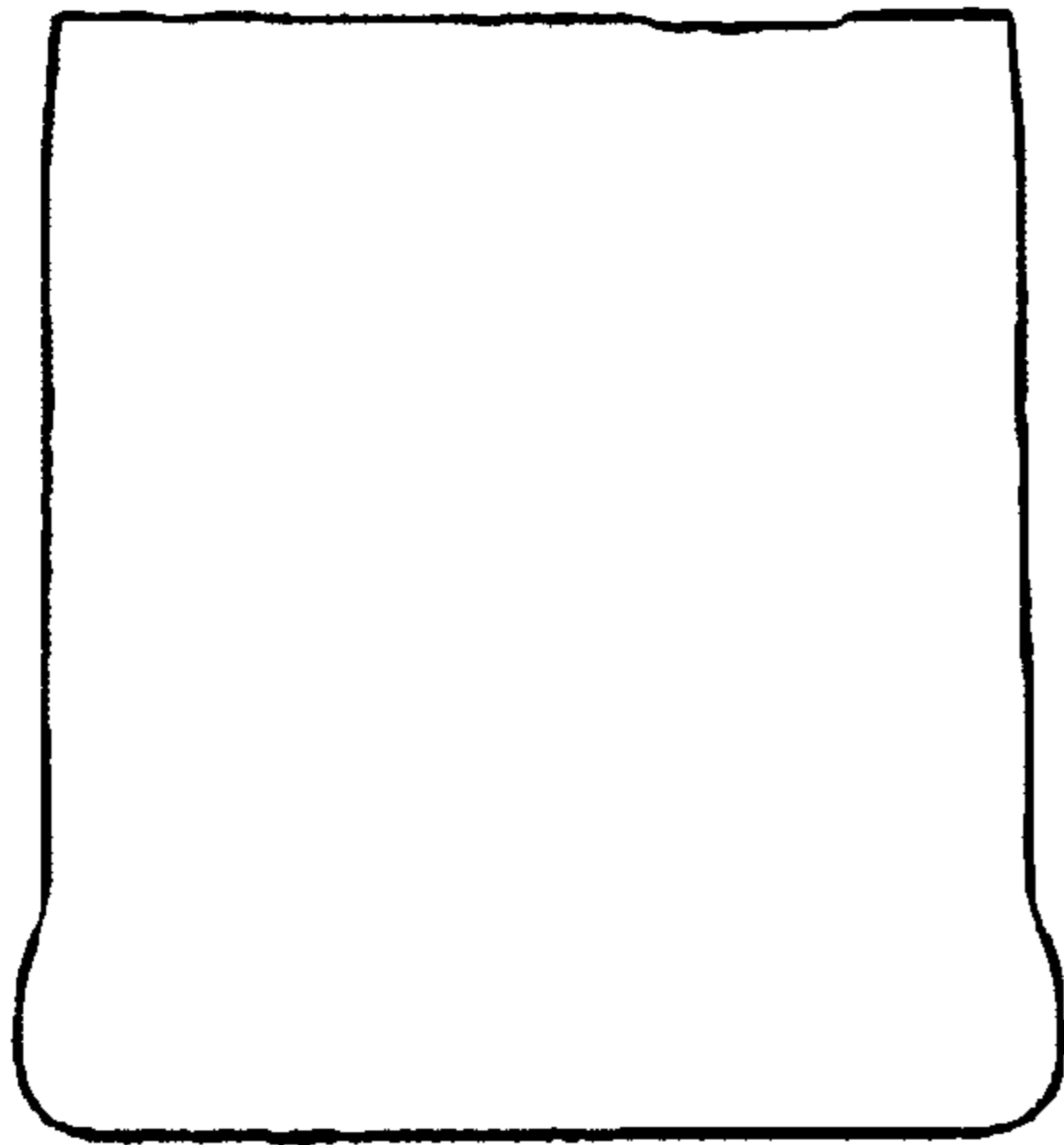

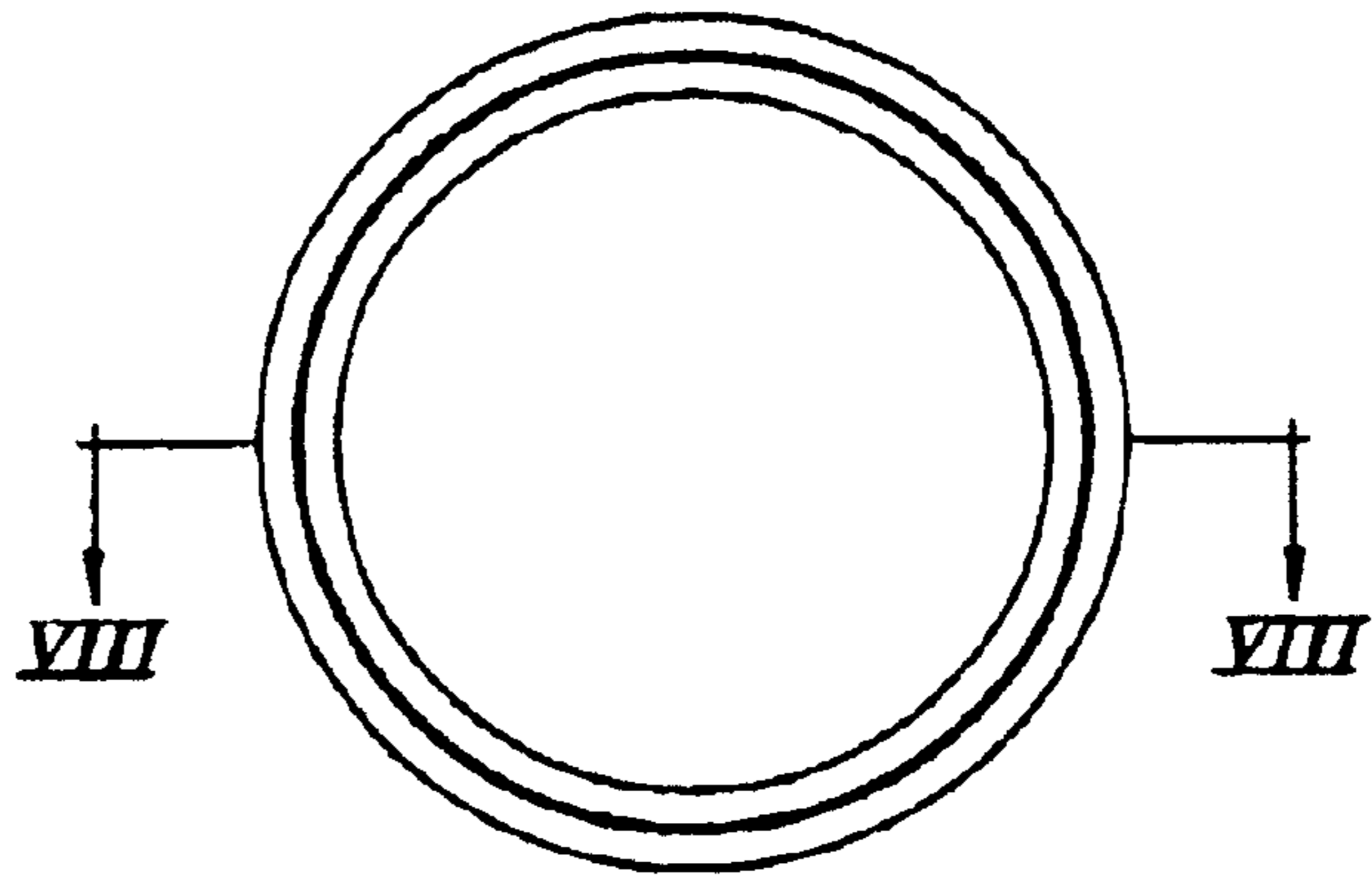

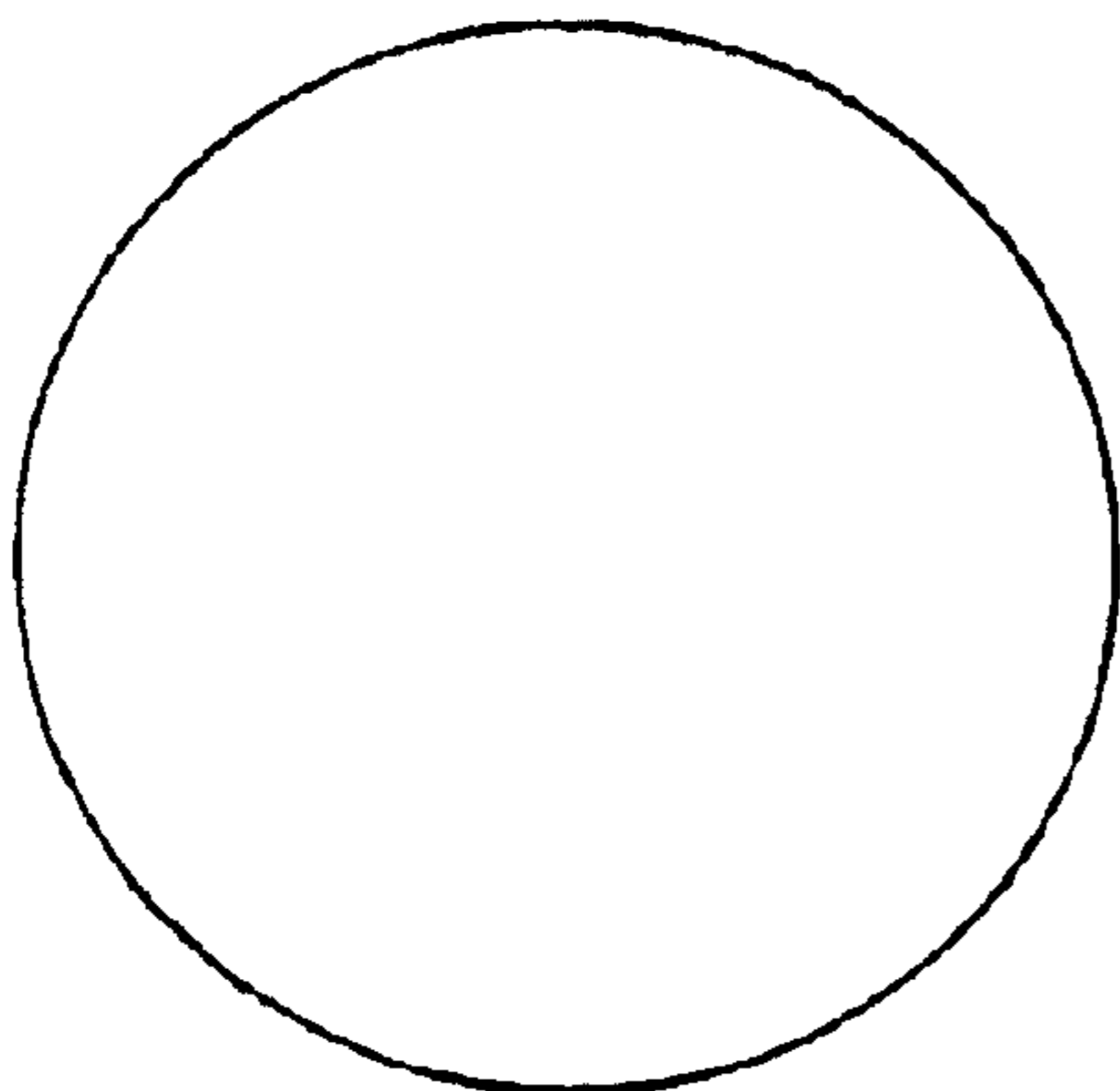

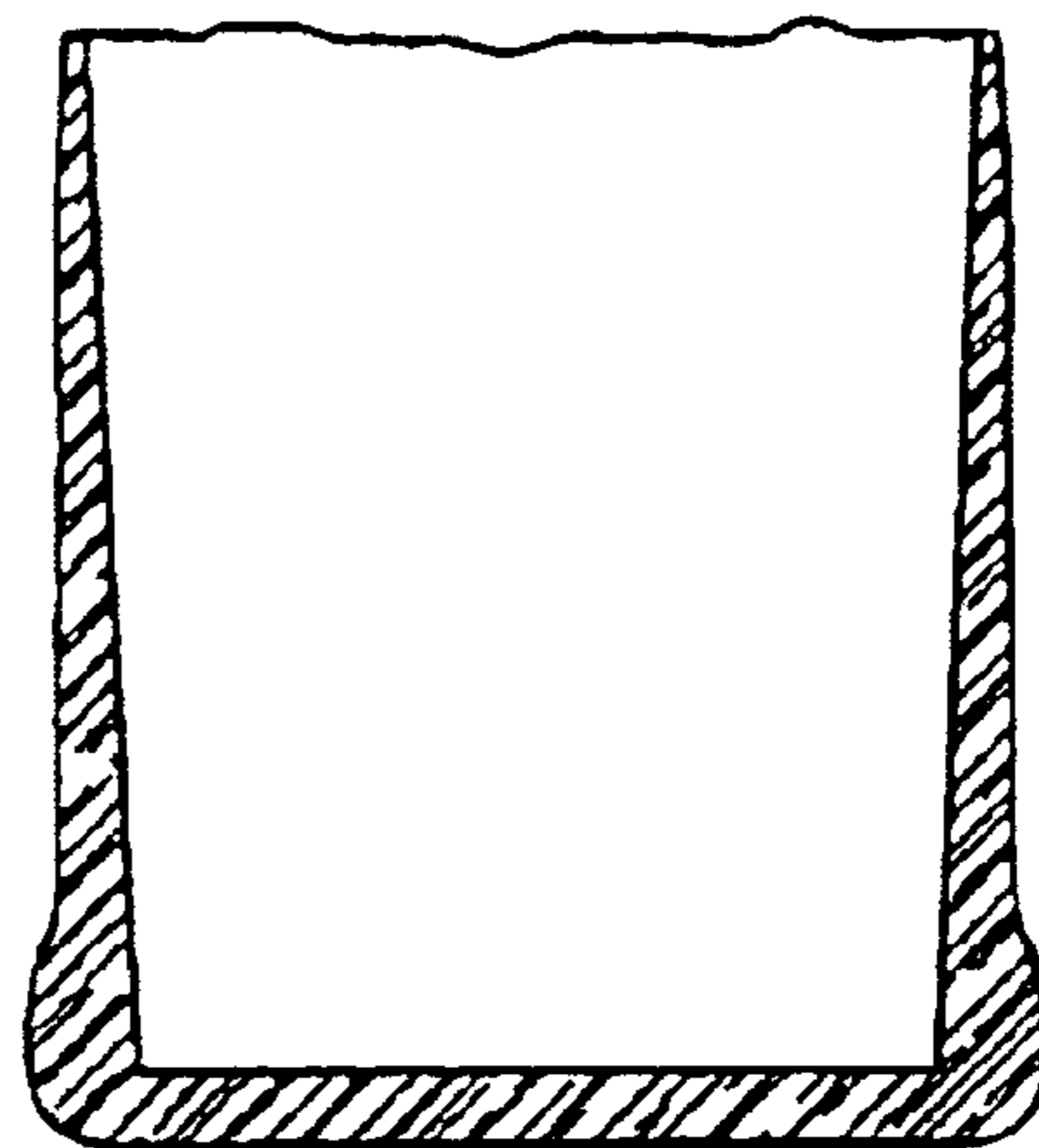
