(57) **CLAIM**

The ornamental design for a combined tray and product, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a combined tray and product showing my new design;

FIG. 2 is a top plan view of the combined tray and product of FIG. 1;

FIG. 3 is a front elevation view of the combined tray and product of FIG. 1;

FIG. 4 is a rear elevation view of the combined tray and product of FIG. 1;

FIG. 5 is a bottom plan view of the combined tray and product of FIG. 1; and,

FIG. 6 is a left side elevation view of the combined tray and product of FIG. 1, the right side elevation view being the mirror image thereof.

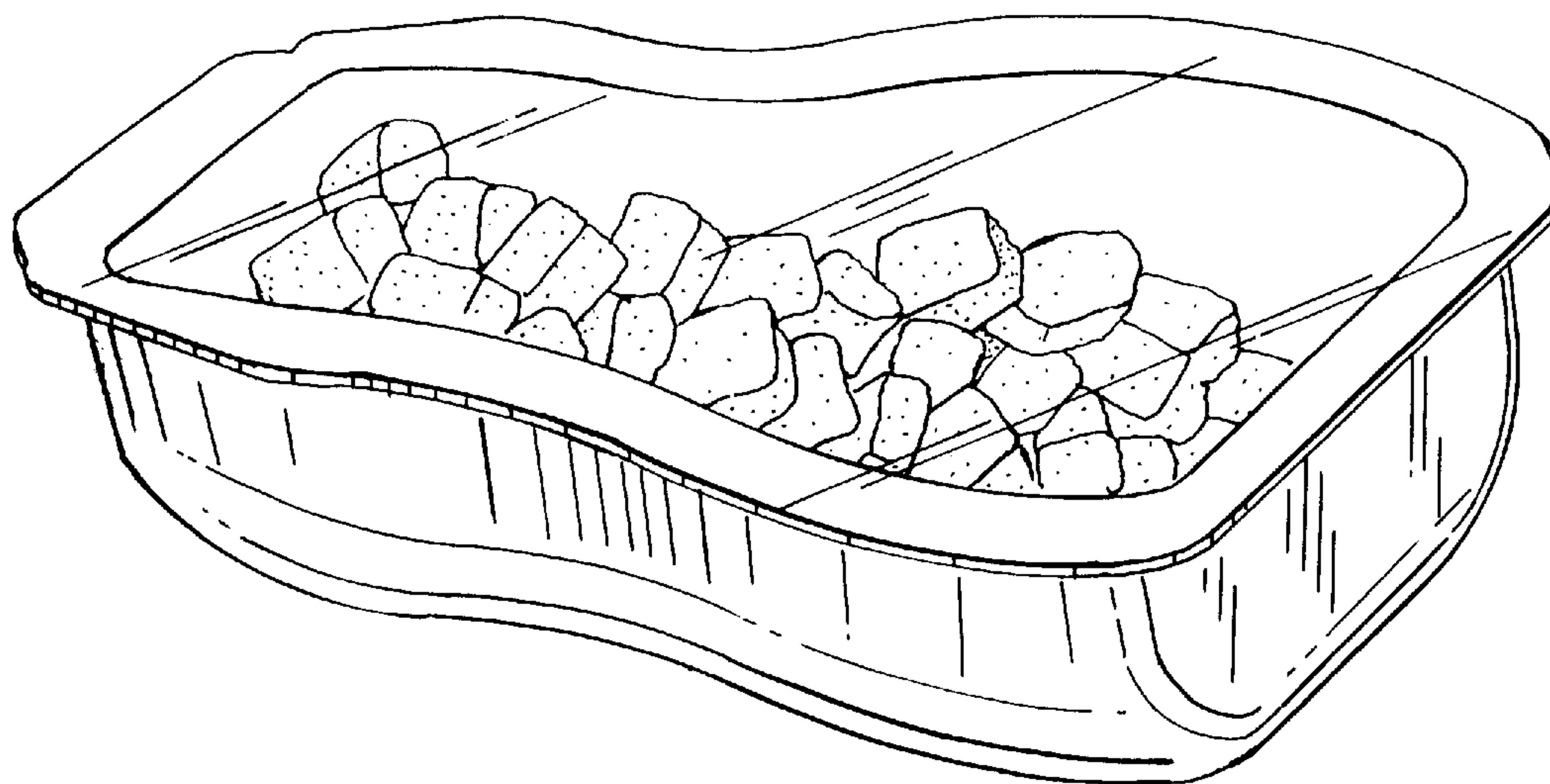

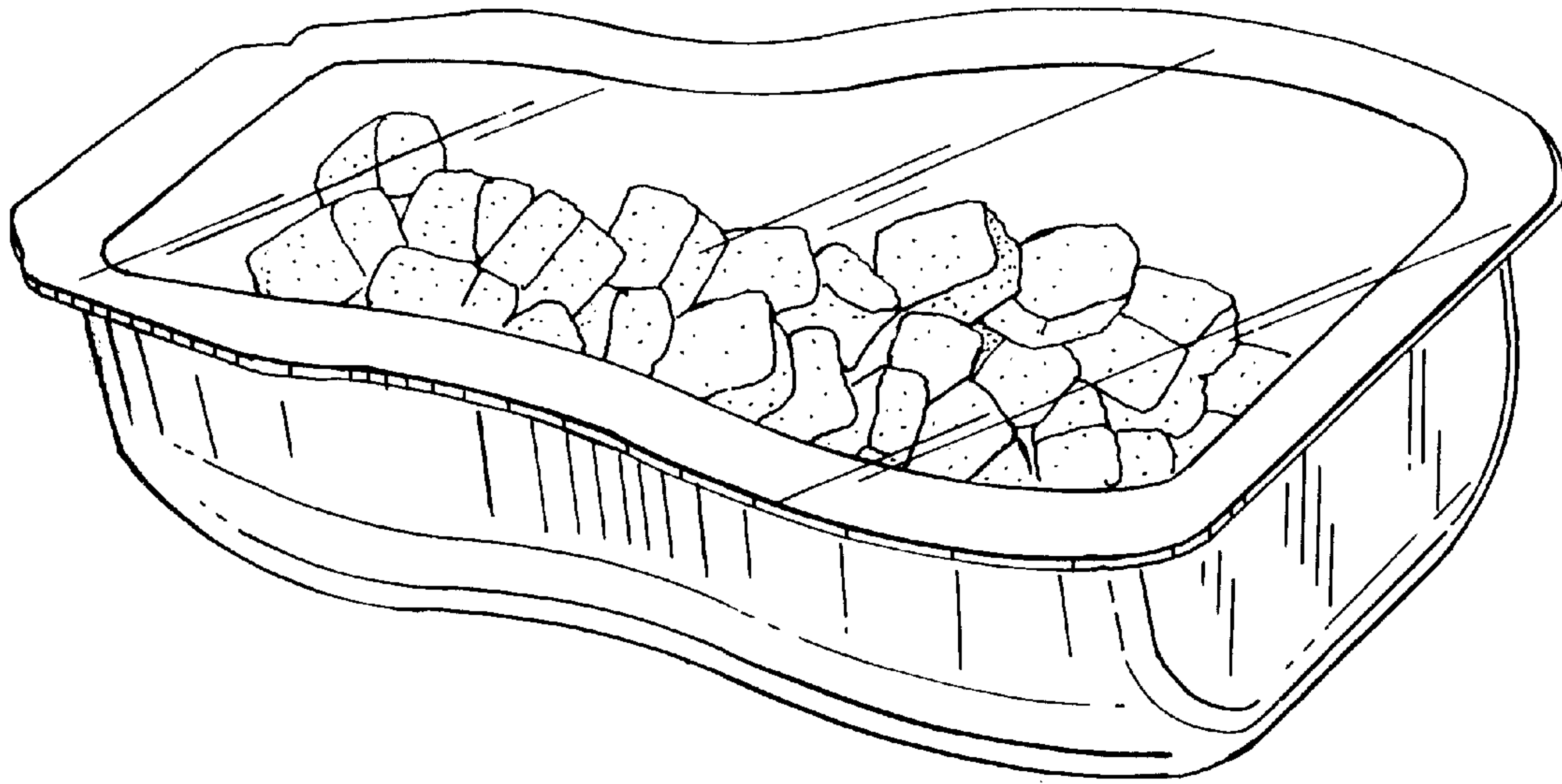

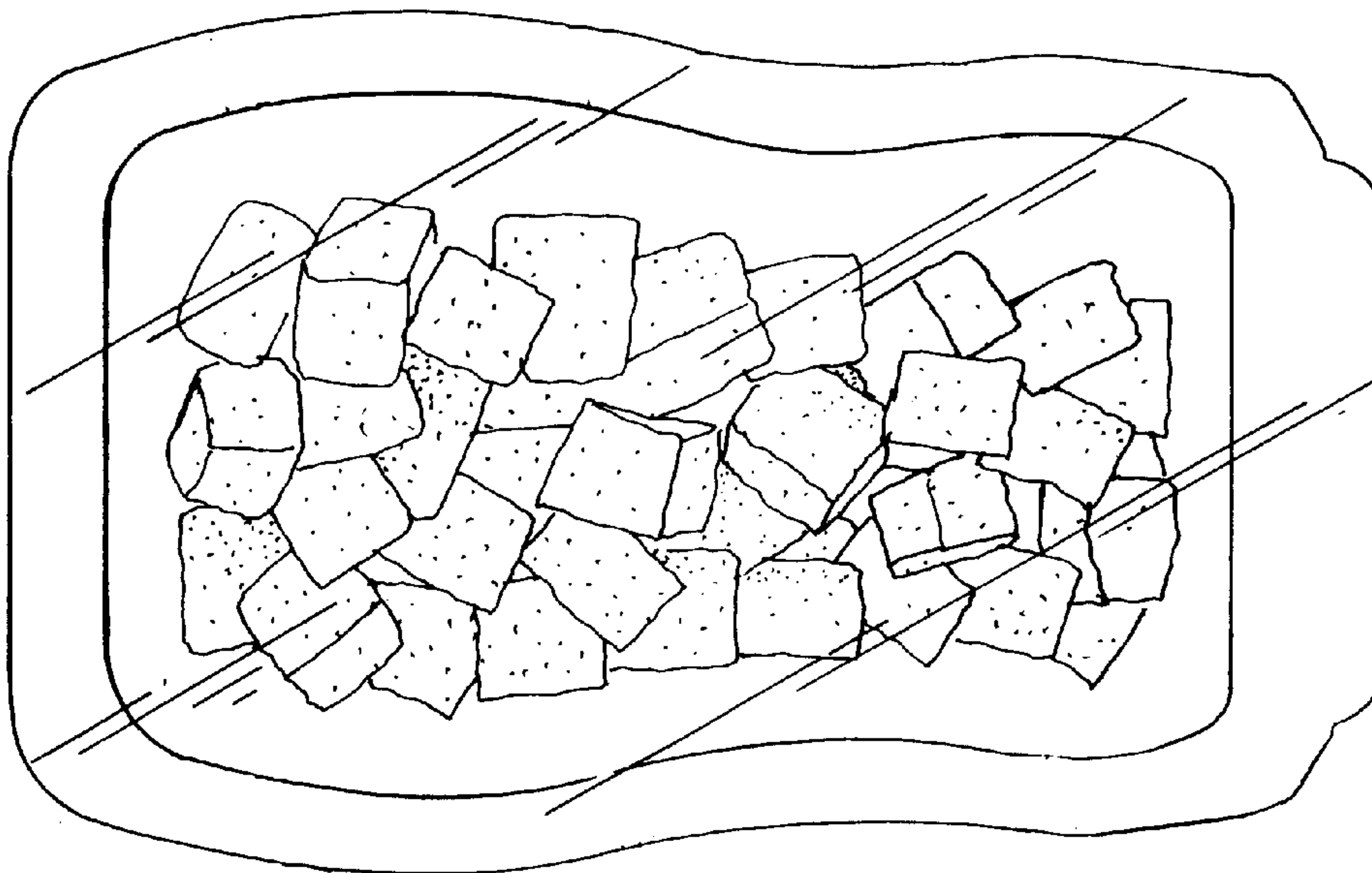

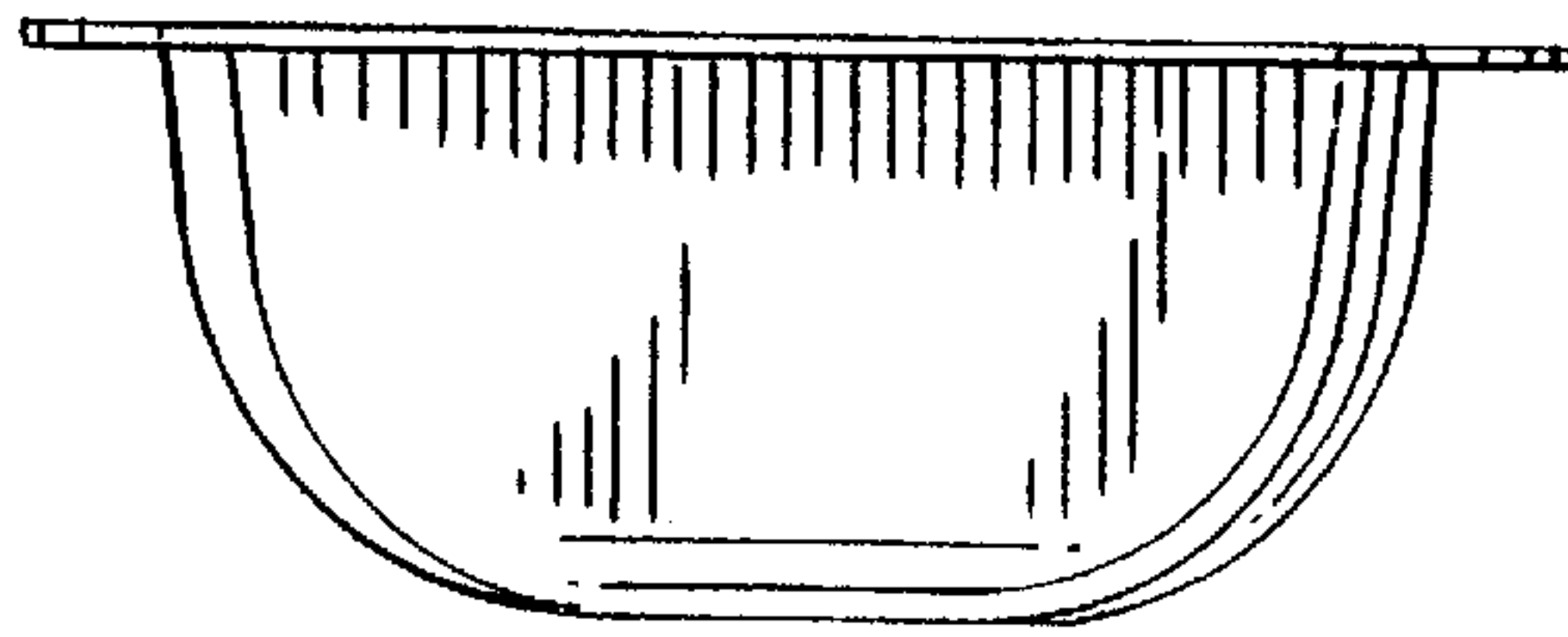

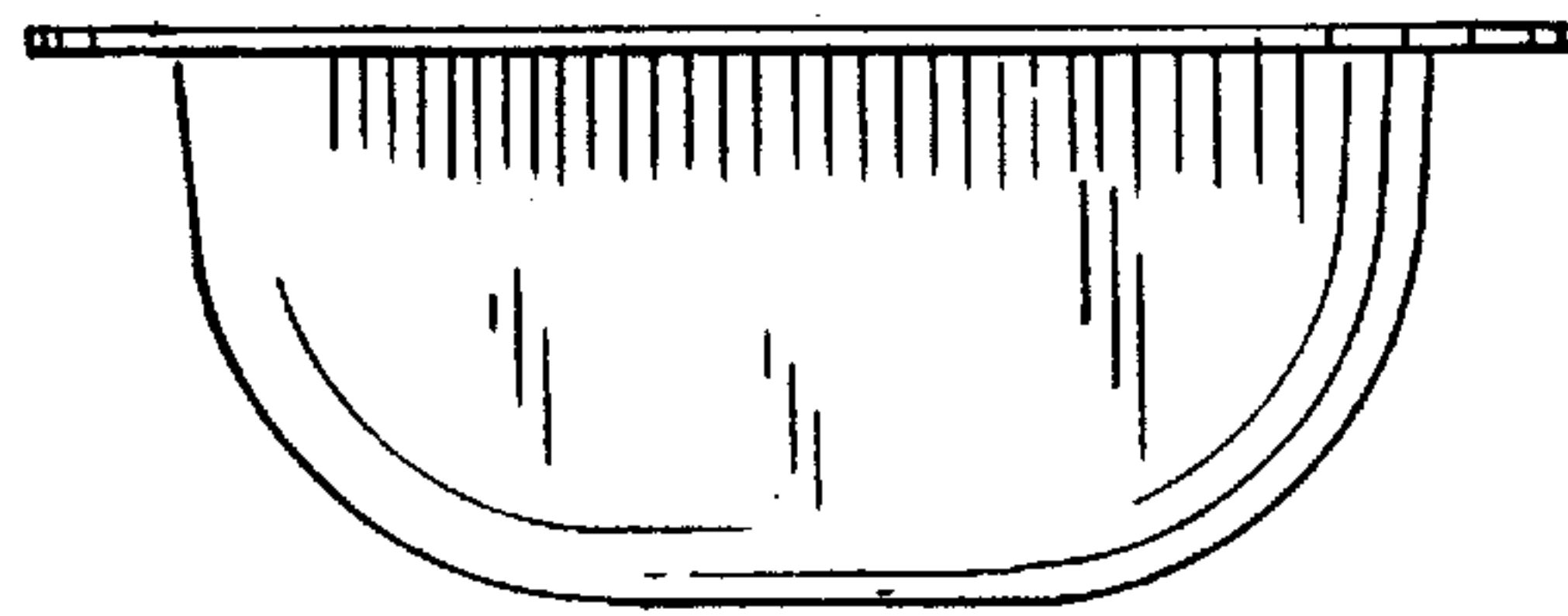

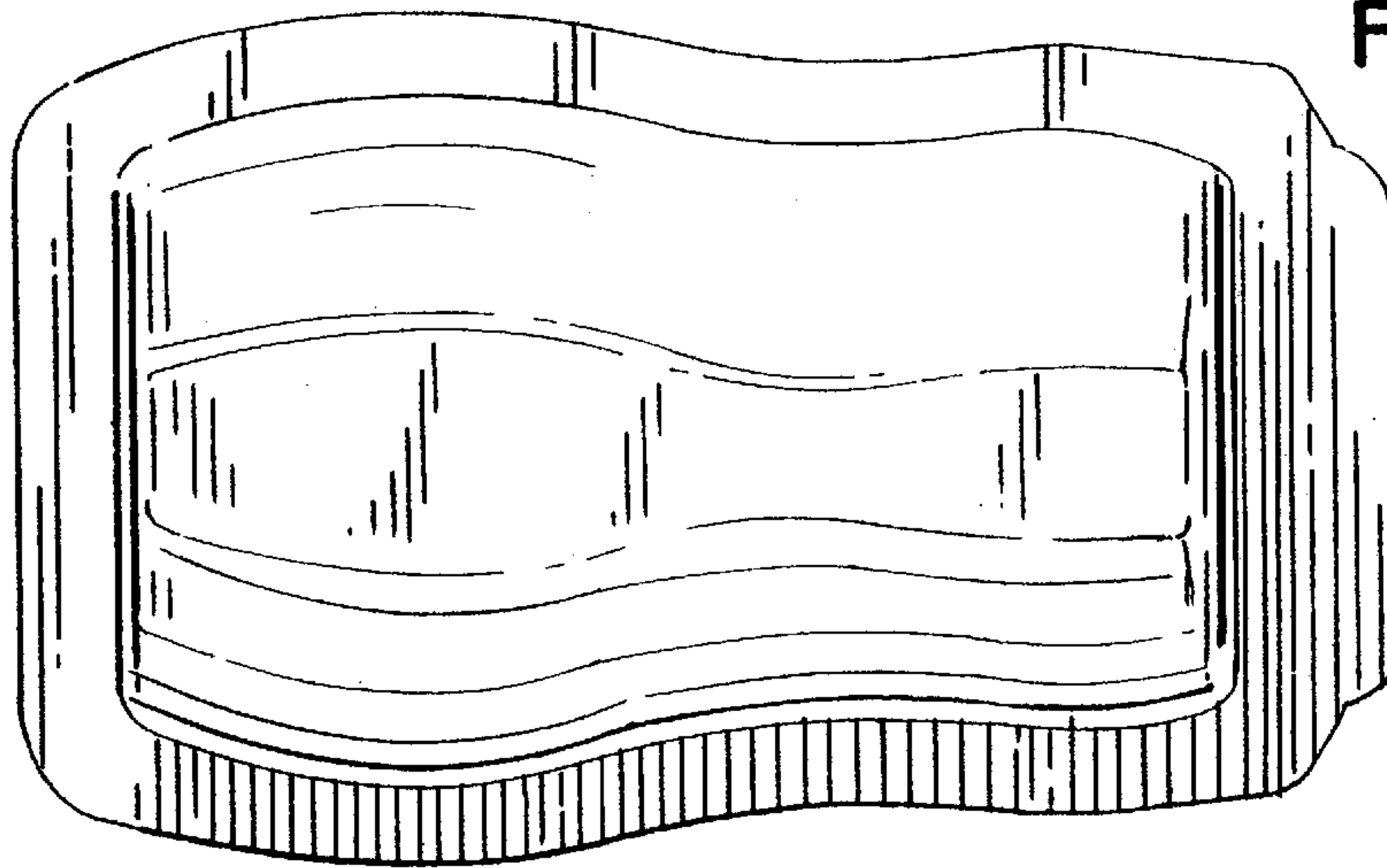
