FIG. 1 is a front, right side, and top perspective view of an enclosure for a hydrogen generation system showing the new design;

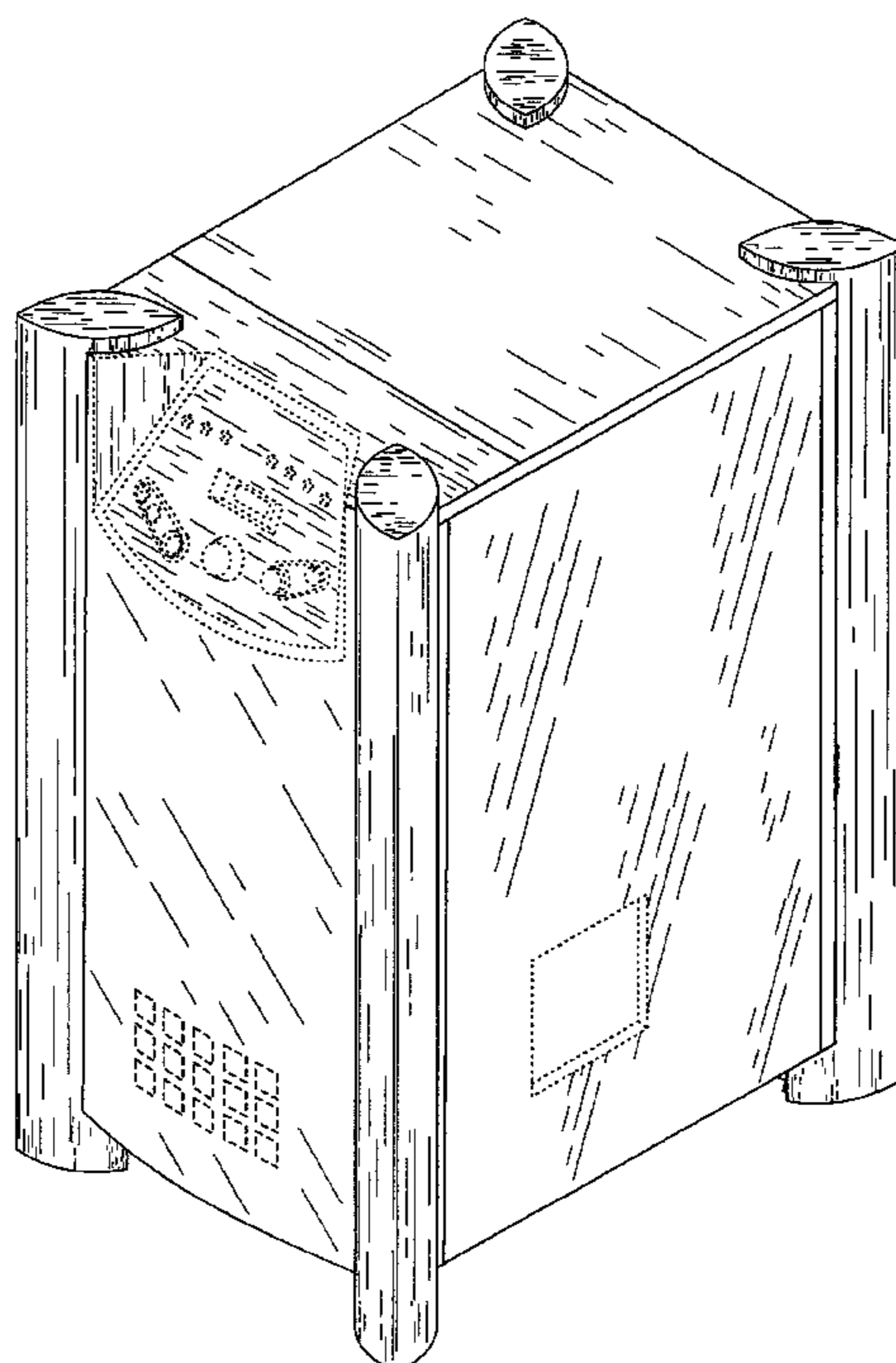
FIG. 2 is a front elevational view thereof;

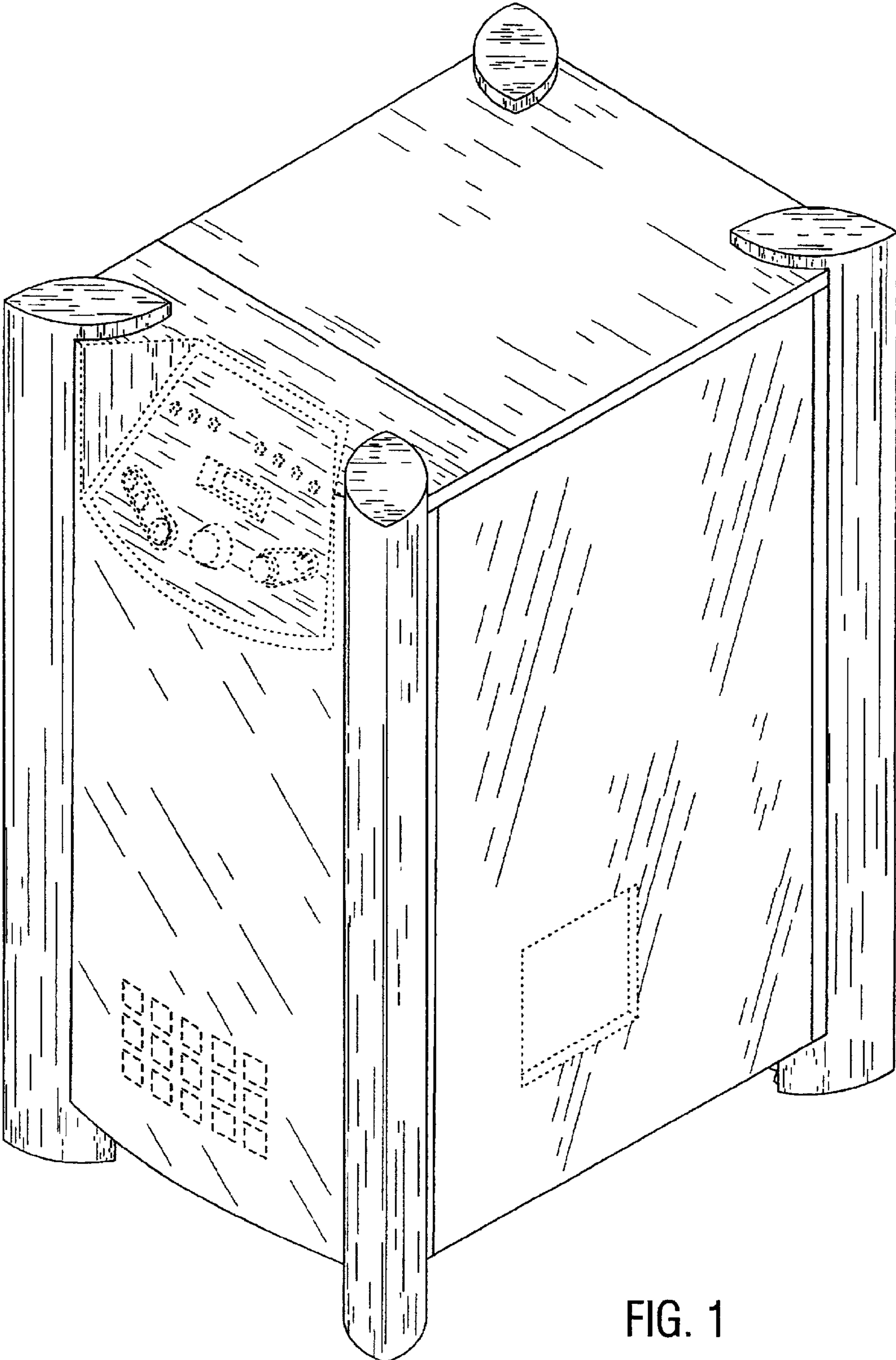

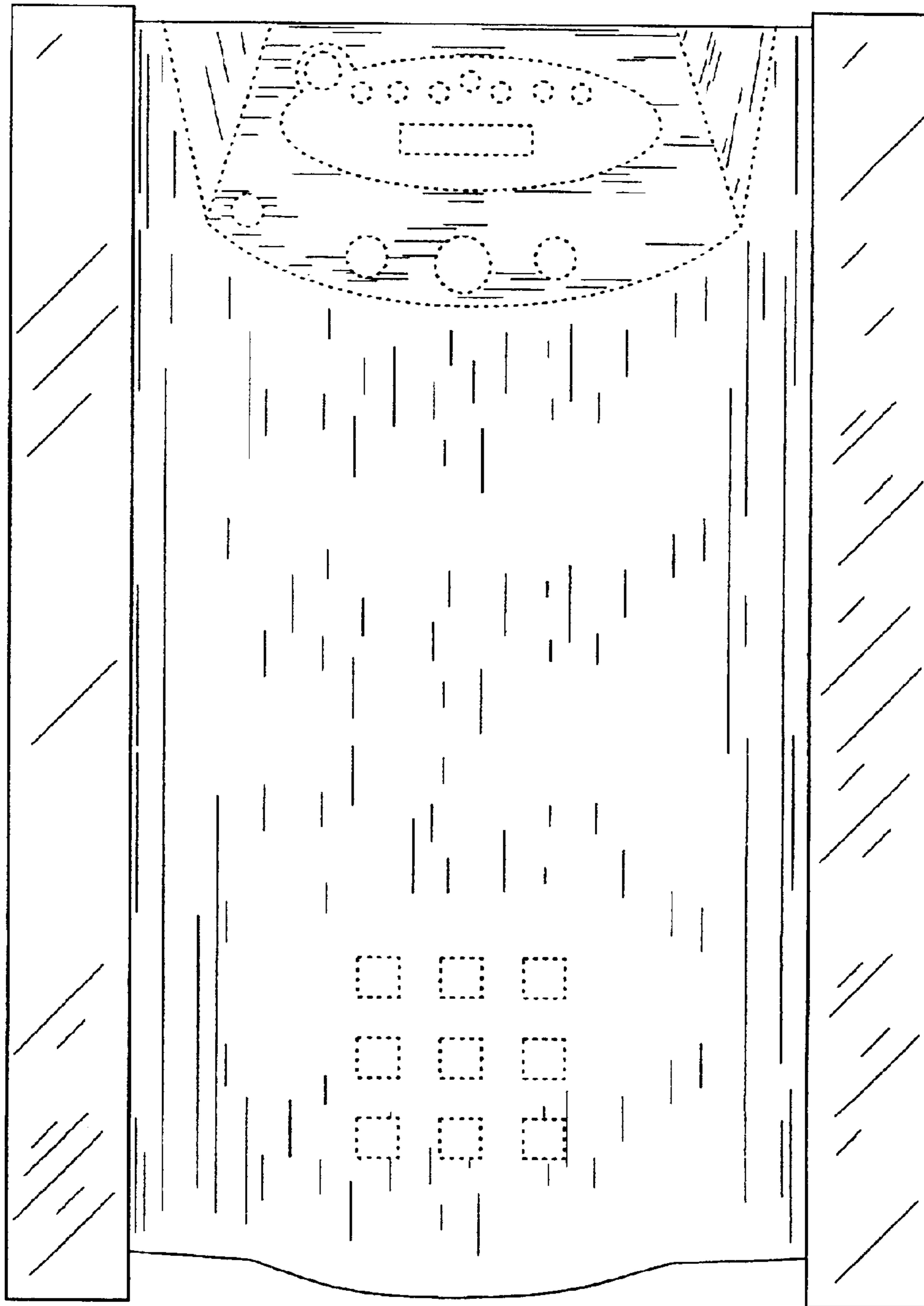

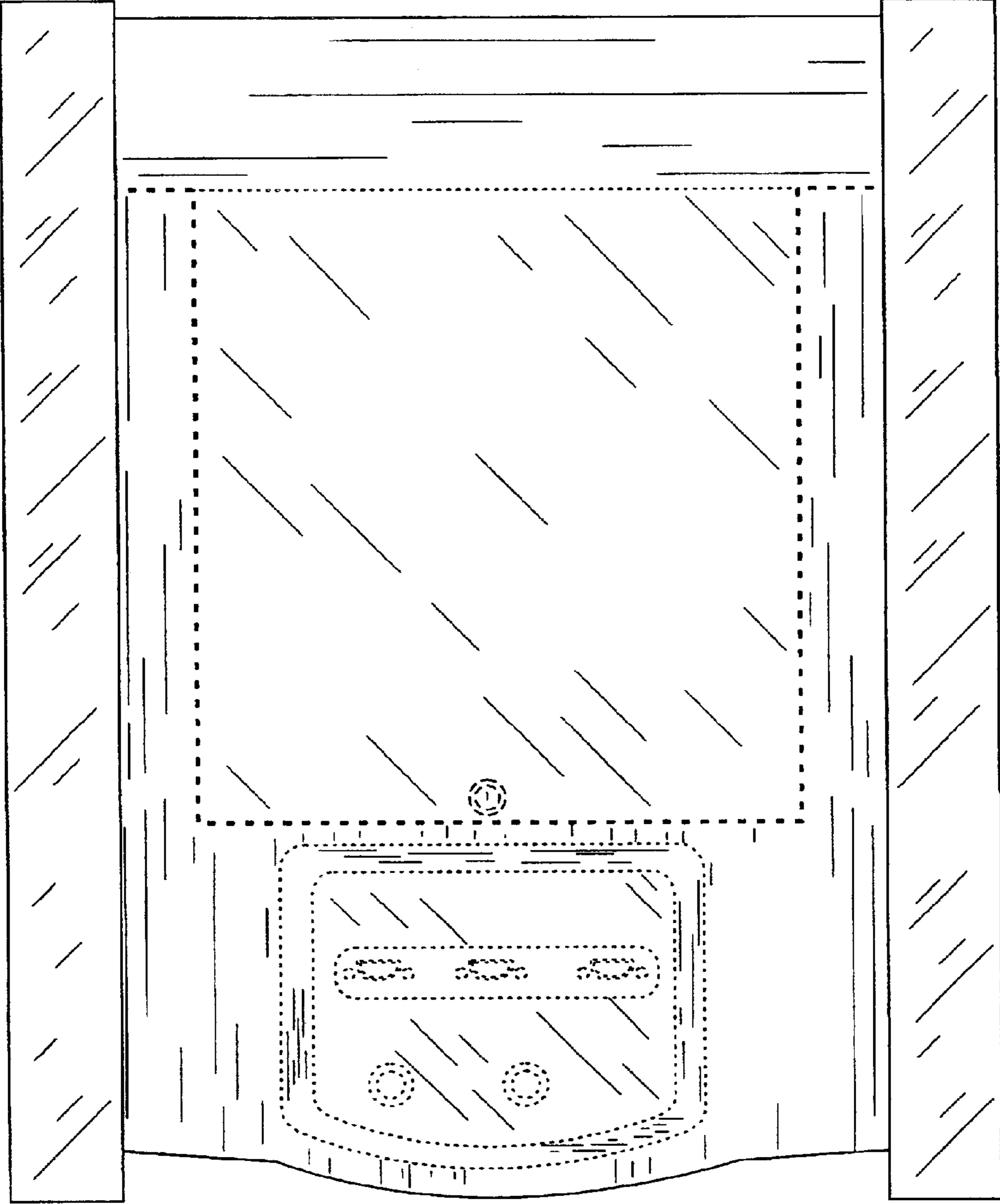

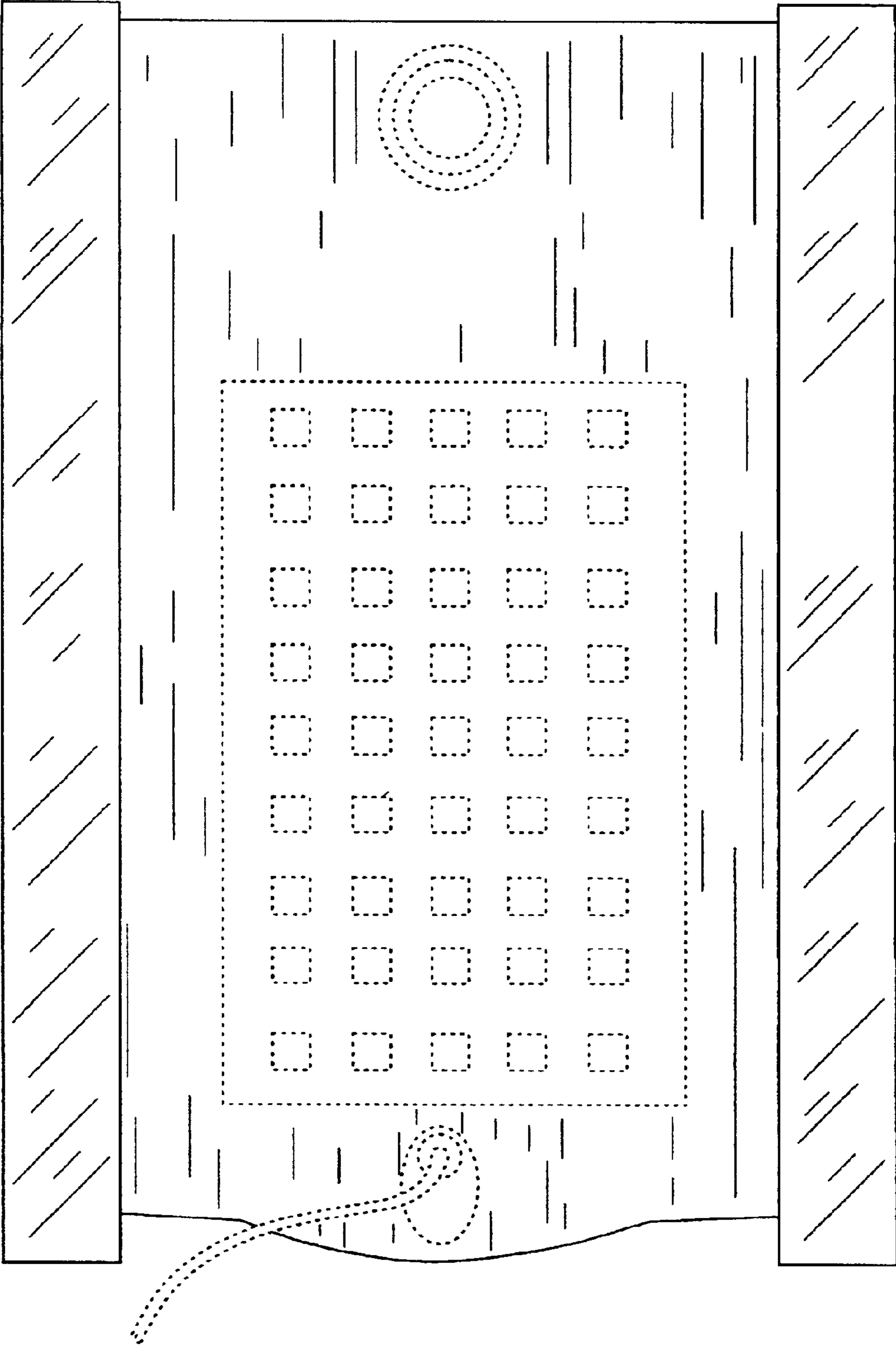
