FIG. 2 is a perspective view from below of a lighting fixture in accordance with my design;

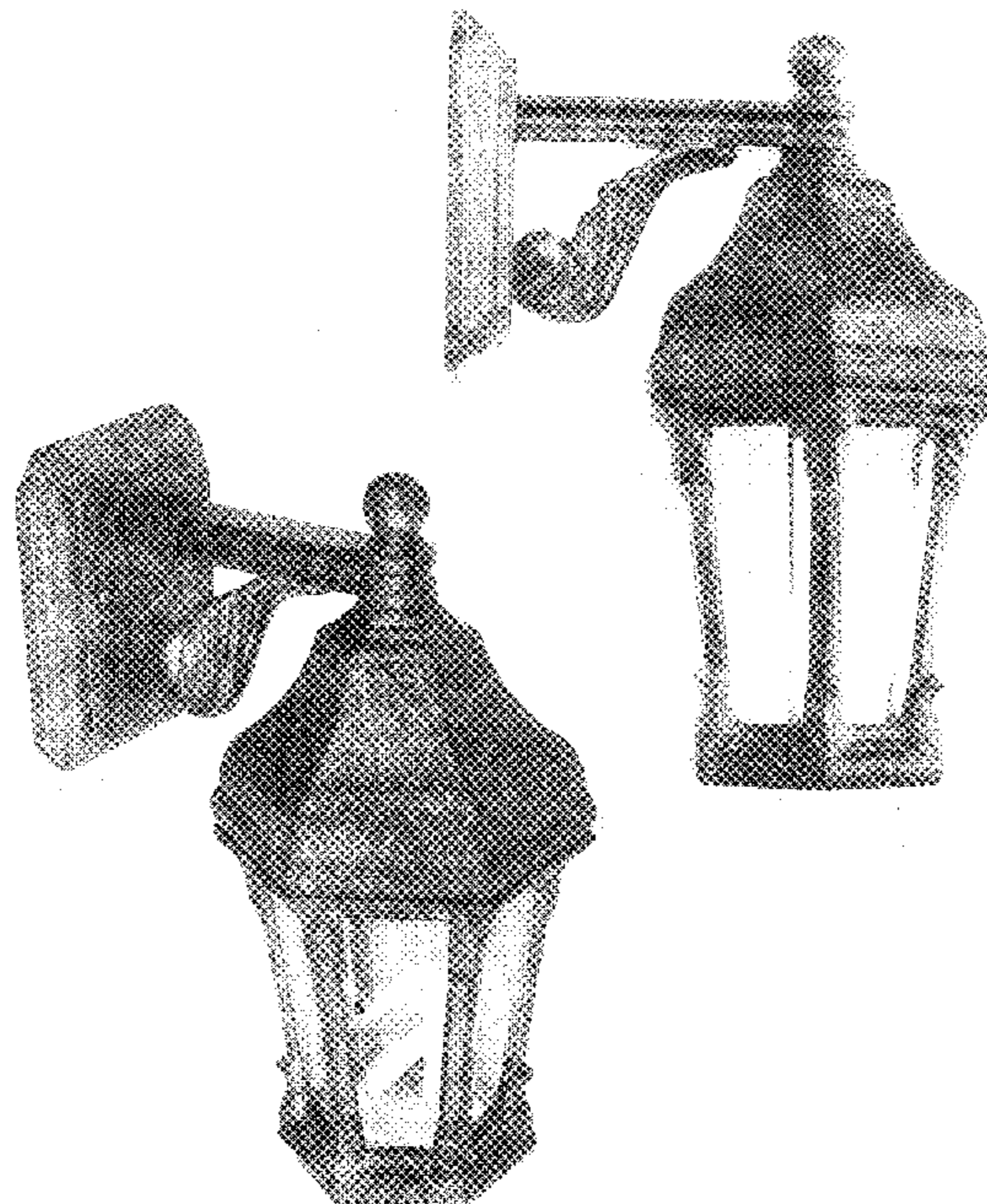
FIG. 3 is a side elevation view of the lighting fixture in accordance with my design;

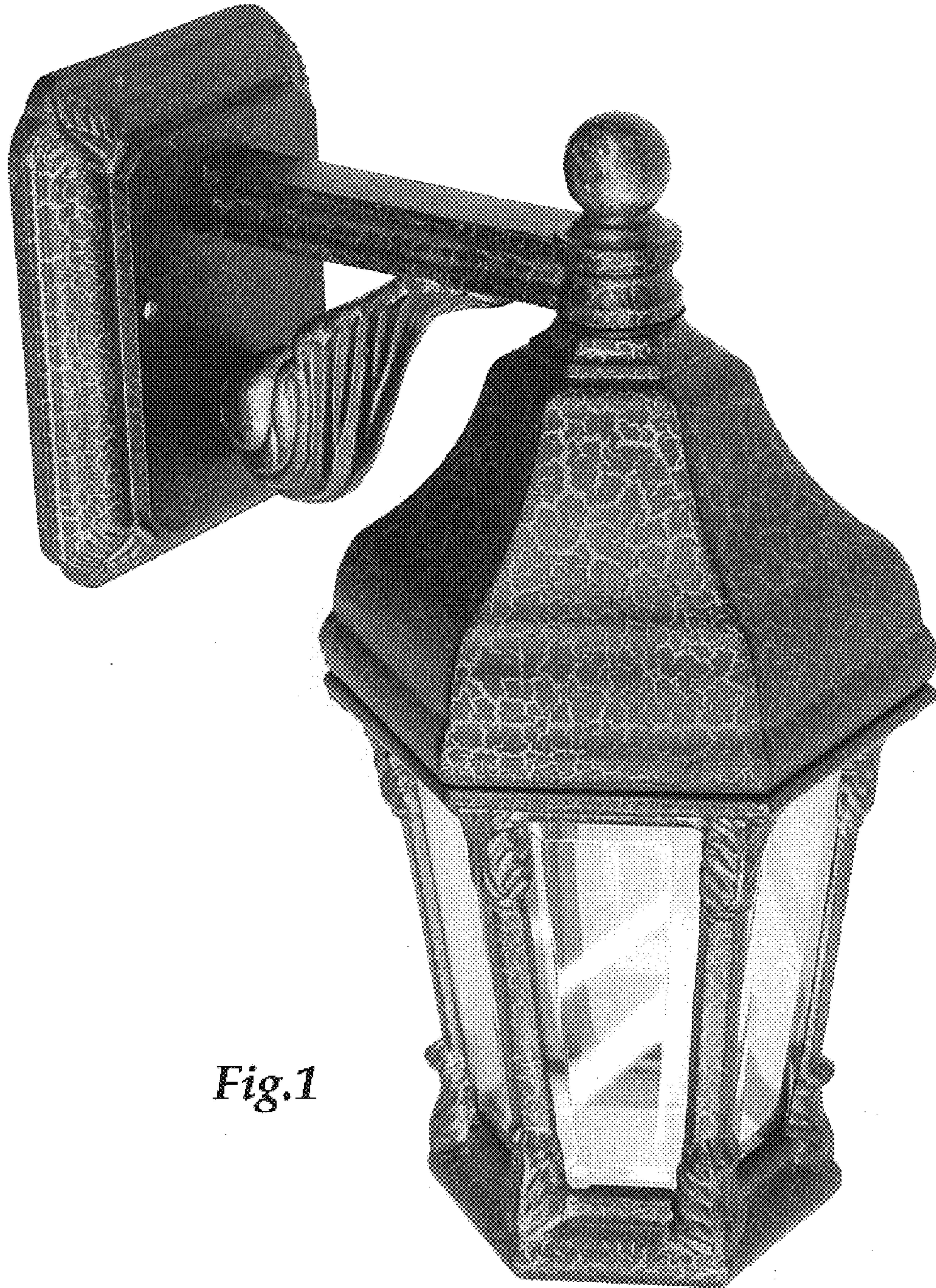
FIG. 4 is a front elevation view of the lighting fixture in accordance with my design;

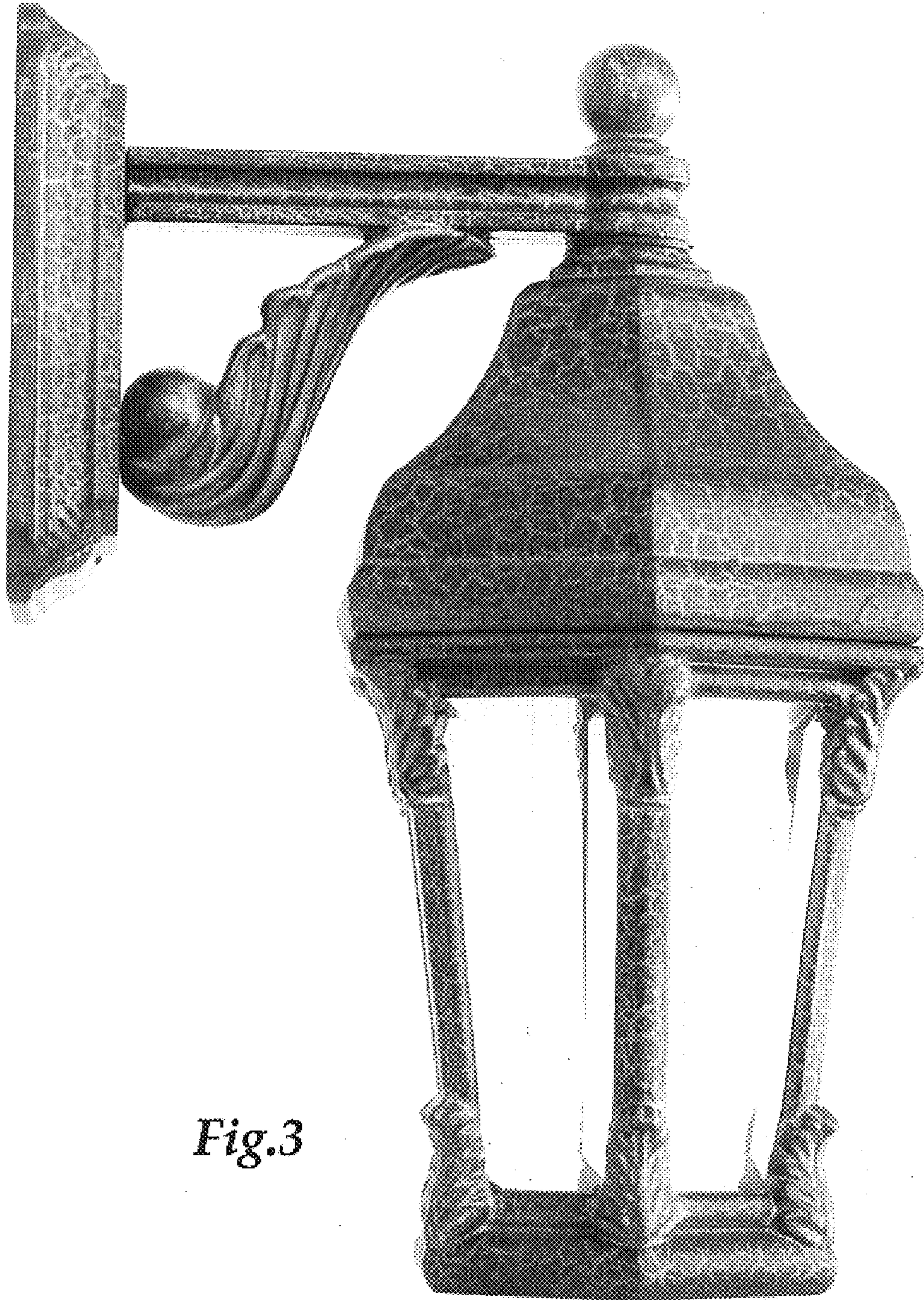




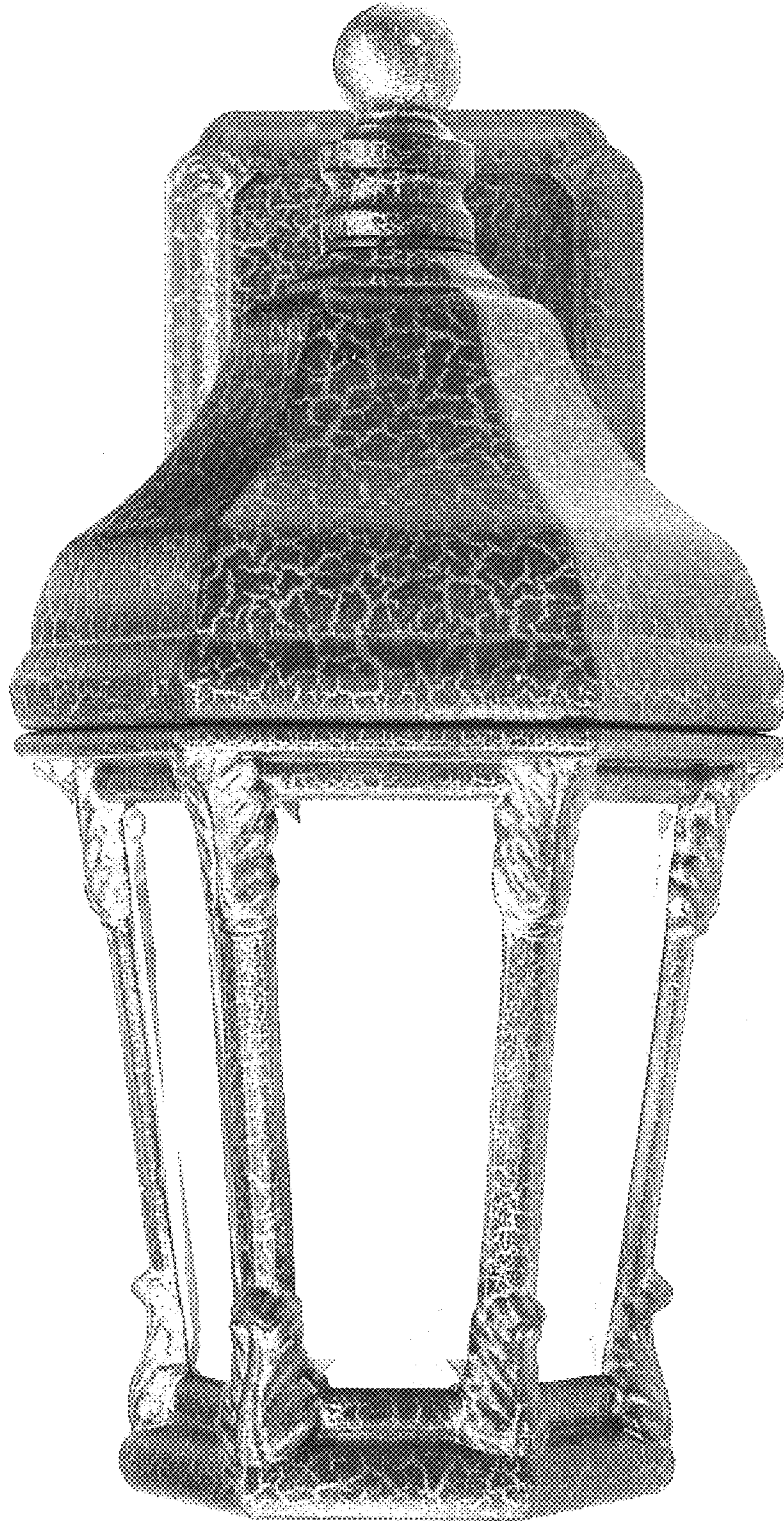

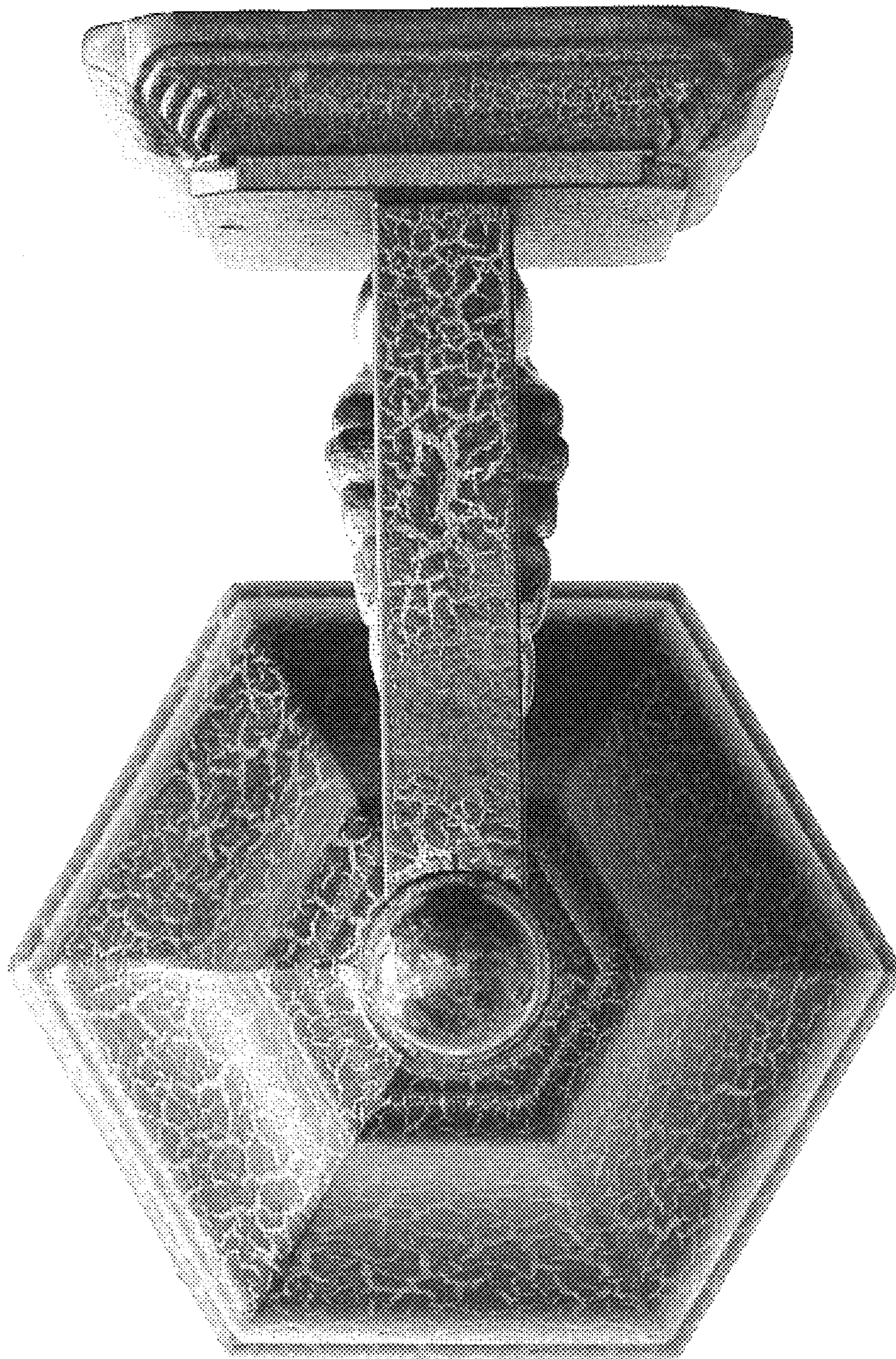

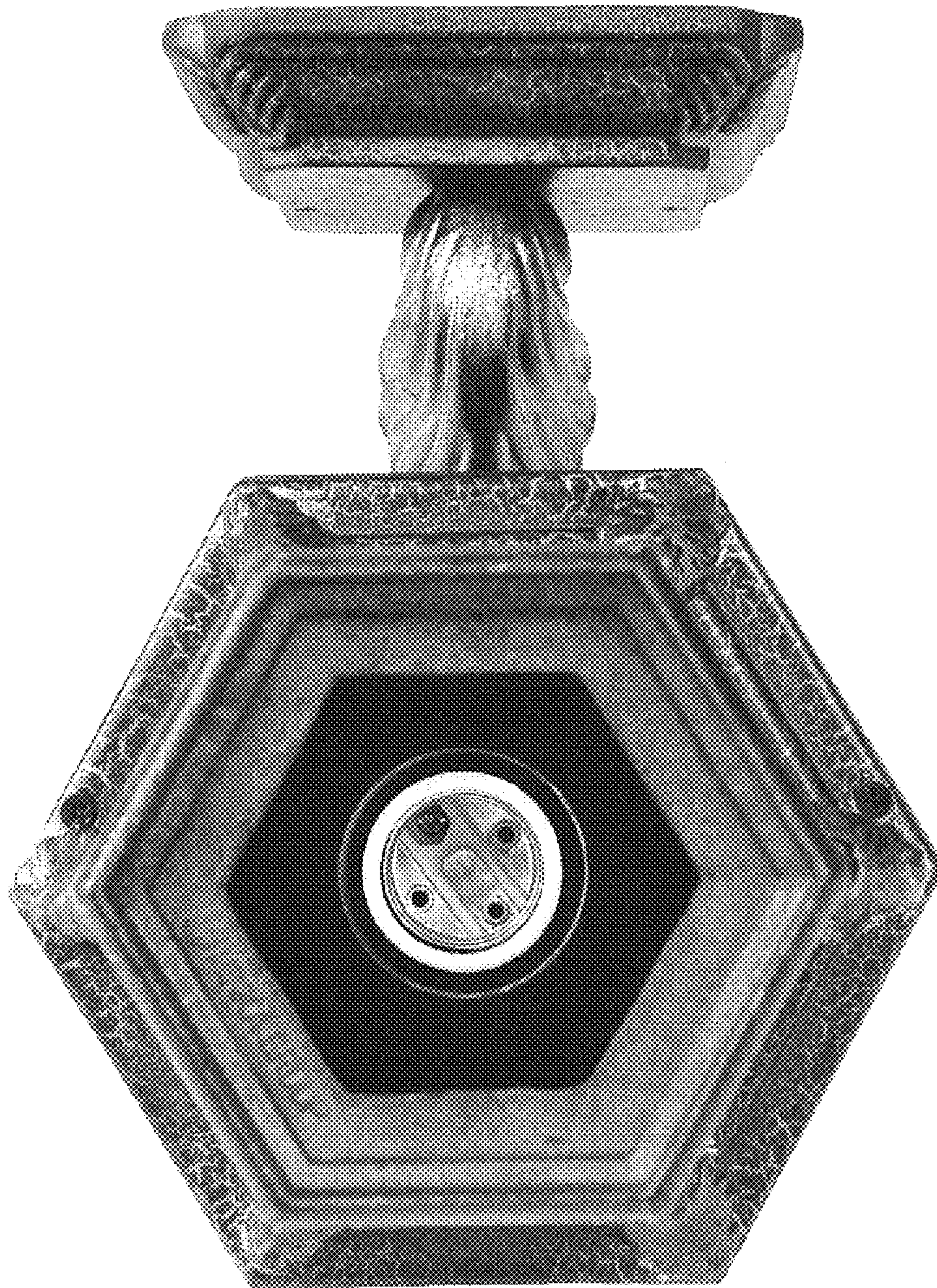
