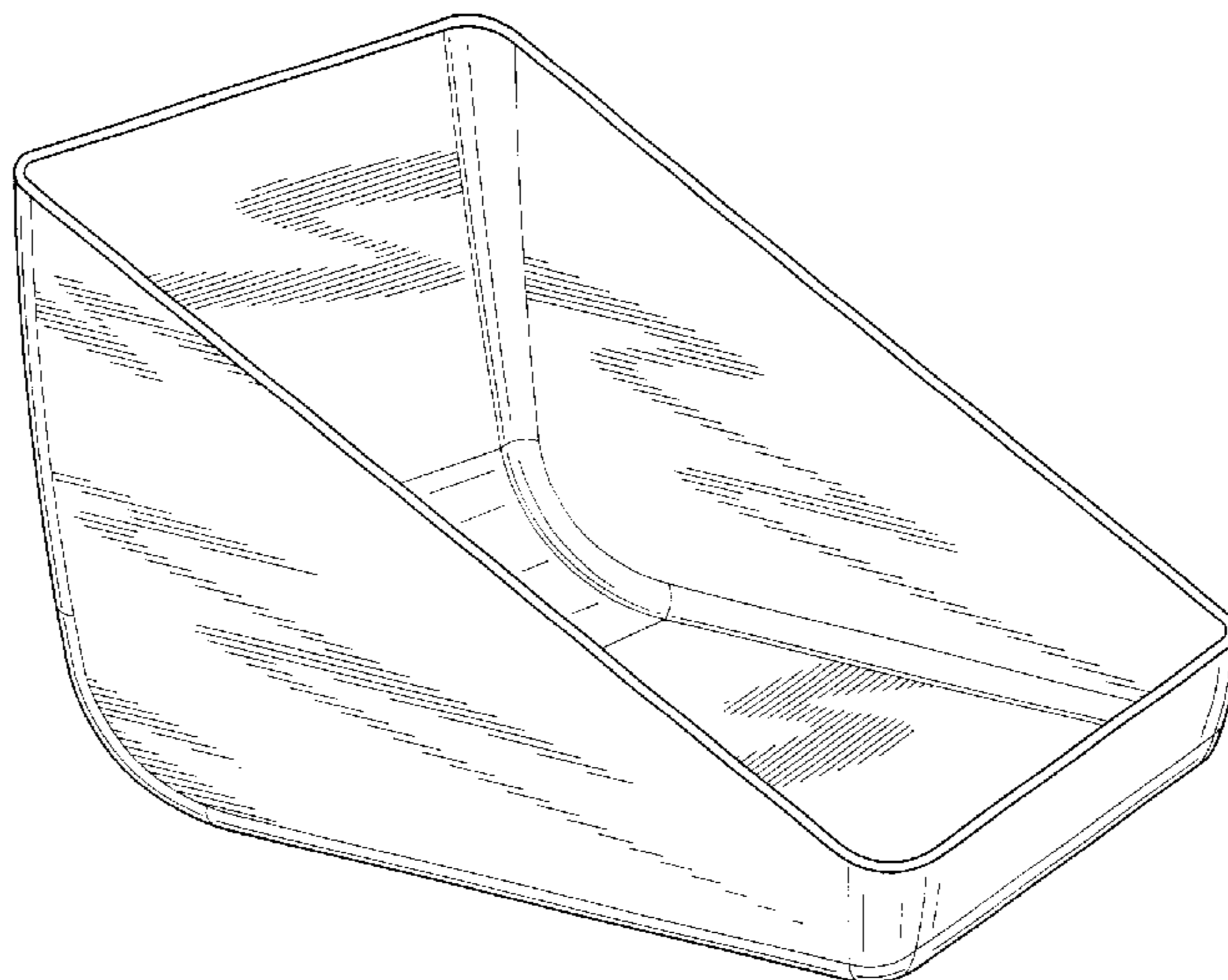
(57) **CLAIM**

An ornamental design for a litter box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the litter box of the present invention;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof; and,
FIG. 6 is a top plan view thereof.

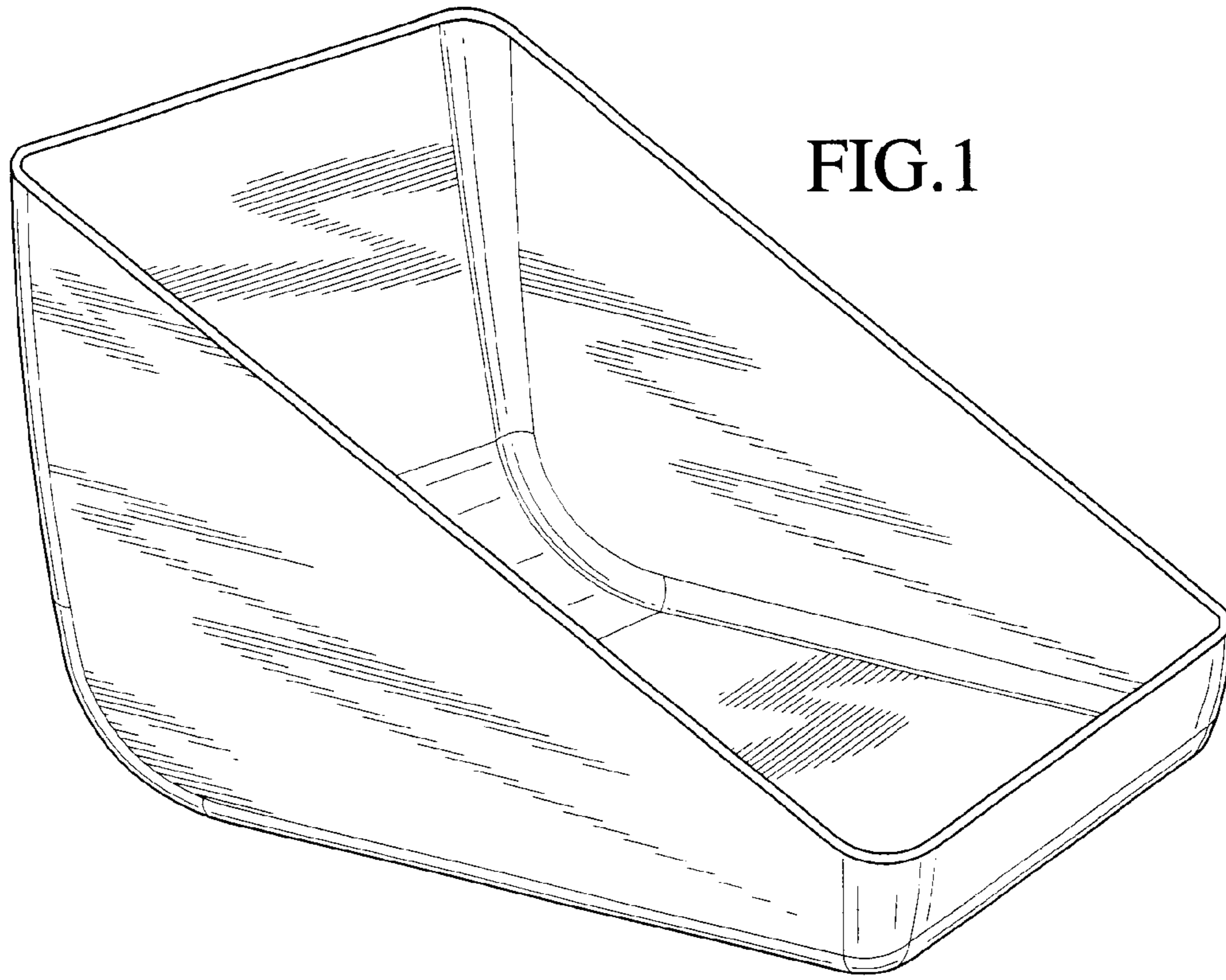
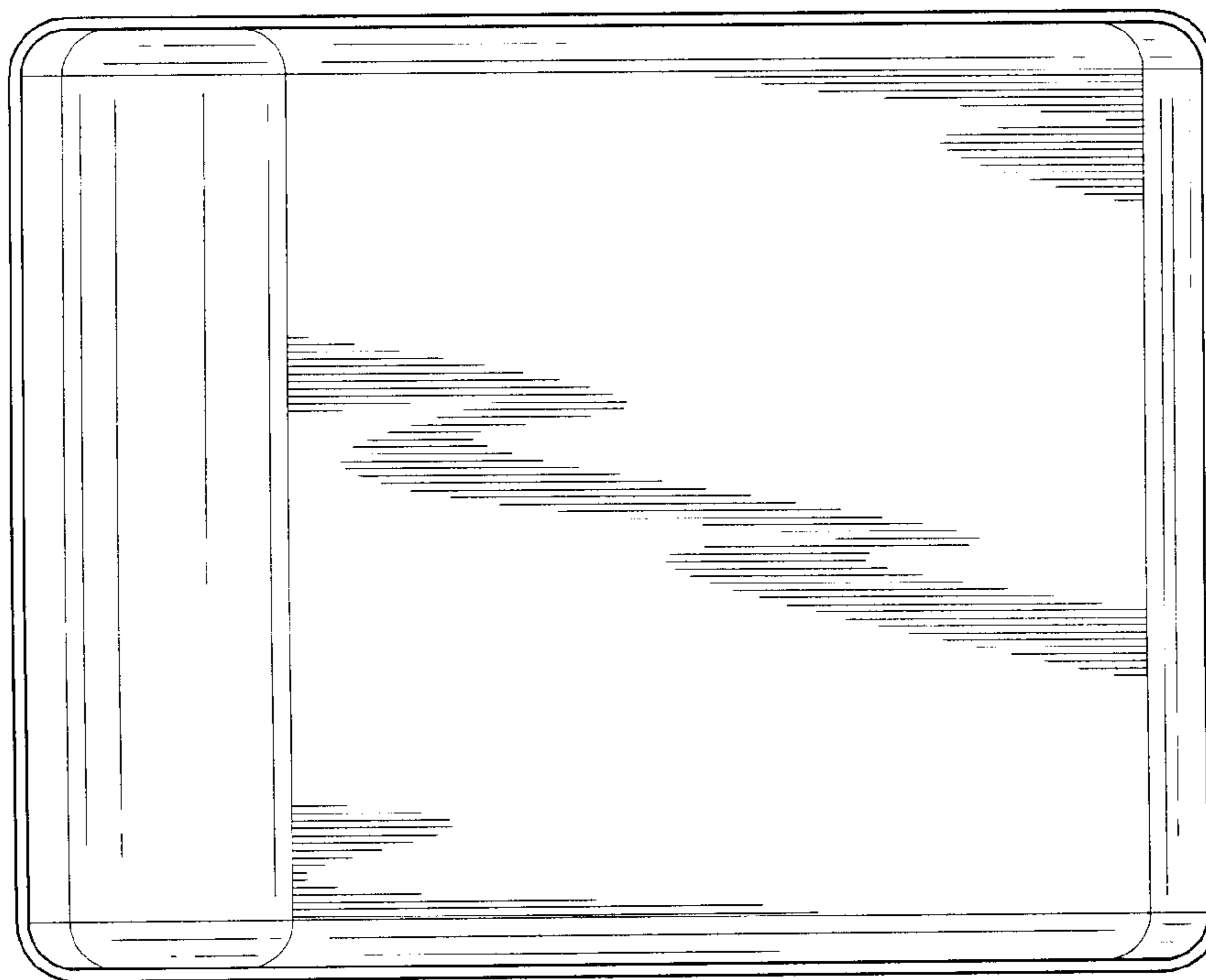

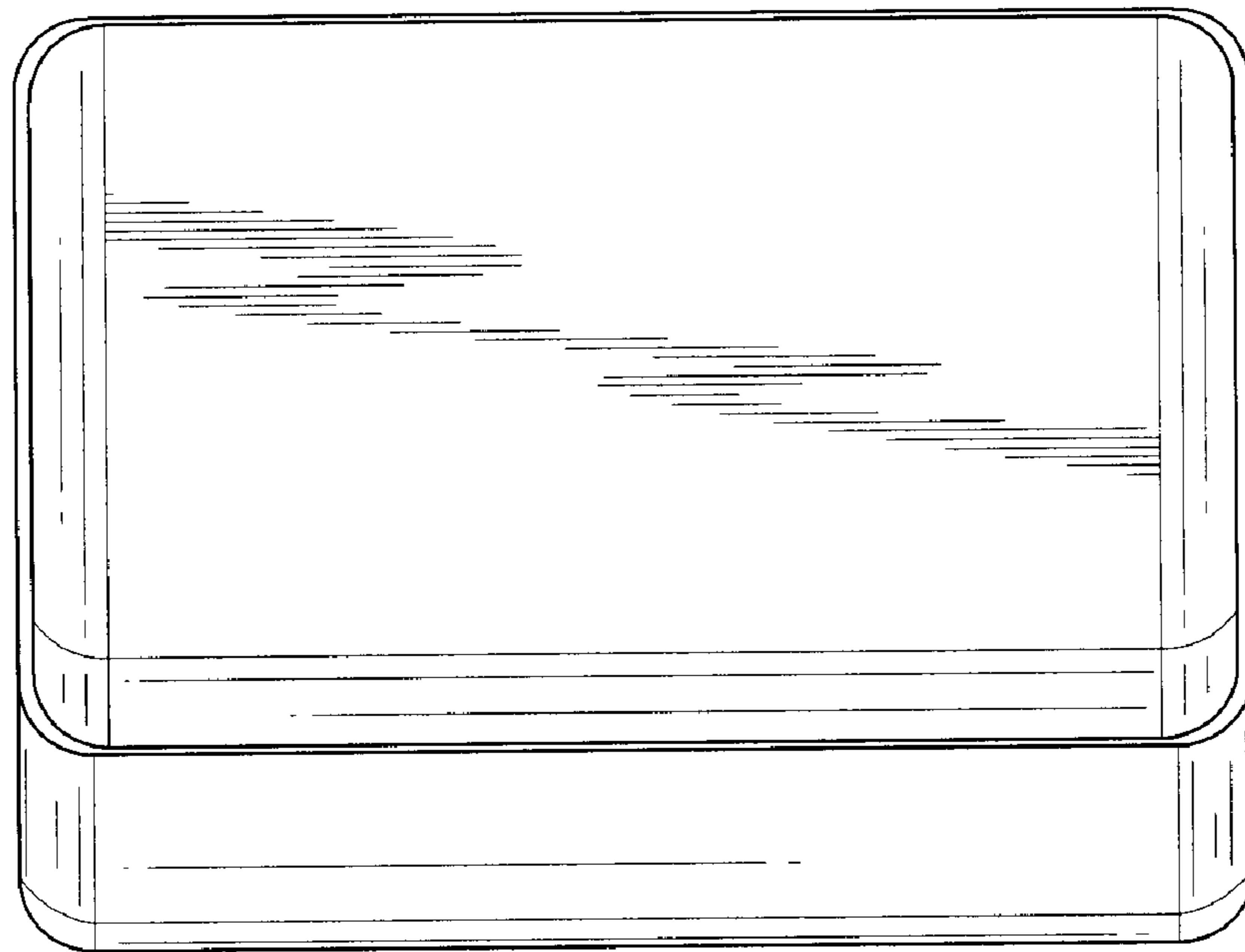

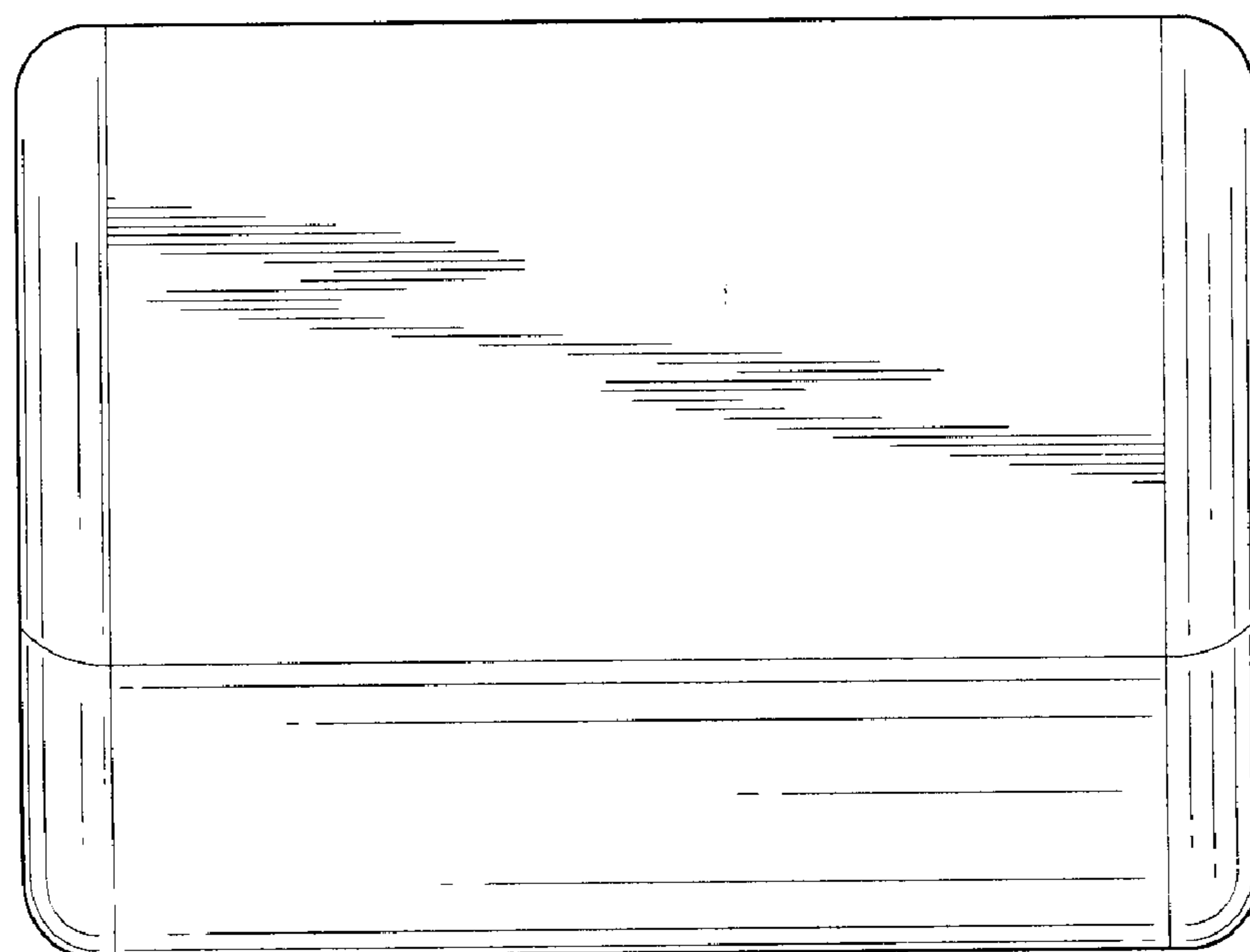

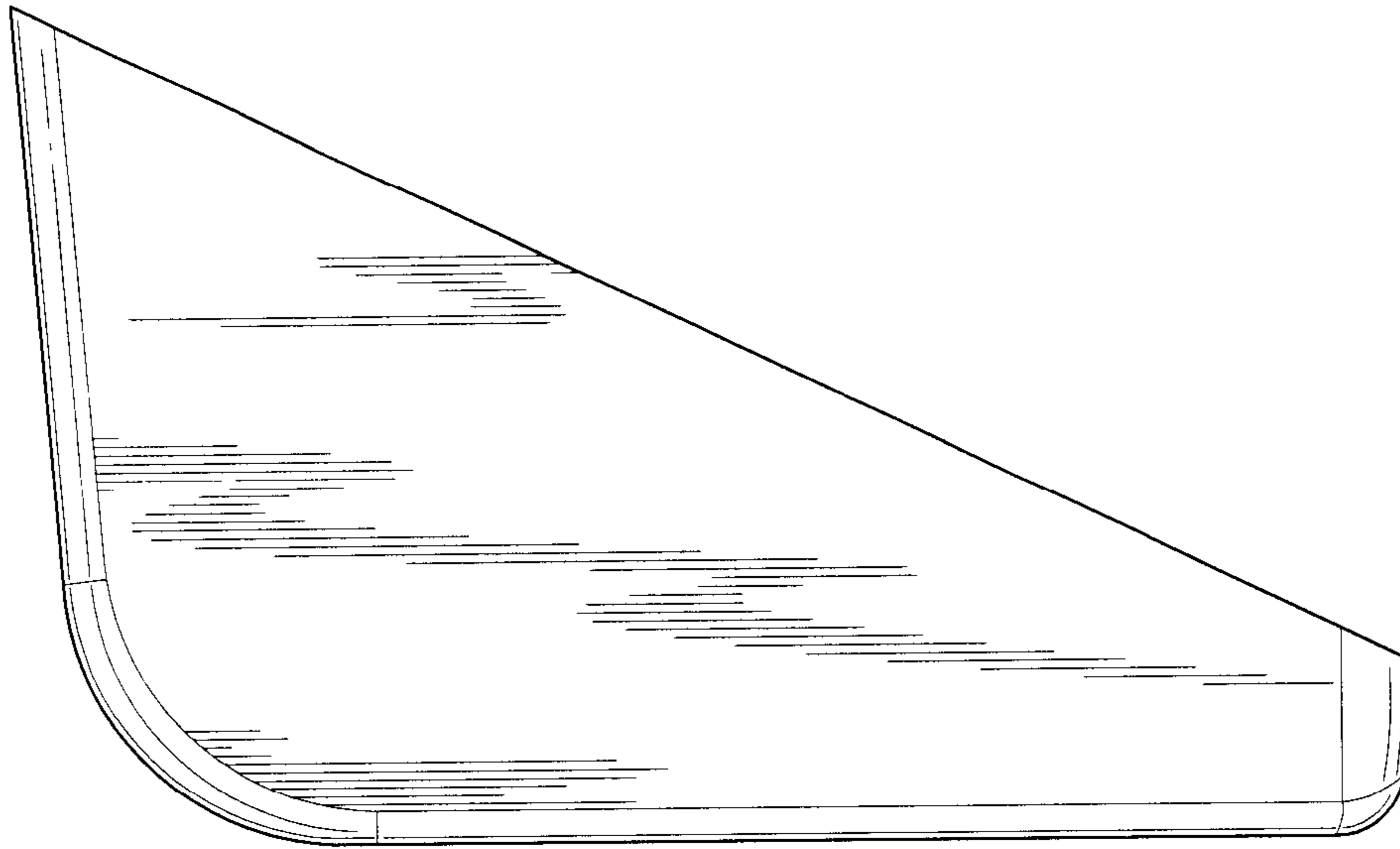

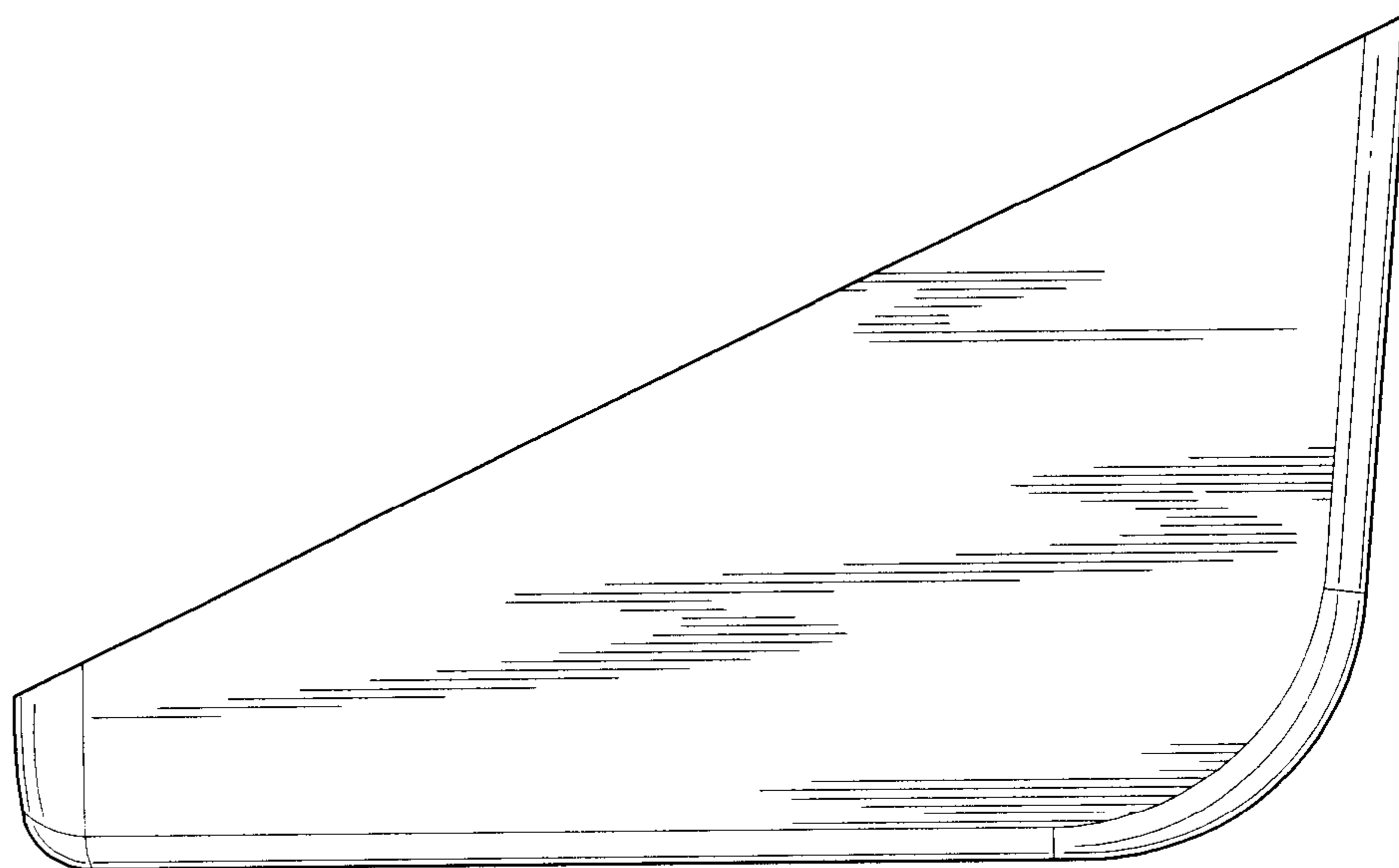
