DESCRIPTION

FIG. 1 is a perspective view of the jack stand showing my
new design;
FIG. 2 is a front view of the jack stand of FIG. 1;
FIG. 3 is a left side view of the jack stand of FIG. 1;

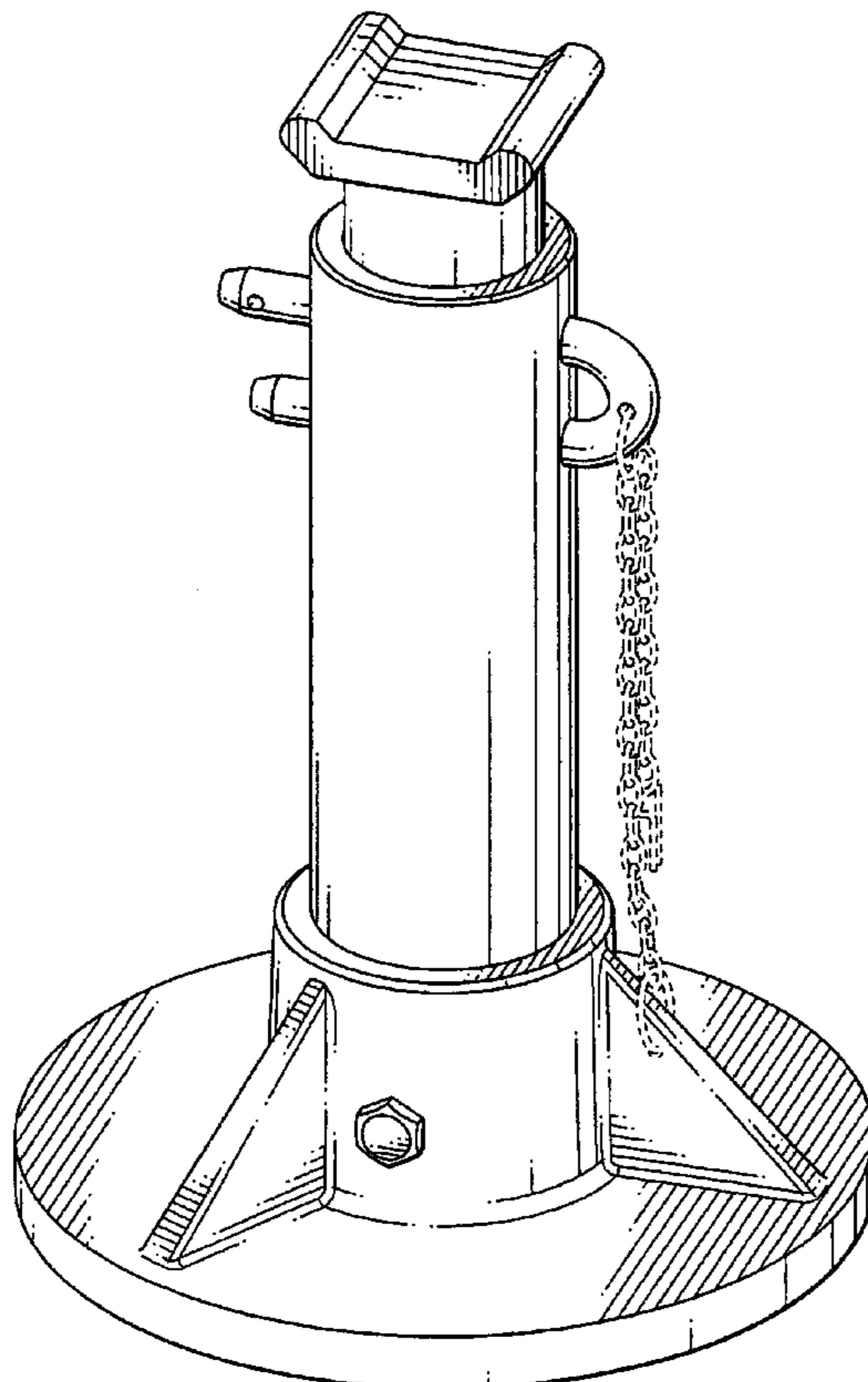
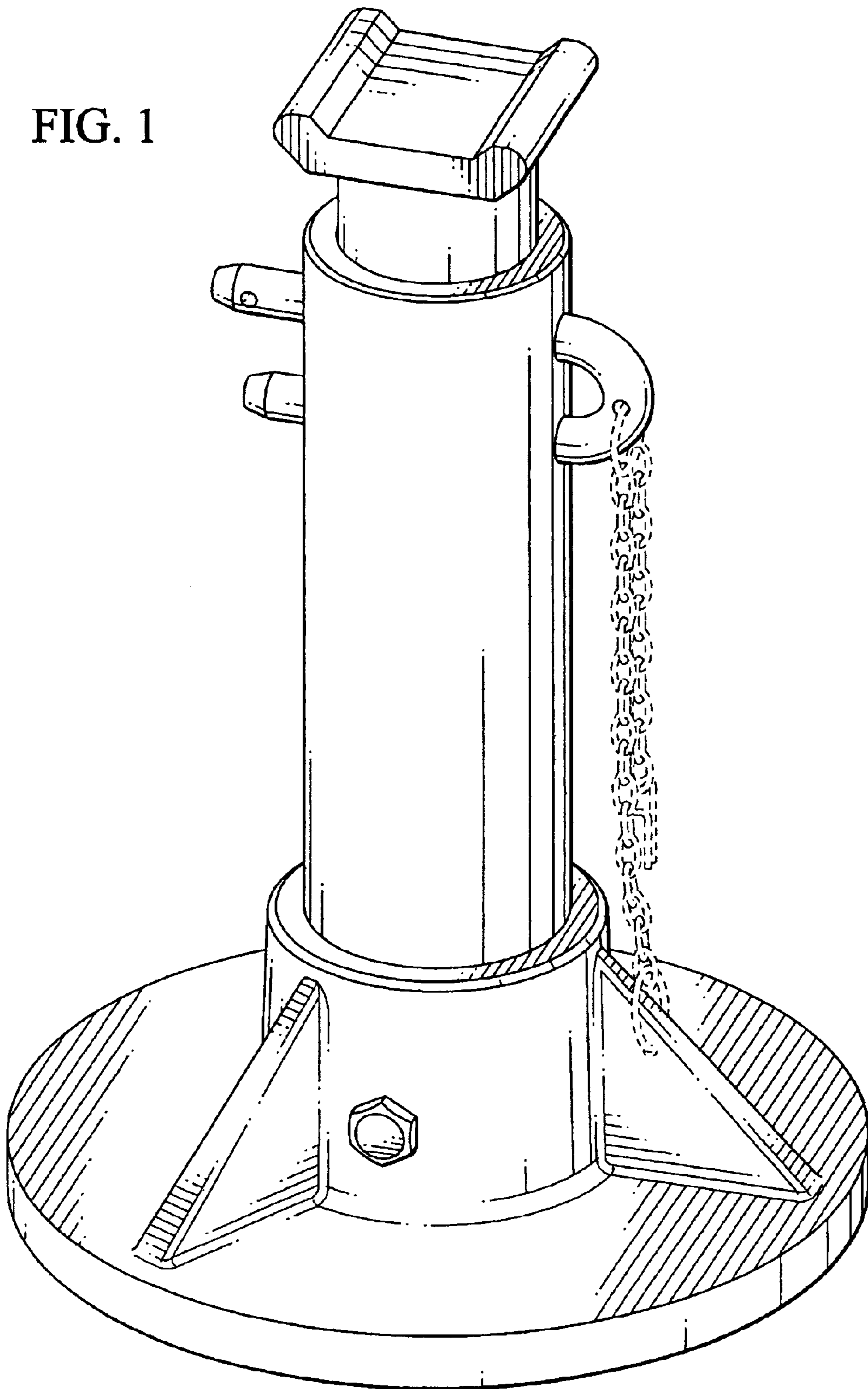
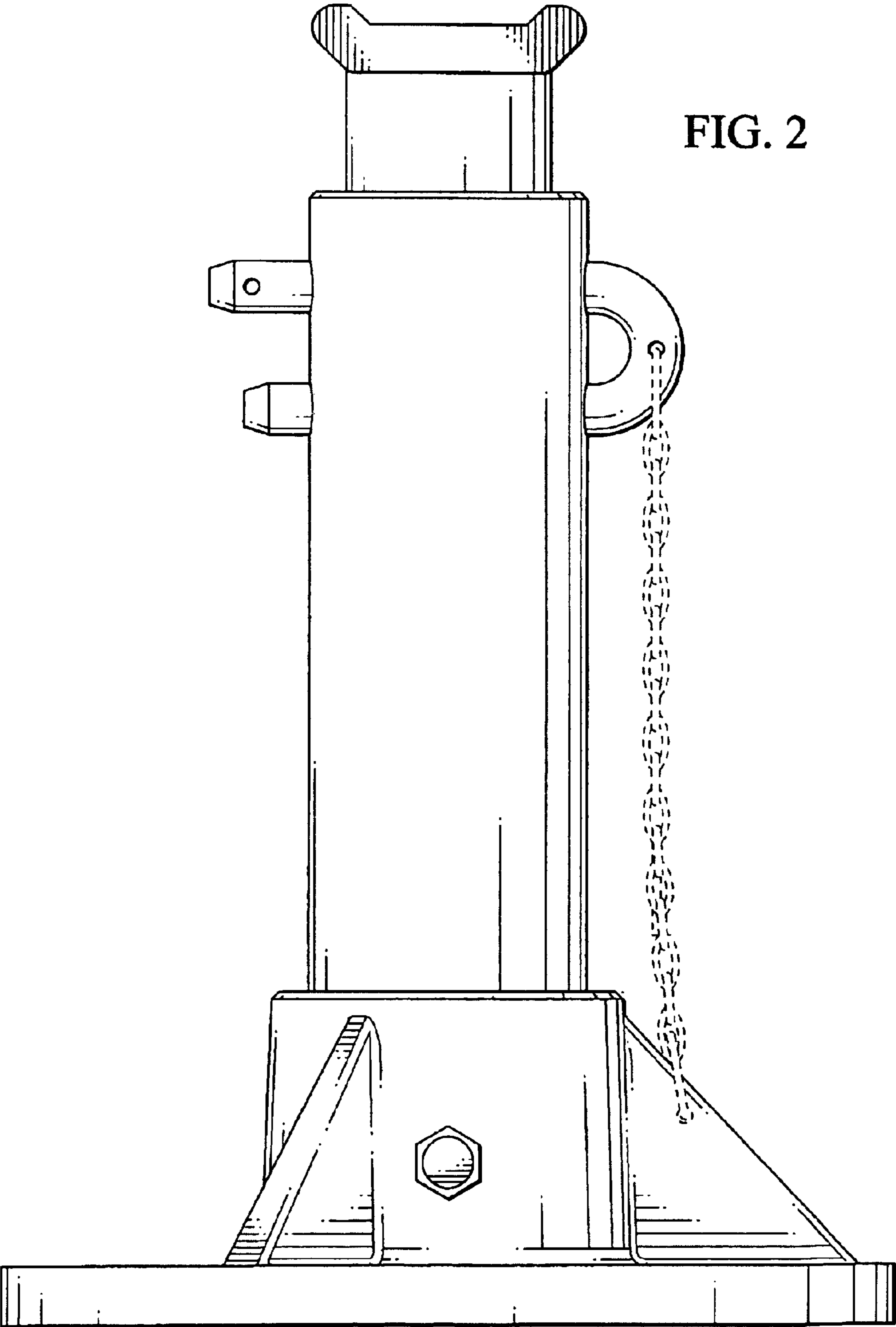

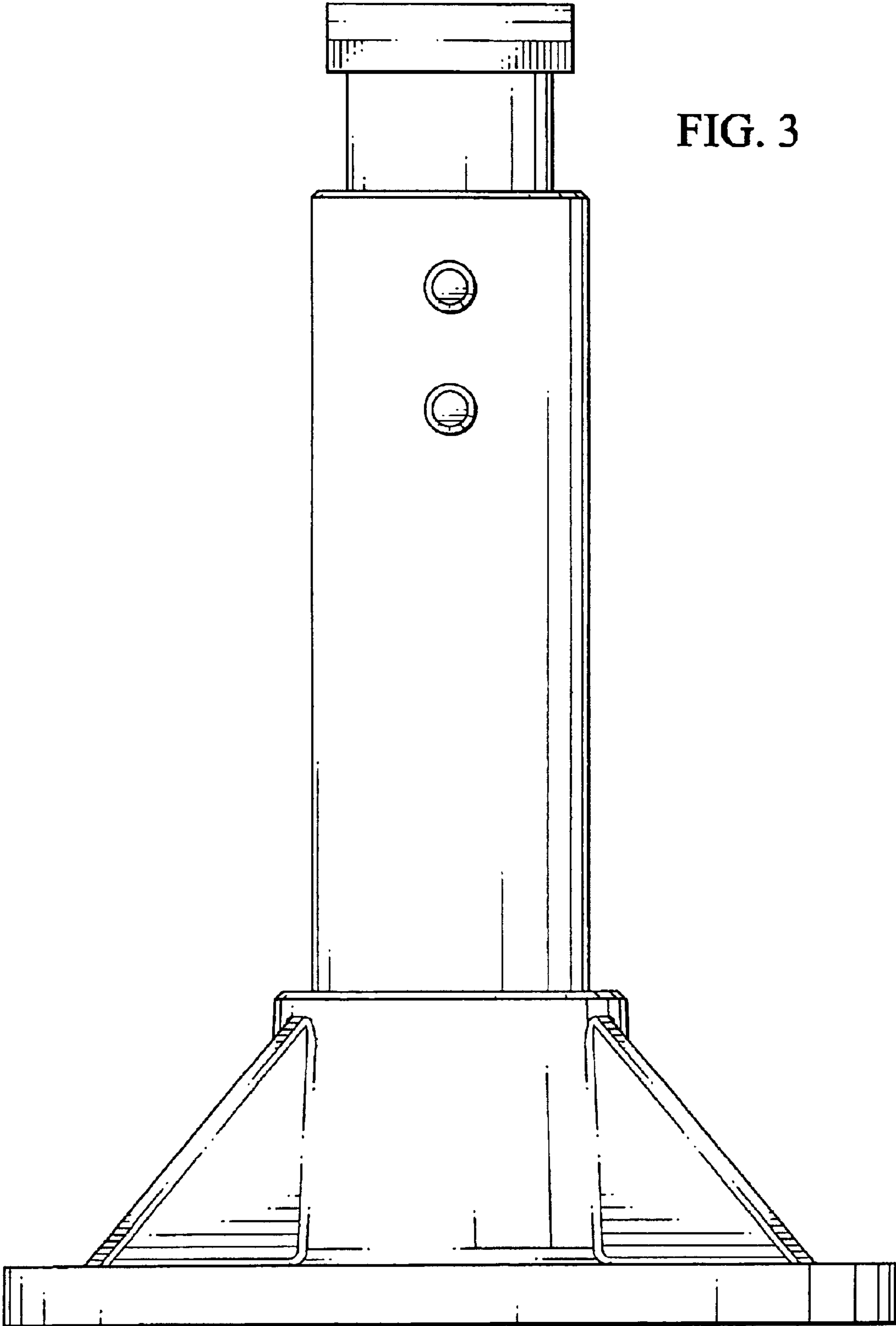

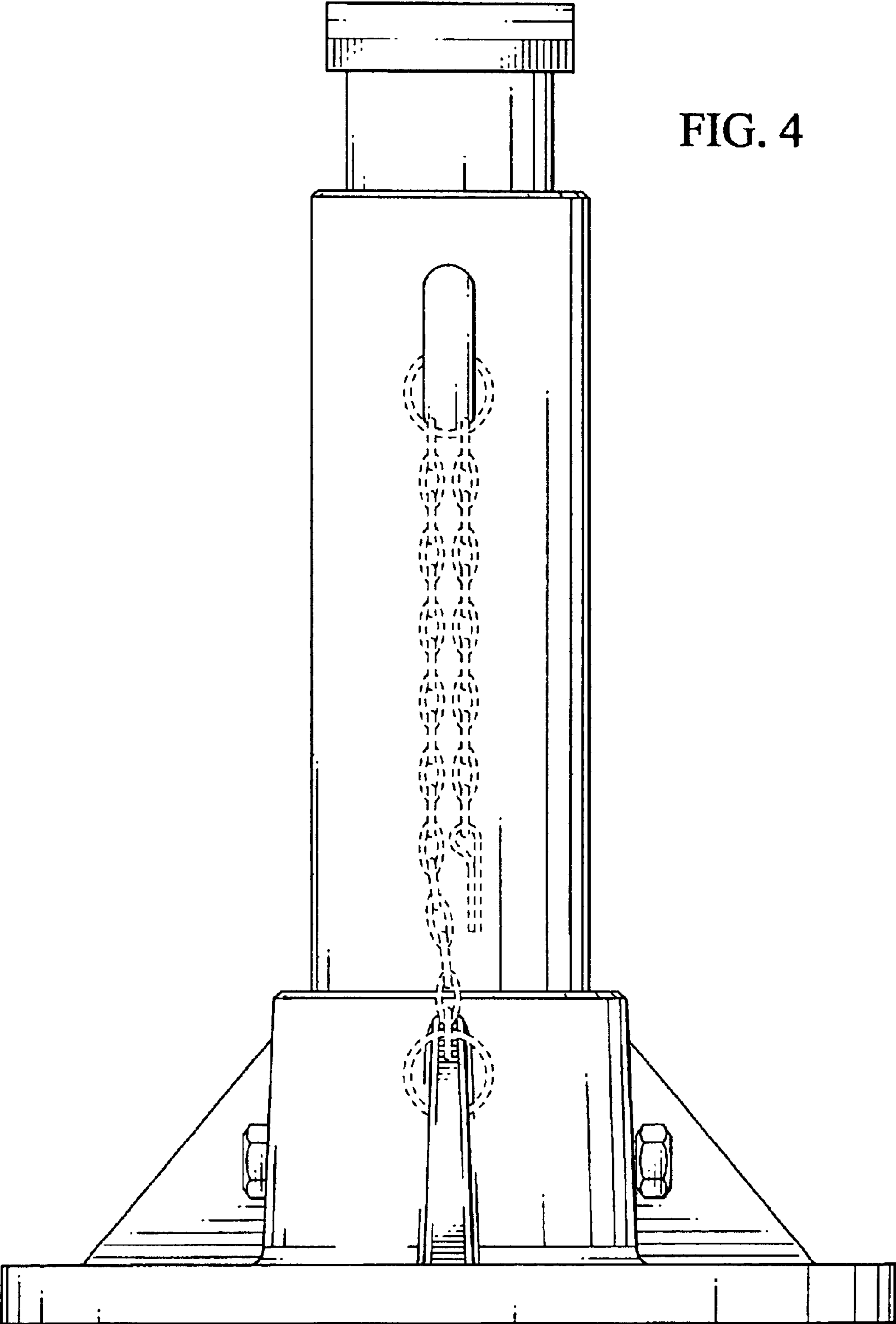

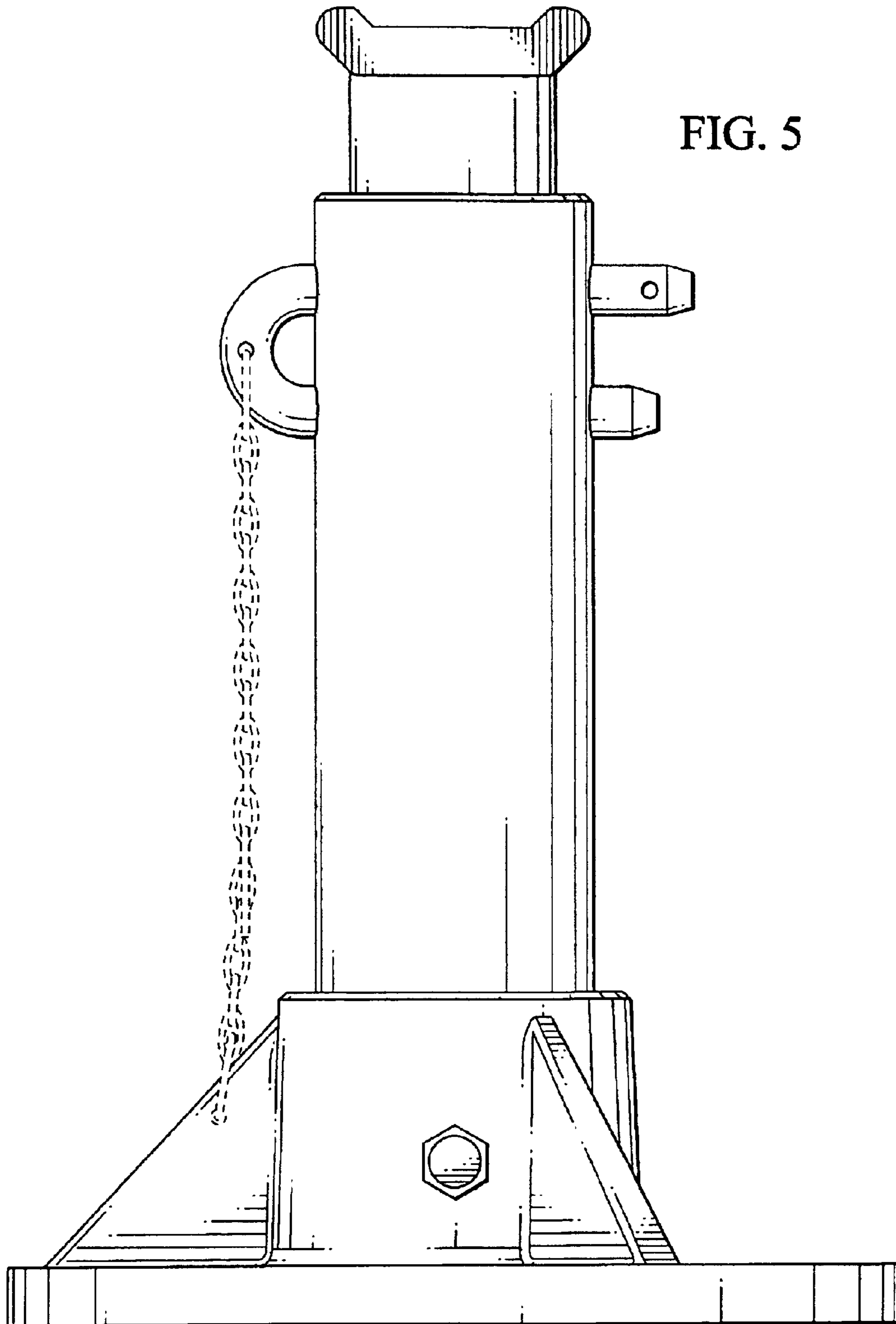

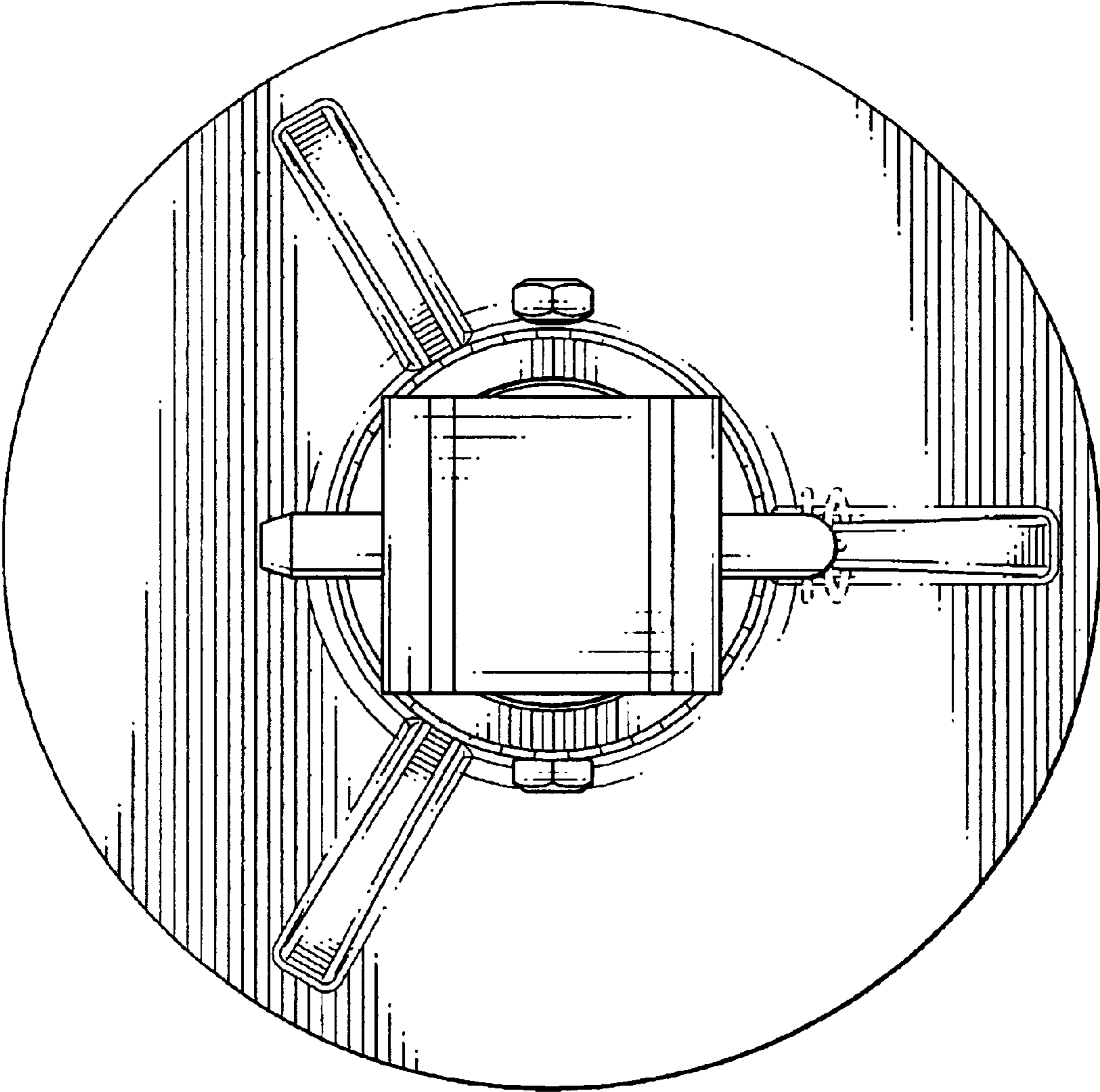
